BEEB TO TRUMP: sorry, no moolah

■ **Embattled broadcaster apologizes for splicing parts of Jan 6th speech, but refuses demands for compensation**

The BBC has apologized to US President Donald Trump for a Panorama episode which spliced parts of a speech together, but rejected his demands for compensation.

The corporation said on Thursday that the edit had given "the mistaken impression that President Trump had made a direct call for violent action" and said it would not show the program again.

Lawyers for Trump have threatened to sue the BBC for \$1bn (£759m) in damages unless the corporation issues a retraction, apologizes and compensates him.

The fallout from the scandal led to the resignations of BBC director general Tim Davie and head of news Deborah Turness earlier this week.

'sorry for the edit'

The apology comes after a second similarly edited clip, broadcast on Newsnight in 2022, was revealed by the Daily Telegraph.

In its Corrections and Clarifications section,

published on Thursday evening, the BBC said the Panorama programme had been reviewed after criticism of how Trump's speech had been edited.

"We accept that our edit unintentionally created the impression that we were showing a single continuous section of the speech, rather than excerpts from different points in the speech, and that this gave the mistaken impression that President Trump had made a direct call for violent action," it said.

Lawyers for the BBC have written to President Trump's legal team in response to a letter received on Sunday, a BBC spokesperson said.

"BBC chair Samir Shah has separately sent a personal letter to the White House making clear to President Trump that he and the corporation are sorry for the edit of the president's speech on 6

January 2021, which featured in the program," they said.

The BBC had no plans to rebroadcast the documentary on any platforms, the spokesperson said.

"While the BBC sincerely regrets the manner in which the video clip was edited, we strongly disagree there is a basis for a defamation claim."

'defrauded' viewers

In Trump's speech on 6 January 2021, he said: "We're going to walk down to the Capitol, and we're going to cheer on our brave senators and congressmen and women."

More than 50 minutes later in the speech, he said: "And we fight. We fight like hell."

In the Panorama programme from 2024, the clip shows him as saying: "We're going to walk down to the Cap-

itol... and I'll be there with you. And we fight. We fight like hell."

Speaking to Fox News, Trump said his 6 January 2021 speech had been "butchered" and the way it was presented had "defrauded" viewers.

The BBC received the letter from Trump's lawyers on Sunday. It demands a "full and fair retraction" of the documentary, an apology, and that the BBC "appropriately compensate President Trump for the harm caused".

It had set a deadline of 22:00 GMT on Friday for the corporation to respond.

In its letter to Trump's legal team, the BBC set out five main arguments for why it does not think it has a case to answer, as follows:

- First of all, it says the BBC did not have the rights to, and did not, distribute the Panorama episode on its US channels.

- When the documentary was available on BBC iPlayer, it was geographically restricted to viewers in the UK.

- Secondly, it says the documentary did not cause Trump harm as he was re-elected.

- Thirdly, it says the clip was not designed to mislead, but just to

shorten a long speech, and that the edit was not done with malice.

- Fourthly, it says the clip was never meant to be considered in isolation. Rather, it was 12 seconds within an hour-long programme, which also contained lots of voices in support of Trump.

- Finally, an opinion on a matter of public concern and political speech is heavily protected under defamation laws in the US.

A BBC insider said that internally, there is a strong belief in the case the corporation has put forward, and in its defence.

91 prisoners 'released by mistake', Calamity Lammy tells the House

A total of 91 prisoners were freed by mistake between April and October this year, according to new government figures.

The data for England and Wales was published by the Ministry of Justice, as ministers face pressure over accidental releases after a number of high-profile cases in recent weeks.

Justice Secretary David Lammy told MPs the figures were "symptomatic of a prison system under a horrendous strain", saying the Labour government had inherited a "crisis" from the Conservatives.

But shadow justice secretary Robert Jenrick said "the confusion created by Labour's botched early release scheme", which was brought in to ease prison overcrowding, was partly to blame.

'radical overhaul'

Giving a statement to the House of Commons after the figures were released, Lammy said: "I'm clear that we must bear down on these numbers, which are symptomatic of a prison system under a horrendous strain."

He told MPs the number of frontline prison

officers had been cut by a quarter between 2010 and 2017, leaving fewer experienced staff.

"Unsurprisingly, mistakes happen in those cir-

cumstances," he added.

Lammy said the prison release process needed "a radical overhaul" and "only technology will fix this issue over time".

He set out a number of actions the government was taking, including:

- A team of data scientists to review historic accidental releases and understand systemic issues.
- Up to £10m over six months for new AI tools to help reduce human error and upgrade "archaic" paper-based systems
- A new urgent courts hotline so prison staff can quickly check for outstanding warrants before offenders are released
- Simplifying release policy to standardize how cases are treated

released in error in June 2025.

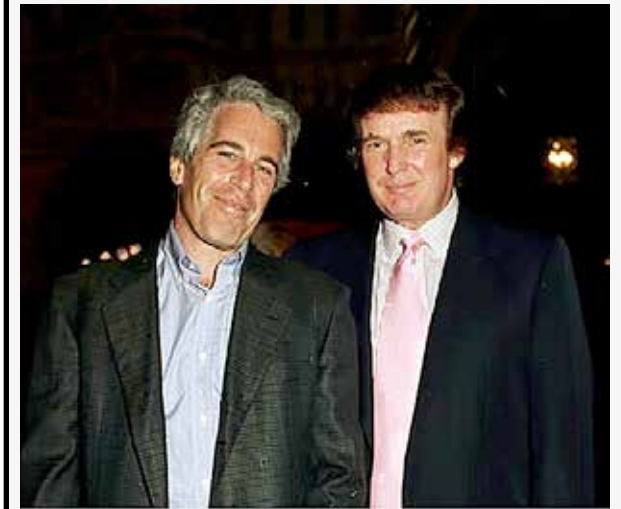
One is a foreign national offender and the other two are British.

Lammy said His Majesty's Prison and Probation Service was also investigating a further case of a potential release

in error on 3 November, who may still be at large.

Conservative shadow justice secretary Robert Jenrick accused Lammy of presiding over "a complete and utter farce", saying he had "literally lost track of how many prisoners he's lost".

I have an 'obligation' to sue, insists the President

US President Donald Trump has said he has an "obligation" to sue the BBC over the way a section of his speech was edited in a Panorama documentary.

Speaking to Fox News this week, he said his 6 January 2021 speech had been "butchered" and the way it was presented had "defrauded" viewers.

It is the first time Trump has spoken publicly about the matter since his lawyers wrote to the BBC and said he would sue for \$1bn (£759m) in damages unless the corporation issues a retraction, apologises and compensates him.

BBC chair Samir Shah has previously apologised for an "error of judgement" over the edit.

Appearing Tuesday evening on Fox News's The Ingraham Angle, the president was asked if he would go ahead with the lawsuit, responding "well I guess I have to, you know, why not, because they

defrauded the public, and they've admitted it".

Trump continued: "They actually changed my January 6 speech, which was a beautiful speech, which was a very calming speech, and they made it sound radical.

"And they actually changed it. What they did was rather incredible."

Asked again if he would proceed with the legal action, he said: "Well I think I have an obligation to do it, because you can't get people, you can't allow people to do that."

The Fox News interview was recorded on Monday, though the section concerning the BBC was not published by Fox News until late on Tuesday evening in the US.

If Trump sues in Florida, he would also need to establish the BBC Panorama documentary was available there. There is no evidence so far to suggest that it has been shown in the US.

'utter farce'

It comes after the government launched an independent review of accidental releases, which is expected to report back in February next year.

In his statement, Lammy also gave more details about three prisoners released by mistake who are still at large.

The first was in jail for failure to surrender to the police and was released in error in December 2024.

The second was in prison for a drug offence and released in error in August 2024, while the third was in prison for aggravated burglary and

Seven charged over child rape ring

Seven men have been charged with more than 40 offences against 11 teenage victims in an investigation into group-based child sexual exploitation in Bristol.

Avon and Somerset Police said the alleged offences date from between 2022 and 2025.

Avon and Somerset Police said: "It follows an investigation which began in November 2023 after concerns were raised about the sexual exploitation of a teenage girl.

In April 2024, initial arrests were made as part of a day of action in the city. Those arrested were released on bail to allow enquiries to take place, with a dedicated team working to identify and investigate offences."

The charges relate to 11 victims in total, who were aged in their mid to late teens at the time of the alleged offences.

Syrian national Mohamed Arafe, 19, of Speedwell in Bristol, has been charged with five counts of arranging or facilitating the sexual exploitation of a child, one count of causing or inciting the sexual exploitation of a child, one count of sexual assault, one count of being concerned in the supply of cocaine and a further count of being concerned in the supply of ecstasy.

Iranian national Sina Omari, 20, of Fishponds in Bristol, has been charged with two counts of rape, four counts of arranging or facilitating the sexual exploitation of a child, one count of causing or inciting the sexual exploitation of a child, two counts of making an indecent photograph of a child, one count of being concerned in the

Andrew's name get another tweak

Andrew Mountbatten-Windsor's name to be hyphenated, as decreed by late queen

BUCKINGHAM Palace corrected itself this week, restoring the hyphen to the former Prince Andrew's new official name.

Ever since the disgraced royal was demoted to plain Mr Andrew Mountbatten Windsor, royal observers and historians have scratched their heads over his missing hyphen.

Buckingham Palace's official statement announcing his new commoner status was clear, in black and white, that aside from losing his HRH and princely title and dukedom, he was also to be deprived of a punctuation mark that had been officially decreed by his late mother, Queen Elizabeth II.

Princess Anne signed her 1973 marriage register as Anne Mountbatten-Windsor, the Duke and Duchess of Edinburgh's children use Mountbatten-Windsor, as do the Duke and Duchess of Sussex's children – all with hyphens.

Even in a family with numerous and ever-changing surnames – Windsor, Wales, York,

Edinburgh – Mountbatten-Windsor has stood fast since Queen Elizabeth's decision 65 years ago that her descendants should be so named – in tribute to her husband, Prince Philip.

So why not Andrew? His surname was missing the hyphen when his new name was announced on 30 October in the fallout over his friendship with the convicted sex offender Jeffrey Epstein.

When asked about the absence of a hyphen at the time, a palace spokesperson said: "Andrew Mountbatten Windsor was the name agreed."

But royal sources have now confirmed that Mountbatten-Windsor will indeed use the punctuation mark between his two last names. It is understood the palace has examined the 1960 privy council declaration, which includes a hyphen, and will use one from now on.

In 1960, Queen Elizabeth declared that her direct descendants – other than those with the style of royal highness and the title of prince or princess

– would use Mountbatten-Windsor when they needed a surname.

It was an important gesture to her husband, after she had decided on her 1952 accession that the royal family's surname would remain Windsor, and not Mountbatten, the Duke of Edinburgh's surname. Philip is said to have exclaimed: "I'm just

a bloody amoeba," and complained he was the only man in the country whose children would not bear their father's name.

Eight years later she gave him a concession of a double-barrelled surname joined by a hyphen – just days before their third child, Andrew, was born.

The official declaration on 8 February 1960 – be-

fore Andrew's arrival on 19 February 1960 – read: "My descendants, other than descendants enjoying the style title or attribute of royal highness and the titular dignity of prince or princess, and female descendants who marry and their descendants, shall bear the name of Mountbatten-Windsor."

Trump pardons UK billionaire Joe Lewis

■ Former Tottenham owner was fined \$5m and given three years probation by New York judge over 'brazen' insider trading scheme

Joe Lewis, the British billionaire and former owner of Tottenham Hotspur FC, has been pardoned by Donald Trump over a 2024 conviction for his part in a "brazen" insider trading scheme.

Lewis, 88, was fined \$5m (£3.8m) and given three years probation by a New York judge last year but was spared jail time after pleading guilty to involvement in a plan that prosecutors said was designed to enrich his friends, lovers and employees.

Lawyers for the east London-born investor initially accused prosecutors

of making an "egregious" mistake by charging him with multiple counts of securities fraud and conspiracy.

But Lewis, who also owns the largest stake in one of the UK's biggest operators of pubs, bars and restaurants, Mitchells & Butlers, later changed his plea to guilty after prosecutors agreed to a non-custodial sentence.

Lewis retained his right to change his plea again if a custodial sentence were imposed.

In a statement to the court at his sentencing last year, he said: "I made

a terrible mistake. I broke the law. I am ashamed, sorry, and I hold myself accountable."

The judge, Jessica Clarke, said Lewis's circumstances did not warrant incarceration and imposed a \$44m fine on his company, Broad Bay, on top of his \$5m personal fine and probation.

The White House confirmed the pardon on Thursday and said Lewis requested it so that he could receive medical treatment and visit his grandchildren and great-grandchildren in the US.

A 26-year-old man, who police are unable to name for legal reasons, has been charged with two counts of rape and one count of sexual assault.

Detective Chief Inspector Tom Herbert, the senior investigating officer, said: "This remains a complex and sensitive investigation which has the protection of young girls from exploitation and the disruption of offending at its very heart."

De Niro 'proud to be a part' of Manchester rebuild as latest Nobu outpost rises

Robert De Niro said he was "proud to be part" of Manchester as work got under way to build the city's tallest skyscraper this week.

The Godfather, Taxi Driver and Goodfellas star is a key investor behind the Nobu Manchester building which, once constructed by leading local developer Salboy, will be operated by Nobu Hospitality, a company co-owned by the Hollywood actor.

The 76-storey building, next to the Deansgate-Castlefield tram stop, will include 452 apartments, a high-end restaurant and a 160-bed-room hotel.

Confirming the project would take six years to complete, De Niro said Manchester had "real character [and was] creative, passionate and strong".

"I look forward to coming back when it is finished, if not before," said the 82-year-old star.

"I think it is going to take six years and I plan to be around."

Once finished, the 807ft (246m) tower - featuring a swimming pool, a spa, a gym and a garden - will be the UK's tallest building outside London.

De Niro said: "I haven't seen the city yet but I'd like to come back. Everyone is very nice, we're having a very nice time."

"It's great being here in Manchester because it has real character, we're proud to be part of it."

The skyscraper has been designed by architect Ian Simpson.

'Booming'
The Nobu brand was launched by De Niro with film producer Meir Taper and celebrity chef Nobu Matsuhisa.

They opened their first restaurant in New York in 1994 and they have since

expanded their hospitality empire to dozens of cities around the world.

Manchester will become Nobu's second UK location, 35 years after it opened in London.

Salboy managing director Simon Ismail said: "Manchester's been booming for over 10 years now and the population just continues to grow."

11-year stretch for 'Queen of Crypto'

A Chinese woman said by police to have bought cryptocurrency now worth billions of pounds using funds stolen from thousands of Chinese pensioners, has been sentenced to 11 years and eight months for money laundering.

Passing sentence at Southwark Crown Court on Tuesday, Judge Sally-Ann Hales told Qian Zhimin she was "the architect of this offending from its inception... your motive was one of pure greed".

After fleeing China, Qian moved to a mansion in Hampstead, north London. The Metropolitan Police raided it a year later and made one of the world's single largest crypto seizures.

More than 100,000 Chinese people invested their

money in her company - which claimed to be developing high-tech health products and mining cryptocurrency. In reality, she embezzled the funds, police say.

Qian Zhimin, 47, arrived in the UK under a fake passport in September 2017, after Chinese police started investigating her.

six year plan

She moved into a mansion on the edge of Hampstead Heath, at a rent of more than £17,000 (\$22,700) a month. To pay for this, she needed to convert her Bitcoin stash back into money she could spend.

So she posed as a wealthy antiques and diamond heiress, and hired a former takeaway worker as her personal assistant,

who she asked to trade the cryptocurrency into other assets, such as cash and property.

As Bitcoin rocketed in value, Qian could achieve what her company promised its investors - that they could "get rich while lying down".

But Qian was also drawing up a bold six-year plan for future schemes,

according to her diary. Her notes outline plans to found an international bank, buy a Swedish castle, and even to ingratiate herself with a British duke.

Her grander stated objective was to become queen of Liberland, an unrecognised microstate on the Croatian-Serbian border, by 2022.

In the meantime, Qian had Wen look for houses she could buy in London. But her attempts to purchase an especially large property in Totteridge Common - an area known for its substantial, secluded residences - triggered a police investigation when Wen was unable to account for her boss's wealth.

Tributes flow as Pauline Collins dies at 85

"She will always be remembered as the iconic, strong-willed, vivacious and wise Shirley Valentine"

Pauline Collins, the star of the film *Shirley Valentine*, for which she was Oscar nominated in 1990, has died at the age of 85.

She died "peacefully" in her London care home surrounded by her family having had Parkinson's disease for several years, her family said.

Collins will be best remembered for her portrayal of disgruntled housewife Shirley in Lewis Gilbert's award-winning film, based on the acclaimed stage play by Willy Russell.

Her critically acclaimed performance also won her the Golden Globe Award for best actress along with a Bafta.

Collins' family said

in a statement: "Pauline was so many things to so many people, playing a variety of roles in her life. A bright, sparky, witty presence on stage and screen. Her illustrious career saw her play politicians, mothers and queens.

"She will always be remembered as the iconic, strong-willed, vivacious and wise Shirley Valentine - a role that she made all her own. We were familiar with all those parts of her because her magic was contained in each one of them."

They added she was their "loving mum, our wonderful grandma and great-grandma", and actor John Alderton's "life-

long love".

"Warm, funny, generous, thoughtful, wise, she was always there for us," they said, thanking her carers, who looked after her with "dignity, compassion, and most of all love".

'brilliant range'

"She could not have had a more peaceful goodbye. We hope you will remember her at the height of her powers; so joyful and full of energy; and give us the space and privacy to contemplate a life without her."

Her husband Alderton also issued a separate statement, describing his wife as "a remarkable star", having worked

with her more than any other actor.

"What I saw was not only her brilliant range of diverse characters but her magic of bringing out the best in all of the people she worked with," he said.

"She wanted everyone to be special and she did this by never saying 'Look at me'. It's no wonder that she was voted the nation's sweetheart in the 1970s."

He added she would always be remembered for *Shirley Valentine*, "not only for her Oscar nomination or the film itself, but for clean-sweeping all seven awards when she portrayed her on Broadway in the stage play, in which she played every character herself".

Shirley Valentine is a middle-aged Liverpool housewife, who is tired of her insensitive husband, played by Bernard Hill,

and her suburban existence.

But her life changes when her best friend wins a holiday for two to Greece. Shirley goes, and falls for a local tavern owner - played by Tom Conti - who she goes on to have a passionate holiday fling with, reinvigorating her lust for life.

global recognition

Collins first played the title role of *Shirley Valentine* at the Vaudeville Theatre in London in 1988. She won that year's Olivier award for best actress.

Her other films included 1991's *City of Joy* with Patrick Swayze, filmed in Calcutta, which brought her wider recognition globally.

Born in Exmouth, Devon, in 1940, Collins was raised near Liverpool and started out her career as a teacher.

Her love of the stage led her to take up acting on a part-time basis, and in 1957 she had a role as a nurse in the *Emergency Ward 10* TV series.

After a number of stage roles, she used her Liverpool accent to land a leading role on *The Liver Birds* in 1969.

She starred as Dawn in five episodes before she left to be replaced by Nerys Hughes, who played the role of Sandra.

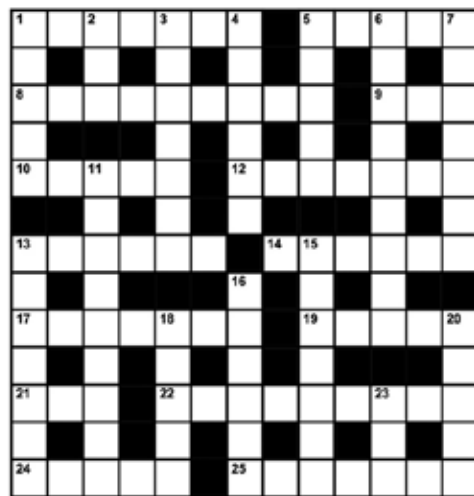
It was through acting that she met her husband John Alderton. They married in 1969 and had three children, Nicholas, Kate, and Richard.

Alderton and Collins starred alongside each other in a number of television and film roles, such as ITV's popular series *Upstairs, Downstairs*, in which she played a maid, Sarah, appearing from 1971 to 1973.

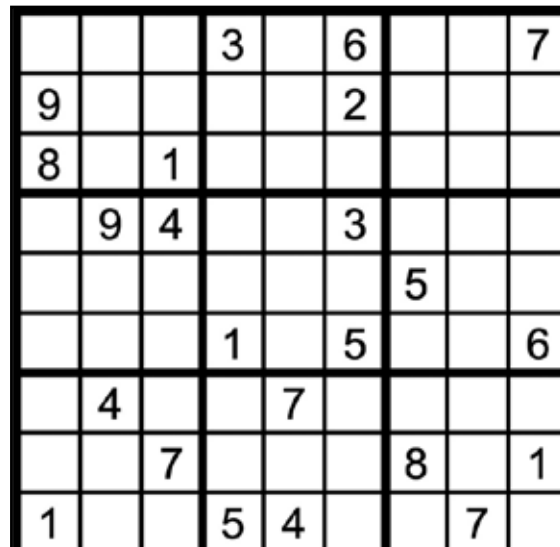

News from Britain

Charles leads royals at the Cenotaph on Remembrance Sunday

King Charles led the annual Remembrance Sunday commemorations this week, laying a wreath at the solemn ceremony held at the Cenotaph on Whitehall in central London.

With autumn leaves falling, he was joined by other members of the Royal Family, senior politicians and dignitaries, sharing the echoing two-minute silence.

But among the 10,000 veterans marching, there were now only about 20 who had served in World War Two, including six now 101 years old.

This was still living memory, rather than a history lesson, for these last survivors of the conflict.

'emotional year'

Many are now in wheelchairs and they drew warm applause from the crowds, aware

that they were seeing history inching out of view.

Sid Machin, aged 101, said it had been an "emotional year" remembering those who served with him in the Far East. This summer saw events marking the 80th anniversary of VE Day and VJ Day, the end of the World War Two in Europe and the Far East.

"I will be thinking of everyone I served with and especially those that didn't make it home," he said.

Donald Poole, also aged 101, who served with the Royal Army Ordnance Corps, wanted to "pay tribute to the poor souls who have died in all conflicts and I know how lucky I am to still be here".

While others were lining up to thank his generation, he paid his own thanks to the civilian services, "particularly the

fire service who saved so many lives during the Blitz".

That was a reminder that as well as the military veterans, the commemoration by the Cenotaph brings together representatives of other types of service.

There were police, fire brigades, ambulance staff, transport workers and coastguards laying wreaths and marching.

The Remembrance service is a time to pause in a noisy world. There's the two-minute silence and then the Last Post played by a bugler, reverberating around Westminster rather than the usual roar of traffic.

The scandals surrounding the King's brother Andrew have been like a howling gale in recent weeks, but this was a moment of quiet and stillness.

It is a ceremony that is about keeping the faith with previous generations. The King, wearing a field marshal's uniform, laid a wreath that is the same as the wreaths once placed here by his grandfather, George VI, with 41 paper poppies on an arrangement of black leaves.

They both would have stood in the same place facing the same message - the Glorious Dead - carved on the Cenotaph.

King Charles's uniform still has the cypher of his mother, Elizabeth II.

The Prince of Wales, back from presenting his Earthshot environmental prize in Brazil, joined his father in laying a wreath.

Meanwhile, Queen Camilla and the Princess of Wales looked down from the Foreign Office balcony.

More than 20 different

faith groups were represented around the plain stone of the Cenotaph, with clerical robes mixing in with the military uniforms.

Sarah Mullally, who is going to become the first female Archbishop of Canterbury, delivered a reading before a hymn was sung.

And like the ghosts of Christmas past, eight former PMs were lined up. Sir John Major is now the elder statesman among them.

The current incumbent, Sir Keir Starmer, said of the moment: "We remember a generation who stood against tyranny and shaped our future. Their

legacy is peace, and our duty is to protect it."

Conservative leader Kemi Badenoch stepped forward with her wreath.

Foreign Secretary Yvette Cooper and Home Secretary Shabana Mahmood laid wreaths on behalf of the intelligence agencies, MI5, MI6 and GCHQ.

Stokes shrugs off 'has-beens' over Ashes prep

Captain Ben Stokes says England will go "balls to the wall" in their only Ashes warm-up game after "has-beens" questioned their limited preparation in Australia.

England began a three-day game against an England Lions team on Thursday at a park ground in Perth in which Stokes took six wickets on the first day.

The build-up to this tour is similar to England's preparations for their five previous overseas tours under Stokes and coach Brendon McCullum.

However, it differs from many of England's previous Ashes tours, when they played several warm-up games.

"The next three days is balls to the wall for everyone - no easing into it," Stokes told reporters.

"Everyone has been preparing for this series for a long time now so, come the 21st, we will be good."

Speaking to the media for the first time since sustaining a shoulder injury in July, Stokes covered a range of subjects, including criticism of England's warm-up plans, his fitness to play a full role as an all-rounder in the first Test and a much-debated decision

to install Ollie Pope as England's number three.

England held a limited training session at Lilac Hill in Perth on Wednesday. The batters and spin bowlers were in attendance, but the pace bowlers sat out after an intense workout on Tuesday.

Past Ashes tours have regularly included at least three warm-up matches before the first Test, usually against domestic opposition. The 2010-11 Ashes, the last time England won in this country, is often used as an example of when they benefited from strong preparation, winning two and drawing one of their three tour games.

However, there are many other Ashes tours when England have played multiple warm-up matches, only to then lose the Test series. The last tour down under, in 2021-22, was the first to employ a shortened build-up, though that was mainly because of Covid restrictions.

There are number of reasons for England's short build-up to the first Test, beyond preference for a method that has served them well in the past.

'arrogance'

In a packed schedule, England have just finished a white-ball series in New Zealand.

Even if they had arranged a string of first-class matches in Australia, their opposition probably would not have been strong, given the ongoing domestic Sheffield Shield competition.

Criticism of England's preparation has come from former captains Lord Botham, Michael Vaughan and Graham Gooch.

Botham said it "borders on arrogance", Vaughan called it a "huge risk" and Gooch labelled it "glorified practice".

"Cricket has changed so much," said Stokes. "Preparation is nowhere near as simple as it used to be. You could come out on a tour two months before the first game started."

"We've been preparing for this tour not over the last three weeks, but putting a lot of thought and process into this for a few years now. I don't know

what else we're expected to be able to do.

"There are quite a few factors that go into why we can't prepare how the has-beens maybe prepared in the past. It's all changed. We're very comfortable with how we prepare because we leave no stone unturned."

Stokes, 34, has not played since being ruled out of the final Test against India in the summer.

He was superb in that series before sustaining the injury, which came after he put himself through a heavy bowling workload. Injuries have prevented Stokes from completing any of England's past four Test series.

However, he has been bowling at full pace in training, which he said he has been doing for two months.

With Australia captain Pat Cummins missing the first Test because of a back

injury, the eventual destination of the urn could be influenced by which skipper spends most time on the field, and Stokes said he is in a "good place" to get through the series.

"That's all I've been doing for last three months; making sure I'm fit and strong," he said.

"When the Test series starts, it's about being sensible through the rest periods, about how much work I do, because I've been building up to get here now."

ta into a mistake while attempting to clear the ball after 15 minutes.

From the resulting corner, Jack Taylor found Liam Scales at the far post, with the Celtic defender's header back into the six-yard area turned in by Parrott.

Sensing opportunities against a shaky Portuguese backline, Chiedozie Ogbene also looked threatening for the hosts and nearly doubled the lead when he cut inside and struck a post with a curling right-foot shot.

With seconds remaining in the first half, Parrott handed the Irish their first two-goal lead in two years when he cut inside Ruben Neves and beat Costa at his near post, sparking ecstatic scenes among the home fans in Dublin.

The Republic of Ireland would have expected a strong response from the visitors, and while Caoimhin Kelleher produced a fine save to deny Goncalo Ramos, the hosts were able to comfortably see the game out and complete a famous win over the team ranked fifth in the world.

It is the Republic of Ireland's first competitive win over Portugal in seven attempts stretching back to 1995 and a vital boost in their bid to reach the World Cup for the first time since 2002.

By contrast it was a bad night for Ronaldo, who was initially shown a yellow card for swinging his elbow into Irish defender Dara O'Shea's back on the hour mark.

However, the Portugal captain's card was upgraded after the video assistant referee (VAR) advised referee Glenn Nyberg to review the incident on the pitchside monitor. It was his first red for Portugal in his 226th appearance.

Rob Edwards relishes taking Wolves hot seat

Rob Edwards was unveiled as the new head coach of Wolves on Monday, saying he made "one of the toughest decisions" of his managerial career by choosing to leave high-flying Championship side Middlesbrough to join a club currently eight points adrift of Premier League safety.

The 42-year-old previously played for Wolves, making more than 100 appearances between 2004 and 2008, has been a coach at Molineux and also grew up in Telford.

"This has been one of the toughest decisions of my career," Edwards wrote on Instagram. "In truth, I wouldn't have considered leaving Middlesbrough for any other club.

"Wolves is a special club for me. It's where I grew as both a player and a coach. It's still

where my family calls home.

"It has always been my dream to come back and these opportunities do not come around too often.

"Middlesbrough is an incredible club with a fantastic owner, staff and passionate supporters. I want to thank everyone at the club for the opportunity to lead this squad.

"It is a great group of players that I genuinely hope and believe will deliver success this season.

"I could not be prouder of the environment we built together and how it all gelled together so quickly - the players, the staff and the fans, who drive it all."

Rob Edwards' appointment on a three-and-a-half-year contract follows the sacking of Vitor Pereira earlier this month.

The gamble for Ed-

wards is that he will need to unite a fractured club where fans' frustrations with the ownership have bubbled over.

Swapping a Premier League promotion challenge for a battle to stay in the top flight is brave enough at the best of times, let alone when the club in question appears to have big issues in the background.

Anger towards owners Fosun and executive chairman Jeff Shi is widespread, even if the fans are unlikely to achieve their ultimate goal of pressuring Fosun to sell.

Wolves are aware of the division and Edwards will be joined by Harry Watling, who takes on the role of assistant head coach and was

part of his team at the Riverside Stadium.

Paul Trollope, Joleon Lescott and Conor Coady have reportedly all been sounded out over potential roles in a new-look backroom staff.

The potential additions of Lescott and Coady are rated as difficult to complete - particularly the latter who is still playing for Wrexham.

Talk less, drive more, Ferrari boss tells Hamilton

Ferrari chairman John Elkann says the company's Formula 1 drivers Lewis Hamilton and Charles Leclerc "need to focus on driving and talk less".

Elkann's comments come on the back of a Sao Paulo Grand Prix last weekend in which Ferrari suffered a double retirement and Hamilton described his maiden season with the team as a "nightmare".

Ferrari dropped to fourth in the constructors' championship as a result of the race. They are 36 points behind Mercedes and four adrift of Red Bull with three grands prix and a sprint remaining.

Elkann said at an Olympics sponsorship event in Rome on Monday that the team's mechanics and engineers were performing well, but "if we look at the rest, it is not up to scratch".

He added: "And we definitely have drivers

who need to focus on driving and talk less because we still have important races ahead of us and getting second place is not impossible.

"In Bahrain, we won the World Endurance Championship title. When Ferrari is united, we get results."

Elkann's remarks reflect the frustration and disappointment at Ferrari, who came close to becoming constructors' champions last year but have failed to win a grand prix this season.

But they are said to be meant to be taken in a constructive way as a spur to improve.

McLaren, who beat Ferrari by only 14 points last year, won the title with six races remaining this season.

The constructors' championship determines the teams' prize money and each position gained close to the top is worth ap-

proximately \$10m (£7.6m) over the place below.

Leclerc said on social media it had been a "very difficult" weekend in Sao Paulo - Ferrari picked up only six points overall, thanks to Leclerc and Hamilton finishing fifth and seventh respectively in the sprint race.

Leclerc added: "Disappointing to come back home with nearly no

points at all for the team in what is a critical moment of the season to fight for the second place in the constructors' championship.

"It's uphill from now and it's clear that only unity can help us turn that situation around in the last three races. We'll give it all, as always."

Hamilton also posted on social media, saying: "I

back my team, I back myself. I will not give up. Not now, not then, not ever."

Leclerc - who qualified third in Sao Paulo at the weekend but was taken out of the race in a crash with Mercedes' Kimi Antonelli after the Italian collided with McLaren's Oscar Piastri - has scored seven podiums, with a best result of second in Monaco and Mexico.

World Cup Qualifying: England cruise to 2-0 home victory as Tuchel records seventh successive win

England extended their flawless record in World Cup qualifying with a seventh successive victory as Serbia were beaten at Wembley on Thursday.

Head coach Thomas Tuchel is now able to fine-tune his plans after the Three Lions confirmed their place last month in next summer's showpiece with two games to spare, and this was a low-key affair on a rain-soaked evening.

Tuchel gave a first senior cap to Manchester City's Nico O'Reilly at left-back, but it was one of England's established stars who made the breakthrough, Bukayo Saka scoring after 28

minutes with a perfectly placed left-foot volley beyond Serbia keeper Predrag Rajkovic.

Aston Villa's Morgan Rogers was selected ahead of Jude Bellingham in the number 10 role and displayed plenty of energy and some nice touches before being replaced by his boyhood friend after 65 minutes.

Phil Foden also came on as substitute at the same time, and he combined with Bellingham to set up another replacement, Eberechi Eze, for a superb curling finish to wrap up England's win in the last minute.

Serbia mounted the occasional threat in the

second half, but England goalkeeper Jordan Pickford was able to extend his record run of clean sheets to 10, while Tuchel's side have now scored 20 goals without reply in their successful qualifying campaign.

It was inevitable that England's meeting with Serbia would lack a sense of jeopardy with World Cup qualification assured, but Tuchel will still have been left with increasing confidence about the forthcoming World Cup following this win.

The sight of Bellingham and Foden emerging from the bench after 65 minutes, along with goalscoring substitute

Eze, was another demonstration of the depth of talent at Tuchel's disposal as he shapes his final World Cup plans.

Rogers, Marcus Rashford and Elliot Anderson had all made their con-

tributions, while Crystal Palace's outstanding young midfielder Adam Wharton, on as a late substitute, finally got more minutes for England for the first time since June 2024.

This has been a hugely satisfying qualifying campaign for Tuchel and England, gathering momentum exactly as he would have wished before the final qualifier in Albania on Sunday.

Ronaldo sick as a Parrot soars

Cristiano Ronaldo was sent off for the first time in international football on Thursday as Portugal missed the chance to secure World Cup qualification with a surprise 2-0 defeat by the Republic of Ireland at Aviva Stadium.

Hungary's victory in Yerevan earlier the same

day simplified the situation for the Republic. Knowing defeat would end their qualifying hopes, they needed to produce the best performance of the Hallgrímsson era against the 2016 European champions.

And boy did they deliver.

While Evan Fergu-

son's injury robbed the Irish of their top scorer, Parrott stepped up in spectacular fashion.

The AZ Alkmaar forward, who has six goals in seven Eredivisie games this season, led the line with energy and intensity, forcing Portugal keeper Diogo Cost. **cont. on page 19, col. 1**
