Hillsborough report 'a waste of time'

Families of the 97 victims say they will never get justice

A woman whose brother died in the Hillsborough tragedy has slammed a long-awaited report into police conduct as a "waste of time".

An Independent Office for Police Conduct (IOPC) inquiry found 12 police officers would have faced gross misconduct proceedings for "fundamental failures" on the day, and "concerted efforts" to blame fans in the aftermath.

Louise Brookes' brother Andrew - a car worker at Longbridge - was among the 97 Liverpool fans who died in the 1989 stadium crush.

Ms Brookes, from Bromsgrove, said she fears justice will never be served, because the 12 will not face disciplinary action as they had retired before the investigation.

If Andrew had survived that day, he would have been really outraged at how deceitful and unfair it has all been when [the victims] were blamed for something that they haven't done," Ms Brookes, from Bromsgrove, said in reaction to the report.

"[Police] are referring to these officers who have been named in the report as being old, but they weren't old when they were lying and covering up.

"They have all led a normal life, a lot of them climbed the career ladder on the back of our dead 97."

law changed

Ex-South Yorkshire Chief Constable Peter Wright and ex-Ch Supt David Duckenfield are among officers who would have had cases to answer over the deaths.

Former Assistant Chief Constable Mervyn Jones and Det Ch Supt Michael Foster, both of West Midlands Police, would have had cases to answer over their roles in leading the subsequent investigation into the disaster, including for "alleged bias towards police and against supporters" and "not intervening in SYP's

account amendment process".

The law was changed in 2017 so that ex-officers were able to face misconduct charges, but not retrospectively. All 12 retired before investigations began in 2012.

A spokesperson for West Midlands Police said: "The deaths of 97 people following the Hillsborough stadium disaster was a tragedy and our thoughts remain with the families and friends of the victims who must live everyday with the loss of their loved ones."

And there were calls for the former chief constable of Merseyside Police Sir Norman Bettison - who is one of the 12 retired officers - to be stripped of his knighthood.

MP for Liverpool West Derby and Hillsborough survivor Ian Byrne said removal of the honour is "the only remaining

sanction left for families and survivors to pursue."

Sir Norman declined to comment on the publication of the IOPC report, but speaking to BBC Radio Merseyside in 2018, he said in the 10 years between the disaster and his application to become Merseyside chief constable "nobody had ever questioned" what he had done "let alone criticised it".

He said at the time: "Of course, people say now, Hillsborough should have been uppermost in your mind in applying to Merseyside.

"And perhaps, perhaps, I didn't read the

Merseyside tempera- ture as well as I should have done, but there was nothing in my mind that connected a task that I'd done 10 years ago with an application for a job a decade later."

He said it was "a myth" that the police authority were kept in the dark about his Hillsborough connections.

"In actual fact, there was a report that went to the shortlisting committee and the final appointments committee that highlighted the fact that I'd been involved in some post-disaster investigation work and I was appointed nevertheless," he added.

Several UK newspapers were excoriating in their reaction to the report, with the i paper featuring photos of all 97 victims on the front page while the Times described the report as "damning".

The Daily Mirror said it confirms what families "have feared all along": that nobody will face justice. The paper claims that officers, criticized for their failures, have been allowed to simply "walk away".

One woman whose son was killed in the tragedy is quoted in the Guardian as saying: "How lucky they are to grow old".

Some jury trials to be scrapped in England and Wales

■ Controversial measure aims to ease huge backlog of cases

Jury trials in England and Wales for crimes that carry a likely sentence of less than three years will be scrapped, the justice secretary has announced.

The reforms to the justice system include creating "swift courts" under the government's plan to tackle unprecedented delays in the court system.

Serious offences including murder, robbery and rape will still go before a jury, and volunteer community magistrates, who deal with the majority of all criminal cases, will take on even more work.

David Lammy said the reforms were "bold" but "necessary", but the Conservatives described the plans as the "beginning of the end of jury trials".

Retired Court of Appeal judge Sir Brian Leveson was asked by the Lord Chancellor to come up with a series of proposals to reduce the backlog in the courts, in a process which began back in December 2024.

'total collapse'

These proposals included jury-free trials and more out-of-court settlements like cautions.

In July, Sir Brian said "fundamental" reforms were needed to "reduce the risk of total system collapse".

A previous version of the plan was to end jury trial for most crimes attracting sentences of up to five years.

But announcing the reforms in the Commons on Tuesday, David Lammy retreated from the

most radical reforms.

Lammy said the new system would get cases dealt with a fifth faster than jury trials.

He added that it was necessary as current projections have Crown Court case loads reaching 100,000 by 2028, from the current backlog of almost 78,000.

This means that currently a suspect being charged with an offence today may not reach trial until 2030.

Six out of 10 victims of rape are said to be withdrawing from prosecutions because of delays.

A defendant's right to a jury trial would also be restricted to prevent

them from "gaming the system", Lammy said.

But jury trials will be guaranteed for the most serious offences, including rape, murder, aggravated burglary, blackmail, people trafficking, grievous bodily harm and the most serious drug offences, the Ministry of Justice (MoJ) said.

German leader to UK: don't look back in anger

Germany's president has drawn a parallel between his country's ties with the UK post-Brexit to the recent reunion of the famously feuding Oasis brothers.

Frank-Walter Steinmeier told MPs and peers that disappointment and uncertainty had followed the UK split from the EU but both sides had decided "not to stay stuck in these feelings".

"Don't Look Back in Anger, as one of the most famous songs by Oasis puts it so well," he said in Parliament on the second day of his state visit.

He began his visit - the first by a German leader in 27 years - on Wednesday with a ceremonial reception by King Charles III and Queen Camilla, and a star-studded festive banquet at Windsor Castle.

He used remarks at this event and his trip to Parliament to stress the improving relations between his nation and the UK since Brexit in 2020.

"I think that is typically British, keep calm and carry on - look ahead pragmatically, move on," Steinmeier said in the House of Parliament's Royal Gallery on Thursday afternoon.

He later returned to the riff on Oasis at the end of his speech, remarking on the band's sell-out reunion tour after 16 years of acrimony between frontman Liam Gallagher and his guitarist brother Noel.

"Cool Britannia is alive! Our relations may have changed, but, my dear Britons, our love remains," he said. "So let us look not to the past, but rather together to the future."

UK and US ink no-tariff deal on pharmaceuticals

The UK and the US have agreed a deal to keep tariffs on UK pharmaceutical shipments into America at zero.

Under the agreement the UK will pay more for medicines through the NHS in return for a guarantee that US import taxes on pharmaceuticals made

in the UK will remain at zero for three years.

This is the first time the amount that the NHS pays for medicines is due to increase in more than 20 years.

The deal comes after US President Donald Trump threatened to raise tariffs to as high as

100% on branded drug imports, one of the UK's biggest exports to the US.

Business and Trade Secretary Peter Kyle said the deal "guarantees that UK pharmaceutical exports - worth at least £5bn a year - will enter the US tariff free, protecting jobs, boosting investment and

paving the way for the UK to become a global hub for life sciences."

The UK exported £11.1bn worth of medicines to the US in the 12 months to the end of September, making up 17.4% of all goods exports in that period, according to the Department for Business and Trade.

Under the terms set out on Monday, the UK will increase the price threshold, at which it deems new treatments to be too expensive, by 25%.

The UK will also increase the overall amount the NHS spends on medicines, with a target to increase that spending from 0.3% of GDP to 0.6% of GDP over the next 10 years.

The amount drug companies must pay back to the NHS to ensure the health system does not overspend its allocated budget will be capped at 15% - last year, drug companies had to pay back more than 20%.

In exchange, UK medicine exports will be protected from tariff increases for the next three years.

White House spokesman Kush Desai said the agreement with the UK was a "historic step towards ensuring that other developed countries finally pay their fair share".

'fair share'

Pharmaceuticals were not included in the wave of tariffs US President Donald Trump had announced earlier this year.

But he has repeatedly threatened to raise tariffs on medicines, citing concerns about America's reliance on medicines made overseas and a desire to increase manufacturing in the US.

He has also argued that US consumers effectively subsidize medicines for other developed countries by paying premium prices for those drugs and pushed for other countries to pay more.

Manslaughter charges may be delivered in Post Office scandal probe

Police officers investigating the Post Office Horizon IT scandal are now considering corporate manslaughter charges.

The National Police Chiefs' Council (NPCC) this week said the investigation is looking at offences of perjury and perverting the course of justice, along with corporate manslaughter - which affects companies, rather than individuals.

The investigation is currently focused on eight suspects, with five interviews conducted under caution.

It said there were now 53 persons of interest, most of whom were likely to be raised to suspect status at a later stage in the probe.

David Enright, a lawyer who represents many former sub-postmasters, told reporters the offence of corporate manslaughter was "very difficult to prove."

"You have to have a clear linkage between the work of senior managers on an executive team to the death involved," he said.

Former sub-postmaster Janet Skinner, who was sent to prison after being wrongly convicted of false accounting in 2007, attended the call with officers in which victims were briefed on the investigation.

"It's still just words," she said. "Unfortunately, we still have to wait for action to happen."

The Horizon IT system, which began operating in 1999, falsely created shortfalls in Post Office branches for which sub-postmasters were held liable.

The scandal has been called the UK's most widespread miscarriage of justice.

Foreign office 'withheld information' following Harry Dunn death

Review into 2019 death blasts government failings after wife of US diplomat allowed to leave the UK

The Foreign Office failed to treat the Harry Dunn case as a crisis and withheld information from his family after he died outside a US military base, an independent review has found.

The 19-year-old motorcyclist was hit by a car being driven on the wrong side of the road by Anne Sacoolas at RAF Croughton in Northamptonshire in August 2019.

The US State Department employee had immunity from prosecution and the UK government department lost "opportunities to influence" the US government before she left the country.

Review chairwoman Dame Anne Owers said there were failings. Foreign Secretary Yvette Cooper said she was "committed to learning lessons from the tragedy".

Sacoolas left the UK on 15 September 2019, but in her report, Dame Anne said the family were not officially told this - as

well as what her name was and that she had immunity - until 11 days later on 26 September.

Mr Dunn's father was already aware Sacoolas's children had left the country because he was head of maintenance at their school, the report said.

"This understandably created distrust both of the message and the messengers," she said.

"The belief that there had been a conspiracy between the UK and US authorities to secretly 'spirit her out', with information deliberately withheld from the family."

In a statement, Mr Dunn's mother Charlotte Charles said the review had been "a hugely emotional experience" that "triggered a lot of anger".

"Having turned to the authorities for help, we got nothing from them," she said.

Mr Dunn's father Tim Dunn said: "The hard-

est part is knowing that more could and should have been done for our boy in those early days."

The report examined actions taken by the department - now called the Foreign, Commonwealth and Development Office (FCDO) - between the teenager's death on 27 August and the end of December 2019.

A police inquiry concluded that Sacoolas was not arrested at the scene because she was deemed to be in a state of shock and it was not deemed necessary at the time.

Dame Anne's report explained that she was a US State Department employee, but had diplomatic immunity at the time because she was the wife of a US intelligence officer.

The then foreign secretary was not told the family had left the UK until the following day, said Dame Anne.

After Sacoolas's departure, Dame Anne said the FCDO asked Northamptonshire Police for a "day or two" to "get our ducks in a row" before informing family.

The department then

asked police not to mention its request - regarding the delay - when the force met the family on 26 September.

Sacoolas pleaded guilty to causing death by careless driving in 2022 and was given an eight-month suspended jail term.

Dame Anne recognised that the Protocol Directorate - the FCDO department responsible - was under "huge pressure".

The loophole, which meant Sacoolas had diplomatic immunity, was closed in 2020.

Putin 'morally responsible' for death of Salisbury woman

Unlucky victim was collateral damage in Russia's attempt to kill former double agent in the Wiltshire town

AN INQUIRY into the Salisbury poisonings has stated that Russian President Vladimir Putin is "morally responsible" for the death of Dawn Sturgess and that her condition was "unsurvivable from a very early stage".

Speaking on Thursday, inquiry chair Lord Anthony said the care Sturgess received from ambulance and hospital staff was "entirely appropriate", adding: "I am sure that no medical treatment could in fact have saved her life."

Sturgess' death was described as 'collateral damage' from the Russian government's attempt to kill

Sergei and Yulia Skripal with the lethal nerve agent Novichok after Sturgess' partner Charlie Rowley had brought home a perfume bottle containing the poison.

After the poisonings, two men accused of the attack appeared on Russian TV, where they insisted they had visited Salisbury as tourists who wanted to see the cathedral spire.

The Russian government has always denied involvement in the Salisbury poisonings.

Skripal is a former Russian military intelligence officer who acted as a double agent for the United Kingdom's intelligence

services during the 1990s and early 2000s and his attempted assassination was

"expected to stand as a public demonstration of Russian power", Lord Hughes conclude.

Dawn Sturgess' death was therefore collateral damage in a plot which "amounted to a public statement, both for international and domestic consumption, that Russia will act decisively in what it regards are its own interests", he wrote.

Everyone involved in the attempt to assassinate the Skripals - including Putin who authorised the attack "at the highest lev-

el"- was "morally responsible" for Ms Sturgess' death, the report concluded.

Dawn Sturgess died in Salisbury District Hospital on 8 July 2018, eight days after coming into contact with Novichok at Rowley's flat in nearby Amesbury.

The eldest of four children and a mother of three, she was described by her mother Caroline Sturgess as an "intelli-

gent...extremely selfless and very kind person".

While her circumstances had "escalated" in the final years of her life to her living in supported accommodation, her mother said, she was looking forward to making a fresh start.

During the inquiry a Wiltshire Police officer apologised for wrongly referring to Ms Sturgess as a "well-known drug addict".

England cricket hero Robin Smith dead at 62

Former England batsman Robin Smith has died at the age of 62.

Nicknamed 'Judge', Smith won 62 Test caps between 1988 and 1996 and scored 4,236 runs at an average 43.67, including nine centuries.

He also averaged 39.01 in 71 one-day internationals.

Smith spent his entire county career at Hampshire, winning two Benson & Hedges Cups and a NatWest Trophy and captaining them between 1998 and 2002.

He finished his 22-year career in 2003, with 26,155 first-class runs at 41.51.

Following his retirement, Smith, who had relocated to Australia, struggled with mental health issues and alcoholism and was hospitalised for several months in 2024.

Born in South Africa in 1963, Smith followed older brother Chris and future England international to Hampshire as a teenager, making his debut in 1982.

After a four-year qualification period, he was eligible to play for England, with his Test debut coming against West Indies at Headingley in 1988.

He made his ODI debut against Sri Lanka later that summer.

The following year Smith was England's leading run-scorer, with 553, in a 4-0 home Ashes defeat by Australia.

Particularly prolific in English conditions, he scored seven of his nine Test centuries and averaged almost 50 on home soil.

He was a member of England's 1992 World Cup squad but did not play in the defeat by Pakistan in the final.

Calls for cameras in nurseries after worker admits 26 counts of child abuse

Calls have been made for the government to consider making CCTV in nurseries compulsory, in response to a nursery worker admitting sexually abusing young children in his care in north London.

Vincent Chan, 45, appeared at Wood Green Crown Court on Wednesday where he pleaded guilty to 26 charges including sexual assault by penetration, sexual assault by touching and making indecent images depicting the most severe category of child sex abuse.

Liberal Democrats education spokesperson Munira Wilson told the Commons that CCTV had been "vital" in securing convictions in a similar case in her Twickenham constituency.

Education Secretary Bridget Phillipson replied to say that CCTV might

still not guarantee safety, and said it "may lead to other forms of abuse", but promised the government would strengthen the ways children were kept safe after the "sickening case".

The investigation into Chan, who was employed at the Bright Horizons nursery in Finchley Road, West Hampstead, followed a tip-off from a whistleblower and became one of the most "harrowing and complex" cases undertaken by the Metropolitan Police, the force said.

When police started to investigate, they found what detectives called "deeply disturbing material" on Chan's devices and iPads seized from the nursery.

They later found the video evidence of sexual abuse of children at the nursery, some of which had been filmed on nurs-

ery iPads.

Chan, of Stanhope Avenue in Finchley, will be sentenced on 23 January.

Judge David Aaronberg KC told the defendant: "Mr Chan, you have pleaded guilty to matters which are going to result in a custodial sentence of many years."

Family members of many of the victims sat in the dock as charges were read out, many of them in tears.

Following Chan's guilty pleas, the victims' parents made a joint statement through their solicitor.

"As parents we are still trying to process the sickening discovery that our children were subjected to despicable abuse... We feel that Bright Horizons has failed us, and we want answers.

"How was someone like Vincent Chan

employed? And how were such horrific crimes against children able to continue for so long without the staff responsible for safeguarding at Bright Horizons nursery acting?

"We are concerned that failures in management and supervision at Bright Horizons allowed

this abuse to go undetected, and we are committed to securing accountability for our children."

Bright Horizons said it was "shocked and appalled" by Chan's crimes, adding that its "thoughts are first and foremost with the children and families affected".

Supreme Court ruling means an end to trans Girl Guides and WI members

The organisation that oversees girl guide groups in the UK has announced it is banning trans girls from joining.

Girlguiding said the move - which means it will not accept biological boys who identify as girls - was in response to the Supreme Court ruling earlier this year that said sex meant biological sex in equality law.

The trustees said they had made the "difficult decision" with a "heavy heart" and there would be further announcements on what this will mean for current members.

Trans rights organisation TransActual said: "There is no problem being solved here, only harm being done."

Women's rights charity Sex Matters said Girlguiding had done the "right thing" in making

the change.

Around 385,000 girls and young women between the ages of four and 18 take part in Rainbows, Brownies, Guides and Rangers groups around the UK.

Girlguiding said: "From today (2 December) trans girls and young women, and others not recorded female at birth, will no longer be able to join Girlguiding as new young members."

"This is a decision we would have preferred not to make, and we know that this may be upsetting for members of our community," the trustees said.

"Girlguiding believes strongly in inclusion, and we will continue to support young people and adults in marginalised groups."

In UK law, the 2010 Equality Act sets out the

rules for single sex organisations and spaces being able to exclude members of the opposite sex.

WI follows suit

In April, the Supreme Court ruled that this meant biological sex, meaning, for example, that a trans man could be excluded from a service set up for men.

Girlguiding said it has made its decision following consultation

with members and legal advice. It will now allow only biologically female members to join.

The organisation was reportedly facing legal action from a parent who felt it was failing to follow the law.

Biological girls who identify as boys are still able to join.

The organisation also said most adult roles were already open to all and it was "confident that no

volunteers will have to leave".

Tuesday's announcement was followed the next day by the Women's Institute announcing they would no longer offer membership to transgender women.

The change to the organisation - which has thousands of local branches offering events, campaigns and social gatherings across the UK - will come into effect from April 2026 and was prompted by the same Supreme Court ruling.

Until now the Women's Institute has allowed trans women - biological males who identify as women - to join.

Melissa Green, chief executive of the National Federation of Women's Institutes, said: "Unfortunately the legal position as it stands means that we can no longer offer that."

Compensation ruled out for Andrew's early surrender of lease on home

Andrew Mountbatten-Windsor is unlikely to receive any compensation upon leaving Royal Lodge in Windsor, according to information published by the Public Accounts Committee.

As part of his leasing arrangement, Andrew

could have been entitled to £488,000 for an early surrender of his 75-year lease.

But a report from the Crown Estate for MPs on the public spending watchdog says that the property is so dilapidated and in need of repairs that in "all likelihood"

Andrew "will not be owed any compensation".

There will now be an MPs' inquiry launched into the Crown Estate and its royal leases, said committee chair, Sir Geoffrey Clifton-Brown.

Sir Geoffrey said the information from the

Crown Estate "clearly forms the beginnings of a basis for an inquiry" which will begin next year and will consider the Crown Estate and property leases with the Royal Family.

It is not known yet whether Andrew Mountbatten-Windsor will be called to give evidence.

dence that Andrew still had a lease on part of his former home at Sunninghill Park in Berkshire, with the Crown Estate saying he was still the leaseholder of East Lodge, which has a separate lease from the main house, which Andrew sold in 2007.

The East Lodge was said by the Crown Estate to have been leased by Andrew for a "member of staff".

MPs on the cross-party committee had wanted to know the details of Andrew's financial arrangements for Royal Lodge and whether taxpayers' interests had been properly protected.

Andrew had taken on a 75-year lease of Royal Lodge in 2003, paying over £8.5m up-front to cover renovation costs and paying in advance to remove any requirement for rent, based on a

notional rent of £260,000 per year.

There was also a token "peppercorn" payment, which the Crown Estate notes is standard practice for long leases, where there's an advance payment in lieu of rent.

A clause allowed him to get some of his advance payments back if he left within 25 years, but that depended on the property being maintained.

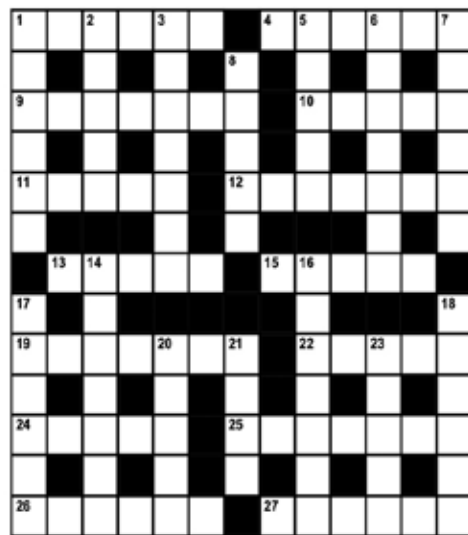
The report says the current condition of Royal Lodge is "not out of keeping with a tenancy of this duration", but the cost of repairing "dilapidations" meant any payback was unlikely.

Overall, the terms of the Royal Lodge deal were "fair, reasonable and in line with market practice", says a letter from the Crown Estate commissioners to MPs.

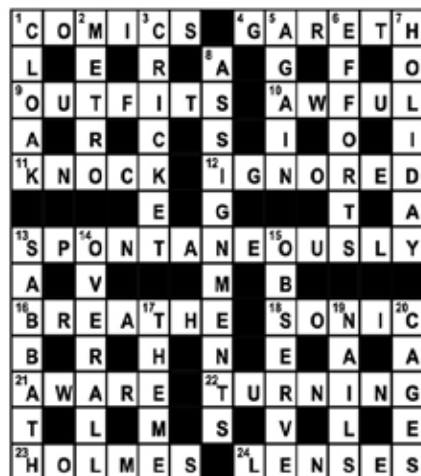

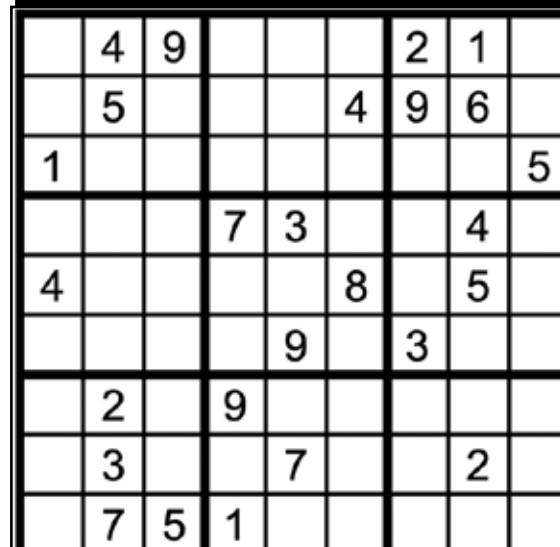

The information supplied by the Crown Estate also showed Andrew handed in his notice on the property on 30 October, the day it had been announced he had lost his titles.

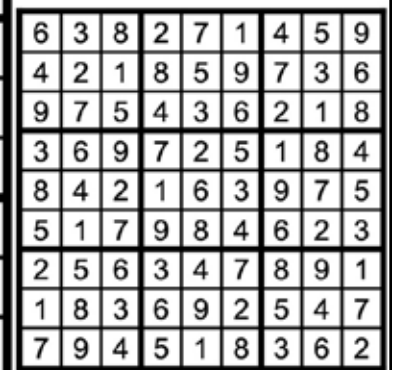

Both Catherine and Camilla dazzled in UK-designed gowns at a spectacular state banquet in Windsor Castle last night for President Frank-Walter Steinmeier and First Lady Elke Budenbender.

The Princess, 43, wore a dress by Jenny Packham, with Queen Victoria's Oriental Cirlet Tiara and a sash and star of the Royal Victorian Order.

Queen Camilla, 78, looked striking in a green lace evening gown by Fiona Clare, accessorised with The Girls of Great Britain and Northern Ireland Tiara and the order of Germany sash.

They and their hus-

bands joined guests in St George's Hall at a 50m-long mahogany table with a towering 6m Christmas tree illuminated with 3,000 lights as the backdrop.

The Nordmann fir, which reached the ceiling and was so wide that the usual 160-person guest list had to be reduced to 152, was the first Christmas tree to feature at the foot of the table in modern times.

It was an acknowledgment of the German tradition, which President Steinmeier referenced in his speech.

Guests with German connections included model Claudia Schiffer, film composer Hans Zimmer and Axel Scheffler, who illustrated the Gruffalo.

German footballer Thomas Hitzlsperger, who spent the early part

of his career playing for Prince William's team Aston Villa, was also invited.

The banquet drew the first day of the state visit to a close after the president and his wife were treated to an impressive display of pomp and pageantry.

The couple travelled by train from Heathrow with William and Catherine, before being met outside Windsor and Eton Riverside station by the King and Queen.

Charles opened his arms as Mr Steinmeier approached. He told the King: "It's so wonderful, Your Majesty, to see you again." As is tradition, Catherine did a double curtsy, one for the King and then, in case the Queen had not seen her, another for Camilla.

The couples then took part in a colourful carriage ride led by a Sovereign's

Tributes flow for West Ham legend Bonds

■ Combative captain played nearly 800 games in 21-year career

West Ham legend Billy Bonds - the club's record appearance maker who captained them to two FA Cup wins - has died aged 79.

Bonds played 799 times for the Hammers and led them to FA Cup titles in 1975 and 1980.

He spent 21 years as a player with the Ham-

mers between 1967-1988 and also managed them from 1990 to 1994.

"We are heartbroken to announce that we lost our beloved dad today," said a family statement.

"He was devoted to his family and was the most kind, loyal, selfless, and loving person.

"Dad loved West

Ham United and its wonderful supporters with all his heart and treasured every moment of his time at the club.

"He will always be in our hearts and eternally missed. We take comfort knowing that his legacy will live on forever."

West Ham said it was with "deep sadness and the heaviest of hearts" that their "legendary player, coach and manager" had passed away

peacefully on Sunday morning.

They added: "Rest in peace Billy, our courageous, inspirational, lion-hearted leader."

Bonds, who played as a defender and midfielder, joined West Ham from Charlton Athletic for £47,000 in May 1967 and, along with the FA Cup successes, he also won the old second division title with the club.

He made his final appearance in April 1988 aged 41 and Bonds, who received an MBE for services to football in the same year, went on to take over as Hammers manager in 1990.

Bonds, who never played for England, twice won promotion into English football's top division and left West Ham in 1994 "after 27 years of impeccable service".

He was given the

club's first ever lifetime achievement award in 2013 and, five years later, the Hammers fans voted him their greatest ever player.

Romero double rescues Spurs

Cristian Romero's superb 95th-minute overhead kick secured a dramatic point for Tottenham Hotspur against Newcastle United on Tuesday to ease the pressure on manager Thomas Frank.

Spurs looked to be heading for a sixth defeat in just eight games before their captain stepped up when they needed him most once again at St James' Park.

Romero, who had earlier equalised to cancel out Bruno Guimaraes' second-half opener, caught the ball superbly after Newcastle failed to deal with a corner to send the travelling support wild up in the gods.

Newcastle had been set for a third successive league win when substitute Anthony Gordon scored a late penalty to make it 2-1.

Spurs were unhappy that the penalty had been awarded in the first place but, after being ordered by the video assistant referee (VAR) to take a second look on the pitchside monitor, referee Tom Bramall ruled that Rodrigo Bentancur had fouled Dan Burn, dragging the towering defender to the floor.

However, Spurs showed their powers of recovery to secure a precious point as Frank's side stay above Newcastle in 11th place.

Frank's side had admittedly been struggling, even with their captain in the side, but his return from suspension at St James' Park was timely.

After conceding two goals in the opening six minutes against Fulham last Saturday without him, Spurs looked in need of added bite.

And Romero was one of four changes Frank made as Pape Matar Sarr, Rodrigo Bentancur and Brennan Johnson

A point still not enough for Slot's struggling champions

Liverpool needed a late own goal to rescue a point after Sunderland threatened to pile even more pressure on head coach Arne Slot at Anfield Wednesday night.

Arsenal move through the gears to draw Bees' sting

■ EPL: Gunners show trademark consistency in tough schedule to move five points clear

Mikel Merino and Bukayo Saka scored as Arsenal beat Brentford Wednesday night to restore their five-point lead at the top of the Premier League.

Manager Mikel Arteta made three changes to the side that drew with Chelsea on Sunday with Ben White, Noni Madueke and captain Martin Odegaard coming in.

And it was White and Madueke who combined in the build-up on 11 minutes with the right-back crossing for Arsenal's makeshift frontman Merino to head home.

Merino has had to play regularly up front because of injuries to Kai Havertz, Gabriel Jesus and Viktor Gyokeres and this goal was his 13th in 2025, the most of any Arsenal player this year.

Saka added the second in stoppage time after being played through on goal by Merino, and his effort bounced over the line despite the best ef-

forts of Caoimhin Kelleher.

Brentford were pinned back for large parts of the game but went close to equalising when Kevin Schade's first-half header from a corner was pushed on to the crossbar by David Raya.

The only worry for Arteta was that Cristhian Mosquera and Declan Rice both had to be taken off with knocks.

The victory extends Arsenal's unbeaten run to 18 games across all competitions and was their eighth successive win at home.

The match against Brentford was always going to be tricky for Arsenal to navigate after recent games against Tottenham Hotspur, Bayern Munich and Chelsea that required such a big effort.

Arteta resisted the temptation to make wholesale changes and kept key players such as Declan Rice, Martin Zu-

bimendi and Riccardo Calafiori in his starting XI.

Merino also kept his place up front and the Spain international scored another important goal to add to his collection with his first-half header.

He then assisted substitute Saka for his sixth goal contribution in his past five games (three goals, three assists).

The Gunners have struggled with injuries throughout the season and there will be a worry that knocks to Mosquera and Rice will further test their squad, before they travel to Aston Villa on Saturday (12:30 GMT kick-off).

"Rest, that's quite a positive word to use - we had to make some changes," said Arteta when asked about rotating players on Wednesday.

"We had a very demanding week at every level. We were asked

to play three days later, with one less recovery [day] than them.

"[Rice] can walk. He cannot play. The thing is, he's played a lot of minutes but as well, now we played Wednesday night and we have to play Saturday morning as well.

"We can play minutes

but if they can please give us just a little more time to recover and to make the welfare of these players a little bit easier, that would be great."

Arsenal continue to build momentum and find ways to get results no matter the opposition they come up against.
