- NHS facing worst winter crisis on record
- Health chiefs urge: get vaccinated NOW

Britain is stumbling into what experts say could be the worst winter health crisis in living memory, as a fast-mutating "super flu" tears through the population and sends hospital admissions spiralling far earlier than usual.

Fresh figures from NHS England reveal a dramatic 50% surge in flu hospitalizations in just one week, with an average of 2,660 patients a day now being treated across England. Health chiefs warn the situation is deteriorating by the day, with no sign that the virus has reached its peak and fears that the number of admissions could burst past 5,000 by the weekend.

To put the crisis into stark perspective, NHS England says the number of flu patients currently occupying beds is the equivalent of three entire hospitals filled to the rafters, with some trusts reporting that almost one in ten beds is now taken up by people struck down by influenza.

mutated strain
This year's outbreak has been fuelled by a mutated version of the H3N2 strain — a variant the public has never encountered in this ge-

netic form. Experts say this means immunity levels are significantly lower than usual, helping the virus spread at alarming speed. The flu season also began a full month earlier than normal, catching health services off guard.

Although national flu admission records only date back to 2021, current levels already surpass anything seen at this point in the winter over the last three years - and health veterans warn the country may be heading for a repeat of the notoriously severe seasons of 2014-15 and 2017-18.

Young spreaders
According to the UK Health Security Agency (UKHSA), children aged 5 to 14 now have the highest positivity rates in England, driven by rapid classroom transmission. But those becoming most seriously ill are young children and the elderly.

Hospital admission rates are highest

among:
• Over-75s, who are most vulnerable to flu complications
• Children under five, many of whom have little natural immunity

NHS medical director Prof Meghana Pandit described the situation as "unprecedented", warning that the NHS is now facing a "worst-case scenario" for this point in the winter.

Staff, she said, are being "pushed to the limit" as they struggle to keep up with rising numbers of seriously ill patients.

Norovirus
Adding to the strain, cases of the winter vomiting bug norovirus are also climbing. More than 350 hospital beds are now occupied by people suffering from the highly contagious infection, further squeezing already limited capacity.

And all this comes days before a planned five-day strike by resi-

dent doctors — the re-branded junior doctors — due to begin next Wednesday.

After a fresh offer from Health Secretary Wes Streeting, the British Medical Association has agreed to poll its members on whether to call off the action. The results will be revealed on Monday.

Prime Minister Sir Keir Starmer slammed the union as "irresponsible" and said it must accept the government's proposal, warning that Britain cannot afford a walkout "particularly in the run-up to Christmas, and particularly with a flu crisis already unfolding".

Daniel Elkeles of NHS Providers echoed the alarm, saying:

"The NHS is in the thick of a storm come early. Flu is hitting hard and other winter bugs

are surging. Now more than ever, we need all hands on deck."

He urged doctors to step back from next week's strike and "end this damaging dispute".

UKHSA data shows infection rates continue to rise, albeit slightly less sharply than the previous week. But experts caution that this should not be mistaken for a peak. Flu trends, they say, are notoriously volatile.

Dr Conall Watson urged all those eligible for a free NHS flu vaccine — including over-65s, pregnant women and people with certain health conditions — to come forward urgently.

"There is still plenty of flu vaccine available — but what's running out is time to build protection before Christmas," he warned.

It takes up to two

weeks after vaccination to gain full immunity.

A&E breaking point
Frontline medics say the NHS is now dealing with the consequences of long-term understaffing and too few hospital beds.

Dr Vicky Price, president of the Society for Acute Medicine, warned that the system is "already buckling", with A&E patients facing long delays as staff struggle to manage the surge.

She accused NHS England and the government of using the flu wave as a "convenient scapegoat" for years of workforce shortages.

"What was once considered a critical incident is now seen as normal," she said. "This is not a one-off emergency but the result of systemic failure."

We stand with Ukraine, says Starmer, as leaders hold No. 10 talks with Zelensky

■ Merz and Macron join the PM to underline European support as fissures with Trump administration threaten to widen

THE PRIME MINISTER underlined his commitment to a free and independent Ukraine this week, joining the leaders of France and Germany to insist 'we stand with Ukraine'.

In a move which further underlines the deepening fissures between leading European nations and the US, Sir Keir Starmer together with French President Emmanuel Macron and German Chancellor Friedrich Merz, met with Ukrainian president Zelensky to confirm their support for his embattled nation.

'strong Europe'

Responding indirectly to President's claim that Europe was 'weak' and 'decaying', Starmer insisted Europe was strong and that he would stand up for its values of freedom and democracy.

"What I see is a strong Europe, united behind Ukraine and united behind our long-standing values of freedom and democracy, and I will always stand up for those

freedoms," Starmer said.

Downing Street said Sir Keir spoke to Trump on Wednesday about the ongoing Ukraine peace talks, in a call with French President Emmanuel Macron and German Chancellor Friedrich Merz.

"Intensive work on the peace plan is continuing and will continue in the coming days," a spokesperson said.

The US has proposed that Ukraine pulls its forces entirely out of eastern regions which Russia has attempted to take by force, but has been unable to capture in full. In return, the US says Russia would withdraw elsewhere and there would be a cessation of fighting.

But this is an unpalatable option for Zelensky, who refuses to reward Moscow for its aggression and who has repeatedly warned that Russia would use any foothold in the eastern regions to launch future assaults on Ukraine.

"Americans are inclined, in principle, to finding a compromise,"

Zelensky said on Monday.

He added that the issue of security guarantees - which Ukraine wants to ensure Russia would be deterred from carrying out future attacks in the event of a peace deal - had yet to be resolved.

'critical moment'

A spokesperson for the UK prime minister's office said: "The leaders all agreed that now is a critical moment and that we must continue to ramp up support to Ukraine and economic pressure on Putin to bring an end to this barbaric war.

"The leaders discussed the importance of the US-led peace talks for European security and supported the progress made," the statement said.

Leaders also "underscored the need for a just and lasting peace in Ukraine, which includes robust security guarantees", it added.

Ahead of the talks he hosted at Downing Street, Starmer said there need-

ed to be "hard-edged security guarantees" in a peace deal for Ukraine.

Merz stated he was "sceptical" about some of the details of the potential plan coming from the US

side. "But we have to talk about it. That's why we are here," he added.

Following the meeting, France said work would be "intensified" to provide security guaran-

tees for Ukraine.

There is nervousness in Kyiv and across Europe that the US could end its support of Ukraine over frustration with the slow progress of negotiations.

You MUST stand up to Trump, LibDem leader tells Starmer

Liberal Democrat leader Sir Ed Davey has urged the prime minister to stand up to Donald Trump, describing the US president's new national security strategy as "deeply alarming".

The document, which was published last week, warns Europe faces "civilizational erasure" and says US policy should prioritize "cultivating resistance to Europe's current trajectory".

Sir Ed called on the PM to "make it clear to President Trump that any attempts to interfere with our democracy are totally unacceptable".

In response, Sir Keir

Starmer avoided criticizing the US President, instead saying he would always stand up for Europe's "longstanding values of freedom and democracy".

The US strategy calls for an end to mass migration and criticises European policies on the issue for "creating strife".

It also raises concerns about "censorship of free speech" and "loss of national identities and self-confidence".

"It is far from obvious whether certain European countries will have economies and militaries strong enough to remain reliable allies," the document

states.

Trump continued to attack European leaders in an interview with Politico on Tuesday, when he branded them "weak" and said they had failed to control migration or take decisive action to end the war in Ukraine.

The strategy also adopts softer language towards Russia, blaming the EU for blocking US efforts to end the conflict and saying the US must "re-establish strategic stability with Russia".

The Kremlin has welcomed the document, calling it "largely consistent" with Moscow's vision.

Farage 'will be next PM' says French right winger

FRANCE'S leading right-wing politician has praised Nigel Farage, predicting he will become the next Prime Minister.

Jordan Bardella, the leader of France's far-right National Rally party, visited the Reform Leader in London this week and told reporters he believed the "extremely resilient" Farage would be the next occupant of No. 10.

The 30-year-old French MEP is leading in opinion polls to win the first round of the next presidential election due in 2027.

A Reform source said the two politicians discussed small boat crossings and energy policy, particularly nuclear energy.

Farage has in the past kept his distance from National Rally (RN), the successor party to the National Front (FN), formerly led by Marine Le Pen.

Le Pen was banned from public office for five years in March after a conviction for embezzling EU funds, barring her from standing in the 2027 presidential race.

She has condemned the verdict as a "political decision" and plans to appeal, with a court due to rule next year.

As leader of Ukip, Farage kept his party out of an alliance with the FN in the European Parliament.

But writing in 2017, he endorsed her to win that year's presidential election, praising Le Pen for reshaping the party, adding that under her leadership since 2011 it had become "about sovereignty, not race".

Suspended sentence for Barton

Combative former footballer "crossed the line between free speech and a crime" with six posts on X, court hears

Former footballer Joey Barton has been handed a suspended sentence for social media posts about broadcaster Jeremy Vine and TV football pundits Lucy Ward and Eni Aluko.

Barton, 43, was found guilty by a jury at Liverpool Crown Court of sending grossly offensive electronic communications with intent to cause distress or anxiety.

The trial heard he had "crossed the line between free speech and a crime" with six posts on X including comparing Aluko and Ward to serial killers Fred and Rose West, and calling Vine a "bike nonce" between January and March 2024.

Barton, originally of Huyton, Merseyside, was given six months in custody, suspended for 18 months.

The ex-Manchester City and Newcastle player was also made by the Honorary Recorder of Liverpool, Judge Andrew Menary KC, to do 200 hours of unpaid work in the community and pay more than £20,000 in costs.

Following a televised FA Cup tie in January 2024 between Crystal Palace and Everton, Barton likened Ward and Aluko to the "Fred and Rose West of football commentary" and went on to superimpose their faces on to a photograph

of the serial murderers.

Speaking to reporters after leaving the court, Barton said: "If I could turn back the clock I would.

"I never meant to hurt anyone. It was a joke that got out of hand."

He added: "Nobody wants to go to jail."

distress

Barton, who has 2.7m followers on X, repeatedly referred to Vine as "bike nonce" and said in one post: "If you see this fella by a primary school call 999," and "Beware Man with Camera on his helmets cruising past primary schools. Call the Cops if spotted."

He was found not guilty of six other allegations that he sent a grossly offensive electronic communication with intent to cause distress or anxiety between January and March 2024.

Jurors cleared Barton, now of Widnes, Cheshire, over the commentary analogy with the Wests but ruled the superimposed image was grossly offensive.

Giving evidence, Barton, who managed Fleetwood Town and Bristol Rovers, said he believed he was the victim of a "political prosecution" and denied his aim was "to get clicks and promote himself".

On sentencing, Judge Menary KC told Barton: "Robust debate, sat-

ire, mockery and even crude language may fall within permissible free speech.

"But when posts deliberately target individuals with vilifying comparisons to serial killers or false insinuations of paedophilia, designed to humiliate and distress, they forfeit their protection.

'abusive and hateful'

"As the jury concluded, your offences exemplify behaviour that is beyond this limit - amounting to a sustained campaign of on-line abuse that was not mere commentary but targeted, extreme and deliberately harmful."

He said Barton launched a "racially charged and sexist attack" on Aluko which asserted that a black female broadcaster held her position solely due to her race.

The judge said while

he was convinced the "custodial threshold" had been crossed in this case, he was prepared to suspend those jail terms.

He noted Barton had taken steps to moderate his online behaviour but added "only time will tell whether this resolve endures".

Two-year restraining orders were issued against each of his victims which includes publishing any reference to them on any social media platform or

broadcast medium.

Following the verdict, a Cheshire Police spokesperson said the force hoped the case would deter others using social media to share "abusive and hateful messages".

They said Barton's posts "would have been seen by hundreds, if not thousands of people, and yet he showed no regard or consideration for how this would impact on his victims and their wellbeing".

Swim great Sharron Davies made a peer

Olympic medal-winning swimmer and campaigner Sharron Davies has been named as one of three new Conservative peers.

Ms Davies, a vocal critic of trans women in women's sport, was nominat-

ed by Conservative leader Kemi Badenoch.

The Tories said it was in recognition of her sporting achievements and her campaigning on women's rights.

Iceland supermarket chairman Richard Walk-

er and former Number 10 communications director Matthew Doyle are among 25 new Labour peers nominated by Sir Keir Starmer. Liberal Democrat leader Sir Ed Davey nominated five new peers.

Ms Davies will sit alongside ex-Tory cabinet minister John Redwood and journalist and historian Simon Heffer - who have also been handed peerages.

She has become an outspoken campaigner

against allowing transgender athletes in female competitions in order to "protect women's sport".

The swimmer, who won a silver medal at the 1980 Olympics in Moscow and two Common- **cont. on page 4, col. 3**

not rule out entering the same group as the rebranded RN after the European Parliament elections in 2019, but ultimately decided not to join the group ahead of the ejection of the party's MEPs in 2020 in the wake of Brexit.

However he criticised her party's more interventionist economic policies last year, saying they would be a "disaster" for France.

Speaking to the Political Thinking with Nick Robinson podcast on the BBC, Bardella acknowledged Farage "may have been harsh in the past" towards his party.

"But that's politics - you're allowed to evolve," he added. "My political party has also evolved, even in its name."

Bardella's party wants to place a "national priority" on welfare, limiting benefits to French people.

He said he believed in police co-operation between France and the UK on small boats, but with the intention of returning migrants to their "countries of origin" rather than the French coast.

He said: "If I am head of the French government tomorrow, France will no longer be a country of mass immigration."

"Therefore, by implementing measures designed to drastically reduce immigration to France, this will inevitably have consequences for the departure of migrants from Calais, in northern France, to Great Britain."

Writing on X after the meeting, Bardella said the pair had discussed shared challenges facing the UK and France, including "mass immigration" and boosting economic growth.

Two Afghan teens raped for 'horrific' rape of Leamington girl

■ Jan Jahanzeb and Israr Niazal arrived on small boats and were seeking asylum

Two teenage Afghan nationals seeking asylum in the UK have each been given custodial sentences for the rape of a 15-year-old girl in Leamington Spa.

Jan Jahanzeb and Israr Niazal, both 17, had pleaded guilty to the 10 May attack at a hearing in October.

During a sentencing hearing at Warwick Crown Court, Judge Sylvia de Bertodano lifted reporting restrictions on naming the boys following applications by various media organizations.

Deportation papers have been served to Jahanzeb. He was sentenced to a youth detention term of 10 years and eight months. Niazal, about whom the judge invited the government to recommend deportation, was sentenced to nine years and 10 months.

Ahead of the sentencing, the court heard an impact statement on behalf of the victim in which she said: "The day I was raped changed me as a person. Now every time I go out I don't feel safe."

"Watching [other family members] feeling crushed as they believe they should have been there or done something is particularly painful for me, even though I know they couldn't have done anything to stop what happened."

"I hate the fact that I am now looked at as a victim, even though that's exactly what I am."

'Horrific' attack

At the opening of the sentencing hearing, prosecutor Shawn Williams said the de-

fendants, who each appeared in the dock assisted by their own interpreter, were unaccompanied child asylum seekers.

Jahanzeb fled Afghanistan and underwent an age assessment after arriving in the UK in January, which concluded he was 17, Mr Williams said.

Niazal arrived in November last year. He was initially accommodated in Kent before being moved into local authority care in the Warwickshire area.

The rape, which took place after the victim became separated from friends on a grassed area, was described as "horrific" during legal submissions regarding reporting restrictions in the case.

Mr Williams told the court that video evi-

dence showed Jahanzeb with the victim and speaking in Pashto - the official language of Afghanistan - to summon Niazal to join him.

Footage from a mobile phone recovered by the

police was highly distressing, Mr Williams said, adding the victim had screamed for help but Jahanzeb had placed his hand over her mouth.

He said Jahanzeb and Niazal led the highly

distressed victim into a "den-type" area in parkland in Leamington Spa where they attacked her.

The victim had repeatedly shouted for Jahanzeb to let go of her as she

wealth golds, denied that her comments were transphobic and claimed she had spoken to many other female athletes who "feel the same way as me".

Following her nomination, Ms Davies said it would be "exciting to carry on fighting for women's rights and safeguarding as well as trying to get as many kids, in particular, doing sport as possible".

Meanwhile, a Labour spokesperson said their new 25 peers would allow the government to "deliver on our mandate from the British people" and "correct" the imbalance against Labour in the House of Lords, where the Tories currently have more representa-

tion.

Despite having a majority in the House of Commons, Labour is currently outnumbered in the Lords, with 209 peers to the Tories' 282.

Mr Walker's nomination confirms reports earlier in the week from La-

bour sources calling him "a committed champion of families dealing with the cost of living".

The 45-year-old left the Conservative Party in 2023, and was later seen at the launch of Labour's manifesto for the 2024 general election.

In February this year, he gave the new government a score of "six out of 10" in comments to the Financial Times, taking issue with it raising employer national insurance contributions but praising its attempts to improve relations with the EU.

was led away.

She was later assisted by a member of the public who advised her to contact the police and stayed with her until she was safe.

'public anger'

Explaining her decision to lift reporting restrictions, the judge said keeping them in place could lead to speculation which might see innocent people being targeted.

"A lack of information stokes public anger and leads to the unchecked spread of false information," she said.

In a further impact statement from the victim's mother, she said: "We have watched our vibrant, happy and confident daughter shrink down and suffer with anxiety so bad, she is often physically sick."

Speaking of the attack, she said "something broke in all of us that day".

After the pair were sentenced, Det Ch Insp Richard Hobbs from Warwickshire Police said: "Jahanzeb and Nizal went out of their way to befriend the victim with the intention of raping her.

"The length of their sentence reflects the severity of their crime and the need to protect the public from them."

■ Fife heathlands course to change its name from the Duke's Course to Craigtoun

The St Andrews golf course named after the former Prince Andrew is to be rebranded.

The Duke's Course, which is three miles from the centre of the Fife university town, will become the Craigtoun Course, after a nearby country park.

A heathland course unlike the links which dominate the home of golf, the Duke's was opened by Andrew Mountbatten-Windsor in 1995.

He later became captain of the Royal and Ancient Golf Club, which is based in St Andrews.

Andrew has given up his honorary membership, as part of

his retreat from public life in the wake of the scandal about his close friendship with the paedophile and sex trafficker Jeffrey Epstein.

The course and club are also to come under the management of the St Andrews Links Trust on a long-term lease.

The club's logo is also being changed, to remove the royal association.

An illustration featuring trees will replace a lion rampant holding a saltire flag.

The trust already runs seven public courses around the Fife town, including the world famous Old Course, which hosts the

Open Championship every five years.

Until 5 January, the Duke's will continue to be run by golf resort operator Kohler, alongside its ownership of the Old Course Hotel.

From then on it will be known as the Craigtoun Course.

Following a growing public outcry about his links to Epstein, Andrew was stripped of titles such as the Duke of York and his status as prince, becoming Andrew Mountbatten-Windsor.

'revitalised'

As part of that announcement in October, Andrew was also to leave Royal Lodge and to move into some other accommodation in Sandringham, the King's private estate in Norfolk.

Andrew has also faced calls from Democrat members of the US Congress to give evidence to a committee investigating Epstein's activities.

Mr Mountbatten-Windsor had not replied to the request

by the end of their deadline last month.

A press release confirmed the course would take on a "revitalised identity" but it did not mention the former prince.

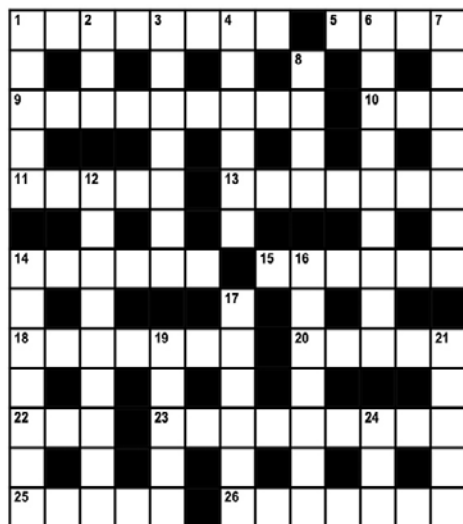
Neil Coulson, chief executive of St Andrews Links Trust, said: "The agreement for The Craigtoun Course will see the first new course added to the Home of Golf's portfolio in 18 years and presents an ideal opportunity to expand the golf experiences we offer.

"We are delighted to have reached agreement with the Old Course Hotel and look forward to taking over what it is already a significant asset for St Andrews and Scotland and building on its reputation."

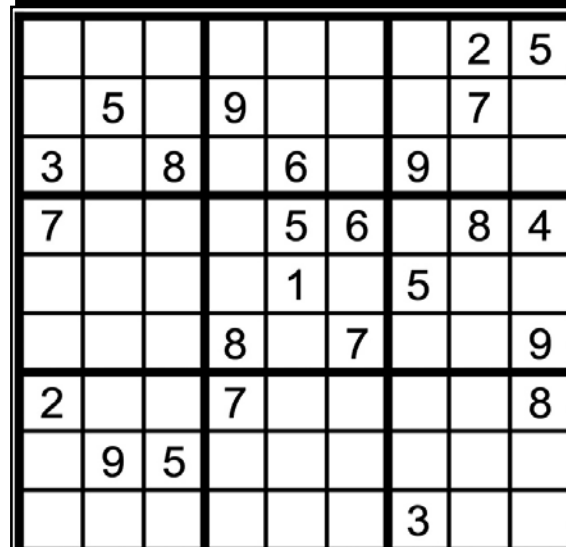

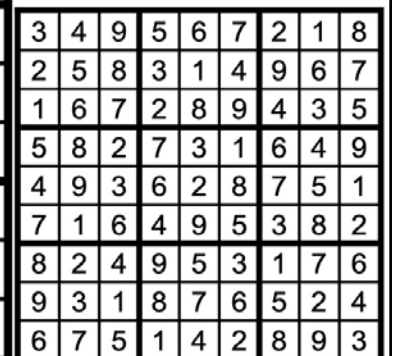

Brits and Irish lead the charge at Golden Globes

Nominations prove very good news for talent from across the pond

British and Irish stars look set to make a major impression at the 2026 Golden Globes, with this year's nominations reading like a roll call of UK and Irish excellence across film, television and music.

Monday's announcement made one thing clear: the talent from across the pond is firmly at the forefront of the international awards race.

Netflix's acclaimed drama *Adolescence* led the charge, with Owen Cooper, Stephen Graham, Ashley Walters and Erin Doherty all earning nominations for their standout performances. The series, which already enjoyed significant success at the Emmys, appears poised to continue its awards-season momentum.

The first category revealed was Best Male Actor in a Television Dra-

ma, where Gary Oldman secured an early nomination, signalling a strong showing for British talent from the outset. This year's Globes will span 28 categories, including - new for 2026 - a dedicated podcast section.

Across the acting fields, British and Irish nominees appeared time and again. In Best Supporting Male Actor in a Motion Picture, Ireland's Paul Mescal was recognized for his critically praised role in *Hamnet*, continuing his impressive awards trajectory.

A particularly strong British presence emerged in the Best Male Actor in a Limited Series, Anthology or TV Motion Picture category. Stephen Graham (*Adolescence*), Charlie Hunnam (*Monster: The Ed Gein Story*), Jude Law (*Black Rabbit*) and Matthew Rhys (*The Beast in Me*) all secured

Meanwhile, Erin Doherty's performance in *Adolescence* earned her a nomination for Best Supporting Female Actor in TV, where she will compete alongside fellow Brit Aimee Lou Wood.

In the leading TV categories, Dame Helen Mirren and Bella Ramsey were recognized for their performances in *Mobland* and *The Last of Us* respectively, highlighting the continued strength of British actresses across both established and emerging roles.

On the film side, Emily Blunt was nominated for Best Supporting Female Actor in a Motion Picture for *The Smashing Machine*. Cynthia Erivo picked up a nomination in the Musical or Comedy category for her powerful performance as

Time to switch off, says Britain's latest F1 champ

Lando Norris says he is looking forward to switching off and forgetting all about the year in which he achieved his lifetime's ambition of winning the Formula 1 World Championship.

The McLaren driver spent Sunday night in Monday morning celebration in Abu Dhabi, before digesting his triumph in a hotel on Yas Island, a stone's throw from the F1 track.

Speaking to reporters, Norris was at pains to stress his work was not yet done for the year, as he would be heading to the McLaren factory to analyze this year, and for work in the simulator, already thinking about next season.

There were more celebrations due later in the week, including picking up the official championship trophy at a prizegiving ceremony in Tashkent, Uzbekistan, on Friday, before the McLaren Christmas party in London on Saturday.

When asked about his immediate plans, Norris replied: "Honestly... try to forget this season, try to forget a little bit what we've been able to achieve together. Forget that I drive in Formula 1."

"I don't want to for-

get what we've achieved this season, but just try to live a normal few days of the year, and go play some golf and do some normal things and that's it."

The realization of what he has achieved is beginning to dawn on the 26-year-old Briton but he says he "still finds it very surreal".

"I was just by the pool earlier," he says. "And when someone says, 'Congrats, world champ' or something, it's definitely got a very different ring to it (than) when it's just 'Congrats, Lando,' or whatever it may be."

At the celebrations, and waiting for him in the lobby of the hotel, were his father Adam and mother Cisca.

The family are wealthy, thanks to Adam Norris' success as a pension trader, which made him a multi-millionaire.

But becoming an elite sportsman still means starting learning your trade at a very young age, and a lot of personal sacrifices.

"Everything is different for everyone," he says, "so the sacrifices you've made are just very different sacrifices to all the people in the world who made. So I don't want anyone to feel sorry for me."

Few would have predicted the final outcome at the time of the Dutch Grand Prix at the end of August, when Norris's McLaren teammate Oscar Piastri enjoyed a 34-point lead over his stablemate and seemed a certain bet for the title, only for Norris to rally and overhaul it all.

Manchester City recovered from a goal down to deliver a magnificent Champions League victory at perennial winners Real Madrid on Wednesday night and leave the La Liga side's manager Xabi Alonso precariously holding on to his job.

Alonso is under severe pressure following a poor run in the league and a reported clash of culture with his players, and the heat will now crank up after Real failed to hold on to their early advantage.

The hosts suffered a blow as leading goalscorer Kylian Mbappe was deemed only fit enough to be on the bench, but the France captain did not make an appearance

moment for Nottingham Forest as they recorded a first away win in Europe since 1995.

But they certainly made hard work of it against a side that had managed just one point from five games in the Europa League this season.

Forest had made a dominant start with eight attempts on goal in the first 20 minutes and deservedly took the lead early in the second half.

But they will be frustrated with the equaliser as they switched off at the crucial time to allow Van der Hoorn a free header.

That was the first time Forest had conceded in Europe under Sean Dyche and for a spell they looked in danger of conceding a second.

But Dyche's decision to send on Igor Jesus late on proved pivotal as he finished with pretty much his first attempt on goal.

The win means Forest are well placed to finish in the top eight - the positions that qualify automatically for the knock-outs - with two league phase games remaining.

as his team-mates fell to a demoralizing defeat.

City almost suffered a nightmare start when Matheus Nunes tripped Vinicius Jr inside the first two minutes and the referee pointed to the spot, but then awarded a free-kick on the edge of the box after consultation with the video assistant referee (VAR).

Federico Valverde almost converted the resulting effort but his drilled shot deflected narrowly wide, while the sprightly Vinicius dinked wide at the far post shortly after.

It seemed like City had weathered the early storm and were controlling the possession, before being hit on the break as Rodrygo collected Jude Bellingham's cross-field pass and rifled in his first goal since March.

But City were behind for just seven minutes as the visitors scored with their first clear opportunity of the contest,

academy left-back Nico O'Reilly poking home from close range after Josko Gvardiol's header was scooped back into the danger zone by Thibaut Courtois.

The English side turned the game around on the stroke of half-time courtesy of Erling Haaland's penalty after the striker was bundled over in the box by Antonio Rudiger.

Real attempted to draw level in the second half, with Bellingham chipping over and substitute Endrick flicking a header which clipped the crossbar, but City held on for a tremendous victory.

Real and City have become familiar foes in the Champions League, defining this particular era of the competition by facing each other for the 15th time and the fifth consecutive campaign.

City faced a hostile Real crowd which made their feelings known before kick-off, jeering and

whistling ex-Barcelona boss Pep Guardiola's name when it was read out by the stadium announcer.

But the Spaniard and his side will be highly satisfied in gaining a measure of revenge following their play-off stage defeat here in February, with Guardiola now losing only seven of his 28 meetings against Real.

City started nervously in the Spanish capital and went behind but showed excellent character in the cauldron of the Bernabeu to recover, keep their cool and see out the contest.

Academy product O'Reilly never seems to put a foot wrong and scored a dream equaliser to drag his side back into the contest on 35 minutes, while defensively he won three tackles and contributed four important clearances.

The ever-reliable Haaland made no mistake

with his penalty to score his 55th Champions League goal, with no player managing more since his debut in the competition for RB Salzburg in 2019.

Bad night for both of Glasgow's faded giants

Rangers are all-but out of the Europa League after unbeaten Ferencvaros came from behind in Budapest to inflict a fifth defeat in six matches on the Ibrox outfit.

Bojan Miovski gave Danny Rohl's side a lead against the run of play Thursday night with a spectacular acrobatic volley.

But Rangers were unable to hold on to their slim advantage until half-time as Bence Otvos found the bottom corner via a deflection to level for Robbie Keane's side.

The Hungarian hosts squandered several chances to go in front - with striker Bamidele Yusuf particularly profligate - but eventually their dominance told as Barnabas Varga nodded in Calum O'Dowda's cross on 72 minutes.

Findlay Curtis almost snatched a point for

Rangers late on, but was denied by a fine save from home goalkeeper David Grof.

Rohl's side - still without a win in the competition - must now beat both Ludogorets and Porto in their final two league-stage matches and hope for results elsewhere to fall in their favour.

Even then, seven points is highly unlikely to be enough with 22 sides already on at least eight.

Rangers' uptick in form in the past month has been built on an improvement at the back, despite centre-back pairing Nasser Djiga and Emmanuel Fernandez looking vulnerable.

Villa just keep on winning

Aston Villa's remarkable winning run continued as Unai Emery's side beat Basel in the Europa League, their eighth successive victory in all competitions.

Emery named a much-changed line-up after last weekend's last-gasp Premier League win over leaders Arsenal, but Evann Guessand's second goal since signing from Nice in the summer put them on their way in Switzerland.

The hosts, watched by Swiss tennis great Roger Federer, were level after Flavius Daniliuc flicked home after a clever free-kick by former Liverpool and Stoke midfielder Xherdan Shaqiri.

For the third succes-

sive game, Villa's decisive goal came from a substitute.

After Donyell Malen scored his side's fourth in a seven-goal thriller at Brighton and Arsenal were felled by Emiliano Buendia's late goal, Youri Tielemans climbed off the bench to fire Villa to a fifth win in Europe this season.

Tielemans struck from inside the D, his first club goal since May, after Buendia rolled the ball into his path.

Villa's latest win keeps them on course for the last 16, with 15 points from six games and matches away to Fenerbahce and at home to Red Bull Salzburg to come.

Meanwhile, their run of eight straight wins is their longest as a top-flight side since 1914 (run of 11).

This result was hugely satisfying for Emery, and not just because it maintained his side's incredible winning run.

Not only did it come in the stadium where the Spaniard won his third Europa League trophy with Sevilla in 2016, Villa's latest victory also demonstrated the strength in depth at Emery's disposal.

He made eight changes, with Ezri Konsa, Maty Cash and Amadou Onana the only starters from the statement win over Arsenal last weekend.

With a match at West Ham on Sunday, Emiliano Martinez was given the night off while the likes of Ollie Watkins, John McGinn and Morgan Rogers made cameo appearances from the bench.

Villa survived one or two nery moments but

still ran out winners and are guaranteed at least a play-off spot. Another win, however, should be enough to secure an automatic place in the knockout stages.

Emery's side have now won 14 of their past 16 games in all competitions, remarkable con-

sidering they did not win any of their first six league and cup games at the beginning of the season.

Having failed to score in any of their first four matches, Villa are one of the best performing teams in Europe's top five leagues.

Late show boosts Forest growth
