# Britain 'between peace and war' as Putin ramps up 'bully' tactics

## ■ New MI6 boss issues blunt assessment of growing threat

Britain is living "between peace and war" as Vladimir Putin ramps up attempts to "bully, fearmonger and manipulate", the head of MI6 has warned.

Blaise Metreweli said the Kremlin continues "dragging out" peace negotiations in Ukraine and is "testing us in the grey zone with tactics that are just below the threshold of war".

Ms Metreweli, 48, in her first public engagement as "C", warned of the growing power of social media firms, saying some internet algorithms

could "become as powerful as states".

The Cambridge graduate and first female MI6 chief said: "Our world is more dangerous and contested now than for decades.

"Conflict is evolving and trust is eroding, just as new technologies spur both competition and dependence.

"We are being contested from sea to space, from the battlefield to the boardroom, and even our brains as disinformation manipulates our understanding of each other and ourselves. We

are now operating in a space between peace and war."

Ms Metreweli was speaking before European leaders, including Sir Keir Starmer met in Berlin for the latest talks on the Ukraine war.

### Sabotage

Setting conditions for peace, they stated that any deal with Russia must allow Kyiv to maintain its armed forces at 800,000 troops, involve a European-led multinational force operating inside Ukraine and support the country joining

the EU.

Meanwhile, US officials have reportedly offered unspecified security guarantees to Ukraine.

Ms Metreweli said of the war and the threat to the rest of Europe: "I find it harrowing that hundreds of thousands have died, with the toll mounting every day because of Putin's historical distortions and his compromised desire for respect.

"He is dragging out negotiations and shifting the cost of war on to his own population. Russia is testing us in the grey

zone with tactics that are just below the threshold of war.

"I am talking about cyber attacks on critical infrastructure, drones buzzing airports and

bases, aggressive activity in our seas, state-sponsored arson and sabotage, propaganda and influence operations that crack open and exploit fractures in societies."

# Pay Chelsea sale proceeds now, PM tells Abramovich

## ■ £2.5bn in proceeds currently frozen in British bank

The prime minister has said Russian oligarch Roman Abramovich must "pay up now" to victims of the war in Ukraine or face court action.

Mr Abramovich, the former owner of Chelsea Football Club, pledged in 2022 that the £2.5bn he made from the sale of the club would be used to benefit victims of the Russian invasion of Ukraine.

But there has been a de-

lay in releasing the funds, which are currently frozen in a British bank account, due to a standoff over how exactly they should be used.

Sir Keir Starmer told the Commons on Wednesday: "My message to Abramovich is clear: the clock is ticking."

### 'Pay that money'

The government wants the money to be used for humanitarian aid, but

Mr Abramovich insisted it should be used for "all victims of the war" – meaning that Russians could also benefit.

The oligarch cannot access the money under UK sanctions but the proceeds from the Chelsea sale still legally belong to him.

Updating MPs, Sir Keir said the UK had issued a licence "to transfer £2.5bn from the sale of Chelsea Football Club that's been

frozen since 2022."

And, in a warning to Abramovich, he said: "Honour the commitment that you made and pay up now, and if you don't we're prepared to go to court and ensure that every penny reaches those whose lives have been torn apart by Putin's illegal war."

And Foreign Secretary Yvette Cooper told reporters Mr Abramovich "needs to honour that commitment, pay that money".

Asked if a legal battle could drag out the process for years, Ms Cooper said: "I'm urging him not to try and pursue further

court action."

But she confirmed the government will take the matter to court if he does not act.

Mr Abramovich's representatives declined to comment.

### ties to Putin

The Treasury said that under the terms of the licence, the money must go to "humanitarian causes" in Ukraine and cannot benefit Mr Abramovich or any other sanctioned individual.

The government first threatened to sue Mr Abramovich in June.

Chancellor Rachel Reeves said: "It is unac-

ceptable that more than £2.5bn of money owed to the Ukrainian people can be allowed to remain frozen in a UK bank account."

Mr Abramovich –who made his fortune in oil and gas – was granted a special licence to sell Chelsea following Russia's invasion of Ukraine, providing he could prove he would not benefit from the sale.

He is alleged to have strong ties to Russian President Vladimir Putin, something he has denied.

It is understood that Mr Abramovich has 90 days to act before the UK considers taking legal action.

# Justice done as Paul Doyle gets 21 years

## ■ Raging former Royal Marine injured more than 100 after plowing his car into crowds celebrating Reds' title win

A Liverpool courtroom was the scene of raw emotion and chilling testimony this week as 54-year-old Paul Doyle was handed a 21-year-and-six-month prison sentence for deliberately driving his car into a crowd of jubilant football fans at the city's Premier League victory parade in May.

The sentence marks one of the most serious and harrowing criminal cases the city has seen in recent memory.

Doyle, a former Royal Marine and father of three, admitted guilt to 31 charges including dangerous driving, affray, and multiple counts of causing and attempting grievous bodily harm with intent after his Ford Galaxy ploughed into crowds on Water Street on 26 May 2025. The attack left at least 134 people injured, from infants to pensioners, turning what should have been a day of celebration into a scene of chaos and trauma.

The Liverpool FC

parade, marking the club's Premier League triumph, drew nearly a million supporters into the city centre. As crowds spilled into the streets, Doyle, travelling into town to collect friends, became increasingly frustrated by the congestion. Prosecutors told the court that rather than wait, he lost his temper and used his vehicle "as a weapon", repeatedly accelerating towards groups of pedestrians.

Courtroom screens showed dashcam footage of Doyle swearing and urging people to "move" as fans fled in terror. Witnesses described hearing thuds as people were struck and watching prams topple under the car's wheels. One victim likened the scene to a bomb blast - "carnage everywhere" - as emergency crews rushed to help the injured.

Victims ranged in age from just six months old to 77 years, with many suffering life-changing

injuries and ongoing psychological trauma. One man required a wheelchair for months; another said he now battles PTSD and has had to abandon his apprenticeship due to his injuries.

### Rage

Prosecutor Paul Greaney KC told the court Doyle's actions were not a panic response - an early defence claim that he feared for his life after seeing someone with a knife was dismissed - but a fit of rage as he drove through packed streets. "He not only caused injury on a large scale, but he also generated horror in those who had attended what they thought would be a day of joy," Greaney said.

In court, Doyle sobbed as prosecutors recounted the footage and read out emotional victim statements. He later told police at the scene, "I've just ruined my family's life." His barrister maintained he was "remorseful, ashamed and deeply sorry" for the devasta-

tion caused.

Sentencing him, Judge Andrew Menary KC described Doyle's conduct as driven by "inexplicable and undiluted fury" and said the "disregard for human life defies ordinary understanding." The judge noted that the scale of harm - both physical and psychological - was exceptional and well warranted a lengthy custodial term.

### Heroism

Amid the horror, there were moments of bravery. A former soldier, Daniel Barr, leapt into the back of Doyle's vehicle mid-rampage and managed to shift the automatic gear stick into park, eventually bringing the car to a halt and preventing further injuries. Barr has since been lauded by police and civic leaders for his quick thinking.

Merseyside Police labelled the investigation "one of the most extensive in its history," and prosecutors called it "nothing short of a mir-

acle" that no one was killed despite the scale of the attack.

In the aftermath, dozens of injured supporters have reported ongoing physical pain, counselling for trauma, and a long road to recovery. Liverpool FC and local authorities have highlighted support services available to those affected, including mental health resources and victim care programmes.

For many in the city, the sentence brings a measure of closure, though the scars run deep. As one victim told reporters, "It was supposed to be a day of joy. Instead, my life changed forever."

With Doyle now heading to prison for over two decades, attention turns to healing for a community still reeling from a moment that turned celebration into shock and sorrow.

## BBC likely to fight like hell as Trump sues UK taxpayer for \$10bn

### ■ President's suit claims BBC's Panorama "intentionally, maliciously and deceptively" edited January 6, 2021 speech

**THE BBC has vowed to defend itself after Donald Trump confirmed he was suing the corporation for \$10 billion.**

The US president is seeking equivalent to £7.5 billion damages, alleging that the broadcaster defamed him and violated Florida's deceptive and unfair trade practices act.

Mr Trump alleged in the complaint filed on Monday the BBC "intentionally, maliciously and deceptively" edited the January 6, 2021, speech

he gave before US Capitol attack.

His lawyers argue the depiction of him given in the edit, which aired in a Panorama documentary a week before the results of the 2024 US election, "was false and defamatory" and they also said "the BBC sought to fully mislead its viewers around the world".

### 'unintentional'

A clip from Mr Trump's speech was spliced to show him

saying: "We're going to walk down to the Capitol... and I'll be there with you. And we fight. We fight like hell."

The BBC, which apologized to the president last month for the "unintentional" edit, said: "As we have made clear previously, we will be defending this case. We are not going to make further comment on ongoing legal proceedings."

The Panorama programme was not broadcast in the US, but the lawsuit claims it can be

watched on the BritBox subscription streaming platform and "millions of Florida citizens use a

virtual private network to view content such as the documentary".

Mr Trump is sepa-

rately engaged in legal action with the New York Times and the Wall Street Journal.

# Sir Cliff opens up about prostate cancer treatment

■ **“Get tested, get checked” say veteran singer after revealing recent diagnosis**

Sir Cliff Richard has revealed he has been treated for prostate cancer.

The 85-year-old singer said the cancer was discovered when he had a check-up for a recent tour, but that it had been caught early and had not spread.

“I was going to Australia and to New Zealand and the promoter said, ‘Well we need your insurance, so you need to be checked up for something’. They found that I had... prostate cancer,” he told ITV’s Good Morning Britain.

“But the good fortune was that it was not very old, and the other thing is that it had not metastasized. It hadn’t moved,

nothing into bones or anything like that. And the cancer’s gone at the moment.”

Sir Cliff was speaking to journalist Dermot Murnaghan, who revealed in June that he has stage four prostate cancer.

The singer continued: “I don’t know whether it’s going to come back. We really can’t tell with those sort of things.

“But we need to, absolutely, I’m convinced, get there, get tested, get checked.

“I think we, as men, have got to start saying, we’ve got to be seen as human beings who may die of this thing.”

Sir Cliff said he wants to work with the King to

improve cancer screening for men, after the King spoke last week about his own cancer treatment and emphasised the importance of checks to catch cancer at an early stage.

## ‘absolutely ridiculous’

Sir Cliff is known for decades of hits including The Young Ones, We Don’t Talk Anymore and Summer Holiday.

The musician described the lack of a national screening programme as “absolutely ridiculous”.

“We all deserve to have the same ability to have a test and then start the treatments really early,” he said.

“It seems to me - I’ve only been for one year

now in touch with cancer, but every time I’ve talked with anybody, this has come up, and so I think our government must listen to us.”

Last month, the National Screening Committee – which advises governments across the

UK – said a screening programme for prostate cancer for all men in the UK is not justified.

They say only men with specific genetic mutations that lead to more aggressive tumours should be eligible.

A three-month consul-

tation began at the end of November before the committee meets again and gives its final advice to ministers in England, Wales, Northern Ireland and Scotland, who will each have to make their own decision on prostate screening.

## ‘Nudification’ apps banned

The UK government says it will ban so-called “nudification” apps as part of efforts to tackle misogyny online.

New laws - announced on Thursday as part of a wider strategy to halve violence against women and girls - will make it illegal to create and supply AI tools letting users edit images to seemingly remove someone’s clothing.

The new offences would build on existing rules around sexually explicit deepfakes and intimate image abuse, the government said.

“Women and girls deserve to be safe online as well as offline,” said Technology Secretary Liz Kendall.

“We will not stand by while technology is weaponised to abuse, humiliate and exploit them through the creation of non-consensual sexually explicit deepfakes.”

Creating deepfake explicit images of someone without their consent is already a criminal of-

fence under the Online Safety Act.

Ms Kendall said the new offence - which makes it illegal to create or distribute nudifying apps - would mean “those who profit from them or enable their use will feel the full force of the law”.

Nudification or “de-clothing” apps use generative AI to realistically make it look like a person has been stripped of their clothing in an image or video.

Experts have issued warnings about the rise of such apps and the potential for fake nude imagery to inflict serious harm on victims - particularly when used to create child sexual abuse material (CSAM).

In April, the Children’s Commissioner for England Dame Rachel de Souza called for a total ban on nudification apps.

“The act of making such an image is rightly illegal - the technology enabling it should also be,” she said in a report.

# Delinquent Duke: Toffs gasp as Spencer - Churchill charged with triple choking

The Duke of Marlborough has been accused of strangling his estranged wife on three occasions in an 18-month period, court documents show.

Charles James Spencer-Churchill, 70, formerly known as Jamie Blandford, has been charged with three counts of non-fatal intentional strangulation against Edla Marlborough.

## Diana link

He had been due to appear before Oxford magistrates on Thursday morning but the court heard he was “unable to attend” and the case was adjourned ahead of a plea hearing at High Wycombe Magistrates’ Court on 5 January.

The attacks are alleged to have taken place in Woodstock, Oxfordshire, between November 2022 and May 2024.

The twice-married

aristocrat, formerly known as the Marquess of Blandford, was arrested on 13 May 2024.

He inherited his dukedom in 2014, following the death of his father, the 11th Duke of Marlborough.

He is a first cousin, three times removed, of Sir Winston Churchill and a distant relative of the late Princess Diana through the Spencer

family.

The duke married his second wife, Welsh ceramicist Edla Griffiths, in 2002 but they are thought to have separated in 2024.

## ‘private life’

They are said to have met while she was living in Chelsea and working on her art, and they wed after dating for seven years.

His ancestral family home is Blenheim Palace in Woodstock - Sir Winston’s birthplace - which is owned and managed by Blenheim Palace Heritage Foundation.

The foundation said it was “unable to comment on the charges, which relate to the duke’s personal conduct and private life, and which are subject to live, criminal proceedings”.

## Christian Turner confirmed as UK's new ambassador to Washington

The UK has named career diplomat Christian Turner as its new ambassador to the US, Downing Street has confirmed.

The previous ambassador, Peter Mandelson, was sacked by UK Prime Minister Sir Keir Starmer after evidence, including emails and photos, emerged showing his continued association with the paedophile Jeffrey Epstein.

Turner has spent nearly 30 years working across Whitehall and the Foreign Office.

As the new ambassador in Washington, he will have to navigate relations with the Trump administration, which have been partly strained by disagreements over how to handle the war in Ukraine, as well as President Donald Trump's criticism of Europe.

The Foreign Office said

in a statement that King Charles had formally appointed Turner, and the UK would now seek official approval - or agreement - for his appointment from the US.

### 'pivotal time'

Turner said he was "honoured" to be nominated for the position.

"At a pivotal time for the transatlantic relationship, I look forward to working with President Trump's administration, and leaders in Congress, business and society to strengthen that bond in the years ahead," he said.

Turner will face a heavy load of diplomatic tasks when he takes up the role.

Chiefly among them is working with the US on Trump's push to end the war in Ukraine, which European nations fear will undercut the long-

term interests of the continent in favour of a quick resolution.

Earlier this month, a US national security strategy document - signed by Trump - argued that Europe was facing "civilisational erasure" and questioned whether certain European countries could remain reliable allies.

Turner will also have to work to secure a long-anticipated but delayed tech deal with the US, amid concerns from some White House and congressional officials who have been critical of the UK's online safety laws. Some have characterised those regulations as "censorship" and legal overreach that impacts US firms.

### 'unbreakable bond'

Starmer's government has pushed for close ties

with Trump, hosting him on a second state visit in September, during which Trump praised the "unbreakable bond" between the US and UK.

But just days before Trump arrived, Starmer sacked Mandelson after revelations over his friendship to Epstein. Mandelson has repeatedly said he regrets his relationship with Epstein, who died in jail in 2019 while awaiting trial on sex trafficking offences.

The Foreign Office reportedly pushed hard for a diplomatically experienced figure to be appointed as the new ambassador.

Turner's previous roles include political director at the Foreign Office, British High Commissioner to Pakistan, and Foreign Office Director for the Middle East and North Africa. He also previously worked in

10 Downing Street as private secretary to the prime minister.

Before entering government, he worked in television documentaries.

In a statement released by the Foreign Office, Starmer said: "The United Kingdom and United States have a very special relationship, and Christian's extensive experi-

ence as an outstanding diplomat will support this uniquely close bond and ensure it continues to flourish."

Foreign Secretary Yvette Cooper said Turner would bring "exceptional diplomatic experience and deep understanding" to the role.

Ambassador to the US is seen as one of the UK's top diplomatic postings.

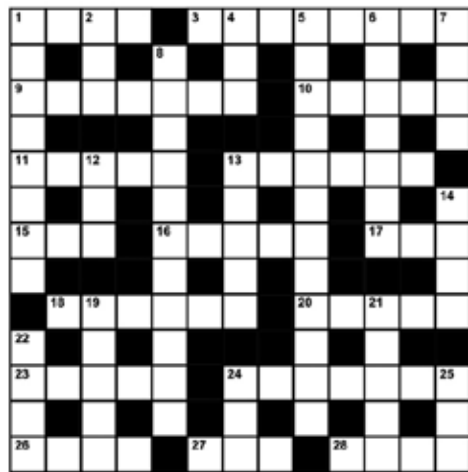

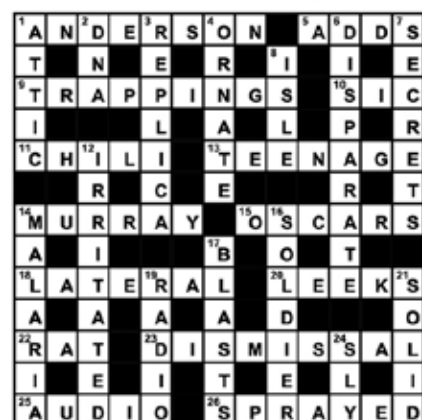

Stephen Graham is devastating as a father fighting disbelief and guilt, while the young central cast deliver performances far beyond their years. Ashley Walters and Erin Doherty add further heft in supporting roles. A global Netflix hit and an awards magnet, it's essential viewing for US audiences who want to see British drama at its bravest.

**2. Death Valley (BritBox / Amazon Channels)** Death Valley is the sort of British crime drama that feels like a comforting Sunday-night watch, but with enough bite to keep things fresh. Set against the lush landscapes of South Wales, it stars Timothy Spall as a retired actor who once played a TV detective — now unexpectedly putting those fictional instincts to real use. He's paired with Gwyneth Keyworth's no-nonsense young police sergeant, and their odd-couple chemistry is the show's real joy. Light on its feet, gently

funny and warmly character-driven, it's a cosy mystery with a knowing wink, streaming in the US via BritBox and Amazon. **3. Toxic Town (Netflix)** Written by Jack Thorne, Toxic Town tackles weightier material, dramatising the real-life Corby toxic waste scandal. Jodie Whittaker is superb as a mother refusing to be silenced, while Robert Carlyle brings his trademark intensity to a story about institutional failure and working-class anger. **4. House of Guinness (Netflix)** If you enjoy your period drama rich, glossy and packed with family intrigue, House of Guinness delivers in spades. Created by Steven Knight, this sweeping saga charts the rise of the iconic Irish brewing dynasty, blending boardroom ambition with messy personal lives. The cast is stacked with familiar British and Irish faces, including Jessie Buckley and Cillian Murphy in standout roles. Lavish production values and muscular storytelling make it feel like prestige television through and through — and, thanks to

Netflix, it's fully available to US viewers.

**5. Fear (Amazon Prime Video)** Short, sharp and deeply unsettling, Fear stars Martin Compston at his most tightly coiled, alongside Anjali Mohindra, who brings emotional depth and quiet steel. Adapted from Dirk Kurbjuweit's novel, this three-part psychological thriller explores paranoia, obsession and the moral lines people cross when pushed too far. Its stripped-back approach and claustrophobic atmosphere make it ideal for a tense weekend binge on Amazon Prime Video.

**6. Outrageous (BritBox)** Outrageous dives headlong into the scandalous world of the Mitford sisters, played by an excellent ensemble including Bessie Carter and Joanna Vanderham. Set in the 1930s, it captures both the glamour and the ugliness of the era, as politics, fascism and family loyalties collide. Richly performed and morally complex, it's one of BritBox's standout originals of 2025 and a rewarding watch for fans of intelligent historical drama.

**7. Maigret (PBS Masterpiece)** PBS Masterpiece's new Maigret offers a moody, beautifully paced take on Georges Simenon's famous detective. Benjamin Wainwright brings quiet authority to the role, supported by a strong British

cast despite the Parisian setting. Thoughtful rather than flashy, it's classic Sunday-evening television — and freely accessible to US audiences via PBS.

**8. Lynley (BritBox)** This fresh adaptation of Elizabeth George's Inspector Lynley novels reintroduces aristocratic detective Tommy Lynley and his grounded partner Barbara Havers. With polished production and strong central performances, it balances case-of-the-week plotting with emotional character arcs. Released weekly on BritBox, it's a welcome return to classic British detective storytelling.

**9. Call the Midwife (PBS / PBS app)** Still going strong, Call the Midwife continues to charm and devastate in equal measure. Led by long-standing cast favourites including Jenny Agutter and Helen George, the 2025 season once again explores social change, compassion and community in post-war East London. Available on PBS, it remains one of Britain's most beloved exports.

**10. Protection (BritBox)** Gritty and grounded, Protection stars Siobhan Finneran in formidable form as a detective working within the fraught world of witness protection. With a supporting cast that includes Barry Ward, it blends personal

said after receiving the award. "First of all, I would like to congratulate all of the other finalists. I know how much hard work and dedication it takes, so it is a pleasure to just be in this room. I feel truly honoured to just be a part of it.

"2025 has been the year I made my dreams come true. From August to the Ryder Cup and everything in between. It's the year dreams are made of."

England rugby union player Ellie Kildunne came second, with Formula 1 driver Lando Norris in third.

Just minutes before collecting his individual award, McIlroy - along with Tommy Fleetwood - collected the Team of the Year award after

Team Europe were honoured for their Ryder Cup success.

England forward Chloe Kelly, Lionesses goalkeeper Hannah Hampton and darts player Luke Littler were also shortlisted for the award by a panel of experts, with the winner decided by a public vote.

McIlroy is just the third golfer to win Sports Personality, after Dai Rees in 1957 and Nick Faldo in 1989.

The Hollywood-born McIlroy is the third Northern Irishman to win the award, following boxer Barry McGuigan in 1985 and jockey Sir AP McCoy in 2010.

"I have a lot of people to thank," said McIlroy. "Firstly, the public, my family, my mum and my

dad. They sacrificed so much for me. I wouldn't be here without them, so thank you.

"My wife Erica and my daughter Poppy, they are what holds me together. My rock. They couldn't be here tonight but I can't wait to get back tomorrow and celebrate this with them. I love you.

Tottenham's Europa League final match-winner Brennan Johnson is facing an uncertain future at the club amid growing Premier League interest in the attacker.

"And to the BBC for hosting these awards. It has always been something growing up that I watched on TV.

"It was always a big part of the run-up to Christmas, so I am very honoured to get my hands on this trophy.

"Hopefully I can challenge to get it again next year."

Multiple reports from North London suggest the club, while not actively looking to sell the Wales international, are open to letting Johnson leave should they receive a suitable offer.

Crystal Palace are currently the club most advanced in their interest for Johnson, but other teams are believed to be monitoring his situation closely.

Johnson was Spurs's leading Premier League goalscorer last season with 11, and etched his name in Spurs folklore by scoring the winner in their Europa League final triumph over Manchester United in Bilbao, ending the club's 17-year wait for a trophy.

But the departure of Ange Postecoglou and arrival of Thomas Frank as new head coach has meant Johnson has played more of a peripheral role this season.

## Cherki chappie leads the way as City start to look ominous

■ EPL Cup: Pep's men purring as they book semi final spot

Rayan Cherki's thunderbolt strike helped Manchester City overcome Brentford to reach the semi-finals of the Carabao Cup on Tuesday night.

City, who had not reached the last four of the competition since claiming a fourth triumph in a row in 2021, will face Newcastle in a two-legged semi-final.

Brentford started brightly but could not capitalize and were then reliant on stand-in goalkeeper Hakon Valdimarsson to push away a rising effort from Cherki.

Having had a sighter at goal, the Frenchman gave City the lead just after the half hour mark.

The forward picked the ball up on the edge of the box, cut on to his right foot before unleashing an unstoppable effort high into the top corner of the net.

Before the goal, Brentford were left incensed when Abdukodir Khusanov received only a yellow card for tripping Kevin Schade close to the edge of the box. The visiting players argued their striker was through on goal but with no video assistant referee (VAR) in operation, the on-field decision from Sam Barrott stood.

Nico O'Reilly long range strike in the second half was straight at Valdimarsson, while at the other end Kristoffer Ajer's arrowed drive was brilliantly pushed away at full stretch by James Trafford.

And City sealed progression in the next round as Savinho's deflected strike on 67 minutes looped over Valdimarsson and landed in the net to leave them one step away from another trip to Wembley.

This was already City's fifth game in a relentless December, with two more Premier League to come to round off the year.

Victory over the Bees in treacherous conditions maintained their flawless record this month and Guardiola's men are starting to look ominous having won six straight matches across all competitions.

This competition is likely to be fourth on the list of trophy priorities for City, as they sit two points adrift of Arsenal in the league and inside the top-eight in the Champions League group phase.

But after finishing last season without winning major silverware for the first time in eight years, the Carabao Cup could provide the first opportunity to put that particular record right, should they progress through the next round.

in and out but striking his shot straight at the Brentford goalkeeper.

The one concern for City will be a possible addition to their list of unavailable players.

City are already without Omar Marmoush and Rayan Ait-Nouri who are both at the Africa Cup of Nations, while Jeremy Doku, John Stones and

Rodri are out injured.

Guardiola will be hoping Oscar Bobb is not

added to that list after hobbling off injured in the first half. His withdrawal brought the in-form Phil Foden off the bench and he almost scored a seventh goal in his last six games but saw a snapshot clawed away by Valdimarsson.

## Chelsea in the hunt for yet another trophy as Maresca shrugs off 'worst' week

Chelsea held off League One leaders Cardiff City to secure their place in the EFL Cup semi-finals with a hard-fought and absorbing win in south Wales Wednesday night.

Roared on by a fervent capacity crowd at Cardiff City Stadium, the home side impressed in and out of possession as they contained their Premier League opponents and showed flashes of their own attacking threat in a goalless first half.

Chelsea boss Enzo Maresca had changed his entire team from Saturday's Premier League victory over Everton, which had been overshadowed by his post-match comment that the preceding 48 hours had been the

"worst" of his tenure.

The Club World Cup champions' underwhelming first-half display will have done nothing to improve the Italian's mood, so he made two half-time substitutions and it was one of those – Alejandro Garnacho – who fired them in front after Cardiff centre-back Dylan Lawlor had given the ball away.

Brian Barry-Murphy's side responded strongly and equalised as David Turnbull headed in superbly from Perry Ng's inviting cross to prompt deafening celebrations.

They were short-lived, however, as another Chelsea substitute, Pedro Neto, restored their lead with firm a low drive

which took a deflection on its way in.

Garnacho then added a third in added time to make sure of victory.

Those goals momentarily deflated the raucous atmosphere, but Cardiff can take great encouragement from the way they equipped themselves against elite opposition as they turn attentions back to their bid to make an instant return to the Championship.

As for Chelsea, this was a welcome result – if an unconvincing display – after a difficult few days for Maresca. He had come under scrutiny after his unexpected, somewhat cryptic remark had dominated the aftermath of Chelsea's win against

Everton as well as the build-up to this encounter, with the Italian clearly irritated when he was repeatedly asked to clarify his comment during a pre-match news conference on Monday.

That was a distraction but, ultimately, not enough to derail Chelsea here.

Even with 11 changes from the Everton game,

Maresca was able to name a strong line-up with the likes of £100m midfielder Moises Caicedo recalled, while the bench was worth close to £400m.

Unimpressed by a first half in which his side barely troubled their lower-league opponents, the head coach brought on Garnacho and Joao Pedro at the interval.

Their introduction im-

mediately added a purpose and sharpness the Chelsea attack had been lacking, with Garnacho forcing Cardiff goalkeeper Nathan Trott into a fine save.

Garnacho's late second arguably flattered Chelsea, but they were worthy winners as they went a step closer to winning this trophy for the first time in 10 years.

# Palace with some work to do!

## Europa Conference: Second string Eagles fail to dispatch minnows and are left facing two legged playoff

Crystal Palace will have to win a two-legged knockout phase play-off in February if they are to advance to the last 16 of the Conference League after drawing with KuPS at Selhurst Park.

With Palace kicking-off at Leeds less than 48 hours after the end of this game, boss Oliver Glasner fielded a mixture of fringe players and youngsters for the must-win match against the Finnish champions.

Sixteen-year-old Joel Drakes-Thomas became the youngest Englishman to play in Europe's third-tier competition, while Dean Benamar, 17, and George King, 18, also made their

senior debuts.

And all seemed to be going well when Christantus Uche sent Palace into a fifth-minute lead with a lovely curling finish with the outside of his boot.

That sent Palace, who started the day in ninth in the table, up into third - and an automatic last-16 place.

However, last season's FA Cup winners conceded two goals in the space of three second-half minutes early in the second half.

Former Charlton forward Piotr Parzyszek equalised from 12 yards in the 50th minute before Ibrahim Cisse put the visitors ahead for the first time.

Justin Devenny made it 2-2 with a 76th-minute header after the visitors had been reduced to 10 men when Clinton Antwi was shown a straight red card for a foul on substitute Will Hughes.

But Palace could not find a winner - and must now negotiate a two-legged play-off after finishing 10th in the table.

This was the first of three matches in six days for Palace and Glasner will not relish the prospect of an extra two extra European games in the new year.

The Palace boss was forced to field an under-strength side against KuPS because of the tight turnaround before

the Leeds game at 20:00 GMT on Saturday, which is swiftly followed by a Carabao Cup quarter-final away to Arsenal next Tuesday.

Palace do not have the strength in depth of some of their Premier League

rivals.

Yet Drakes-Thomas, Benamar and King did not look out of their depth on what was a big night for the academy trio.

In the past seven months, Palace have won

the FA Cup and the Community Shield, while they occupy fifth spot in the Premier League.

And despite finishing two points and two places off an automatic last-16 spot, Palace are still fighting in Europe.

## Toon face City in semi

**Holders Newcastle United will face eight-time winners Manchester City in the semi-finals of the Carabao Cup.**

Chelsea will either meet Arsenal or Crystal Palace in the other two-legged last-four tie but must wait until Tuesday 23 December to find out which of their London rivals it will be.

The Gunners' quarter-final match against the Eagles was rescheduled to prevent Oliver Glasner's Palace side playing three match-

es in five days because of their involvement in the Europa Conference League on Thursday.

The first legs of the semi-finals take place in the week commencing 12 January 2026 with the second-leg fixtures in the week beginning 2 February.

Chelsea were runners-up to Liverpool in both 2022 and 2024, last winning the trophy in 2015.

Manchester City won the trophy for a fourth-consecutive time in 2021 but have not

reached the last four since while the Magpies beat Liverpool in March to win a first domestic trophy in 70 years.

## SPOTY win for Rory

Golfer Rory McIlroy has been voted BBC Sports Personality of the Year 2025 after clinching the career Grand Slam and playing a key role in Europe's Ryder Cup win.

The 36-year-old from Northern Ireland achieved golfing immortality in April when he

won the Masters at Augusta National to complete the set of all four majors.

He became just the sixth man - and first European - to achieve the Slam, joining Americans Gene Sarazen, Ben Hogan, Jack Nicklaus and
