British campaigners for social media regulation denied visas to USA

■ Pair are among five Europeans described as part of “global censorship-industrial complex”

Two British campaigners are among five people denied US visas after the State Department accused them of seeking to “coerce” American tech platforms into suppressing free speech.

Imran Ahmed, an ex-Labour adviser who now heads the Centre for Countering Digital Hate (CCDH), and Clare Melford, CEO of the Global Disinformation Index (GDI), were labelled “radical activists” by the Trump administration and banned from entering the US.

A French ex-EU commissioner and two senior figures at a Germany-based anti-online hate group were also denied visas.

European leaders have condemned the measures, while the UK government said it is “fully committed” to upholding free speech.

“While every country has the right to set its own visa rules, we support the laws and institutions which are working to keep the internet free from the most harmful

content,” a UK government spokesperson said.

French President Emmanuel Macron described the travel ban as “intimidation and coercion aimed at undermining European digital sovereignty” while the EU’s foreign policy chief Kaja Kallas said it was “unacceptable and an attempt to challenge our sovereignty”.

‘collaborator’

The US billed the measures as a response to people and organisations that have campaigned for restrictions on American tech firms, with Secretary of State Marco Rubio saying they belonged to a “global censorship-industrial complex”.

He said: “President Trump has been clear that his America First foreign policy rejects violations of American sovereignty. Extraterritorial overreach by foreign censors targeting American speech is no exception.”

Ahmed from the CCDH, which says it advocates for govern-

ment action against hate speech and disinformation online, has links to senior Labour figures. He was previously an aide to Labour minister Hilary Benn, and Sir Keir Starmer’s chief of staff Morgan McSweeney has served as a director of the group he founded.

The US government labelled Ahmed a “collaborator” for the CCDH’s purported past work with the Biden administration.

Melford founded the GDI, a non-profit that monitors the spread of disinformation, in 2018.

US Undersecretary of State Sarah B Rogers accused the GDI of using US taxpayer money “to exhort censorship and blacklisting of American speech and press”.

A GDI spokesperson said that “the visa sanctions announced today are an authoritarian attack on free speech and an egregious act of government censorship”.

“The Trump Administration is, once again, using the full weight of the federal government

to intimidate, censor, and silence voices they disagree with. Their actions today are immoral, unlawful, and un-American.”

Also targeted was Thierry Breton, the former top tech regulator at the European Commission, who suggested that a “witch hunt” was taking place.

Breton was described by the State Department as the “mastermind” of the EU’s Digital Services Act (DSA), which imposes content moderation on social media firms.

However, it has angered some US conservatives who see it as seeking to censor right-wing opinions. Brussels denies this.

Breton has clashed with Elon Musk, the world’s richest man and owner of X, over obligations to follow EU rules.

Breton called the decision an “act of repression by a government that is increasingly disregarding the rule of law and trying to silence its critics by any means necessary”.

Robotaxis set their sights on London



Baidu’s driverless Go taxis are already on roads in China, Hong Kong and Dubai

Chinese robotaxis could be set to hit UK roads in 2026 as ride-sharing apps Uber and Lyft announce partnerships with Baidu to trial the tech.

The two companies are hoping to obtain approval from regulators to test the autonomous vehicles in London.

Baidu’s Apollo Go driverless taxi service already operates in dozens of cities, mostly in China, and has accrued millions of rides without a human behind the wheel.

Transport secretary Heidi Alexander said the news was “another vote of confidence in our plans for self-driving vehicles” - but many remain sceptical about their safety.

“We’re planning for self-driving cars to carry passengers for the first time from spring, under our pilot scheme – harnessing this technology safely and responsibly to transform travel,” Ms Alexander said on a recent post on X.

Uber said in June it would bring its plans to trial UK driverless cars forward as the government sought to accelerate framework to allow pilots of small autonomous “bus and taxi like” commercial services in 2026.

“We’re excited to accelerate Britain’s leadership in the future of mobility, bringing another safe and reliable travel option to Londoners next year,” it said of its

Baidu partnership on Monday.

Lyft said in August it would look to deploy driverless taxis in the UK and Germany as part of a European agreement with Baidu.

It already operates "autonomous rides" in Atlanta, US - where Uber also operates a robotaxi service through its partnership with Waymo.

Lyft chief executive David Risher said on Monday that London passengers would be "the first in the region to experience Baidu's Apollo Go vehicles".

But both firms still need to convince regulators.

Mr Risher said if green lit, Lyft's initial fleet of dozens of Baidu Apollo Go cars would begin testing next year "with plans to scale to hundreds from there".

But Jack Stilgoe, professor of science and technology policy at University College London, said driverless cars "can't just scale up like other digital technologies".

"There's a big difference between having a few test vehicles using public streets as their laboratory and a fully-developed, scaled-up system that becomes a real transport option for people," he said.

safety concerns

But many people remain uneasy about the safety of taxis without a human operator.

Almost 60% of UK respondents to a poll in October said they would not feel comfortable riding in a driverless taxi under any circumstances.

Many also expressed a lack of trust in the tech, with 85% saying they would opt for a cab with a human driver if given the same price and convenience.

"Driving Home" Musician Chris Rea dead at 74

■ Singer-songwriter was best known for the festive classic and "Fool if You Think It's Over"

Chris Rea, the musician behind the festive classic *Driving Home for Christmas*, has died at the age of 74.

The singer died on Monday in hospital following a short illness, a spokesperson for his family said.

A statement on behalf of his wife and two children read: "It is with immense sadness that we announce the death of our beloved Chris.

"He passed away peacefully in hospital earlier today following a short illness, surrounded by his family."

The blues-influenced star had a string of hits including *Auberge*, *On the Beach*, *Fool (If You Think It's Over)*, *Let's Dance* and *Road to Hell*.

Paying tribute on X, Middlesbrough FC said: "We're deeply saddened to learn of the passing of Chris Rea. A Teesside icon. Rest in peace, Chris."

Rea's 1980s smash *Driving Home for Christmas* tells the story of a weary traveller making his way home in heavy traffic.

This year, it has been brought to new audiences as the backdrop to the Marks & Spencer Food Christmas advert.

In 2020, the singer Rea revealed in a chat with his friend and fellow

Middlesbrough native comedian Bob Mortimer, explaining how he came to write the track.

Rea said he was on the dole at the time, his manager had just left him and he had been banned from driving.

His then-girlfriend Joan (who he met when they were both 16 and went on to marry) had to pick him up in London in her mini and drive him home.

That's what inspired the song, which was written in 1978, 10 years before it was released as a single in 1988.

Asked about what he thinks of when he hears the song, the singer joked about how it bought him "that lovely little holiday in the Maldives".

bouts of ill health

The song has since been covered by artists including Engelbert Humperdinck and Stacey Solomon.

Rea was good friends with Mortimer and in 1997 they recorded *Let's Dance* for Middlesbrough Football Club's FA Cup Final.

On Monday evening, Mortimer posted on X: "So so sad. A lovely brilliant funny giant of a bloke. Oh Man... RIP Chris... Boro legend forever. Love to family and friends."

But alongside the singer-songwriter's success, he had suffered with various bouts of ill-health over the years.

He had his pancreas removed a few years after being diagnosed with pancreatic cancer at the age of just 33 in 1994, which meant he developed type 1 diabetes. He later had a stroke in 2016.

Once he found the guitar, he soon began playing in various bands and released his debut album *Whatever Happened To Benny Santini?* in 1978.

His commercial breakthrough came in the 1980s, as two of his studio albums - *The Road To*

Hell (1989) and *Auberge* (1991) - went to number one in the UK.

He returned to his blues roots in his later years while facing his health challenges.

After his stroke nine years ago, he recovered to launch a new album, *Road Songs For Lovers*, in 2017.

He took the album on the road at the end of that year but had to cancel a number of shows after he collapsed mid-song while performing at the New Theatre in Oxford.

Rea released a new album in October 2025, titled *The Christmas Album*, featuring a remas-

ter of *Driving Home For Christmas* as well as other festive tracks.

Paying tribute to Rea following his death, journalist Tony Parsons described him as a "top man" and "hugely underrated songwriter".

TV personality Lizzie Cundy, who appeared in the music video for a 2009 version of *Driving Home For Christmas*, said that she was "so sad" to hear the musician had died.

"I loved every minute and was an honour to work with him and be in his iconic music video," she said. "He will always be an inspiration and legend to me."

Cowboy builder jailed for 14 years for £1.25m fraud

A prolific cowboy builder who defrauded 37 customers out of more than £1.25m has been jailed for 14 years.

Mark Killick, from Paulton in North East Somerset, also used the names Marc Cole and Mark Jenkins when he agreed to take on building work.

Between 2019 and 2021, while trading as TD Cole, he failed to complete work for dozens of cus-

tomers despite many of them paying tens of thousands of pounds up front.

Sentencing Killick, 56, at Bristol Crown Court, Judge Moira Macmillan told him he had caused "serious and ongoing" harm to his victims, leaving their homes in a "truly shocking" state.

It is the fourth time Killick has been found guilty of fraud since 2008, and police estimate the 37 victims in this case collective-

ly lost more than £1.25m.

During his five month trial the prosecution highlighted Killick's spending on luxury goods, including a £25,000 Rolex watch he claimed was an asset for the failing business.

Dozens of victims also gave evidence against him, telling how their homes had been ruined by his unfinished work.

Killick, of Shoe Lane, was found guilty of 37 counts of fraud and

cleared of one at Bristol Crown Court.

The jury failed to reach a verdict on eight further charges against him.

"You decided to exploit the need for building services in the pandemic. In contrast to others in the industry you visited immediately and at short notice," the judge added.

"You transferred money multiple times through business accounts and your own and your wife's

accounts. This made it impossible to establish what happened to individual payments.

"You bought yourself Rolex watches including one you paid for using a Covid bounceback loan.

"You repeatedly asked clients to advance you further funds even though little or no progress was being made."

Avon and Somerset Police and Trading Stan-

dards received more than 100 complaints against Killick covering a period between 2019 and 2021.

Originally from Neath in South Wales, Killick has asked the Court of Appeal for permission to appeal against his conviction.

In court, he said he had always run an honest business and did not intend to defraud his customers.

Banning order

Killick will be made subject to a Serious Crime Prevention Order (SCPO) that will last for five years from the date he is released from prison.

He will also be subject to a 15-year order disqualifying him from being a company director.

Killick remained in denial right up until sentencing, telling the court he would have completed all the outstanding jobs if he had not been arrested in November 2021.

Killick has a decades-long criminal record.

In 2006, he was handed a 12-year Bankruptcy Restriction Order which prevented him getting more than £500 credit without revealing the order.

He went on to plead guilty to fraud in 2008, 2009 and 2014.

The 2014 conviction involved 42 victims, whose losses he accepted at £573,000.

He has had six custodial sentences, including three for unspecified crimes in magistrates' courts in the 1990s, the Ministry of Justice said.

"Of course I'm angry," said Stephen Gledhill from Bristol.

"But I just feel sad for him [Killick] really that he's behaved in that way without any kind of real indication that he cares."

"A" from Balmoral seeking "inappropriate friends": new Epstein reveal heaps more bad news on Andrew

■ Latest tranche of documents appear to link Prince even closer to disgraced former financier

An email sent from an individual named "A", saying they are at Balmoral and asking Ghislaine Maxwell for "inappropriate friends", is among the latest tranche of Epstein files released on Tuesday.

The message, sent to Maxwell on 16 August 2001, begins: "I am up here at Balmoral Summer Camp for the Royal Family." Later in the email, the sender asks: "How's LA? Have you found me some new inappropriate friends?" before signing off "see ya A xxx".

Balmoral Castle is a royal residence.

The former prince has previously denied all wrongdoing and has also previously said he did not "see, witness or suspect any behaviour of the sort that subsequently led to his [Epstein's]

arrest and conviction".

The message was sent from email address "abx17@dial.pipex.com" entitled "The Invisible Man" and forms part of the more than 11,000 files published on Tuesday.

In an email sent back to this address on the same day, Maxwell wrote: "So sorry to dissapoint [sic] you, however the truth must be told. I have only been able to find appropriate friends."

A different email address - aace@dial.pipex.com - is listed in Epstein's phone book under a contact labelled "Duke of York", a previously released image showed.

A further exchange between Maxwell and "The Invisible Man" also published on Tuesday shows the alias attached to both of the email ad-

The messages, sent in February 2002, discuss a trip to Peru.

Maxwell initially forwarded an email to "The Invisible Man" at abx17@

dial.pipex.com with details of plans for a visit to the South American country asking "What do you think [?]"

The forwarded email comes from an address

labelled "Juanesteban Ganoza" and makes suggestions on possible activities including a small lunch and horse riding.

It also said: "About the

Husband in court charged with drugging and raping ex-wife

A former councillor has appeared in court accused of a string of sexual offences against his ex-wife over a 13-year period.

Philip Young is charged with 56 offences, including multiple counts of rape and administering a substance with intent to stupefy his former spouse Joanne Young, who has waived her legal right to anonymity.

Appearing at Swindon Magistrates' Court on Tuesday, the 49-year-old - formerly of Swindon but now of Amberley Road in Enfield - confirmed his name and address. He did not enter a plea.

Five other men charged with sexual offences against Ms Young, 48, appeared at the same court, with two pleading not guilty to all charges.

Among the 56 charges,

Mr Young - who police described as a white British national - is accused of voyeurism, possession of indecent images of children and possession of extreme images.

Mr Young served as a Conservative Swindon borough councillor for Covingham and Nythe between 2007 and 2010. The alleged offences are said to have taken place between 2010 and 2023.

The following men also appeared at Swindon Magistrates' Court earlier accused of offences against Ms Young:

Norman Jackson, 47, of Wood End Close in Sharnbrook, Bedfordshire pleaded not guilty to one count of rape and possession of extreme images. Police described him as a black British national.

Dean Hamilton, 47, of no fixed abode, pleaded not guilty to one count of

rape and sexual assault by penetration and two counts of sexual touching. Police described him as a white British national.

Connor Sanderson Doyle, 31, of Crofton Road in Swindon, is charged with sexual assault by penetration and sexual touching. He did

not enter a plea. Police described him as a white British national.

Richard Wilkins, 61, of Tattershall in Toothill, Swindon, is charged with one count of rape and sexual touching. He did not enter a plea. Police described him as a white British national.

Mohammed Hassan, 37, of Torun Way in Swindon, is charged with sexual touching. He did not enter a plea. Police described him as a British Asian male.

They were released on bail on the condition they had no contact - direct or indirect - with Ms Young.

Russell Brand hit with two additional sex charges

Russell Brand has been charged with two further offences including one count of rape, the Metropolitan Police has said.

In a new statement on Wednesday, the police force said the Crown Prosecution Service (CPS) has authorised an additional charge of rape and a charge of sexual assault relating to two further women.

The broadcaster, comedian and actor previously pleaded not guilty to five charges including two counts of rape, two counts of sexual assault and one count of indecent assault in relation to four women.

Mr Brand, 50, is due to appear at Westminster Magistrates' Court on 20 January 2026 in relation

to the two new charges.

Detectives began investigating allegations into Mr Brand which came to light following reporting from the Sunday Times, the Times and Channel 4's Dispatches in September 2023.

The two new charges allegedly took place in 2009 and relate to separate women, the CPS said.

A trial is set to start at Southwark Crown Court on 16 June 2026 for the five original charges which allegedly took place on dates spanning between 1999 and 2005 in central London and Bournemouth.

Mr Brand, of Oxfordshire, is accused of raping one woman in Bournemouth in 1999, and

indecently assaulting another in the Westminster area by grabbing her arm and dragging her towards a male toilet in 2001.

A third charge alleges he sexually assaulted a woman by kissing and groping her in Westminster between 2004 and 2005, while the remaining counts relate to the alleged oral rape and sexual assault of an additional woman in 2004 in the Westminster area.

Det Ch Insp Tariq Farooqi from the Metropolitan Police has said the women who have made reports are receiving support from specially trained officers.

Mr Brand, who was born in Essex, rose to fame as a stand-up comedian and became a

household name as host of TV shows like Big Brother's Big Mouth, and with his own radio programs on stations

including BBC Radio 2 and 6 Music.

He went on to establish a Hollywood career, starring in films like For-

getting Sarah Marshall and Get Him To The Greek.

girls... how old is he? I doubt it that he will find someone here, but we can try."

A reply from "The Invisible Man" is sent to Maxwell via the other address "aace@dial.pipex.com" with comments including: "As far as food is concerned I am very easy and will fit in with whatever he plans [...] As for girls well I leave that entirely to you and Juan Estoban!"

The sender signs off "Masses of love A xxx".

In a later exchange, in March 2002, Maxwell forwards an email to aace@dial.pipex.com, which begins: "Thought

you would like to see what I sent."

The email then appears to copy in a note sent to someone else beginning: "I just gave Andrew your telephone no [sic]."

"Some sight seeing some 2 legged sight seeing (read intelligent pretty fun and from good families) and he will be very happy."

In October, Andrew Mountbatten-Windsor lost use of his prince and Duke of York titles following scrutiny over his links with Epstein.

The US Department of Justice has been releasing documents, known as the Epstein files, relating to two criminal investigations into the convicted sex offender

during his lifetime.

Congress passed a law mandating the files be released in their entirety by 19 December.

Not all the files have yet been released.

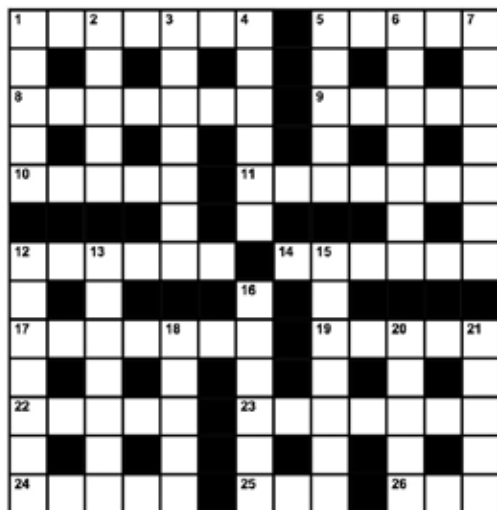
Also among the newly released documents is a formal request from the US Department of Justice (DOJ) dating to April 2020 asking for assistance from the British authorities "to interview H.R.H Prince Andrew Albert Christian Edward" relating to two criminal investigations.

The document also underlined that Andrew was not a "target" of the investigation and no evidence had been gathered that he had committed any crime under US law.

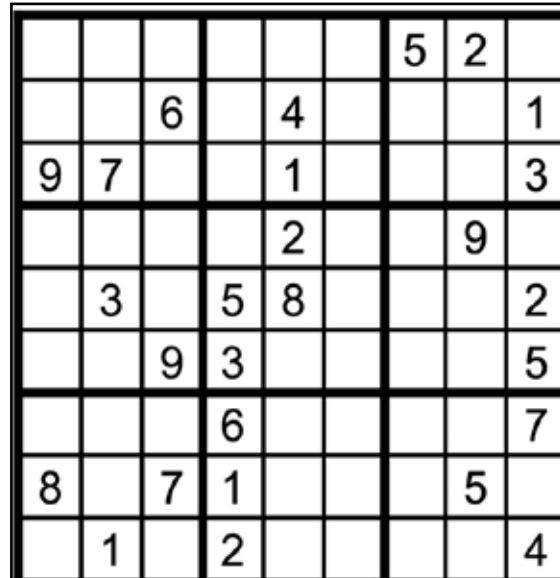

Manchester's royalty come out in force for funeral of Stone Roses' Mani

■ Liam Gallagher, Paul Weller, David Beckham and former bandmates were among the celebrity mourners at Manchester cathedral this week

The Stone Roses singer, Ian Brown, has remembered his bandmate Gary "Mani" Mounfield as a "true musical comrade" and "always a beautiful soul and spirit" as hundreds gathered for the charismatic bassist's funeral.

Paul Weller, Liam Gallagher, Peter Hook, Tim Burgess, Bez, David Beckham and Gary Neville were among the mourners at the service at Manchester Cathedral on Monday morning. Outside, fans packed the street.

Mounfield was the Stone Roses' much-admired bassist and later a member of Primal Scream. He died at his home in Stockport on 20 November, aged 63.

His coffin, resembling the cover of the first Stone Roses album, was carried out of the cathedral by Brown, Gallagher, Primal Scream's frontman, Bobby Gillespie, the band's guitarist, Andrew Innes, and his Stone Roses bandmates John Squire and Alan "Reni" Wren.

Brown told the service: "One thing we can all agree on is Mani was one of the greatest lads we ever met, one of the greatest men we ever knew. Lucky us. Mani was like a brother to me. A dream as a friend. A true musical comrade."

He continued: "We all know Gaz lived his life laughing. And laughing was his number one pursuit – always looking for the next laugh, a non-stop laugh machine."

"Mani's been in my corner whatever the situation, for 45 years – non-stop, unconditionally. Always a beautiful soul and spirit."

Brown told the congregation how his friend had loved the same things all his life: "His family, his pals, fishing, football, [Manchester] United, music, Lambrettas, dancing, clobber, town and all the usual gentlemanly pursuits."

"He lived a full, a fulfilled and a blessed life, going round and round the world lifting people up with his bass guitar skills."

Brown said there had

been a "tsunami of love" for Mounfield since his death, adding: "He loved everyone and everyone loves him ... he was the life and soul of wherever he was, making every room he was in brighter."

He told the gathered mourners: "Mani wouldn't want us to be broken-hearted. But we all are."

There were cheers in church when Brown said Mounfield loved Manchester more than anyone, and "few have done so much for this city", calling for a 50ft, solid gold statue to be erected in his memory.

Gillespie told the service how much he cherished Mounfield's time in Primal Scream after he joined in 1996. "He was a funky little mother, with a rock'and'roll heart," he said.

"He stalked the stage with the stealth of a panther, with the grace of a dancer. How fortunate we were to have him in our band and in our lives," said Gillespie. "Mani's not dead, he's just gone."

The King's Christmas Broadcast was the most-watched TV programme in the UK on Christmas Day, with nearly 7m tuning in on the BBC, ITV, Sky News and GB News to watch King Charles deliver his annual message, this year recorded in Westminster Abbey.

After the King, the next most popular show was The Scarecrows' Wedding on BBC One, watched by 4.3m. It is based on the picture book by Julia Donaldson and Axel Scheffler, who wrote and illustrated The Gruffalo.

The King used his traditional speech to in-

voke the wartime spirit, urging people to get to know their neighbours and "never lose sight" of the values in which communities came together "in the face of such great challenge".

Strictly Come Dancing's Christmas Special - which saw Tess Daly and Claudia Winkleman host the show together for the final time - was the third most popular programme, with 4.2m tuning in.

They ended the festive special with their "keep dancing!" catchphrase, with Winkleman saying the audience watching over the years had

"meant a world to us".

There was a drop in viewers for EastEnders however, eighth most-watched this year with 2.85m for the first of its two Christmas Day episodes.

The second did not make the viewing figures top 10.

Soaps Coronation Street and Emmerdale, both on ITV1, did not make the top 10 with their Christmas Day episodes.

The BBC's chief content officer Kate Phillips said this was "a timely reminder that shared moments really do still matter even in a world of so much choice".

Forest legend Robertson dead at 72

John Robertson, the Scottish left winger who won two European Cups for Nottingham Forest, has died at 72.

Robertson's ability to deliver a pinpoint cross led to him once being described by legendary Forest manager Brian Clough as "the Picasso of our game".

brains and talent that had been hidden behind the Scot's often unkempt appearance to magnificent effect in Forest's great team of the late 1970s and early 1980s.

Indeed, the left-winger was widely regarded as the most influential player in a team that won the First Division title and the League Cup in their first season after winning promotion in 1977-78.

only the start.

Forest followed this up with the even more remarkable feat of not only winning the European Cup in 1979 against Malmo when Robertson provided the perfect left-wing cross for Trevor Francis' decisive header, but retained it the next year when his goal beat SV Hamburg at the Bernabeu in Madrid.

Robertson was also at the centre of the bitter split between Clough and his long-time managerial partner Peter Taylor in 1983.

Clough never forgave Taylor, who was by then managing Derby County, for signing Robertson on a transfer with a fee to be decided by a tribunal, without informing him of his plans.

To Clough's great regret, the rift was never healed before Taylor died in 1992, aged 62.

Clough often made teasing mention of Robertson's scruffy appearance and knew about his smoking habit, but regarded it as all worthwhile for the magic he provided with his two-footed touch-line-hugging brilliance, measured crossing delivery and his knack of scoring crucial goals.

Robertson had played for Scotland at schoolboy and youth level before joining Forest as a teenager in 1970. He had failed to make an impact

until Clough's appointment, but the great manager saw something he could nurture.

In his autobiography Clough wrote: "Rarely could there have been a more unlikely looking professional athlete... scruffy, unfit, uninterested waste of time... but something told me he was worth persevering with and he became one of the finest deliverers of a football I have ever seen."

He also wrote: "If one day, I felt a bit off colour, I would sit next to him. I was bloody Errol Flynn in comparison. But give him a ball and a yard of grass, and he was an artist, the Picasso of our game."

Clough was idolised by Robertson, who said: "I knew he liked me but I loved him. I wouldn't have had a career without him."

Robertson played in 243 consecutive games between December 1976 and December 1980, and despite the big-name buys such as England goalkeeper Peter Shilton and Francis, Britain's first £1m footballer, he was the player who made Forest tick.

For all the talent elsewhere, Robertson was Forest's fulcrum.

In Forest's first season back in the top flight under Clough in 1977-78, Robertson not only played a vital role

in winning the title, but also scored the winner from the penalty spot against Liverpool in their League Cup final replay at Old Trafford.

It was not just Clough who recognised Robertson's significance, with former team-mate Martin O'Neill saying: "He was the most influential player in Europe for maybe three-and-a-half to four years."

And Forest's captain under Clough, John McGovern, stated: "He was like Ryan Giggs but with two good feet."

All this despite Robertson's own admission that he had no pace and could not tackle.

Clough, however, was not bothered about what Robertson could not do, preferring to give him licence to concentrate on what he could do. It was the perfect footballing marriage of manager and player.

In a famous interview before the 1980 European Cup final against Hamburg, who had England captain Kevin Keegan in their side, Clough was asked about the prospect of their great Germany right-back Manfred Kaltz keeping Robertson quiet.

"We've got a little fat guy who will turn him inside out," said Clough. "A very talented, highly skilled, unbelievable outside-left."

The collection of 69 cars accumulated over more than 50 years has been purchased by Mark Mateschitz, the 32-year-old billionaire heir to Red Bull founder Dietrich Mateschitz.

Though the exact price has not been disclosed, the collection is estimated to be worth around £500 million, and the broker handling the sale confirmed it exceeded any previous transaction in the collectors' car world by a significant margin.

The fleet includes some of the most important racing cars ever built: Ferraris driven by world champions Mike Hawthorn, Niki Lauda, and Michael Schumacher, along with Brabhams raced by Nelson Piquet, Carlos Pace, and Lauda. Among the most famous cars is the Brabham-Alfa Romeo BT46B "fan car," which raced only once, winning the 1978 Swedish Grand Prix.

Kepa the hero as Gunners edge Palace

Kepa Arrizabalaga was the hero as he saved the decisive penalty from Maxence Lacroix to help Arsenal beat Crystal Palace in a shootout Tuesday night and progress to the semi-finals of the Carabao Cup in a game packed with late drama.

The Gunners thought they had won the match when the unfortunate Lacroix scored an own goal in the 80th minute, bundling the ball into his own net when trying to clear after an Arsenal corner.

However, Palace got a dramatic leveller in the fifth minute of stoppage time when Adam Wharton floated in a free-kick and Marc Guehi was the quickest to react to Jefferson Lerma's knockdown to score from close range.

Declan Rice then had a chance to win the match for Arsenal with the last kick of the game, but he could not score past the excellent Walter Benitez.

The stand-in Palace goalkeeper had been their best player throughout the match,

making two excellent saves from Gabriel Jesus to keep the scores level until the latter stages.

The Palace centre-back's night got worse when he stepped up with the score at 8-7 in a high-quality penalty shootout and Arrizabalaga got down well to his right to push the ball away and give Arsenal the win.

The Gunners move into the last four of the competition and will face London rivals Chelsea over two legs for a place in the final.

Mikel Arteta will be pleased that his side managed to get through penalties to reach the semi-finals but the way that his players managed the tie will have disappointed the Arsenal manager.

The Gunners were again far from their best and missed a host of chances before Lacroix's late own goal.

Arteta made eight changes to the side that beat Everton 1-0 at the weekend, with Gabriel

Jesus coming in for his first start in 345 days after recovering from an anterior cruciate ligament (ACL) injury - and the performance felt disjointed.

Even by his own standards Arteta was exceptionally emotional in his technical area, and only became more lively as the game ticked into the final couple of minutes.

William Saliba gave away a needless free-kick in stoppage time which led to the Palace equaliser but fortunately for him, his team-mates

ensured that his mistake did not lead to them exiting the competition.

Arsenal had a small wobble recently, with draws against Sunderland and Chelsea and a loss to Aston Villa, and even though they have started a new run of victories, Arsenal are not near to the levels of performance they set at the beginning of the season.

For Crystal Palace, 2025 has been one of the best years in the history of the club.

With the FA Cup and Community Shield in the

trophy cabinet and a first European campaign under way, things are pretty good in south London.

However, there is the feeling that things could be even better if their top-class manager Oliver Glasner had more options in his squad.

The Palace boss made three changes to the side thrashed at Leeds but the Eagles have started to falter and look tired in recent weeks, as their increased fixture schedule starts to catch-up with their relatively small squad.

Ramsdale no chance as he touched it into the corner.

Benjamin Sesko struck the crossbar before Dalot had a chance to double the home side's lead in the second period, but arriving at speed behind the visitors' defence he could not keep his shot down with only Ramsdale to beat.

Newcastle ended the game camped around their opponents' box.

But the home side stood firm to claim only their second clean sheet of the season, and win without Fernandes for the first time since March 2022.

In contrast, Newcas-

tle have now lost six of their past nine away games.

If someone was going to burst forward and stretch the Newcastle defence, the former Lecce player was generally the man.

His last surge downfield was six minutes into stoppage time - his legs must have been burning - as Manchester United clung desperately to only their second clean sheet of the season.

Manager Howe can rightly point to his own

injuries in justification that Manchester United should not be made a special case.

Yet this was a night when the home side finished with an 18-year-old, a 19-year-old and two 20-year-olds on the pitch, plus Tyrell Malacia who had not played all season and would have been sold in the summer if a suitable buyer had been found.

Despite this - and the fact they had two-thirds possession, more shots and smothered the home penalty area for the last half hour to the extent they had three times as many touches in the opposition box - Newcastle's goal threat was not extensive.

In the end, they just

ENGLAND'S ASHES SHAMBLES

■ Heavy losses, heavier drinking and 'cockiness' - how Ben Stokes's men lost a series in just 11 days

ENGLISH cricket will face a long hard winter of introspection after the national team self-destructed in just eleven days of cricket Down Under.

The Ashes tour of 2025-2026 will be remembered not as a contest, but rather a feeble capitulation marked by a rash of reckless batting, countless missed catches, adolescent binge-drinking and a complete and utter lack of professionalism.

Ben Stokes' men lost the first Test inside two days and although they made it through to day four in the second test and day five in the third, they were still comfortably bean in both, by eight wickets and 82 runs respectively.

The England management have promised to investigate reports of players drinking excessively during a break from the Ashes series in the beach town of Noosa in which numerous eye

witnesses reported seeing marathon drinking sessions from the England stars.

The squad spent four nights on the Queensland coast between the second and third Test and were reportedly day drinking throughout that time.

Although England produced an improved performance in the third Test in Adelaide, Australia won to take an unassailable 3-0 lead and retain the Ashes in the shortest timeframe in a century.

"We'll be looking into seeing what the facts are as opposed to the things that have been embellished or elaborated on," England director of cricket Rob Key said of the tour.

"Headlines can be misleading at times, saying it's a stag do and stuff like that.

"Stories of players drinking six days solid - that's unacceptable."

But former Australia

batter and head coach Darren Lehmann told Australian radio station ABC he spent time with some England players in Noosa.

"They were actually really well behaved. They mixed with the locals and had a good time," he said.

"The reports of them on a stag do are just wrong. I will defend them there.

"I will defend them a little bit because it is a little bit out of order. I didn't see a stag do. I saw people just relaxing and enjoying Noosa for what it is."

England have now gone 15 years without winning a Test series Down Under, and the team can expect criticism to mount. Ever since taking over, Brendon McCullum (head coach) and Stokes (captain) have failed to win a single Test series against the Big Two - Australia and India.

England are already coping with a lot of criticism for coming into

the Ashes "under-prepared", and Sir Geoffrey Boycott has called for the sacking of McCullum as the head coach.

Former England captain Sir Michael Vaughan, added his voice to the fray, writing in The Telegraph: "The whole approach of this England side has been badly exposed on this Ashes tour, and you don't have to look far into history to know that heads will roll after a defeat like this. In the end, with defeat in-

side 11 days, it's the worst I can remember in Australia. England have had a cockiness about them for three years, and the entire cricketing world has wanted to shut them up as a result.

"Aussies are laughing. They can't believe how fragile this team have been given the quality in the side. England have had a message shoved down their throat for four years, that this style would win in Australia. I don't know where that came from.

The only teams I've seen win in Australia have been those willing to do the hard yards, grind the opposition down, and have a bowling unit that bowled with great discipline. We have neither," he added.

The Fourth Test began on Boxing Day at the Melbourne Cricket Ground, and at press time Australia were 46 runs ahead after a wicket-laden opening day in which England were skittled out for just 110.

Gritty United climb into top five with Boxing Day win

Badly depleted Manchester United clung on to climb back into the Premier League's top five as Patrick Dorgu's stunning volley proved enough to beat Newcastle at Old Trafford on Boxing Day.

Missing seven senior players through injury and international duty including skipper Bruno Fernandes, Ruben Amorim's side also lost Mason Mount at half-time.

But despite Newcastle having 66% possession and Lew-

is Hall's thunderous strike bouncing down off the underside of the bar, Eddie Howe's side could not come up with a leveller as their dismal recent form continued.

In fairness, Dorgu's first Manchester United goal was worthy of winning any game.

As Diogo Dalot's long throw was cleared to the edge of the Newcastle area, Dorgu strode confidently forward and hit the loose ball as it dropped, giving goalkeeper Aaron
