■ Former leadership candidate Jenrick defects to Reform after being sacked by Conservatives

Former Conservative shadow minister Robert Jenrick has announced he is joining Reform UK, hours after he was sacked by Tory leader Kemi Badenoch for plotting to defect to Nigel Farage's party.

Jenrick was unveiled at a press conference by Farage, who thanked Badenoch for expelling her former Tory leadership rival and helping "realign the centre-right of British politics".

In a tirade against his old party and former colleagues, Jenrick said the Conservatives "broke" the country, were "rotten" and had "betrayed its voters".

Speaking minutes before he took to the stage, Badenoch said it was a "good day" for the Conservatives and Jenrick was "now Nigel Farage's problem".

dramatic day

Jenrick becomes the second sitting Tory MP - after Danny Kruger in September 2025 - to switch to Farage's party, which has been consistently leading in national opinion polls for months.

It also follows the defection of former Chancellor Nadhim Zahawi this week, and about 20 former Tory MPs to Farage's

party, which now has six sitting MPs in the House of Commons.

Jenrick's switch to Reform UK was the culmination of a dramatic day that started with Badenoch posting a video to announce he had been dismissed from her shadow cabinet and suspended as a Conservative Party member.

In the video, she said: "I was presented with clear, irrefutable evidence that he was plotting in secret to defect in a way designed to be as damaging as possible to his shadow cabinet colleagues and the wider Conservative Party."

Hours passed without a response from Jenrick, as Conservative sources told the BBC his plans had been rumbled after materials, including a defection speech, had been found "lying around".

When Farage appeared at a press conference in Westminster on Thursday afternoon, he said he "had to think very quickly as to how I should respond to

this".

Farage said that, while he had been talking to Jenrick for months, he had not intended to present him as the party's latest Tory defector at the press conference.

'Britain is in decline'

But he thanked Badenoch for what he called "the latest Christmas present I've ever had" before Jenrick walked on stage, following an awkward delay, to join the Reform UK leader.

"It's time for the truth," Jenrick said in his speech. "Britain has been in decline. Britain is in decline."

He added: "Both Labour and the Conservatives broke Britain. And both are now dominated by those without the competence or backbone needed to fix it."

He said the Conservatives were in denial about the state of Britain and called out some of his former shadow cabinet colleagues by name in a string of personal criticisms.

He said shadow chancellor Mel Stride had "oversaw the explosion of the welfare bill" and "blocked the reforms needed" when he was the work and pensions secretary.

'frontline team'

Dame Priti Patel, Jenrick said, had allowed a "million migrants to come here" in what he called "the greatest failure of any British government in the post-war period".

Jenrick - a former housing secretary and immigration minister - served alongside both Stride and

Patel in the Conservative governments led by Boris Johnson and Rishi Sunak.

While Jenrick accepted he had roles in governments that had "failed so badly", he said he had been "let down" by Johnson and Sunak.

Questioned by journalists, Jenrick said he had already "resolved to leave" the Conservatives before his sacking, saying it was something he had "given a great deal of thought to over a very long time".

He said he would not resign to force a by-election in his Newark constituency and stand as a

Reform UK candidate.

He also had no ambitions to lead Reform UK, he said, telling reporters "I want Nigel to be prime minister".

Farage said Jenrick "will be joining our frontline team", without specifying his role.

The Reform UK leader said the local and national elections on 7 May represented a "deadline" after which no further Tory defections to Reform would be accepted.

It appears Jenrick was bounced into the move to Reform UK by Badenoch.

PM won't rule out social media ban for the young

■ Britain expected to follow Australia's lead on issue

Prime Minister Sir Keir Starmer has not ruled out banning British under-16-year-olds from social media, saying "all options are on the table".

He said more needed to be done to protect children from social media and that he was watching "what is happening in Australia" where a ban has been recently introduced.

Privately, many Labour MPs and officials have said they expect the UK government to follow

Australia's example.

Next week, the House of Lords is set to vote on proposals for a ban, which, if passed, could see pressure grow on the government to act.

"addictive"

Last week, the Conservatives announced they would block under-16s from social media platforms, as well as prohibiting smartphones in schools, if they won the next election.

Tory party leader Kemi

Badenoch said "addictive" social media apps "correlates quite strongly" with a rise in mental health problems among young people.

Labour Greater Manchester Mayor Andy Burnham has said he agrees with "a lot of what Kemi Badenoch is saying" on social media use.

Earlier this week, Meta announced it had blocked about 500,000 accounts on its sites including Facebook and Instagram during its first week of

compliance with the new law in Australia.

Asked if he would back a ban in the UK, Sir Keir said: "We need to better protect children from social media.

"We're looking at what is happening in Australia - all options are on the table in relation to what further protections we can put in place - whether that's under-16s on social media

or an issue I am very concerned about, under fives and screen time.

"Children are turning up age four at reception having spent far too much time on screens."

Fresh demands to boot Mandy out of Lords

■ Former Ambassador to US refuses to apologize to Epstein victims

LABOUR faces fresh demands to boot Peter Mandelson out of the Lords after he refused to apologise to victims over his friendship with Jeffrey Epstein.

The former US ambassador and cabinet minister had previously described the convicted paedophile as his "best pal".

Offered the chance to say sorry to the victims for his association with Epstein the peer refused, saying he would apologise only for "a system" which let them down.

Speaking in his first

interview since being sacked as the UK's ambassador to the US, the Labour grandee told BBC's Laura Kuenssberg show: "I want to apologise to those women for a system that refused to hear their voices and did not give them the protection they were entitled to expect."

Pressed on whether he would apologise for his friendship with Epstein after the financier's conviction, Lord Mandelson said: "If I had known, if I was in any way complicit or culpable, of course I would apologise. But I

was not culpable, I was not knowledgeable for what he was doing.

"And I regret, and will regret to my dying day, the fact powerless women were not given the protection they were entitled to expect."

In an awkward moment, he challenged Ms Kuenssberg over suggestions that he knew of allegations around Epstein.

He said: "Do you really think that if I knew what was going on and what he was doing with and to these vulnerable young

women, that I'd have just sat back and moved on and said, 'Okay, that's his that's his life'? I'd have done that?"

"Do you think I'd have written emails like that if I had any knowledge or suspicion of what he was doing?"

The peer also strongly implied he disagreed with his sacking by Sir Keir Starmer.

The interview was met with anger from the government with Transport Secretary Heidi Alexander saying Mandelson should have apologised.

The SNP's Stephen Flynn lashed out at the peer's remarks and said he should be kicked out of the Lords. He said: "Says he had no knowledge of what Epstein was doing when he maintained he [had] friendship with his 'best pal'.

"Yet knew Epstein had been convicted of soliciting prostitution from a minor. Why are Labour continuing to allow this man to sit in the House of Lords?" He added: "He should have been stripped of that title months ago. The fact this hasn't happened is a stain on this deplorable Labour government."

Crackdown On Shocking AI 'weapons of abuse' Images

Creating non-consensual intimate images was made a criminal offence in the UK this week,

The government will also criminalize apps which allow users to create fake nude images of people.

Technology Secretary Liz Kendall labelled AI-generated images of women "tied up and gagged, with bruises, covered in blood and much, much more" as being "weapons of abuse".

Speaking in the Commons on Monday, Ms Kendall said the Internet Watch Foundation also "reports criminal imagery of children as young as 11, including girls sexualized and toddlers". Referring to the fakes, she added: "Lives can and have been devastated by this content, which is designed to harass, torment and violate people's dignity."

Media watchdog Ofcom has launched a probe into whether Elon Musk's social media platform X has breached UK law after reports its AI chatbot Grok was used to create and share sexualised images of children.

Grok launched a new image generation feature

in July last year and its use for creating nude fake images has become widespread over the past few weeks.

Downing Street has indicated that it is willing to consider banning X if the tycoon's company did not act, and PM Sir Keir Starmer said that if X cannot control Grok, "we will". He added: "The actions of Grok and X are absolutely disgusting and shameful."

Mr Musk accused the government of trying to curb free speech - a fear echoed by Reform UK leader Nigel Farage.

Tory leader Kemi Badenoch said banning X is "the wrong answer".

Another week, another U-turn

LABOUR is set to abandon plans for mandatory digital IDs in what the Tories branded “yet another humiliating U-turn”.

Sir Keir Starmer said the scheme would be compulsory to work in the UK when he announced it last year as part of efforts to tackle the small boats crisis.

But it will now reportedly be voluntary when it is introduced in 2029.

Shadow Cabinet Office minister Mike Wood said: “Keir Starmer’s spinelessness is becoming a pattern, not an exception.”

“What was sold as a tough measure to tackle illegal working is now set to become yet another costly, ill-thought-out experiment abandoned at the first sign of pressure from Labour’s backbenches.”

Reform UK leader Nigel Farage pledged that his party would scrap digital ID altogether.

He said: “This is a victory for individual liberty against a ghastly, authoritarian government.”

A government source said that the compulsory element “was stopping conversation about what digital IDs could be used for generally”. They told The Times: “Stepping back from mandatory-use cases will deflate one of the main points of contention. We do not want to risk there being cases of some 65-year-old in a rural area being barred from working because he hasn’t installed the ID.”

The U-turn comes after almost three million people signed a petition on the official Parliament website against the introduction of digital ID. A YouGov poll also showed public support for the idea has plummeted.

Every cent you make: Sting pays out \$800k.. but former bandmates want much more

■ Unpaid digital royalty shares amount to almost \$13m, claim lawyers for Copeland and Summers

Sting has paid his former bandmates in The Police more than half a million pounds after acknowledging underpaying royalties, court documents show.

In a filing at London’s High Court, the musician’s lawyers said Andy Summers and Stewart Copeland received a payment of “over \$800,000” (£595,000) after they launched legal proceedings last year.

The pair sued Sting and his publishing company in September, claiming they were owed between \$2m (£1.5m) and \$10.75m (£8m) in royalties for hit songs like Roxanne and Every Breath You Take. At a hearing on Wednesday, their lawyers said their claim could rise above £8m.

‘oral agreement’

Sting denies that they are entitled to a portion of his income from streaming and download sales.

His bandmates did not receive writing credits on most of The Police’s hits, but argue that the group entered an “oral agreement” to share income in 1977, which was later formalized in written contracts.

The agreement acknowledged that, although Sting was the chief composer, the other two members sometimes made crucial contributions - such as Summers’ guitar line on Every Breath You Take.

As a result, the trio decided that when any of them received publishing income for a song they had written, they would share a percentage of that money - usually 15% - with the other two members, in what was termed an arrangers’ fee.

Summers and Cope-

land argue he has withheld some of those payments.

None of the band members were in court for the start of the two-day preliminary hearing on Wednesday.

But lawyers for guitarist Summers and drummer Copeland are asking the court for permission to bring new and additional arguments that they are owed money from all downloads and streaming income, under the terms of their prior agreements made in 1997 and 2016.

They say the language of those agreements should be interpreted in light of changes to the music industry, where streaming income has largely replaced the sale of vinyl, CDs and cassettes.

In court papers, they acknowledged a recent payment from Sting and his publishing company, disclosing a figure of \$870,000 (£647,000), but noted that no interest had been added to the “historic underpayment”.

Speaking in court on Wednesday, the musicians’ lawyers said the total value of their claim was “not less than £8m” and “will be considerably larger” if their amended case is allowed to proceed.

trial expected

Meanwhile, Sting’s lawyers argue that he shouldn’t have to give his former bandmates royalties when The Police’s music is played on streaming services like Spotify because that counts as “public performance” rather than a sale.

Furthermore, they say Summers and Copeland are not eligible for royalties from streaming and digital sales because their 2016 agreement only

allows for royalty payments derived “from the manufacture of records”.

They added that the musicians’ attempt to amend their case should be thrown out as it has “no real prospect of success”.

The hearing, before

Mr Justice Bright, is due to conclude on Thursday, with a trial expected at a later date.

The Police formed in 1977 and quickly became one of the UK’s most successful bands.

Their innovative fusion of rock guitars with

reggae rhythms spawned chart-topping hits like Message in a Bottle, Walking on the Moon and Every Little Thing She Does is Magic.

However, The Police split up in 1984 amid personal and musical animosity.

Health inspectors ‘don’t understand food’, says Michelin-starred chef given raw deal over hygiene rating

A Michelin-star chef has hit back at food inspectors for not understanding sashimi after his kitchen was handed a one-star hygiene rating.

Officials said ‘major improvement’ was required at Wales’ first two-Michelin star restaurant Ynyshir, near Machynlleth in Ceredigion, after an inspection raised concerns over the ‘cleanliness and condition’ of facilities.

A report on November 5 found the hygiene of food handling was ‘generally satisfactory’ but the £468-a-head dining experience fell short in its ‘layout, ventilation, hand washing facilities and pest control’.

A particular concern was voiced over the ‘management of food safety’.

But head chef Gareth

Ward, who has starred as a guest judge on the highly popular British TV show MasterChef: The Professionals has hit back at the findings.

He claimed the low score was partly down to the fact inspectors don’t understand the luxury restaurant’s use of raw ingredients, such as sashimi and dry-aged fish.

Mr Ward defiantly said: ‘We buy in the best ingredients from around the world and a lot of it I serve raw.’

‘I’m buying sashimi-grade fish from Japan and they’re questioning, “Well, we don’t know the water, so how do we know it’s sashimi grade?”

‘Well, it is sashimi grade, this stuff’s eaten raw all over the world, and just because our rules don’t fit their rules, they’re questioning it.’

Ward, 45, also has a Saltan salt chamber, used for his 300-day-old dry-aged Welsh wagyu beef - also among the ingredients that he claimed came under scrutiny.

‘They (the inspectors) obviously don’t like the idea of ageing stuff’, he said.

Ward added: ‘I’m not sat here thinking “Oh my God, I’m embarrassed, I’ve done something wrong”, because we haven’t. What we have done is something different.’

The 30-course dinner experience takes up to five hours to enjoy at the hideaway restaurant in the Welsh countryside.

Diners can opt for the ‘full experience’ at the restaurant and stay the night for an additional £330 for the cheapest room or £714 for the garden room.

Lift off for Amazon as drone flights begin in UK

Amazon has started to test drone flights ahead of launching its UK airborne delivery service later this year.

The US tech giant has begun "a limited number of flights" from its base in Darlington but has not yet launched a delivery service for customers.

Amazon announced a year ago that the town would be its test centre.

The firm said in a new statement: "We can confirm we have commenced a limited number of Prime Air drone flights out of our Darlington fulfilment centre in Symmetry Park.

"Deliveries are not yet being made but the service is expected to officially launch in 2026.

"This marks an exciting next step in bringing drone delivery to the UK, and we continue to work closely with Darlington Council and the Civil Aviation Authority."

When Amazon launches the service, eligible customers in Darlington will be able to receive their items within two hours, as long as the package weighs less than 5lbs.

The firm will use its MK30 drone, fitted with sophisticated tech to avoid obstacles and ensure "the safety of people, pets and property".

David Carbon, VP of Prime Air, said: "Our MK30 drones are designed to operate quietly and efficiently.

"We look forward to demonstrating how this innovative technology can serve the people of Darlington while maintaining the highest safety standards."

Amazon said that as the drone descends for delivery, its onboard systems identify and steer clear of obstacles such as clothes lines or trampolines – items that might not appear in satellite maps.

Serial rail fare evader faces jail over 112 unpaid tickets

One of Britain's most prolific rail fare dodgers could face jail after admitting dozens of travel offences.

Charles Brohiri, 29, travelled without buying a ticket on Govia Thameslink train journeys a total of 112 times, Westminster Magistrates' Court heard this week.

He could be ordered to pay more than £18,000 in unpaid fares and legal costs, the court was told.

District Judge Nina Tempia warned Brohiri "could face a custodial sentence because of the number of offences he has committed".

Brohiri, from Hatfield in Hertfordshire, was dressed in black as he pleaded guilty to 76 offences on Thursday.

Each offence was read out to him, with Brohiri quietly and repeatedly replying "Guilty" for around 20 minutes.

It came after he was convicted in his absence of 36 charges at a previous hearing.

During Thursday's hearing, Judge Tempia dismissed a bid by Brohiri's lawyers to have the 36 convictions overturned.

They had argued the prosecutions were unlawful because they had not been brought by a qualified legal professional, but by a lay prosecutor.

But Judge Tempia rejected the argument, saying there had been "no abuse of this court's process".

In a written ruling setting out her decision, she said she agreed that "a lay prosecutor can commence proceedings".

She added there has been an "industry-wide use of non-authorized employees to lay information which has been a long-standing process".

A Govia Thameslink Railway spokesperson welcomed the decision to uphold the previous 36 convictions.

The 112 charges span from February 2024 to November 2025. They relate to journeys between London and Brighton, and on the Thameslink lines into Hertfordshire and Bedfordshire.

In addition, Brohiri is

also accused of continuing to dodge fares in late November and December last year, and in January, prosecutor Lyndon Harris told the court.

The most recent allegation was three days ago - on 12 January, he said.

At a previous hearing in August last year, Brohiri was bailed and told "not to be present on or attempt to gain access to

any train owned or operated by Govia Thameslink".

He was bailed on the same conditions as imposed at previous hearings, to return for sentencing on 11 February.

In addition, he is accused of failing to pay fines worth £48,682 from separate prosecutions between August 2019 and April 2025.

2027 Tour De France to kick off in British cities

■ News underlines huge growth of cycling's popularity in the UK over recent decades

The world of cycling is bracing for a monumental milestone.

13 days later, remote Welsh village finally welcomes the New Year

■ The folk of Cwm Gwaun still proudly follow the Julian Calendar

In one remote valley in Pembrokeshire time really does move slowly.

In fact, the residents of Cwm Gwaun are 13 days behind the rest of us in celebrating the New Year.

No, they haven't mixed up their dates, this community still celebrates the New Year according to the old Julian Calendar, which was replaced by the Gregorian Calendar in 1752 to fall in line with most of Europe.

The move - which

saw Britain and its empire skip nearly two weeks overnight - proved controversial, and generations of non-compliance means Hen Galan, which is Welsh for "old New Year", is still celebrated in the Gwaun Valley.

It sees children walking door-to-door from dawn until dusk singing traditional Welsh songs in exchange for gifts known as "calenig".

After wishing the householders good fortune for the rest of

the year with a new year's greeting, usually in song and verse, the children are then given a small gift of money or sweets. Originally, this was food to help sustain families through the hard months of winter. Anyone who has the audacity to ignore the children's good wishes is destined a year of bad luck or, as the Cwm Gwaun community labels it, 'llondty o fwg' (a houseful of smoke).

Farmers also open their homes to the

community for feasts in a peculiarly Welsh tradition which remains as popular as ever.

The Gregorian calendar modified the use of leap years as a means to keep more accurately to the revolution of the Earth around the sun. Catholic countries were more inclined to accept the reform while Protestant Britain clung to its traditions until the middle of the 18th century.

As the Julian calendar gained a day every 128 years, by the mid 18th century Britain

found herself 11 days ahead of her continental neighbours which naturally resulted in confusion and complications for trade and diplomacy.

So from 1752 onwards, the Calendar Act resulted in the new year starting on January 1 rather than on March 25, as had previously been the custom. The tax year, incidentally, which begins on April 6, is the old date for the previous new year of March 25, with the missing 11 days added on.

Another ancient

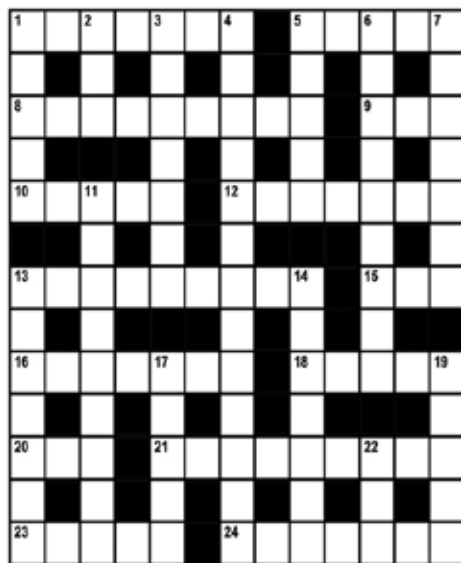
Welsh custom to mark the Julian new year is the Mari Lwyd, where a horse's head is paraded around on a pole decorated with ribbons and bells. In bygone years, this would have been a real horse's skull, whereas in more recent years it is a wooden effigy covered in white cloth.

Mari Lwyd' is translated as 'grey mare', connecting the traditional to the heritage of the pale horses in Celtic and British mythology, many of which crossed over to the underworld.

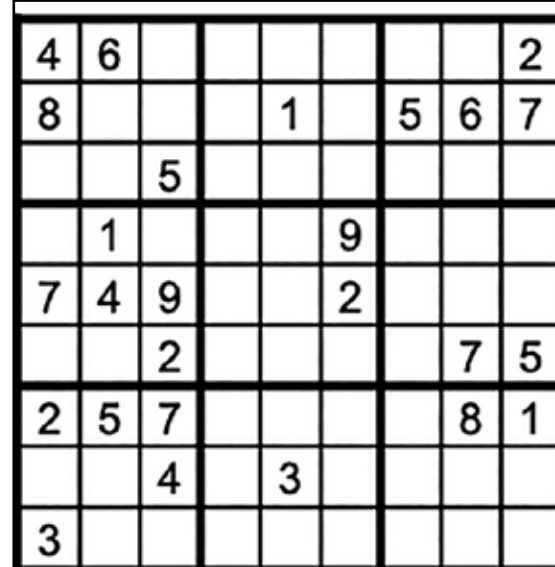

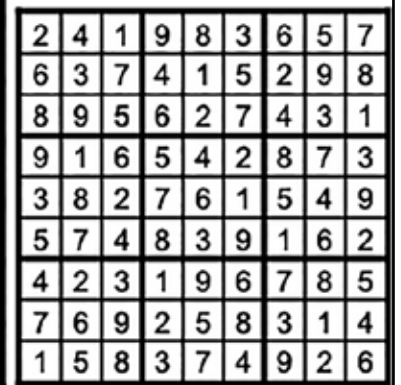

Gallagher left the Blues for Atletico in August 2024 for about £33m, with Portugal forward Joao Felix - who has since left Chelsea - moving the other way.

"I'm so happy and excited to be here, taking the next step in my career at an amazing club," said Gallagher.

Gallagher has 22 caps for England but has played only once under current boss Thomas Tuchel, featuring for 59 minutes in a 3-1 friendly defeat by Senegal.

'top midfielder'

He will hope a move back to the Premier League and impressing in Thomas Frank's side will boost his chances of making England's squad for this summer's World Cup.

Gallagher was an unused member of the squad at the 2022 tournament, but made five appearances during the 2024 Euros cam-

paign, where the Three Lions were beaten in the final by Spain.

"Conor has captained teams so will bring leadership, maturity, character and personality to our dressing room, while his running power, pressing ability and eye for goal will strengthen us in a key area of the pitch," said Spurs boss Frank.

"He is a top midfielder, who we have worked tirelessly to add to our squad...He is still young, so has plenty of room for improvement, but also has huge experience across the Premier League, La Liga and with the England national team."

Spurs had been looking to add to their midfield options after Rodrigo Bentancur was ruled out for at least three months.

The Uruguay international needs surgery after sustaining a hamstring injury in the 3-2 Premier League defeat by Bournemouth last

week.

Spurs are 14th in the table on 27 points after 21 games and have had a run of poor form in which they have won just one of their last six league matches.

They remain in contention for automatic qualification for the Champions League, with Spurs currently 11th in the standings, but they were beaten by Villa in the third round of the FA Cup last Saturday - a seventh defeat in 13 games across all competitions.

'amazing club'

They next host strugglers West Ham in the Premier League on Saturday.

Gallagher started his career at Chelsea as a youngster in 2006 and during his professional career there he had loan spells at Charlton, Swansea, West Brom and Crystal Palace.

He made 136 Pre-

mier League appearances in total - for Chelsea, West Brom and Palace - before joining La Liga side Atletico, who he represented 77 times across all competitions, scoring seven times.

Conor Gallagher says his decision to join Tottenham proved "very easy" and the midfielder has been hailed as a player of "huge experience" by Spurs boss Thomas Frank.

On the completion of a £35m switch from Atletico Madrid, Gallagher, 25, said: "I'm so happy and excited to be here, taking the next step in my career at an amazing club. I wanted to be a Spurs player and thankfully the club felt the same. It was very easy, it happened very quickly and I'm ready to get on the pitch.

"I know how great the fans are, I'm really happy to be a part of it here and want to create special moments and memories together."

dared to dream once more - but there was to be no grandstand finish for the hosts this time.

This time Cherki landed what felt like a mortal blow in the 98th minute as Newcastle supporters streamed out.

What a contrast to the scenes before kick-off.

The home fans certainly believed as a huge flag display depicted the Wembley arch above a banner, which read "Gannin' Alang Wembley Way".

The noise was raucous.

Trafford, who turned down a move to Newcastle to return to Manchester last summer, was booed mercilessly throughout. Throw-ins and corners were celebrated. The roar that greeted Semenyo's goal being disallowed was deafening in the second half.

Howe knew his side had to feed off it and take something back to Manchester next month.

There was a different dynamic to this game, as a result, compared to previous semi-finals when Newcastle went away first, in 2023 and 2025, before finishing the job off at a febrile St James'.

But this was ultimately a case of what might have been for Newcastle on a night they fired a rare blank.

An almighty challenge now awaits.

Newcastle have only ever won once at the Etihad, and Howe's side have yet to even score in the stadium since he took charge in 2021.

This team are going to have to finally overcome that hoodoo - and some - to return to Wembley.

"We're still alive," Howe said. "We're still in there fighting. It's very difficult to turn it around but it's still possible and football can conjure up some magical moments."

Rising star Carrick named United caretaker manager

■ Long-serving midfielder considered a safe pair of hands after tumultuous Amorim era

Manchester United have appointed former player Michael Carrick as their caretaker head coach until the end of the season.

Carrick will be assisted by former England number two Steve Holland, with Jonathan Woodgate, Jonny Evans and Travis Binnion also part of his staff.

Former United midfielder Carrick, 44, had a three-game stint as United's temporary boss after Ole Gunnar Solskjaer's dismissal in 2021.

He will be back in the Old Trafford dugout for Saturday's Premier League derby against Manchester City.

United sacked Ruben Amorim on 5 January after 14 months in charge, and Darren Fletcher took charge as caretaker boss for two matches.

"It's an unbelievable feeling to come back through the doors and be part of the club again," Carrick told the in-house Inside Carrington podcast.

"It's a big responsibility, a massive pleasure and a privilege to be here, but we want to do a good job - this place deserves that".

Carrick added he "might have to play certain ways" in order to win games but insisted he wants his side to show "a really exciting

type of football, be positive and express and bring excitement".

"I want to be off my seat, I want to be enjoying watching the boys play and results obviously need to come with that," he said.

Carrick held face-to-face talks with United officials last Thursday and is understood to have impressed chief executive Omar Berrada and director of football Jason Wilcox with his vision for the team.

He is set to play a 4-2-3-1 formation - a move away from the three-at-the-back set-up employed by Amorim.

Norwegian Solskjaer, who has played for and managed United, also held talks with the club about the vacancy.

But Carrick has been chosen as he is more of a hands-on coach than Solskjaer.

Fletcher, who took charge of the games against Burnley and Brighton immediately after Amorim's exit, will return to the under-18s.

United view him as a key part of their coaching staff moving forward but it was mutually agreed a return to the under-18s is best to continue his development.

Holland worked under Gareth Southgate



Michael Carrick is expected to implement a 4-2-3-1 system at United

when England finished fourth at the 2018 World Cup and were runners-up at Euro 2021 and 2024.

He spent several years with Chelsea, where he had major success under a number of managers.

The 55-year-old was sacked as manager of Japanese club Yokohama F Marinos in April after only four months in charge.

Woodgate worked under Carrick at Middlesbrough and was a team-mate of Wilcox at Leeds. He managed Boro between 2019 and 2020, and had a short spell as

Bournemouth manager in 2021.

Former United defender Evans returns to Old Trafford, while Binnion was already part of the club's coaching staff.

The feeling that Carrick arguably provides greater hands-on coaching expertise than Solskjaer was at the heart of why United decided to take the path they have.

Both candidates impressed during talks, and both made absolutely clear their interest in replacing Amorim was in order to help a club they hold so dearly to their hearts out of its cur-

rent difficulties.

The potential for Solskjaer to again inspire a squad so clearly in need of a pick-me-up - as he did when he initially replaced Jose Mourinho on an interim basis in 2018 - was a key consideration for United chiefs.

But the sense that coaching was at the heart of Carrick's appointment ultimately became one of the overriding factors behind the decision.

Carrick - during his relatively short managerial career - has developed a reputation as one of Britain's most adept young coaches.

and William Saliba also sent shots either wide or over.

After Chelsea fell 2-0 behind, new head coach Liam Rosenior introduced Garnacho, who pulled one back by guiding Pedro Neto's cross into the net. However, Zubimendi skipped past both Andrey Santos and Wesley Fofana before finishing from just inside the box to restore Arsenal's two-goal cushion.

Garnacho remarkably reduced the deficit again, and Estevao saw an excellent effort from the edge of the box saved, while Gabriel Magalhaes and Mikel Merino both had chances to further extend Arsenal's lead.

Arsenal, who scored their 18th goal from a corner and 24th from set-pieces across all competitions this season, are now unbeaten in 10 matches. Chelsea, meanwhile, have won just three of their past 13 games, with Rosenior losing his first home match, having

replaced Enzo Maresca last week.

Such was the importance of this fixture that Rosenior had been planning for it even before Chelsea's previous match against Championship side Charlton in the FA Cup.

The new head coach wanted to be ready for a major test against the Premier League leaders, who have lost only two games in all competitions this season.

Having focused on mentality and intensity when preparing for an

FA Cup tie against second-tier opposition, this was the first genuine tactical examination for the former Strasbourg head coach.

However, none of his injury doubts - Cole Palmer, Reece James or Malo Gusto - were able to feature on the night. In addition, Liam Delap and Jamie Gittens withdrew through illness shortly before kick-off, while Moises Caicedo was suspended.

Despite those absences, Chelsea competed with Arsenal in the first half,

but fell behind as Sanchez failed to deal with a cross.

Conceding a second set-piece goal inside Rosenior's first two matches, with Sanchez again at fault for the second, will be frustrating and may prompt questions about the goalkeeping situation.

Yet with fans chanting against the club hierarchy and in favour of former owner Roman Abramovich, there remain a host of issues beyond Rosenior's control that could affect Chelsea not just in the EFL Cup, but across the competitions still to come.

Antoine Semenyo and Ryan Cherki both scored as Manchester City took control of their Carabao Cup semi-final against holders Newcastle United on Tuesday night.

Semenyo completed his £65m move from Bournemouth barely a week ago, but the new arrival has already made a huge impact.

After netting one and setting up another on his debut, in the club record-equalling 10-1 rout against Exeter City at the weekend, the forward

stepped up with a crucial opener in the first leg of this semi-final at St James' Park.

Semenyo, who later had a goal disallowed, was in the right place at the right time to convert at the back post after Jeremy Doku's cross was hooked on by Bernardo Silva.

No wonder Newcastle head coach Eddie Howe rued how Semenyo was eligible to play on Tuesday night following a rule change - despite already featuring for Bournemouth earlier in the

competition.

But Newcastle's evening got worse deep into stoppage time when substitute Cherki doubled his side's advantage after lashing the ball into the net.

Newcastle were left to curse the lack of a killer finish after the hosts created a number of opportunities to open the scoring.

Manchester City goalkeeper James Trafford clawed Yoane Wissa's looping header away before Newcastle captain Bruno Guimaraes struck

the bar with a rasping effort just seconds later.

Wissa also had a golden chance to put his side in front early on - only to scoop the ball over the bar from close range.

But it was Manchester
