Hollywood hunk Elba leads the New Year Honours as Lionesses and ice legends Torvill and Dean are showered with gongs

HE IS the East End boy who conquered Hollywood, but now Idris Elba has bagged his most prestigious role yet - as a Knight of the Realm.

The Luther star leads a star-studded New Year Honours list that proves Britain is still top of the class, with a staggering 1,157 heroes recognized

for their service to the nation. Sir Idris, 52, was honored not just for his glittering screen career, but for his "heart of gold" charity work, including a fierce anti-knife crime campaign and his Elba Hope Foundation.

In a touching nod to his humble roots, the actor - who first found fame in the gritty US drama *The Wire* - recalled how a £1,500 grant from the Prince's Trust as a teenager allowed him to attend the National Youth Music Theatre. Without that helping hand, the world might never have seen his powerhouse performances in *Beasts of No Nation* or his portrayal of Nelson Mandela.

Standing tall as a beacon of British excellence, Sir Idris remained modest as the news broke. "I receive this honour on behalf of the many young people whose talent, ambition and resilience has driven the work of the Elba

Hope Foundation," the new Sir Idris declared, dedicating the moment to the disadvantaged youngsters his foundation supports across the UK, the US, and Africa.

Lionesses Roar

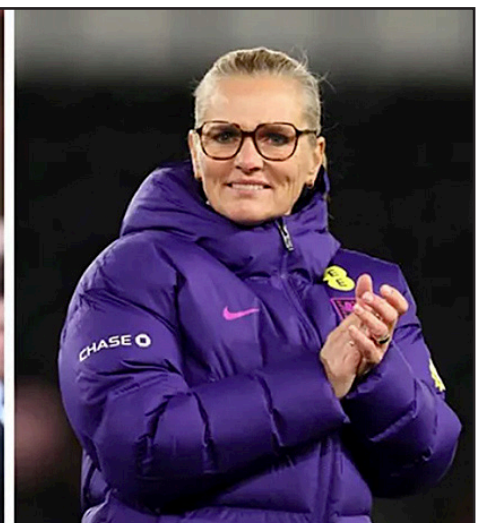
It wasn't just Tinseltown taking the glory. The history-making Lionesses have been rewarded for their sensational European Championship victory that set the nation's hearts racing last summer. The tactical mastermind behind the success, coach Sarina Wiegman, is made an honorary Dame, cementing her status as one of the greatest minds in the game.

But the honors didn't stop with the dugout. The "Golden Girls" of the pitch were showered with accolades for their "contributions to the triumph." Captain and two-time European champion Leah Williamson - the face of a new generation of

sporting icons - leads the charge with a CBE. Joining her in the royal winner's circle are the stars who kept us on the edge of our seats: Ella Toone, Keira Walsh, Alex Greenwood, and Georgia Stanway have all been awarded MBEs. The list of OBEs reads like a "Who's Who" of the small screen. Star Wars and Harry Potter star Warwick Davis is recognized for his services to drama, while the ever-polished Gabby Logan is honored for

Justice & the Arts

Beyond the bright lights of celebrity, the list highlights those who have fought for what is right. An OBE goes to Betty Brown, the tireless campaigner who has spent years fighting for justice for those caught up in the Post Office wrongful prosecution scandal. Starmmer vows to 'defeat decline'

PM promises lower bills and brighter days – but his critics insist Britain is still going backwards

Sir Keir Starmer has vowed to “defeat the decline and division offered by others” as he struck an upbeat tone in his New Year message, insisting 2026 will finally be the year voters start to feel “positive change” in their everyday lives.

Admitting that “things have been tough in Britain for a while”, the Prime Minister said the public should now begin to see tangible improvements – from lower household bills and frozen rail fares to more police on the streets and new neighbourhood health hubs.

But the optimistic pitch comes after a bruising year for Sir Keir, marked by slowing economic growth, stubbornly poor poll ratings and simmering Westminster speculation over his long-term grip on the Labour leadership.

In his address, the PM acknowledged public frustration at the pace of reform but urged patience, arguing the problems facing the country

had been “decades in the making”.

“Renewal is not an overnight job,” he said. “By staying the course, we will defeat the decline and division offered by others.”

‘positive change’

Sir Keir promised that over the next 12 months life would “start to feel easier”, pointing to a raft of measures including frozen rail fares, prescription charges and fuel duty, alongside increases to the minimum wage.

“In 2026, the choices we’ve made will mean more people begin to feel positive change in your bills, your communities and your health service,” he said.

He added that beyond financial relief, voters would also regain “a sense of hope” and belief that “things can and will get better”, insisting his government would turn the “promise of renewal” into reality.

The Prime Minister’s message was swiftly challenged by rivals

across the political spectrum.

Conservative leader Kemi Badenoch delivered a stinging verdict on the past year, saying 2025 had brought “no growth, higher taxes and record unemployment” under Labour.

However, she insisted Britain was “not destined for decline”, claiming the Tories had a plan to “back business and fix our economy” in order to properly fund the armed forces, police, schools and the NHS.

‘gloomier and poorer’

As parties look ahead to May’s crucial local elections, the political temperature is already rising. The contests will span thousands of council seats in England, as well as elections to the Scottish Parliament, the Welsh Senedd and a handful of powerful directly elected mayors.

Liberal Democrat leader Sir Ed Davey said his party could “win again in 2026” following what he called “record-breaking success” at the last set

of local elections.

He vowed to “stop Trump’s America becoming Farage’s Britain” and promised to “change our country for the better”.

Reform UK leader Nigel Farage, whose party has topped national opinion polls since last spring, struck an even more apocalyptic note. He warned Britain was becoming “gloomier” and “poorer”, with unemployment rising and national debt “running completely out of control”.

Farage described the May elections as “the single most important set of elections between now and the next general

election”, accusing both Labour and the Conservatives of failing to grasp the “new world” of cryptocurrencies, artificial intelligence and digital assets – which he branded “the technologies of growth”.

The Green Party also weighed in, with co-deputy leader Rachel Millward pledging to do “everything we can to stop Nigel Farage getting anywhere near Downing Street”.

Her fellow co-leader Mothin Ali claimed the Greens had gained 110,000 new members since the summer, declaring: “We’re here to replace Labour.”

In Scotland, SNP leader and First Minister John Swinney struck a more reflective tone, acknowledging that the past year had been “difficult” for many amid global “conflict and upheaval”.

Looking ahead, he said he would be raising a glass to Scotland’s memorable World Cup qualification victory over Denmark, while also looking forward to the tournament itself and the Commonwealth Games in Glasgow later this year.

With bold promises, dire warnings and political point-scoring already flying, the battle lines for 2026 – and beyond – are firmly drawn.

Farmers chew over great beef battle

Trump’s ‘Prosperity’ Deal kicks in this week - but is it a ‘Golden Age’ for Britain or a high-stakes gamble for our farmers?

British farmers noted the passing of the New Year this amid further concerns that the Special Relationship is being ground further into mincemeat.

January 1st saw a complex new trade pact with Donald Trump’s America officially came into force and while the deal is intended to open the gates for British beef to cross the Atlantic, industry leaders are already questioning whether the Prime Minister has been outmanoeuvred by Washington’s formidable negotiating team.

Billed by Downing

Street as a “strategic milestone,” the Economic Prosperity Deal (EPD) marks the first significant post-tariff agreement between the UK and the returned Trump administration.

The agreement, which became legal at the stroke of midnight, aims to soften the blow of the 10% universal tariff imposed on all British goods by the White House last spring.

At the heart of the deal is a reciprocal trade-off that has caused a stir across the British countryside. For the first time, British ranchers have a guaranteed 13,000-tonne

quota for high-quality, grass-fed beef to be sold in premium US markets.

Supporters claim this is the “crucial opening” the industry has needed to diversify away from European markets. In return, however, the UK has agreed to accept 1.4 BILLION litres of US bioethanol, a move that has left the domestic green-fuel industry fearing for its future.

“It is a classic American-first trade,” one senior Whitehall source admitted. “They have given us a foothold for our premium beef, but in ex-

change, they've secured a massive outlet for their agricultural surplus."

While the deal offers specific "carve-outs" for certain sectors, the reality for many British businesses remains challenging. Despite the optimistic New Year launch, the vast majority of UK exports -from high-end Scotch whisky to precision machinery- remain subject to the baseline 10% "restoration" tariff.

'pawn'

The National Farmers' Union (NFU) has reacted with a blend of cautious optimism and concern. NFU President Tom Bradshaw warned that British agriculture cannot afford to be a "pawn" in wider geopolitical shifts.

"While access to the US market is a welcome development, we must be clear-eyed," he said.

"The US is still seeking significantly greater concessions, and we must ensure our high welfare standards are never traded away for a short-term diplomatic win."

tax bill

British car manufacturers are also navigating a "bittersweet" start to the year. Under the new agreement the first 100,000 British vehicles sent to the US will benefit from a "reduced" 10% rate but any vehicle exceeding that limit could face a steep 25% TAX if negotiations don't progress by autumn.

Industry experts have branded the current quota "conservative," warning that Britain's most successful automotive plants may have to carefully manage their exports to avoid a massive tax bill later in the year.

In Washington, the mood is one of triumph. President Trump took to social media on Thursday to hail the deal as the start of a "new dawn" for the American heartland.

Shamima Begum and British citizenship: Government vows to fight European court

Human rights court quizzes UK over stripping ISIS bride of citizenship

The European Court of Human Rights has waded into Britain's most toxic national security row by questioning the UK's decision to strip ISIS bride Shamima Begum of her British citizenship.

Judges in Strasbourg have asked the Home Office to explain whether it failed in its duty to treat Begum as a potential victim of child trafficking when she fled the UK to join Islamic State in Syria.

The move has handed fresh hope to Begum's legal team - and sparked fury among Tory and Reform figures, who accuse foreign judges of meddling in British justice and renewing calls for the UK to quit the European human rights framework altogether.

refugee camp

Begum was just 15 when she left her east London home in 2015, travelling with two school friends to territory controlled by the brutal Islamist death cult. Within weeks she was "married off" to an ISIS fighter and went on to have three children, all of whom later died in infancy.

In 2019, then home secretary Sajid Javid stripped her of British citizenship on national security grounds after she was discovered in a Syrian refugee camp. That decision was upheld by the Court of Appeal last year and remains the position of the current government.

Now 26, Begum is effectively stateless and remains stuck in a camp in northern Syria.

Campaigners and her lawyers insist she was groomed and trafficked as a child and should never have been abandoned by the British state. They

argue her case was mishandled from the outset, with officials failing to recognise her as a vulnerable schoolgirl rather than a hardened extremist.

A document published by the European court this month confirms that Begum is challenging the Home Office decision under Article 4 of the European Convention on Human Rights, which bans slavery and forced labour.

The case was lodged in December 2024 after Britain's Supreme Court ruled she could not return to the UK to pursue her appeal.

warning signs

Among a series of pointed questions sent to the Home Office, judges asked whether the government had a "positive obligation" to consider if Begum had been a victim of trafficking before deciding to remove her citizenship.

They specifically queried whether Sajid Javid should have examined whether any duties towards her flowed from that status before taking the "exceptional" step of cutting her off from the UK entirely.

Her solicitors, Birnberg Peirce, said the intervention marked a critical moment. The firm claimed the case offered an "unprecedented opportunity" for the UK to confront issues it said had been "ignored, sidestepped or violated" by successive governments.

Veteran human rights lawyer Gareth Peirce said it was beyond dispute that Begum had been targeted as a child.

"It is impossible to dispute that a 15-year-old British child was lured, encouraged and deceived

for the purposes of sexual exploitation," she said, describing how Begum was taken to ISIS territory "for the known purpose of being given, as a child, to a fighter to propagate children for Islamic State".

She also accused authorities of failing to act despite warning signs, claiming officials knew Begum was at high risk after a close friend had already disappeared to Syria via the same route.

The legal challenge comes as the government insists tackling grooming gangs and human traf-

ficking is now a national priority - a point Begum's team say exposes a glaring contradiction.

But ministers remain defiant.

A Home Office spokesperson said the government would "robustly defend" any action taken to protect national security.

"The government will always protect the UK and its citizens," they said. "That is why Shamima Begum - who posed a national security threat - had her British citizenship revoked and is unable to return to the UK."

Opposition figures

were even blunter.

Shadow home secretary Chris Philp said Begum had "no place" in Britain because of her support for violent extremists.

"It is deeply concerning the European Court of Human Rights is now looking at using the ECHR to make the UK take her back," he wrote on X.

Reform UK deputy leader Richard Tice was more scathing still, posting: "ECHR can jog on... none of their business... just another reason why we must leave this foreign court."

'Shameful' 41,000 small boat arrivals

More than 41,000 people crossed the Channel in small boats last year, figures branded "shameful" by the Home Office have revealed.

The government said 41,472 people arrived in the UK by crossing the Channel in 2025 - the second highest number on record after 45,774 made the journey in 2022.

The number of crossings was running at the highest level on record for much of the year, but the pace slowed

in the last two months of 2025. The total for the year ended up being 13% higher than the figure for 2024.

Keir Starmer had fought the election in 2024 promising to "smash the gangs" and last year negotiated a "one-in, one-out" returns deal with France to act as a disincentive.

A Home Office spokesperson said the number of small boat crossings was "shameful and the British people deserve better".

But they added: "This

government is taking action. We have removed almost 50,000 people who were here illegally, and our historic deal with the French means those who arrive on small boats are now being sent back.

"The home secretary has announced the most sweeping reforms to tackle illegal migration in decades, removing the incentives that bring illegal migrants to the UK and scaling up the return of those with no right to be here."

Locals give Vinnie both barrels...

Vinnie Jones has caused uproar with plans to build a shooting retreat on his country estate.

The football hard man turned actor wants planning permission for a development that would accommodate country sports.

However, the Lock, Stock and Two Smoking Barrels star, 60, is facing significant opposition.

More than 12,000 have backed a campaign by Protect the Wild, which calls on Chichester District Council to reject the plan for Blackwool Farm in Ebernoe, West Sussex.

Objectors say it will put further strain on wildlife and argue it would hand over "shared national landscape to a tiny, wealthy minority".

In an open letter to the council and the South Downs National Park Authority, campaigners said: "A development designed to accommodate shooting parties – however it is phrased in planning language – adds further strain to wildlife that should be protected, not exploited. "National parks belong to the nation. They are places for walking, nature recovery, education, tranquillity, and public access.

"They are not places for commercialised bloodsports or luxury shooting retreats."

The open letter added: "Approving this planning application would hand over part of our shared national landscape to a tiny, wealthy minority at the direct expense of the wildlife the National Park Authority is legally bound to protect."

Under the plans, empty farm buildings would be converted into seven units of private "bespoke accommodation" for countryside "sporting activities", which will include shoots.

Camilla opens up about teen assault

Queen reveals she was once attacked on a train - and how she fought back

The Queen has spoken publicly for the first time about being assaulted as a teenager, as she joined racing commentator John Hunt and his daughter Amy for a discussion on violence against women this week.

Camilla described how the assault, which happened on a train, left her "so angry".

She praised the pair for their courage and their charity work after Mr Hunt's wife Carol and daughters Louise and Hannah were murdered in a horrific crossbow attack at their home.

And she told them their loved ones would be proud of them.

'so angry'

Camilla said on the recording, aired on BBC Radio 4's Today programme: "It had been lurking in the back of my brain for a very long time, when I was a teenager, I was attacked on a train, and I'd sort of forgotten about it, but I re-

member at the time being so angry.

"I was reading my book, and you know, this boy, man, attacked me, and I did fight back.

"And I remember getting off the train and my mother looking at me and saying 'Why is your hair standing on end?' and 'Why is a button missing from your coat?'. "But I remember anger, and I was so furious about it, and it's sort of lurked for many years.

"And I think when the subject of domestic abuse came up, and suddenly you hear a story like John and Amy's, it's something that I feel very strongly about."

Louise Hunt, 25, her sister Hannah, 28, and their mother Carol, 61, were killed by Kyle Clifford, 27 – Louise's ex-partner – at their house in Bushey, Hertfordshire, on July 9, 2024.

domestic violence

Mr Hunt and Amy set up The Hunt Family Fund in memory of Car-

ol, Louise and Hannah to raise money for charities and causes that help and inspire young women.

After hearing the Queen share the story, Amy said: "Thank you for sharing that story first, Your Majesty, because that takes a lot to share these things because every woman has a story."

The incident was first recounted in the book Power and the Palace: The Inside Story of the Monarchy and 10 Downing Street by Valentine Low, a former royal reporter for The Times.

It told how the man touched the then-teenage Camilla Shand and that she hit him with the heel of her shoe.

When she arrived in London, she reported the incident to station staff and the man was arrested, the book reported.

Camilla did "what my mother taught me" and took off her shoe to fend off the man as she travelled to London's Paddington station in the early 1960s when aged 16 or 17, it was previously reported.

The conversation formed part of a wider

discussion about combating sexual and domestic violence and the power of talking about experiences and trauma. It was recorded in the Garden Room at Clarence House in November.

Former Prime minister Baroness Theresa May also took part, and the discussion was chaired by BBC broadcaster Emma Barnett.

Camilla paid tribute to the Hunts in the moving broadcast.

She told them: "I'd just like to say, wherever your family is now, they'd be so proud of you both."

New Labour guru warns PM: Reform is an existential threat

■ Advertising mastermind issues a 'terrifying' warning to No 10 over rise of Farage's party

Sir Keir Starmer got a brutal New Year wake-up call this week after a legendary New Labour strategist warned his leadership is sleepwalking into a national disaster.

Sir Chris Powell the marketing genius who helped propel the party to power in the 1990s - has issued a scathing assessment of the Prime Minister's performance, claiming he lacks any real plan to defeat the "new and terrifying threat" of Reform UK.

And Sir Chris warned that the government has just three years to save British democracy from a populist takeover.

Writing for The Guardian, the advertising titan did not hold back. He described the current lack of a counter-strategy as "potentiall suicidal" for freedom and democracy.

"We are at a very dangerous moment," Sir Chris warned. "We simply cannot afford to allow Reform UK to have a free run, and become established and entrenched as a credible potential government in the minds of disenchanted voters."

He added that simply "hoping" that Nigel Farage or his party would "implode" was a recipe for catastrophe.

The timing could not be worse for the Prime Minister. Sir Keir is already grappling with "deep unhappiness" within the Labour ranks as his personal popularity hits rock bottom.

While Reform UK has dominated opinion surveys for almost a year, Labour has been left scrambling to find a narrative that sticks. Sources suggest the PM is now planning a desperate New Year "reset," promising deep cuts to energy bills and lower interest rates and pledging to ensure that voters' lives ge easier in 2026 - but many critics wonder if that

will be far too little, too late.

A defiant Labour party source insisted the gov-

ernment was "tackling the problems that populists exploit," specifically pointing to the cost of living.

The Great Brummie Blunder!

■ Hundreds of revellers left in the dark after falling for fake New Year fireworks hoax for SECOND year in a row

THEY never learn!

Hundreds of hopeful revellers in Birmingham were left staring at a silent sky Wednesday night after falling hook, line, and sinker for a cruel New Year's Eve fireworks hoax.

Crowds of expectant party-goers flocked to the city's Centenary Square to see in 2026, tricked by "dazzling" promises of a pyrotechnic extravaganza that was supposed to light up the West Midlands sky. But the only thing exploding was their frustration when they realized they'd been duped by fake news

spread online.

Incredibly, it is the second time in two years that hapless Brummies have been caught out by internet pranksters. Last year, thousands swarmed the city centre expecting food vendors and live performances that simply didn't exist. You'd think the lesson would have been learned, but once again, the "fake news" brigade won the day.

This year's digital trap was particularly sophisticated. One online advertisement claimed there would be a "dazzling" fireworks show where attendees could "expect

a lively atmosphere featuring music alongside the brilliant show as the city welcomes the new year". It was a tempting invitation that proved too good to be true for the hundreds who ignored official warnings.

West Midlands Police had already attempted to pull the plug on the rumours, issuing a stern warning as early as Tuesday. The force made it crystal clear that there were "no official firework displays or city-organised events" planned for Birmingham city centre on New Year's Eve. They pointed the

finger squarely at the "spread of rumours online" that seems to plague the city every single year.

"Unfortunately, these false claims often lead to confusion and disappointment," the force blasted in a candid statement. But despite the police plea, social media footage captured the embarrassing reality of the situation. A large group of people were seen huddled in front

of the ferris wheel at Centenary Square - a focal point of the city - waiting for a show that was never coming. One viral clip was mockingly captioned: "When you queue for fireworks and the sky stays silent".

It's not just Birmingham being targeted by these high-tech tricksters. This latest "phantom firework" fiasco follows a worrying trend of digital deception across the coun-

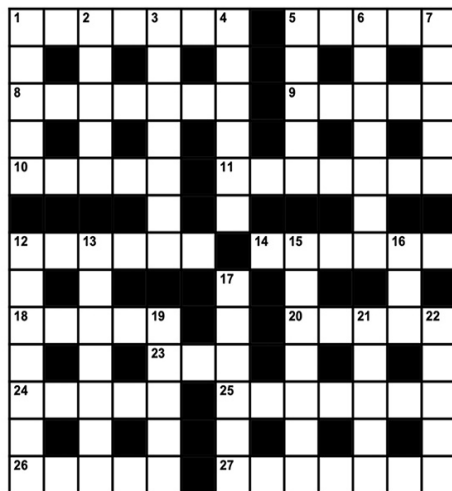
try. Only last month, devastated tourists arrived at Buckingham Palace expecting a picturesque Christmas market - only to find the "festive scene" was actually a fake AI-generated image.

Police have now warned that these misinformation incidents are no laughing matter, creating "real safety issues" as massive crowds gather for events that aren't even happening.

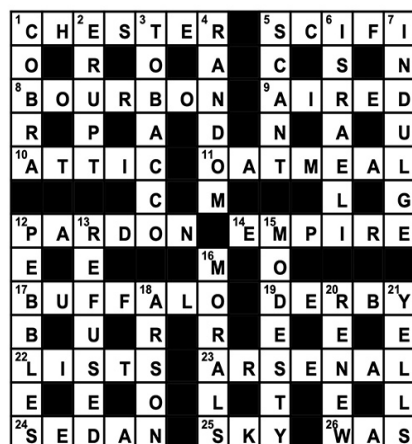

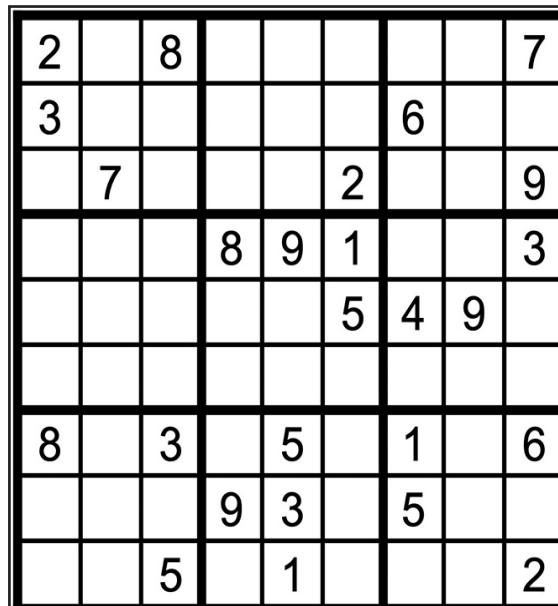

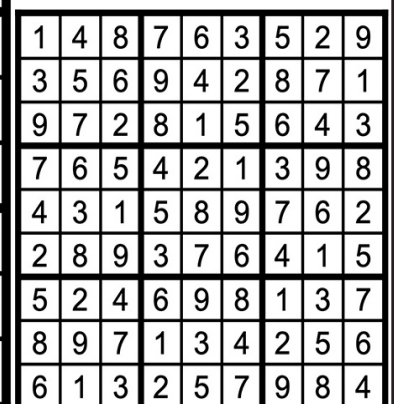

News from Britain

Millions celebrate arrival of 2026

Millions of people across the UK have officially rung in the new year, gathering at firework events and parties all over the country.

In London, 12,000 fireworks were set off in the city's biggest pyrotechnic display to date, with 100,000 people watching on from the banks of the Thames.

Edinburgh Castle was lit up by six minutes of carefully

choreographed explosions, surrounded by tens of thousands of revellers attending the famous Hogmanay street party.

But though the mood was warm the weather was not, with snow and ice forecast across much of the UK.

As the iconic midnight bongs of Big Ben sounded across London, the London Eye was at the centre of Europe's biggest firework display, which

celebrated some of the highlights of 2025.

The soundtrack included Raye, Sabrina Carpenter, Ed Sheeran and Coldplay, and featured voiceovers from stars such as Celia Imrie, Andrew Cotter and Alison Hammond.

England's Women's Rugby World Cup triumph was acknowledged in the display, along with the Lionesses' win at the Euros and Cynthia Erivo's performance in *Wicked: For Good*.

London Mayor Sir Sadiq Khan hailed the display as the most "legendary" in the world, writing on X that the city's new year celebrations held a clear message about "the importance of togetherness".

Other celebrations took place across the country, from Belfast to Cardiff, Manchester and Newcastle.

Edinburgh held its last official celebration in 2024, after "extreme weather" forced organisers to cancel Hogmanay celebrations.

This time, approximately 45,000 people attended the sold-out street party to usher in 2026, with some of the fireworks used in the display salvaged from last year's cancelled event.

The spectacle was accompanied by a soundtrack that featured some of Scotland's biggest artists, such as Lewis Capaldi and Simple Minds, before concluding with a version of Auld Lang Syne by Skye duo Valtos.

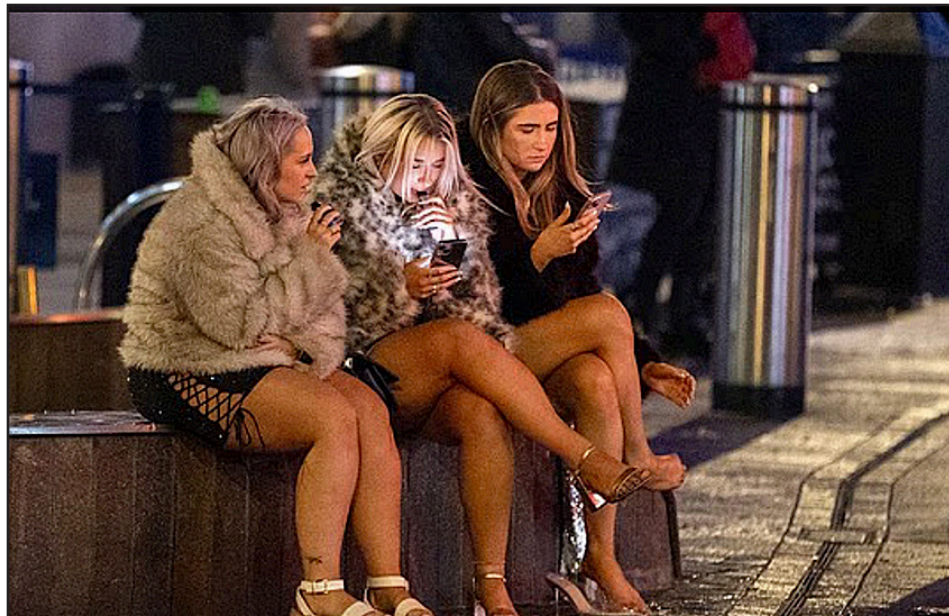

the Champions League, which remains realistic, while also aiming for domestic cup runs.

Chelsea were satisfied with Maresca at the end of last season when he delivered Champions League qualification – regarded internally as his most important achievement – plus success in the Conference League and Club World Cup.

While victory in Europe's third-tier competition was broadly expected, beating Paris St-Germain to be crowned world champions was a welcome surprise.

Maresca had delighted key figures at Stamford Bridge – including sport-

ing directors Paul Winstanley and Lawrence Stewart, and influential co-owner Behdad Eghbali.

Tongue in dreamland after match winning performance

Friends and family of bowler Josh Tongue said his performance for England against Australia was a "dream come true".

The former Redditch, Bromyard and Worcestershire cricketer took seven wickets in the fourth Ashes test at the MCG, England's first test win down under in nearly 15 years.

The player will finish 2025 as the first England bowler to be named player of the match in an Ashes test in Australia since 1998, when Tongue was just a baby himself.

Tim Piper, the landlord of The Cricketers Arms in Redditch, went to Australia to watch with the bowler's dad Phil Tongue and told reporters Her-

- Italian out at Blues just months after trophy triumph
- Rising star Liam Rosenior tipped to take over

Less than six months after guiding Chelsea to Club World Cup success, Enzo Maresca has left his post as head coach.

The Blues won just one of their final seven Premier League matches under Maresca and sit fifth in the table – 15 points adrift of leaders Arsenal.

After their most recent game – a 2-2 draw with Bournemouth on 30 December – assistant manager Willy Caballero said Maresca felt too unwell to speak to the media, but it is understood his absence was more due to him considering his next steps.

The speed with which things have unravelled for the Italian is shocking. At the end of November, the club appeared in a harmonious place, with the team third in the Premier League and having

recently dismantled Barcelona in the Champions League.

On 12 December, Maresca was named Premier League manager of the month for November.

Just one league win followed in December but it was not only results that added to the focus on Maresca, with fissures emerging between the Italian and the club's hierarchy.

Maresca stunned key figures at Stamford Bridge – and even his own staff – when, after beating Everton 2-0 for Chelsea's solitary Premier League win in December, he said "many people" had made it his "worst 48 hours" since joining the club.

Those comments came from a position of strength after a good

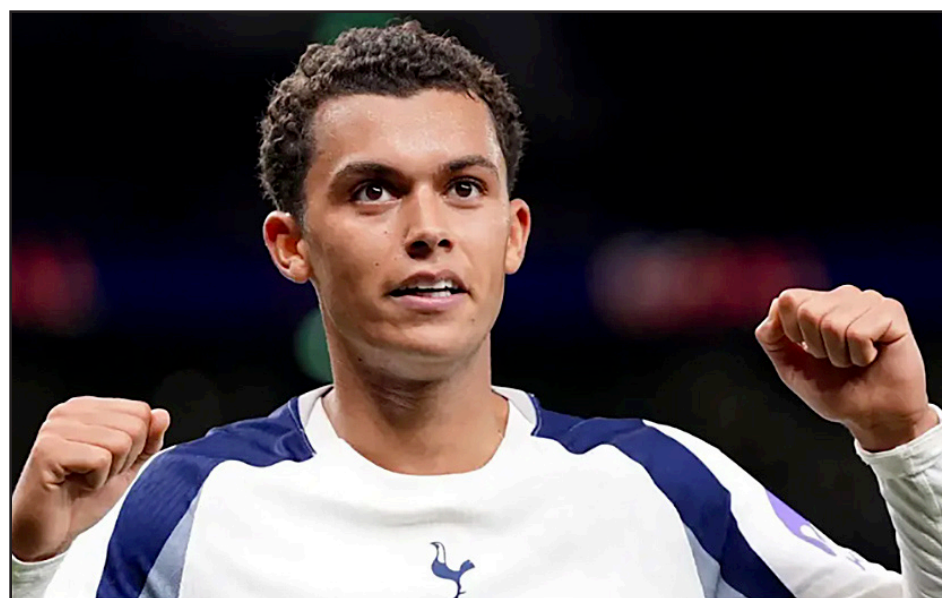
performance but were viewed dimly by the club hierarchy, at whom they appeared to be aimed.

They have since been explained as being linked to medical recommendations. Senior figures inside Chelsea said instructions were ignored and decisions either risked players getting injured again – or prevented them from training because of overload. Maresca felt the club were telling him who to pick, based on a player's value.

Even after that, the plan remained to conduct an end-of-season review to decide whether to move forward with Maresca or part company.

Those with knowledge of Maresca's views, though, said he was capable of walking away having grown unhappy
