Snow misery for UK

“Danger to life” as 100mph Arctic blast shuts schools and cuts power to thousands

Britain woke up up to a winter wonderland from hell on Thursday as Storm Goretti - the first named monster of 2026 - slammed into the country with hurricane-force fury.

From the wave-battered cliffs of Cornwall to the snow-choked streets of the Midlands, by evening the nation was in the grip of a “multi-hazard” weather bomb that has left thousands in the dark and travel networks in total meltdown.

‘freight train’

The Met Office issued a rare ‘red danger to life’ warning as the storm underwent a terrifying “rapid deepening,” with central pressure plummeting like a stone. Residents in the Isles of Scilly and Cornwall were rocked by “violent gusts” of up to 99mph - shattering local records and sending roofs flying.

Emergency alerts blared from mobile phones as the Cabinet Office warned families to stay indoors and “seek a safe location away from windows.” One local in Truro described the sound as “like a freight train hitting the house,” as beach material and debris were hurled onto coastal roads by monstrous waves.

While the South-West battled the gales, the rest

of the country was being buried under a thick white blanket. At press time an Amber Snow Alert was in force across Wales and the Midlands, with forecasters warning that up to a foot of the white stuff could fall on higher ground.

The BigChill has already brought the following:

Schools Shut: More than 250 schools across Scotland and dozens more in the Midlands have bolted their gates, leaving parents scrambling for childcare.

Power Out: Over 47,000 homes in the South West were plunged into darkness last night as lines were downed by falling trees.

Airport agony: Birmingham Airport was forced to freeze its runway as heavy snow turned the tarmac into an ice rink, leaving hundreds of passengers stranded.

Rail Misery: Friday morning commuters were facing a “strictly transactional” morning of misery, with National Rail cancelling all services in parts of the South West and North-

ern Trains issuing a “Do Not Travel” alert for routes in the Peak District.

RAC experts have warned that batteries are failing at record rates as temperatures plummeted to a bone-chilling -14.7°C in the Scottish Highlands. “If your journey isn’t essential, don’t even think about it,” warned one breakdown spokesperson. “The ice is a silent killer out there.”

Cost of the cold

It’s not just Britons’

nerves being frayed it’s their wallets too. Energy experts warn that the “Arctic Blast” has pushed UK power demand to a seven-year high, forcing the National Grid to fire up gas plants as wind turbines are shut down for safety. Wholesale electricity prices have reportedly skyrocketed to ten times their normal levels as the nation huddles for warmth.

Goretti was expected to wane by Friday evening, but the nightmare isn’t over. A fresh “bat-

tleground” of weather is expected this Sunday as milder Atlantic air clashes with the frozen remains

of the storm, bringing the threat of even more snow and ice for the start of next week.

STAY OUT: Home Secretary vows to fight judges to keep ISIS bride barred from Britain

■ Now ECHR challenges UK on decision to strip British citizenship from Shamima Begum

SHABANA Mahmood has insisted she will fight European judges over Shamima Begum's bid to return to the UK.

The jihadi bride's hopes of leaving Syria were revived after the judges challenged Britain's stance in the case.

The European Court of Human Rights has formally told the Home Office to justify its decision to strip Isis fanatic Begum of her British citizenship in 2019.

But Home Secretary Ms Mahmood insisted the government will continue to defend its position, after every UK court had ruled the move legal.

'robustly defend'

Facing questions over the controversy on Monday, the Home Secretary said: "The case against Shamima Begum has been litigated by the previous government

all the way to the UK Supreme Court, who did not hear the last appeal on this because all legal questions have been now dealt with.

"We have accepted that position as a government in this case.

"We will robustly de-

fend this at the European Court of Human Rights."

Ms Mahmood was grilled by Shadow Home Secretary Chris Philp in Parliament.

He told reporters: "Shamima Begum chose to go to Syria and sup-

port Daesh which is a murderous, violent terrorist regime.

"It's deeply worrying the European court is now looking at using the Convention to make the UK take her back. This case is a further reason why we need to leave

the European Convention on Human Rights."

Shadow Home Office minister Katie Lam added: "Once again we see a foreign court in Strasbourg trying to get in the way of keeping the British public safe."

The European judges

have asked the government if it broke human rights and anti-trafficking laws.

Begum's lawyers called the latest twist an "unprecedented opportunity". She left East London aged 15 for Syria in 2015.

Phone seizures and jail time: the new front in the war on people smuggling

■ After a record-breaking 2025, new law allows onsite tech to harvest mobile data to "restore order"

THE GOVERNMENT signalled its hardening stance on migrants this week by introducing a

new policy to seize mobile phones and SIM cards from migrants without needing to ar-

rest them to help stop people smugglers.

Officers began taking devices at Manston processing centre in Kent on Monday with onsite tech available to download data to gather intelligence on gangs.

It is hoped the new powers for law enforcement agencies will hasten probes.

'restore order'

They come after the Border Security, Asylum and Immigration Act became law last month.

Border security minister Alex Norris said: "We promised to restore order and control to our borders, which means taking on the people-smuggling networks behind this deadly trade.

"That is why we are implementing robust new laws with powerful offences to intercept, disrupt and dismantle these vile gangs faster than ever and cut off their supply chains. These measures sit alongside sweeping reforms to the system, to make it less attractive for migrants to come here illegally, and to remove and deport people faster."

A total of 41,472 migrants arrived in 2025 after crossing the Channel – the second-highest figure on record.

The yearly total was 13% higher than the 2024 figure, when 36,816 migrants came.

And the new law introduces criminal offences, such as up to 14 years

in jail, for storing or supplying boat engines to bring migrants via the Channel.

'key moment'

Smugglers downloading maps on where to depart on small boats or researching the best places to buy equipment for the dinghies could get up to five years in prison under recently introduced legislation.

Border Security Commander Martin Hewitt said more than 4,000 disruptions against smuggling gangs have taken place since his unit was set up, such as by seizing cash and convicting ring-leaders.

He said the move marked a "key moment" with the additional tools.

Tributes flood in as 'King Kev' begins cancer battle

■ Messages of support flood in for former England player and manager

TRIBUTES and pledges of support have flooded in from across the football world following the announcement that Kevin Keegan, one of the most transformative figures in the English game, has been diagnosed with cancer.

The 74-year-old, affectionately known as "King Kev" to generations of supporters, was recently admitted to hospital after suffering from persistent abdominal symptoms. In a poignant statement, his family confirmed that investigations revealed the illness and that he will now begin a formal course of treatment.

While his family has requested privacy, the news has triggered an unprecedented outpouring of affection from former teammates, rivals, and fans.

The response to his diagnosis this week re-

flects that deep-seated respect. Current Newcastle manager Eddie Howe spoke emotionally before the Magpies' clash with Leeds United, describing Keegan as an "absolute icon" and an "inspirational figure."

Howe noted, "I've been lucky enough to meet him a few times. He's been so kind and generous with his time and his words for me. The whole city is behind him."

"Mighty Mouse"

Clubs including Manchester City, where he won the First Division title as manager in 2002, and Fulham have also sent messages of support. The Football Association and the Premier League joined the chorus, acknowledging a man who earned 63 caps for England and captained his country 31 times.

Keegan's impact on the game is difficult to overstate; his journey began at Scunthorpe United, but it was at Liverpool under Bill Shankly where he became a household name. During a golden era at Anfield, he secured three First Division titles, an FA Cup, two UEFA Cups, and the European Cup.

But it was his move to Hamburger SV in 1977 that cemented his global legacy. In Germany, his boundless energy earned him the nickname 'Mighty Mouse' and became the first Englishman to win back-to-back Ballon d'Or awards (1978 and 1979), a feat that remains a pinnacle of individual achievement for British players abroad.

His playing days concluded with spells at Southampton and Newcastle United. His arrival at St. James' Park in

1982 was a seismic event for the North East, as the reigning PFA Player of the Year dropped down a division to drag the Magpies back into the top flight. When he finally retired in 1984, he famously left the pitch in a helicopter, still wearing his full Newcastle kit—a flamboyant exit that perfectly captured his "Messiah" status on Tyneside.

However, for many

modern fans, Keegan is best remembered for his two spells as Newcastle manager. Taking over in 1992 when the club was facing bankruptcy and relegation to the third tier, he sparked a "Geordie Revolution." He built the legendary "Entertainers" side, featuring stars like Les Ferdinand, David Ginola, and Alan Shearer. This team's fearless, attacking philosophy fa-

mously led the Premier League by 12 points in 1996, resulting in one of the most dramatic title races - and late collapses - in history against Manchester United.

Ultimately Keegan's managerial career was more about glorious failure than trophies...but fans everywhere will be hoping for an emphatic victory against this particular opponent.

Free at last: Ruben's a Go-Go

■ Sacked United boss grins for the camera 'manager, not coach' rant gets him fired

RUBEN Amorim looked like the weight of Old Trafford had finally been lifted as he took a winter stroll with his wife - just hours after his sacking as Manchester United manager this week.

The 40-year-old Portuguese tactician - who arrived from Sporting Lisbon in November 2024 to a hero's welcome - seemed more like a man who had won the Euro-Millions than one who had just presided over the club's worst season in over half a century. Despite being shown the door following a dismal run that left the Red Devils trailing the Premier League pack, Amorim and his partner Maria Joao Diogo were spotted stepping out of

their Cheshire mansion wearing huge grins.

The source of that joy? A staggering £12million compensation package due to land in his bank account.

spending spree

The end came swiftly following a turgid 1-1 draw away at Leeds United on Sunday. While United's board expected results after backing their man with a massive £250million summer spending spree, Amorim instead launched into a startling, bridge-burning rant against the club's hierarchy.

Witnesses claim the outgoing boss left the training ground laughing and joking with his departing coaching staff, but his final words in

the press room were anything but lighthearted. He went "nuclear," delivering a series of quotes that effectively signed his own pink slip.

'not going to quit'

Amorim didn't hold back, fuming: "I came here to be the manager of Manchester United, not to be the coach. I am the manager of Manchester United and it's going to be like this for 18 months or when the board decides to change. I'm not going to quit. I will do my job until the other guy is coming here to replace me. And that is going to finish in 18 months and then everyone is going to move on. That was the deal, that is my job, not to be a coach. If people cannot handle the

Gary Neville, the criticism, everything... We need to change the club. In every department, the scouting department, the sporting director needs to do his job, and I will do mine for 18 months and then we move on."

The board's patience finally snapped. Despite

being told the squad was good enough to play an "attacking style," the lowest ebb of Amorim's 14-month tenure came last August with a "shock defeat" to League Two minnows Grimsby Town in the Carabao Cup.

As the "beaming" Am-

orim prepares to enjoy his mega-payoff, former midfielder Darren Fletcher was swiftly installed as caretaker manager for the midweek trip to Burnley. The circus continues, but for Ruben, the show is over - and he's laughing all the way to the bank.

Police left red-faced after dead crash teen wrongly identified

A teenager wrongly believed to have died in a car crash was misidentified by police through visual checks as no forensic tests were initially carried out, a coroner has been told.

Trevor "TJ" Wynn, 17, was reported to have died in the 13 December collision while the family of Joshua Johnson, 18, were told he had been seriously injured.

However, doubts emerged when the injured boy woke in hospital three weeks later and confirmed he was Trevor and not Joshua, Doncaster Coroner's Court heard.

Asked if issues with identification had now been fully resolved, South Yorkshire Police's Det Ch Insp Andy Knowles told the coroner: "Yes, to a high degree of certainty."

The early hours crash happened between Dinnington and Todwick

near Rotherham when the silver Toyota Corolla the group were in left the road and collided with a tree.

Knowles told the hearing, overseen by Senior Coroner Nicola Mundy, the female driver, Summer Louise Scott, 17, and

one male passenger died at the scene, while a second male was left critically injured.

Knowles said several personal items were found at the scene of the crash, but none were physically on a person.

These included a

phone in a case and a driving licence in the name of Joshua Johnson, as well as a second phone displaying medical identification in the name of Trevor Wynn, with a bank card attached to the device.

Knowles said one of the

attending officers used this to establish the next of kin and called Trevor's mother to explain what had happened.

She provided her son's college identification card plus a description of his appearance, build and footwear.

The ID card was then taken to the mortuary by the officer, Knowles said, where details of build and clothing were compared.

"The officer was satisfied that this was the body of Trevor Wynn,"

£500 fine for the fake admiral

Jonathan Carley, 65, ordered to pay after pleading guilty to attending ceremony in Royal Navy uniform without permission

An ex-history teacher who dressed as an admiral at a Remembrance event has been fined £500.

Imposter Jonathan Carley, 65, joined dignitaries laying wreaths and saluting at the ceremony in Llandudno last November.

But service personnel and veterans had become suspicious of his rare Distinguished Ser-

vice Order medal and the ceremonial sword he carried at previous events he attended in the area since 2018.

When he was arrested five days after last year's Remembrance Sunday event he told police: "I've been expecting you", Llandudno magistrates heard on Monday.

Carley, from Harlech, Gwynedd, told

police the uniform was issued to him when he was in the cadets but he had rear admiral rings added by a tailor and bought medals online.

After admitting wearing uniform without permission. District Judge Gwyn Jones fined Carley £500 and ordered him to pay £85 towards prosecution costs and a £200 surcharge.

He told him: "It's do such a thing on a sad reflection upon a very difficult day for so many."

World Cup national holiday for Scotland

A public holiday will mark Scotland's men's national team playing in its first World Cup since 1998.

Scotland will face Haiti in Boston on the evening of Saturday, 13 June, before taking on Morocco and Brazil in their remaining group fixtures in the United States.

First Minister John Swinney has proposed that 15 June is designated as a national bank holiday.

Only public sector employees in areas controlled by the Scottish government would be assured of a day off, depending on their contract, though other employers could follow suit.

'standstill'

The proposal will be formally confirmed once it has been rub-

ber-stamped by the King.

Speaking at an event in Glasgow, Swinney said: "The whole nation will come to a standstill in June - even more so in July once we've seen off Brazil and progressed to the knockout stages.

"This is a moment 28 years in the waiting - and I want as many people as possible to share the occasion."

He added: "That will mean that supporters across the country can watch our men's team in their first World Cup match for almost 30 years, and share in the chance for Scotland to be on the world stage, to attract business development, to create tourism and hospitality interest within the country and to make deep and lasting cultural and sporting

connections."

Scotland is able to set distinct bank holidays from the rest of the UK.

A day can be appointed as a bank holiday in Scotland by royal proclamation.

The first minister is able to advise the Privy Council - an advisory board to the monarch - on proclamations for Scotland, which are formally signed off by the King.

Scotland face Morocco in Boston on 19 June, and Brazil in Miami on 24 June. Both games kick off at 23:00 BST, prompting to Swinney to promise his government would work with local authorities on extending pub opening hours.

The Scottish government simply does not have the power to give people across the country - including those working

in the private sector or in parts of the public sector controlled by the UK government - an extra, specified day off work.

Decisions on whether or not to give staff the day

off are for individual employers to take.

In general, bank or public holidays do not have to be given as paid leave by employers.

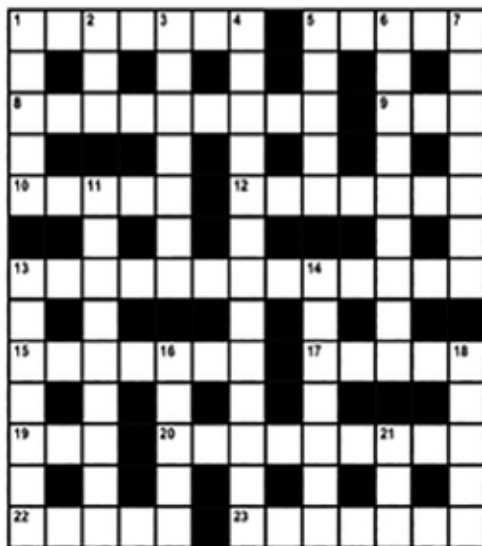
Even the major Scottish

high street banks do not close on Scottish bank holidays now - they observe English bank holidays, to stay in line with their sister businesses south of the border.

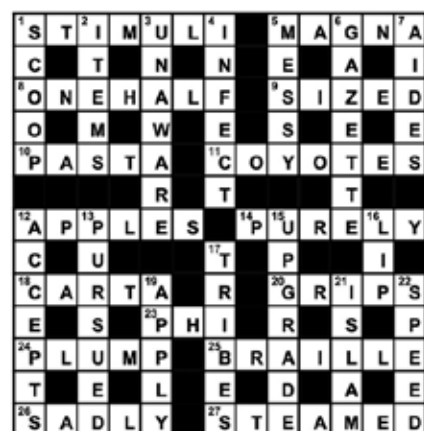

he added.

Meanwhile, a second officer, who had been travelling in an ambulance with the surviving male, said he had been told by an officer at the scene the victim was Joshua Johnson, based on driving licence photos.

That officer then liaised with medical staff

at the hospital and the photograph was compared with the victim.

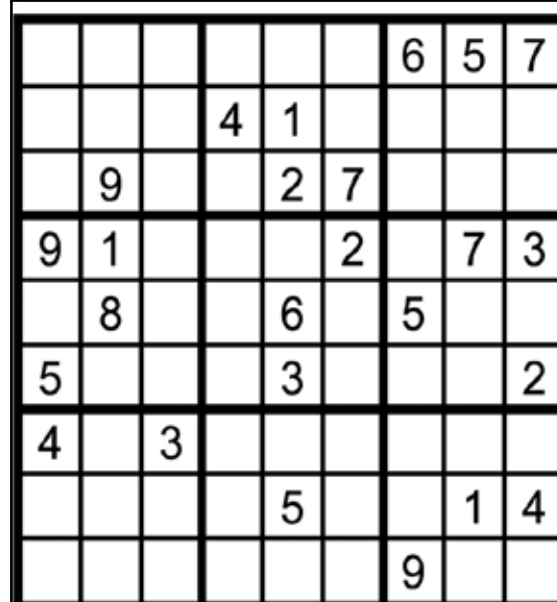
The medical staff and officer were satisfied the person in hospital was Joshua Johnson, said Knowles, who had no involvement in the investigation prior to 5 January.

Doubts about identity emerged when the boy woke up on Sunday, prompting Johnson's father to call South Yorkshire Police and voice concerns the person in

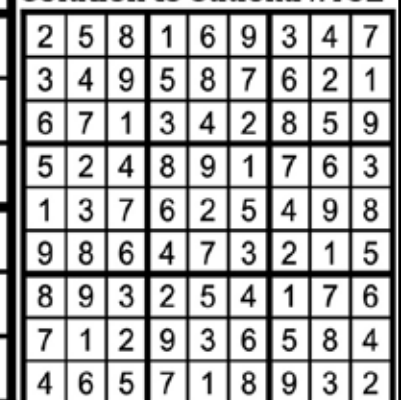
hospital was not his son. Knowles said at that point it was decided police would no longer rely on visual identification and obtained dental records, which confirmed the boy in hospital was actually Trevor.

Doncaster Coroner's Court officer Siobhan Golightly said she had no reason to doubt the police identification and said an inquest had been opened for Trevor on 22 December.

■ Much loved former co-owner of Ye Olde Kings Head passes away in Rancho Mirage after short illness

THE BRITISH Community suffered a heavy blow this week with the passing of longtime King's Head co-owner Ruth Elwell.

Ruth passed away peacefully on January 6th in Rancho Mirage after a short illness. She is survived by her broken-hearted husband Phil. The couple had been married for close to 60 years and together shepherded the growth of the pub, which first opened in small premises on Santa Monica Boulevard in 1974, into the much larger enterprise it is today.

Born Ruth Anne Sweeney in Scranton, Pennsylvania, she met Phil shortly after his arrival from Birmingham when they lived in the same Los Angeles apartment building. According to family folklore, one night Ruth was dressed up to go on a double date with her sister Mary when they

bumped into Phil, who invited Ruth out for a ride in his car instead. Ruth promptly ditched her date and the rest, as they say, is history.

Shortly after tying the knot they opened the King's Head to fulfil their dream of creating a genuine British hostelry for transplanted Brits to come together and build a community. And Ruth was just as much a partner in that endeavor as Phil. An accountant by trade, she kept a tight eye on the finances while Phil employed his gregarious charm to make friends with everyone who walked through the doors.

During their stewardship the pub became THE place for Los Angeles-based Brits of all vintages to meet for a drink, and a chat, and grab some authentic British food. The pub also became famed for its celebrity cli-

entele, with guests as diverse as Rod Stewart, Englebert Humpdinck, Jeff Lynne, Ozzy Osbourne, Richard Branson and Hugh Grant all popping for a quick bevvy or to pick up a tasty treat from the Gift Shoppe

Regulars at the pub became close friends, and the employees became family. Although the couple had no children of their own, Ruth was famed for her generosity to staff and their children, and for many years she organized an annual Christmas party, buying presents for the children and hiring a 'Santa' to add to the fun.

After retiring midway through the Noughties and handing the reins over to the current owners Paul Boetcher and Donal Tavey, the pair moved to Rancho Mirage, where Ruth kept busy with charity events, ladies' lunches and their beloved McCallum theatre in Palm Desert. When they weren't

indulging in their love of global travel to exotic places, Phil explored painting and sculpture at home, while Ruth kept busy with Pilates and was very fond of brisk walks before the heat of the day set in.

Former Spurs striker Martin Chivers dead at 80

The former Tottenham, Southampton and England striker Martin Chivers has died at the age of 80.

Chivers, a League Cup and Uefa Cup winner with Spurs, won 24 caps from 1971 to 1973, scoring 13 goals.

"It is with immense sadness that we announce the passing of our legendary former striker Martin Chivers," Spurs said. "We extend our deepest sympathies to Martin's family, friends and former teammates at this incredibly sad time. Our players will wear black armbands during this evening's fixture against AFC Bournemouth. Rest in peace, Martin. One of the all-time greats."

Chivers started his career with his home-city club Southampton, making his debut in 1962, and

joined Spurs in 1968.

After a long, successful spell there he moved to Switzerland to play for Servette, where he won further honours, before returning to England to play for clubs including Norwich and Brighton.

Southampton said they were "deeply saddened" by the death of Chivers, who made 189 appearances for the club, scoring 108 goals. He scored 174 times in 367 competitive games for Spurs, including both goals to beat Aston Villa in the 1971 League Cup final and two to help defeat Wolves in the two-leg 1972 Uefa Cup final. He won a second League Cup in 1973 and was inducted into the Spurs hall of fame in 2007.

Chivers was given his England debut against Malta and scored seven times in his first eight appearances. His final international game was against Poland at Wembley when a 1-1 draw meant England failed

to qualify for the 1974 World Cup.

Chivers told Tottenham's magazine in 2009: "In my day tackles from behind were commonplace, the pitches were muddy and uneven, the ball was heavy and we did not have dietitians and psychologists. Today, players are faster because they play on the top of the ground and they're fitter. But I do think that my style of play would have suited today's game."

In the final years of his career Chivers made appearances in non-league for Dorchester and Barnet, and played in Australia for Frankston City and in Norway for Vard Haugesund.

CHELSEA confirmed the arrival of Liam Rosenior this week but Wednesday's 2-1 defeat at Fulham underlined the scale of the task ahead.

The 41-year-old described his appointment as "one of the proudest moments of his life", yet the reality was clear as the Blues dropped out

of the Premier League top five for the first time since August.

Sitting in the directors' box alongside co-owner Behdad Eghbali and members of the sporting leadership team, Rosenior watched as the side he has inherited slipped to eighth.

He replaced Enzo Maresca after the Italian fell out with the Blues hierarchy, with Rosenior joining from French club Strasbourg who share Chelsea's owners. Those decision-makers were targeted by chants from the away end during the match, while the Chelsea players struggled against their west London rivals on the pitch.

The team have won

just one of their past nine league games and two of 11 in all competitions, falling from potential title contenders in November to a side now lagging far behind.

They have ground to make up to achieve their minimum aim this season - qualifying for the Champions League, which should be achievable with a top-five finish.

If Chelsea's relationship with the fans isn't broken, it is certainly fraying. Just hours after Rosenior was confirmed in his new post, the Chelsea Supporters' Trust released a highly critical survey - not aimed at the appointment, but at the club's leadership.

Among the headlines was that more than half of respondents doubt Chelsea will achieve success in the next three to five years under the current regime. A similar proportion lack confidence in the ownership's decision-making.

by a loss of form and injuries to key players, England surrendered the series at the earliest opportunity with defeats in the first three Tests.

Ben Stokes' side at least took the fourth Test in Melbourne for their first Test win in this country since 2011, but that two-day shootout on a grassy pitch was the outlier in a series where they were humbled.

Stokes was able to lead his team onto the field for the final act in Sydney despite a groin injury. The all-rounder has said he wants to carry on as captain and fitness would appear to be the only barrier to him remaining in charge.

Greater pressure is on head coach Brendon McCullum and director of cricket Rob Key. Both men have admitted failings on this tour and expressed their desire to stay.

They look set to be given the opportunity if they can demonstrate to the management of the England and Wales Cricket Board that the set-up of the men's national team has improved.

That begins with the T20 World Cup and a preceding white-ball tour of Sri Lanka, which starts in just two weeks' time.

Ultimately, they were defined as another England outfit trounced in Australia. This was the fourth successive Ashes tour where England have lost at least four Tests.

This century alone, England's record in this country is 27 defeats from 35 matches. Three of their five Test wins in that period came in the glorious triumph of 2010-11 - the only series England have won Down Under in the past 40 years.

Nancy out, O'Neill in at Celtic

Celtic have parted company with manager Wilfried Nancy, with Saturday's 3-1 defeat by Rangers his sixth loss in just eight matches and his 33-day reign the shortest in the club's history.

The 48-year-old signed a two-and-a-half-year contract with the Scottish champions after the conclusion of the Major League Soccer season with Columbus Crew and took charge on 4 December.

But, having won seven of their eight games under interim manager Martin O'Neill, Celtic's form slumped dramatically under Nancy.

The Frenchman became the first Celtic manager to lose his first two games before suffering a 3-1 defeat by St Mirren in the Premier Sports Cup final and a 2-1 reverse at Dundee United.

It was the first time Celtic had lost four games in a row since a

similar run under the legendary Jock Stein in 1978.

They won back-to-back league matches against Aberdeen and Livingston to stop the rot, but were beaten 2-0 at Motherwell on Tuesday and collapsed in a dismal second-half at home to Rangers.

Celtic have also removed Paul Tisdale from his position as head of football operations.

The former Exeter

City and Stevenage manager had been in the role since October 2024.

A brief club statement confirms the exits, along with Nancy's coaches Kwame Ampadu, Jules Gueguen and Maxime Chalier, adding that a "further update will be provided to supporters as soon as is practical".

O'Neill is returning as manager for the remainder of the season.

"I am really pleased,

in fact, very honoured to be asked back to manage the team again and I am looking forward to getting back to work again with the players," O'Neill told club media.

"I know we would all have hoped for things to have worked out differently under Wilfried and I personally want to wish him good luck with everything he does in the game. He is a fine man and I am sure he will go on and achieve

success again, I have no doubt of that.

"For me, I've been asked to take this great job on again and my focus will be to try and get us back to winning ways if we can. We will need everyone right behind us."

O'Neill, who won seven trophies with Celtic from 2000-05, will again be assisted by Shaun Maloney, Mark Fotheringham and Stephen McManus.

Leeds and Wales great Yorath dead at 75

Former Wales captain and manager Terry Yorath, who has died at the age of 75, was the first Welshman to play in a European Cup final, but was deeply affected by two off-field tragedies.

He played for Leeds United, Coventry City and Tottenham Hotspur, skippered Wales in 42 of his 59 international appearances, and later managed Swansea City, Bradford City, Cardiff City and Sheffield Wednesday.

Yorath will however perhaps always be most closely associated with the Wales team he managed that just missed out on qualification for the 1994 World Cup as a result of an agonising defeat by Romania.

He is survived by three children - son Jordan and

daughters Louise and Gabby, the BBC Sport presenter who married Scotland rugby union international Kenny Logan in 2001.

Another son, Daniel, died suddenly at the age of 15 in 1992 from the genetic heart condition hypertrophic cardiomyopathy.

Yorath was also player-coach of Bradford in 1985 and was at Valley Parade when a fire killed 56 people.

Born in Cardiff, Yorath was a combative midfielder and a natural leader after emerging in Don Revie's Leeds United team in the early 1970s.

He joined Leeds as a schoolboy in 1965 and signed on as a professional two years later, but his early first-team

chances were limited by the presence of Billy Bremner and Johnny Giles in Revie's famous line-up.

But he was a regular when Leeds won the First Division title in 1973-74, and was in the side that lost 2-0 to Bay-

ern Munich in the 1975 European Cup final.

Sold to Coventry a year later, he captained the Sky Blues for most of his three seasons there before joining Tottenham in 1979.

After Tottenham, Yorath played for Vancou-

ver Whitecaps before joining Bradford as player-coach. Later, for a time he combined club management at Bradford and Swansea with managing Wales on a part-time basis, before eventually taking the Wales job full-time.

Stubborn Reds frustrate Arsenal

The script was written for a coronation, but Liverpool clearly hadn't read it.

On a night when the Emirates Stadium was primed to celebrate a definitive step toward a first Premier League title in 22 years, Mikel Arteta's Arsenal instead found themselves reminded of the agonizing margins of the elite game.

Playing under the lights on Thursday amid the deluge of Storm Goretta, the Gunners missed a golden chance to tighten their grip on the summit, held to a frustrating draw by a resilient, makeshift Liverpool side.

Despite the pre-match optimism fueled by Manchester City and Aston Villa's mid-week stumbles, Arsenal's six-

point lead at the top now feels more like a target than a cushion. Arteta had urged the home faithful to "make the difference," and they responded with a vibrant mosaic of red and white as the teams emerged into the torrential rain. But on the pitch, the clinical edge required to dispatch a "big six" rival was nowhere to be found.

Gamble

Arne Slot, facing a striker crisis with Hugo Ekitiké sidelined, opted for ingenuity over desperation. Dominik Szoboszlai was deployed as a "false nine," supported by the creative spark of Florian Wirtz. It was a system designed to frustrate, and it worked to perfection. While Arsenal's Bukayo Saka ini-

tially terrorized Milos Kerkez - a surprise inclusion over Andy Robertson - the Gunners failed to capitalize on their early dominance.

Saka's mesmerising run early on left Kerkez and Alexis Mac Allister trailing, but Martín Zubimendi couldn't convert the resulting cutback. When Saka later forced a sharp save from Alisson, it felt like a matter of when, not if, the breakthrough would come. Yet, as the rain intensified, so did Liverpool's resolve.

Missed Chances

The visitors grew into the game, nearly punishing a rare lapse in concentration from William Saliba. The Frenchman's casual back-pass caught David Raya off guard, nearly gifting Liverpool

an opener. The woodwork then came to Arsenal's rescue when Conor Bradley's brilliant chip rattled the crossbar.

Liverpool's

much-maligned defense, which Slot later praised for their bravery, effectively neutralized Arsenal's record signing Viktor Gyökeres. The

Swede endured a night to forget, looking isolated and ineffective as the hosts went nearly the entire second half without a shot on target.



Ashes to Ashes for England

England's atrocious Ashes tour ended with a five-wicket defeat in the fifth Test that gave Australia a 4-1 series triumph on Wednesday.

Australia chased a target of 160 after lunch on the final day in the sunshine of the Sydney Cricket Ground.

Disrupted by injuries, including to captain Pat

Cummins, Australia dominated yet another Ashes on home soil - this was their fourth consecutive series win down under - and extended a hold of the urn that began in 2018.

For England, this was the conclusion of one of their most disappointing Ashes tours in recent memory.

In what was billed as a golden chance to at least compete in this country, the tourists never recovered from an astonishing implosion to lose the first Test in Perth in two days.

Hampered by a lack of adequate preparation, scrutinized for their off-field activities, then hit
