

# Starmmer's 'sorry' to Epstein victims

- Prime Minister's future in doubt after latest Epstein/Mandelson revelations
- Disgraced former Labour grandee and Ambassador to UK to be stripped of peerage

Sir Keir Starmer has apologized to the victims of Jeffrey Epstein for believing Lord Mandelson's "lies" and appointing him as the UK's ambassador to the US.

The prime minister began a planned speech on funding to improve local communities on Thursday by addressing the growing anger over how he had dealt with the issue.

While he acknowledged it had been publicly known for some time that Lord Mandelson knew Epstein, he said: "None of us knew the depths and the darkness of that relationship."

However, Conservative leader Kemi Badenoch said the PM's position was "untenable", while the Liberal Democrats called for a confidence vote to see if Labour MPs supported him.

The prime minister is facing calls from some of his own MPs to stand down.

Sir Keir's former political director Luke Sullivan said he thought the PM

was "fighting for his premiership".

He said: "I don't think you can understate how serious the situation and the peril is that the prime minister finds himself in."

Seeking to defuse the row in a speech earlier, Sir Keir said he regretted appointing Lord Mandelson and would not have done so if he had known what he knows now.

### climbdown

Directly addressing Epstein's victims, he said: "I am sorry, sorry for what was done to you, sorry that so many people with power failed you. Sorry for having believed Mandelson's lies and appointed him and sorry that even now you're forced to watch this story unfold in public once again."

Sir Keir has promised to release files, which he says will prove Lord

Mandelson lied about the extent of his friendship with Epstein when he was being vetted for the US ambassador role.

At the time, Lord Mandelson was appointed as US ambassador in December 2024, it was public knowledge that he had maintained a friendship with Epstein after his conviction for soliciting sex from a minor.

In 2023, the Financial Times reported emails suggesting he stayed at Epstein's Manhattan mansion in 2009, while the financier was in jail.

The PM said Lord Mandelson was asked directly about the nature of his relationship with Epstein before he was appointed as ambassador, whether he had stayed at his home after his conviction and whether he had accepted gifts and hospitality from him.



Starmer said Mandelson "portrayed Epstein as someone he barely knew".

"The information now available makes clear that the answers he gave were lies," he said.

"He portrayed Epstein as someone he barely knew.

"And when that became clear and it was not true, I sacked him."

Lord Mandelson's view is that he answered questions about his relationship with Epstein in the vetting process accurately.

Challenged after his speech over whether he should stand down as PM, Sir Keir said he understood the "anger and frustration amongst Labour MPs" over Lord

Mandelson.

However, he added: "I was elected on a mandate in 2024 to change the country for the better... that's what I intend to do." Jonathan Hinder, the MP

for Pendle and Clitheroe, said the PM's decision to appoint Lord Mandelson as US ambassador was a "catastrophic error of political and moral judgement".

# Mandelson lied to me, says Starmer after latest release reveals extent of his Epstein friendship

■ Emails exchanges between the two were peppered with friendly banter and casual, often disparaging references to Tony Blair and Gordon Brown

Prime Minister Sir Keir Starmer has said Peter Mandelson misled him about the extent of his friendship with convicted paedophile Jeffrey Epstein before he was appointed US ambassador.

Emails released by the US Department of Justice illustrate the depth of that friendship and appear to confirm that it continued, and even flourished, after Epstein's 2008 conviction.

In April 2009, while Epstein was still serving a prison sentence, he messages Lord Mandelson to say: "ahh... here we go again".

A few minutes later, Lord Mandelson picks up his Blackberry and re-

plies: "Meaning? At least I am not involved."

Epstein replies: "Your romantic complexities".

On the day Epstein is released from jail, in July 2009, the two friends appear to have been in a jubilant mood.

"Free and home," Epstein emails the then Labour peer at 08.37am on 22 July.

### 'firm and creamy'

"How shall we celebrate?" writes back Lord Mandelson, who at the time was business secretary under Gordon Brown.

"With grace and modesty (those are the names of two strippers)," Epstein

replies.

"From now on, grace and modesty should be discovered in London," Lord Mandelson appears to joke back a few hours later, before adding: "How is freedom feeling?"

"She feels fresh, firm and creamy," Epstein says.

Lord Mandelson responds with two words: "Naughty boy."

The tone of the messages from this time is often jokey and indiscreet, occasionally veering into excruciatingly frank.

They also suggest that the pair were in frequent phone contact in addition to emails, with one or the

other saying "call me".

The veteran Labour politician appears to have valued his wealthy friend's advice and support, on his political career as well as his private life.

When Lord Mandelson tells Epstein he is out of government in May 2010, and is at Labour Party headquarters for a "farewell" event for Gordon Brown, the disgraced financier offers a "big hug". Lord Mandelson jokingly replies "you won't leave me will you?"

In November 2009, the pair are discussing pressure on Gordon Brown to resign as prime minister. "What does tony [sic]

say?" Epstein emails, in what appears to be a reference to Sir Tony Blair, the previous prime minister.

"Talking to him tonight but he has said I should facilitate not initiate," Lord Mandelson writes back.

### 'always there'

Epstein responds, "tell gb [Gordon Brown] you see the winds blowing and you are loyal, first second and third [...] I don't suggest you tell him to step down...tell him you are his friend and am frustrated as much as he".

"He will immed[iate]ly push panic button," replies Lord Mandelson.

"Are you sure the backpressure from you[sic] lack of sex is not turning your brain into fois gras," Epstein writes.

"It's certainly a serious problem," Lord Mandelson seems to joke back. "Cure coming to London from S'hai [Shanghai] next weekend."

After his departure from government in May 2010, Lord Mandelson seeks Epstein's opinion on a draft of his memoir, *The Third Man*, which chronicles his role in New Labour's rise to power and his relationships with Brown and Blair.

Epstein seems to be concerned about the impact the book could have on Lord Mandelson's future business plans, which are the subject of several other exchanges.

"I have finished my first read [...] The deals you want to be involved in require discretion, trust, handshakes, privacy. This book announces that you are willing to sell all of these for a farthing," Epstein wrote as part of an email exchange dated 16 May 2010.

"Your friend, and boss, tony [sic], is more often described as frail, flustered, tired, weak, and Gordon, flawed, demanding, pig-headed, irrationally determined."

Epstein adds: "It is not uplifting, it is gossipy and defensive," saying he found the draft book "troubling" and recommending that Lord Mandelson look at his manuscript again.

By 2012, the friendship between the two men appears to have soured somewhat.

In one exchange, Epstein expresses his "disappointment" that their relationship has been a "one way street".

"... jeffrey can I have, jeffrey can you give jeffrey can you organize... can you call, can you arrange .. you have yet to offer real assistance, sign of gratitude or appreciation. ... sorry."

Lord Mandelson is apparently stung by Epstein's criticism and tells him in a reply "how much I appreciate your support," adding "during your trials and tribulations I never left your side, I was always there with advice and moral support, and I never turned away".

## Starmer wounded: but will he survive?

IT WAS less than two years ago that Sir Keir Starmer won the general election by an enormous margin: 411 MPs, a huge mandate that left the Tories in disarray and the new PM relishing the prospect of a comfortable five year stretch in which he could remake Britain according to his manifesto and vision.

How times change.

In the interim Starmer

has been forced into several embarrassing U-turns on keynote policies, he has seen his party eclipsed in the polls by a surging Reform UK and he has been faced with a rising tide of criticism, whispering campaigns and off-the-record briefings from restive members of his own party.

And with this week's hugely damaging revelations concerning the scope

of Peter Mandelson's friendship with Jeffrey Epstein, his future as PM looks in serious doubt.

On Thursday Starmer delivered an apology specifically to the victims of Epstein for having "believed Mandelson's lies" and appointed him to the UK's top diplomatic posting - British Ambassador to Washington.

But while his apology

was welcomed by some, to others in his party, who are keen to replace him with a more progressive, hard left leader, his words merely opened up the flesh in which they could twist the knife.

Labour MP Rachael Maskell said she thinks his position as prime minister is "untenable" and it is "inevitable" that he will have to stand down.

"I don't believe he's got a choice.

"He kept from the House [of Commons] for several months the fact that he knew of the associations between Peter Mandelson and Jeffrey Epstein at the point of appointment."

This was a "dishonourable thing to do" to MPs, as well as Epstein's victims, she added.

Another Labour MP, who did not want to be named, said: "I have to say, I don't see how he can carry on."

"It's been terminal for months," added another, "but the patient has now stopped responding to treatment."

# IT JUST GETS WORSE: Andrew and Epstein 'asked for a threesome' with stripper at financier's Florida mansion

■ "She was working as an exotic dancer, but she was treated like a prostitute."

Andrew Mountbatten-Windsor and Jeffrey Epstein asked an exotic dancer to "engage in various sex acts" at the late convicted sex offender's Florida home, a legal letter claims.

In a letter released as part of the latest tranche of Epstein files, the unnamed woman's lawyers said she had been offered \$10,000 to dance and that after she performed

Epstein and Mountbatten-Windsor had asked for a threesome.

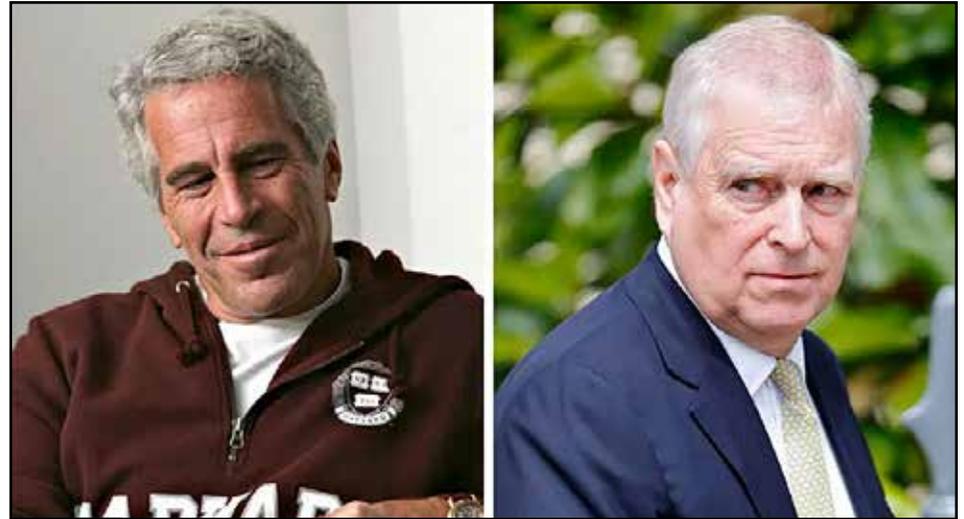
Lawyers said the woman had not been paid the promised amount and would keep the alleged 2006 encounter in which she was "treated like a prostitute" confidential in exchange for a payment of \$250,000.

Andrew has declined all requests for comment. He has always denied

any wrongdoing.

The letter, dated March 2011, claims that the woman and other exotic dancers from "Rachel's Strip Club" in West Palm Beach had been chauffeured to Epstein's house and offered \$10,000 to perform.

The document claims that she had seen "other young women dressed provocatively" at the party, some of whom "ap-

## Charles confronted over Andy's Epstein shame

KING CHARLES was forced outside his comfort zone this week as a heckler demanded to know why Prince Andrew has not been grilled by cops.

The Monarch's picturesque visit to an Essex village was soured when a man in the crowd launched a verbal broadside over the disgraced Duke's ties to billionaire beast Jeffrey Epstein.

As the King and Queen Camilla greeted well-wishers in Dedham, amid a typical February downpour while a local brass band fruitless played the Morecambe & Wise anthem "Bring Me Sunshine", the respectful tone was shattered by a man clutching a mobile phone who barked: "Charles, Charles! Have you pressurized the police to start investigating Andrew?"

### Deaf ear

The King appeared to turn a deaf ear to the shouting, even as a female reporter pressed him further on whether the Royal Family would assist with the ongoing Epstein probe. Police

were forced to intervene, leading the vocal protest away from the barriers as he told officers: "This is a way to make it clear to people that Andrew should not be let off".

The drama unfolded while the King and Queen met with domestic abuse charity Next Chapter and the Dedham Art Society, before the couple decamped to the local Sunn Inn pub, where Camilla tried her hand at making ravioli.

Local schoolchildren later performed for the Royal couple before Charles unveiled a plaque at the Essex Rose Tea-house.

The confrontation continues as fresh allegations swirl around Prince Andrew follow-

ing a massive "document dump" from the US Department of Justice. The files reportedly include images of the Duke and email exchanges with the convicted paedophile.

While locals like handyman Adrian Sharpe, 62, defended the King - noting that "what Andrew's done is what Andrew's done" - the shadow of his brother's "strenuously denied" friendship with Epstein continues to haunt Charles's reign.

The King and Queen eventually departed the village in a Bentley, but the echo of the heckler's questions remains a chilling reminder of the crisis still looming over the House of Windsor.

peared to be as young as 14 years old".

After she arrived, she was directed upstairs where she was introduced by Epstein to Mountbatten-Windsor, the letter says.

### 'sex acts'

It alleges: "My client then danced for the men, undressing until she was wearing only a bra and panties. Mr. Epstein and Prince Andrew then told my client they wanted to have a threesome.

"She said she was hired to dance, not to have sex. Mr Epstein said they would pay her later for dancing, and they prevailed upon her to engage in various sex acts."

The letter claims that "after the men had satisfied themselves" she was invited to take a trip with the pair to the Virgin Islands, which she declined.

Lawyers said she had only been paid \$2,000 of the promised fee of \$10,000.

The woman had not previously pursued the claims because she was "not proud of the circumstances of that night," the letter says. "She was working as an exotic dancer, but she was treated like a prostitute."

It is unclear whether the claim was ever settled.

Andrew moved out

of his home in Windsor to the Sandringham Estate in Norfolk.

He on Monday night and is currently living at Wood Farm while his permanent home undergoes renovations.

Buckingham Palace had said the move would happen in early 2026, but the fallout from the latest drop of Jeffrey Epstein files appears to have sped up his departure.

Pressure has been building on Mountbatten-Windsor to give ev-

idence in the US over his relationship with the paedophile financier. He has always denied any wrongdoing.

The Palace announced that he would be moving from Royal Lodge in October, at the same time his title of prince was removed.

The Sandringham Estate is privately owned by the King and he will pay the costs of his brother's new home. It is believed he will ultimately live at Marsh Farm on the estate.

## Fergie's Epstein emails show increasing desperation

Sarah Ferguson's image was once about her good-humoured ability to bounce back from misfortunes and embarrassment, but the latest Epstein emails appear to cast her in a different light.

She comes across as a needy figure, chasing money and support, more desperate than duchess - apparently describing herself to Epstein as "very traumatised and alone", and seeming to suggest she could be employed to "organize your houses".

But there are also glimpses of a life of privilege, as the same email mentions she's in the south of France with the "perfect butler".

The messages between Ferguson and Epstein almost seem like he's talking about someone on his payroll, such as asking her to show business contacts round Buckingham Palace - and her daughters get included too.

In a message to "Ferg" in March 2010, Epstein writes: "Thank you Sarah, could you are (sic) one of your daughters show (redacted) buckingham thanks."

An apparent reply from "Sarah" reads: "Of course."

That July, referring to a separate occasion, she apparently writes to Epstein apologising that "the girls were not around this weekend".

"Shows I don't crack the whip when I am not in the country!" the message continues. "Actually eugie was in france and beatrice was out with dave."

Epstein also messages to say a friend will be in London, adding:

## After approving, then disapproving, of the UK's Chagos deal, Donald Trump approves it again. At least for now.

■ Starmer 'got the best deal he could' says President after lengthy call with PM

First he approved it. Then he criticized it. Now he approves it again.

Donald Trump has backed off his criticism of the UK's deal to hand over the Chagos Islands to Mauritius and lease back a key military base, after a 'long and productive' phone call with the Prime Minister this week.

On Thursday, Donald Trump signalled his approval for the move, describing Sir Keir Starmer's agreement as the "best he could make".

It comes just a few weeks after the US president prompted fears in Whitehall that he would withdraw his support, after he branded the deal an "act of great stupidity".

Trump's comments led to additional talks between officials to confirm continued American support for the agreement, which will impact the future of a joint UK-US airbase.

### 'very productive'

The deal, originally announced last year, would see the UK transfer sovereignty of the Chagos Islands while releasing back the joint military base on the largest island, Diego Garcia, for an initial 99 years.

During a conversation on Thursday, the two leaders "agreed on the importance" of the deal to secure the base, Downing Street said.

A spokeswoman said they agreed the UK and US would "continue to work closely on the implementation of the deal".

In a post on his Truth Social platform earlier on Thursday, Trump wrote that his discussions with Sir Keir had been "very productive".

He added: "I un-

derstand that the deal Prime Minister Starmer has made, according to many, the best he could make."

"However, if the lease deal, sometime in the future, ever falls apart, or anyone threatens or endangers US operations and forces at our base, I retain the right to militarily secure and reinforce the American presence in Diego Garcia," he said.

Asked about Trump's comments, White House Press Secretary Karoline Leavitt told reporters: "He spoke with Prime Minister Starmer directly, he understands Prime Minister Starmer's position - and he supports it."

### 'total weakness'

"But as the president reiterated in that statement, of course, the United States reserves the right to protect our assets."

Warren Stephens, the US's ambassador to the UK, said while the "ideal" outcome would be for the UK not to transfer sovereignty of the Chagos Islands, it was the "best deal on the table for successive UK governments".

Echoing the president, Stephens said the US "retains the right to maintain and to reinforce our security interests on Diego Garcia if needed in the future".

The deal was originally announced last year, and had been endorsed by Trump and US officials. But last month the US president labelled it an "act of total weakness".

He added in a post on Truth Social: "The UK giving away extremely important land is an act of GREAT STUPIDITY, and is another in a very long line of National Security reasons why Greenland has to be acquired."

Trump's criticism of the agreement came

during an international row over his threats to take control of Greenland.

At the time, Sir Keir accused Trump of making the comments to pressure the UK over its support for the sovereignty of the Danish territory.

The comments threw into doubt whether the US would continue to support the Chagos deal. At the time, Downing Street said it believed the US still supported it, despite the president's com-

ments.

Officials in London and Washington have since been involved in talks to determine whether US support for the agreement still stood.

Those talks, which included two direct phone calls between Starmer and Trump, have now been completed.

A draft law to ratify the Chagos Islands deal is making its way through Parliament but has been delayed since the pres-

ident's outburst last month.

Sir Keir has insisted the deal is necessary to protect the continued operation of the base, amid previous attempts from Mauritius to dispute the legality of British sovereignty over the islands.

The deal has been heavily criticised by the Conservatives and Reform UK, who argue it undermines national security because of Mauritius's ties to China.

## 15-year old pupil charged with attempted murder after Welsh teacher wounded

**A 15-year-old boy has been arrested on suspicion of attempted murder after a teacher was injured at a school.**

Dyfed-Powys Police said officers were called to Milford Haven Comprehensive School in Pembrokeshire at about 15:20 GMT on Thursday.

Supt Chris Neve said they were responding to reports of the assault of a teacher by a pupil brandishing a weapon.

"The teacher's injury is not a stab injury. A lockdown was implemented but has now been lifted," he said.

Wales First Minister Eluned Morgan said "violence of any kind has

no place in our schools".

"All pupils at the location are safe and most have gone home," said Supt Neve, adding that the teacher is receiving medical treatment for their injuries.

He added that officers remained at the school, and that the 15-year-old boy was in police custody.

A Welsh Ambulance Service spokesperson said they were called to the scene and one patient was transported to hospital.

Pembrokeshire council said most pupils had now left the school and confirmed police officers remained on site.

"Any planned af-

ter-school events have been cancelled this evening," a spokesperson said.

Morgan, who visited the school last week, said her thoughts were with the injured teacher, their family and the entire school community, adding her government would support all those affected.

Mid and South Pembrokeshire MP Henry Tufnell said he was "very grateful to the school staff and our emergency services for their swift response in ensuring the safety of pupils and colleagues".

He described the local area as a "really close community".

# Snooker legend and commentator John Virgo dead at 79

■ **Player who fell just below the sport's elite enjoyed long second career as much-loved commentator**

**Snooker legend and BBC commentator John Virgo has died aged 79.**

Virgo enjoyed an 18-year professional career, winning the UK Championship and reaching the semi-finals of the World Championship in 1979.

He is perhaps best known for his post-playing career, presenting popular snooker TV show *Big Break* alongside comedian Jim Davidson from 1991 to 2002.

Following his retirement from playing in 1994, Virgo became a BBC commentator.

His last commentary for the BBC came 17 days ago when Kyren Wilson beat John Higgins in the Masters final.

Virgo was a popular

commentator, with his famous "where's the cue ball going?" catchphrase when a player was close to committing a foul.

Players and officials held a minute's silence at the World Grand Prix in Hong Kong on Wednesday.

Seven-time world champion Ronnie O'Sullivan said: "Finished my match to get the news that JV has passed away.

"Such a great mate who I loved spending time with. Absolutely gutted."

Four-time world champion Mark Selby said: "So sad to hear the news of the passing of John Virgo! Such a great guy and a huge character! He will be greatly missed! RIP JV."

Six-time world champion Steve Davis, who is part of BBC Sport's snooker coverage, said "one of our most loved friends has passed and our hearts are broken".

He added: "Our thoughts are with his family and it's become a day to reflect on how much this warm-hearted and funny maverick meant to us all.

"He was a brilliant commentator. Snooker fans couldn't help but be swept up in his enthusiasm in the moment. The Crucible will shed more than a few tears this April."

Former world champion Shaun Murphy, who also worked alongside Virgo for the BBC, said: "I first met John in

1994, filming *Junior Big Break*. He then went on to become a friend and colleague.

"I learned so much from him whilst sharing a commentary box. The voice of snooker will be sadly missed."

BBC Sport presenter Hazel Irvine said Virgo "was hugely loved and

is completely irreplaceable".

She added: "This is just such an immeasurable loss for snooker. It's a very tight-knit sport but it's an even tighter broadcasting community and it's a real shock because John was in such great form and voice just a couple of weeks ago at

the Masters.

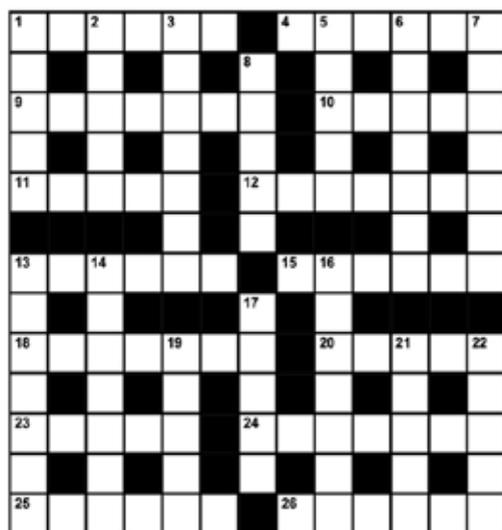
"He was a great champion himself and I think his experiences as a player really informed his commentaries."

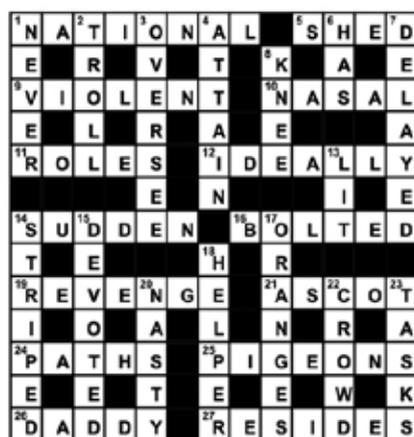

"Any chance of your daughters saying hello."

As more emails emerge, there's a growing impression of how much Ferguson seemed to depend on Epstein, telling him he was her "pillar" and confiding "I have been so so sad".

Some of the emails date from when Epstein was still serving a sentence for soliciting sex from a minor, according to the documents. He was released from prison on 22 July 2009 after serving 13 months of an 18-month sentence.

There are emails in the files from that June and earlier in the July from "Sarah".

An email from August

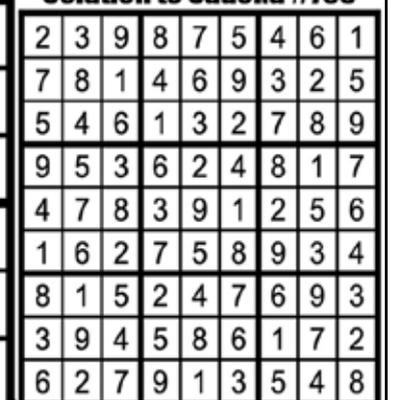
the following year reads: "I am feeling very traumatised and alone. I am wanting to work for you at organising your houses."

Referring to her former husband, Andrew Mountbatten-Windsor, Ferguson writes later in 2010: "So you have not forgotten about me. I do know that my handsome Prince is a saint.. And you worship him, I do too.

# As tensions simmer, Hoops boss calls for unity

Celtic interim chairman Brian Wilson has called for "unity behind the team" amid plans from some fans to boycott Saturday's Scottish Cup match against Dundee.

Supporters' groups have urged fellow fans not to attend the last-16 tie at Parkhead as they continue to demand change at the club.

Sections of the support remain unhappy with the board following what

they perceived as another underwhelming transfer window.

Fans have also criticised a lack of engagement from the Celtic hierarchy, but Wilson hopes supporters can unite behind Martin O'Neill's side.

"I don't expect suddenly all the issues to go away," he told Celtic TV. "What I've asked for, and what I think the great majority of Celtic supporters want to see, is unity behind the team."

"Let's sort out these other issues - and in no way am I dismissing them or marginalising them. Short term, it's imperative to support the team."

"It's up to each individual to decide whether a boycott inside the stadium or outside the stadium helps that. That's for people to judge."

Having recently replaced Peter Lawwell - who stood down as



Celtic's lack of investment in recent years has prompted a growing revolt

Celtic chairman at the end of December, citing 'abuse and threats' - Wilson accepted "there hasn't been as much engagement [with the fans] as I would've liked" in the past month.

Wilson says that has mainly been down to the transfer window being the priority, while he also praised O'Neill, assistant coach Shaun Maloney and the Celtic players for pulling themselves back into Scottish Premiership title contention.

Celtic's winter window was disrupted by the sackings of manager Wilfried Nancy and head of football operations Paul Tisdale in early January.

The club had recruit-

ed five players by the deadline, all of which were loans, and rejected a £25m bid from Nottingham Forest for midfielder Arne Engels.

After a "turbulent" month, Wilson says the club have "reached out to every supporters' group" and he is hopeful meetings can take place "within the next week or so".

"Let's see if we can go forward," he added. "There's no reluctance on my part to engage and I hope that can be put into practice soon."

"We're not going to agree on everything, but we can talk about [the issues]. But don't let it distract from what's going on inside the stadium, that's all I'm asking for."

One bright spot on the horizon is that the club are also in talks to sign former Arsenal and Liverpool midfielder

Alex Oxlade-Chamberlain.

It has been nine months since Alex Oxlade-Chamberlain last played - he was subbed on for 11 minutes in a Turkish Super Lig game - so what exactly would Celtic be getting should the 32-year-old sign?

After six years on Merseyside Oxlade-Chamberlain left Liverpool in 2023 with winners medals from the Champions League, Premier League, FA Cup, League Cup, Super Cup and Club World Cup.

At his peak the midfielder - a £35m signing for the Reds from Arsenal - was a pacy, dynamic and creative presence who could play anywhere across the mid-

field. But injuries have hampered his career and that explosiveness. He missed a year of football from April 2018 with knee ligament damage and was a bit-part player in his final season at Anfield following a hamstring problem.

Oxlade-Chamberlain sat out 105 Liverpool games because of injury. Despite that, the England international managed 18 goals and 14 assists in 146 appearances.

Martin O'Neill had nothing but praise for the player this week:

"He could play midfield for us, easily," O'Neill said earlier this week.

Chelsea, last reached the League Cup final in 2018.

The noise from the home supporters as Havertz's late strike rolled into the net signalled the significance of this victory for Arsenal.

The Gunners have not won a major trophy since they lifted the FA Cup in Arteta's first season in charge and, after three successive second-placed finishes in the Premier League, reaching a final feels like an important step in the grand plan to secure silverware.

Arteta was part of the backroom staff when Manchester City won their first trophy under Pep Guardiola, and saw the impact it had as they started a period of dominance.

Arsenal have built a squad packed with quality and are having an excellent season. They are top of the Premier League, through to the fourth round of the FA Cup, have a clean sweep of eight victories in the Champions League so far - and now a place in the EFL Cup final.

# Reds ink deal for 'the next Van Dijk'

**Liverpool have finalized a deal for Jeremy Jacquet in a deal worth up to £60m - but the defender will not move to Anfield until the summer.**

It would not be an understatement to say he was a name most people were unaware of at the start of the winter window.

To commit up to £60m - £55m up front before a potential £5m in add-ons - for a 20-year-old is a hefty call but Liverpool view the French centre-back as a long-term investment and someone who will form an integral part of their backline for years to come.

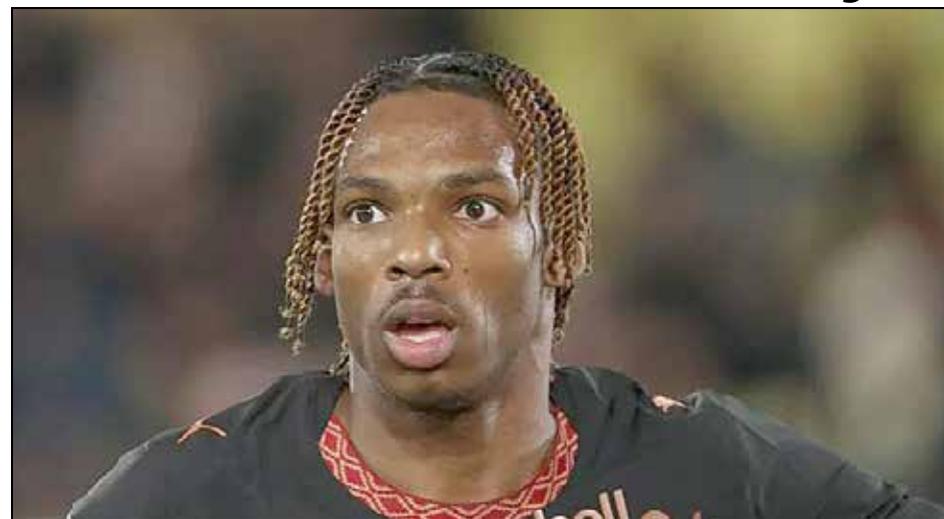
Given the club's defensive problems this season - they have conceded 33 goals from 24 Premier League games - and their ongoing injury crisis, it is also tell-

ing Arne Slot's side are prepared to wait until the summer for Jacquet, who will join from Ligue 1 Rennes.

The question of whether they could have got him now has a simple answer - Rennes are simply unwilling to sanction a move until the summer.

The French side are not in a rush for the money and adamant any fee for Jacquet would have to surpass their previous club record sale of £55.4m when Manchester City signed Jeremy Doku from them in 2023. Meanwhile, Liverpool are happy to wait, signing the player on a five-year contract until 2031, with the option for a further year.

They see Jacquet as a young defender with plenty of senior experience for his age

and their data analysis has backed the decision to spend so much on a player they believe has immense potential.

"It's a lot of money but Jacquet has everything to become one of the best centre-backs in the world in the next few years," said French football expert and ESPN's Julien Laurens. "He is

arguably the best centre-back of his generation.

"He's quite tall, quick and strong - and he's a machine when it comes to duels in the air and on the ground. He reads the game well and is good on the ball.

"He's not a proper ball-playing centre-back yet. Technically, there is

a lot to improve on, but he's a smart kid and he can get there and become like a Virgil van Dijk."

At Rennes, Jacquet has primarily played in a back three this season.

His strength in the air has been a standout this season, winning 75.51% of his aerial duels - the highest among Ligue 1 defenders in 2025-26.

## Premier League: all quiet on the transfer front

**The Premier League had its quietest ever winter transfer deadline day as just seven deals were completed on Monday.**

Not a single arrival was confirmed until 19:04 GMT - four minutes after the window

closed - with Crystal Palace announcing the signing of striker Jorgen Strand Larsen from Wolves in a deal worth up to £48m.

Clubs can make signings for up to two hours after the official deadline, as long as a deal sheet is submitted before 19:00 to provide extra time for the necessary paperwork to be completed.

There were five further deals confirmed after the deadline - among them, **Sunderland** brought in Ecuador winger Nilson Angulo from Anderlecht in a deal worth £17.5m, while **Wolves** signed midfielder Angel Gomes from Marseille on loan and replaced Strand

Larsen with Adam Armstrong from Southampton for £7m.

That took the overall spending in the Premier League during the winter window to more than £390m.

**Liverpool** did agree a deal on deadline day to sign defender Jeremy Jacquet from Rennes, but that move - and the payment of the £60m fee - won't happen until the summer.

**Crystal Palace** ended a horrendous January in fitting fashion - with Dwight McNeil's switch from Everton breaking down at the 11th hour.

Norway striker Jorgen Strand Larsen arrived from Wolves in a deal worth up to £48m but, seeing a loan agreement for McNeil with a £20m obligation to buy in the summer failing due to late paperwork, transfer deadline day would have done little to ease the fans' mood.

In signing Strand Larsen, Palace broke their

club record for the second time in the same window, having acquired forward Brennan Johnson from Tottenham for £35m early last month.

But with their captain Marc Guehi gone without a replacement found, striker Jean Philippe-Mateta wanting away but failing a deadline-day medical, manager Oliver Glasner already on his way out and a deal for McNeil breaking down, have the struggling Pal-

ace addressed the faults running through the spine of their team?

Palace are the second-biggest spenders behind Man City this month but appear to have merely stuck a glossy bandage over their problems.

Less than eight months ago, Palace fans were living a dream as their side won the FA Cup and qualified for a first-ever European campaign. They would have hoped for that triumph to be a

springboard for further success - a platform to grow and continue their upward trajectory under Glasner.

But it has proved anything but that.

Eberechi Eze, their match winner against Manchester City at Wembley, was the first to depart for Arsenal in a deal worth up to £68m in the summer. Eze scored 40 goals in 169 games for Palace and claimed 14 goals and 11 assists in all competitions last season.

# Another final date for City!

## EPL's top two set for Carabao Cup final showdown

Manchester City booked a tantalising Carabao Cup final against Premier League leaders Arsenal by hammering holders Newcastle 5-1 on aggregate in a one-sided semi-final.

Trailing 2-0 heading into Wednesday's second leg, Eddie Howe's side needed something special in Wednesday's return game at Etihad Stadium but endured the worst possible start as Omar Marmoush's sixth minute goal set City on their way to a 10th final in the competition.

Marmoush, starting in place of Erling Haaland, nipped in and saw a deflected strike loop over Aaron Ramsdale

and into the back of the net, while the Newcastle goalkeeper denied Tijjani Reijnders with a stunning save shortly after.

The visitors had chances to hit back but James Trafford did brilliantly to smother the ball at the feet of both Joe Willock and Anthony Gordon - and those near misses proved severe as they were punished by City thereafter.

Marmoush headed in from close range on the half hour mark and Reijnders slotted in a loose ball before half-time to make certain of the tie and allow the home supporters to enjoy a stress-free second period.

Anthony Elanga

pulled a goal back for Newcastle on 62 minutes with a fine curling effort and Harvey Barnes had another disallowed.

But the damage had long been done as Pep Guardiola's side confirmed their place in the League Cup final on Sunday, 22 March at Wembley Stadium.

In a week where uncertainty was cast on Guardiola's long-term future at City, the Spaniard saw his side take apart Newcastle to ensure another crack at glory.

"Wembley again, ole ole," was the chant from the home faithful at full-time as they prepare to visit the national stadium for the 22nd

time since Guardiola's appointment as boss in 2016.

City's last trip to the capital for a final ended in a shock FA Cup defeat by Crystal Palace in May, but Guardiola will have the opportunity to make amends by adding a 19th trophy to his illustrious career.

His first piece of silverware came in this competition in 2017, with Mikel Arteta by his side, but Guardiola's compatriot will now be aiming to plot his downfall and put an end to Arsenal's tag of 'nearly men'.

Next month's final not only pits master against his apprentice, but also the top two sides in English football - the Gunners looking to deal a psychological blow as they hold a six-point lead at the summit of the Premier League.

## Arsenal edge Blues again

Arsenal took a step closer to winning their first major silverware since 2020 as they beat Chelsea to reach the Carabao Cup final.

Leading 3-2 from the first leg, the Gunners had to wait until the 97th minute of Tuesday night's clash to seal their progress on a tense evening at the Emirates Stadium.

Substitute Kai Havertz scored the only goal of the night deep into injury time, rounding goal-

keeper Robert Sanchez before slotting home.

Mikel Arteta's men, who are top of the Premier League and still involved in three cup competitions, will face either Manchester City or Newcastle in the final at Wembley next month.

The hosts started the game in the ascendancy but, with Chelsea lining up with a back five, chances were limited in the first half.

Blues boss Liam Rosenior brought on attack-

ers Estevao and Cole Palmer on the hour mark in an attempt to spark his team into life, but Arsenal were able to keep them at bay.

That laid the platform for Havertz, who has only recently returned from injury, to seal Arsenal's aggregate victory with a cool finish in the closing seconds.

The Gunners, whose last major silverware came by virtue of an FA Cup victory over
