

# Interview Andrew NOW, former PM tells police

■ Gordon Brown makes surprise foray into roiling Epstein-Andrew scandal

The former Prime Minister, Gordon Brown, has called for detectives to interview Andrew Mountbatten Windsor about allegations that Jeffrey Epstein trafficked women and girls through the UK.

Mr Brown says he's been told privately that investigations related to the former prince did not properly check what he describes as vital evidence of flights. Thames Valley Police, meanwhile, has confirmed its assessing allegations of misconduct in public office.

### British girls

Writing in the influential left-wing newspaper The New Statesman, Mr. Brown said the emails released by the US Department of Justice suggest a number of British girls were on 90 flights linked to Epstein that used UK airports. He adds that 15 of these flights were given the go-ahead after Epstein's conviction in 2008 and says how this was allowed to happen should be fully investigated. Mr Brown also criticized the Metropolitan Police for stating that any investigation into human trafficking would be largely focused on activities and relationships outside the

UK and suggesting that the problem was a US issue."

He writes he has asked the Met urgently to re-examine their decision making. He alleges that investigations related to the former Prince Andrew didn't properly check vital evidence of flights. The former Prime Minister goes on to say he's asked the police to look at this as part of an inquiry and that the claims required detectives to interview Andrew.

### opportunities

Separately, Thames Valley Police says it is assessing allegations relating to misconduct in public office, in relation to claims that the former Prince shared official documents with Mr. Epstein when he was a trade envoy. On Wednesday afternoon the force said it had held discussions with specialist prosecutors from the Crown Prosecution Service about the allegations and was making

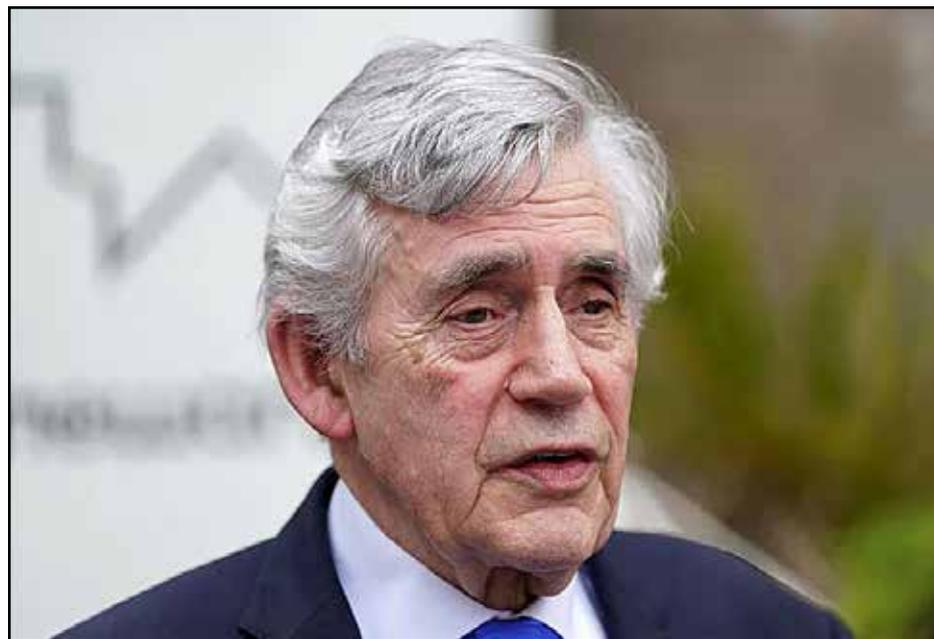
progress 'as quickly as possible'.

According to a report from the BBC, a briefing prepared for the then Duke of York by UK government officials in 2010 outlined investment opportunities in Afghanistan, focusing on commercial opportunities from significant high-value mineral deposits in Helmand Province, such as gold and uranium and possibly oil and gas. Trade envoys have a duty of confidentiality and Sir Vince Cable was the business secretary at the time and is highly critical in response to the claims.

### secret plan

"Well, I've heard of the information that's available on the leak of these documents and passing them to Epstein. I mean, really is appalling behaviour and a breach of trust. I mean, whether it's a criminal matter is a matter for the police."

It had emerged later in the week from files

released by the US Department of Justice that Andrew hatched a secret plan 13 years ago to make money from his connections to rich individuals and state institutions. This involved Howard Lutnick, who is now President Trump's Commerce Secretary. Jeffrey Epstein helped in these negotiations.

The documents show that in 2013, Mr Lutnick's firm planned to lend the then Prince one million pounds in a joint venture to attract wealthy investors and split the resulting fees 50-50. The former Prince had made valuable con-

tacts both as a member of the Royal Family and as a trade envoy for the UK between 2001 and 2011. The email chains involve Andrew, his representatives, Jeffrey Epstein and How-

ard Lutnick's lawyers at Canter Fitzgerald, the investment firm he part owned and ran for three decades until he was appointed to the Trump administration last year.

# Mandy scandal: Heads roll as Starmer clings to power...for now

**SIR Keir Starmer's entire cabinet came out this week in a coordinated show of support for the Prime Minister, after the leader of the Scottish Labour Party, Anas Sarwar, publicly called for him to step down.**

In a turbulent week at Westminster amid the fallout from the Peter Mandelson-Jeffrey Epstein scandal, several leading Labour figures suggested that perhaps Starmer's time was up.

But in the end, several high profile resignations from No. 10's inner circle - most notably chief of staff Morgan McSweeney - seems to have quelled a growing rebellion. At least temporarily. The following day, Keir's Director of Communications, Tim Allen, followed suit.

McSweeney had been at the centre of Sir Keir Starmer's Labour project from its earliest days. The man who ran his bid to become party leader in 2020 and masterminded his remaking of the party. He's been at the heart of the political operation and decision-making process at number 10.

Announcing his depar-

ture, McSweeney said he took full responsibility for having advised the Prime Minister to appoint Lord Mandelson as the UK's ambassador to the US. In a statement Mr McSweeney said the decision to appoint Mandelson as US ambassador was wrong, accusing him of damaging the party, the country and trust in politics itself. He said he wanted to remember the women and girls whose lives had been ruined by Epstein and called for a fundamental overhaul of the government's due diligence and vetting process.

## 'genuine friendship'

Sarwar had truly set the cat among the pigeons with his startling speech 24 hours earlier, calling for the PM to quit. He told reporters: "This isn't easy and it's not without pain, as I have a genuine friendship with Keir Starmer. But my first priority and my first loyalty is to my country, Scotland. And I am not willing to sacrifice Scotland's NHS, our schools, our communities, our towns, cities, villages and

islands to a third decade of an SNP government.

That's why the distraction needs to end and the leadership in Downing Street has to change."

But the backing of his Cabinet, including possible leadership rivals such as West Streeting, Shabana Mahmood and on the backbenches, Angela Rayner, seems to have stemmed the tide for Starmer.

## combative mood

The PM himself was in combative mood at the dispatch box this week, telling a febrile House of Commons: "There are some people in recent days who say the Labour government should have a different fight, a fight with itself, instead of a fight for the millions of people who need us to fight for them. And I say to them, I will never walk away from the mandate I was given to change this country. I will never walk away from the people that I am charged with fighting for. And I will never walk away from the country that I love."

The Labour Mayor of Greater Manchester,

Andy Burnham, widely seen as a threat to Sir Keir, said the Prime Minister had his support at a crucial moment and pitched a change of tack.

"What we all need to do now is drive the pace of change more quickly. And that means greater unity. And I think we are at a generational moment in politics.

"I think recent events have kind of really drawn a heavy line under a political culture that was kind of too close to wealth and power and too distant from the lives of people that we're talking about."

But this being Westminster, his enemies are not likely to let the matter rest anytime soon.

Conservative Party leader Kemi Badenoch launched a blistering critique of the PM on Tuesday, telling the house: "He (Starmer) is in office, but not in power. He is completely at the mercy of Labour MPs, who, let's be frank, have not been voting his way since the U-turn on the two-child benefit cap."

## Ratcliffe 'sorry' for 'colonizers' quip

**British billionaire Jim Ratcliffe said on Thursday he was sorry he had offended some people by saying the country had been "colonised by immigrants", after Prime Minister Keir Starmer joined a chorus of criticism over the remarks.**

Ratcliffe, one of Britain's most successful businessmen, responded to the outcry with a statement saying it was important to raise the issue of immigration, but that he regretted his "choice of language" had caused concern.

The founder of chemicals giant INEOS, and owner of nearly a third of Manchester United, had previously told Sky News that high migration and people living on benefits were damaging the economy.

"You can't have an

economy with nine million people on benefits and huge levels of immigrants coming in. I mean, the UK has been colonized - it's costing too much money," Ratcliffe said in the interview aired on Wednesday.

"The UK has been colonized by immigrants, really, hasn't it?" he added.

Starmer said the re-

marks were wrong and would play into the hands of those who wanted to divide the country. Finance minister Rachel Reeves said the comments were "unacceptable" and "disgusting".

On Thursday, INEOS issued a statement from Ratcliffe in response to "reporting of his com-

## Last Post for Scottish D-Day veteran

One of Scotland's last surviving D-Day veterans has died at the age of 100.

Albert Lamond was 18 years old when he played a key role in the Allied invasion of Normandy in 1944 to help liberate France from Nazi Germany. Mr Lamond's family said he'd never thought of himself as a hero.

Lamond joined the Royal Navy days after his 17th birthday. He was a signalman on HMS Rowley helping to liberate France from the Nazi occupation, protecting a battleship off the coast of Normandy, a battle that changed the course of history. Speaking to the Erskine Veterans Charity, he remembered seeing soldiers landing on the beaches.

### "human cost"

"Hundreds of thousands of men gunned us over and they went from the sea onto the beach, from the landing craft onto the beach. Some of them never made it."

After D-Day in 1945, Mr Lamond helped in the rescue of prisoners of war from remote islands in the Pacific.

His family said he believed he was just doing his duty.

His nephew Richard Copeland described him as "a quiet, unassuming, modest man, cheeky and great fun, but a gentleman and never makes a fuss."

"Mr Lamond said what he saw would live with him forever and it was vital that future generations never forgot the human cost and sacrifice of war."

# 'I just want him home', says wife of Irish man detained by ICE

■ Seamus Culleton tells of 'concentration-camp' like conditions in detention center

An Irishman living in the United State for more than 20 years has been held by US Immigration and Customs Enforcement (Ice) officials since being arrested last September.

Originally from Glenmore, Co Kilkenny, Seamus Culleton is married to a US citizen and owns a plastering business in the Boston area. He was arrested on September 9th, 2025, and has been in an Ice detention facility in Texas for nearly five months, despite having no criminal record, "not even a parking ticket". In a phone interview from the facility, he said conditions there are "like a concentration camp, absolute hell".

### work permit

Culleton said he was carrying a Massachusetts driving license and a valid work permit issued by the US government when he was pulled over by Ice on the way home from work in September. His work permit was issued as part of an application for a green card which he initiated in April 2025. He has a final interview remaining.

ments".

"I am sorry that my choice of language has offended some people in the UK and Europe and caused concern but it is important to raise the issue of controlled and well-managed immigration that supports economic growth," he said.

He said he wanted to stress that governments must manage migration alongside investment

After his arrest, Culleton was allowed a brief phone call to his American wife Tiffany Smyth. She said she "broke down and cried. To know he was just taken, and he or I had no idea where they were taking him, was traumatising".

Mr. Culleton's wife, Tiffany Smith, speaking a press conference this week, has said she wants her husband "home where he belongs" and described the experience as "overwhelming".

### 'good man'

A US government spokesperson said Culleton was offered the chance to be sent to Ireland, but he "chose to stay in ICE custody" after he was issued a final order of removal by an immigration judge.

On Wednesday, Culleton's wife told reporters: "Seamus is a good man, he doesn't deserve what is going on. It's heartbreaking, it's absolutely heartbreaking".

"I don't know how I've gone on these past five months to be honest. It's been awful. I don't wish this upon anybody," she added.

Culleton's lawyer Ogor Winnie Okoye has called for his immediate release, and for him to be allowed to complete the process of applying for his green card.

Okoye said she saw him two weeks ago: "He did not look well, he looked like he had lost about 30-40 pounds. He looked yellow, like someone who has jaundice."

Smith said she had last spoken to her husband "this morning".

"We have normal conversations, he asks me about my day, tells me to have a good day at work," she added.

### visa waiver

"We're both just trying to stay positive".

She said the pair are hopeful they "can finish what we started".

"We tried to do everything the right way, that you're supposed to do".

"Let us at least finish that," she concluded.

Culleton entered the United States in 2009 under the visa waiver program, which allows people to stay in the US for 90 days without needing a visa.

While he had previously been undocumented in

the US, Culleton's lawyer said he was in the final stages of receiving his Green Card and had a valid work permit.

Speaking to Irish broadcaster RTE this week, Culleton said he had been locked in the same room with 71 other detainees in what he described as squalid conditions and with insufficient food and negligible time outside for fresh air, sunshine or exercise.

"You don't know what's going to happen on a day-to-day basis."

"You don't know if there's going to be riots, you don't know what's going to happen. It's a nightmare down here."

He said showers and toilets were "filthy" and daily meals were child-sized, "so everybody is hungry". He added: "This place is best described as a modern day concentration camp."

Culleton said he was trying to stay positive: "I try my best. I talk to my wife every day, she's my rock."

"I talk to my mother and sister most days. They're all rooting for me."

Speaking in the Dáil on Tuesday, Taoiseach Mi-

cheál Martin said there are "five to six" cases of Irish citizens detained by ICE

He said the government's position is that they will do everything they can to help Culleton.

The taoiseach added that efforts to assist him had to be done in a way that could really help him and be effective.

### 'full due process'

In a statement on the case, Department Of Homeland Security assistant secretary Tricia McLaughlin said: "On September 9, 2025, ICE arrested Seamus Culleton, an illegal alien from Ireland".

She added: "He entered the United States in 2009 under the visa waiver program, which allows you to stay in the US for 90 days without a visa. He failed to depart the US. He received full due process and was issued a final order of removal by an immigration judge on September 10, 2025."

She said Culleton was offered the chance to be removed to Ireland but he "chose to stay in ICE custody, in fact he took affirmative steps to remain in detention".

## Bad news for UK on coveted transparency rating

"The UK has recorded its worst ever score in an annual corruption index published by the group Transparency International.

Each year, the Watchdog compiles surveys of business people and experts for their views on the level of bribery and abuse in public office around the world. The UK came 20th out of 182 countries, below the likes of Denmark, Singapore, Switzerland and Germany, but ahead of France and the United States.

The UK was once in the top 10 of Transparency International's rankings, perceived as one of the least corrupt countries in the world. But over the past decade, it's fallen back. It now sits in 20th place with its worst ever score.

The organisation warned that scandals such as Lord Mandelson's friendship with the late sex offender Jeffrey Epstein do huge damage to public trust. But it also said record levels of political donations and troubling reports of cash for access arrangements risk making corruption concerns the new normal.

More broadly, Transparency International said western democracies were failing to provide robust leadership. The report said: "Corruption is getting worse across the globe. And what is very concerning is that it's also getting worse in well established democracy and why. What we see is actually blurred lines between public and private interests.

"We see lack of leadership in driving anti-corruption reform."

The United States also saw its score on the index fall to a new low.

## Jailed: the pot grower who rigged his house with lethal traps after watching "Home Alone"

A man who rigged his house with "Home Alone-style" booby traps, including a flamethrower and tripwires, to protect his drugs enterprise has been jailed.

Ian Claughton, 60, "heavily fortified" three properties in Grimethorpe, Barnsley, with fishing wire, adapted crow-scarers and homemade pipe bombs to protect his cannabis growing operation.

Claughton and his ex-wife Lesley, 59, who "assisted and encouraged" his criminality, were found guilty of drug and firearms offences following a trial at Doncaster Crown Court in November.

At Sheffield Crown Court on Tuesday, Ian Claughton was sentenced to seven years in jail, while Lesley was handed a 21-month sentence, suspended for two years.

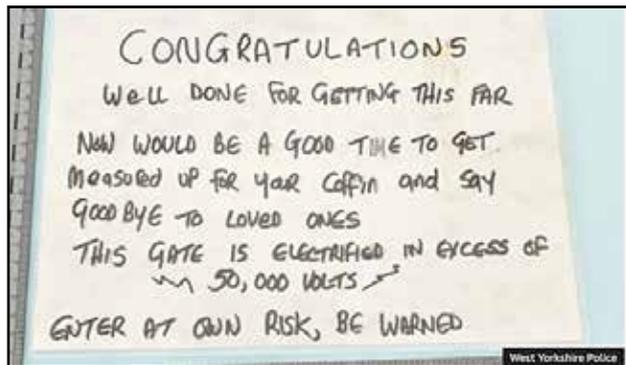
### imitation firearms

Their trial heard police raided the couple's properties in Brierley Road in May 2024 after Border Force officers discovered imitation firearms in a parcel addressed to Lesley Claughton.

About 100 neighbouring properties were evacuated while specialist detectives from the Yorkshire and Hum-

His co-defendant, Mohamed Kabir, who is also an Afghan asylum seeker, was found not guilty of strangulation, attempted child abduction and at-

ber Regional Organised Crime Unit (YHROCU) searched the Claughton's homes.

Inside, officers initially found two primed mantraps, two potential firearms and four large plastic bags of cannabis buds, with an estimated value of £16,000.

### trip wires

During police interviews, Ian Claughton said the devices were "crow-scarers", similar to banger-type fireworks, which he had attached to trip wires to deter anyone breaking into his home.

A cannabis growing set-up with 24 plants was found hidden in a secret room at one next-door property, and, at his ex-wife's home, 1.5kg of amphetamine was found.

An array of imitation firearms were also found along with a crossbow and a home-made flamethrower, fashioned from

a fire extinguisher filled with petrol.

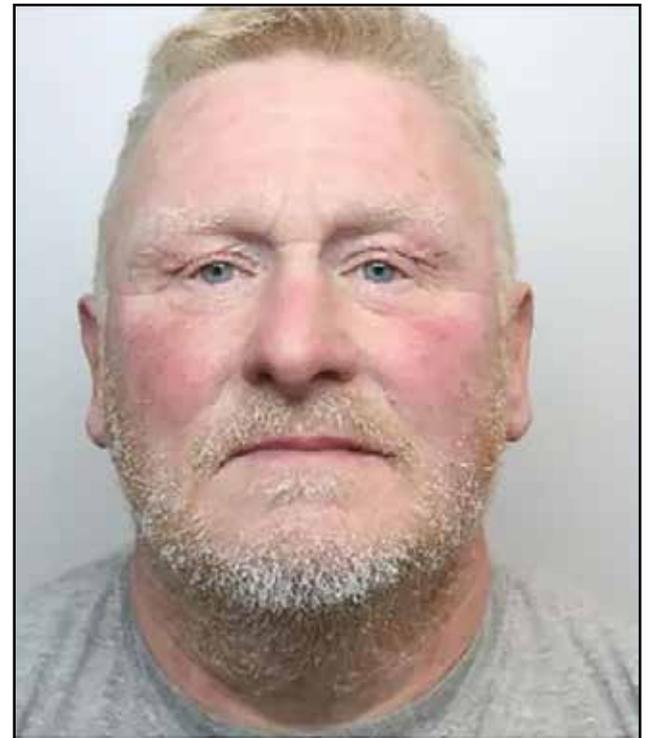
Claughton was seen demonstrating it on a video recovered from his phone.

A large amount of cash was recovered, including £27,000 found stitched into a sofa, which the couple initially claimed had been obtained from car boot sales and inheritance.

Claughton told police he had ordered the imported "switch guns", believing they were blank firers and intended to use them at a themed birthday party.

Police said he claimed the amphetamine was his to use for weight loss and chronic fatigue, and that he had been growing the cannabis under duress and threats from unnamed others and that he had not benefited financially.

Ian Claughton told jurors the fire extinguisher-turned-flamethrower had been used to "wow"

people during Bonfire Night and that he got the inspiration for his booby traps from the Macaulay Culkin film Home Alone.

### 'siege mentality'

Before the trial Ian Claughton pleaded guilty to bringing a realistic imitation firearm into Great Britain, being concerned in production of a controlled drug of Class B, namely cannabis, and possession with intent to supply a controlled drug of Class B, namely amphetamine and cannabis.

He was later found guilty of two counts of possession of a firearm, possession of criminal property and possession of explosive substances.

Lesley Claughton was

found guilty of bringing a realistic imitation firearm into Great Britain, possessing Class B drugs with intent, possessing criminal property and being concerned in production of Class B drugs.

Senior investigating officer, Det Supt Al Burns, of the YHROCU, said Ian Claughton had been involved in drugs offending to a "very significant degree".

"He appears to have developed a siege mentality that saw him go to unusual and elaborate lengths to defend his home and its illicit contents from would-be intruders, drawing inspiration from Macaulay Culkin's character in the popular Christmas film Home Alone," said Burns.

## Afghan asylum seeker guilty of rape of 12-year-old

tempting to commit a sexual offence.

The 12-year-old girl was in a park in Nuneaton one evening last July when she was approached by two men. One of them, Ahmed Moulikhail, led her to a quiet cul-de-sac and raped her. He'd already admitted one count of rape.

On Wednesday, he was convicted of a further

count of rape, child abduction and making indecent images of the girl.

Detective Chief Inspector Colletto Keefe from Warwickshire Police said the victim's entire life had been affected: "She's got to live with this for the rest of her days. And I think that to come forward in the way that she has, she's extremely brave, which, you know, at that age, I

think it just shows really how robust she is."

The case sparked protests and accusations of a cover-up. Police didn't initially say Muller Keel was an asylum seeker from Afghanistan who'd arrived on a small boat four months earlier. This prompted a change in guidance, as Superintendent Steve Flavel explained.

"The response from Warwickshire Police in respect to the communication that went out at that time was in line with what the guidance was. As we now know, national guidance has since been changed, and as a result of that, we would now look at, on a case-by-case basis, releasing that information that wasn't released at that time."

# 18-year sentence for 'utterly wicked' nursery worker who abused his young charges

An "utterly wicked" nursery worker who filmed himself sexually abusing young children in his care in north-west London has been jailed for 18 years.

Vincent Chan, 45, admitted 56 charges including sexual assault by penetration, possession of indecent images and voyeurism.

Judge John Dodd KC told Wood Green Crown Court that Chan was a "perverse and depraved" man who had "clearly lost all sense of moral compass".

He filmed himself abusing young chil-

dren at the Bright Horizons nursery in Finchley Road, West Hampstead, between 2007 and 2017.

Chan, who was sentenced to a further eight years on extended licence, amassed a collection of at least 26,000 indecent images online, including clips of children being raped.

Judge Dodd said the mass of images and videos found by police clearly displayed Chan's "deep-seated sexual obsession" with children, adding that he had breached the trust of children and parents "in the most de-

spicable of ways".

He added that Chan's offending "escalated and became far more serious" after he left his job at a primary school in 2017 and started work at the nursery.

In total, Chan admitted five counts of sexual assault by penetration, four of sexual assault by touching, one charge of sexual assault on a female, 23 counts of taking indecent images of children, six charges of making indecent images of children, six counts of outraging public decency, and 11 charges of voyeurism.

He was first reported by the nursery in May 2024 over concerns that he had been "filming children in his care who were clearly distressed, superimposing audio or imagery over the videos in an apparent attempt at humour".

He was first arrested on suspicion of child neglect, but searches of his electronic devices led officers to discover his sexual offending.

The Metropolitan Police additionally discovered that Chan had taken upskirt videos of girls in class

when he worked as a teaching assistant at a primary school in Finchley, north London.

He also confessed to spying on girls and women as they got undressed in their bedrooms and used the toilet, as well as sexually assaulting a woman as she slept.

In impact statements, young victims said they had been left devastated and were

coping with lasting trauma after being told about the abuse.

Families said his offending at the nursery and school - labelled "every parent's worst nightmare" - had shattered their trust.

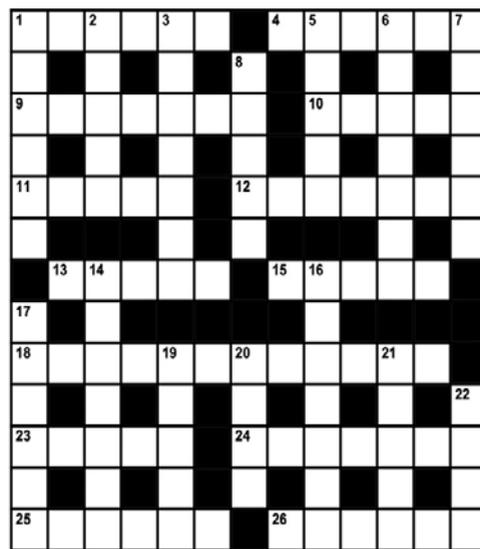
One woman covertly recorded said she felt "violated and humiliated" and was now paranoid about using the bathroom.

Another woman who testified in court that she was sexually assaulted as she slept called Chan "a person who shows a total disregard for human dignity".

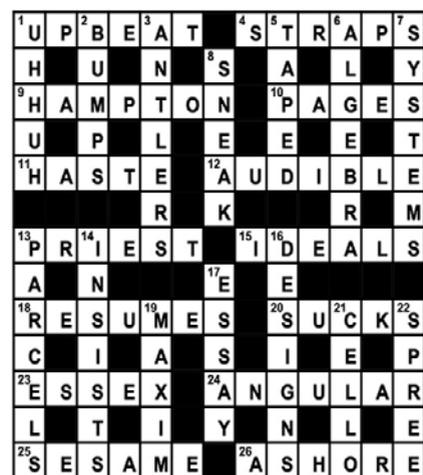

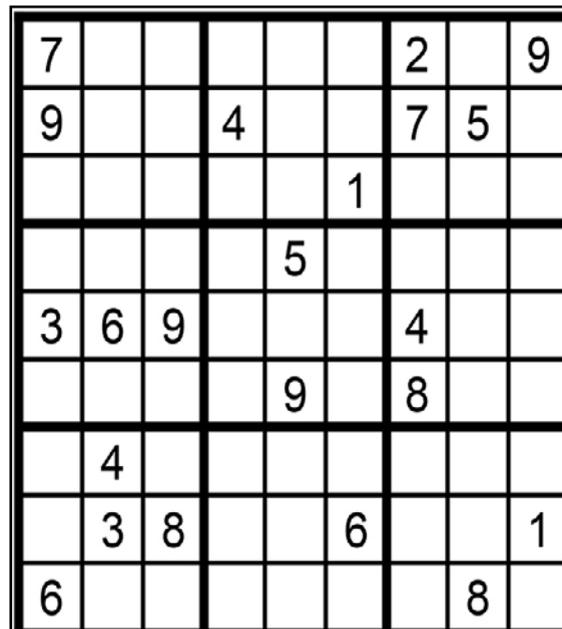

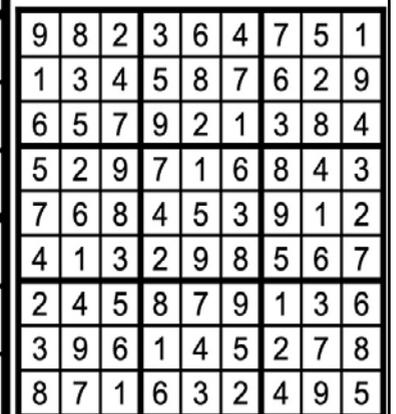

Both sides had chances to win it late on, with Igor Thiago denied by an excellent tackle from Cristian Mosquera and Arsenal's Martinelli denied by Kelleher in stoppage time.

Arsenal will be disappointed with the manner of this draw despite Brentford only losing twice at home this season.

The Gunners struggled to break down their resolute opponents in the first half, with centre-back Gabriel Magalhaes having their best opportunity from a corner.

Arteta gave England international Eberechi Eze his first start in the league since December, but the number 10 did not take his chance with Kai Havertz out of the squad and was replaced by captain Martin Odegaard at half-time.

## Pereira closes in on Wolves job

Nottingham Forest are close to appointing former Wolves boss Vitor Pereira as their new head coach.

The Premier League club Sean Dyche shortly after being held to a goalless draw by bottom club Wolves on Wednesday, leaving them three points above the relegation zone with 12 games remaining.

Forest had opened

talks with Pereira and those discussions are understood to have progressed with an agreement now described as close on Thursday night.

The 57-year-old quickly emerged as the preferred option to replace Dyche, having worked previously under Forest owner Evangelos Marinakis at Greek club Olympiacos.

Pereira was credited

for keeping Wolves in the Premier League last season having joined midway through the campaign, but he was sacked in November with the club on two points from 10 matches.

The Portuguese is in line to become Forest's fourth manager of the season following Nuno Espirito Santo, Ange Postecoglou and Sean Dyche.

and as a coach there is nothing more you want than to compete with the very best on the biggest possible stage," he added.

Tuchel's backroom staff - Anthony Barry, Henrique Hilario, Nico Mayer and James Melbourne - have also signed contracts through to summer 2028.

Tuchel guided England to eight wins from eight matches in World Cup qualifying and they will play Croatia, Ghana and Panama in their group at the finals.

News of his extension coincides with the former Chelsea manager attending Thursday's draw for the 2026-27 Nations League.

On this decision, the FA had to weigh up two different scenarios.

Letting Tuchel go into a World Cup with a contract coming to an end, or signing him up with a new deal.

And one outcome on that really resonated.

Tuchel's body of work as England manager will mean the team goes to North America as one of the favourites to win the tournament. If they didn't move and England did well, they would be open to criticism amid the expected manager market this summer.

So, while there is a chance they have signed someone up for longer when the side might not deliver, it was felt the bigger risk was not doing so.

If England do underachieve, the option of terminating the agreement is of course open to the FA just as it would be in club football.

This answers the question of why you would reward a manager with a new deal, which will likely include a pay increase on his reported £5m salary, before he has even completed the original job.

## ANGE: Spurs 'not a big club'

Ange Postecoglou has criticised Tottenham's transfer strategy while claiming his former side are "not a big club" in the wake of Thomas Frank's sacking.

Frank, who replaced Postecoglou as head coach last summer, was sacked on Wednesday with Spurs five points above the Premier League relegation zone.

Speaking on The Overlap's Stick to Football podcast, the Australian praised the club's "unbelievable" facilities but said financial limitations meant they could not sign his main targets, such as Pedro Neto, Bryan Mbeumo, Antoine Semenyo and Marc Guehi, in 2024.

"When you look at their expenditure and particularly their wages structure, they're not a big club," he said.

"I saw that because, when we were trying to sign players, we weren't in the market for those players."

Portuguese forward Neto joined Chelsea in a £54m deal in 2024, Mbeumo moved to Manchester United for £65m last summer, while Semenyo and Guehi moved to Manchester City for a combined £85m last month.

Postecoglou guided Spurs to fifth in the Premier League during his first season in charge, but he was sacked after a 17th-placed finish the following season. He did, however, end the club's 17-year wait for silverware by winning the Europa League in 2025.

"I think they didn't realise that, to actually win, you've got to take some risks," he said.

"I felt like Tottenham as a club were saying, 'we're one of the big boys', and the reality is I don't think they are."

## Tuchel signs new England contract

**Thomas Tuchel has extended his contract as England manager through to Euro 2028.**

The German took charge in January 2025 on a deal that was scheduled to run until this summer's World Cup.

Tuchel said it was "no secret to anyone that I have loved every minute so far" and that he was "very happy and proud" to continue in the role.

The 2028 European Championship finals are being hosted by England, Wales, Scotland and the Republic of Ireland, and it is understood Tuchel views leading the side

into a home Euros as a rare opportunity.

For its part, the Football Association (FA) was keen to ensure continuity and remove speculation over Tuchel's future heading into the World Cup.

'potential distraction' The 52-year-old had been strongly linked with Manchester United, where Michael Carrick is in charge until the end of the season.

It was not the first time he had been viewed as a potential manager at Old Trafford and Tuchel is said to have met with United co-owner Sir Jim

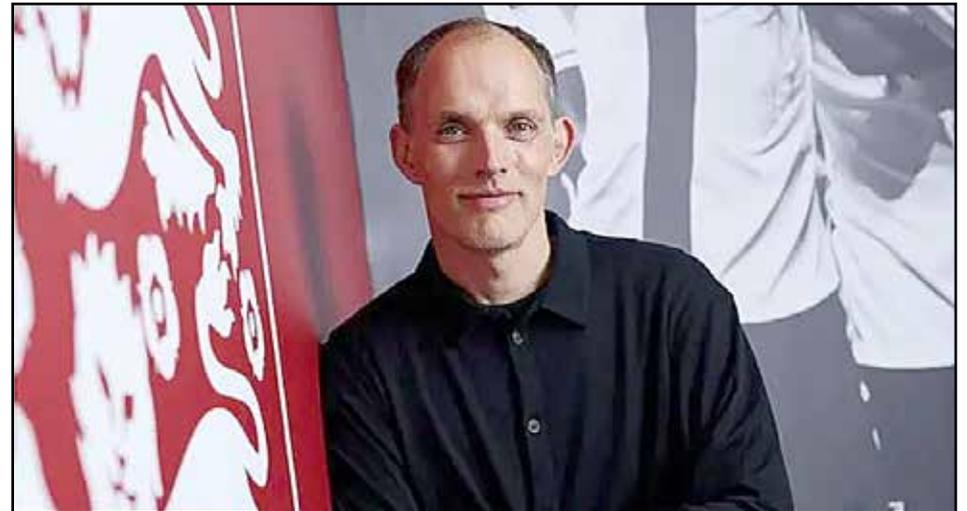
Ratcliffe in France in 2024 when the club were considering replacing Erik ten Hag.

FA CEO Mark Bullingham said Tuchel's extension would ensure the England squad and staff were fully focused on the World Cup.

"We know the players are right behind him, and the togetherness within the group is there for all to see," said Bullingham.

"By securing them early for 2028, we have taken away the potential distraction of contract negotiations around the tournament."

Last November Tuchel

said the England role had "re-energised" him and that he would be open to extending his time in charge, having initially been the driving force behind signing an 18-month

contract that would give him time to see how he felt in the job.

In a statement announcing his new deal, Tuchel said he had received so much support

from the FA and fans "that I did not hesitate when asked to continue in this dream job".

**Arsenal missed the chance to restore their six-point lead at the top of the Premier League in a frustrating draw at Brentford on Thursday.**

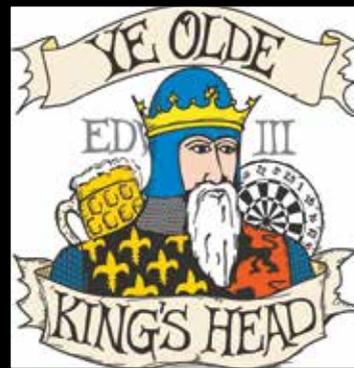
The Gunners' lead at the top was halved when Manchester City beat Fulham on Wednesday and Mikel Arteta's side faced a tough assignment against a Brentford side who had lost just twice at home this season.

It was a subdued performance in the first half as Arsenal struggled to break down a well organ-

ised Brentford side, but they took the lead in the 61st minute when Noni Madueke headed Piero Hincapie's cross back across goalkeeper Caoimhin Kelleher.
