A DRAMATIC new chapter in the fallout from the Epstein affair began on Thursday with the arrest of Andrew Mountbatten-Windsor.

The former Prince Andrew was taken into custody early Thursday morning at his Norfolk home and questioned during the day in relation to a probe into official misconduct stemming from his time as a UK Trade Envoy more than a decade ago.

Thames Valley Police confirmed it had 'arrested a man in his 60s in Norfolk and was carrying out searches at addresses in Berkshire and Norfolk'.

King Charles III said the "law must take its course" in response to Andrew's arrest and that the police had his "full and wholehearted support and co-operation".

Police had previously said they were considering investigating Andrew over allegations relating to his association with the late sex offender Jeffrey Epstein and were reviewing allegations he shared confidential material.

Communications between the pair featured among the tranche of files released by the US government last week.

In an updated statement on Thursday evening, Thames Valley Police confirmed the man "had been released under investigation". It added that its searches in Norfolk had now been concluded.

privileged access

The former prince was pictured slumped back in the back seat of a vehicle after leaving Aylsham police station.

This is the first time Andrew has been arrested. He has consistently and strenuously denied any wrongdoing.

Thames Valley Police said that, following a "thorough assessment", a formal investigation had now been opened.

It also said earlier in February that it was as-

sessing a separate allegation that a second woman was sent to the UK by Epstein for a sexual encounter with Andrew in 2010. The woman, who is not British, was in her 20s at the time.

The arrest, which took place at Sandringham at 08:00 GMT on Thursday, is not in relation to any allegations of sexual offences.

It emerged that the Berkshire property also searched was the Royal Lodge - Andrew's former home in Windsor Great Park. A number of uniformed officers were spotted behind the gates during the day.

The former Duke of York served as the UK's trade envoy between 2001 and 2011, travelling globally and enjoying privileged access to senior government and business contacts around the world.

In 2010, Andrew ap-

pears to have forwarded government reports from visits to Vietnam, Singapore and China to Epstein, files relating to the late financier recently released by the US Department of Justice appear to show.

'deepest concern'

The documents also appear to show Andrew forwarded information on investment opportunities in gold and uranium in Afghanistan to Epstein.

Under official guidance, trade envoys have a duty of confidentiality over sensitive, commercial, or political informa-

tion about their official visits.

King Charles said he learned of the news his brother's arrest with the "deepest concern".

"What now follows is the full, fair and proper process by which this issue is investigated in the appropriate manner and by the appropriate authorities," he said in a statement.

"Let me state clearly: the law must take its course.

"As this process continues, it would not be right for me to comment further on this matter. Meanwhile, my family and I

will continue in our duty and service to you all."

Neither the King nor Buckingham Palace were given advance warning of Andrew's arrest, which occurred on his 66th birthday.

The royals maintained a business as usual approach on Thursday, opting to continue with their engagements.

The King, who had been attending a solo engagement to mark the start of London Fashion Week on Thursday, did not react to questions from reporters asking for his reaction to his brother's arrest.

“Moral Case for Rearmament”: Brits and Germans signal hike in defence spending

■ In a joint statement, both nations insist more money for arms is a must to counter Russian aggression

In a significant departure from decades of post-Cold War military restraint, Prime Minister Sir Keir Starmer has signaled that Britain must “step up and go faster” regarding its defence spending.

The shift comes as top military officials from both the United Kingdom and Germany presented a united front at the weekend, arguing that the rearmament of Europe is no longer a choice, but a moral imperative to counter Russian aggression.

The Prime Minister’s comments follow reports that the government is considering accelerating its timeline to meet critical spending targets. Specifically, the administration is weighing whether to hit a defence spending goal of 3% of national output during the current parliament rather than the next. This acceleration underscores a growing sense of urgency within Downing Street as the conflict in Ukraine continues to reshape the European security landscape.

However, the path to

a more robust military is fraught with economic hurdles. Experts suggest that meeting these targets earlier than planned could cost an additional £14 billion per year. With the national budget already under strain, funding such a massive increase would likely require a difficult combination of increased borrowing, tax hikes, or significant cuts to other public services.

General Sir Richard Barons, a key author of last year’s strategic defense review, emphasized that the UK is currently in “great jeopardy.” Barons highlighted that modern warfare has evolved beyond traditional battlefields to include cyber-attacks, social media disruption, and the sabotage of critical infrastructure.

“We used to live in a world where war was outsourced to the military,” Barons noted. “We now live in a world where it is a whole-of-society problem. Civil society and the public are now at the heart of this. It is a very different place to be -

much more like the world of the Cold War and the Second World War.”

‘moral case’

This sentiment was echoed by Air Chief Marshal Sir Richard Knighton, the head of Britain’s armed forces. In a joint push with his German counterpart, Carsten Breuer, Knighton argued that rearmament is not “warmongering” but a necessary deterrent. In an article published on Sunday, the two military leaders suggested that European governments must be honest with voters about the scale of the threat.

The joint statement focused on a “moral case” for rearming, suggesting that if Russia perceives weakness or

disunity within Europe, it may be emboldened to extend its aggression beyond the borders of Ukraine. To prevent this, the leaders are calling for a “whole-of-society” approach to defense, where a strong defense industry is seen as a pillar of national stability.

Evidence of this cooperation is already visible. Plans are moving forward for new munitions factories in the UK, while a German combat brigade

is being stationed on NATO’s eastern flank.

German About-Turn

The shift is perhaps most dramatic in Germany. For decades, German security policy was premised on military restraint. However, Russia’s full-scale invasion of Ukraine in February 2022 triggered a historic about-turn. The German government is now spending considerably more on defense as it seeks to modernize the

Bundeswehr, which had seen decades of consistent cutbacks. Berlin has even moved toward making essentially unrestricted funding available for national defense.

As the US security umbrella appears to retreat, European nations are realizing they must find the funds to meet their own security needs. The immediate reality is prosaic but pressing: military costs are rising, and the time for debate is narrowing.

Starmer: another week, another U-turn

BELEAGUERED Prime Minister Sir Keir Starmer was forced into another damaging U-turn this week as he abandoned plans to postpone local elections across 30 councils in England this May.

The delays were originally granted to help deliver a major reorganisation of local authorities.

But ministers say the polls will now go ahead in light of recent legal advice. The U-turn has been condemned by opposition parties. Reform UK, which had started a legal challenge against the delay, suggested that the local government secretary Steve Reid should resign.

The Conservative leader, Kemi Badenoch, called the announcement predictable chaos from a useless government that cannot make

basic decisions.

For Starmer, this is yet another high-profile reversal of a policy his government had been pressing in the face of criticism. At lunchtime, before the decision to abandon the plan to delay some local elections had been announced, the prime minister, speaking on the BBC’s Jeremy Vine show, dismissed suggestions that more U-turns were on the way.

“Can we be sure you’ll stick to your course now after those U-turns?” asked Vine.

“Absolutely. I know exactly why I was elected in with a five-year mandate to change this country for the better and that’s what I intend to do,” Starmer replied.

However, less than two hours later, the housing secretary Steve

Reid, who had approved the postponement of elections due this May for 30 English councils, said he was reversing that decision after reviewing legal advice. A legal challenge brought by Reform UK was due to be heard in the High Court on Thursday. Reform UK’s leader Nigel Farage was delighted.

“We’ve won, and we haven’t just won on our behalf, we’ve won on behalf of 4.6 million people whose vote was being denied, in some cases, for the second year in a row, but there’s a much deeper principle. We pay council tax, and we should be able, once every four years, to judge whether those we voted for are doing a good job. It’s called democracy.”

“We’ve stood up for it, and we’ve won.”

Frog poison used to kill Navalny, says Foreign Secretary

The UK wants action to be taken after evidence showed Russia killed political prisoner Alexei Navalny with frog poison, Foreign Secretary Yvette Cooper said this week.

Two years ago, Russian opposition leader Navalny, a vocal critic of President Vladimir Putin, died suddenly in the Siberian prison where he was being held on trumped-up charges.

European labs have now confirmed he died from the obscure poison, which Cooper says only the Russian government had the "means, motive and opportunity" to use.

She told reporters proof of the toxin was a "clear breach" of international chemical weapons rules and "we do want to see action" taken, which could include continuing coordinated sanctions on Russia.

Cooper was attending the Munich Security Conference alongside Prime Minister Sir Keir Starmer, where the pair have been calling for European allies to be ready to fight, particularly against threats from Russia.

Speaking from a snow-covered Munich rooftop, Cooper said Britain and its allies must be ready to face down Russian aggression, which includes "the use of lethal toxins against their own citizens".

"We have been pursuing the truth on this since Alexei died in prison," she said, in an effort to continue Navalny's work to "tell the truth, spread the truth" about the Russian regime under Putin, "because that is the most dangerous weapon of all".

Visiting the UK? Don't forget your UK passport

■ New regulations means dual nationals MUST bring their British passport - or a Certificate of Entitlement - to enter the UK

NEW UK BORDER regulations coming into force this week could significantly impact expat Brits planning a trip back home - so be prepared.

For years, dual nationals - those holding both a British and a U.S. passport - frequently traveled to the UK using only their American documentation. However, new digital enforcement measures mean that the era of "picking and choosing" which passport to use for a trip home has come to an end.

British or Bust

The core of the change lies in the full rollout of the Electronic Travel Authorisation (ETA) system. Under these rules, all non-visa visitors to the UK (including U.S. citizens) must now obtain a digital ETA before they can board a flight.

The catch for dual nationals is simple but strict: British citizens are **ineligible** for an ETA. Because the UK government's digital systems recognize

you as a citizen, you cannot be granted "visitor" permission. Consequently, if you attempt to check in for a flight with a U.S. passport, the airline's system will look for a valid ETA. When it finds neither an ETA nor a British passport linked to your identity, the airline is now legally required to deny boarding.

For many UK citizens settled in the U.S., British passports have often been allowed to lapse. Renewing a UK passport from abroad is more expensive and time-consuming than doing so domestically, leading many to rely on their U.S. passport for all international travel.

Under the 2026 rules, this is no longer a viable strategy. If you have an upcoming trip to visit family, attend a wedding, or handle an emergency, a lapsed red passport could see you stranded at a U.S. airport.

Expensive option

The Home Office has introduced a Certificate of Entitlement as an al-

ternative for those who do not wish to carry a British passport. However, this is far from a budget-friendly fix. The certificate currently costs £589 - roughly six times the price of a standard passport renewal. Furthermore, the certificate is linked to your specific foreign passport; if you renew your U.S. passport, you must pay for a new certificate.

Expiry Dates

So if you are a British citizen living in the U.S. with plans to visit the UK, do not wait until you book your flights to check your docu-

ments.

Ensure your British passport is valid. If it has expired, start the renewal process immediately via the official GOV.UK website.

Overseas passport processing can take several weeks, and you may be required to mail in your original documents, including your U.S. passport in some cases.

In extreme cases, the UK government can issue Emergency Travel Documents, but these are typically reserved for urgent situations like the death of a family member and are

not a substitute for regular travel planning.

While these rules may feel like an administrative hurdle, they are part of a global move toward fully digital, "pre-checked" borders. For the dual national, the message is clear: when heading to the UK, you must arrive as a Briton, not a guest.

Renewing your UK passport from the United States is currently taking approximately 3 to 4 weeks for standard online applications. While the process has become more digital, it still requires physical document handling that prevents "instant" turnarounds.

Trump flip flops on Chagos after US denied permission to use US British bases

Donald Trump has reversed himself yet again over the UK's Chagos deal, launched a stinging criticism on Thursday of the plan that would see the UK hand over the Indian Ocean islands to Mauritius and lease back a joint UK-US military base.

The US president urged Sir Keir Starmer not to "give away Diego Garcia" - the largest island on the archipelago and home to the base.

Trump said "this land should not be taken away from the UK" and if it did it would be "a blight on our Great

Ally", in a post on social media.

This comes despite Washington on Tuesday giving its official backing to London's plan to cede sovereignty of the British Indian Ocean Territory to Mauritius.

Trump's U-turn is seen as payback for the British government's refusal to give permission for the US to use UK military bases to support potential US strikes on Iran.

The US has in the past used RAF Fairford, in Gloucestershire, and Diego Garcia to carry

out strikes in the Middle East.

A UK government spokesperson said: "As routine, we do not comment on operational matters."

The US has been pressuring Iran to agree to curb its nuclear programme.

It has threatened possible strikes if it fails to do so and has moved warships, aircraft and other military assets to the region in preparation for a possible strike.

At the same time, some progress has been reported at talks between American and Ira-

nian negotiators in Switzerland.

On Thursday, Trump said the world would find out "over the next, probably, 10 days" whether the US would reach a deal with Iran or take military action.

A UK government spokesperson said: "There is a political process ongoing between the US and Iran, which the UK supports."

"Iran must never be able to develop a nuclear weapon, and our priority is security in the region."

Sir Keir spoke to Trump over the phone on Tuesday, after the US

government gave its formal support for the Chagos deal.

Insiders believe the Pentagon's preparations for possible strikes on Iran - which could potentially be launched from Diego Garcia - may have shifted the president's understanding of the significance of the island, the largest in the Chagos archipelago.

Trump referenced this in his Truth Social post, saying: "Should Iran decide not to make a deal, it may be necessary for the United States to use Diego Garcia, and **cont. on page 4, col. 1**

the [RAF] Airfield location in Fairford [Gloucestershire], in order to eradicate a potential attack by a highly unstable and dangerous regime."

Neither RAF Fairford nor Diego Garcia were used in the US strikes carried out last year on Iran's nuclear facilities.

At the time a senior UK defence source said Washington had not sought permission.

RAF Fairford and other UK military bases were most recently used by the US in support of a military operation to seize the registered tanker known as Bella 1 earlier this year.

But that operation was carried out with the full support of the UK. At the time ministers said the operation was justified under international law.

Questions of international law would likely be applied by the UK government in justifying support for any US military action in Iran.

Under a long-held agreement, the US would have to first request to use any UK sovereign military bases before conducting military operations.

Under international law, there is no distinction between a state carrying out the attack and those which have supported that state, if the latter has "knowledge of the circumstances of the internationally wrongful act".

Reacting to the latest developments, Liberal Democrat leader Sir Ed Davey, a long-standing Trump critic, said: "It's now clear Donald Trump is trying to bully the government into letting the US use UK bases like Diego Garcia to pursue unilateral military action."

NHS alert after North London measles outbreak**■ Capital has seen 88 cases this year as vaccination rates continue to drop**

NHS officials were put on alert this week following an alarming outbreak of measles in North London.

Figures released on Thursday by the UK Health Security Agency (UKHSA) showed there had been 16 new cases in Enfield in the past week. The figures also show it has spread to nearby Haringey, where 10 new cases were recorded.

It brings the total number of recorded measles cases in London to 88 since the beginning of the year, with the majority of cases occurring in children under 10 years old.

Earlier this week, parents in the area were told their children could be excluded from school if they were not fully vaccinated against measles and had been in contact with someone with measles.

In the year 2024 to 2025, the average measles vaccination rate in England

was 83.7%.

However, in London, this fell to 69.6%, with only 64.3% being vaccinated in Enfield.

Dr Oge Ilozue, a GP in Barnet and senior clinical advisor for the NHS London Vaccination Programme, said that there were a number of reasons why people were not getting themselves, or their children vaccinated, including the abundance of misinformation online.

'safe and effective'

She said: "We've used (the vaccines) for years and years and we know they are safe and effective at protecting against these diseases and the complications that might occur.

The GP said she believed some people may also be "complaisant," with some people thinking "it's only measles" - but, Ilozue explains: "These infections can cause quite serious com-

plications."

The GP said vaccination programmes were being taken out into communities and places of worship, to try and encourage more people to protect themselves and families.

Lucia das Neves, member for health at Haringey Council, said they were working closely with local and national partners, including the UKHSA, NHS and Enfield Council, to protect residents and limit the spread of mea-

sles in Haringey.

She added: "As vaccination is the most effective way to protect your family and the whole community, we have and will continue to urge everyone who is not fully vaccinated to do so now.

"We will continue to mobilise every resource available to us and work alongside healthcare services, schools and community groups to support our residents."

The UK recently lost its

World Health Organization measles elimination status after more than 2,900 cases of measles were confirmed in England in 2024, the highest level for more than a decade.

There were nearly 1,000 cases in 2025.

The outbreak in Enfield comes as the government launches a wider campaign to improve childhood vaccination uptake for measles and other jabs for under-fives.

Essex man found guilty in first prosecution after XL Bully death

An amateur rapper has been found guilty of owning one of two XL bully dogs that mauled his mother-in-law to death - two days after the breed was banned.

The pet, named Bear, killed Esther Martin, 68, while she was at Ashley Warren's home in Jaywick, Essex, on 3 February 2024.

Warren was filming a music video in London when Martin suffered "dozens and dozens" of bite wounds.

The 41-year-old, now of Addlestone in Surrey, will be sentenced at Chelmsford Crown Court on 1 April.

The jury spent 14 hours and 28 minutes deliberating before coming to a verdict.

Warren sat in the dock wearing a grey hoodie with his head facing down throughout the

hearing.

He had denied being the owner or in charge of two dogs that caused injury resulting in death while dangerously out of control in a private place.

Jurors found him guilty by a majority of 11 to one of being the owner of Bear but cleared him of being in charge of the other dog, Beauty, which also injured Martin, but which, the court heard, belonged to his girlfriend.

Martin, from Woodford Green, east London, was described in court as a "doting and loving grandmother".

She was 5ft 3in (1.6m) tall and had restricted movement due to a hip replacement, arthritis and a limp. Christopher Paxton KC, prosecuting, said it was a "ludicrous suggestion" to say she could be considered a "fit and proper person" to control the dogs.

She was attacked within hours of arriving in Jaywick, where Warren had asked her to watch his dogs while he was in London shooting the video.

"Esther suffered dozens and dozens of dog bite marks and wounds, which led to a catastroph-

ic bleed and her death," said Paxton, when opening the trial.

Warren had been in a relationship with Martin's daughter Clare for 14 years before she died suddenly in 2021.

He would have been aware of Martin's mo-

bility issues and had "no basis" to believe she could "physically stop the dogs", Paxton said.

Leaving her in charge of the two XL bully dogs, and eight puppies, was a "tragedy waiting to happen", prosecutor Christopher Paxton KC said.

Six of Fergie's companies being wound down...but none make any money

Six companies linked to the former Duchess of York, Sarah Ferguson, are being wound down, documents filed with Companies House show.

Ferguson is the director of all six businesses that were due to be struck off the register by this coming Thursday - unless legal cause is shown to prevent it.

It is unclear what the firms' activities were, although one is related to public relations and another to retail. None appear to be very commercially active.

Their closure comes in the wake of further revelations from the Epstein files which suggest the ex-wife of Andrew Mountbatten-Windsor told the wealthy paedophile how

desperate she felt over her financial difficulties.

Email exchanges between Ferguson and Epstein indicate she asked for his financial advice over how to deal with her £6m debt pile while he was still in jail for soliciting prostitution from a minor.

Being named among the Epstein files is not an indication of wrongdoing.

The companies that are set to close are S Phoenix Events, Fergie's Farm, La Luna Investments, Solamoon Ltd, Philanthrepreneur Ltd and Planet Partners Productions Ltd, none of which have any public profile.

Listings for five of the six companies state there is an "application to strike the company off the regis-

ter". That means the company will stop trading and will cease to exist.

The sixth, S Phoenix Events, which also notes the receipt of an application to strike off, lists Sarah Ferguson as the person authenticating the application on behalf of the company.

Ferguson is listed as an active director for three other businesses registered with Companies House: Ginger and Moss, set up as a lifestyle brand to sell tea, jewellery and housewares, a "motion picture production activities" business called Coat, and Librasol, classified under "artistic creation" on the official register for private companies.

All the companies being dissolved were set up

more than a decade ago. Most are classed as "dormant companies", with very little or no reported recent commercial activity.

Ferguson is the sole remaining director for all of them.

Late last year, documents show she submit-

ted an official change to her details for all the firms from Sarah Duchess of York to Sarah Margaret Ferguson.

There have been reports of Ferguson's financial difficulties for many years, but the publication of the files of Jeffrey Epstein's correspon-

dence has laid bare how much pressure she was under.

One of the files suggests she told Epstein she was about to "freak with exhaustion" at a time when he was still in custody in Florida and that she also leaned on him for emotional support.

Amazon van follows GPS into the sea

AN AMAZON delivery van got stuck on mudflats this week, a path locals described as the "deadliest footpath in Britain".

HM Coastguard Southend was called out to rescue the driver and remove the van on The Broomway, at Great Wakering, Essex, after the driver had been following a GPS route to Foulness Island.

The Broomway is a route across flat sands from the shore near Southend-on-Sea to Foulness Island and is home to a Ministry of Defence firing range.

Amazon said it was

"aware" of the situation and was "investigating".

The route, said to be 600 years old and covering six miles, is managed by Essex County Council. Qinetiq - a global defence and security company which manages the firing range - describes the path as a "unique right of way which requires both caution and specialist knowledge to negotiate safely".

The full route is not suitable for vehicles, and people are advised to only walk there accompanied by a guide who knows the mudflats.

According to parish council records, 100 people have died on The Broomway, with the last known death in 1919.

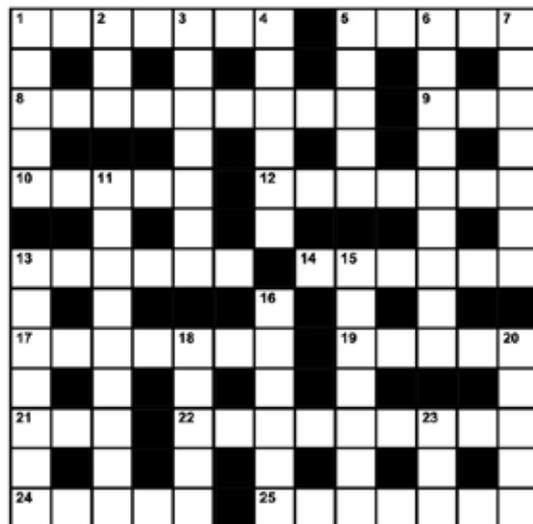
The coastguard said it had spoken to a Qinetiq security officer who said the incident had taken place on Saturday evening and that the driver had "removed themselves from the van and reported the incident to Amazon".

It said the vehicle had already been there during high tide and that, alongside a farmer, Amazon arranged to remove the vehicle on Sunday.

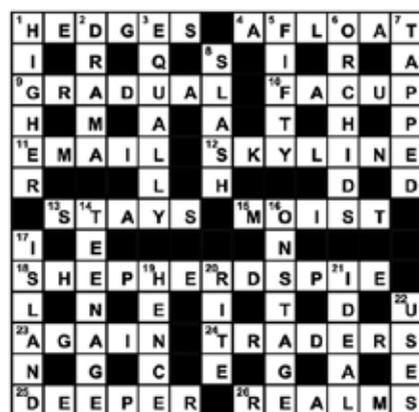

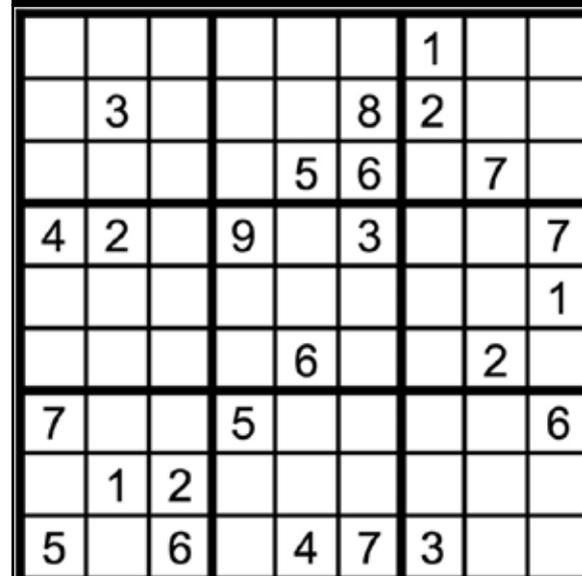

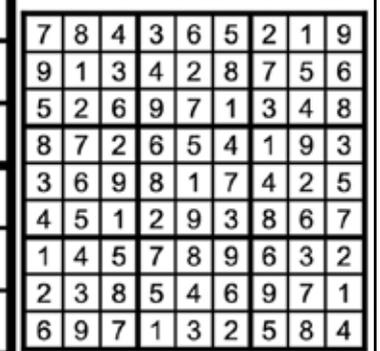

TV Review: Small Prophets is a pint-sized gem

Mackenzie Crook has a singular talent for finding the sacred in the mundane.

The actor turned writer who shot to fame in Ricky Gervais's original office is perhaps best known to American audiences for his eye-popping supporting role in *Pirates of the Caribbean*. But back in the UK, he has become one TV's best loved writers, for his quietly majestic BBC TV show *Detectorists*.

This week saw the debut of his latest project, *Small Prophets*, which is best described as a small miracle. Although currently only available on these shores via a VPN and the BBC's streaming service iPlayer, hopefully the show will be available on a US streaming service soon.

Pure pleasure

In this new comedy, Crook shifts his lens to what he calls the "urban ordinary," proving that there is just as much wonder to be found in a Manchester cul-de-sac as there is in the rolling hills of Danebury, the bucolic setting of *Detectorists*. This show is everything a fan of Crook's work could wish for: a pure pleasure that takes his fa-

miliar, gentle sensibilities and reshapes them into "phantasmagorical new shapes" to quote just one British review.

Our guide through this strange, delicate landscape is Michael, played with a weary, soulful grace by Pearce Quigley. Michael is a man living a life defined by "quiet repetition" in an overgrown semi-detached house at the dead end of a south Manchester cul-de-sac. His days are a rhythmic, almost ritualistic loop: waking from "strange dreams about birds," coaxing a "battered Ford Capri" into life, and navigating the monotonous shop floor of a vast DIY superstore.

It is a life haunted by a profound vanishing act - seven years ago, on Christmas Eve, his girlfriend Clea disappeared. Her car was found abandoned by the Severn Bridge, but she was never seen again.

Michael's sanity is preserved by his penchant for elaborate, improvised wind-ups at work. Whether he is spinning an intricate variation on the classic "tartan paint" joke or stone-facedly convincing a man standing in front of a vast wall of bright blue buckets that

the store unfortunately does not sell buckets, Quigley portrays Michael as a man whose mischievous mind is his greatest survival tool. This trait is clearly a legacy from his father, Brian, played by the legendary Michael Palin. Brian, now residing in a nursing home, may struggle to remember the painful fact that Clea is gone, but he remains a whiz at constructing intricate, Rube Goldberg-style marble runs.

It is Brian who suggests a scheme for confirming the truth about Clea that "cannot possibly work," yet Michael and his colleague Kacey open their hearts and minds to it anyway. It involves some alchemy allegedly revealed to Brian by "an Egyptian metaphysicist" who has mastered growing small beings in glass jars. Beings who can answer any question they are given. Hearing this, an intrigued Michael gets to work in his garden shed.

The heartbeat of the series is the bond between Michael and Kacey, played by Lauren Patel. Their platonic relationship stands as one of the most beautiful friendships we've seen on television in recent years. Patel is sen-

sational as the thwarted, hopeful Kacey, providing the perfect emotional counterpoint to Quigley's outsider charm. Together, they navigate the small mysteries of their lives: the nature of Kacey's own improbable dream of appearing on the Australian soap opera Neighbours, and the identity of the sullen teenager who endlessly cycles in circles around Michael's cul-de-sac.

The supporting cast is a collection of singular delights. Jon Pointing is pitch-perfect as Clive, a millennial version of a classic curtain-twitching neighbour who is obsessed with trimming Michael's rambling hedge. Then there is Gordon, Michael's officious but ineffectual boss, played by Crook himself. Sporting a ponytail long enough for him to reach behind his back and pull it straight with greasy fingers, Gordon is the perfect embodiment of petty, slightly grubby workplace authority.

Crook unspools a tale that, in any other hands, might dissolve into facile whimsy. Instead, every decision feels right, resolving the show's many mysteries with sunbursts of imagination that are fantastically unlikely and yet perfectly rational. There is a scene involving a mugging that is so ut-

terly absurd, then deeply moving, then both at once that no viewer could have predicted the outcome.

Ultimately, Small Prophets is a profound message of hope. It suggests that wonderful things are still at hand in a world that might seem like it is running out of them.

Cortina proves winter wonderland for Team GB

Great Britain may be short of the targeted eight medals in Milan-Cortina right now, but the team have already smashed a gold medal record at the Winter Olympics.

Having previously never secured more than one gold at a winter

Games, all three of Team GB's medals this year have been gold -- and two were secured on the same day.

The team still have work to do to get past their best-ever medal total of five, though -- achieved in 2014 and 2018.

Here's all the medals won so far, and how the star athletes did it:

Matt Weston broke consecutive four track records on his way to opening Team GB's account in the men's skeleton in Cortina.

'almost numb'

He finished a commanding 0.88 seconds ahead of his closest rivals, Germany's Alex Jungk and Christopher Grotheer, turning his recent form into Olympic glory. "I literally can't describe it. I've been fortunate enough to win world championships, European championships and other things as well and this blows them all out of the water," he said after winning gold.

"I can't describe the feeling. I almost feel numb. It's kind of not real. I keep touching it [his medal] to make sure it is real but it doesn't feel real."

Then Charlotte Bankes and Huw Nightingale

set a Team GB first on the weekend, winning gold on the snowboard cross.

It was a drastic change of fortunes for the pair who had both struggled in the individual events after a week where the British ski and snowboard team had disappointed.

'immense relief'

Those struggles ended though, as Bankes and Nightingale stormed to victory, with Bankes crossing first in the final to make British Olympic history.

"[I'm feeling] immense relief. For me, but also the team. I think that's what is amazing. And I think that we've made it -- we're Olympic champs." Matt Weston and Tabby Stoecker kept the momentum in the skeleton going as they teamed up to earn Team GB's third gold of the games, winning by 0.17 seconds in the team event.

The team gold also saw

Weston become the first British athlete to win two medals at the same Winter Olympics after he cut a deficit of 0.3 seconds on his final run.

Fellow Britons Marcus Wyatt and Freya Tarbit finished fourth.

"We're so so happy for Matt and Tabby to do well and we've seen some of our closest friends just win gold, so on the one hand we're absolutely buzzing for them but on the other hand it's obviously gutting to miss out on a medal," Tarbit said.

Both Weston and Stoecker honed their craft at the Sliding Centre in Bath, the only track of its kind in the UK. The place, which looks a bit like a mine railway track sloping away down a concrete canyon, is hardly the ideal environment for future Olympians to train, but this is where milliseconds have been shaved off Team GB's skeleton performance.

GB men's curlers into final

Bruce Mouat and his rink have guaranteed Team GB's fourth medal of these Winter Olympics after seeing off unbeaten Switzerland 8-5 on Thursday to reach the men's curling final in Cortina.

The British quartet - who are the reigning world champions - will face Canada in Saturday's final (18:05 GMT), looking to upgrade the silver medal they won four years ago in Beijing.

But that is the least these four Scots will achieve in these Games in Italy.

Mouat, Grant Hardie,

Hammy McMillan and Bobby Lammie came to town atop of the world rankings and targeting nothing other than what the emotional skip called "our gold medal" in the immediate aftermath.

And for all they struggled in the round robin and only earned their place in the medal-matches thanks to Italy losing on Thursday morning, they now stand one step away from achieving that ambition.

"It will be the biggest match of our lives and we're so excited to get that opportunity again," vice-

skip Grant Hardie said.

However, Britain's women had their own dreams shattered earlier in the day in the most dramatic of circumstances.

Rebecca Morrison's rink needed to beat Italy in their final round-robin match, and they did. The other part of the equation was that Switzerland had to overcome the United States.

But the Swiss were unable to do their bit - despite coming from three down to force a nerve-shredding extra end - rendering Britain's 7-4 victory over the hosts moot.

Mosquera, as their lead over Manchester City is five points, with Pep Guardiola's side having a game in hand.

It was a damaging night for Mikel Arteta's men in their quest for a first league title since 2004.

Yet they still remain in the hunt for a quadruple of trophies, also facing City in next month's Carabao Cup final, into the Champions League last 16 - having topped the league phase - and FA Cup fifth round.

But this result will once more spark doubts over Arsenal's staying power, having finished second in the past three successive seasons.

Despite being adrift at the bottom and 17 points from safety, Wolves are still fighting and will still have a say in how this Premier League season finishes.

With an hour gone it was a very different scenario as Arsenal led 2-0 and looked on course to see out a comfortable victory.

But that is when Wolves relaxed and began to play, Hugo Bueno scoring the goal of the game with a cracking effort.

Edozie's dream leveller - the teenager's first appearance in senior football marked by a first goal even if Calafiori played his part - epitomized Wolves' spirit.

That is all they had left - and had to find - under Rob Edwards, with the salvage operation already bleak when he replaced Vitor Pereira in November.

They sensed an Arsenal collapse and scrapped their way to a point - something that was denied them at Emirates Stadium back in December when Mosquera's 90th-minute own goal gave the Gunners a 2-1 success.

Forest's new manager bounce!

Vitor Pereira made the perfect start to his reign as new Nottingham Forest boss on Thursday as they claimed a stylish victory at Fenerbahce in the first leg of their Europa League knockout round play-off tie.

The visitors dominated from start to finish to record their biggest ever away win in European competition.

Forest will now be strong favourites to advance to the last 16 - where either Midtjylland or Real Betis await - when the second leg gets under way at the City Ground on 26 February (20:00 GMT).

In a performance brimming with adventure and

confidence, returning central defender Murillo surged through midfield to open the scoring with a 20-yard strike that zipped past home goalkeeper Ederson into the bottom right corner.

It was largely one-way traffic in the opening period as a Fenerbahce side containing a smattering of players with Premier League experience struggled to retain possession and cope with Forest's intensity.

Aside from a Talisca effort which cannoned into the arm of Murillo and prompted sustained calls for a penalty, which was not awarded after a video assistant referee (VAR) check, there was little for

audible as the evening progressed as their side put aside their struggles in the Premier League, which led to Pereira coming in to replace Sean Dyche.

And they were able to rejoice just three minutes later, when Igor Jesus registered his seventh goal in the competition with a

close-range header from Morgan Gibbs-White's near-post flick on.

Jesus' strike also broke Garry Birtles' club record of most goals in a single European campaign - six when Forest won the European Cup in 1979.

Any notion they might sit back after the break content with their two-

goal lead was quickly dispelled five minutes after the restart.

Jesus and Gibbs-White reversed their roles as provider and goalscorer as the England midfielder tapped in to ensure a wonderful first ever trip to Turkey for the two-time former champions of Europe.



Wolves pounce on Arsenal jitters

Leaders Arsenal blew a 2-0 lead in dramatic fashion in midweek to draw at rock-bottom Wolves and missed the chance to go seven points clear at the top of the Premier League.

Gunners defender Riccardo Calafiori turned in debutant Tom Edozie's shot in the fourth minute of added time for a late leveller after goalkeeper David Raya and centre-back Gabriel made a mess of clearing a high ball into the box.

Hugo Bueno had started Wolves' comeback with a stunning curling effort after Bu-

kayo Saka - with his first goal in 15 games - and Piero Hincapie gave Arsenal what seemed a commanding lead.

The Gunners had control at Molineux as Bukayo Saka celebrated his new contract with the fifth-minute opener.

The England forward nodded in Declan Rice's cross - just a day after signing a fresh five-year deal at the Emirates - before Hincapie added a 56th-minute second with a smart finish from a Gabriel pass for his first goal for the club.

Yet after Saka - who ended a 15-game goal

drought in all competitions - went off following treatment, Arsenal struggled under pressure as Hugo Bueno pulled a goal back with a stunning curler in the 61st minute.

Wolves pushed at the end and when Gabriel got in the way as Raya tried to clear a cross, 19-year-old Edozie - on for his senior debut as a substitute - slammed in a shot that struck Calafiori and went in off the post.

Arsenal were stunned, with tempers frayed at the end after Gabriel Jesus shoved over Yerson
