DRILL BABY, DRILL!

■ **Fossil fuel reversal will bring more jobs and increased revenues, says Farage**

Reform UK leader Nigel Farage has called on the UK Government to “change course” on oil and gas, saying opening up licensing in the North Sea could lead to “thousands of jobs, increased tax revenues and cheaper gas prices”.

The clash at Prime Minister’s Questions came ahead of Reform’s Scottish conference on Thursday, where the party unveiled its candidates for May’s Holyrood election. Reform is keen to make North Sea drilling a central battleground in the contest.

Mr Farage told MPs that Norway had opened 49 new oil and gas drilling sites in the past year while “on our side of the North Sea, the number is zero”.

“Given that our critical reserve of natural gas is down to two days and how vulnerable we are, and with talk potentially of energy rationing coming later this year, isn’t it time we changed course, got rid of excessive taxation on the exploration companies, opened up the licences, became self-sufficient in natural gas, and with that would come thousands of jobs, increased tax revenues and cheaper gas prices? Isn’t it time we followed

Norway?”

Prime Minister Sir Keir Starmer insisted oil and gas would be “part of the mix of energy for many, many years to come, as I have set out many, many times”. However, he criticised the Reform leader’s position on the US-Iran war.

‘regime change’

Last week, Mr Farage said that if the UK “can’t even defend Cyprus, let’s not get ourselves

involved in another foreign war”.

That contrasted with previous public comments after the start of the war, when he said that he was in favour of “regime change” in Iran and told a press conference in Westminster: “We should do all we can to support the operation.”

Sir Keir told MPs: “But he is now highlighting the consequences of the war that he said we should rush into. He wanted us to go to war. He said it was perfectly, perfectly clear that we should support the strike. Then, just like the Leader of the Opposition, a week later he said, ‘Oh no, I got that

one wrong.’ You cannot make mistakes about decisions as serious as committing to war.”

The fallout from the US-Israeli war against Iran has seen oil prices soar. The Energy Profits Levy (EPL) was introduced by the Conservatives nearly four years ago after Russia’s invasion of Ukraine sent prices soaring. Labour then increased the headline tax rate on oil and gas operators to 78%.

existing fields

The UK government has maintained its manifesto ban on brand-new exploration licences but moved to allow tightly defined extra production “on or near exist-

ing fields” via so-called Transitional Energy Certificates. Last week, Energy Secretary Ed Miliband said that remained the government’s position.

“New exploration licences in the North Sea will not take a penny off people’s bills,” he told the BBC.

National Gas data this month showed around 6,700 GWh in storage — roughly one and a half days of peak winter demand — against a technical maximum of about 12 days for UK sites. Ministers have stressed that Britain also relies on continual flows from the UK continental shelf, Norway, LNG and interconnectors, not just storage.

Party crypto donations to be banned, says PM

British political parties will be banned from accepting donations in cryptocurrencies, the Prime Minister announced Wednesday, saying illicit finance poses a “stark” danger to the country’s democracy.

Starmer told lawmakers that “we will act decisively to protect our democracy” from outside meddling. “That will include a moratorium on

all political donations made through cryptocurrencies,” he said during the weekly Prime Minister’s Questions session in the House of Commons.

The move could be a financial blow to Reform UK, the rising party led by Nigel Farage which currently leads in the opinion polls, and is one of the few in Britain to accept cryptocurrency donations.

The government also

said it will put an annual cap of £100,000 (\$134,000) on donations by British voters living abroad. Reform has received £12 million in the past year from Christopher Harborne, a British businessman based in Thailand, according to Electoral Commission figures.

Reform MPs walked out of the House of Commons chamber after Starmer made the announcement.

Social Media ban for U16s likely as Government seeks 'consultation'

■ UK almost certain to follow Australia's lead on issue

The Government is weighing up whether to implement a blanket ban on social media for under-16s after a similar prohibition in Australia.

Prime Minister Sir Keir Starmer said on Thursday that he is "very keen" for the Government to tackle addictive features on social media after a landmark trial in the US.

To that end, the government is inviting input from British voters of all ages on whether there should be an Australia-style ban on children using social media and at what age this could begin.

The Australian government says its ban protects children from risks coming from "design features that encourage

them to spend more time on screens, while also serving up content that can harm their health and wellbeing".

curfews

The consultation, available via a survey at the government's official website (www.gov.uk) also asks whether social media platforms should be made to switch off addictive features which can lead children to stay up late at night, such as infinite scrolling and autoplay features on video content.

As well as overnight curfews on social media, the consultation is looking at potentially restricting children's access to AI chatbots.

Ministers plan to close the consultation on May

26, and will then aim to respond in the summer, with hundreds of teenagers taking part in a trial of social media bans, time limits and curfews.

Alongside the consultation, the Government plans to hold a "national conversation" about online safety, which will include community events, discussions led by MPs in their constituencies, and engagement in schools.

quick changes

An academic panel will investigate the evidence base as it emerges from places like Australia.

The Prime Minister and the Technology Secretary Liz Kendall have already vowed to change the law swiftly based on

the answers they gather.

Under a Commons-backed amendment put forward by ministers, children could be banned or restricted from accessing selected social media services.

The Secretary of State would also gain new powers to bring in social media curfews for young people, or limit

the amount of time children can spend on social media.

The Government has begun to prepare powers which will allow them to make quick changes in the law, instead of having a years-long parliamentary process like that which led to the Online Safety Act.

Bans, curfews and time

limits on apps are to be trialled in the homes of hundreds of UK teenagers.

The test will see 300 teens have their social apps disabled entirely, blocked overnight or capped to one hour's use - with some also seeing no such changes at all - in order to compare their experiences.

Iranian man released after he attempted to enter vital naval base

An Iranian man charged after allegedly trying to enter the Faslane naval base has been released pending further inquiries without appearing in court.

The 34-year-old was arrested at HM

Naval Base Clyde near Helensburgh, Argyll and Bute, at about 17:00 on Thursday.

He had been expected to appear at Dumbarton Sheriff Court on Monday - but the Crown Office said that "after full

and careful consideration of the facts and circumstances of the case" the man had been freed pending further inquiries.

'under consideration'

Prosecutors said the case against him

was still live and under consideration - but that there would be no proceedings against a 31-year-old Romanian woman who was also arrested at the base.

She has been released without charge following consideration of the "available admissible evidence," although the Crown said it reserved the right to proceed with the case in the future should further evi-

dence become available.

Faslane, on the Gare Loch about 25 miles (40km) north-west of Glasgow, is the home of all the Royal Navy's nuclear submarines.

Those include the UK's four Vanguard-class ballistic missile submarines which carry Trident nuclear missiles.

It comes after the US and Israel launched wide-rang-

ing strikes on Iran, killing the country's supreme leader on 28 February.

Iran has responded by launching attacks on Israel and US-allied states in the Gulf.

On Monday, president Donald Trump claimed "productive conversations" about a "complete and total resolution" to the conflict had taken place between the US and Iran.

Faster trains will be slower, government says (and much more expensive!)

BRITAIN'S much-ballyhooed HS2 train link between London and Birmingham will NOT be the fastest in the world, despite promises to the contrary from the successive British governments.

And to make matters worse, it will cost more than expected.

Another week. Another batch of bad news for British commuters.

Transport Secretary Heidi Alexander revealed that slowing down the flagship high-speed rail scheme from its planned 223mph (360km) could save "low billions" and bring services into operation more swiftly.

In a written statement to MPs, she explained that the proposed 223mph speed would be faster than any operational high-speed train globally, requiring safety tests to either wait until the new railway line between the country's two biggest cities was completed, or necessitating trains to be sent overseas for testing.

She characterised this as "an approach which could increase costs and delay the completion of the project", and confirmed she had asked HS2 chief executive Mark Wild to provide a report before summer on the feasibility of operating trains at reduced speeds.

"Mark Wild's initial and provisional estimate is that a specification at reduced speeds could save in the low billions and bring the railway into service sooner, by reducing

Two held after arson attack on London ambulances

■ Counter terror officers probe 'antisemitic' attack on vehicles owned by Jewish charity

Two men who were arrested over the arson attack on Jewish charity-owned ambulances in north London have been released on bail, the Metropolitan Police has said.

Four Hatzola ambulances in the car park of a synagogue in Golders Green were set alight in the early hours of Monday, in an incident being treated as an antisemitic hate crime.

The men, British nationals aged 47 and 45, were arrested on Wednesday on suspicion of arson with intent to endanger life and have now been bailed until April.

Cdr Helen Flanagan, head of Counter Terrorism Policing London, said there were "strict bail conditions in place while we continue to investigate their suspected involvement in this incident".

"We continue to work to try and identify all of those involved in this appalling attack and the investigation team is working around the clock to do this," she said.

"I'd like to thank the public and particularly the local Jewish community in the area for their continued support," she added, appealing for anyone with information to get in touch with the force.

Islamist group

Although the case is not being classed as a terror incident, the Met said the investigation is currently being led by counter-terror officers.

The Met previously said the investigation was looking at an Islamist group with potential links to Iran, following unsubstantiated claims of responsibility by Harakat Ashab al-Yamin al-Islamiya - The Islamic Movement of the People of the Right Hand.

The group has claimed responsibility for a number of similar arson incidents across Europe.

Police say that searches have been carried out at addresses in north west and central London where the two men had been arrested - with further searches at two

addresses in north west London on Wednesday.

CCTV from Golders Green showed three men running off after setting the ambulances on fire in the early hours.

'deeply shocking'

No injuries were reported, but several explosions - due to gas canisters on board the ambulances - caused windows of nearby buildings to shatter, while some residents were evacuated.

Prime Minister

Sir Keir Starmer condemned the incident as a "deeply shocking antisemitic arson attack", while Mayor of London Sadiq Khan said it was a "dark day" for the city and that it was "really important for all of us to show allyship to the Jewish community".

Security around areas with large Jewish communities have been tightened with extra patrols including armed police.

Hatzola is a Jewish-led non-profit or-

ganisation that provides free emergency medical response and hospital transportation to the north London community regardless of faith.

Four replacement ambulances, provided by the government, arrived at the non-profit on Tuesday.

Hatzola chairman Shloimie Richman said more than £1.7m raised by public donations since the arson attack would be put towards a new, secure headquarters.

Stop the migrants or give us back our £700m, demands Reform

■ Payments to France a "scam perpetrated on the British people," claims Farage

Reform UK has demanded France repays £700 million given to stop Channel migrant crossings.

The party states it will not pay France "another penny" and calls the payments a "scam perpetrated on the British people."

Reform's home affairs spokesman, Zia Yusuf, criticized the current arrangement on Monday. He said: "The French are laughing at us." He stat-

ed: "Hopeless Tory and Labour governments have paid them £700 million of British taxpayer money to stop the boats."

'more transparency'

Mr Yusuf highlighted increased crossings despite payments. He said: "Illegal boat crossings skyrocketed."

The current £475 million deal expires Tuesday. Since its inception, over 107,000 migrants

crossed the Channel.

The arrival rate rose by 41%. Interception rates fell by 13%. Reform vows to increase Channel surveillance. They would order Royal Marines to tow dinghies back to France.

Reform also plans to deport every illegal migrant in the UK. French police have been seen watching crossings. They have also been spotted handing out life jackets.

Under Ms Mahmood's

proposals, France would be paid for intercepting asylum seekers. France reportedly agreed to this idea. However, they did not agree to specific payment thresholds.

Critics urged Ms Mahmood to demand France intercept dinghies in the water.

Former Border Force Director General Tony Smith called for British officers to work in Calais and Dunkirk. He wants "more transparency over

outcomes."

Shadow Home Secretary Chris Philp stated: "The French only preventing 30% of embarkations last year."

He added: "It is clear they need to up their game." He said no more money should be given unless France intercepts boats near the shore.

This ongoing dispute highlights significant concerns over the effectiveness of current Channel migration policies.

Ex-Google man named BBC new head honcho

Former Google executive Matt Brittin has been confirmed as the BBC’s new director general.

The ex-president of Google’s Europe, Middle East and Africa operations will replace Tim Davie, who said he was resigning in November following a storm over how Panorama edited a speech by US President Donald Trump.

BBC chairman Samir Shah said Brittin, who left Google in 2025 after 18 years, “brings to the BBC deep experience of leading a high-profile and highly-complex organisation through transformation”.

‘pace and energy’

Brittin, 57, said he “can’t wait to start this work”, describing it as “a moment of real risk, yet also real opportunity”.

He said the UK needs “a thriving BBC that works for everyone in a complex, uncertain and fast changing world”.

Setting out his agenda, he added: “The BBC needs the pace and energy to be both where stories are, and where audiences are. To build on the reach, trust and creative strengths today, confront challenges with courage, and thrive as a public service fit for the future.”

Shah called Brittin “an outstanding leader” with “the skills needed

to navigate the organisation through the many changes taking place in the media market and in audience behaviours”.

The chairman also praised Brittin’s “passion for the BBC, his understanding of the challenges facing the organisation, his commitment to its independence and his determination to maintain the BBC’s position as one of the country’s greatest national assets”.

‘critical time’

The new director general joins at “a critical time”, as the government reviews the BBC’s royal charter, Shah continued.

“It is clear there is need for radical reform of the BBC, its funding model and the framework in which it operates. The stakes for the BBC, and the future of public service broadcasting, have never been higher.”

Some have questioned the BBC’s appointment of someone with a background in tech rather than public service or traditional editorial and broadcasting sectors.

Mark Thompson, former director general and current CEO and chairman of CNN, said he welcomed the appointment.

“It’s clearly a bold and interesting choice, an advance payment on the future,” Thompson said.

Meningitis outbreak has ‘passed its peak’

■ 29 confirmed or suspected cases of meningitis have been linked to the Kent outbreak

The peak of a fatal meningitis outbreak, thought to have originated in a Canterbury nightclub, has passed according to the UK Health Security Agency (UKHSA).

A total of 29 confirmed or suspected cases of meningitis have been linked to the Kent outbreak, which has killed two people.

Trish Mannes, the agency’s regional deputy director for the South East, told local radio that “this peak has passed, absolutely”.

“We could still see cases continuing to come in, we need to keep an eye on those. We need to really understand exactly what happens a bit more before we can be too optimistic about this,” Mannes said.

The UKHSA count of confirmed cases dropped on Sunday from 23 to 20 and suspected cases were reduced from 11 to nine after further testing.

Authorities said on Monday that there had been no change to the figures.

Two people have died following the outbreak, an 18-year-old former, Juliette Kenny, from Faversham and an unnamed University of Kent student aged 21.

Kate Bradley, a lecturer at the University of

Kent, said it had been a really difficult week for students.

It was already a “nerve-wracking” time because students had assessments, but the outbreak had “tipped everything upside down”.

She said: “Some of them are grieving. They’ve got friends who are in hospital. They are worried about their own

health.”

Abbie Lebbie, who was queuing for a vaccine at the University of Kent on Monday morning, said the situation was less stressful than before.

“I feel quite relaxed,” she told reporters.

“Cases have dropped and people are doing as much as they can to put procedures in place.”

Trans members must be out of girl guides by September

The organization that oversees girl guide groups in the UK has said transgender girls must leave the organization by September.

It follows an announcement in December by Girlguiding that it would no longer allow biological boys who identify as girls to join.

It said the action was being taken in response to the Supreme Court ruling in 2025 that said sex meant biological sex in equality law.

Campaign group Trans+ Solidarity Alliance described the news as “heartbreaking” for children. Sex-based rights group Sex Matters said it was “the right thing” for Girlguiding to do.

Girlguiding said the timeframe allowed “affected members and their families time to plan, pre-

pare, access support, and decide when - between now and September - they feel ready to leave”.

Transgender members of Girlguiding have until 6 September. The organization said that any transgender girls or women currently volunteering in a role open to women only will need to move to a role that is open to all volunteers.

It is not clear how many people will be directly affected by the rule change, as the organization says it does not collect data on gender identity.

Girlguiding said its original decision was made to ensure the organization was “operating lawfully” and was in keeping with its governing charity documents, “which affect how our membership eligibility is defined”.

Girl guide members can range in age from four to 18. There are currently about 300,000 members across the Rainbows, Brownies, Guides and Rangers groups, as well as around 80,000 volunteers.

Girlguiding said since 2025 it had been engaging with charities and other organizations to help deal with the effect of the Supreme Court decision. It called for the guidance

from the Equality and Human Rights Commission on the issue to be “clear, workable and informed by the voices of young people and volunteering organizations”.

“We remain committed to standing up for the rights, safety and dignity of girls and women, and to supporting marginalized communities, including LGBTQ+ people, to improve the lives of girls,” it added.

even worse news arrived this week with the price tag of an adult 'match' shirt for this summer's World Cup reaching

a hefty £134.99, representing a price hike of around eight percent on the equivalent kit released ahead of Euro 2024 which cost £124.99

England fans reacted with anger and dismay today after the launch of the most expensive Three Lions replica kit in history and one has threatened to buy a 'fake one'.

Families were hit hardest, with full junior 'match' strips priced at £114.99. What Nike markets as the adult 'stadium' shirt costs £89.99, while the junior version costs £64.99. 'Match' shirts are sought after because England's players will wear them for the World Cup in the US this summer. The 'stadium' alternative is designed for supporters to wear in the stands. Supporters who opt to have a name and number printed on

the back must fork out another £60. They add up to the most expensive England kits ever.

George Smith, 42, an Exeter City fan and father of four who now

lives in San Diego, California, has tickets for some of England's World Cup games this summer. He is due to attend at least one game with his wife, Monica, and he

said: "The cost to kit out kids is exorbitant, for a larger family like mine we would be looking at the best part of £600 to get us the shirts and the kids the full kit."

risk in the delivery of the programme and its testing," the Transport Secretary informed MPs.

High-speed trains are classified as those travelling at a minimum of 250km per hour, typically on purpose-built railway infrastructure. Both China and Spain currently operate such trains at 350km per hour. The current maximum speed on the UK's conventional rail lines is 200km per hour, whilst Channel Tunnel services – also known as HS1 – run at 300km per hour.

Ms Alexander stated: "This Government is determined to deliver HS2 as effectively and efficiently as possible. In doing so, I will look at every opportunity to claw back construction time, save taxpayers' money and ensure the project delivers for the country.

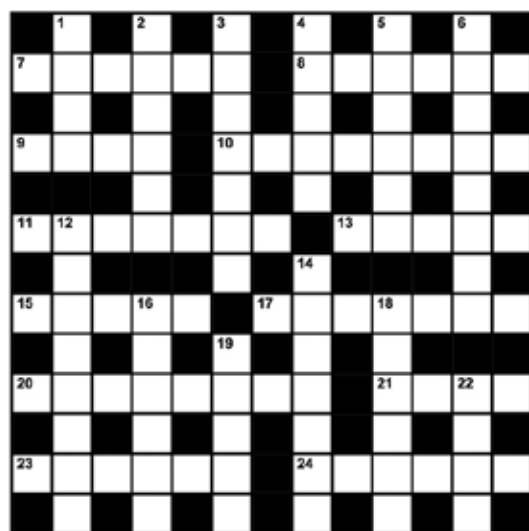

Tell us about Epstein, Congressman tells Fergie

A US lawmaker has made a direct plea to Sarah Ferguson to testify about her "close personal and business ties" to Jeffrey Epstein, according to a letter which emerged Thursday night.

Congressman Suhas Subramanyam urged her to provide information to the US congressional committee investigating the late sex offender. He also asked for any knowledge she had of her ex-husband Andrew Mounbatten-Windsor's involvement in Epstein's operations.

The letter represents the most direct pressure on the former duchess to

testify since the start of the Epstein scandal.

Mounbatten-Windsor has denied any wrongdoing in relation to Epstein.

There is no legal mechanism to compel the former duchess to testify in the US.

In the letter, which was sent to Ferguson on Thursday and set a two-week deadline for her to respond, Democratic Congressman Subramanyam, a member of the House Oversight Committee, said the recent drop of Epstein files by the US Department of Justice had revealed her "close personal and business ties" with the Ameri-

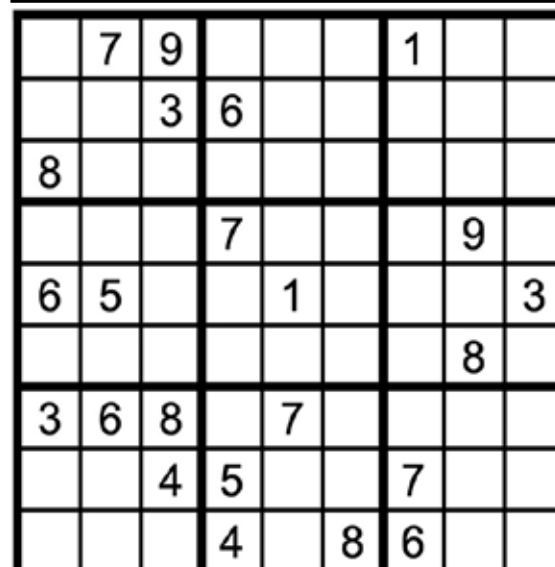
can financier.

"As the committee seeks justice for the survivors of Mr Epstein's criminal enterprise, and transparency for the American public, I respectfully request your co-operation with the committee's investigation," he wrote.

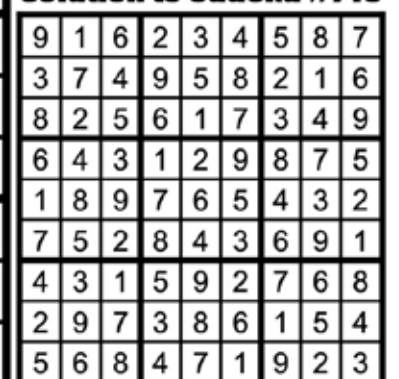
The letter referred to an email from a "Sarah" describing Epstein as "a legend" after his conviction in 2008 for soliciting prostitution from a minor - in which it was written: "I am at your service. Just marry me."

It also referenced emails that suggest Ferguson asked Epstein directly for financial assistance.

Adolescence dominates 2026 Bafta TV award nominations

■ Jack Thorne's blistering show picks up the most nods, followed by Steven Knight's boxing period drama *A Thousand Blows* and *Star Wars* spin-off *Andor*

Adolescence, Jack Thorne's groundbreaking drama about a teen accused of murder, has been nominated for more 2026 TV Bafta awards than any other show.

Described by the *Guardian* as "the closest thing to TV perfection in decades", the Netflix psychological crime drama leads the pack with 11 nominations, including best supporting actor and actress awards for four of its stars, Ashley Walters, Christine Tremarco, Erin Doherty and Owen Cooper.

Created by Thorne and Stephen Graham, and directed by Philip Barantini, the drama was also nominated for Bafta's memorable moment award, the only honor voted for by members of the public, for the scene where Jamie snaps at the psychologist.

Jane Millichip, CEO of Bafta, said: "2025

[was] an exceptional year for television, reflected in 124 nominated programs that highlight the strength and originality of British storytelling.

"From powerful documentaries and standout comedy to homegrown drama and the international series that captured global attention, this year's nominees demonstrate a medium at its creative peak," she said.

"It's especially exciting to see so many first-time performance nominees, showcasing the vibrant new talent shaping the future of our industry."

First-time nominees include Ellis Howard (*What It Feels Like for a Girl*) and James Nelson-Joyce (*This City Is Ours*), who are both up for best leading actor, as well as best leading actress nominee Narges Rashidi (*Prisoner 951*). Rafael Mathé also gets his first Bafta nod

for best supporting actor for the adaptation of Nick Cave's novel *The Death of Bunny Munro*, alongside Owen Cooper for *Adolescence*, while Chyna McQueen receives her first for best supporting actress in crime drama *Get Millie Black*.

Aimee Lou Wood (*The White Lotus*, Film Club) and Erin Doherty (*A Thousand Blows*, *Adolescence*) both have double nominations, while Rose Ayling-Ellis – who won the breakthrough star award in 2022 – is up for best supporting actress for British Sign Language thriller *Reunion*.

A Thousand Blows, a historical drama series created by Steven Knight and based on the *Forty Elephants*, an all-female crime syndicate, received seven nominations, including drama series, leading actress and costume design.

Mohamed Salah to leave Liverpool at end of season

Liverpool forward Mohamed Salah will leave the club at the end of the season, the Premier League side said in a statement on Tuesday.

"Salah expressed his wish to make this announcement to the supporters at the earliest possible opportunity to provide transparency about his future due to his respect and gratitude for them," the club statement said.

The 33-year-old Egyptian international confirmed the news via a video message on his social media accounts.

"Unfortunately, the day has come. This is the

first part of my farewell," Salah said. "I will be leaving Liverpool at the end of the season.

"I never imagined how deeply this club, this city, this people, would become part of my life. Liverpool is not just a football club; it's a passion, it's a history, it's a spirit," he added. "I can't explain in words to anyone not part of this club.

"We celebrated victory, we won the most important trophies, and we fought together through the hardest time in our life."

Signed from AS Roma in 2017, Salah established himself as one of the best

players in the club's history, helping Liverpool to two Premier League titles, the Champions League, FIFA Club World Cup, UEFA Super Cup, FA Cup and two League Cups, as well as an FA Community

Shield. He has scored 255 goals in 435 appearances, making him the club's all-time third highest goalscorer, during which he won the Premier League Golden Boot on four occasions.

CRICKET: DESPITE England's recent humiliation Down Under in the Ashes Tour, the national cricket team's head coach Brendon McCullum WILL keep his job, and indeed sacking him would have been the "easy thing to do", according to England and Wales Cricket Board chief executive Richard Gould.

McCullum, director of cricket Rob Key and Test captain Ben Stokes are to remain in their posts despite the 4-1 Test defeat in Australia, a tour blighted by poor planning, substandard performances and off-field issues.

Gould was speaking alongside Key at Lord's on Monday, discussing the findings of a review of the tour.

"I've seen the driving ambition and determination that we're lucky enough to have within our leadership group to take the lessons from the Ashes and move forward," said Gould.

"These are all individuals that have got other things that they can do in their lives. They are all committed to doing the best for England and to learning the lessons that are evident."

Gould is the son of former Wales and Wimbledon football manager Bobby and has also previously served as the chief executive of Bristol City Football Club.

World Cup dreams in tatters as Bellamy's men fail to hold onto lead as Bosnia triumph in penalty shootout

Wales suffered the agony of missing out on a second successive major tournament on penalties as they lost their World Cup semi-final at home to Bosnia-Herzegovina following a shootout in Cardiff on Thursday night.

Craig Bellamy's side had looked on course to set up a play-off final against Italy as they led 1-0 in the second half, only to concede a late equalizer before losing on penalties, as they did to Poland exactly two years earlier in their Euro 2024 play-off final.

Wales controlled a cagey first half, dominating possession and coming closest to an opening goal as Harry Wilson's beautiful bending effort cannoned off the post.

The home side took

the lead in spectacular fashion six minutes after the restart, Daniel James latching on to a wayward backpass and smashing a swerving 25-yard strike into the roof of the net.

James then hit the crossbar as the game opened up, while Wales goalkeeper Karl Darlow produced a save for the ages to claw away a goalbound header from Ermedin Demirovic.

Bosnia grew in confidence and had chances to equalise before their 40-year-old captain, former Manchester City striker Edin Dzeko, headed in from a corner in the 86th minute to send the game into added time.

Both teams looked exhausted in extra time, unable to create any op-

portunities of note, with Bosnia trying everything they could to run down the clock and force penalties.

Darlow denied Demirovic again from the first spot-kick, while Wilson, Haris Tabakovic, Mark Harris and Ivan Basic all scored before Brennan Johnson skied his to make it 2-2 after three penalties each.

Amir Hadziahmetovic converted Bosnia's next penalty and Neco Williams saw his saved by Nikola Vasilj, handing Kerim Alajbegovic the chance to clinch victory as he sent Darlow the wrong way.

Bosnia will now host Italy on Tuesday for a place at this summer's World Cup in the United States, Canada and Mexico.

Wales, meanwhile, same night for a match with Northern Ireland, who lost will return to Cardiff that nobody wants, a Thursday's other City Stadium on the friendly against North- semi-final to Italy.

Italians too tasty for Northern Ireland

Four-time winners Italy moved one game closer to a first World Cup since 2014 with victory to end Northern Ireland's dream in their play-off semi-final in Bergamo on Thursday.

Newcastle United midfielder Sandro Tonali broke the visitors' resolve, and the growing tension at the New Balance Arena, with a thunderous effort from the edge of the area in the 56th minute.

As Northern Ireland pressed forward, Moise Kean added a second off the inside of the post to secure the success with 10 minutes remaining.

Prior to that, Michael O'Neill's side - with the second-youngest average age since World War Two at just 22.5 years - had not only frustrated Italy, but had

good spells going forward, but a lack of end product in the final third proved to be costly.

Northern Ireland, who were aiming to qualify for a first World Cup in 40 years and a fourth time in their history, did not trouble home keeper Gianluigi Donnarumma.

But it was Italy, under huge pressure not to become the first winners to miss out on three tournaments in a row, who overcame a side without three key players in Conor Bradley, Dan Ballard and Ali McCann.

Gennaro Gattuso's side will now travel to Bosnia-Herzegovina, who defeated Wales 4-3 in a penalty shootout after a 1-1 draw in Cardiff.

The winner of Tuesday's match will be rewarded with a place in

Group B at the World Cup alongside co-hosts Canada, Switzerland and Qatar

For Northern Ireland, they now face a friendly against Wales in Cardiff as the dust from the World Cup play-off settles.
