



# 'HE'S NO CHURCHILL'

## ■ Miffed Prez blasts PM over denial of use of British airbases

President Donald Trump has told reporters Sir Keir Starmer is "no Winston Churchill" in the row over the refusal to permit the use of UK bases for the initial US-Israel strikes on Iran.

The US had sought to use the military base in Diego Garcia on the Chagos Islands, but the PM refused, only agreeing to the US request to use British military bases subsequently for "defensive" strikes on Iranian missile sites.

Speaking to journalists in the Oval Office, Trump said he was "not happy with the UK" over the decision, which led to US planes "flying many extra hours".

### 'national interest'

Royal Navy warship HMS Dragon has now been sent to bolster security at a British air base in Cyprus after it was hit by drone strikes.

On Sunday, the UK agreed to the US request to use British military bases - likely to be RAF Fairford in Gloucestershire and Diego Garcia - but following that decision, the prime minister told MPs the UK government "does not believe in regime change from the skies".

"President Trump has expressed his disagree-

ment with our decision not to get involved in the initial strikes, but it is my duty to judge what is in Britain's national interest," he told MPs.

### 'shocking'

The situation changed on Sunday when Iran's "outrageous" response became "a threat to our people, our interests and our allies", the PM said.

Iran's retaliation to the US and Israeli attacks had threatened British people across the Middle East, prompting the decision to allow the bases to be used to hit Tehran's missile infrastructure, he said.

Calling Sir Keir's decision on the bases "shocking", Trump said: "That island that you write about, the lease...for whatever reason, he made a lease of the island. Somebody came and took it away from him and it's taken three or four days for us to work out where we can land.

"It would have been

much more convenient landing there as opposed to flying many extra hours. So we are very surprised.

"This is not Winston Churchill that we're dealing with."

Trump went on to criticize UK government policy on energy and immigration, before adding "this is not the age of Churchill".

Earlier on Tuesday, the president criticized the PM to the Sun newspaper, saying: "It's very sad to see that the relationship is obviously not what it was", adding that Sir Keir had "not been helpful", adding he "never thought I'd see that from the UK".

### 'serious rift'

Lord Darroch, former British ambassador to the US during Trump's first term, said the comments were "pretty brutal", adding there was "obviously a serious rift there now".

"Trump is very unhappy about that denial of British airbases and I think that anger will

hang around for a while.

"There have been in history ups and downs between No 10 and the White House - not many quite as brutal as this in terms of the language the president has used."

However, he cautioned that this was an "impulsive and unpredictable" president and he said "some of the bedrock of the special relationship is still there" in terms of the military and intelligence cooperation being "as close and effective as ever".

He added the pair are likely to get past the disagreement because "in the end there's busi-

ness needs to get done between London and Washington and we need a functioning relationship to do it".

The prime minister and his team have invested a lot of energy into building a good relationship with the US president, including inviting him to the UK for a second state visit.

Downing Street are maintaining a public silence for now, wary of stoking already volatile rhetoric but aides are insisting Sir Keir has acted in the British national interest, with a sense of where British public opinion is.

Treasury Minis-

ter Torsten Bell told the BBC that "on the ground" the US and UK were continuing to work closely together and that "what's most important is that in practice, we're seeing that cooperation happen".

He said that while the UK had taken a different view to the US, he said he believed "most of the country supports the prime minister in that".

"We're really clear about what we're saying, we're saying - we don't support trying to deliver regime change from the air, but we are going to do what's necessary to protect British nationals."

# Former NATO commander: 'Trump 'has launched a war of choice'

■ Gen Sir Richard Shirreff fires back at Starmer critics, insisting the prime minister had acted "with a cool head"

Britain cannot become embroiled in a war "without a clear end point", a former senior Nato commander has said, as he defended Keir Starmer after Donald Trump's jibes that he was "not Winston Churchill".

Trump was "another American president who had launched a war of choice," said Gen Sir Richard Shirreff, as a minister insisted that the UK prime minister had acted "with a cool head" by not allowing British bases to be used for initial strikes.

The US president launched a deeply personal attack on Starmer over his refusal to let Washington launch initial strikes on Iran from British bases, telling reporters on Tuesday in the White House: "This is not Winston Churchill that we're dealing with."

In his latest extraordinary salvo, Trump said he was not happy with

the UK even though Starmer eventually agreed the US could use the Diego Garcia military base in the Chagos Islands for strikes on Iranian missile facilities.

Asked in a series of interviews on Wednesday morning about Trump's comments, the chief secretary to the Treasury, James Murray, said: "The prime minister took the decision he did in the national interest.

### 'clarity of purpose'

"He's approached this with a cool head, with a real clarity of purpose, with a real focus and a determination to do the right thing for the British people."

Shirreff, who was Nato's deputy supreme allied commander Europe, was among those who supported Downing Street's approach, saying: "Britain has to do what is right for Britain.

"There is absolutely a case for getting in-

involved but it should not get involved in any shape or form with an operation where the end stage has not been made clear, there is not a clear strategy and yet again where we have an American president who has launched a war of choice with no clear understanding of how this thing is going to end," he told the BBC.

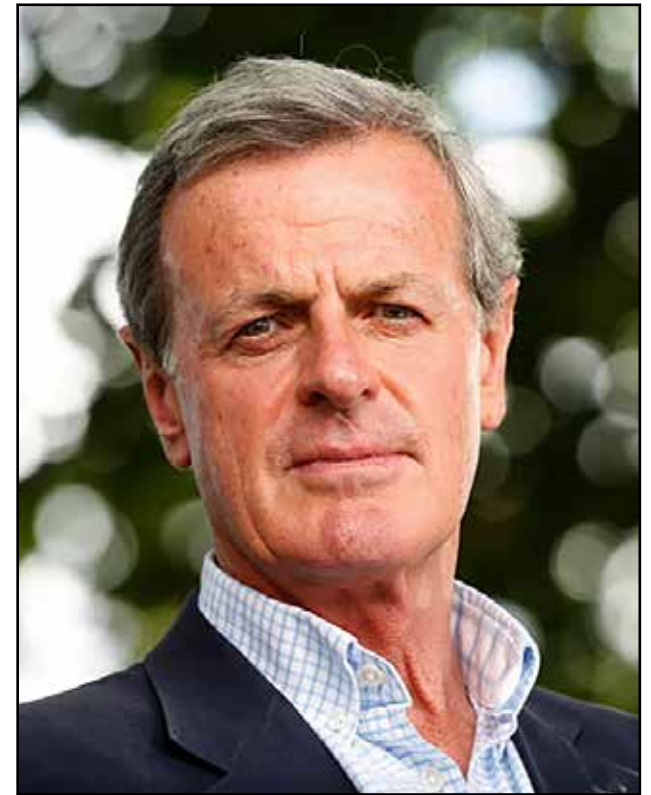
"We have been here before with Iraq in 2004 and we don't want to be

going back again into a situation like that."

### 'serious situation'

However, opposition politicians on the right in Britain seized on Trump's attack, with the Conservatives claiming that the prime minister's stance had made it more difficult to protect the UK's national interest.

The shadow chancellor, Mel Stride, told Fox News: "The takeaway of all of this is that in a very

uncertain and dangerous world allies matter, and no ally matters more to our country than the United States.

"To have ended up in a situation because of the

way the prime minister has played support to the US around Iran, where Donald Trump is really questioning the relationship he has with us, is a serious situation."

## Government scrambles to fly British residents out of danger zone

■ The Gulf is home to around 140,000 British nationals

THE GOVERNMENT was desperately scrambling this week to organize flights to rescue British nationals stranded in the war-torn Middle

East.

Several charter flights were organized at government expense in the 48 hours following the joint Israel-USA attack on Iran,

which was followed by Iranian reprisals to countries including Saudi Arabia and the UAE, which host sizeable British populations.

LIFT OFF: at least a dozen charter flights have evacuated Britons this week

About a dozen flights between London and the UAE took place during week as well as several other flights between Heathrow and the Omani capital Muscat. Several thousand Britons have already returned but there were many more stuck in

place as the weekend approached.

However, there is not expected to be a widespread evacuation of the estimated 138,000 British nationals who have registered their presence in the Middle East.

Some commercial

flights are operating from Dubai and Abu Dhabi in the UAE but the vast majority are cancelled due to airspace restrictions caused by the US-Israeli war against Iran.

British Airways, which does not usually serve

Muscat, said it remains unable to operate its scheduled flights from Abu Dhabi, Amman, Bahrain, Doha, Dubai and Tel Aviv.

Muscat has become as a key location for people to escape the ongoing conflict in the Middle East.

The Foreign Office has not advised against travel to Muscat's airport, unlike the current advice in place for airports in Dubai, Abu Dhabi and Doha.

Muscat can be accessed by road from both Dubai and Abu Dhabi with journeys of about 300 miles.

The UK's Foreign Office said: "There are a limited number of commercial options available, including by air from UAE and from Oman.

"If your presence in UAE is not essential, you may wish to consider departing – if you judge you can access these options safely."

Oman Air has continued to operate its two daily return flights between Muscat and Heathrow despite the war.

Flight-tracking service Flightradar24 said Muscat has "become a popular alternative for flying out of the region" but warned that "almost all scheduled flights from Muscat are fully booked".

Private jets are being chartered "to evacuate those who can afford it", it added.

Around half a million passengers per day usually frequent airports in Dubai, Doha or Abu Dhabi, which are crucial hubs for travel between Europe and the continents of Asia and Australia.

Experts believe it could take weeks to clear the backlog of passengers as the war unfolds.

## THE BODYGUARD BULLY: How Andrew 'browbeat' Scotland Yard into paying millions for daughters' security

■ 24/7 security ended by Charles after Eugenie's gap year jolly cost taxpayers £100k

**ANDREW Mountbatten-Windsor bullied his way to millions of pounds' worth of security for his daughters, all paid for by the public, the former head of Royal Protection has claimed.**

The former prince "browbeat" Scotland Yard over bodyguards, even before Beatrice and Eugenie were born, Dai Davies said.

The tense showdown is understood to have taken place at Buckingham Palace, some time after his wedding to Sarah Ferguson in July 1986, as the newlyweds planned to become parents.

Mountbatten-Windsor demanded that any future offspring be given 24/7 security from birth at the taxpayers' expense, irrespective of the cost.

Davies, who was head of the Royal Protection Command from 1994 to 1998, said he personally queried the decision to approve the security after Mountbat-

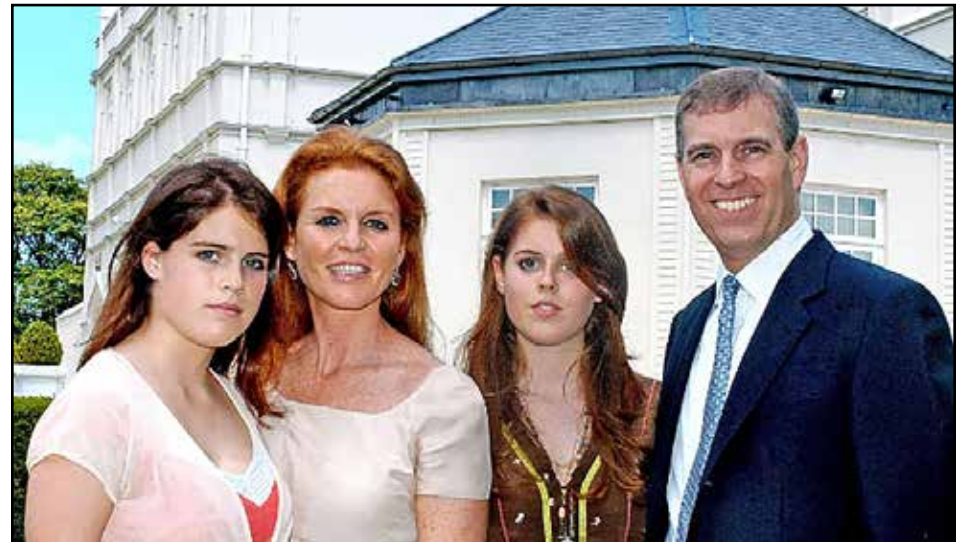
ten-Windsor's demand but: "No one wanted to question the Queen.

"It was an example of how he has operated as a bully, supported by his mother, who chose to ignore the reports."

### 'too much to pay'

Noting that Mountbatten-Windsor's elder sister, Princess Anne, had not made a similar request for her children, Peter and Zara, Mr Davies explained that as a family, Mountbatten-Windsor and ex-wife Sarah, along with their two daughters, "have cost the taxpayer hundreds of millions" over the years. The security was revoked in 2011 after Eugenie's gap year racked up a taxpayer bill of more than £100,000, as she was accompanied by police bodyguards while travelling to India, the US, South Africa and Thailand.

Speaking on the Channel 5 documentary, Beatrice and Eugenie: Pampered Princesses, royal expert Richard

Kay said: "She was sort of flitting from country to country as most middle-class young people do who take gap years. But, of course, she was accompanied by police bodyguards."

It was the then-Prince Charles who reportedly stepped in to control the spending, much to his brother's chagrin.

Also speaking on the program, royal biographer Angela Levin said: "Charles decided that

as they were not likely to be very senior royals, that this was too much for the public to pay, so he stopped that.

"Prince Andrew was so angry that he wrote a note to the Queen.

"He said he wanted them to be considered as proper royals. He did not want the protection officers to leave them."

Mr Davies notes Mountbatten-Windsor tried to "plead" and "demand" that the decision be reversed but was un-

successful.

It is now understood that both princesses, who are not working royals, have any security they need privately funded. The only royals with 24/7 police security now are the King, Queen and the Prince and Princess of Wales.

The Duke and Duchess of Edinburgh and the Princess Royal do not have full-time protection but do have bodyguards for when they carry out public engagements.

## Bonkers Britain: failed asylum seekers will be given up to '£40k to go away'

**Families of failed asylum seekers are set to be offered payments of up to £40,000 to leave Britain under a controversial new Government pilot scheme.**

The initiative, designed by the Home Office, targets migrants who have exhausted their legal options and agree to cooperate with the system by departing the United Kingdom within a strict seven-day window.

Under the terms of the plan, individuals who comply will receive payments of £10,000 per person, though the total

amount is capped at four people per family.

The trial has already begun to move into its operational phase, with some 150 families currently residing in taxpayer-funded hotels receiving messages on Thursday informing them of their eligibility to participate.

### political row

However, the move has immediately sparked a fierce political row over the use of public funds and the message it sends to those seeking to enter the country illegally.

## “Arrogant and toxic” Diana’s former bodyguard lays into Andrew

■ SAS-trained Scotland Yard inspector describes former Prince as one of the most arrogant individuals I’ve ever had the misfortune of meeting.”

Princess Diana’s former bodyguard has lashed out at Andrew Mountbatten-Windsor, labelling him arrogant and toxic.

SAS-trained Scotland Yard inspector Ken Wharfe revealed his intense dislike for the former prince when asked about him on the UK’s Suddenly Single podcast.

### ‘personal stand’

And Mr Wharfe, who worked for Diana from 1988 to 1993, said: “I did, on a few occasions, have dealings with him

in a professional capacity and I found him to be one of the most arrogant individuals I’ve ever had the misfortune of meeting.”

During the chat, he made it clear he had tried to avoid commenting on Andrew’s arrest and the Epstein Files revelations as long as possible.

He said: “Ever since the Epstein crisis that hit the Royal Family, I’ve taken a personal stand on this. The whole issue of the Duke of York, as he was, and now Mountbatten-Windsor, is excruciatingly toxic, and

continues to be.

“It’s a subject that, as yet, is not finished. It’s only just begun, and who knows where this might end up?”

Andrew was arrested on February 19 on suspicion of miscon-

duct in public office. It is alleged he passed on confidential information to Jeffrey Epstein while a trade envoy for Britain. Andrew has not been charged and has previously denied all wrongdoing.

“This is an insult to the British taxpayer,” Philp stated, arguing that offering £40,000 to those who have failed their asylum applications will only serve to reward and incentivize illegal arrivals.

The Home Office has hit back at these suggestions, with a spokesperson insisting the plan is not a “pull factor”. They noted that illegal migrants often pay smugglers tens of thousands of pounds to reach Britain and argued that if families refuse the time-limited payment, they will face forcible removal.

### ‘no future’

Home Office minister Alex Norris also defended the scheme on fiscal grounds, claiming it could save the British taxpayer roughly £20 million in hotel costs. Speaking to LBC, Norris highlighted that the average cost of housing a single family in a hotel reaches an eye-watering £158,000 a year. “We’re

doing a targeted pilot at 150 families that, if effective in its totality, will lead to a saving of £20 million to the taxpayer,” he explained.

Norris emphasised that the people targeted are those who have failed their initial applications and their subsequent appeals. “They have no live asylum application in this country and, frankly, no future in the country,” he said.

### Danish model

He argued that the current situation is detrimental to both the adults and the children involved, and while similar support has been offered in the past, the Government is increasing the amounts to effectively incentivise departure.

The shift in policy follows Home Secretary Shabana Mahmood’s recent visit to Denmark, a country known for having one of Europe’s toughest immigration systems. Denmark currently pays failed asylum seekers up to £30,000 to leave, a strategy the country claims has helped

halve the number of people awaiting deportation. Ms. Mahmood has expressed admiration for the Danish model and is expected to unveil a comprehensive overhaul of the British system. This overhaul will include tough new rules, such as the immediate removal of asylum seekers from Government-funded accommodation if they break the law or work illegally in Britain.

The Home Secretary has framed these reforms as a “compassionate but controlled asylum system,” reflecting what she describes as a “firm, but fair” approach aligned with Labour values. Outlining her case, Ms. Mahmood insisted that the state must be a “force for good” and that restoring order at the border is essential for public trust.

“Restoring order and control at our border is not a betrayal of Labour values; it is an embodiment of them,” she said, asserting that such control is a necessary condition for the Government to achieve its wider goals.

## United’s Maguire avoids Greek jail term



EXTRA TIME: the sentence stemmed from an incident on Mykonos in 2020

Manchester United defender Harry Maguire has been handed a 15-month suspended sentence by a Greek court following an incident on the island of Mykonos in August 2020.

England international Maguire was given a suspended sentence of 21 months and 10 days in prison in 2020, after initially being found guilty of repeated bodily harm, attempted bribery, violence against public employees and

insult.

The following day Maguire’s legal team lodged an appeal against the verdict. In accordance with Greek law, the appeal nullified his conviction and meant there would be a full retrial.

The retrial was postponed on four occasions between 2023 and 2025, before it restarted in Syros on Wednesday.

It concluded that Maguire was guilty of non-serious assault, resisting arrest and at-

tempted bribery.

In accordance with the reduced severity of the defender’s crimes, Maguire’s sentence was reduced to 15 months.

Maguire denies wrongdoing and plans to appeal to the Supreme Court.

Maguire has rejected a number of opportunities to settle the case out of court, as he is determined to clear his name legally.

Maguire was not required to attend the

# Murphy: Peaky passion is 'wonderfully humbling'

Cillian Murphy has said it's "wonderfully humbling" to see the passion for Peaky Blinders, as he reprises his long-running role as Tommy Shelby in a feature film.

The Irish actor has returned to play the Birmingham gangster in Peaky Blinders: The Immortal Man, 13 years after he first took on the part in the BBC TV series.

"There wasn't promotion at the beginning. The show came out, and then very slowly it became this phenomenon, and it was down to the fans," he said.

"It's a wonderfully humbling thing to know that these fans have such an investment in the characters. And I've al-

ways felt like this [movie] is a return on your investment."

The Immortal Man comes four years after the sixth and final series of the TV show. In the intervening period, Murphy has won an Oscar, a Bafta and a Golden Globe for Oppenheimer.

New additions to the world of Peaky Blinders include Oscar nominee Barry Keoghan, who plays Shelby's son Duke, plus Dune actress Rebecca Ferguson and Reservoir Dogs actor Tim Roth.

### 'loyal and passionate'

Peaky Blinders creator Steven Knight said the cast "couldn't be better".

"I think we have got the cream," he said. "When we approach

pretty much anybody they say yes. That's true of actors, music, everything, because Peaky has an effect."

The fans "have been so great, and they've been the source of an enormous amount of energy and confidence for us to go forward", Knight said.

"We see how loyal they are, how passionate they are, the tattoos and all kinds of things that that have been going on spontaneously, not because of promotion or marketing."

The film will be on the big screen for two weeks before it's released on Netflix on 20 March, and Knight said he wanted it to have a cinema release partly to give those fans a chance to get together.

"What we wanted to do was to make a film that will be in theatres, so that people who are fans can watch the thing together, in person, and not just communicate virtually."

The film picks up in 1940 during World War Two, with Tommy Shelby being forced to revisit his past.

"When you meet him at the beginning of the Second World War, he's retreated from society,"

Murphy explained. "He's on his own, rattling around in his big house with all these demons and ghosts, and the consequences of his deeds come rushing back in."

Shelby is seen writing a book as a form of therapy, before the world of the Peaky Blinders gangsters "draws him back in, and ultimately his son draws him back into the world", Murphy said.

The Immortal Man

isn't the end of the legendary gang - after the film, Peaky Blinders will return to TV to follow the exploits of the new generation of the Shelby family after World War Two.

"There is more to be told in the universe, but this is the final chapter of this part of the story," Knight added with a smile.

hearing in person. In Greece, defendants in cases of this level can be represented by their lawyers.

Another factor is Greece's statute of limitations. For offences of this type, legal proceedings must conclude within eight years - meaning the case would expire in August 2028 if not resolved before then.

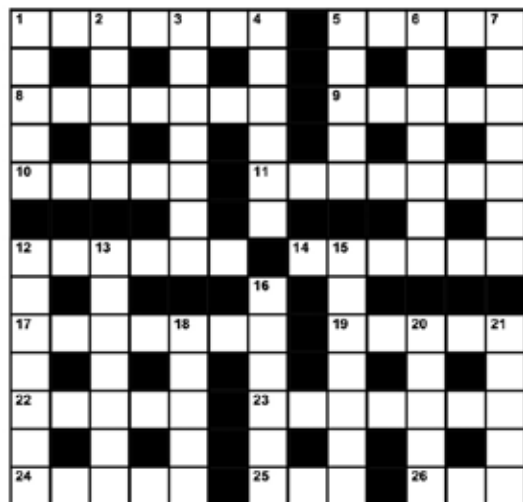

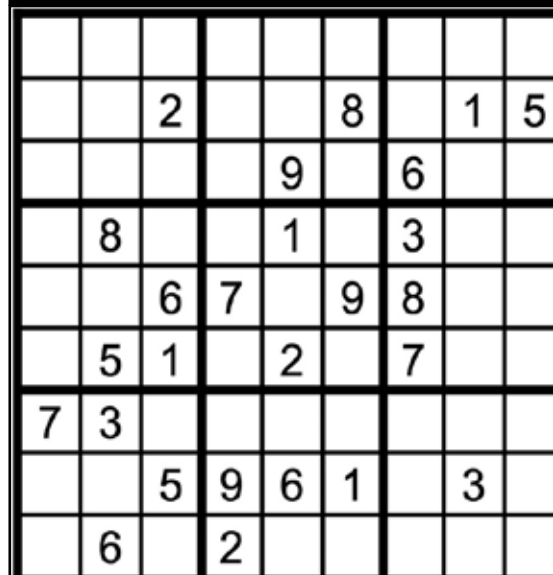

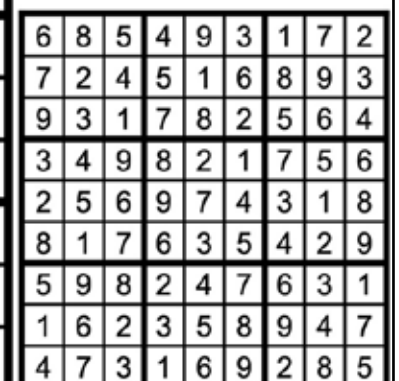

## Osula late show ends Carrick run



Substitute William Osula (above) scored a superb late winner as 10-man Newcastle United inflicted Michael Carrick's first defeat as Manchester United manager in midweek.

Carrick grew up watching Newcastle on the Gallowgate End, and warned his players the stadium was "tough place to go" before a ball had been kicked.

So it proved - even after Newcastle midfielder Jacob Ramsey was sent off in the first half - as the spirited hosts rallied at a raucous St James' Park.

It looked like both sides were going to have to settle for a share of the spoils after Casemiro's header cancelled out Anthony Gordon's pen-

alty.

But Osula cut inside the box and lashed the ball past the stunned Senne Lammens, who could only watch it hit the net in the 90th minute to send the stadium into raptures.

What a contrast to the scenes in first-half stoppage time when Newcastle players, staff and supporters were furious when Ramsey was sent off for a second booking.

Referee Peter Bankes felt the midfielder dived in an attempt to win a penalty when he nudged the ball past goalkeeper Lammens.

But Newcastle quickly channelled their anger and Gordon was awarded a spot-kick after the forward was brought down by Bruno Fer-

nandes inside the box.

Gordon coolly placed his penalty straight down the middle of Lammens' goal to open the scoring and net his 15th goal of the campaign.

But Manchester United have recovered more points (nine) from a losing position than any other side in the Premier League in 2026 for a reason, and Newcastle were not in front for long.

There was still time for another dramatic twist in the ninth minute of first-half stoppage time after Manchester United midfielder Casemiro made a smart run to the near post to head home from Fernandes' free-kick.

Newcastle were quick-

chester City slipped up.

Arsenal's performance in victory was desperately average throughout, hanging on in a scrap and barely creating a chance - and yet the result was greeted like a title win itself.

Saka's fortunate early strike, aided and abetted by the hapless Verbruggen, was a rare moment of danger for Brighton, who set the tempo throughout.

And yet, as Brighton's efforts became more laboured, Arsenal survived the storm to celebrate at the final whistle, the noise from the travelling supporters coming to a crescendo when news of Forest getting a draw at Etihad Stadium filtered through.

Arsenal were in retreat for most of the game, their cause not helped by a lack of creation and ability to maintain possession or hold the ball up front, with Viktor Gyokeres anonymous before being substituted.

At the heart of it all was defender Gabriel, magnificent with his usual partner William Saliba out injured, almost mounting a one-man barrier of defiance as Brighton pushed.

The celebrations at the final whistle on and off the pitch reflected the importance of the win as Arsenal fans chanted "We're going to win the league".

And it is results like this, on nights like this, when titles are sometimes won.

## Cricket: England fall short in T20 semi

AFTER A DISMAL Ashes Series over the festive season, England's limited overs team gave the nation something to cheer about, putting together an encouraging run to the semi-finals of the T20 World Cup in India, before being narrowly beaten by the hosts in Mumbai on Thursday.

A thrilling century by rising star Jacob Bethell was not enough as India pipped England by just seven runs to seal a spot in the final in a high-scoring thriller.

Needing 254 for victory - a record in this competition - after being flogged around Wankhede Stadium, Bethell hit a scarcely believable 105 from 48 balls to threaten one of England's all-time white-ball victories.

The 22-year-old kept England afloat from 63-3 and 95-4 and took boundaries from the final two balls of the 17th over to leave 45 to get from the final three.

The Wankhede Stadium crowd, jubilant when

for 18 in the 19th - Hardik Pandya also holding his nerve - and Bethell was unable to get 30 needed from the last alongside Jamie Overton.

He was run-out attempting to keep the strike and England, despite three sixes by Jofra Archer when the game was all but done, finished on 246-7.

India were also boosted by two sensational catches by Axar Patel, first to dismiss Harry Brook and then a relay effort to see off Will Jacks, but England will rue a crucial drop by Brook.

In the third over he put down Samson on 15 - a mistake India punished by piling up the highest T20 score ever made against England.

It means co-hosts India will play New Zealand in Sunday's final in Ahmedabad.

England do not play again until the first Test of the summer against New Zealand in June but Bethell's knock ensured they do not depart completely deflated.

Sanju Samson earlier crashed 89 from 42 balls, had become increasingly nervous but the great Jasprit Bumrah remained calm through the tension, conceding only six from the next over.

caused chaos in the area.

Tottenham responded with an attack of their own, ending with Mathys Tel cutting in from the left and firing at Dean Henderson.

third goal since joining from Wolves.

Last season's FA Cup winners piled the misery on Tottenham - and cued a mass home supporter walkout - in the seventh minute of first-half stoppage time as Sarr grabbed his second after another defence-splitting pass from Wharton, who was inexplicably left unmarked for both his decisive assists.

The goal sparked a huge exodus from the home fans, with an estimated 15,000 of them heading for the exits before the second half had begun - which at least spared them the misery of a turgid second half with both teams barely going through the motions.

If Tudor was meant to be the firefighter to save Tottenham's Premier League season, so far he has only fanned the flames of a miserable campaign.

## ...while Arsenal inch into seven point lead

Arsenal rode their luck to survive a torrid encounter at Brighton Wednesday night and extend their lead at the top of the Premier League to seven points.

Brighton were the superior side for long periods - but Bukayo Saka's deflected early strike proved enough to give Mikel Arteta's side a priceless triumph, especially with

Manchester City being held to a 2-2 draw at home by struggling Nottingham Forest.

Arsenal's night almost began in catastrophic fashion in the opening seconds when goalkeeper David Raya sent a clearance straight to Carlos Baleba, but his attempted chip was weak, allowing Gabriel to retreat and head off the line.

And the Gunners' luck was in after nine minutes when Saka's routine shot took a deflection off Baleba and went through the legs of Brighton keeper Bart Verbruggen, who should have done better.

Brighton's fans, whipped up by head coach Fabian Hurlzeler on the sidelines, were infuriated by what they saw as
