House of Lords bill abolishes the remaining hereditary seats in Upper Chamber

Dozens of hereditary peers are set to lose their seats in the House of Lords, after the passage of a bill that will end a parliamentary role dating back hundreds of years.

Peers passed the House of Lords (Hereditary Peers) Bill on Thursday after ministers offered a compromise to end a long-running dispute with opponents of the reform.

The majority of hereditary peers, who inherit their titles through their families, were abolished in 1999 under the last Labour government and this bill gets rid of the last remaining 92.

Lords Leader Baroness Smith said the "historic legislation" realized Labour's manifesto pledge to remove the right of all hereditary peers to sit and vote in the upper house.

"meaningful reform"

"This has never been about the contribution of individuals but the underlying principle that was agreed by Parliament over 25 years ago that no-one should sit in our Parliament by way of an inherited title," Baroness Smith said.

"Over a quarter of a century later, hereditary peers remain whilst meaningful reform has stagnated.

"We have a duty to find a way forward."

Baroness Smith con-

firmed the government would offer life peerages to the Conservatives and crossbenchers, meaning some hereditaries are likely to remain in the Lords.

As a result, the Conservatives withdrew their opposition to the bill.

Ministers have offered the Conservatives the chance to retain 15 hereditary members of the House of Lords as life peers.

A Lords source said the agreement involves the Conservatives delivering a number of retirements from among their life peers.

The final number of life peerages offered to the Conservatives or any other parties will be decided and announced by the prime minister.

Up to 92 hereditary peers will leave the Lords when the current session of Parliament ends, which is expected to be in May.

The Conservative leader in the Lords, Lord True, said he accepted the government's mandate to end hereditary membership of the upper house.

Confirming the Tories would no longer fight the bill, he said he had always believed there was a need to dial down

"eternal [parliamentary] ping-pong" even though the compromise would be a bitter pill for some on his side to swallow.

'proud to sit here'

In another compromise, the government also plans to increase the number of paid ministers in the Lords - some have worked without a salary due to restrictions in the current law.

Baroness Smith said interim measures had been in place for 25 years since the first hereditaries were removed under former Prime Minister Tony Blair's government.

Ministers are looking

at further reforms with a possible retirement age and minimum participation rates.

For hundreds of years, hereditary peers had the right to make and debate laws in Parliament, a right they generally inherited from their fathers and passed on to their sons.

Throughout history most hereditary peers have been male, although some titles have been passed to women including the Countess of Mar who retired in 2020.

In 1999, Blair described their presence in the House of Lords as an "anachronism" and got

rid of more than 600 of them but, following what was supposed to be a temporary compromise, 92 were saved.

One of the departing hereditaries, the Earl of Devon, said the bill was regrettable.

He said his family had been in the Lords for 900 years - and complained the notice period was less than required in employment law.

"I think this House, Parliament, and the public more widely will miss us," the Earl of Devon said.

He said hereditary peers should be "proud to sit here as embodi-

ments of the hereditary principle dating back a millennium".

He added: "I will miss this place and would of course love to return, but only on merit and not by dint of my hereditary privilege."

The Lord Speaker thanked hereditary peers for their service in the upper chamber.

"Whatever views people may have of this constitutional change, it is sad to say goodbye to friends, who in many cases have contributed significantly to debate and scrutiny and to our institutional memory," Lord Forsyth of Drumlean said.

British base targeted by Iranian drones

■ Lone British warship despatched to eastern Mediterranean

British forces based in Iraq shot down two Iranian drones on Wednesday night, Defence Secretary John Healey has said.

But some drones in the attack hit the coalition base in the Iraqi city of Erbil, the capital of the Kurdistan region, and injured a number of US troops. There were no British casualties.

Brigadier Guy Foden said the base and another in the Iraqi capital of Baghdad were struck "a number of times" on Wednesday night and British personnel are currently in Erbil helping to defend that base.

Since the US-Israeli strikes on Iran, US bases in Iraq have been targeted in retaliation.

The Western base in Erbil is controlled by the US but often houses other forces including British troops.

Foden said British forces "shot down two UAVs (unmanned aerial vehicles) coming out of the camp but a number of UAVs did impact the camp".

Healey said from the point when Iran began "hitting back indiscriminately" at countries across

the Middle East, there had been a British team involved in Iraq.

"We've had a team at the base in Erbil that's been pulling down drones, protecting themselves but also protecting the base and other service people that they serve with there," he said.

Healey was speaking during a visit to the UK's military headquarters in Northwood, north-west London, where he received a briefing on the latest situation in the Middle East.

Putin's windfall

The UK's chief of joint operations, Lieutenant General Nick Perry, told Healey at the briefing that there were "definitively" signs of a link between Russia and Iran in the way attack drones are being used.

Healey later told reporters that Iranian drone attacks have the hallmark of the way Russia is attacking Ukraine, adding: "No one will be surprised to believe that Putin's hidden hand is behind some of the Iranian tactics."

The defence secretary said Putin was the "one world leader" benefiting

from the war because of higher oil prices, which he said help the Russian president with a fresh supply of funds for his brutal war in Ukraine.

Foden said the UK flew air combat patrols over Jordan and the United Arab Emirates, in addition to a "number of sorties" over Qatar.

RAF jets also continued to fly in defence of Cyprus with European allies in the region.

Healey added that the UK had clocked up more than 300 pilot flying hours over the last 13 days.

A British warship, HMS Dragon - which left the UK for the region on Tuesday - was still on the way to the Mediterranean as of midday on Thursday.

The Strait of Hormuz was also discussed with defence personnel, Healey said, as reports were becoming clearer that Iran "may have been mining" the Strait.

Healey said the UK had some "autonomous de-mining assets" in the area, but the only Royal Navy mine-hunting ship that was stationed in Bahrain, HMS Middleton, had returned to Portsmouth for planned maintenance.

'Visa Brake' imposed on four countries following abuse

Government to end study visas from Afghanistan, Cameroon, Myanmar and Sudan, and work visas for Afghans

An 'emergency brake' on visas has been imposed for the first time on nationals from four countries following a surge in asylum claims from legal routes.

Asylum applications by students from Afghanistan, Cameroon, Myanmar and Sudan rocketed by over 470% between 2021 and 2025 - making them among the most likely nationalities to claim.

Meanwhile the number of Afghans on work visas claiming asylum is now outstripping the number of visas issued.

In an unprecedented

step, the Home Office will end sponsored study visas from all 4 countries and skilled worker visas for Afghan nationals.

Tough action is required as asylum claims from legal routes have more than trebled since 2021, making up 39% of the 100,000 people who applied last year. In total, 133,760 people have claimed asylum after arriving legally in the past 5 years.

Many are then accommodated at taxpayer expense, with an above average proportion of people from these 4 countries claiming destitution. Asylum support

is currently costing more than £4 billion a year - with nearly 16,000 nationals from the 4 countries currently supported at public expense, including over 6,000 in hotels.

Mahmood said: "Britain will always provide refuge to people fleeing war and persecution, but our visa system must not be abused."

"That is why I am taking the unprecedented decision to refuse visas for those nationals seeking to exploit our generosity."

"I will restore order and control to our borders."

Starmmer 'ignored warnings' to hire 'reputational risk' Mandelson

■ PM under fire as leaked 'Mandelson Files' reveal he was warned REPEATEDLY of Lord's murky ties to billionaire pedophile before botched US Ambassador stint

Sir Keir Starmer is facing a political firestorm this week after a cache of explosive government documents revealed he ignored blunt warnings to appoint Lord Mandelson as Britain's man in Washington.

The so-called "Mandelson Files" - a 136-page dossier of due diligence and high-level emails - lay bare a catastrophic lapse in judgment at the heart of Number 10.

The documents reveal that the Prime Minister was explicitly told of the "reputational risk" by appointing him to the most prestigious posting in the diplomatic service.

Despite a dossier flagging Mandelson's deep and enduring ties to the late sex offender Jeffrey Epstein, Starmer pressed ahead with the doomed appointment, only to see it end in a bitter sacking and a grubby row over a

taxpayer-funded golden parachute.

The most damning revelations in the files concern the sheer scale of the peer's relationship with Epstein. While Starmer has previously attempted to claim he was "misled" by Mandelson regarding the extent of these links, the released papers tell a very different story.

Officials warned the PM that Mandelson:

- Maintained a "particularly close relationship" with Epstein long after the financier's 2008 conviction for procuring an underage girl.

- Stayed at Epstein's house in June 2009 - while the billionaire was actually serving time in jail.

- Facilitated meetings between Tony Blair and Epstein, records of which are held by the Cabinet Office.

- Signed up as a "founding citizen" of an

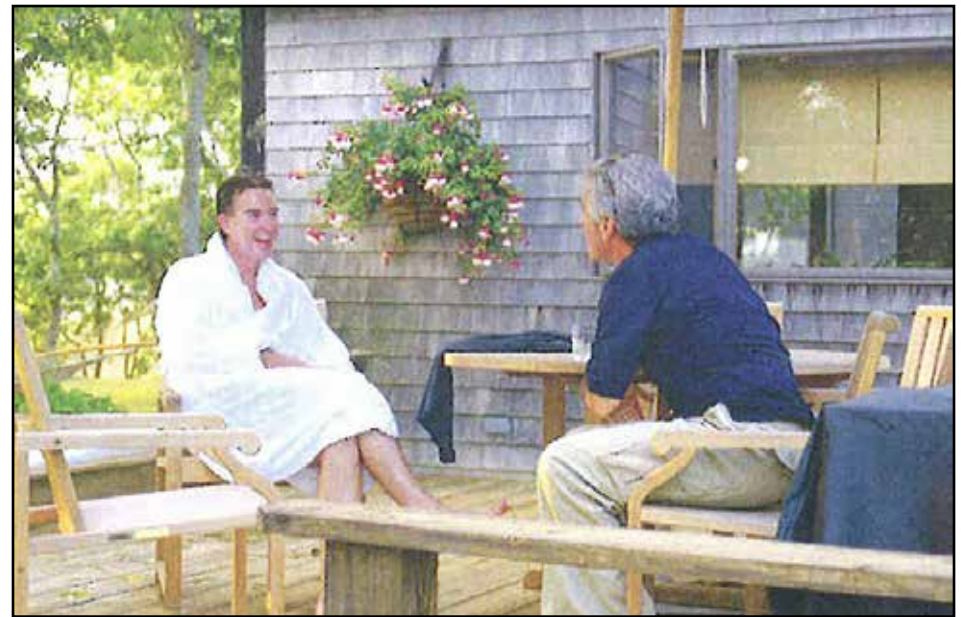
ocean conservation group founded by Ghislaine Maxwell and bankrolled by Epstein as late as 2014.

The "due diligence checklist" sent to the Prime Minister didn't pull its punches, reminding Starmer that Mandelson had already been forced to resign from the Cabinet twice under Blair and Brown following separate financial scandals. Yet, in a move that has left Westminster reeling, the PM chose to look the other way.

Severance package

The files also expose the unedifying scramble for cash that followed Mandelson's eventual removal from the post. Internal emails show that the peer, evidently not content with a simple exit, attempted to squeeze the taxpayer for a staggering £550,000 severance package.

Negotiations were de-

scribed as "fraught" as Mandelson demanded a full payout of his entire contract. While he was eventually forced to settle for a £75,000 payout, the revelation that he sought over half a million pounds after being sacked from a role he was deemed a "risk" for in the first place has sparked fresh outrage.

Critics are now asking why Starmer - a man

who prides himself on his background as a former Director of Public Prosecutions - chose to ignore such a glaring paper trail of red flags.

The Cabinet Office advice was clear: Mandelson was a liability. The 150 pages of evidence, which include advice from former Cabinet Secretary Simon Case, suggest that the "reputational risk" wasn't just a possibility—

it was a certainty.

By releasing these papers now, the Prime Minister appears to be trying to burn his former ally to save his own skin, claiming Mandelson lied during the vetting process. But with the files proving the warnings were sitting on his desk from day one, it's the PM's own vetting of the facts that is now under the microscope.

Fellow inmate charged with slaying of Soham killer Huntley

■ Monster responsible for 2002 killings which shocked the nation had been attacked several times since he was given life term

A prison inmate who has been charged with the murder of Soham killer Ian Huntley has appeared in Crown Court for the first time.

Anthony Russell, 43, appeared via video link from HMP Frankland at Teesside Crown Court on Thursday.

He was not asked to enter a plea but was told there would be a pre-trial preparation hearing on 24 April at Newcastle Crown Court.

Huntley, 52, was taken to hospital following the attack at the prison on 26 February and died nine days later.

He was repeatedly

hit over the head with a metal bar in the prison's workshop.

Huntley had been serving a life sentence for the murders of 10-year-olds Holly Wells and Jessica Chapman in 2002.

'most shocking'

At the 10-minute preliminary hearing before Judge Francis Laird KC on Thursday, Russell only spoke to confirm his name and provide his date of birth.

The trial could last up to five days, the court heard.

The Ministry of Justice has previously said

Huntley's crime "remains one of the most shocking and devastating cases in our nation's history, and our thoughts are with their families".

Huntley killed best friends Holly Wells and Jessica Chapman after they left a family barbecue to buy sweets in Soham, Cambridgeshire.

He then dumped their bodies in a ditch 10 miles (16km) away.

previous attacks

The girls were not found for 13 days despite a search involving hundreds of police officers.

Huntley denied murdering the girls but was convicted after a trial at the Old Bailey in 2003.

He was jailed for life with a recommended minimum term of 40

years.

The attack in February was not the first time Huntley had been targeted in prison.

In 2005, he was attacked by an inmate who

threw boiling water over him at HMP Wakefield in West Yorkshire.

Five years later, he was slashed across the throat at HMP Frankland and needed 21 stitches.

Fire leaves historic Glasgow station facing demolition

The “highly dangerous” remains of a historic Glasgow station wrecked by a fire will be demolished, Glasgow City Council has confirmed.

The council’s building standards team said there was risk of further collapse - including a “floating” chimney stack still attached to an adjoining building, several storeys above ground.

The demolition is expected to begin on Friday with the station to remain closed for the rest of the week.

The fire started in a vape shop on Sunday afternoon and spread through the B-listed Victorian building. There were no casualties.

Glasgow City Council has now taken control of the building from the Scottish Fire and Rescue Service and carried out its own assessment of the damaged structure.

Raymond Barlow, from the council’s building standards team, said the building had been “fatally compromised” and the remaining structure was “highly dangerous”.

He pointed out that one of the most dangerous elements left behind was the floating chimney stack, which would be the first part to be brought down.

PM warns fuel profiteers

Sir Keir Starmer has vowed to crack down on those companies in Northern Ireland “profiteering” from the fuel crisis triggered by the war in the Middle East.

The prime minister was speaking during a visit to Northern Ireland where he held talks with party leaders and also visit a community centre.

Firefighters have been on site all week to cool any remaining hot spots in the remains.

Network Rail said “all available options” for safely reopening the station were being explored, including a partial or phased reopening of some platforms.

Services from the station’s low level platforms resumed earlier this week.

At First Minister’s Questions John Swinney told MSPs that the Scottish government had been in discussions with Glasgow City Council over supporting local businesses.

He said ministers were also looking at ways for tighter regulation of vape shops.

Scottish Conservative leader Russell Findlay said help for local firms should be the immediate focus, while Scottish Labour leader Anas Sarwar called for an investigation into the resourcing of the fire service.

Sarwar claimed high-reach appliances in the city had been cut from six to two, both of which were off for annual inspection on the night in question. This meant one had to be called through from Edinburgh.

Swinney said resources required to tackle the fire were available.

He said the government will not hesitate to act if companies “fleece customers or rip them off” with “unfair” heating oil prices.

Recognizing the majority of households in Northern Ireland rely on heating oil, the prime minister said prices must be “fair transparent and justifiable and not inflated.”

‘Very formidable’ Adams was IRA’s ‘de facto’ leader, High Court told

■ Three victims of bombings sue Sinn Fein leader for ‘vindicatory’ damages in London

A former Northern Ireland police officer who worked in intelligence said Gerry Adams was “a very formidable opponent” as the IRA’s “de facto” leader.

Witness B has been giving evidence against the former Sinn Féin leader at the High Court in London.

Adams, 77, is being sued by John Clark, Jonathan Ganesh and Barry Laycock, who were injured in IRA bombings in London and Manchester in 1973 and 1996.

Adams strenuously denies any involvement and has consistently rejected claims he was ever in the IRA. He is due to testify next week.

The claimants, who are seeking “vindicatory” damages of £1, allege he is personally liable for decisions to plant the bombs.

Witness B testified from behind a screen, after the court ordered his identity be kept secret.

He worked in Royal Ulster Constabulary (RUC) special branch from 1979.

Based on intelligence he read, he alleged Adams had been a senior member of the IRA army council and the “de facto” leader of the IRA.

‘Strategic thinker’

Asked why he was not arrested, he replied: “He wouldn’t answer any questions so what would have been the purpose of arresting him?”

Witness B described him as “a very formidable opponent” and a “strategic thinker”.

He said the London Docklands bomb in February 1996, which ended the first IRA ceasefire, “was a great shock”.

Although the RUC felt the ceasefire would break, the bombing “took us all by surprise”.

In his witness statement, he stated: “Much of the intelligence I had access to led me to conclude that the defendant (Adams) was undoubtedly a member of the army council for the period encompassing the 1980s and 1990s.

“All the intelligence I saw pointed to his membership and leadership within the IRA.”

It went on: “It is my certain knowledge, based on the materials I had access to at the time... that the bomb at Canary Wharf on 9 February 1996 was not simply sanctioned by the army council but was ordered by the army council.

“It is inconceivable that such an action would be carried out without its explicit orders.

“The defendant was at that time very much the first among equals on the army council of the IRA.”

Witness B’s statement added that if Adams was not the most important member of the IRA, “he pulled off a remarkable coup”, as the British, Irish and United States governments believed otherwise.

“Had (Adams) not been the senior figure in the IRA that he was, there would have been

absolutely no point in the governments dealing with him the way they did on the road to the Good Friday Agreement in 1998.”

‘Pure intimidation’

The court also heard from Austin Stack, whose father Brian was an Irish prison officer murdered by the IRA in 1983.

He met Adams in 2013, as part of efforts to obtain an apology.

Stack claimed Adams told him he was “very brave to meet with him” - a remark he described as “pure intimidation”.

In his witness statement, he stated: “This was a strange opening comment from a man who presented himself as a politician and a man of peace.”

Adams’ lawyer said his client disagreed that he had used the words and asked Stack if his memory is accurate.

He said he remembered the comment, adding his brother was also at the meeting and would verify what was said.

Stack added that Adams had not challenged his version in a book he had published.

“He would’ve been open to take legal action

but chose not to.

“I think the court can take its own inference from that.”

Intelligence reports

Tim Hanley, a retired detective chief superintendent, also appeared in the witness box.

He served in the RUC and the Police Service of Northern Ireland (PSNI) between 1986 and 2016 and first saw intelligence reports in 2006.

Hanley claimed they stated Adams had sat on the seven-member IRA army council until the 2000s.

Hanley alleged information he saw stated that Adams was “responsible for directing” the bombing of the Old Bailey and London Docklands.

Adams’ lawyer James Robottom asked if there was evidence, why was his client not arrested?

“The operational reality from experience is Mr Adams, or anybody else in the IRA, would go through a ‘no comment’ interview.

“That’s just the way it was back then.

“That’s not making an excuse, that’s just the reality.”

The trial will resume next week.

Joey Barton must stump up £300k for social media posts blasting female footy pundit

Former England footballer and pundit Eni Aluko has been awarded more than £300,000 damages and legal costs after suing Joey Barton for libel over social media posts.

Pundit Aluko brought legal action against Barton over two posts he made in 2024 on social media site X.

Earlier the High Court heard the case had been stayed, meaning proceedings were halted and

Barton was ordered to pay "substantial" damages and Aluko's legal costs.

Gervase de Wilde, for Aluko, said that in the two X posts Barton, from Huyton, had wrongly claimed she had "cynically sought to exploit her status as an alleged victim of racism and bullying", and that she was a hypocrite.

Barton - who managed Fleetwood Town and Bristol Rovers - did not attend the hearing, with De Wil-

de telling the court that he was arrested on Monday and is currently being held in custody after allegedly attacking a man near a golf course in Huyton, Merseyside earlier.

De Wilde said that between January and August 2024, Barton published 48 posts relating to Aluko on his X account, adding that he had "carried out a deliberately targeted public campaign of vilification".

He said one post

included an image of Aluko's head superimposed onto serial killer Rosemary West's body.

"The campaign amounted to an attack on multiple aspects of her life and personality," he said.

"Mr Barton's campaign caused Ms Aluko enormous distress. When she sought to defend herself against Mr Barton's conduct, and that of his followers, he criticised and attacked her for doing so."

De Wilde said Aluko was worried that however she tried to stop the harassment, Barton "would exploit and manipulate it to use against her".

The barrister said: "Mr Barton has now

accepted that his campaign against Ms Aluko amounted to harassment and that he should not have made the publications."

According to a court order seen by the Press Association, Barton has been told to pay £339,000, with

the first £100,000 plus interest due by March 24.

Justice Nicholas Lavender granted Barton seven days to ask to change the order.

Aluko attended the London court earlier and said: "I'm glad it's the end."

Peter Purves, who played the Doctor's assistant Steven Taylor, was invited to the Phoenix

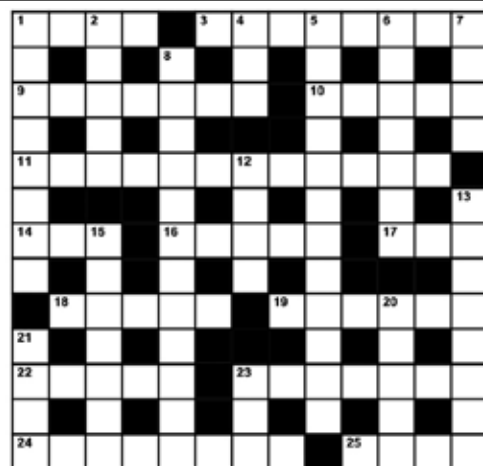
Cinema in Leicester on Wednesday under false pretenses to view the two episodes, and he said: "My flabber has never been so gasted."

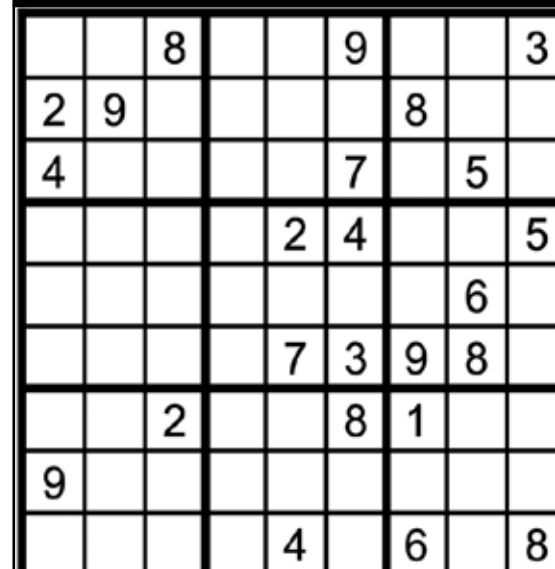

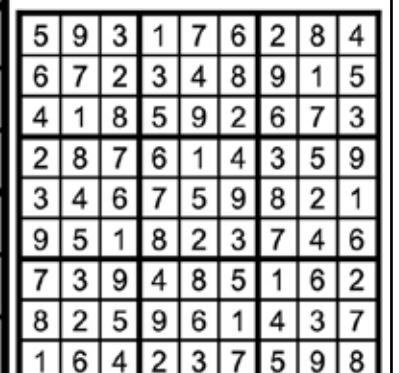

The memorial bench for Keith Flint, lead singer of early 1990s stars Prodigy, is located at St Mary's

Church in Bocking, Essex, which is near to where the singer grew up and the band was founded in Braintree.

But some have questioned whether the Satanic detail was appropriate for a place of Christian worship.

When asked about this, the Reverend Rod Reid said both the award-winning band and Flint's family had been "very respectful" in their design.

Flint often gelled his hair into the shape of two devil horns, of which a silhouette is etched into the backrest of the bench.

"The band and the family wanted something fitting for the churchyard," Reid told reporters.

"They were very respectful and very aware of the setting."

Reid, who presided over Flint's funeral in 2019, insisted people were "amazed" by the bench "and what it means to have it here".

More than 5,000 people attended the funeral after Flint was dead at his home in March 2019.

Band manager John Fairs and Prodigy founder Liam Howlett helped to design the tribute, later signed off by Flint's family.

"For local people here in Braintree and around, this means an awful lot," Reid said.

"They remember seeing [Flint and Howlett] on the dance floors in Braintree. They have followed them all the way through and they are proud."

The design of the seat was praised by many people commenting on the band's Facebook page.

Flint already had a tribute in Braintree, where a mural of him was spray-painted on to a water tank at Braintree Town Football Club's ground.

Prodigy were formed in Braintree in 1990 by producer, keyboardist, and songwriter Liam Howlett. At their critical and commercial peak, the band also featured MC and lead vocalist Maxim, dancer and occasional live keyboardist Leroy Thornhill, and dancer and occasional vocalist Keith Flint. The band were described as "the premiere dance act for the alternative masses"

and "the Godfathers of Rave". The band describe their style as electronic punk.

The band emerged during the underground rave scene and achieved early success in 1991 with their debut singles "Charly" and "Everybody in the Place", which reached the UK top five. They reached their commercial and critical peak with their third studio album *The Fat of the Land* (1997), which went to No. 1 in 16 countries, including the UK and the US, and spawned the UK number one singles "Firestarter" and "Breathe" in 1996.

Manchester City face a mammoth task to keep their Champions League ambitions alive after Federico Valverde's brilliant first-half hat-trick Wednesday night put Real Madrid in control of this last-16 meeting.

Valverde tormented City with a display of the highest class, Pep Guardiola's side offering threat up front but too often vulnerable at the back.

Real were without injured pair Kylian Mbappe and Jude Bellingham, as well as long-term absentee Rodrygo, but still had enough firepower to punish City's defensive frailties.

The English side actually started brightly, giving Real some anxious moments, before it all started to unravel in dramatic fashion on 20 minutes.

Real's opener was sim-

licity itself, keeper Thibaut Courtois' long pass dropping behind Nico O'Reilly for Valverde to round the on-rushing Gianluigi Donnarumma to score from a tight angle.

The Uruguayan doubled Real's advantage seven minutes later with a low finish across Donnarumma before he completed his hat-trick in superb style.

Collecting a delightful, lofted through-ball, the Real captain showed great invention to lift the ball over Marc Guehi in a tight space before beating Donnarumma on the volley.

City looked to be plunging further into trouble on the hour when Real were awarded a penalty after Donnarumma brought down Vinicius.

He took the spot-kick himself, but far too casually against a goalkeeper of such expertise in this situa-

tion, Donnarumma diving to his left to save.

City thought they had pulled one back when O'Reilly pounced on Thiago in the area, but Courtois stuck out a leg to save.

Before this meeting at the Bernabeu, City and Real Madrid had met 15 times in the Champions League, with results split evenly between wins, losses and draws.

Guardiola must now inspire one of the greatest comebacks of his reign if City are to maintain their interest in Europe's elite competition.

The fact that they had their chances will give City hope of mounting a comeback in the second leg, but this was a hugely disappointing loss and the experienced Champions League campaigners of Real Madrid will feel quietly confident of progress.

actually a doomsday scenario. Everything that could go wrong went wrong. "For our goalkeeper it's terrible as well of course. You don't wish that on anyone.

"For 15 minutes we just conceded goals that you really can't do anything about."

A cruel moment for Chelsea was followed by one of pure magic as Kvaratskhelia delivered an unstoppable curling strike from the edge of the box, with a further sidefoot finish making it five goals for the European champions.

Chelsea will now have to overturn a threegoal deficit when they host PSG in the second leg at Stamford Bridge on Tuesday night.

Europa League: Villa back to winning ways

Ollie Watkins' second-half header ensured Aston Villa eked out a narrow victory at Lille in the first leg of their Europa League last-16 tie Thursday night.

The result ends a winless sequence of four matches for Villa in all competitions and means Unai Emery's side will be favourites to advance to the quarter-finals when the sides meet again in the West Midlands next Thursday.

There had been very little goalmouth action until Watkins' clever in-

tervention with Villa's first effort on target.

The England forward raced on to Emiliano Buendia's flick-on and improvised superbly to loop a header over home goalkeeper Berke Ozer.

While neither side was able to impose themselves in an uninspiring opening 45 minutes, Watkins' header just after the hour mark did at least spark the contest into life.

Amadou Onana curled a shot against the woodwork, Watkins failed to convert when

one-on-one against Ozer and Buendia volleyed wide from 12 yards.

Lille's best opportunity arrived before the break when veteran striker Olivier Giroud glanced a header across the face of goal.

The winners of the tie will face Bologna or Roma in the last eight of the competition.

Villa defeated Lille on the way to the Conference League semi-finals in 2024 and reached the Champions League quarter-finals last term.

of this season, continental glory may well be a realistic prospect for the former European champions.

Not only was this Villa's first win in France at the seventh attempt, but

it was also a professional display from a team without key personnel, like the injured Matty Cash and Youri Tielemans.

The return of captain John McGinn - fit

enough to make the bench after being sidelined with a knee problem since 18 January - was also a welcome sight with the business end of the season approaching.

Doomsday scenario for Spurs, says VDV

Tottenham defender Micky van de Ven says they found themselves in a "doomsday scenario" during their Champions League match against Atletico Madrid, adding the club is "just taking blow after blow".

Spurs suffered a shameful 5-2 defeat at Atlet-

ico Madrid in the first leg of their Champions League last-16 tie on Tuesday - their fourth successive defeat under interim boss Igor Tudor. The Premier League club trailed 4-0 after only 22 minutes, with goalkeeper Antonin Kinsky withdrawn in the 17th minute, having conceded

ed three times in an error-strewn start. Spurs have lost six straight games in all competitions and are winless in nine.

Van de Ven, speaking to Dutch broadcaster Ziggo Sport, said the start of the match was "terrible", adding: "It's
