UK 'will not be drawn into the wider war' in Gulf

"British national interest' comes first, says Starmer after Trump demands Nato send warships to help reopen Strait of Hormuz

The UK will not be drawn into the wider war in the Middle East, Sir Keir Starmer has said, as concerns mount over US demands for the British military to be involved in keeping shipping lanes open.

He told a Downing Street press conference this week he was "looking through the options" after Donald Trump called for Allies to send warships to the strait of Hormuz to help unblock global oil supplies from the region.

The prime minister acknowledged the decision was "difficult, there's no hiding that" after the US president ratcheted up pressure by warning that Nato faces a "very bad" future if members failed to come to Washington's aid.

'viable plan'

Starmer said the UK, which is considering sending ships and mine-hunting drones to the Middle East, was working with allies on a "viable plan" to reopen shipping lanes. Otherwise energy prices would remain high.

"While taking the necessary action to defend ourselves and our allies, we will not be drawn

into the wider war. We will keep working towards a swift resolution that brings security and stability back to the region and stop the Iranian threat to its neighbours," he said.

'difficult question'

"I want to see an end to this war as quickly as possible, because the longer it goes on, the more dangerous the situation becomes, and the worse it is for the cost of living back here at home."

He added: "It's a discussion; we're not at the point of decisions yet. It's obviously a difficult question, that goes without saying, in relation to how you safeguard maritime traffic ... But we are discussing that with the US, with Gulf partners and with Europeans.

"We cannot allow the war in the Gulf to turn into a windfall for Putin. Now it's clear the US operation has massively

weakened the military capability of the abhorrent regime in Iran. The question is, what comes next?"

Ministers have been alarmed by the apparent lack of a plan from Trump for ending the conflict, but Starmer - who spoke to the US president on Sunday night - said the UK "must not lose sight" of the fact there would ultimately have to be a negotiated settlement.

targeted support

He said that his decision not to join the initial US offensive had been a matter of principle. "Principles, which I believe are shared by the British people, that our decision should be based on a calm, level-headed assessment of the British national interest."

After oil costs surged following the outbreak of the Iran conflict, Starmer announced that households reliant on heating oil to warm their homes

would receive £53m of government support to help with their bills.

He said lower-income households would get targeted support, while heating oil suppliers engaged in price gouging would face legal action and future market regulation.

The prime minister said he was not ruling out government support for energy bills more broadly if costs had risen when the cap came to an end this summer - but suggested it was diffi-

cult to predict where oil prices would be and that de-escalating the conflict should be the priority.

Starmer said his "instinct" was to help people struggling with the cost of living.

But he added: "I'm not going to stand here and pretend to you that we all know what the situation will be in three or six months' time. We don't.

The best way, though, to do this is to de-escalate and reduce the conflict, because that is the most

effective way to deal with the cost of living."

The prime minister underlined his commitment to investing in renewable energy, to give the UK more control over its own supply, despite criticism from his political opponents.

"We should go further and faster in relation to renewables.

"Let's get control of our own energy, so that whatever is happening the world, we control what's happening in this country," he said.

Iran and Russia regimes are “brothers in hatred”, Zelensky tells MPs

■ Ukraine leader urges against easing oil sanctions on Russia

The Iranian and Russian regimes are “brothers in hatred”, Volodymyr Zelensky has told MPs and peers, as he warned about the dangers of drone warfare.

Addressing around 120 parliamentarians in a Westminster committee room, the Ukrainian president highlighted how Tehran was selling Shahed ‘kamikaze’ drones to Moscow, which had been used in Ukraine.

He also warned against easing sanctions on Russian oil, saying it was “crucial” to keep up the pressure against Moscow.

The US has temporarily eased sanctions on some Russian oil in an attempt to tackle surging prices triggered by the conflict in the Middle East.

Among those in the audience in a packed committee room were Prime Minister Sir Keir Starmer, Nato secretary-general Mark Rutte, Defence Secretary John Healey and leaders of opposition parties.

In his speech, Zelensky sought to link the headline-generating war in the Middle East with the

long-running conflict in Ukraine.

He argued that Ukrainians were now pioneers in modern warfare and schooled in techniques they could share with allies.

In its fight against Russia, Ukraine has been using cheap, mass-produced interceptor drones to defend its skies.

Zelensky said there were now 201 Ukrainian military experts in the Middle East, with another 44 ready to deploy, who were sharing their knowledge on how to defend against Iranian drones.

He added that Ukraine was “ready to offer similar deals to all our reliable partners”.

Standing beneath a huge painting of Gladstone’s cabinet of 1868, President Zelensky gesticulated towards a more modestly sized television screen, showcasing the daily digital mapping of the war effort he leads.

Zelensky demonstrated how Ukraine was mapping Russian strikes and defensive action against them in real time.

He explained how us-

ing technology as simple as an iPad allowed Ukrainian commanders to control the country’s security.

The president’s message: his front line, is our front line. The inheritance Ukraine’s allies will be bequeathed by this conflict: a savviness about the conflicts of the decades ahead.

Zelensky added that during a meeting earlier at Buckingham Palace, he gave the King the iPad “as a sign of respect and gratitude”, to “strengthen our cooperation with the United Kingdom”.

During their meeting, the leaders agreed a new defence partnership aimed at tackling cheap attack drones.

Downing Street said the deal would bring together “Ukrainian expertise and the UK’s industrial base” to manufacture and supply drones and other capabilities.

Under the partnership between the UK and Ukraine, closer co-operation in the defence industries will also be sought with third countries as part of efforts to bolster international security.

Brexit ‘disaster for Britain’, says Reeves as she signals closer EU ties

BREXIT has been a disaster for Britain, Chancellor Rachel Reeves declared this week - demanding the UK snuggles up closer to its EU ex.

The tax-hiking Treasury boss pulled no punches in her savage attack on Britain’s historic exit from the bloc, insisting there is now “an awful lot we can do to improve our trading relations” with our continental neighbours.

As Britain’s battered economy stubbornly refuses to grow and hard-pressed families continue to struggle with sky-high living costs, Ms Reeves has her eyes firmly set on closer economic ties across the Channel.

Labour Ministers have been queuing up to bash Brexit in recent months - especially in the run-up to last year’s bombshell Budget - insisting the decision to quit the EU hammered the economy even harder than the doom-mongers predicted, in a bid to score points over Nigel Farage’s Reform UK.

Speaking to The Times, Ms Reeves said: “Brexit has not been good for our country, for growth, for prices in the shop. It’s almost 10 years since we voted Leave. That ship has sailed, but there’s an awful lot we

can do to improve our trading relations. Where that requires alignment in our national interest, we should absolutely align.”

The chancellor revealed she had recently hobnobbed with a super-market boss and the head of a major business empire - both of whom told her Brexit was causing serious financial pain.

“These are two huge businesses saying it’s difficult for us and it pushes up prices and costs, but for small businesses, it is really challenging,” she admitted.

Her comments come as Sir Keir Starmer prepares new legislation to hand ministers sweeping powers to drag Britain

back in line with EU law - slashing red tape and turbo-charging growth, No 10 insists.

The bill, part of Labour’s controversial Brexit “reset” plan, would give Ministers the authority to align Britain with EU rules on areas like food standards, animal welfare and pesticide use - in a move critics are already calling a surrender to Brussels.

The chancellor also revealed ambitions for a youth mobility deal with the EU, letting young Brits and Europeans live and work freely across borders - but she desperately insisted it would NOT mean a return to full free movement.

Scottish MPs vote No on assisted dying

MSPs have rejected the chance to make Scotland the first part of the UK to legalize assisted dying.

The proposals, tabled by Liberal Democrat Liam McArthur, would have allowed terminally-ill, mentally competent adults to seek medical help to end their lives.

Following an emotionally-charged final debate, the bill was defeated by 69 votes to 57.

Opponents raised several concerns about the bill - particularly fears of people being coerced into an assisted death.

McArthur accused those who rejected the bill of a "woefully inadequate response to the suffering and trauma experienced by dying Scots and their families".

The Assisted Dying for Terminally Ill Adults (Scotland) Bill would have made it legal for a medical practitioner or authorised health professional to give an eligible patient a lethal drug to end their own life.

To get to that point, they would have to make two declarations affirming their wishes, as well as passing checks from doctors to see if they had been coerced or influenced.

A bill to legalise assisted dying in England and Wales is being considered at Westminster, though it appears unlikely to pass before the end of the parliamentary term.

McArthur made several changes to the bill in a bid to win over dithering MSPs.

This included limiting eligibility to those with less than six months to live, despite the MSP earlier arguing against such a move.

But ultimately his efforts were in vain.

Deadly meningitis outbreak hits Kent

■ NHS on alert as a super spreader club leaves two young people dead

Concerns about a possible health crisis in South East England were growing this week after a deadly meningitis outbreak left two young people dead and dozens more fighting for their lives.

A total of 27 young adults have been struck down by the horror meningococcal disease in Kent, sending shockwaves through the region.

nationwide alert

Health Secretary Wes Streeting has branded the surge "unprecedented," as the Prime Minister Keir Starmer offered his deepest sympathies to the families of the victims during a somber session in Parliament.

Tests have confirmed that the culprit is the dreaded "Group B" meningococcal disease. This brutal bacteria is a dual threat, causing both meningitis—a terrifying inflammation of the brain—and septicaemia, a lethal infection of the bloodstream.

The deadly bug has been traced back to Club Chemistry, a popular student haunt in Canterbury. At least 10 of the victims were regulars at the venue. Doc-

tors have now been issued a nationwide alert to hand out life-saving antibiotics to anyone who visited the club between March 5 and 7.

One tragic victim was a student at the University of Kent, while an 18-year-old school pupil from the outskirts of Canterbury also lost their life on Saturday.

The reach of the killer bug isn't confined to Kent. Health officials confirmed that cases have appeared as far as London and even France, all with direct links to the Canterbury cluster.

Doctors across the length and breadth of Britain have been issued an emergency directive: prescribe life-saving antibiotics to anyone who stepped foot in the club between March 5 and 7.

Prime Minister Keir Starmer joined the chorus of concern, calling it a "deeply difficult time" for the families involved.

The second victim, an 18-year-old school pupil from Faversham, was named as Juliette. Her headteacher, Amelia McIlroy, paid a heartbreaking tribute, calling her a "kind, thoughtful and intelligent" student whose "beautiful

smile" would be hugely missed.

Speaking in Parliament, Health Secretary Wes Streeting didn't mince his words about the gravity of the situation. "What's worried us about the Canterbury outbreak is the pace and extent of the spread of the disease - that is unprecedented," he told stunned MPs. He later clarified that while the risk remains low for the general public, officials are "proactively managing" what has become a rapidly developing emergency.

While Britain usually sees around 300 cases of meningitis a year, experts are terrified by how fast this Group

B strain is moving.

Dr. Michael Head, a Senior Research Fellow in Global Health at the University of Southampton, warned that the public must remain vigilant despite the medical response.

"Meningitis B is a severe disease that is still with us," Dr. Head explained. He noted that while the targeted vaccination and antibiotic blitz is a "sensible" move, the nature of the strain is particularly dangerous.

"The current response... is providing public health benefit and hopefully reassurance for those who are potentially exposed. Antibiotics are highly effective as

a preventative measure," he added, but cautioned that we may still see more cases emerge.

The bacteria is notoriously difficult to spot early on. "The symptoms are easily mistaken for other common conditions, and even for something like a hangover," Mr. Streeting warned, urging young people to look out for their friend group.

Vaccination has greatly reduced meningitis cases and deaths in Britain in recent years. A Meningitis C vaccine, introduced in 1999, led to group C cases falling by over 90 per cent, according to official public health data.

Beeb asks judge to dismiss Trump suit

The BBC has already said sorry for the dodgy edit, which mashed two

parts of the speech together.

But they insist the lawsuit is way off the mark,

failing to meet the "actual malice" bar needed for a win.

Trump filed the suit in

December, chasing \$5bn for defamation and another \$5bn for "unfair trade practices."

£10m slap on the wrist for Chelsea

Chelsea have been fined £10m and handed a suspended transfer ban after admitting making £47m in secret payments to unregistered agents and third-parties over transfers between 2011 and 2018.

The £10m fine is the largest ever imposed by the Premier League, topping the £5.5m fine given to West Ham United in 2007 over the signings of Javier Mascherano and Carlos Tevez. However, the Blues avoided a sporting sanction, such as a points deduction, for what the Premier League called "voluntarily self-reporting... historical breaches of rules".

Chelsea also received an immediate nine-month academy transfer ban and a £750,000 fine over the registration of academy players between 2019 and 2022.

The Premier League's report named a number of transfers related to the unregistered payments, including those of Eden Hazard, Samuel Eto'o, Willian, Ramires, David Luiz, Andre Schurrle and Nemanja Matic. There is no suggestion of any wrongdoing on the part of those players.

Payments to representatives of another four players are detailed by the Premier League. But their names have been redacted in the report. No reasons have yet been given for them not being made public. The club accepted the charges, which occurred under Roman Abramovich's ownership. The Premier League said "undisclosed payments by third parties associated with the club were made to players, unregistered agents and other third parties" for the "benefit of Chelsea". The Premier League added that the £10m fine would have been £20m, but was reduced by 50% on account of Chelsea's proactive self-reporting and co-operation with the process.

30 year stretch for nursery sex abuser

■ Nathan Bennett convicted of multiple abuse counts against two and three year old boys

An "evil" nursery worker has been handed a 30-year sentence for sexually abusing children in what was described in court as "every parent's nightmare".

Nathan Bennett was convicted in February of multiple counts of sexual abuse, including two counts of rape against five boys at Partou King Street Nursery in Bristol. The victims were two and three years old at the time.

The 30-year-old, of Corston near Bath, had previously admitted 13 other sexual offence charges relating to four of the boys.

'lurking, ready'

Handing down sentence, His Honour Judge William Hart described Bennett as "evil" and an "incorrigible and dangerous paedophile".

The judge said Bennett had been "lurking, ready" to abuse children and "pollute their innocence" with his "own vile desires".

The judge explained Bennett would serve at least two-thirds of his

30-year sentence behind bars.

Bennett began working at the nursery in July 2024.

In February 2025, concerns were raised over his behaviour with the children, specifically a group of five who the prosecution said he would "favour".

He was suspended from the nursery after CCTV of him putting his hands down a boy's trousers was reviewed.

The nursery informed the council's Local Authority Designated Officer - who deals with allegations against adults working with children - and Avon and Somerset Police were alerted the following day.

After a six-month criminal investigation, he was charged. Ofsted closed the nursery in December 2025.

During the sentencing hearing, the court was read a number of statements from the victims' parents by prosecuting barrister Virginia Cornwall.

The mother of Child E, who described her son

as a "hilarious, cheeky, happy little boy," said his trust had been "manipulated and ultimately destroyed".

"What will our son remember as he grows and as he understands the impact of the abuse? We will not truly know the impact of Nathan's actions for many years," she said.

The father of Child B said he felt "dead inside" after learning of what had happened to his son, while his mother said she had "screamed and cried".

They added that the trauma of the case had led to the loss of a job, and in "desperate need of therapy" they could not afford to pay for.

The parents of Child C, who described their son as a "sunny child", said Bennett had "seemed clumsy but very paternal", which was something they initially liked.

They explained that their child had become "obsessed" with Bennett as he was groomed, becoming "a different person".

"Since we found out that our son was involved, our emotions have changed," they added. "We were distraught at the start and now we are angry."

Det Insp Lucy Forde, from Avon and Somerset Police, said officers spent "hundreds of hours" watching CCTV

footage from the nursery's 18 cameras to isolate Bennett's offending period and the children affected.

But, according to the force, the footage only spanned back a month before it was overwritten.

Forde described the footage as "absolutely sickening".

"It is him offending against children in the middle of the nursery in sight of other children.

"There is nothing that could prepare you for seeing that," she added.

A total of four victims were identified through CCTV, and a fifth came forward after confiding in their parents what had happened.

Scottish boffins find surprising new ally in Parkinson's battle - plastic bottles

IN A promising new development in the battle against Parkinson's disease, a group of scientists in Scotland have uncovered what they believe is a secret weapon - plastic bottles.

Around 50 million tonnes of polyethylene terephthalate, the plastic widely used in food and drink packaging, is thrown away every year. But boffins at the University of Edinburgh say they've found a way to convert that waste into levodopa, the gold standard treatment for Parkinson's disease, which helps restore dopamine

levels in the brain and improve motor function.

The process uses specially engineered E coli bacteria. First, the plastic is broken down into its basic chemical building blocks. The bacteria then transform those compounds through a series of biological reactions, producing the medicine in just over a day and at room temperature.

Researchers say that makes it far less energy intensive than conventional pharmaceutical manufacturing.

Professor Stephen Wallace, who led the study, says this could be

the beginning of a new era.

"This is part of a sort of emerging technology that's called engineering

biology, and we're only really sort of getting to grips with the potential that this technology could have for the future.

It feels like just the start for what could be a really exciting point for industry and for the way that we use these bacteria."

Len Deighton, best-selling spy story author, dead at 97

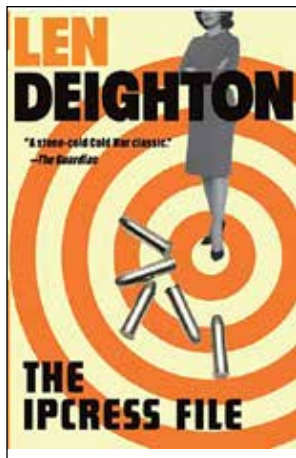
Len Deighton, creator of Harry Palmer, one of the world's most famous spy characters, has died aged 97.

The London-born writer sold millions of books and was translated into 20 languages over a career spanning half a century.

According to his literary agent Tim Bates, Deighton, "passed away peacefully on Sunday". No cause of death has been given.

"Len was a Titan," Bates said. "He was not only one of the greatest spy and thriller writers of the 20th century but also one of our greatest writers in any genre."

His first novel, "The Ipcress File" introduced the world to his depiction of espionage as a grubby, error-strewn business. It was a stark contrast to the glamour of Ian Fleming's James Bond novels and the charm of John Le Carré's rogue's gallery of

gentlemen.

Deighton's working-class hero 'Harry Palmer' was anonymous in the first book and his sequels "Horse Under Water", "Funeral in Berlin" and "Billion-Dollar Brain."

But the thick-besppectated character was specifically named for the enormously successful 1965 film adaptation of the book with the character played by

Michael Caine. A role which helped propel both he and the writer to stardom.

Caine went on to feature in the film versions of "Funeral in Berlin" and "Billion-Dollar Brain" and later praised writers like Deighton for giving him his big breaks.

"They started writing for working-class people, and it made all the difference," he said in 2017.

Before moving full-time into literature, Deighton served in the Royal Air Force as part of Britain's then-mandatory national service.

He also studied art and worked as a waiter, pastry chef and flight attendant before having success as a book and magazine illustrator. His designs included the first U.K. edition of Jack Kerouac's "On the Road" in 1958.

"Berlin Game," published in 1983, was the

first of 10 novels featuring the smart, cynical MI6 officer Bernard Samson. Along with "Mexico Set" and "London Match" it was adapted into the 1988 TV series "Game, Set and Match."

Deighton set several novels around World War II, including

"Bomber" (1970), which depicted the conflict in the air war from both British and German viewpoints, and "SS-GB" (1978), an alternative-history novel set in a Nazi-occupied Britain. It was made into a TV series in 2017.

Another passion was

food. Deighton was food correspondent for The Observer newspaper in the 1960s and penned several cookbooks aimed at men — a then-novel idea — including "Len Deighton's Action Cook Book" (1965), with recipes illustrated like comic strips.

at which prices are rising. The ONS said the last few years had seen higher sales and a wider range

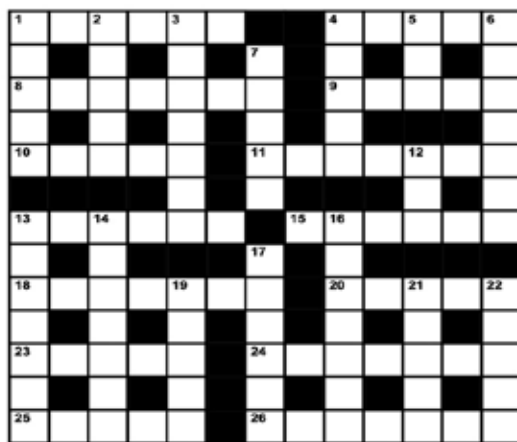
of options on the shelves, reflecting a broader shift towards healthier choices. That trend has also seen hummus becoming more popular, meaning that it too has been added to the list.

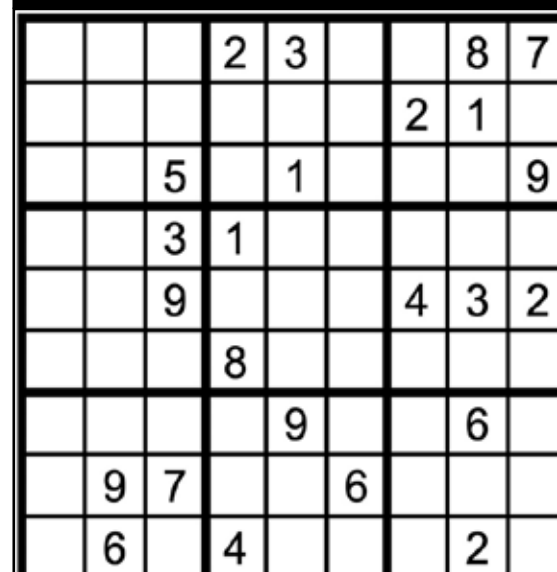

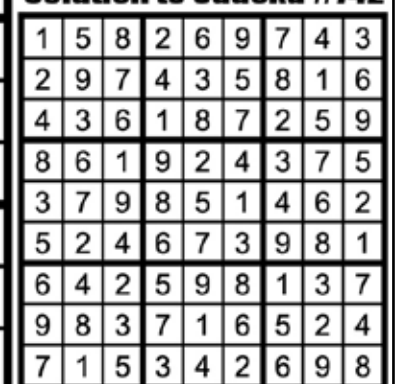

TIME TO TAKE A HIKE? 2689 miles and 18 years in the making, King Charles III opened his namesake path this week

Joy for ramblers! England's Coast Path opens this week - allowing walkers to explore the country's shoreline step-by-step

King Charles has inaugurated a new footpath stretching around the entire coast of England.

At 2,689 miles long, it is the longest managed coastal walking route in the world, according to Natural

England, the government body which created it.

Its name is quite a trek too - King Charles III England Coast Path - but for the first time it creates a continuous trail, allowing walkers to explore England's shoreline step by step.

Along the way, it passes through some of the country's most beautiful and varied landscapes, from salt marshes and sandy beaches to cliffs, dunes and historic coastal towns.

The King inaugurated the coastal path and the new nature reserve at a reception hosted by the South Downs National Park Authority on Monday.

He later walked a section of the newly completed path at Seven Sisters, joined by Natural England Chair Tony Juniper and Environment Secretary Emma Reynolds.

Juniper said the path "is a testament to how public enjoyment, conservation, heritage, history and community can come together, helping make life better for millions of people."

Much of the new coastal route already existed, but more than 1,000 miles of new paths have been created, and many other sections upgraded. Paths have been resurfaced, stiles removed, boardwalks built and bridges installed.

The project was initiated during Gordon Brown's government, and it has taken 18

years and seven prime ministers to get to this stage.

About 80% of the route is now open and most of the rest of the path is due to be completed by the end of the year.

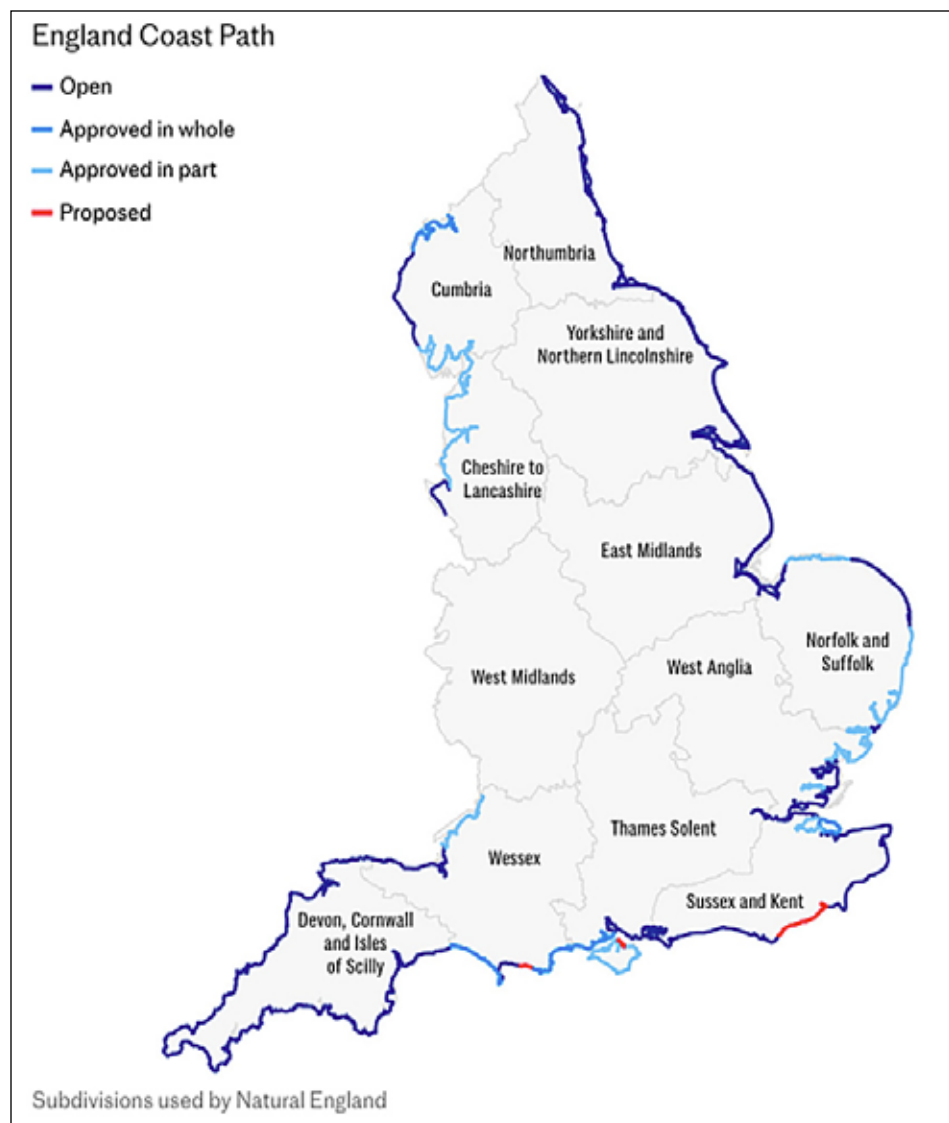
"It is brilliant - the best thing I'll do in my working life," says Neil Kenworthy, who led the project for Natural England.

For him, the length of the path isn't really the point. What makes it so special, he says, is that you can walk to the coast anywhere in England, turn left or right, and walk beside the sea for as long as you like.

Creating the route required new legislation - the Marine and Coastal Access Act, passed in 2009 - as well as years of careful planning and extensive work along the shoreline to establish a clear and continuous footpath.

Natural England says that in many places, new rights of

access have opened land that was previously off-limits to the public - including beaches, dunes and cliff-tops between the path and the sea.

It says accessibility for those with reduced mobility has been improved so that more people can enjoy sections of the trail.

Gaps in the existing network of footpaths have been filled with a focus on bringing the route closer to the water and connecting stretches of coastline that had never been joined by a single walking trail.

But in a few places, walkers must briefly leave the trail. In north-west England, for example, a ferry across the Mersey is needed to follow the route.

One stretch in south Devon is particularly challenging. At the

River Erme, there is no bridge or ferry, and the land further upstream is privately owned and inaccessible. Walkers must therefore roll up their

trousers and wade across the river within an hour either side of low tide.

"It's all part of the experience," says Constable.

Arsenal a bright spot in bad week for English clubs

Goals from Eberechi Eze and Declan Rice helped Arsenal comfortably beat Bayer Leverkusen as the Gunners secured their place in the quarter-finals of the Champions League.

itor, Silva was shown a straight red and a penalty was awarded to the visitors. Vinicius made no mistake from the spot, Donnarumma the wrong way to silence an expectant Etihad Stadium crowd.

PSG pile on misery for off-color Blues

Chelsea suffered their joint-heaviest defeat in a twolegged European tie on Wednesday night, losing 8-2 on aggregate and 3-0 on the night to European champions Paris StGermain at Stamford Bridge.

Chelsea then mounted a flurry of attacks through Cole Palmer, Enzo Fernandez, Pedro Neto and Trevoh Chalobah before PSG struck again. After Moises Caicedo lost possession in midfield, PSG broke forward and Barcola produced a superb first touch with his weaker left foot before halfvolleying into the top corner to double the lead.

It was an ultimately forgettable game which suited Villa as Lille rarely threatened, with Ollie Watkins' goal in France last week giving the hosts their platform for success.

from 10 games, which has meant Villa's place in the top five has come under threat but European success can help inspire a recovery.

Tammy Abraham and Amadou Onana forced Berke Ozer into smart stops before McGinn struck in the second half, finishing off a quick break after goalkeeper Emi Martinez launched a perfect pass to Jadon Sancho after saving Nabil Bentaleb's free-kick.

Sancho then hit the post before Bailey

tapped in his first Villa goal for a year with five minutes left as they finished off their Ligue 1 visitors.

Keeper Martinez was serenaded by the Aston Villa fans after his vital contribution.

He turned into Villa's quarterback when he launched a pinpoint pass for Sancho to run on to and tee up McGinn.

The Argentina international ran half the length of the field to celebrate with his teammates before raising his fists towards the North Stand on returning to his goal.

The second-half opener settled Villa's nerves, which were evident around Villa Park during a tepid first half. Villa could have drifted into trouble but they remained largely in control.

Lille looked to contain them in the first half and then open up to try to level the tie after the break, but it only served to help Villa with gaps appearing for McGinn, and then Bailey late on, to score.

Even when they were

left chasing the game at 2-0 down on aggregate the French side did not have the necessary class to worry Villa.

The second goal added gloss to a performance which again lacked quality and energy. Villa did what they needed to do

to get the job done, but still need to improve - both in the Premier League and Europe.

Yet they can still produce one-off moments, like Martinez did, to lift them and ensure their Europa League dream remains alive.

Nottingham Forest secured a Europa League quarter-final place with a penalty shootout win over Danish side Midtjylland following a dramatic last-16 tie Thursday night.

Cho Gue-Sung and Aral Simsir both struck the same post for Midtjylland in the shootout before Edward Chilufya slipped and also missed, while Morgan Gibbs-White, Ibrahim Sangare

and Neco Williams all scored from the spot to send Forest through.

Vitor Pereira's side now face a quarter-final against either Stuttgart or Porto next month as they put their Premier League struggles behind them to continue their European quest.

Forest midfielder Ryan Yates arrowed a low strike from 20 yards into the corner to put his side ahead in the tie, af-

ter Nicolas Dominguez had headed the visitors in front on the night and level on aggregate before half-time.

Then Midtjylland defender Martin Erlic forced extra time by pulling one back for the hosts when he found the net from inside the area.

But Forest would not be denied and got through as they came back from a first-leg deficit.
