

As war rages and insults fly, MPs bitterly divided on whether King should join USA's 250th birthday bash

WHAT HUMILIATION? CHARLES STATE VISIT WILL GO AHEAD

Despite a firestorm of political backlash and a growing conflict in the Middle East, King Charles III will proceed with a high-stakes state visit to the United States this April.

The decision, confirmed by the Palace this week, comes amidst warnings from senior British politicians that the trip amounts to little more than a "humiliation" while Donald Trump remains locked in a "war with Iran."

The timing could not be more volatile. While the Foreign Office insists the visit is essential to mark the 250th anniversary of US independence, MPs across the spectrum are sounding the alarm. Privately, members of Parliament have expressed grave concerns that the trip has the "potential to embarrass the king" if the US president persists in his public evisceration of the UK's military capabilities.

political fallout

The rhetoric from the White House has been anything but diplomatic. Just minutes before the visit was

announced, Trump launched what has been described as "another verbal attack" on the UK, telling the country it should learn to "fight for yourselves" and suggesting Britain should seize jet fuel from the Middle East by force. This follows his dismissive claim last week that the UK's aircraft carriers were nothing more than "toys" and were "unwanted."

The political fallout in Westminster has been swift and biting. Emily Thornberry, chair of the foreign affairs select committee, is leading the calls for a ceasefire on the travel plans. Thornberry argued there should be a delay while the war continues, suggesting it would be "safer to delay" as Charles and Camilla could be left feeling "embarrassed" by the ongoing crisis.

Opposition leaders have been even more

blunt. Liberal Democrat leader Ed Davey accused Prime Minister Keir Starmer of a "staggering lack of backbone" for failing to stand up to the US president.

'too weak'

"To send the king on a state visit to the US after Trump dismissed our Royal Navy as 'toys' is a humiliation, and a sign of a government too weak to stand up to bullies," Davey declared.

"What appalling thing does Trump have to do next to make the government see sense and cancel the state visit?"

Green Party leader Zack Polanski echoed the sentiment, demanding the Prime Minister "end this involvement in Iran and stop the king's visit to the USA."

Despite the chorus of disapproval, the Palace remains resolute.



WHAT ARE THEY THINKING? Nobody knows for sure...

The visit, scheduled for three days starting April 27th, is being undertaken "on advice of his majesty's government and at the invitation of the president of the United States." It marks a significant milestone: the first visit to the US by Charles as monarch, and the first state visit by a British sovereign since Queen Elizabeth II's 2007 tour.

The itinerary is prestigious. The King is ex-

pected to address Congress and participate in events commemorating two and a half centuries of American independence.

Donald Trump, for his part, took to Truth Social to trumpet the arrival of the royals. "Melania and I are pleased to announce that Their Majesties, the King and Queen of the United Kingdom, will visit the United States for a Historic

State Visit," Trump posted, highlighting a "beautiful Banquet Dinner at the White House on the evening of April 28th."

As the end of April approaches, the world will be watching to see if this visit bridges a widening Atlantic gap or if, as critics fear, the King is walking straight into a diplomatic minefield. For now, the "Historic State Visit" is a go-backbone or not.

Reform Rupture: Farage axes housing chief

Simon Dudley's comments on Grenfell described as 'rather shocking'

Nigel Farage has taken the axe to his own housing spokesman, Simon Dudley, after a "sickening" outburst regarding the Grenfell tragedy. Dudley's claim that "everyone dies" sparked a firestorm of fury, forcing Farage into a damage-limitation exercise as Reform UK's policy drive is overshadowed by yet another scandal.

Speaking at a press conference on Wednesday, Nigel Farage described Dudley's comments as "deeply inappropriate", and "rather shocking", adding that Dudley had been "dealt with" and was no longer a party spokesperson.

Farage claimed not to have spoken to Dudley, telling reporters: "I haven't spoken to him... Richard [Tice] appointed him... and Richard has dealt with him."

Other political voices, including the prime minister had called on Farage to sack Dudley, with the PM calling his comments "shameful".

'sorry'

Shortly before his sacking, Dudley posted a statement on X, writing: "Grenfell was an utter tragedy and quite rightly prompted a wholesale review and tightening of fire regulations.

"I said it was a tragedy in my interview with Inside Housing and in no shape or form am I belittling that disaster or the huge loss of life.

"It must never happen again. I reiterate that, and am sorry if it was not sufficiently clear."

This all comes after an interview published on Wednesday by Inside Housing, in which Dudley said housing safety regulations had "swung too far the wrong way" on regulation after the deadly blaze at the west London tower block in 2017, which killed 72 people.

He called Grenfell a "tragedy" but added that "everyone dies in the end. It's just how you go, right?"

'dehumanising'

The Grenfell Inquiry found that the 72 deaths were avoidable and had been preceded by "decades of failure" by governments and the building industry to act on the dangers of flammable materials on high-rise buildings.

Dudley was appointed as housing spokesman for Reform last month, and the party said at the time he would lead an

urgent review into "Britain's building crisis" that would set out reforms to planning, housing delivery and national infrastructure.

Grenfell United, which represents some bereaved and survivors, described the comments as "deeply dehumanising".

In a statement on Thursday, it wrote: "Our

loved ones did not simply 'die.' They were failed. They were trapped in their homes, in a building that should have been safe, in a fire that should never have happened. Reducing their deaths to an inevitability strips away the truth: this was preventable.

"To speak about Grenfell in this way is to erase responsibility. It sug-

gests this was just fate, just 'how it goes,' rather than the result of years of ignored warnings, poor decisions, and a failure to value the lives of residents, and is deeply offensive and ill-informed.

"Everyone deserves the right to a safe home. But this attitude clearly shows Simon Dudley is not the man to ensure that happens."

Clapham chaos: parents told to 'take responsibility' after teen mob swarms London high street

Six girls arrested after hundreds of young people gather in Clapham in 'swarming the streets' trend

Police have urged parents to "take responsibility" after scenes of widespread disorder in Clapham, south-west London, on Saturday and Tuesday. Officers said the incidents were caused by a social media trend for swarming the streets. Six teenage girls have

been arrested so far, and the Metropolitan police said there would be more arrests in the coming days as officers reviewed CCTV and body-worn camera footage of the disorder. It urged parents not to allow their children to take part in similar events over the Easter weekend.

'appalling scenes'

Footage of Tuesday's incident showed hundreds of young people gathering on Clapham High Street, amid reports that shops and restaurants were being stormed. Fireworks were set off on nearby Clapham Common.

The antisocial behaviour took place after link-ups arranged on social media sites including TikTok and Snapchat. In a statement, the Met urged

social media companies to "play their part by taking responsibility for content on their platforms that promotes or incites disorder".

After the unrest on Saturday, 100 police officers were sent to Clapham on Tuesday. Four officers and one member of the public were assaulted.

Sadiq Khan, the mayor of London, condemned the "appalling scenes", adding: "[They] are abso-

lutely unacceptable – and those responsible will face the full force of the law."

Reposting a video apparently showing an M&S supermarket in Clapham being stormed by teenagers on Saturday, Kemi Badenoch said: "We have created a culture where too many young people believe they can do what they like and nothing will happen. That is the problem.

"We should be honest about where that leads," the Conservative party leader added. "If a child loots a shop today, films it for social media, and faces no real consequence, they are going to do much worse tomorrow."

assault

Three girls, one aged 17 and two aged 13, were arrested on Tuesday on suspicion of assaulting an emergency worker. On Saturday, two 16-year-old girls and one aged 15 were arrested on suspicion of shoplifting and assault.

DCS Emma Bond said: "Our officers will continue to maintain a strong, visible presence around Clapham and we will respond robustly to any reports of disorder, thefts or planned meet-ups."

"I'd urge those young people who think this is just a bit of fun to carefully consider the consequences. Events like this, fuelled by on-line trends and viral content on social media platforms, can quickly escalate and lead to serious outcomes."

"If you join in or cause further disorder, you should expect to be arrested and risk a criminal record, which can have long-lasting consequences for your future, including employment opportunities and potentially your ability to travel."

Bond said a review of video evidence would lead to further arrests. She added: "The parents or guardians of those involved in last night's disorder also have a role to play. I'd appeal to them to take responsibility, to be proactive in knowing where their children are and who they're with, and to take steps to make sure they're not involved in this sort of unacceptable antisocial behaviour."

Work your ass off! There is no shortcut: Arnold returns to Ulster to receive honorary degree

Northern Ireland may be a small country, but its people have big dreams, Ulster University's latest graduate has told students.

Six decades after he first set foot in Belfast as an ambitious teenage bodybuilder, Arnold Schwarzenegger was back this week - this time to receive an honorary doctorate from Ulster University (UU).

The institution's highest award recognised the Austrian-born former film star, bodybuilder and Governor of California's contribution to public service, environmental action and the arts.

Famous snap

The star of 80s sci-fi classics such as *The Terminator* and *Predator* was warmly welcomed at UU by cheering students holding signs such as "Hasta La Vista Ulster".

Schwarzenegger in turn praised local talent, telling the crowd it "is remarkable how much talent comes out" of here.

The university's Belfast campus is just yards

from where the now 78-year-old was famously photographed outside the old Belfast Telegraph building on his first visit here back in 1966.

The snap of a 19-year-old Schwarzenegger holding two Telegraph employees — Sandra Weir (Burrows) and Deirdre Cullen of the advertising department — one in each arm, was taken by Roy Smyth, one of the newspaper's photographers.

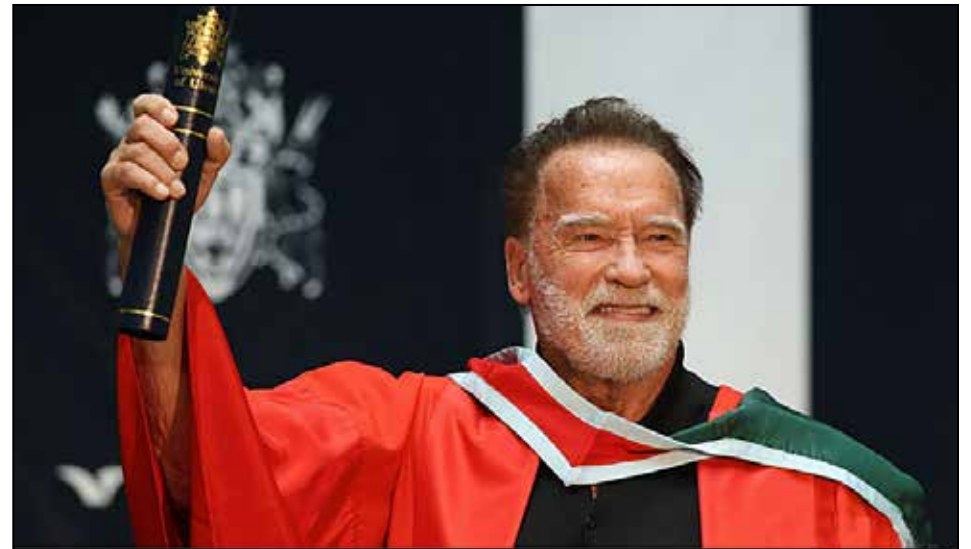
environmental work

The seven-time Mr Olympia was awarded the doctorate by university chancellor, Colin Davidson, who the star praised as "a great painter".

Now Dr Schwarzenegger, he was recognised for his environmental work and philanthropy by Dr Davidson in an address to those gathered.

They were also treated to a traditional Austrian dance, a nod to the actor's roots, as well as a Terminator-themed Irish dancing showcase.

The man once named 'The Austrian Oak' told the crowd that the lessons he learned weight

training as young man have served him well over the decades.

"If I do the exercise and it's easy, no bicep will grow. But when I train with heavier weight and I struggle, then it will grow. And that's the way it is in life," he said.

"Most important thing is work your ass off. Work, work, work. There is no shortcut."

He said he still had ambitions, though hinted he was feeling some of the aches of ageing.

"I'm almost 79 years old, so 40 years ago I said I'll be back. Now I say, oh, my back."

Horror in Hull

'Monster' funeral director left bodies to rot

A funeral director who gave grieving families the wrong ashes while their loved ones' bodies were left in his parlour for months has pleaded guilty to 30 counts of preventing a lawful and decent burial.

Officers found 35 bodies and more than 100 sets of ashes when they raided Legacy Independent Funeral Directors, in Hull, in March 2024. One of the bodies had been there for a year.

Robert Bush also

pleaded guilty at Hull Crown Court on Thursday to one count of theft from 12 charities, including the Salvation Army and Macmillan Cancer Support.

He previously admitted presenting families with the ashes of strangers and fraudulently selling funeral plans. He will be sentenced on 27 July.

Bush, 48, who arrived at the court carrying a large black holdall, stood in the glass-fronted dock

as the clerk spent 10 minutes reading out 31 charges.

Wearing a dark grey three-piece suit with a white shirt and mauve tie, he clasped his hands in front of him as he said "guilty" to each count in a quiet voice.

About a dozen members of the victims' families remained composed in the public gallery throughout the 24-minute hearing.

Judge Mr Justice Hilliard told Bush a "custo-

dial sentence is inevitable in this case" before releasing him on bail.

Bush was charged after a major investigation into human remains found at the premises, including four babies lost in pregnancy.

Humber-side Police

said all the charges dated from a period between May 2012 and 6 March 2024.

Prosecutor Chris Paxton KC told the court there would be up to 240 victim impact statements from people who

had been affected by the case. These would be provided before the sentencing hearing.

"The fraudulent trading relates to funeral plans involving over 150 individuals," he said.

'Horror film'

Leaving court, Bush made no comment as he walked briskly away carrying the holdall.

Michaela Baldwin's stepfather, Danny Middleton, was in his 70s when he died in November 2023.

The family was told his body was one of the 35 found at Legacy's premises.

They were given ashes by Bush who claimed they were those of their loved one.

Speaking outside court, Baldwin said: "Bush is a pure, true monster. It's like being in a horror film.

"What hurts us is that Bush has pleaded guilty but he is allowed to walk out of court today. He should have been remanded."

"He didn't look any of us [affected families] in the eye.

"The judge should throw the book at him."

Tristan Essex, whose grandmother, Jessie Stockdale, was identified through DNA after her body was also found at the funeral home, said Bush "genuinely seemed like he cared" when the family went back to the premises several times after they were told she had been cremated.

"We'd been in there a few times afterwards to get the ashes transferred and the whole time my grandma was there in the back, just rotting," he said.

Oldest British WW2 veteran dies at 109

Harry Waddingham, the oldest known British veteran of the Second World War, has died aged 109.

Waddingham joined the Royal Navy as a boy seaman aged 16, and his first ship was a cruiser off the coast of Spain during the Spanish Civil War. He specialized as a seaman gunner, and though only weighing 140lbs he found he was more agile than larger men and managed more easily as a shell-loader, especially on the upper deck in "cold, wet and nasty seas".

He was soon advanced to leading seaman, qualified as a "spring bosun" or physical training instructor (PTI), and was sent to the destroyer Wakeful.

Dunkirk chaos

In later years Waddingham recalled the organized chaos of evacuation from the beaches of Dunkirk, where, while Wakeful lay off in deeper water, he took the ship's whaler inshore. Summoned by an army officer to "come closer", he refused, for risk of ground-

ing, and when soldiers on the beach rushed his boat, he fired two shots into the water. After several journeys from shore to ship, with many hundred extra men embarked, Wakeful was no more than a powered, unstable hulk unable to manoeuvre when she was attacked by a German E-boat in the early hours of May 29 1940. Only four troops onboard and 25 of Wakeful's crew survived: Waddingham was plucked from the water by another destroyer.

another sinking

Next, he served in the destroyer Juno and witnessed the Battle of Cape Matapan in March 1941, but on May 20 she was bombed by the Italian air force off Crete, capsized and sank within two minutes. Some 116 men were killed, but as a gunner on the upper deck, Waddingham was among the 104 survivors.

Waddingham's father and uncle had been English immigrants in Montreal when the First World War broke out

and both volunteered for the artillery. His parents met during Harry senior's brief deployment to Northern Ireland: postwar, he returned temporarily to Canada to complete his service. The younger Harry was brought up by his mother in Belfast until 1922, when the Troubles had broken out, and the family thought it safer to move to East Anglia. Young Harry grew up in Clacton-on-

Sea.

When the Second World War was over, Waddingham obtained a teaching diploma and joined the Royal Air Force's educational wing. He retired in the rank of squadron leader before becoming a PE teacher and running the Combinbed Cadet Forces at Archbishop Tenison's Grammar School at the Oval in Lambeth. He subsequently became principal of the Streatham and

Tooting Institute.

Harry married his second wife, Collette Goubault, in 1984. She died in 2025, aged 92, and Waddingham lived on alone, keeping his flat in Bexhill "shipshape and Bristol fashion" as though ready for admiral's rounds until his last months. He is survived by two sons and three grandchildren, one of whom is the actress and star of *Ted Lasso*, Hannah Waddingham.

French court throws out Cardiff's claim for £100m compensation

Cardiff City's claim for more than £100m in compensation following the death of footballer Emiliano Sala has been thrown out by a French judge.

Sala, 28, and pilot David Ibbotson died when the Piper Malibu plane carrying them crashed into the English Channel on the night of 21 January 2019.

The Argentine striker was on his way to join Cardiff City – then in the Premier League – from FC Nantes for a £15m transfer fee.

In the latest chapter of a long-running dispute, a French court tasked with ruling on whether the Welsh club was due compensation from Nantes for the loss of Sala has dis-

missed its claim.

Cardiff City was claiming more than €120m (£104m) for loss of income and other damages, based on the belief that Sala could have kept the club in the Premier League.

But, on Monday, a court in Nantes dismissed its claims and also ordered the club to pay about £400,000 in legal fees and moral damages suffered by FC Nantes.

The penalty is payable immediately, regardless of any possible appeal.

Cardiff City is yet to make a decision on whether or not to appeal. Capital Law, which represents the club, said it would take some time to reflect on the verdict.

It has one month to

lodge an appeal, which would be heard before the Court of Appeal of Rennes, with the process taking up to two years.

An appeal would trigger a new trial – a second chance at the case being heard and re-examined in its entirety.

Celine Jones, of Capital Law, said it "deeply regrets" that the court didn't rule in Cardiff's favour.

"We initiated these proceedings so that the full truth of this case would come to light in respect of Emiliano Sala's memory," she said.

"Today we note with great bitterness that the principles of transparency, integrity and safety in professional football have

not prevailed in this decision."

Jones added: "More than ever there is an urgent need to strengthen safety in and ethical standards in the management and the protection of players so a tragedy never ever happens again. The world of football needs to take a hard look at itself."

In a joint statement, FC

Nantes' attorneys Jérôme Marsaudon and Louis Marie Absil said they welcomed the court's decision.

"FC Nantes is in no way responsible for the tragedy that occurred, and we are pleased that the court has heard our case and confirmed this in very clear terms," they said.

Ten years for aspiring rapper whose banned dogs killed his child's grandma

A man has been jailed for 10 years and three months after his XL bully dog mauled his ex-partner's mother to death.

The pet, named Bear, killed Esther Martin, while she was at Ashley Warren's home in Jaywick, Essex, on 3 February 2024.

The 68-year-old was looking after two adult dogs, eight puppies and a child while Warren, an amateur rapper, was filming a music video in London.

The 41-year-old, who was sentenced at Chelmsford Crown Court earlier, was the first person charged with XL bully offences after new laws came into force.

The court heard Bear had not been walked in

the four weeks before the attack.

"I am sure that you could and should have reasonably foreseen the risk," said Mr Justice Jeremy Johnson KC.

"As well as knowing it was prohibited, you knew it had been pent up in the house for weeks, you knew it was capable of being aggressive and you knew Esther Martin could not control it."

Johnson also banned Warren from owning a dog indefinitely.

Martin, a grandmother, had travelled from Woodford Green in east London to Warren's house.

Her daughter Clare had been in a relationship with Warren for 14 years before she died suddenly in 2021.

Prosecutors had said

leaving Martin with the dogs was "a tragedy waiting to happen".

Martin was 5ft 3in (1.6m) tall and had restricted movement due to a hip replacement, arthritis and a limp.

Johnson said the puppies "may have started fighting" and jurors had already been told Martin used a broom to try to break them up.

'gentle' dogs

"The two adult dogs responded by attacking her. She was mauled to death," the judge said.

Evidence suggested Warren was aware of the dogs' strength.

He chased Bear outside after the dog escaped from the house on 31 January 2024, and CCTV footage showed him struggling to hold

him.

The day before, Warren wrote in a message that the animals were "too much for me".

While giving evidence, he insisted he could not have predicted "in a million years" his "gentle" dogs killing someone.

Bear and Beauty were put down at the scene after police arrived, and the puppies were later destroyed.

Jurors found him guilty of being the owner of a dog that caused injury resulting in death while dangerously out of control in a private place.

They found him not guilty in relation to the second adult dog, Beauty, on the basis that she was owned by his girlfriend.

Prior to sentencing, Warren also pleaded guilty to two summary offences of owning or being the custodian of a

banned breed – the first person in the UK to be charged with the offences since the XL bullies were banned two days prior to Esther Martin's death.

Martin's family clapped and hugged after the sentencing was passed. Someone else from the public gallery

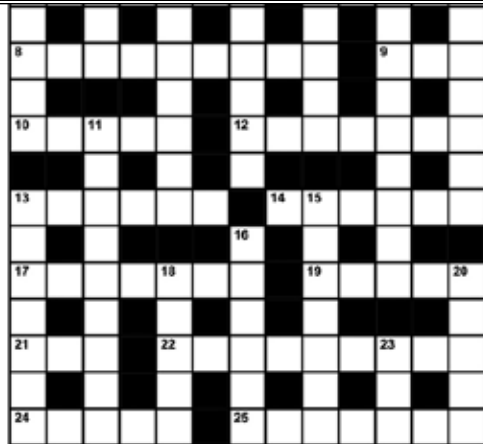
cried "yes".

In a victim impact statement, Sonia Martin-Coppen, Esther Martin's daughter, sobbed:

"[The] last conversation I had with her was about setting a date for my wedding... I've missed out on my mum seeing me in my wedding dress."

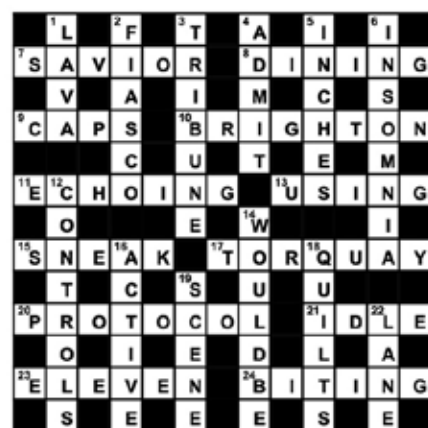

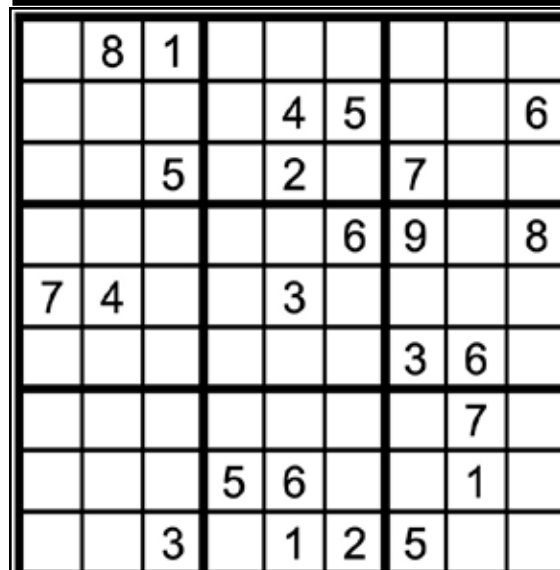

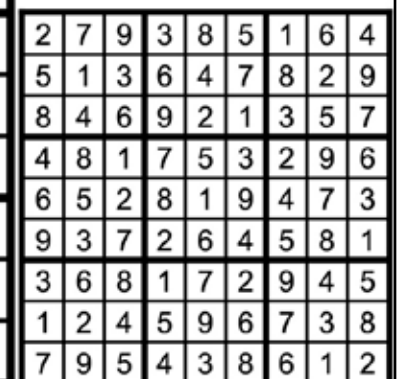

MAN MEETS BOY: In his new documentary, Justin Theroux delves deep into the lives of social media influencers including HSTikkyTokky (Harrison Sullivan)

Inside the Manosphere: Theroux's chilling visit into the world of toxic male influencers

BRITISH filmmaker Louis Theroux, the king of the awkward pause and the raised eyebrow, is back - but this time, he's swapped his sensible jumpers for a front-row seat to the most toxic show on earth.

Netflix's *Inside the Manosphere* is a disturbing, 90-minute descent into a subterranean world of "Alpha Males," "Red Pills," and self-appointed gurus who treat women like disposable commodities and young men like ATM machines.

Theroux takes us into the gold-plated, neon-lit lairs of the "Manfluencers" - men with names that sound like malfunctioning robots, such as Sneako and HSTikkyTokky. These are the high priests of a new, dangerous religion that preaches "one-sided monogamy." Translation? They expect their wives to stay locked away like Victorian relics while they prowl the world for "clout" and fresh conquests.

We meet London-born Harrison Sullivan (the aforementioned HS) peacocking for the cameras, more interested in his "metrics" than any semblance of human decency. When Louis asks why he promotes "disgusting" content while claiming to be a moral arbiter, the an-

swer is as chilling as it is simple: "I'm doing it for the money."

It's a world where empathy is a "weakness" and "depression doesn't exist" - unless, of course, you haven't bought their latest life-coaching "cheat codes" to "level up" your bank balance.

Watching this documentary is like witnessing a slow-motion motorway pile-up. You want to look away from the carnage of broken logic and blatant misogyny, but Theroux's lens won't let you. He captures the moment the "mask slips," though as one critic poignantly noted, in the social media age, "the mask is all there is."

Lost Boys:

These men don't care about being "exposed" because they've already yelled their worst slurs into a smartphone to the cheers of thousands. They don't fear the truth; they fear being irrelevant.

But beneath the Ferraris and the flashing lights lies a much sadder story. The real tragedy isn't the millionaires in the mansions; it's the army of "Lost Boys" following them. The documentary hints at a heartbreaking pattern: many of these followers are young men nursing wounds from absent or

abusive fathers, desperately seeking a "strong" role model.

Instead of a guiding hand, they find grifters who tell them they are "born without inherent value" and must "earn" their worth through dominance and dollars. It's a digital cult grooming the vulnerable, turning legitimate insecurities into a weaponized hatred of women, the "system," and anyone else the algorithm tells them to loathe. Three top-20 sides faced by Thomas Tuchel's England - and still no wins

The Three Lions breezed through qualification for the World Cup winning all of their eight games without conceding a goal.

But after losing 1-0 to Japan, the world's 18th-ranked side this week at Wembley in England's last match before Tuchel names his World Cup squad, questions about whether the Three Lions struggle when they come up against elite nations are being asked.

After their loss at Wembley, which saw Japan become the first Asian side to beat England, the Three Lions end the March international break without a win.

There is an argument that Tuchel experimented with his line-ups in last June's 3-1 loss to 14th-ranked Senegal, the 1-1 draw with 17th-

ranked Uruguay and in the Japan defeat, something he would not do at a major tournament.

But critics will suggest that the England manager should be using these games to find his best XI, and get them ready for the challenge that is coming at this summer's World Cup, especially as the sides that England did not face the same tests in qualification.

The biggest worry for England and for Tuchel is what they will do without captain and record goalscorer Harry Kane if he is not available.

Kane missed the game against Japan after picking up a knock in training and England, who lacked ideas in attack, do not have a candidate who is ready to be his back-up.

Manchester City midfielder Phil Foden was trialled as a false nine

and did not have a good night but Tuchel has said this window has provided him "more clarity" than questions about his side.

"I am disappointed, everyone is." Tuchel said. "I knew that we had a top exam in this window because our

players are heavy in club football and in European football in the most physical toughest league that there is.

"We played against two top-20 teams, well drilled and very good opponents who arrived with their best line-up.

"We had big changes

in the middle of camp, suddenly after the [Uruguay] match we had seven or eight injuries who had to leave.

"It is not an excuse, it is just an explanation why things are not perfectly smooth and perfectly at the highest level we expect."

\$10k final tickets a testament to FIFA's astounding greed

THE ASTOUNDING greed of FIFA and the US World Cup powers that be showed no let up this week, as the first open tickets were released to a chorus of disappointment from fans from around the globe.

Fifa is charging up to \$10,990 (£8,333) to be at the final, which is thought to be the most expensive ever general admission to a football match, based on box office prices rather than the resale market.

In its World Cup bid book, the US, Canada and Mexico said tickets to the final would cost a maximum of \$1,550 (£1,174). That promise evaporated once they had secured the prize.

By the time tickets went on sale to members of each country's official supporters' club in December, the

most expensive was listed at \$8,680 (£6,581).

Prices then went up again when Wednesday's final sale period began.

Tickets for the Qatar World Cup final in 2022 cost the equivalent of \$1,604 (£1,214) for the top-priced seat.

Establishing the actual cost of tickets for this summer's tournament is difficult as Fifa has never released its pricing structures.

It is also using a version of dynamic pricing, whereby prices change at the start of each sales point depending on past demand.

Late last year the cost of the initial ticket releases was described as a "monumental betrayal". In December, Fifa announced a small number of \$60 (£45) tickets.

On Wednesday, tickets were put on open sale for the first time - and gave another glimpse at what is being charged by tournament organisers.

With no pricing structure and scant information published in advance of sales windows, supporters have found it difficult to plan for the World Cup.

"It seems to be top secret," Thomas Concannon, who leads the the Football Supporters' Association's fans' embassy for England away games, said.

"Supporters just don't know where they stand."

The situation was no different on Wednesday, with fans given no details of the "last-minute sales" and sent into incorrect ticket queues.

"It's just yet another stain on Fifa's ticketing sales," Concannon said.

"It's been a common theme for the entire tournament."

Concannon said that the cost of attending the World Cup will be "well into the thousands, if not over £10,000" for just a few games when all costs are taken into account.

"Sometimes in your life, you only get one opportunity to be able to go to a World Cup," he said.

"For many, this was their opportunity and they just won't be able to afford to go."

A series of technical glitches left fans furious and frustrated with wait times totalling six hours for many.

Of the 72 group games, 35 matches were listed with tickets available - but there was no allocation for the England or Scotland games, or any of the knock-out matches, when we ini-

tially made it through.

With the exception of the host nations, only one match of the top-10 seeded countries, the Netherlands, was available to buy.

Prices ranged from \$140 (£106) to \$2,985 (£2,261). The average price of those displayed was \$358 (£271).

The most expensive group stage match seen was the first of the tournament between Mexico and South Africa at \$2,985 (£2,261), with only a tiny proportion of the 87,000 capacity available.

Additionally, there were plenty of corporate hospitality packages, including one for England v Panama which was \$124,800 (£94,444) for a luxury suite with 24 match tickets, food and drink - \$5,200 (£3,935) per person.

Spurs gamble big on De Zerbi: Italian given five year contract and "Sir Alex-like" authority at Prem strugglers

ROBERTO de Zerbi was named Tottenham's new head coach this week as the North London club threw the dice in their battle to stave off relegation.

And the combustible Italian demanded - and received - a five-year contract which will grants him more power at the club than any manager since Bill Nicholson, as he expected to oversee all footballing matters at the club, including, crucially, recruitment.

Goal.com reported on the Thursday that, "De Zerbi is expected to be given powers beyond a mere coach.... the same as those Sir Alex Ferguson once received."

"Tottenham Hotspur appointed De Zerbi as part of a desperate effort to avoid relegation. This move signals a huge change across overall club operations. Tottenham intends to give him the heavy responsibility of completely rebuilding the club."

And in a drastic departure from the Daniel Levy era, the club seem to have realized that having a winning coach is pointless if you denying him the budget to sign the very best players available. The failures of Mauricio Pochettino, Jose Mourinho and Antonio Conte to bring silverware to the club under the right financial re-

straints imposed by former CEO Levy have been noted by the club's ownership, and giving their newest hire carte blanche is believed to be the best gambit to get them back among the elite.

De Zerbi is the club's third manager this season. Thomas Frank, who was brought in ambitiously before the season, was sacked in February after poor results, and Igor Tudor, who came in as a firefighter, left the team after a dismal Premier League record of one draw and four losses.

Tottenham have now gone 13 league matches without a win. They have dropped to 17th in the

table and face the threat of relegation. The gap to 18th-place West Ham United is only one point, so they could fall into the

relegation zone depending on the next round's results.

Spurs director Johan Lange welcomed him,

saying, "De Zerbi was our top target this summer, and we are very pleased to bring him in at this point."

England manager Thomas Tuchel has said Phil Foden does not have a guaranteed place in his World Cup squad.

The 25-year-old Manchester City midfielder was the only player to start both games in England's final camp before Tuchel selects his 24-man squad.

But he failed to fill the void left by striker Harry

Kane's absence when he played in a false nine role in the defeat by Japan on Tuesday.

And when asked after the game whether there are doubts about the player's spot in the World Cup squad, the German said: "Well, it's not a guarantee that he will come."

Tuchel said Foden was "excellent" in training but "struggles to show it on

the pitch".

"Obviously he didn't have a lot of minutes for City recently, then he came to camp with the brightest smile and was so good in training," the England boss added.

"And I thought he will just surprise us and will play with the same verve and excitement but, yeah, he struggles to have the full impact."
