**MORE calls for PM to go as it emerges Epstein pal FAILED security check before landing plum DC job**

**A SINGLE HEAD** has finally rolled at the Foreign Office following the highly damaging Lord Mandelson-Jeffrey Epstein saga.

Sir Olly Robbins, the most senior official at the FO, was fired Thursday night after it emerged that a decision to fail Lord Mandelson's security vetting for the role of US ambassador was overruled by Robbins' department.

The firing came just a few hours after the government confirmed the FO went against the recommendation of the vetting agency.

But a spokesperson said neither PM Sir Keir Starmer nor any minister were aware Lord Mandelson had failed the vetting process until earlier this week.

Not surprisingly the news that Mandelson in effect 'failed' his security screening and was still allowed to take the most prized post in the British diplomatic service sparked outrage at Westminster, prompting Conservative leader Kemi Badenoch to call for Starmer to resign.

"The prime minister appointed Peter Mandel-

son before the vetting had been completed, vetting Mandelson failed," she said on Wednesday.

"Starmer then said full due process was followed. That is misleading Parliament.

**"he should go"**

"I'm only holding him to the same standards to which he's held previous prime ministers - that if they mislead parliament, they should resign.

"In these dangerous times, Britain cannot afford to have a prime minister who the country doesn't trust. Starmer has betrayed our national security. He should go."

A government spokesperson had earlier said: "The decision to grant Developed Vetting to Peter Mandelson against the recommendation of UK Security Vetting was taken by officials in the FCDO.

"Neither the prime minister, nor any government minister, was aware that Peter Man-

delson was granted Developed Vetting against the advice of UK Security Vetting until earlier this week.

"Once the prime minister was informed he immediately instructed officials to establish the facts about why the Developed Vetting was granted, in order to enact plans to update the House of Commons."

In February, the government agreed to release documents relating to Lord Mandelson's appointment, following a vote by MPs for them to be published.

**"reputational risk"**

However, a report in the Guardian claimed that senior government officials have been considering whether to withhold documents from Parliament revealing Lord Mandelson was not given vetting approval from security officials.

The government has already published some files, including an earlier

due diligence check carried out by a team at the Cabinet Office, which was sent to the PM on 11 December 2024.

That advice - which is largely based on public information such as media reports - warned that Lord Mandelson's relationship with Epstein posed a "reputational risk".

A spokesperson said the government was committed to complying with a parliamentary motion demanding the release of documents related to the appointment "in full as soon as possible".

Lord Mandelson was announced as the UK's ambassador to the US in December 2024, be-

fore in-depth vetting had been carried out, and formally took up the role on 10 February 2025.

Just seven months later he was sacked over his ties to the late convicted sex offender Jeffrey Ep-

stein.

Sir Keir has faced calls to resign over allegations he misled Parliament and MPs when he claimed "full due process" was followed during the appointment.

# UK economy to be 'hit hardest' by Iran war

■ IMF forecast adds to gloomy outlook - and food shortages MIGHT be on the way, warns government

The energy shock from the Iran war will hit the UK the hardest of the world's advanced economies, the International Monetary Fund (IMF) has forecast.

In its latest World Economic Outlook, the IMF cut its estimate for UK growth this year to 0.8%, from the 1.3% prediction made in January before hostilities began.

The Fund said the downgrade was due to the war, fewer interest rate cuts, and the expectation that the impact of higher energy prices would linger into next year.

It also warned the war threatened to throw the world economy "off course" and a prolonged conflict risked a global recession. The IMF urged central banks to be cautious over raising interest rates to counter higher inflation.

The UK's downgrade of half a percentage point is the largest of the world's advanced economies, with the UK now earmarked to have middling growth this year compared to its peers.

The revision is similar to that made by the OECD, which last month also

predicted the UK would face the biggest hit to economic growth of the G20 major economies from the Iran war.

The IMF suggested the UK, as a net importer of energy, remained sensitive to rapid rises in energy prices.

However, it expects the UK to then recover, to again become the fastest growing European economy next year in the smaller G7 group of advanced economies, albeit at a slightly slower rate of growth of 1.3%.

## worst case scenario

But in a darker development, it emerged that the UK could face food shortages, including chicken and pork, by the summer if the Iran war continues, in a worst case scenario drawn up by government officials and made public on Thursday.

A government source said it was planning for a scenario which would involve the continued closure of the Strait of Hormuz and breakdowns in the supply of carbon dioxide (CO<sub>2</sub>), which is used in the slaughter of some animals and in food pres-

ervation.

A spokesperson from the Department for Environment, Food & Rural Affairs said it would continue to work closely with businesses to tackle the impact of the war.

"Reasonable worst case scenarios are a planning tool used by experts and are not a prediction of future events", they added.

Since the US and Israel launched wide-ranging strikes on Iran, the Iranian government has responded by effectively shutting the Strait of Hormuz - a crucial waterway for oil and gas transport - causing prices for petrol, diesel and fertiliser to soar.

Business Secretary PETER KYLE said CO<sub>2</sub> shortages were not a concern "at this moment".

"Right now, people should go on as they are," he told Sky News.

Food sector leaders echoed the government reaction, with some saying they were more concerned about price rises than shortages.

Tesco's chief executive Ken Murphy said the supermarket giant's growers, suppliers and manufacturers were yet to

raise supply risks.

"We are in very good shape," Murphy said, but he would not comment on what could happen to food prices as "we don't know what it's going to look like, because clearly this is a volatile, unpredictable situation".

The British Retail Consortium, which represents over 200 of some of the largest brands, including Sainsburys and Pret, said it expected the govern-

ment to carry out contingency planning, adding that retailers were experienced in managing supply chain disruption.

"However, the situation in the Middle East continues to add inflationary pressure at a time when retailers already face significant new costs from domestic policies," a spokesperson said.

Other industry groups, such as the Food and Drink Federation, forecast

food inflation to reach 9% by December, while the Agricultural Industries Confederation (AIC) raised concerns about increased fertiliser costs.

Head of the AIC Jo Gilberton said rising fertiliser prices could have an impact on "planting decisions in autumn".

"That's when we end up with a potential food crisis, if the fertiliser and the fuel costs are too much."

## PM: Iran blockade 'not in UK national interest'

The UK will not be involved in enforcing the US military blockade of Iran, Sir Keir Starmer has said.

UK minesweepers and anti-drone capabilities will continue operating in the region but British naval ships and soldiers will not be used to block

Iranian ports.

The prime minister said he was focused on getting the vital shipping channel of the Strait of Hormuz reopened in order to reduce energy prices "as quickly as possible".

The US announced its blockade after talks with

Iran failed to secure a lasting peace deal to end hostilities in the Middle East.

Following a meeting between US and Iran negotiators in Pakistan's capital Islamabad, President Donald Trump said the US would start

# “We’ve always tried to be the best parents that we can be”, says Posh as Brooklyn rift rumbles on

■ Victoria opens up about troubled relationship with oldest son in new Wall St Journal interview

Victoria Beckham has said she and husband Sir David have “always tried to be the best parents that we can be”, in her first public response after their eldest son Brooklyn exposed a rift in the family.

Brooklyn Peltz Beckham posted a lengthy Instagram statement in

January, accusing his parents of trying to “ruin” his relationship with his wife Nicola, and of basing family love on the public promotion of “Brand Beckham”.

In an interview with the Wall Street Journal, Lady Beckham said: “I think that we’ve always - we love our children so

much.

“We’ve always tried to be the best parents that we can be. And you know, we’ve been in the public eye for more than 30 years right now, and all we’ve ever tried to do is protect our children and love our children.”

Lady Beckham wished Brooklyn a happy birthday on social media last month, but her latest interview marks her first direct comment on the rift.

## ‘public promotion’

In his six-page Instagram statement in January, Brooklyn made clear that relations with his parents had broken down, saying he had been forced to respond after they had “continued to go to the press”.

He made claims including that his mother

had “cancelled making Nicola’s [wedding] dress at the eleventh hour” and “danced very inappropriately on me in front of everyone” during the ceremony.

He also claimed his family values “public promotion and endorsements above all else”, adding that “family ‘love’ is decided by how

much you post on social media, or how quickly you drop everything to show up and pose for a family photo opp”.

## ‘hardly the truth’

The events of the wedding have been disputed by some guests. DJ Fat Tony backed up Brooklyn’s claim about the “awkward dance” with

his mother, but singer Marc Anthony said the way events had been presented was “hardly the truth”.

Sir David has not commented directly, but speaking generally about social media at a panel in Davos shortly after Brooklyn’s statement, he said children are “allowed to make mistakes”.

## Andrew ‘invited’ to relinquish Freedom of the City of London

Andrew Mountbatten-Windsor has been invited by councillors to relinquish his inherited Freedom of the City of London.

The disgraced former prince received the honour in 2012 “by virtue of patrimony”, due to his father Prince Philip having been a Freeman.

Despite calls for the title to be removed, the City of London Corporation (CLC) previously said the honour, which historically allowed its recipients to walk sheep over London Bridge with no tariff, cannot be taken back.

A CLC spokesperson said: “Elected members have today agreed to write to Mr Mountbatten-Windsor, inviting him to formally relinquish the Freedom.”

The CLC said it “will consider the response received, if any, at a future meeting and determine what action may be taken”.

“Applications via patrimony are not considered or endorsed by our elected members, and there is no effective legal mechanism to remove this type of Freedom,” the spokesperson added.

In February Andrew was arrested on suspicion of misconduct in public office after correspondence in the Epstein Files suggested he may have passed on sensitive trade information, and was released under investigation after spending 11 hours in custody.

He has denied any wrongdoing.

“BLOCKADING any and all Ships trying to enter, or leave, the Strait of Hormuz”.

The US Central Command (Centcom) later confirmed its forces would enforce the blockade “impartially” on vessels leaving and entering Iranian ports, including those located in the Arabian Gulf and Gulf of Oman.

Centcom added that US forces would not impede the freedom of vessels transiting to and from non-Iranian ports, and that additional information would be provided to commercial mariners via a formal notice before the blockade starts.

Sir Keir, who has recently returned from a visit to the Gulf region,

said he had been working with allies to “keep the Strait open, not shut”.

## ‘clear, lawful basis’

“We’re not supporting the blockade and all of the marshalling diplomatically, politically and capability... that’s all focused, from our point of view, on getting the Strait

fully open.”

He said the UK did have mine-sweeping capability but “wouldn’t go into operational matters”.

Sir Keir has repeatedly ruled out direct UK military involvement in the conflict.

In an interview with the BBC, he said: “My decision has been very

clearly that whatever the pressure - and there’s been some considerable pressure - we’re not getting dragged into the war.

“That’s not in our national interest, because I’m not going to act unless there’s a clear, lawful basis and a clear thought-through plan.”

## Promises fly as Scots prepare to vote

About four million voters north of the border will head to the polls on May 7th to elect the seventh Scottish Parliament - and the country’s major parties are falling over themselves to sell their own vision of the country’s future.

In the first election during the coronavirus pandemic, a total of 129 MSPs will be elected to the parliament, often referred to as Holyrood after the area of Edinburgh where the parliament

building stands.

Scottish Labour leader Anas Sarwar has been much in the news recently for his pointed criticism of Sir Keir Starmer, and he was not shy with his promises this week, vowing to fix the NHS and make life more affordable should his party form the next government.

Launching Labour’s manifesto, he also pledged to build more homes and approve the construction of nucle-

ar power stations. The Scottish Labour Manifesto also includes plans to fund 9,000 apprenticeships, build 125,000 homes and repair 5 million potholes.

Mr Sarwar said he would increase the tax-free childcare allowance, fund breakfast and summer holiday clubs and hire more teachers.

Meanwhile the Scottish Greens, who are seen as a growing force in UK-wide politics, laid out a

plan to tackle the climate crisis by reiterating their opposition to new oil and gas fields. Speaking in Glasgow, the party's co-leaders also promised an expansion of child care and free bus travel.

The slogan for this manifesto launch was Let's Demand Better, and at its core were big picture promises - like tackling climate change and growing what it described as a green economy - and more tangible vow, like increasing teacher numbers, improving public transport and extending free bus travel to everyone in Scotland.

Meanwhile SNP leader John Swinney said the election's defining issue was the cost of living. Speaking in Glasgow, he promised a £2 cap on all single bus journeys and legal price ceilings for essential items such as bread, milk and eggs sold in large supermarkets. He's already faced questions about the legality and practicality of such a scheme.

But Mr Swinney insists Holyrood does have the power to intervene in the free market on public health grounds.

Speaking on Tuesday, Swinney said: "Friends, the cost of living is hammering people, no more so than when they get to the supermarket till. Inflation has come down, but prices have not. People are quite simply struggling to afford food.

"In a rich country like Scotland, that is a proper moral outrage."

Under political pressure about levels of taxation for middle and high earners and warnings from independent experts that Scotland's welfare bill is unsustainable, Mr Swinney said he hoped to simplify income tax and he would focus on jobs and growth by attracting investment, funding more childcare and reforming planning.

**'Catastrophic failures' led to Southport slaughter****■ Public inquiry highly critical of several local agencies AND the Southport killer's parents**

**Catastrophic** failures by the parents of the Southport killer and various agencies meant clear chances to prevent the 2024 child murders were missed, a public inquiry has concluded.

Axel Rudakubana, 17, should have been detained before he walked into the Taylor Swift-themed dance class and stabbed three girls, inquiry chair Sir Adrian Fulford found.

Sir Adrian said if his parents had done "what they morally ought to have" and reported his suspicious behaviour, he would not have been free on the day of the attack.

But a "merry-go-round" of referrals, assessments and "hand-offs" - and his autism being used as an "excuse" for past conduct - meant no agency understood the danger he posed.

**'warning signs'**

Bebe King, six, Elsie Dot Stancombe, seven, and nine-year-old Alice da Silva Aguiar were killed in the attack while eight other children and two adults were severely wounded.

In a 760-page final report - following Phase One of the inquiry into how Rudakubana was able to carry out the attack - Sir Adrian called for the end of what he described as a "culture" of agencies passing responsibility

between each other or downgrading their own involvement in cases like Rudakubana's.

He described it as the "single most important conclusion" of his report, adding: "This failure lies at the heart of why [Rudakubana] was able to mount the attack, despite so many warning signs of his capacity for fatal violence."

Those criticised included Lancashire Police, the government's counter-extremism service Prevent, various NHS mental health services, Lancashire County Council, elements of children's social care, youth offending services and a broader "multi-agency" approach.

**'preventable'**

A lawyer representing the three bereaved families welcomed the report but added that "seeing the extent of the failures in black and white is devastating".

"The Southport murders were not only predictable, they were preventable," he said.

"For our families, this has always been about honouring their girls and ensuring no one else endures what they face every day.

"On behalf of our clients we welcome the report's clear - though deeply distressing - findings on the profound systemic fail-

ures and individual failures, that preceded this attack and the responsibility borne by AR's parents."

He stated reforms were required urgently: "On behalf of the families, we repeat the chair's hope that this marks a genuine turning point."

In his report, Sir Adrian said: "Over a long period of time, [Rudakubana] had become an aggressive, near-total recluse, who bullied and threatened his family and unashamedly lied to officials."

He said the inquiry's evidence revealed a pattern of mental health services and social care treating the teenager's autism spectrum disorder as an "excuse" for his behaviour - rather than appreciating that in his individual case his condition "significantly increased the risk that he posed".

He also highlighted how different agencies had shown "scant regard" and a "lack of curiosity"

over Rudakubana's internet usage.

The retired High Court judge singled out an attack Rudakubana carried out on a boy with a hockey stick at the Range High School in Formby in December 2019, a couple of months after he had been expelled for admitting carrying a knife, as a "watershed moment".

He said it proved "beyond doubt" that he "was motivated by an ensuring desire to inflict severe harm on and possibly kill another pupil.

"Nothing occurred during the next five years to indicate that this level of danger had diminished."

There was stark criticism particularly for his father Alphonse Rudakubana, who Sir Adrian said had deliberately withheld information about his son amassing a stash of deadly weapons including the biological toxin ricin.

Sir Adrian said if the parents had reported

their true level of knowledge to the authorities before the attack, the killer would "undoubtedly have been taken into care or held in custody".

He did accept that Rudakubana had made his mother and father's lives "a nightmare" and parenting him had been "challenging".

Giving evidence during the inquiry last year, his father tearfully apologised and said he regretted not contacting the police about his son following a range of troubling incidents in the months and weeks before the attack.

"The love I had for him overrode [my] good judgement," he said.

Speaking after the report's conclusions were made public, Sir Adrian said: "Numerous systems that should have provided oversight, assessment and protection were ineffective or inadequately used. Some failed outright."

**Lack of defence cash leaves UK 'in peril'**

**The UK's security is "in peril" and Sir Keir Starmer's government has shown "corrosive complacency" towards defence, a former Nato secretary general has said.**

Lord George Robertson, the ex-Labour defence secretary who wrote the

government's Strategic Defence Review, accused "non-military experts in the Treasury" of "vandalism", in a speech on Tuesday.

The SDR was delivered in June last year but the 10-year investment plan to fund it has been repeat-

# Albanian gang used property website to plan million pound break-in spree

A gang of Albanian burglars who used Google Maps and leading UK property website Rightmove to plan dozens of break-ins at wealthy homes across the UK have been jailed.

The four men stole £1m worth of valuables, including designer watches and handbags, and even set weekly targets of how much gold they wanted to steal.

Kristian Gropcaj, 31, George Pepa, 31, and Krisjjan Dedndreaj, 29, all from the West Midlands, and Sidorjan Lleshi, 27, from Sheffield, all pleaded guilty to the burglaries at Chester Crown Court.

They were given prison sentences between nine years and 10 years and nine months.

Endrit Nikolli, 27, will be sentenced at a later date.

Jade Tubb, Nikolli's partner, of Walsall, also admitted conspiracy to possess criminal property and was handed a 12-month sentence, which was suspended for two years, and ordered to carry out 200 hours of community service.

### 'no mercy'

Judge Patrick Thompson said the gang had been "stealing with no mercy", leaving their victims suffering paranoia and anxiety.

"You have taken something from them that cannot be replaced," he said.

"You have taken their sense of security in their own homes and left them feeling vulnerable and uneasy."

The court heard the men used Google to search for affluent post-

codes to identify potential targets, before browsing Rightmove to research floorplans of various properties.

They would then break into the properties, stealing money, jewellery, and other valuables.

The gang, originally from Albania, were linked to eight burglaries in Cheshire, two in Middlesbrough, nine in Derbyshire, two in Leicestershire, five in Nottinghamshire, seven in Staffordshire, two in Warwickshire and three in Birmingham, three in Worcestershire, two in Hereford and one in Shropshire.

Ultimately the combination of intelligence, technology and old-fashioned policework would build an undeniable case.

All five men admitted the crimes when they appeared in court.

edly delayed and Lord Robertson had earlier told the Financial Times that the prime minister was "not willing to make the necessary investment".

Defence minister Luke Pollard denied the claims, saying the government was "working flat out" to publish the plan.

He said "we already have extra money in our budget this year" for defence, and ministers were continuing to announce contracts which give "our fighting forces the kit and equipment they need to deter aggression".

In a directly political intervention, Lord Robertson - who is now a key government adviser

- warned in his speech: "We cannot defend Britain with an ever-expanding welfare budget."

Speaking in Salisbury, he said: "We are under-prepared. We are under-insured. We are under attack. We are not safe...Britain's national security and safety is in peril."

He added: "There is a corrosive complacency today in Britain's political leadership."

"Lip service is paid to the risks, the threats, the bright red signals of danger - but even a promised national conversation about defence can't be started."

The prime minister's official spokesman said: "I completely reject that, our armed forces are working around the world every minute of the day to keep us safe at home and strong abroad".

Defence spending last year was 2.3% of GDP (around £66bn). A defence official highlighted the government's target to spend 3% of GDP on defence by the end of the next Parliament and 3.5% of GDP on core defence by 2035.

Welfare spending is forecast to be 10.6% of GDP, or £322.6bn, in 2025 to 2026.

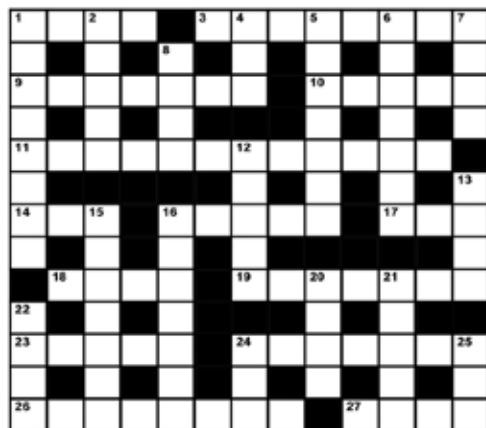
The SDR was published in June 2025 and the government accepted it would implement all 62 of the review's recommendations, but has yet to share how it will fund these plans.

A government spokesman said the spending review was "backed by the largest sustained increase in defence spending since the Cold War, with a total of over £270bn being invested across this Parliament".

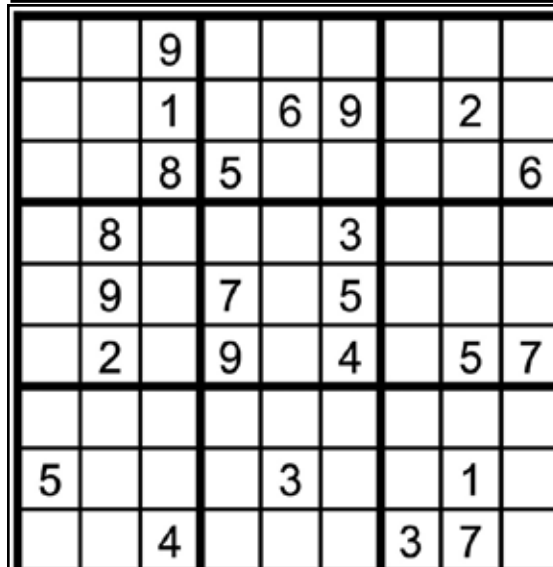

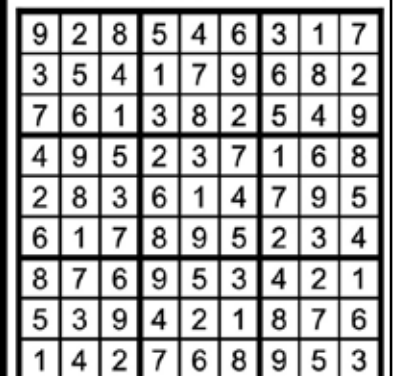

# Cagey Gunners squeak into CL semis

Arsenal reached the Champions League semi-finals after fighting out a cagey goalless draw with Sporting at Emirates Stadium Wednesday night.

In contrast to the ding-dong battle taking place the same night in Munich, where Bayern and Real fought a seven goal thriller of high drama, in North London it was a much cagey affair.

The Gunners came into the game with a 1-0 lead from the first leg thanks to Kai Havertz's late goal in Portugal last week and that strike was enough to see Mikel Arteta's team take their place in the last four of the competition.

Arsenal started the game in an extremely positive manner but despite the Gunners having more of the ball, it was visitors Sporting who came closest to scoring in the first half.

Francisco Trincao, Pedro Goncalves and a loose pass from Arsenal goalkeeper David Raya gave Sporting opportunities before Geny Catamo hit the post with a volley after Maxi Araujo found him with a cross inside the area.

The home crowd inside the stadium produced a nervy atmosphere as the game went on with the Gunners defending a slender lead and following their defeat to Bournemouth in the Premier League last weekend.

Araujo had Sporting's best chance in the second period when he shot wide from inside the area while substitute Leandro Trossard hit the

post with a header from a corner late on for Arsenal.

The victory over two legs means that Arsenal have reached successive semi-finals in the competition for the first time in their history and will take on Atletico Madrid for a place in the final.

This is a pivotal week in Arsenal's season and although they did not produce a sparkling performance, the fact that they are into the semi-finals of the Champions League will fill them with confidence.

The Gunners were under huge pressure coming into this game after the manner of their Premier League defeat against Bournemouth, and having also suffered three losses in their previous four matches in all competitions.

Mikel Arteta named a front three of Viktor Gyokeres, Noni Madueke and Gabriel Mar-

tinelli and as has been the case on most occasions when the trio have played together, the Gunners' attack did not click.

Madueke was forced off with an injury in the second half and the Gunners boss will have to think of an alternative frontline if Arteta wants his Arsenal side to cause title rivals Manchester City problems on Sunday.

Arsenal are not in good form but can now focus on a top of the table clash with City as they look to take the next step under Arteta and put themselves in a great position to secure the silverware everyone at the club craves so much.

Sporting head coach Rui Borges will feel hard done by after seeing side go out but he can be proud of the performances they produced against the Premier League leaders.

## Achilles rupture puts Ekitike out of World Cup

Liverpool have confirmed that striker Hugo Ekitike has sustained a "serious" Achilles injury and will miss the rest of the season and the World Cup with France.

The forward had to be substituted during the first half of Tuesday's Champions League defeat to Paris Saint-Germain at Anfield after a slip on the turf and scans on the injury have confirmed a rupture of the Achilles tendon.

There are fears the 23-year-old could be out for at least six months and the worst-case scenario is an absence as long as nine months, but it will take more analysis to determine a timeline for his recovery.

Liverpool confirmed on Thursday: "Ekitike will therefore be sidelined for the remaining weeks of the club season and unable to participate at this summer's World Cup with France."

# Sharp Villains slice through Bologna

## EUROPA LEAGUE: Emery's men cruise to victory to set up all English semi-final

Aston Villa set up an all-English Europa League semi-final with Nottingham Forest after completing a commanding 7-1 aggregate victory against Bologna at Villa Park on Thursday night.

Already 3-1 up from the first leg, tournament favourites Villa produced a statement display under four-time Europa League-winning manager Unai Emery to take another step closer to ending a 30-year trophy drought.

It only took the Premier League side 16 minutes to increase their advantage in the tie as Ollie Watkins - the star of the first leg - applied the finishing touch on a wonderful

team move to score his 100th goal for the club in all competitions.

Morgan Rogers then had his spot-kick saved by Bologna goalkeeper Federico Ravaglia after Martin Vitik's handball inside the box but Villa pulled away further 44 seconds later through Emiliano Buendia.

With the Bologna defence switching off, Buendia latched on to Lucas Digne's long throw and slotted past Ravaglia for his second goal in Europe this season.

Rogers then put the disappointment of his penalty miss behind him as he found the back of the net from a narrow angle with his weaker left foot after

being found in space by his captain John McGinn - ending his 11-game goal drought.

Centre-back Ezri Konsa then added to his first-leg goal with an impressive volley on the turn following a corner to seal the victory in the 89th minute.

Villa's third win over the Rossoneri at Villa Park in 18 months secured their second European semi-final in three seasons and a first all-English semi in Europe since Arsenal and Manchester United met in the 2008-09 Champions League.

The first leg of their last-four tie against Forest will be played in Nottingham on 30 April before

the return leg in Birmingham on 7 May, while Portugal's Braga face Bundesliga side Freiburg in the other semi-final.

Villa did much of the hard work in the first leg where they ran out 3-1 winners in Italy.

Watkins struck twice - including a decisive goal

in 94th minute - to give Villa a firm grip on the quarter-final tie and his timing was impeccable again at Villa Park, opening the scoring early to allay any fears of an improbable Bologna comeback.

Finishing off a slick team move which in-

involved nine Villa players, Watkins became the 11th player to hit 100 goals for the club and the first since Peter McParland in 1962 to reach the milestone.

He also became their outright top scorer in major European competition with 10 goals, overtaking Peter Withe and McGinn.

## Nerveless Forest swallow Porto

Nottingham Forest beat 10-man Porto on Thursday night to advance to the semi-finals of a European competition for the first time since 1984, where they will face Premier League rivals Aston Villa.

After last week's 1-1 draw in Portugal, Morgan Gibbs-White scored the only goal at the City Ground to set up a mouth-watering final-four Europa League tie with Villa later this month.

Porto had failed to win any of their previous 24 matches on English soil, including a 2-0 defeat to Forest in October.

The task became even tougher for the Portuguese side when Jan Bednarek was sent off after just eight minutes for a high challenge on Chris Wood.

Referee Danny Makkelie had initially decided against booking the former Southampton and Aston Villa defender before the video assistant referee recommend-

ed an on-field review.

From that moment, Forest - who have used this competition as a welcome escape from their struggles in the Premier League this season - stepped up the pressure and took the lead through Gibbs-White four minutes later.

The England midfielder latched onto a pass from Neco Williams before firing past Diogo Costa, with his strike taking a deflection off Pablo Rosario, who was deputising at the heart of defence following

Bednarek's dismissal.

Gibbs-White dedicated his celebration to team-mate Elliott Anderson, who missed Thursday's match after the death of his mother earlier in the day.

The only downside of a magical night for Forest came shortly after the 15-minute mark as Wood - who made his return from a six-month lay-off in last week's first leg - was unable to continue after the earlier challenge from Bednarek.
