KEIR AT THE BRINK!

Embattled PM rubbished and ridiculed as Mandelson saga rumbles on

SIR KEIR STARMER was facing the most difficult days of his Premiership this week with Cabinet colleagues refusing to back him and a Labour MP publicly supporting calls for his resignation.

Hartlepool MP Jonathan Brash became the first of Sir Keir's backbenchers to openly suggest he should go as the crisis over Peter Mandelson's appointment as ambassador to the US continued.

Mr Brash said: "I don't think anyone reasonably expects the Prime Minister to lead the party into the next election."

Asked why the PM should go, Mr Brash, replied: "Because ultimately, we've become completely consumed by this turmoil..."

"It's a reasonable thing to set a timetable to get this done in an orderly way, because we have got a very, very big job ahead of us."

"I genuinely think, as far as the Prime Minister is concerned, it's not a case of if, it's when."

Work and Pensions Secretary Pat McFadden was the latest senior minister publicly to cast doubt on Sir Keir's judgment, following rebukes from Energy Secretary Ed Miliband and Foreign Secretary Yvette Cooper.

There may be more damaging revelations next week, when MPs question former Downing Street chief of staff Morgan McSweeney, who championed Mandelson's candidacy for the role.

The Commons Foreign Affairs committee also questioned Cabinet Office permanent secretary Cat Little over reports that officials discovered a document from January 2025 that recommended against giving Mandelson security clearance.

Mandelson was granted clearance by the Foreign Office anyway, and began work in Washington weeks later.

Sir Keir has insisted he was not told about the vetting verdict until April this year, and sacked Foreign Office permanent under-secretary Sir Olly Robbins.

Mr McFadden declined to back the Prime Minister when asked three times if the sacking was justified, saying: "Look, it's the Prime Minister's judgment."

But he later issued a plea for Labour MPs to back Sir Keir, saying: "We've had far too

many changes to prime minister in the UK in the last decade."

It came after Mr Miliband said Mandelson "should never have been appointed" and Ms Cooper criticised No10's attempts to find a diplomatic role for Matthew Doyle, Sir Keir's former head of communications.

'he'll be gone'

Doyle, a Labour member of the Lords, has since been suspended after it emerged he supported a council candidate charged with indecent child image offences.

Tories kept up the assault in the Commons on Wednesday, as Kemi Badenoch accused Sir Keir of misleading MPs and demanded his resignation.

Skirting Commons rules that bar MPs from accusing each other of lying, the party leader said: "I cannot accuse the PM of deliberately misleading the House, but everyone can see what has happened here."

Sir Keir insisted he was not to blame and repeated his assertion no one told him that

UK Security Vetting, the government body responsible for making recommendations on clearance, had raised concerns about Mandelson.

Reform UK leader Nigel Farage predicted the PM will be ousted by the end of next month if Labour suffers a May 7 local elections blood-bath.

He said: "If Labour get obliterated in the Red Wall, in South Wales and in Scotland then he'll be gone by the end of May."

Sir Keir is set to escape another grilling next week after Labour MPs were told to expect the prorogation of Parliament on Tuesday.

It ends the Parlia-

mentary session ahead of the polls on May 7 and MPs will not meet again until the King's Speech on May 13.

Downing Street said

Sir Keir was confident he has the backing of the Cabinet and it was wrong to suggest everyone expects him to quit before the next election.

Charles visit 'could help repair' relations, Trump tells the BBC

US President Donald Trump has said next week's state visit from King Charles and Queen Camilla could help repair relations with the UK.

When asked in a phone interview with the BBC on Thursday whether the visit could help repair the relationship, Trump said: "Absolutely. He's fantastic. He's a fantastic man. Absolutely the answer is yes."

"I know him well, I've known him for years," he said. "He's a brave man, and he's a great man. They would absolutely be a positive."

The president also spoke about his relationship with the UK Prime Minister, saying their relationship could only "recover" if he changed course on immigration.

increasingly at odds

The King and Queen will travel to the US for a four-day visit beginning on Monday, and will meet with Trump at the White House.

The King will have a private meeting with the president and also deliver an address to Congress.

After two days in Wash-

ington DC, they will travel to New York, Virginia and Bermuda before returning to the UK.

The Foreign Office said the trip would mark the 250th anniversary of US independence, and would celebrate a partnership of "shared prosperity, security and history".

Trump and Sir Keir have been increasingly at odds over the war in Iran, and the prime minister has faced mounting pressure over his decision to appoint Lord Mandelson as UK ambassador to the US.

In a post on Truth Social on Monday, Trump said Lord Mandelson was "a really bad pick" but the prime minister had "plenty of time to recover".

'national interest'

When asked what he meant by that post, Trump said: "If he opened the North Sea and if his immigration policies became strong, which right now they're not, he can recover, but if he doesn't, I don't think he has a chance."

Trump has repeatedly called on the UK to

increase oil and gas extraction in the North Sea.

Sir Keir Starmer says he will not be "diverted or deflected" from acting in what he says is the "best national interest", following critical remarks made about him by US President Donald Trump to the BBC.

Speaking to reporters on Thursday, Sir Keir Starmer once again said he stood by his decision not to drag the UK into the Iran war, which began in late February.

Following Trump's remarks, Starmer said: "I'm here to serve the British people always, to have their interests and to make sure that I make the right decisions for them."

"That is why I took the decision that we would not be dragged into the war in Iran. That is why I took the decision we wouldn't be dragged into the blockade of the Strait [of Hormuz].

"That is in our best national interest. That is my duty. I will stick to it, and I'm not going to be diverted or deflected from that by what anybody else says."

Nationside school mobile phone ban coming down the line

Children will be banned from using mobile phones at school by law under new plans unveiled by the government.

Number 10 will seek to make existing recommendations on phone use in schools statutory by introducing an amendment in the House of Lords to the Children's Wellbeing and Schools Bill.

Currently, Department for Education (DfE) advises headteachers to stop pupils from using the devices on school grounds - but they are free to ignore this guidance if they wish.

A spokesperson for the DfE said: "We have been consistently clear that mobile phones have no place in schools, and the majority already prohibit them. This amendment makes existing guidance statutory, giving legal force to what schools are already doing in practice.

It builds on the steps we've already taken to strengthen enforcement, with Ofsted considering schools' mobile phone policies as part of inspection from this month. We will always put children's

interests first, including through this Bill - which is widely recognised as the biggest piece of child safeguarding legislation in decades, with critical measures like laws to crack down on profiteering in children's social care and a new unique identifier to stop children falling through the cracks."

On Monday evening, peers voted through a Conservative amendment to the bill on mo-

mobile phones. They voted by 276 to 169, a majority of 107, to ban pupils from having smartphones during the school day. MPs voted to approve the Government amendment on Wednesday.

Skills minister Baroness Smith of Malvern told the Lords: "We've listened to concerns about how we support headteachers in delivering on this policy and we have listened to Parliament."

Legal setback for Amy's dad

Amy Winehouse's father has lost a High Court claim against two of his late daughter's friends over the auctioning of items she had owned.

Mitch Winehouse, her estate administrator, sued stylist Naomi Parry and Catriona Gourlay over

claims they profited from selling clothes and other pieces. A 2021 sale in the US of 834 items made £1.05million.

His lawyers had told a trial in December the two had "deliberately concealed" they were selling

items linked to the Back to Black singer.

But barristers for the women said they either already owned the items or were given them by the star, who died from alcohol poisoning in 2011, aged 27.

Deputy High Court judge Sarah Clarke KC said in a judgment Monday: "Neither Ms Parry nor Ms Gourlay deliberately concealed any of their disputed items from the claimant." The judge added that she found Mr Winehouse to be an "unreliable witness".

He had denied acting out of "petty jealousy". Ms Parry said the court had cleared her name "in full".

UK to pay France half a billion to get their finger out on migrant crossings

ALL ABOARD: migrants board a flimsy dinghy bound for the UK



The UK and France have signed a three-year deal aimed at reducing the number of migrants crossing the channel in small boats.

Under the agreement, the UK will pay more than half a billion pounds for more French police officers with new equipment to patrol the northern coast. A further sum is conditional on the measures being effective.

At a police station close to the biggest mi-

grant camp in northern France this week, Home Secretary Shabana Mahmood and her French counterpart, Laurent Nunes, praised how the negotiations for this deal had gone and talked up what they see as a British investment in sophisticated equipment such as drones and new helicopters.

'mix of skills'

Mahmood said a 42% rise in the number of police was significant:

"That is a huge increase in the number of officers that will be working to prevent people from getting into the boats. Even better than that, the mix of skills and capabilities that we will now have, because now we will have specially riot-trained police who will be able to deal with increasing levels of violence that some of these migrants and people smugglers use to get on the boats, they will be able to push them back."

But there have been sticking points on how much money should be contributed and on what terms. It's not clear how the UK will decide whether to use the option of withdrawing £160 million of funding in the first year if there is unsatisfactory progress. Under the previous three-year agreement, signed in 2023, small boat crossings rose to nearly record levels.

There remains no shortage of motivation

among the migrants, who all see the UK as their most desired destination. It's why Nicholas Larar from a local police union believes little will change.

Larar told reporters: "I've been with the border police for 18 years. We've never succeeded in preventing migrant crossings by either trucks or boats. They always come, even if they failed 40 times.

"To be honest with you it's an endless game."

Afghan first to be convicted under new endangering law

Migrant abandoned severely overcrowded dinghy he was piloting across the Channel on January 17

An Afghan migrant has become the first person to be convicted of endangering others during a sea crossing to the UK.

Tajik Mohammad, 32, abandoned the dinghy he was piloting across the Channel and its passengers when a rescue ship arrived, prosecutors said.

The boat was said to be overcrowded and some migrants were not wearing life jackets.

It headed to Britain despite poor weather on January 17.

Mohammad travelled on to the UK the same

day before being arrested.

He pleaded guilty at Canterbury crown court on Thursday and will be sentenced on June 10.

The offence had only come into force weeks before his arrest.

He was charged under the Border Security, Asylum and Immigration Act – part of a range of measures designed to curb Channel crossings.

James Fisher, a senior CPS prosecutor, said: "I'm pleased the CPS has secured the first conviction for endangering the lives of others during a

Channel crossing since it became an offence in January.

"We will carry on using new laws to prosecute individuals and gangs who undermine UK border security.

shipping lanes

"The Channel is one of the busiest shipping lanes in the world and we argued Tajik Mohammad abandoned the tiller on the arrival of the rescue ship. That, along with the boat being overcrowded, some passengers not wearing life jackets, the weath-

er conditions that day, and that small boats are shoddily made, meant he was endangering the lives of others, which he's accepted."

A 16-year-old boy was the first person to be charged with the offence.

The teenager – who is also from Afghanistan – has denied endangering 46 people on January 5. He told a court he was "forced to do so".

According to the Home Office, the new offence is designed to stop more people being crammed into unsafe boats and would ap-

ply to those involved in physical aggression and intimidation, as well as to anyone who resists rescue.

'crime scenes'

When the plans for the new laws were first announced last January, Home Office sources said there had been instances of "floating crime scenes", where people had acted in such a reckless way that people died on board in crushes and drownings.

Those who commit the offence could face up to five years in prison, or

up to six years if they are in breach of a deportation order.

Earlier this month, another alleged dinghy pilot was charged over the deaths of four migrants.

Sudanese national Al-nour Mohamed Ali, 27, appeared before Folkestone magistrates court charged with endangering life after two men and two women died trying to board a boat on April 9.

Some 6,000 people have arrived in the UK after crossing the Channel by inflatable dinghy so far this year.

Life term for rapist who deliberately spread HIV

A man from Sunderland who deliberately infected five young men and two boys aged 15 and 17 with HIV has been jailed for life.

Adam Hall, who's 43, will serve a minimum of 23 years in prison.

He was found guilty of raping four men and intentionally inflicting grievous bodily harm upon them and three others. The trial heard that Hall's actions had left them traumatised and unable to live the lives they wanted.

The court heard that Adam Hall deliberately targeted vulnerable young men. One was just 15 when he met Hall on a dating app. Hall raped him and deliberately passed on HIV.

The teenager was on his way home from school when he received his diagnosis. In his impact statement, the victim said: I mean, there's a lot of people who just think that it's a death sentence. You know, a lot of people still judge, as you've seen, as either dirty, unclean, that you just sleep around all the time. You know, just those types of comments.

"I was just angry and I couldn't comprehend why someone could do this to harm someone, you know. Adam Hall could have taken medication, which would have made him unable to pass on HIV, but he didn't. Instead, he lied about his status, and right through this case, he's insisted the victims shouldn't be believed."

Detective Chief Inspector Emma Smith from Northumbria Police led the investigation.

"It's quite clear that he's quite an arrogant man. He hasn't shown any kind of remorse for his actions or his offending," she said after the hearing.

Zoologist and TV star Desmond Morris dead at 98

■ Star also enjoyed huge success as author of The Naked Ape

ZOOLOGIST and TV presenter Desmond Morris has been remembered for a "lifetime of exploration, curiosity and creativity".

The star hosted the popular Granada TV show Zoo Time, but rose to even greater fame in 1967 when his book The Naked Ape became an international bestseller.

He died on Sunday, aged 98.

His son Jason said: "His was a lifetime of exploration, curiosity and creativity."

'great man'

"A zoologist, man-watcher, author and artist, he was still writing and painting right up until his death.

"He was a great man and an even better father and grandfather."

The Wiltshire-born author joined the British Army in 1946. He did two years of national service before later pursuing his interests in the arts and natural history.

Morris began his ac-

ademic career studying zoology at the University of Birmingham, and later completed a doctorate in animal behaviour at Oxford University, where he remained to study the reproductive behaviour of birds.

Zoo Time

He became the face of the hit nature series Zoo Time in 1956, which ran until 1967 and featured animal experts and zoo staff, exploring animal behaviour.

Morris also hosted many art exhibitions throughout his career, including one at the Institute of Contemporary Arts in London in 1957. It combined his interests in animals and painting, showcasing a series of works created by chimpanzees. He also co-organised an exhibition at the Royal Festival Hall in London titled The Lost Image in 1958 which compared pictures created by infants, human adults and apes.

Morris became the Zoo-

logical Society's curator of mammals at London Zoo in 1959, a post he held for eight years.

He started his career with the BBC in 1965, hosting its Life in the Animal World programme, and later went on to front many documentaries for the corporation. In 1967, Morris penned his most popular book, The Naked Ape: A Zoologist's Study of the Human Animal, which led to his global recognition. It was translated into multiple lan-

guages, selling well over 10 million copies.

He wrote many follow-up books including The Human Zoo (1969), Intimate Behaviour (1971) and Bodywatching (1985).

He also contributed to over 90 other titles during his career.

As a broadcaster, he hosted BBC documentaries including Man-watching (1977), TV and Natural History (1986) and The Human Animal (1994). He also regularly

appeared on shows such as The Animals Roadshow and Friday Night, Saturday Morning.

In recent years, Morris continued to dedicate his life to his academic endeavours and his work as a surrealist artist, having held many exhibitions showcasing his paintings.

The BBC even released a programme titled The Secret Surrealist in 2017, showcasing Morris and his artwork as it examined his "double life" as a painter.

MAGA influencer banned from entering UK

A US-based anti-Islam influencer who had been authorized to attend a far-right rally in London has been blocked from entering the UK by the home secretary.

Valentina Gomez, a self-styled Maga influencer, was given permission last week to enter via a UK electronic travel authorisation (ETA).

She was due to speak at the United The Kingdom rally on 16 May organized by Tommy Robinson, the controversial far-right firebreand whose real name is Stephen Yaxley-Lennon.

But Home Secretary Shabana Mahmood this week intervened to withdraw the authorization on the grounds that Gomez's presence "would not be conducive to the public good".

The government gave the same reason when refusing permission for the rapper Kanye West, now known as Ye, to travel to the UK earlier this month. His ETA was withdrawn after concerns over a string of antisemitic, racist and pro-Nazi comments.

Gomez, 26, attended the first Unite the King-

dom rally in September last year alongside Yaxley-Lennon, and warned from the stage that "rapist Muslims" were "taking over" the UK.

100,000 attendees

"England, they took your guns, they took your swords, and they raped your women. You have nothing else to lose, but there's still hope. You

are still the majority. So you either fight for this nation or you let all of these rapist Muslims and corrupt politicians take over," she said.

She also addressed police officers, telling them: "I need you to stop following orders because you know you are being told to look the other way while your country is being raped into sub-

mission."

An estimated more than 100,000 people attended the event, thought to be the largest far-right rally of its type in British history.

Gomez reacted to the ban by posting on X: "I'm coming to England on a boat. They can try to ban me, but they cannot ban the TRUTH. See you May 16th."

Blue Peter Maj! New gong for Charles is the stuff of TV legend

■ King declares himself 'delighted' to receive the award from iconic children's TV show in recognition of his environmental work

HERE'S one I made earlier, Your Majesty... the King was this week presented with a Blue Peter green badge in recognition of the "amazing work" he does to protect nature and the environment.

Joel Mawhinney, one of the current hosts of the world's longest-running children's TV show, gave Charles the shield-shaped award at The King's Foundation HQ at Dumfries House in Ayrshire, Scotland, on Earth Day (Wednesday)

After being handed

the badge to applause from guests including local schoolchildren, the King said: "Oh I say, I'm not sure I deserve this. You're very kind."

Joel replied: "Oh, I think you do deserve this."

Three green award follows Charles and Queen Camilla receiving Blue Peter gold badges in 2023.

Previous recipients of the eco badge include Sir David Attenborough, Greta Thunberg and Prince William.

The King, proud-

ly wearing his gold badge, will appear in a special edition of Blue Peter on BBC and iPlayer next Friday, May 1. His Majesty met young green badge holders taking part in the foundation's Growing Together, Cooking Together and Food for the Future education programmes.

He heard about their innovative ideas to help reduce food waste and protect the planet.

Several of their designs and inventions were sealed inside the foundation's time cap-

sule, to be opened in 100 years' time. It also included a letter from the King, secateurs he used for gardening on the estate and other items that represent the foundation's achievements and legacy.

Joel asked: "Do you recognise much of the stuff inside?"

The King remarked on a "marvellous" painting, believed to be The Kitchen Garden by landscape artist Jo Rance, which represents the organisation's dedication to nature and sustainability.

Charles placed another Blue Peter badge into the box to mark the foundation's 35th

anniversary before locking it with a key, giving it a tap and thanking the iconic BBC show's team for coming.

Later the King hosted a reception for firefighters and other frontline services who tackled a blaze at a Victorian building in Glasgow last month.

UK servicemen fathered almost a hundred children near Kenya army base, BBC reveals

A BBC World Service investigation has found nearly a hundred documented cases of children being fathered by British military personnel near a UK army base in central Kenya.

Legal teams used commercial DNA testing kits and genealogy databases to track down the fathers. Of the 12 cases that have been legally confirmed, some are eligible for Brit-

ish citizenship and child support.

One girl quoted in the British press this week, known only as Kathy, said she had grown up believing her father had died, but as a teenager she found his profile online and asked her mother who he was. That was when she was told the truth. Her father was alive and that he had been a British soldier based near

her home in Kenya.

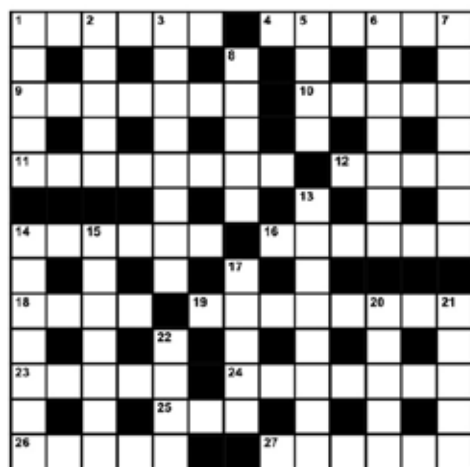
Lawyers in the UK say Kathy is one of nearly 100 cases involving children born near the training base in Nanyuki. Many of those affected described growing up without support and facing discrimination because of their heritage.

Kathy says that for her, the priority is now rebuilding a relationship with her father.

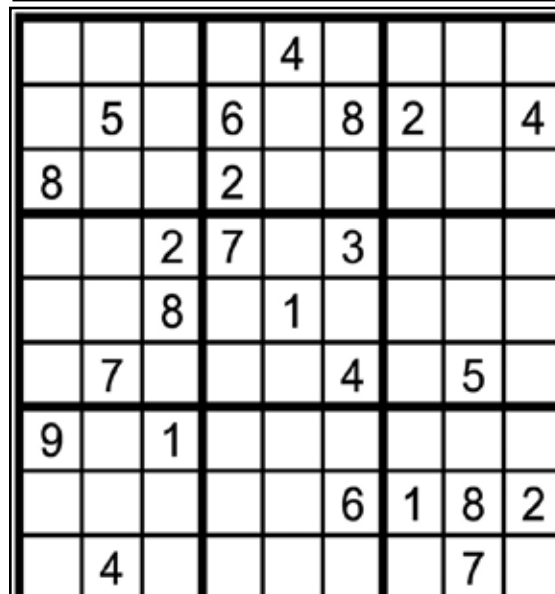

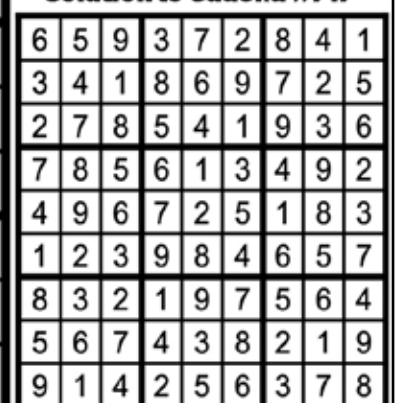

Los Angeles has a British secret, and it's been here since before the Civil War....

Every April 23rd, St. George's Day passes largely unnoticed in Los Angeles. While the world knows St. Patrick's Day as a celebration of Ireland's patron saint, marked globally with parades, pints, and pageantry, fewer people are aware that Britain has its own trio of patron saints: St. David for Wales (celebrated March 1st), St. Andrew for Scotland (November 30th), and St. George for England, whose day falls on April 23rd.

Unlike St. Patrick's Day, which has become a global phenomenon embraced far beyond its Irish roots, these celebrations remain quieter affairs, even among the British diaspora itself. There are no parades shutting down Hollywood Boulevard, no fireworks over the Santa Monica Pier. The patron saint of England gets a quieter salute here. A raised glass at a bar in Santa Monica during a pub quiz or the King's Breakfast, or a knowing nod between colleagues on a Burbank studio lot. And yet, if you know where to look, the British presence in this city is enormous, deeply rooted, and quietly extraordinary.

Los Angeles is home to one of the largest British communities anywhere in the world.

They are writers, directors, musicians, chefs, financiers, teachers, and nurses. They fill the writers' rooms of major studios, headline world tours at SoFi Stadium, run some of this city's best restaurants, and, often invisibly, help power the engine of the en-

ertainment industry that defines Los Angeles to the world. The creative DNA of this city has an unmistakably British strand running through it.

But here is something that almost none of those 200,000 people, and precious few Angelenos, are likely to know. That there has been a charity quietly watching over the British community in California since 1858. Before California was even a decade into statehood. Before the Civil War. Before Hollywood existed as anything more than a dusty agricultural crossroads.

The British Benevolent Society of California is one of the oldest continuously operating charities in the United States. Founded in the Gold Rush era, when thousands of British emigrants flooded west and found themselves far from home with no safety net, the Society was built on a simple, radical idea: that a community looks after its own. That principle has not changed in 167 years.

I serve as Vice President of the Board of Directors, a group of mostly volunteer professionals who take that founding commitment seriously. The charity is lean and deliberate by design, a small team of board members, committee volunteers and ambassadors managing the Society's mission with care and transparency, each case of individu-

al need brought before us for consideration. There is no bureaucracy standing between someone in crisis and the help they need. There is only the question: is this person a British national in California, in genuine distress, with nowhere else to turn? If the answer is yes, we find a way.

What that looks like in practice is as varied as life itself. When the Hollywood writers' strike and industry shutdown left scores of British entertainment workers, many in the country on work visas, ineligible for many federal or state assistance programs, without income or any obvious path to help, the Society stepped in.

Emergency repatriation for those facing homelessness. Document replacement for people stranded without identification. Financial assistance for families struck by sudden loss or illness. Mental health support and safe lodging. These are not abstractions, these are real people living among us in this city, who fell through the cracks and found a hand reaching back.

What makes the Society's position particularly important is a gap that is rarely discussed openly. British nationals living in the United States often do not qualify for the full range of state and federal assistance programs that American residents can access. Visa status, residency requirements, and the complexities of immigration law can leave someone who has lived and worked

and paid taxes in Los Angeles for years suddenly without options in a moment of crisis. The British Benevolent Society exists precisely in that gap.

The British Benevolent Society runs almost entirely on donations and membership fees, a modest \$100 a year, from people who understand that the community they are part of is worth investing in. It asks little. In return, it promises to be there when everything else has fallen away.

This St. George's Day, perhaps it is time to acknowledge it and to support the oldest institution that has been tending it since before this city was a city at all.

Spurs have not won any of their past 15 league games, meaning they are without a top-flight victory in 2026 and have managed only two since 26 October.

They must beat bottom side Wolves on Saturday to avoid equalling the club's worst-ever winless league run - set some 91 years ago, between 1934 and 1935.

By contrast, the form of Spurs' relegation rivals has been picking up.

Leeds have won back-

to the brink of safety, Forest have two wins in their past three games and are unbeaten in five and West Ham have won two of their past five.

Zoom out a little further and the Hammers have taken 19 points from their past 12 games, Forest have 18 from their past 13 and for Leeds it's 18 from 14.

Since beating Palace on 28 December, Spurs have taken six points from 15 matches.

With five games remaining, Spurs will definitely think their run-in, at least on paper, gives them every chance of staying up.

Next up is a trip to Wolves, whose relegation to the Championship was confirmed on Monday night.

A home match against Leeds on 11 May is another Tottenham will view as an opportunity, especially if Daniel Farke's side have beaten Burnley at Elland Road in their previous game and essentially ensured their safety.

Even a tricky looking match at Champions League-chasing Aston Villa on 3 May comes at a good time for Spurs, as it falls between the two legs of the Europa League semi-final for Unai Emery's men.

A visit to rivals Chelsea before hosting Everton on the final day is not a straightforward way to finish given both teams seem likely to be fighting for European places, although the Blues' recent atrocious form and their sacking of manager Liam Rosenior makes that tie look much less daunting.

But given how tight things are, that is something all the relegation candidates will have to deal with.

highest integrity and professionalism following his appointment midway through the season," Chelsea said. "This has not been a decision the club has taken lightly, however recent results and performances have fallen below the necessary standards with still so much more to play for this season."

Sources suggest that Bournemouth manager Andoni Iraola, Fulham head coach Marco Silva, and former Dortmund boss Edin Terzic are under consideration as possible replacements for Rosenior. Iraola, 43, announced last week that he will leave Bournemouth at the end of the season, while Silva's contract at rivals Fulham is due to expire in July. Terzic, meanwhile, was under consideration by Tottenham to replace Thomas Frank when the Dane was sacked earlier this season.

McFarlane, who was Rosenior's assistant, was in charge for a 1-1 draw against Manchester City and a defeat at Fulham in January after previous boss Enzo Maresca was sacked. "As the club works to bring stability to the head coach position, we will undertake a process of self-reflection to make the right long-term appointment," Chelsea added.

Former Premier League defender Gary Neville, reacting to the sacking of Rosenior, told Sky Sports: "Marc Cucurella and Enzo Fernandez, two of the only experienced players, stitched him up in the last few weeks by basically saying they love Maresca. They weren't doing that well under him. I think Maresca is a fine and good coach as well. This policy at Chelsea, this plan, I don't see it. These six-year, eight-year agreements that you see - it's almost laughable from the start."

Burnley 0 Man City 1: Haaland ends Arsenal's 200 days at summit

Manchester City continued their charge towards the Premier League title with victory at Turf Moor Wednesday night to move Pep Guardiola's side top of the table and relegate Burnley back to the Championship.

City have hit form at the right time and are looking in ominous mood, clawing back nine points on Arsenal in less than two weeks to narrowly climb to the summit on goals scored.

Guardiola's men had not been in the number one spot since the opening week of the campaign, but an 11-game unbeaten streak has led to them overtaking the Gunners with five games left.

Top scorer Erling Haaland grabbed the only goal of the night

■ **Chelsea axe Rosenior after dismal run and fifth defeat without a goal**

Liam Rosenior has been sacked following Chelsea's dismal 3-0 mid-week loss at Brighton.

The Blues' US-based ownership group took swift action against the young manager after a run of bad results.

Calum McFarlane will take over at Chelsea as interim manager until the end of the season.

Rosenior signed a five-and-a-half-year deal after arriving from French club Strasbourg, also owned by Chelsea co-owners Todd Boehly and Clearlake Capital. But he managed just 11 wins in 23 matches across all competitions, and Tuesday's 3-0 defeat at Brighton was Chelsea's fifth consecutive league defeat without scoring, the club's worst scoreless run since 1912.



Rosenior: too much, too soon?

Rosenior described the performance as "indefensible" and "unacceptable" after facing angry chants from Chelsea's travelling supporters on the south coast. The defeat led to the Blues slipping to seventh

in the Premier League, seven points behind Liverpool who occupy the fifth and final Champions League spot.
