



Top Labourite quits cabinet - and calls for Starmer to resign

■ **Fallout from dismal local election results grows as Health Secretary says he's lost confidence in the Prime Minister**

Wes Streeting has fired the starting gun on the race to depose Sir Keir Starmer, resigning as Health Secretary on Thursday and warning that the Labour Party - and the country - need new leadership to battle the "dangerous English nationalism" of Reform UK.

Dissatisfaction with Starmer's leadership from within his own party has been simmering for many months, but the catalyst for this new development was Labour's shocking defeats in last week's local elections, where the party lost over 1,100 seats throughout England as well as its 27-year grip on power in Wales. It

finished a distant third in Scotland to the SNP and Reform. Streeting announced his resignation with kind words for the Prime Minister while touting his own achievements within the NHS. He wrote: "The results are in and I am pleased to report that I have delivered against the ambitious targets

you set for me when I became your Secretary of State for Health and Social Care. Today's figures confirm that we surpassed our waiting times target despite strikes, and that waiting lists fell by 110,000 in March - the biggest monthly drop outside of Covid since 2008 - meaning that we are on track to achieve the fastest improvement in NHS waiting times in history.

'road to recovery'

"The only question that matters in government is whether we leave our successors a better situation than we inherited. Ambulance response times for heart attacks and strokes are now the fastest in five years. A&E waiting times are improving, with four-hour waiting figures also the best in five years. We've recruited 2,000 more GPs and satisfaction has risen from 60 per cent to 74.5 per cent since we came to office.

"The National Health Service is the embodiment of all that is best about Britain and our values. Thanks to our La-

bour government, it is on the road to recovery: lots done, but so much more to do. pa

"These are all good reasons for me to remain in post, but as you know from our conversation earlier this week, having lost confidence in your leadership, I have concluded that it would be dishonourable and unprincipled to do so.

'existential threat'

"Last week's election results were unprecedented - both in terms of the scale of the defeat and

the consequences of that failure. For the first time in our country's history, nationalists are in power in every corner of the United Kingdom - including a dangerous English nationalism represented by Nigel Farage and Reform UK. This represents both an existential threat to the future integrity of the United Kingdom, but Reform UK also represent a threat to the values and ideals that have made this country great. " P r o -

gressives across our country understand this threat and our responsibility to confront it, but they are increasingly losing faith that the Labour Party is capable of rising to our historic responsibility of defeating racism and offering hope that Britain's best days lie ahead through social democracy.

"There is no doubt that the unpopularity of this Government was a major and common factor in our defeats across England, Scotland and Wales. Good Labour people lost through no fault of their own. There are many reasons we could point

Leadership challenge will bring 'chaos', says Starmer

■ PM unveils bold new slate of legislation - but will it be enough to save him?

Embattled Sir Keir Starmer has warned his ministers and MPs that a Labour leadership contest could result in "chaos" and only help the rise of Reform UK.

The prime minister sought to rally his quarrelling MPs this week behind a package of new laws aimed at ending "the status quo that has failed working people".

Speaking in the Commons before he met the ministers and MPs, he promised reforms to areas including health, housing and immigration.

On Wednesday eve-

ning, Sir Keir held a series of meetings with Labour MPs and ministers in Parliament, telling colleagues: "We cannot let a leadership contest plunge us into chaos - a challenge would 100% do that."

Ministers told Sir Keir the government needed to act more like insurgents and govern differently, and the prime minister accepted he needed to change.

The legislation announced by King Charles III in the House of Lords included plans to abolish NHS England, to introduce digital ID,

limit trials by jury and end the leasehold system in England and Wales.

There were also proposals to nationalize British Steel, fast-track green energy infrastructure, forge closer trading ties with the EU, and invest in major improvements to rail services in northern England.

Outlining the bills in the House of Commons, Sir Keir said the King's Speech was an "agenda of radical reform across our major public services".

He said he was leading an "urgent, activist, Labour government"

that "tilts power back to workers, renters and the less fortunate, gives voice to the working class, and all those that the status quo has re-

peatedly ignored and dismissed".

The language echoes an attempted reset speech Starmer delivered on Monday, when

the prime minister said "incremental change won't cut it" and promised to "face up to the big challenges" the country faced.

Look out, Reform, there's a new insurgent in town

■ Restore Britain makes waves in Great Yarmouth

THE BIG WINNERS in last week's local election may have been Reform UK, but while the party was comfortably winning seats in many parts of England, it was battered by a locally focused party in a seaside town known for its fish and chips.

Great Yarmouth First (GYF) won all nine seats it stood for on Norfolk

County Council last week.

In each of them it more than doubled the vote of Reform, which surged to 40 seats but was denied an overall majority.

GYF was ultimately the result of an MP's feud with Nigel Farage. The latter had dismissed the party as "a little local difficulty".

So what WTF is GYF? And how is it connected to Elon Musk?

The answer is Rupert Lowe, former Southampton Football Club who won the seat for Nigel Farage's part in the 2024 general election before having a bitter falling out with the party, which alleged he had made physical threats to its chairman,

Zia Yusuf.

Lowe firmly denied the allegations and faced no charges, but ultimately set up his own party - Restore Britain.

Placed firmly on the right, the party says it believes in policies such as low tax, small government and secure borders, promising to "deport all illegal migrants" if it gains power.

Musk endorsement

Other policies include banning the burka along with halal and kosher slaughter, and also "strengthening the teaching of our Christian heritage within national curriculum history modules".

It has been endorsed by the US billionaire and owner of Tesla, Elon Musk, who previously supported Farage.

"It will win. It must win. To Save Britain," Musk posted on X - which he also owns - days after Restore was

launched.

While Restore did not stand any candidates in the local elections, Lowe also set up GYF - which falls under the umbrella of the larger party.

Lowe said he would stand GYF candidates with strong local connections in nine county council seats being contested in and around Great Yarmouth.

Their pre-election pledges included stopping housing developments, rejuvenating high streets and campaigning for better sea defences.

Before voting took place, Farage dismissed

the challenge as "a little local difficulty, it'll blow over".

Instead, GYF blew their competition away.

Each of their candidates received more than double the votes of the second-placed challenger.

In total they secured almost 5% of the total vote in the county council elections, compared with Labour's 10%.

Bear in mind, Labour were standing in 84 seats.

Reform needed 43 councillors for a majority but only secured 40 - Lowe's plan to deny them outright victory had worked.

to: from individual mistakes on policy like the decision to cut the winter fuel allowance to the 'island of strangers' speech, all of which have left the country not knowing who we are or what we really stand for."

Streeting would need the support of 81 MPs to trigger a leadership contest under the Labour Party's rules, but Westminster insiders claim that number was easily reached - and surpassed - as soon as last week's election results became clear.

Come in, Andy?

But Streeting would have a hard time persuading the party's left wing to support him. Their favored candidate is Andy Burnham, mayor of Greater Manchester, whose candidacy is complicated by the fact that he is not even an MP, despite trying to persuade several MPs to stand down for him in recent weeks. His latest hopes are said to be Afzal Khan or Jeff Smith, both Manchester MPs. Khan has said he is focusing on the job but some of his friends believe he is preparing to step aside. If he was to do so, it would be difficult for Burnham to fight a byelection and enter parliament in time for any leadership contest triggered this week. However, there could be huge pressure on Labour's ruling body to delay any contest so that mayor could run.

One Westminster source said: "As usual with Labour, there are plenty of complaints but no workable solutions. They seem willing to risk their largest parliamentary majority in several generations to concentrate their energies - and fire - on each other."

Probe announced into Nigel Farage's £5m gift

■ Did Reform leader break the House of Commons code of conduct?

The Parliamentary Standards Commissioner is launching an inquiry into whether Reform UK leader Nigel Farage broke Commons rules by accepting a £5m gift and not declaring it.

Farage has said he was under "no obligation" to declare the gift from billionaire Reform backer Christopher Harborne because it had been given before he was an MP.

But Reform's opponents say he should have declared it in the MPs' register of interests when he was elected to Parliament in 2024.

The Conservatives wrote to Parliament's standards watchdog, which is now investigating whether the Reform leader broke the House of Commons code of conduct.

'unconditional gift'

A spokesman for Reform UK said: "Mr Farage's office is in communications with the Parliamentary Commissioner for Standards.

"He has always been clear that this was a personal, unconditional gift

and no rules were broken. We look forward to this being put to bed once and for all."

Labour Party chair Anna Turley said: "Nigel Farage has been avoiding legitimate questions since news of his billionaire backer's 'gift'.

"It's right that he faces a proper investigation."

A Conservative Party spokesman said £5m was "more than most people will earn in a lifetime".

"Nigel Farage needs to explain how he got it, why he got it, and why he didn't declare it," they added.

"If there is a simple answer then he should welcome these investigations. But like so often with Reform, there is something very fishy about the whole story."

The Commons code of conduct states that new MPs "must register all their current financial interests, and any registrable benefits (other than earnings) received in the 12 months before their election within one month of their election".

The rules say "purely

personal gifts or benefits" from family or commercial loans would not normally have to be registered.

'inadvertent' gift

The rules also say "both the possible motive of the giver and the use to which the gift is to be put should be considered", adding "if there is any doubt, the benefit should be registered".

MPs who are judged to have broken the code of conduct face a range of punishments from a written or oral apology to suspension from the House or even expulsion, in the most serious

cases.

In January, Farage was found to have failed to register £384,000 in interests on time.

He was allowed to update his register via the "rectification" procedure without sanctions, with standards commissioner Daniel Greenberg concluding it had been an "inadvertent" breach.

The Conservatives have also raised concerns about the £5m gift to Farage with the Electoral Commission, which said it was considering the information.

Harborne, a British cryptocurrency investor who lives in Thailand,

last year gave a single donation of £9m to Reform UK - the biggest to a UK political party by a living person.

In total, the businessman gave £12m to Reform in 2025 and has donated to the Conservatives in the past.

The separate £5m gift to Farage was made in early 2024 and Reform sources say it was made before he had decided to stand as an MP.

Farage has said Harborne gave him the money to pay for his personal security, adding the gift was "purely private" and "wasn't political in any sense at all"

Harry warns of rising tide of anti-semitism

The Duke of Sussex has warned of a "deeply troubling" rise in antisemitism in the UK which has led to "lethal violence" against the Jewish community.

Acknowledging the importance of "legitimate protest" against the actions of a state, Prince Harry said people must be more "clear" about where they are aiming

their anger.

"Nothing, whether criticism of a government or the reality of violence and destruction, can ever justify hostility toward an entire people or faith," he wrote in the *New Statesman*.

There have been a string of attacks at synagogues and other Jewish sites in recent months, includ-

ing the stabbing of two Jewish men in Golders Green, north London, on 29 April.

Pro-Palestinian marches have faced renewed scrutiny, with the government saying antisemitic activity has taken place during the protests as a result of people seeking to sow division.

In an opinion piece titled "my fears for a divided kingdom", the duke wrote: "We have seen how legitimate protest against state actions in the Middle East does exist alongside hostility toward Jewish communities at home – just as we have also seen how criticism of those actions can be too easily dismissed or mischaracterised."

He said "hatred directed at people for who they are, or what they believe, is not protest. It is prejudice"

Prince Harry mentioned the actions of a "state" throughout his piece, but he did not name Israel.

"We cannot ignore a difficult truth: when states act without accountability, and in ways that raise serious questions under international humanitarian law – criticism is both legitimate, necessary and essential in any democracy," the prince wrote.

But he said people who spoke out and protested against such actions must be clear that the "onus falls squarely on the state – not an entire people".

The duke said he had learned from his own "past mistakes", an apparent reference to an incident when he was 20 years old.

In 2005 Harry was heavily criticised because he had worn a Nazi uniform to a fancy dress party with a "Native and Colonial" theme.

Harry publicly apologised for what he did at the time saying it was "a poor choice of costume".

London scrambles to keep opposing marchers apart

■ Unite The Right and a Pro-Palestine group plan to march separately this weekend - the Met hopes to keep it that way

The Metropolitan Police has warned that it is preparing for potential violence and hate speech crimes across two protests in London this weekend.

More than 4,000 officers will be drafted in to police the rival events - possibly one of the largest protest deployment in decades - amid fears that far-right demonstrators could clash with pro-Palestine marchers if the two groups are not kept apart.

In addition, tens of thousands of football fans are also expected at Wembley Stadium for the FA Cup Final, adding further pressures on the capital's police.

facial recognition

Scotland Yard said the risks meant it had to impose the "highest degree of control".

Measures the Met is planning include the first authorization of live facial recognition cameras at a demonstration. The force added it was taking the rare step of putting its armored vehicles on standby.

Drones will also be deployed to scan for suspects, and all officers will be equipped with riot gear.

Tens of thousands are expected to join a "Unite

the Kingdom" event organized by anti-Islam activist Stephen Yaxley-Lennon, better known as Tommy Robinson, as well as at the annual "Nakba Day" Palestinian protest in another part of central London.

Deputy Assistant Commissioner James Harman said he had "significant cause for concern" but the force could not ask for either protest event to be banned.

Under the law, the police can only request the home secretary to stop a march if they do not have the resources to contain a risk of serious disorder.

In this case, the Met believes they can keep both events separate and contained using their "most assertive" powers.

The £4.5m plan includes strict conditions on the routes of both events, making organizers personally responsible for the conduct of speakers on stages and authorizing officers to use enhanced public order powers to stop and search potential troublemakers and disperse them out of central London.

heightened fears

Many of the 4,000 officers called in to police both events are being diverted from normal

crime-fighting duties and 660 are arriving from other forces outside of London.

Harman said that the Nakba Day and Unite the Kingdom events were occurring amid heightened fears among both Jewish and Muslim communities but also in the wake of the national terrorism threat level being raised to its second highest rating.

clashes

"These factors give us significant cause for concern as we head into the weekend and require a policing plan that provides us with the most assertive grip on the movement of large numbers of people, large groups, and the potential for serious disorder and other criminality that may arise as a result," he said.

The first Unite the

Kingdom event staged by Yaxley-Lennon last September drew at least 100,000 to London. While many of those attending saw it as an opportunity to peacefully express their interpretation of British identity, there were a series of clashes with the police and anti-Muslim hate speech incidents.

The Home Office has banned at least seven people from coming to the UK to take part in Saturday's event.

Specialist officers, working with prosecutors, will be on standby to take swift decisions to arrest and charge hate speech crimes. That may include arrests for chants referring to "intifada" at the pro-Palestine march.

"If something is hateful and intimidating we will take action whatever the academic or historical

interpretation of those words," said Harman.

"We have been clear since the outset, we would not accept routes or rally locations that would increase the risk of intimidation to any particular community, or that would risk the two protests coming together."

Harman said the force would "deploy very significant resources" to keep the opposing groups apart "to keep everybody safe".

He added the armored vehicles were "very much a contingency" that had not been used in London for a "significant period of time".

"We will not be using it unless we absolutely have to but it's there to support officers in the face of extreme violence," the senior officer added.

Data says UK's traditional Sunday Roast may be drenched in pesticides

FOR MANY Britons, there's no better way to spend a beautiful early summer Sunday afternoon than to stop for a pub lunch.

A waiter sets down a roast served with carrots, peas, parsnips, potatoes and onion gravy, and then for pudding, strawberries and cream. It feels like the perfect rustic meal to accompany a day in the country.

However, a report by Greenpeace, published on Thursday, has found

that the ingredients of the traditional Sunday roast have potentially been treated with a cocktail of more than 100 pesticides. Data from the Fera pesticide usage survey for 2024, showed 102 – including seven banned in the EU – were used on seven vegetable and soft fruit categories.

Those roast potatoes may have been sprayed with benthialvalicarb, a fungicide banned in the rest of Europe because it causes cancer. They may

have also had a sprinkling of metribuzin, a herbicide, banned because its an endocrine disruptor.

The carrots may have been treated with the insecticide spirotetramat, whose EU approval has expired and can kill bees and fish. Peas are often treated with the herbicide S-metolachlor, which poses risks to mammals and has been implicated in groundwater contamination.

Not only were crops sprayed with a range of

pesticides, Greenpeace found, many were dosed over and over. "Our countryside is being drenched in pesticides, with devastating consequences for bees, birds, butterflies, rivers and the soil," said Nina Schrank, a senior campaigner at Greenpeace UK.

"Fields that once hummed with wildlife are falling silent while agrochemical giants rake in enormous profits and farmers are trapped in a costly cycle of chemical

dependency."

The extensive use of pesticides is devastating the natural world, according to Greenpeace's report. "The signs of nature in decline are everywhere," it said, pointing out stark declines in birds, butterflies and hedgehogs.

Since the end of the second world war, the use of pesticides has become standard practice to eliminate weeds, insects and fungi that get in the way of efficient agricultural production.

Cod slinger counters chippy customers with self-serving tills

Complaints scale up as fish prices keep rising

A fish and chip shop owner says he is installing self-service tills to protect staff from customers with "abrupt" questions about price rises.

Rhys McLoughlin, co-owner of Môr Ffres in Dinas Cross, Pembrokeshire, said there were "lots of questions being asked" and he did not think people understood that "incoming prices are going up and up".

"We have no control over that, so either we work [for] no money, or we follow the price increase and, unfortunately, we have to pass it on," he said.

The average price of takeaway fish and chips rose to £11.17 in March, according to the ONS. In 2019, the average cost was £6.48.

The National Federation of Fish Friers said rising prices had "affected frequency of visits and footfall" in "the majority of [fish and chip] shops".

"The word on the street is cod could actually double in price by September," said McLoughlin.

"That would just be unfeasible for us to even entertain selling it because, ultimately, it's cod and chips. It's not a fillet steak.

"National minimum wage has gone up, oil is going up, the price of fuel," he said, adding that he feared potato costs could also rise "because the price of diesel has gone up".

"If these prices continue to go up, who's going to buy fish and chips for £21? Who can

afford that?"

McLoughlin said he would install digital kiosks where customers can place and pay for their own orders, in part "because it's quite a small building that we've got here and in the summer it does get quite full on".

But he said it was also due to the pressure his staff came under about costs.

"With prices, there's a lot of questions being asked," he said.

"We have got young staff working here and at the end of the day, sometimes this is their first port of business, this is their first stepping stone out of school."

He added: "It's no fun for a boy or girl to come to work to be asked, not abused, but asked prettily abrupt questions on

the spot with 20 people in the chip shop.

"We have actually lost a few members of staff through that."

Sy Crockford, at Marina Fish & Chips in Saundersfoot, said offering the traditional seaside classic at an affordable price had become very challenging.

"Fish alone, we've never seen anything like it. Cod alone has gone up 50%," he said.

"One thing we don't want to do is out-price fish and chips. It's a nostalgia, it's a romance, to come to the beach and have fish and chips, we definitely don't want to outprice."

Crockford said cod

and haddock were becoming "a luxury not a necessity", adding that offering "more sustainable" fish options at a "budget that everyone can afford" could see a change in chip shop menus.

But would customers be open to trying different types of fish?

Nicola Bratherton, 54, visiting Saundersfoot from Northampton, said she "generally would stick to cod" as she's "not that experimental".

Pauline Webb, 71, on holiday from the Midlands, said: "I have realised that [the price] has gone up, but of course, everything is going up.

I know fish has gone up tremendously."

Away from the seaside, chip shops in rural villages are also struggling to justify their prices.

"About a year and a half ago I was paying about £36 a box [of cod]," said Sioned Phillips, owner of Cegin-24 in Crymych, Pembrokeshire.

"Now you're paying between £50, and some places £60, a box for cod."

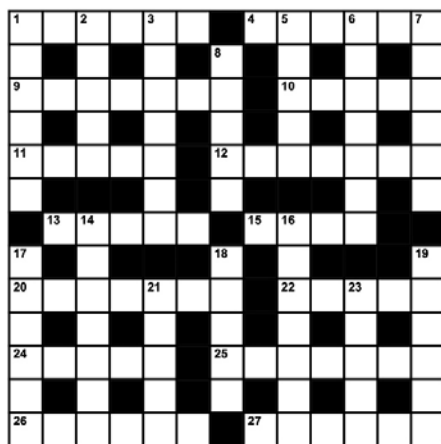
Like many, she's had to increase her prices.

"When I opened, it was £6.95 for a piece of cod. I've had to raise it to £9, and that's being quite reasonable."

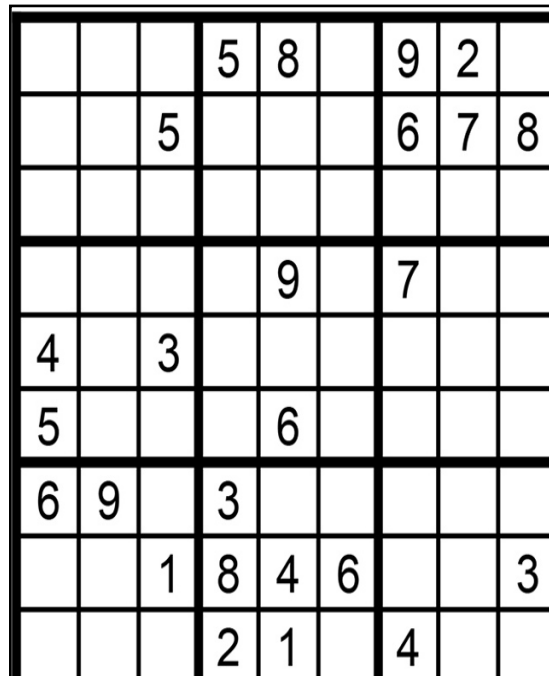

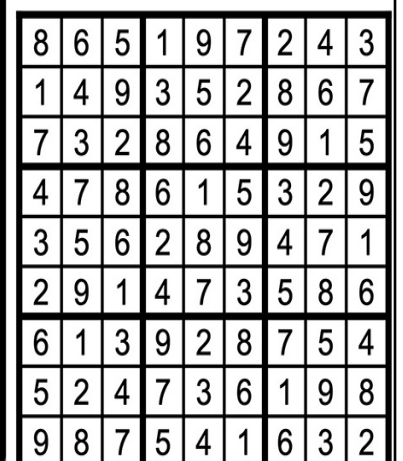

Hymn: Praise-worthy drama

NOW PLAYING at the Odyssey Theatre in Los Angeles, Hymn arrives with an impressive pedigree and an intimate theatrical promise: two actors, a bare stage, and a story built almost entirely on language, rhythm, and connection.

Written by Lolita Chakrabarti — whose stage adaptation of *Life of Pi* won multiple *Oliver Awards* and who also adapted *Hamnet* in London — the play reflects a writer with a remarkable ear for dialogue and a deep understanding of human connection. Under the assured direction of Gregg T. Daniels, this U.S. premiere leans into those strengths, delivering a thoughtful and often moving evening of theatre.

Hymn centers on two men, Gil (Chuma Gault) and Benny (Jason Delane), who meet at a funeral and form an unexpected bond. What begins as casual conversation gradually deepens into something more complex, as both men navigate grief, masculinity, identity, and the quiet ways people try to connect. Chakrabarti structures the play through a series of conversations that feel both naturalistic and heightened, blending humor with emotional honesty.

The writing is unquestionably the production's strongest element. Chakrabarti's dialogue has a musicality — sometimes playful, sometimes probing — that keeps the audience engaged even in the absence of elaborate staging. There's a confidence in the script that allows silence to carry meaning, and when the emotional beats land, they do so

with precision. It's easy to see why Chakrabarti's work has garnered such acclaim; her voice here is intelligent, resonant, and deeply human.

Gregg T. Daniels' direction serves the material well. With only two actors on a small stage, the production relies on movement and spatial awareness to maintain visual interest. The choreography — subtle shifts in position, and carefully staged interactions—works effectively without overshadowing the text. Daniels wisely keeps the focus on the relationship, allowing the dialogue to shine.

Performance-wise, the production is slightly uneven but still compelling. Chuma Gault, as Gil, is sublime. His performance is grounded, nuanced, and emotionally rich, anchoring the play with quiet authority. He listens as well as he speaks, and that presence gives the piece its emotional weight. His accent is also spot on!

Jason Delane, as Benny, is clearly a strong actor, and there are moments where his charisma and instincts come through. However, the accent work is inconsis-

tent and often unconvincing, which becomes a recurring distraction. It pulls you out of the play at key moments, undermining the otherwise strong foundation of the production. It's frustrating because the talent is evident — this feels less like a limitation of ability and more like a lack of fully realized character work. If he continues to work on his accent skills, I'm sure it will get much better with time.

Despite this, the chemistry between the two actors is strong enough to sustain the central relationship, and the emotional core of the play remains intact. When the production connects, it does so with honesty and grace.

The play runs approximately 90 minutes with no intermission, which suits its intimacy and momentum perfectly.

Ultimately, Hymn is a well-crafted, dialogue-driven piece that showcases the power of language and connection. It may not be flawless, but its strengths — particularly Chakrabarti's writing and Gault's performance—make it a worthwhile and engaging theatrical experience.

On Wednesday, Celtic were awarded contentious last-gasp penalty, which Kelechi Iheanacho converted to earn the defending champions a 3-2 victory.

That result, coupled with Hearts' 3-0 win over Falkirk, means Celtic trail by one point going into the final-day showdown.

Robertson will be aided by assistant referees

Calum Spence and David Roome, while Kevin Clancy and assistant Matthew MacDermid will be the VAR officials.

And FoH chairman Gerry Mallon has called for "the highest standards of decision-making" so that the destination of the title is "decided by the players

Harvey Elliott loan spell was 'embarrassing', admits Emery

Midfielder Harvey Elliott's wasted loan at Aston Villa is "embarrassing for everyone involved", says manager Unai Emery.

Elliott, 23, has played only 109 minutes for Villa in the Premier League during a season-long loan from Liverpool.

Villa had an obligation to make the deal permanent for £35m if Elliott played 10 league games, but he has played only four.

Villa wanted Elliott to return to Anfield in January but the clubs could not come to an agreement.

"To now explain about the reason for this

decision is very difficult, or it is easy, but it is not the moment," Emery said.

"My apologies for Harvey Elliott are, every day, in my mind. We have our responsibility and Liverpool have their responsibility.

"How the season has gone has been difficult."

Liverpool played Villa after press time on Friday, with Elliott unable to play against his parent club. The winners will book a place in next season's Champions League.

Elliott's only league start this season came in September - against Fulham, when he was tak-

en off at half-time - and he has not played in the league since February.

Elliott won Euro 2025 with England Under-21s and was named player of the tournament after scoring five goals.

He joined Villa hoping to force his way into the senior team for the World Cup, but under-21 team-mate Elliot Anderson has won seven caps to become a regular under manager Thomas Tuchel.

Elliott has interest from clubs in the Premier League and Europe, but he is not expected to have a future at Liverpool while Arne Slot is in charge.

factor at Old Trafford, with players and fans supportive. He has made Kobbie Mainoo first choice again, after the midfielder did not make a Premier League start this season under Amorim, and a calm media persona has been the antithesis of his predecessor, who could be emotional when speaking publicly. This has convinced the hierarchy that Carrick is the prime candidate, with talks to decide the potential length of his contract, and its terms, rather than his suitability.

Wilcox and Berrada are not thought to be concerned about Carrick's relative inexperience at elite level. By the end of the season he will have managed United in 20 games - 17 this term and three during his previous caretaker spell in November and December 2021. Carrick's success means he has not yet faced a slump in form, but this is not a concern for the executive.

Foden magic sees off Palace

■ Two brilliant assists in 3-0 win signal welcome return to form for England midfielder

Phil Foden's magical first-half assist and welcome return to form was the catalyst that Manchester City

desperately needed to maintain their challenge in this season's fascinating Premier League title race.

The 25-year-old set up the first two goals in Wednesday night's comfortable 3-0 victor over Crystal Palace, to leave Pep Guardiola's side trailing leaders Arsenal by two points heading into the final week of the campaign.

Up until Foden's fabulous backheel for Antoine Semenyo's opening goal, City had looked fragmented and disjointed after Guardi-

ola had taken a chance with his starting line-up by making six changes.

The Spaniard had already been stung earlier this season when he made 10 changes in the Champions League home defeat by Bayer Leverkusen, but leaving out the likes of Erling Haaland, Rayan Cherki and Jeremy Doku on this occasion was necessitated by the forthcoming FA Cup final.

City go into Saturday's contest against Chelsea in the hunt for a domestic cup double and Foden may have played himself into contention for an appearance at Wembley following his impressive showing against Palace.

"I checked a few times before receiving the ball and I saw Ant [Semenyo] make a good movement," Foden said of the opening goal. "It is one of those, sometimes it doesn't come off.

"Sometimes a risk is worth taking and I am very delighted it came off and we scored from it. Buzzing to contribute to a goal and help the lads get three points which is the most important."

Former England midfielder Jamie Redknapp called it the "assist of the season", while ex-City defender Micah Richards added on Sky Sports: "This is why I love him.
