



# BLAIR OPENS FIRE: “Labour has no plan”

■ Without growth there's no cash for leftist policies, former leader tells embattled PM

Sir Tony Blair has accused Sir Keir Starmer's government of having no “coherent plan” for the country and introducing policies that have held back business.

In a highly critical essay, the former Labour prime minister singled out measures including new workers' rights laws, the phasing out of the British oil and gas industry and the above-inflation uplift to the minimum wage.

However, he warned that whether there was a change of leader was “irrelevant if it doesn't start with a policy debate”.

In a response, Pensions Minister Torsten Bell said: “Awkwardly for an essay that argues that policy not politics must come first, is that this is an essay that puts politics not serious policy first.”

### Critique

The essay of more than 5,600 words is Sir Tony's first in-depth critique of Sir Keir's government.

He served as prime minister from 1997 to 2007, winning three general elections in a row during that period.

His essay comes as the prime minister is under severe pressure, following

a disastrous set of election results earlier this month and five ministerial resignations, with a leadership challenge widely expected.

In an interview with BBC Radio 4's Today programme, Sir Tony said he did not think Labour won the last general election “because people read the manifesto and said, this is what we want”.

He suggested Labour should have dropped some of its manifesto commitments when it came into office and prioritized economic growth instead.

### ‘fast-changing world’

“If we carry on like this with these large increases in incapacity benefit, with the triple lock on pensions, we're going to create a situation where economically we're not able to grow,” Sir Tony said.

In his essay, Sir Tony said the government's “principal problem” was not “Keir's personality” or “a failure to communi-

cate ‘our achievements’”, which have often been pointed to as weaknesses of the PM.

He wrote: “It is because we don't have a worked-out coherent plan for the country in a fast-changing world and are in the wrong political position from which we can devise one and win a second term”.

However, he added: “Trying to force the prime minister out before we know what policy direction we're bringing in, is not a serious way of conducting ourselves.”

While Sir Tony said he agreed with some of the government's policies, including investment in infrastructure, reform of the planning system and reducing trade friction with Europe, the former PM said other commitments were “unwise to proceed with” given the current economic circumstances.

He pointed to new workers' rights laws, which have faced criticism from some business

groups who argue they will discourage companies from hiring and hit economic growth.

Sir Tony also criticised the decision to increase National Insurance for employers “Then, in the last Budget, it appeared as if we were increasing tax to pay for additional welfare spending, when the public already thinks welfare bills are too high,” he said.

### ‘rehash’

“Taken together, these measures have given headwinds not tailwinds to British business despite the macroeconomic gains for which the chancellor is rightly praised.”

He called on the gov-

ernment to try and limit the effect of these changes and remove parts of the net-zero agenda “which prioritise clean energy over cheaper energy”.

On the UK's relationship with the European Union, Sir Tony said “Britain has lost from Brexit” and “at some point it is ripe to enter a debate about ‘going back’.”

Wes Streeting, who resigned as health secretary earlier this month in protest at Sir Keir's leadership and has confirmed he would stand in any contest, recently argued that the UK should rejoin the EU one day.

However, Sir Tony said: “Just as Brexit was never the answer to Britain's

challenges back in 2016, reversing it isn't the answer to the country's far worse situation in 2026.”

He also appeared to take a swipe at Andy Burnham, the Greater Manchester mayor who is seeking a return to Westminster as Labour's candidate in the Makerfield by-election.

Burnham has repeatedly said Britain had been “on the wrong path for 40 years”.

In his essay, Sir Tony scoffed at those who voiced “a rehash of the far-left critique about nothing good coming out of the last ‘40 years’ of ‘neo-liberalism’, which presumably includes the last Labour government”.

# FRIENDS NO MORE: Musk and Farage split over Reform rival

■ Ahead of crucial by-election, billionaire throws support behind Restore Britain

**TESLA boss Elon Musk and Reform UK leader Nigel Farage are engaged in a bitter row over the billionaire's support for right-wing rival party Restore Britain.**

It comes as recent polling suggested that Restore could take 7% of the vote in the upcoming Makerfield by-election, with figures close to party leader Rupert Lowe predicting it could be much higher.

Mr Farage has accused Space X CEO Mr Musk, the world's rich-

est man, of trying to divide the right in the UK by supporting Mr Lowe.

Restore Britain has fielded a candidate for the Makerfield seat who is standing on a series of policies including mass remigration and increasing the availability of energy.

## backlash

It comes as polls suggest Reform candidate Robert Kenyon and Labour's Andy Burnham are neck-and-neck to take the seat on June 18.

Tech tycoon Mr Musk

shared a post by Mr Lowe on his social media platform X, on the subject of the by-election, accompanied by the comment: "Restore Britain."

It prompted a furious backlash from Mr Farage, who was once supported by Mr Musk before a spat with Mr Lowe – then one of his MPs – led to his ejection from Reform UK.

Mr Musk then disavowed Reform UK and threw his support behind Mr Lowe's outfit.

Mr Farage said that

Mr Burnham would be "delighted" with the entrepreneur's backing for Restore in Makerfield.

He added: "Elon Musk has decided he will try to split the right of British politics as best he can. This is supporting a party that's one man with a social media account. Quite what he's trying to achieve, I have no idea."

Mr Lowe shared on the social media platform that his party was "under brutal assault" by the establishment who "want us gone". He added: "They've already tried to put me in prison. It will all keep coming. It is going to get a lot worse the more support we gain. The establishment is getting very nasty. Good.

It shows we are making progress.

"Elon Musk backing Restore Britain sends a clear message that real change is possible and the establishment is losing control. Makerfield will show Britain the way. We're not here to patch up a broken system, we are here to restore our country."

## British hostage couple held in Iran 'at breaking point'

■ Pair have been detained in Iran since January of last year

**A British couple detained in Iran are at "breaking point", their son said this week.**

Lindsay and Craig Foreman went on hunger strike in May after their phone access was "cut off".

The pair were detained in January 2025 by Iranian authorities - widely viewed as an attempt to get leverage over the UK government.

Lindsay's son Joe Bennett said he feared that they would continue to refuse food "indefinitely".

"My mum and Craig

are now risking their lives... because they feel they have run out of other options," he said.

"Hunger strikes are not symbolic gestures. They are acts of desperation."

"They have been pushed to breaking point," Bennett said.

"Their only agency is to take control of the one thing they can - their body."

Craig is believed to have entered his 20th day of refusing food on Thursday, while Lindsay was on her 11th day after previously pausing the strike.

Bennett said it was unclear what the Iranian and British sides were negotiating over to secure their release.

"There may be a solution that they [the government is] aware of that they aren't talking about," he said.

"We can't give them [Craig and Lindsay] any positive updates. That's the hardest thing."

The release of British-Iranian nationals Nazanin Zaghari-Ratcliffe and Anoosheh Ashoori in 2022, who were detained

# Broiling Britain's Baking Bank Holiday

■ Records smashed as Mercury rockets to 94F - but cheese rolling ritual bubbles on...

BRITS hoping for some sunshine on the spring Bank Holiday got more than they bargained for as record heat baked the country this week.

Kew Gardens in southwest London saw the mercury top 94 degrees, making it the warmest May day ever, smashing an 82-year-old landmark.

It was also the hottest bank holiday in history, eclipsing August 2019's

high of 91.

But the heat was no hurdle for those drawn like bees to honey to a chunk of cheese sent hurtling 600ft down Cooper's Hill in Gloucestershire, chased by fans from around the world.

In barmy and uniquely British scenes of chaos and competition, it was each human for themselves as they ran, staggered and possibly ended up rolling too as they

tried to nab that coveted prize.

Some dressed up for the occasion as superheroes, some wore bubble wrap.

But it was German YouTuber Tom Kopke, 24, who won the men's race, completing a hat-trick of successive triumphs and fending off a challenge from British 23-time champ Chris Anderson.

## Family tribute after tragic water death of 12-year old

■ Experts warn of cold water shock as Junior Slater is just one of nine who die trying to cool off during the heatwave

A FAMILY have paid tribute to their 12-year-old boy who died trying to cool off in a river.

Junior Slater was one of nine people to have died in open water during this week's heatwave.

He entered the River Ribble near his home in Clayton le Woods, Lancs, on Tuesday as UK temperatures soared to a May record of 96F.

He got into difficulty and his body was recovered from the water after a search involving Lancashire Police's underwater search unit, fire crews and paramedics.

On Wednesday his

family said: "Our little blue-eyed boy will be truly missed. He was the life and soul of our lives."

The Royal Life Saving Society has issued a plea for people to "stop and think" before getting into rivers, canals, reservoirs and lakes.

It warned "warmer weather unfortunately correlates to an increase in accidental drownings" and that water temperatures remain very cold.

Declan Sawyer, 15, died after getting into trouble at Swanholme Lakes in Lincoln on Sunday, and a woman of 72 died at West Angle Bay

beach in Pembrokeshire.

Reco Puttock, 13, died at Leadbeater Dam near Halifax, West Yorks, on Monday, as the body of a 16-year-old girl - named by her school as Lillianna Tomlinson - was recovered at Kingsbury Water Park, Warwickshire.

Also on Monday, Phil Crow, 68, died of cardiac arrest after entering the sea at Tregirls Beach, Padstow, to help two family members in difficulty, Devon and Cornwall Police said.

The body of a teenager was recovered from the water at Rother Valley Country Park in the early hours of Tuesday,

### 'bucket list item'

But the Army veteran was consoled by seeing his son William, 11, who clearly shares his dad's love for a bank holiday tradition thought to date back more than 600 years, win the first children's uphill race.

The women's event was won by French-woman Alix Heugas, 27, who lives in Bishop's Stortford. She

wore a onesie and said she did not have a strategy but added: "I thought it was a great bucket list item to have."

The Met Office said: "This heat would be exceptional in mid-summer - let alone May."

Relief, fun and ice creams could be found at the seaside as day trippers set their sights - and sat-navs on the likes of Bournemouth, Bognor,

Brighton and Blackpool, with record crowds ramming local beaches.

Bookies Ladbrokes' odds have now shortened on 2026 bringing a long, hot summer that will be the warmest on record.

However, the heat brings risks and sadly fatalities too, with at least nine water-related deaths attributed to the high temperatures.

South Yorkshire Police said.

A body was also found in the search for a teenager who went missing after he was last seen swimming at Hawley Lake on the Hampshire/Surrey border on Tuesday.

And Cheshire Police said the body of a 17-year-old boy was found after he went missing in Pickmere Lake at Marston, Northwich.

The RNLI has warned of the "very real risk" of swimming in open

water as the record for May's highest daily minimum temperature was provisionally broken for a third night in a row.

Some 1,128 Channel migrants have arrived during the hot spell, bringing the total for the year so far to 8,704.

in Iran for years, came after the UK settled a £400million tank debt with Iran's government, though British officials never confirmed the link.

Bennett, from Folkestone in Kent, says the couple feels "abandoned" by the Foreign Development and Commonwealth Office (FDCO).

While he says he recognises diplomacy is often invisible and difficult, he has accused officials of not showing any "proactive thinking" or trying "alternative approaches" to secure their release.

"There does not seem to be any sign of progress, just inertia," Bennett added.

The FCDO said Britain's Ambassador to Tehran, diplomats and officials in London have provided consular assistance since the Foreman's arrest last year.

A spokesperson said ministers had met the family and set out "how unjustified and appalling" Lindsay and Craig's incarceration was, alongside the action the government was taking.

"We will continue working to ensure that Craig and Lindsay are returned safely to the UK," they added.

Craig and Lindsay, who are currently detained in Tehran's notorious Evin Prison, have been repeatedly misled and denied proper access to legal support and basic welfare items, according to their family.

The couple, from East Sussex, were sentenced in February to 10 years in prison over espionage charges - something the family denies.

"I feel a weird type of grief...You're grieving someone that you miss but that is still alive, Bennett said, adding: We just want them home".

# Estranged husband of former First Minister admits stealing £400,000 of party funds

■ JK Rowling among many to mock Nicola Sturgeon's claims of ignorance of Murrell's misdeeds

**PETER Murrell, the estranged husband of former Scottish First Minister Nicola Sturgeon, was behind bars this week after pleading guilty to embezzling more than £400,000 from the Scottish National Party.**

The SNP's chief executive for 22 years splashed thousands of pounds on luxuries using money taken from party funds.

Murrell looked gloomy as he stood in the dock at the High Court in Edinburgh to admit fleecing Scotland's governing party before leaving in handcuffs.

His estranged wife insisted she had "no knowledge or suspicion whatsoever" that Murrell was "using SNP funds for personal purposes".

### 'breach of trust'

She said she was "utterly appalled" he had done so, adding that she "could not begin to understand why". The ex-SNP leader added her reaction to the guilty plea was "difficult to put into words".

Murrell, 61, pleaded guilty to embezzling £400,310.65 from the SNP between August 2010 and October 2022.

He admitted using the money to buy items including a motorhome and luxury goods, and putting it towards the purchase of two cars.

A list of hundreds of other purchases includes designer kitchenware, pairs of shoes, expensive pens and a £1,200 telescope. Murrell's crime was called a "terrible breach of trust" and an "overwhelming betrayal" by current party leader and Scottish First Minister John Swinney.

Posting on Instagram,

Ms Sturgeon said she was "angry, hurt, sad and very distressed about the impact of his actions on family, friends and the SNP".

The former party leader, who stepped down as an MSP in this month's Holyrood election said: "To be deceived and let down by a husband I loved and trusted has caused me acute pain.

"Why he acted as he did is, and always will be, beyond my comprehension."

### 'part-time job'

But Ms Sturgeon's words were greeted with derision by many, not least JK Rowling, who took to social media to ridicule her claims of ignorance.

Ms Rowling, 60, made barbed comments online, saying: "Every other day a new motorhome appears in my mother-in-law's drive", adding her partner "hands me another bucket full of jewellery and cosmetics. I can only assume he's got himself a part-time job I'm too busy to ask about".

The former first minister's claim was further addressed by Prime Minister Keir Starmer, who said there are "questions that need to be answered" about the revelations.

Sir Keir said that "anybody looking at what's happening up in Scotland will be baffled that those at the top of the SNP say they didn't know anything about what was going on".

### 'lack of curiosity'

Senior figures in the SNP now want an independent probe into the misappropriation of funds.

Former SNP MP Joanna Cherry accused

Ms Sturgeon of having shown "a remarkable lack of curiosity" over concerns regarding party finances, and called for an independent inquiry. She added: "Nico-

la Sturgeon is very keen to paint herself as the victim here."

Ms Sturgeon, 55, was arrested as part of the police investigation into the party's finances but

later told she would face no further action.

The former SNP leader announced she and Murrell had decided to end their marriage in January last year.

# Tartan Trek: Scotsman crosses USA on foot to raise mental health awareness

A Scottish mental health campaigner has entered the final stretch of a more than 2800 mile journey across the United States.

Craig Ferguson, from Paisley, is walking coast to coast from Santa Monica Pier in California to Boston on the aptly-named Tartan Trek, in order to raise funds for the Scottish Action for Mental Health.

Aiming to raise £1 million for the charity, Craig began his journey on February 24, and has completed the equivalent of a marathon every day, all in a kilt.

So far, he has travelled through California, Nevada, Utah, Colorado, Kansas, Missouri, Illinois, Indiana, Ohio and Mary-

land.

Now, the campaigner has arrived in Washington DC, leaving just 450 miles left on his journey to Boston.

Craig said: "Arriving in Washington DC feels surreal. "Mentally and physically, I'm exhausted - there are days where every single mile hurts - but knowing there's now less than 500 miles to go gives me a huge lift."

The Tartan Trek has been marked by extreme weather and punishing terrain, but Craig said it is the people he has met along the way who have kept him going.

Strangers have offered water and encouragement, while others have spoken about their own mental health experiences.

Many have also shared stories of their Scottish heritage, finding common ground with Craig and his kilted walk across the States.

Craig said: "This journey has tested me in ways I never imagined, but the kindness of people across America has honestly been overwhelming.

"So many people have stopped to share their own stories around mental health, and those conversations stay with you.

"One moment that really hit me recently was meeting a woman with dementia whose granddaughter later told me she kept talking about 'the Scottish boy walking across America'.

"Hearing that genuinely meant a lot

and reminded me why this challenge matters beyond the fundraising total.

"We've now raised more than £170,000 which is incredible, but there's still a long way to go to hit that £1 million target for SAMH.

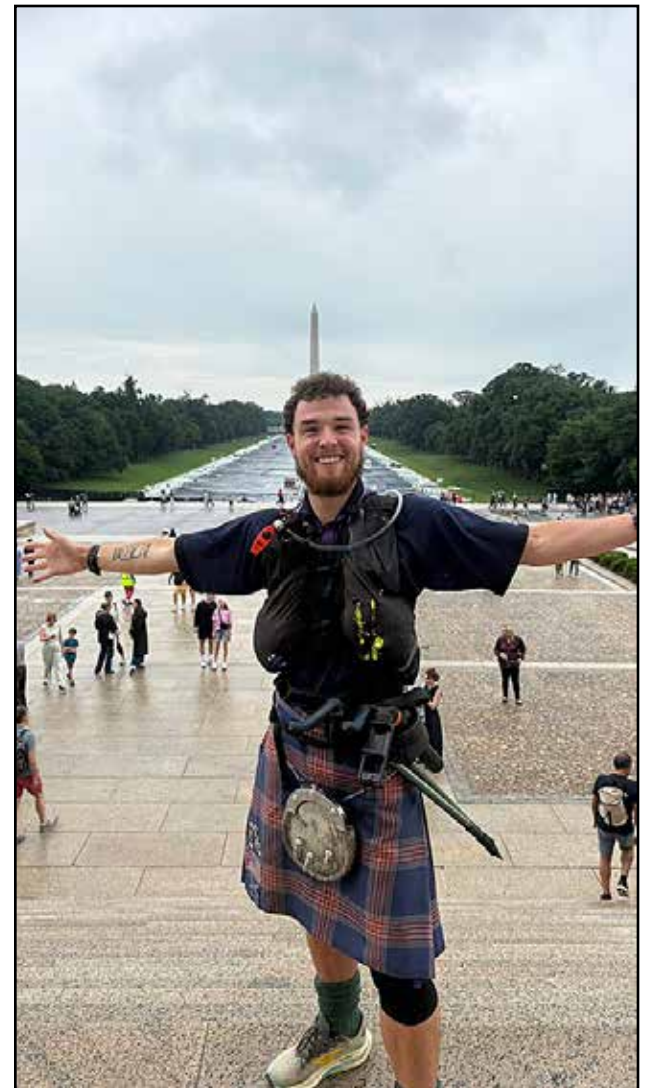
"Being this close to Boston is exciting and emotional in equal measure - and I'm determined to finish strong."

Craig is expected to arrive in Boston in time for Scotland's opening match at the FIFA World Cup.

Hazel McIlwraith, director of fundraising and major appeals at SAMH, said: "What Craig has achieved already is nothing short of extraordinary.

"Walking 2800 miles across the United States while raising awareness of mental health and more than £170,000 for SAMH is a phenomenal accomplishment.

"Craig's openness, resilience and ability to connect with people from all walks of life is helping spark im-

portant conversations around mental health both in Scotland and internationally.

"With the finish line now in sight, we'd encourage anyone who has been inspired by Craig's journey to support the Tartan Trek if they can.

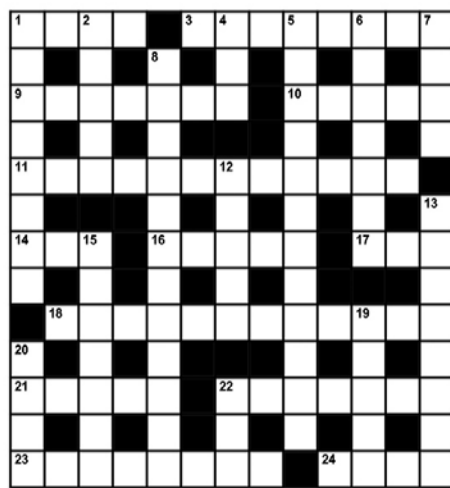

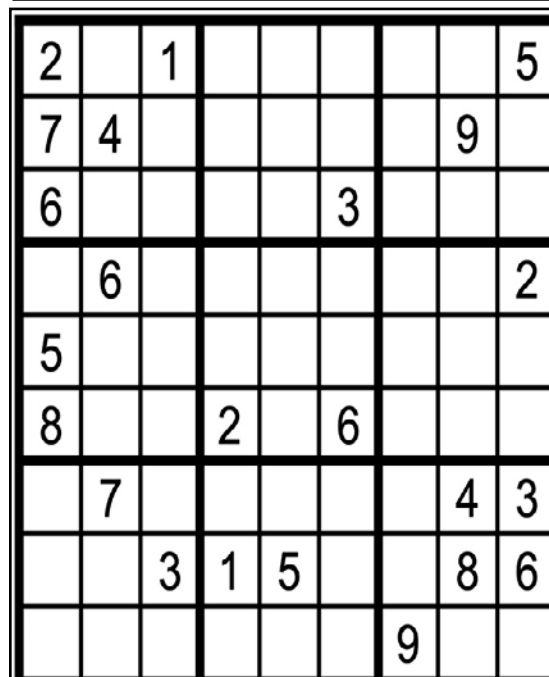

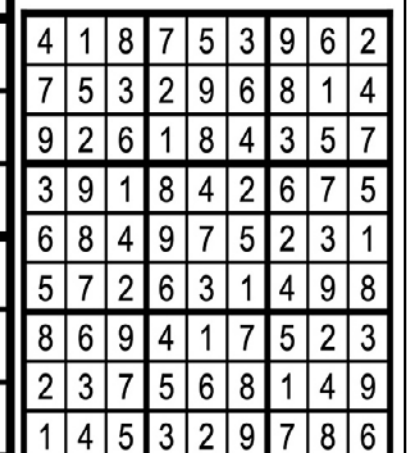

## Greater Together: UK flies in the big guns in biggest-ever trade mission to US

BRITISH BUSINESS, cultural and political bigwigs swarmed LA en masse last week as "Greater Together", the UK's biggest-ever trade mission to the States, put on a blinding showcase highlighting the Best of Britain during a four-day blitz.

Riding high after King Charles's historic address to Congress, the UK Government struck while the iron was hot with a mega-event packing over 250 British financial, tech and creative heavyweights to turbocharge growth and transatlantic ties.

The bash, joint-led by Culture Secretary Lisa Nandy and Economic Transformation Minister Blair McDougall, bagged serious corporate backing, including heavy hitters American Airlines, British Airways, PwC UK and TSL.

Fresh off a star-studded chartered BA flight to Los Angeles carrying Nandy and Sir Gareth Southgate, Nandy kicked off proceedings by declaring: "The UK's creative industries, sporting heritage and world-class tourism are brilliant national assets - and Greater Together LA is a cracking chance to flaunt them globally.

"From tunes and films to sport and arts, this delegation will show off the massive cultural and commercial clout the UK brings to our US partnership. "I'm well keen to deepen those links and unlock fresh doors for British talent and creativity."

Greater Together LA zeroed in on bagging hard commercial results across the government's Modern Industrial Strategy sectors, aiming to clinch fresh growth wins following last year's record-breaking £150 billion investment haul.

Co-hosted by Sir Lucian Grainge and Apple design guru Sir Jony Ive, the shindig featured speakers like Simon Cow-



ell, singer Leona Lewis, Sir Paul Smith, scientist Dr Katie King, WPP boss Cindy Rose, astronaut Major Tim Peake and ambassador Sir Christian Turner, alongside top academics and the chief execs of British Airways, News Corp and American Airlines.

Things kicked off with a glittering bash at the Academy Museum of Motion Pictures on Tuesday night. Fizz and margaritas flowed alongside chats about bilateral trade rules. Right in the thick of it, Southgate mingled with guests while London musician Arlo Parks spun a DJ set. This was Britain doing what Britain does best abroad: flashing soft power with charm, celebs and pure cultural cachet.

Among the most popular guests were Christian Turner, Britain's man in Washington, and ex-NFL star Osi Umenyiora. But while Turner offered a bullish, stats-heavy defence of the UK-US relationship - reminding folks that trade between the two nations tops \$430 billion a year - it was Umenyiora who unexpectedly became the philosophical heart of the summit. Born in Brit-

ain and raised partly in Nigeria before heading to America, he described the US as a place psychologically wired for ambition.

"There's a promise there that if you graft hard, you can achieve anything," Umenyiora told the room.

"There seems to be no ceiling."

He contrasted this with Britain's built-in knack for caution and self-limitation. It was a critique that hit home with the British founders in the room, many of whom quietly admitted they envy America's cultural swagger just as much as its market size. David Abrahamovitch, the boss of top UK coffee chain Grind, noted that the main thing he was bringing back from Los Angeles wasn't a signed deal, but a psychological shift.

"We bloody well need a big dose of US optimism and national pride," Abrahamovitch said. "I'm sick of how much we talk ourselves down."

Yet as seen last week, Greater Together proved that when we pull our fingers out, we Brits can hawk our wares with the absolute best of 'em.

Enzo Fernandez wants to leave Chelsea after they failed to qualify for Europe, but the club will ask for £120m for the Argentina midfielder.

The 25-year-old (right), who joined The Blues from Benfica in 2023 for £107m, is under contract until 2032, which is reflected in the potential fee.

The World Cup winner

remains part of the club's planning for next season, but Chelsea would consider offers that meet their valuation.

After scoring 15 goals and providing seven assists last season, Fernandez finished runner-up in the club's player of the season award.

Javier Pastore, Fernandez's agent, is exploring potential destinations,

notably his preferred option of Real Madrid.

Alternatives include Manchester City - who are expected to appoint former Chelsea coach Enzo Maresca as Pep Guardiola's successor in the coming days, but their priority is signing Nottingham Forest midfielder Elliot Anderson.

Meanwhile, French

club Paris St-Germain have downplayed the likelihood of a transfer despite having been linked with a move.

Real are known to be unwilling to pay Chelsea's asking price unless they are able to raise significant funds in player sales, having also been linked with a move for Manchester City midfielder Rodri.



# Palace move for Iraola?

The glory of Wednesday night's euphoric Conference League win in Leipzig won't fade for some time for Palace supporters.

But for those at the heart of the club, the planning for next season will accelerate with almost immediate effect.

The first task at hand is to appoint a new head coach.

Andoni Iraola is the man Palace want to replace the outgoing Oliver Glasner, who insisted after the triumph in Germany he has no plans to reverse his decision.

They have made the Spaniard a proposal and are awaiting his answer, within that are assurances he will be permitted significant influence over the recruitment operation.

It is understood Palace want an answer by the end of the weekend.

The move is ambitious. Iraola has emerged as one of the brightest managers in European

football - Bournemouth's qualification for next season's Europa League illustrative of his impressive body of work.

"We have got a taste for it now, we want to keep it going," said owner Steve Parish following the win over Rayo Vallecano.

"We have gone up a level and we have got to try and stay there. We will have a week to celebrate and then work hard in the summer."

Palace believe they have done all they can to convince Iraola they can provide the platform for him to continue building his reputation.

All that is left is Iraola's approval.

# Spurs close to Robbo deal

Spurs are close to agreeing a deal with Scotland full-back Andy Robertson following his departure from Liverpool.

The 32-year-old played his final match for The Reds against Brentford on Sunday, having announced he would leave the club when his contract ends this summer.

Details remain to be finalised on the deal with Spurs but an agreement is in place in principle.

Spurs, then managed by Thomas Frank, targeted Robertson during the January transfer window.

A deal was agreed between the two clubs, only for Liverpool to pull out when they were unable to recall Kostas Tsimikas from his loan

at Roma.

Spurs secured survival on the final day of the season by beating Everton under new manager Roberto de Zerbi.

The vastly experienced Robertson, who also has 92 caps for Scotland and will lead his country at this summer's World Cup, played 378 times for Liverpool and won two Premier League titles and the Champions League.

placed finish in the Premier League. This deal will enable the Magpies to reinvest in the transfer market, even after taking into account Everton's sell-on clause. Everton are in line to receive 15% of any profit Newcastle make on Gordon after selling the academy graduate in a deal worth up to £45m in 2023.

Gordon always felt the likeliest of Newcastle's key players to depart and the club's top scorer was even left on the bench for the final four games of the campaign because head coach Eddie Howe had an eye on the future. Supporters in the away end briefly sang Gordon's name following the 2-0 defeat at Fulham on the final day in what proved a farewell.

Newcastle are set to lose their top scorer for the second summer running after selling Alexander Isak to Liverpool for a British record £125m on deadline day.

# Eagles flying high!

■ Glasner steps down in style as Palace clinch Europa Conference trophy - their third piece of silverware in little more than year

Jean-Philippe Mateta fired Crystal Palace to their first European trophy Wednesday night as the Eagles edged out Rayo Vallecano, 1-0, in the Conference League final.

The France striker turned home a close-range winner on the rebound from an Adam Wharton strike early in the second half in Leipzig.

Outgoing Palace boss Oliver Glasner leaves the club having led them to the FA Cup, Community Shield and now Conference League in a remarkable two-and-a-half-year spell at Selhurst Park.

Both teams were competing in their first European final and so the cagey start to proceedings at Red Bull Arena - the

home of RB Leipzig - was perhaps unsurprising.

Alemao turned a half-decent opportunity wide before Unai Lopez placed an effort past the post in the Spanish side's best opportunities of the first half.

But the clearest chance of the opening 45 minutes fell to Palace just before the break, when Tyrick Mitchell headed wide after Wharton had found him with a superb ball into the box.

Palace took the lead just six minutes into the second half when Wharton's strike was palmed into Mateta's path by Rayo goalkeeper Augusto Batalla and the forward diverted it into the net.

It was Mateta's 16th goal of the season for Pal-

ace - and he almost left the club in January before a knee injury scuppered a move to AC Milan.

Jeremy Pino then hit both posts with a free-kick before teeing up Mateta for another chance, but this time Batalla pulled off a fine save.

Rayo, who have the lowest budget in La Liga, struggled to create any real chances late on as Palace held on for their historic moment - and delivered for Glasner in his final game as Eagles boss.

It has been a turbulent campaign, but Glasner bows out in style and will go down as one of Palace's greatest managers.

They had never won a major trophy until last season's FA Cup success against Manchester City -

and now have two in two seasons after this glorious night, while they also picked up the Community Shield by beating Liverpool.

## Gordon seals Barca switch

Barcelona have agreed a deal worth more than £69m with Newcastle United for England forward Anthony Gordon.

The clubs were reportedly in advanced talks last week as they looked to agree a fee, which reports now suggest has been struck worth in excess of £69.3m. Gordon will now finalize the formal-

ties of his move before he flies out with his England team-mates to the United States for a training camp before the World Cup.

Bayern Munich also held formal discussions with Newcastle, but there was a gap in valuation between the two clubs and it was Barca who ended up making an acceptable bid.

Newcastle chief exec-

utive David Hopkinson made it clear they would only sell players on "our terms" in March. The club were in a strong position to command a premium for Gordon, whose contract does not expire until 2030. Newcastle need to trade to rebuild this summer, particularly after a disappointing 12th-
