# GRIEF. RAGE. VIOLENCE.

- **Outrage over police handcuffing dying student, 18, after he was knifed five times**
- **Religious fanatic with a 'weapon obsession' told officers he was the victim**

**BRITAIN'S** growing anxiety about race relations, tolerance of religious extremism and so-called 'two-tier' policing exploded into violence this week as the tragic case of Henry Nowak was splashed across the nation's front pages.

In a case which has shocked the public and provoked angry scenes both on the street and in the House of Commons, it emerged that police handcuffed a dying 18-year-old university student on suspicion of assault - allegedly because they were 'blinded by a modern diversity culture' that allowed a brutal killer to play the victim.

### alone and unarmed

Tragic Henry Nowak, described by his heartbroken family as "kind, hard-working, and exceptionally inclusive," was walking home from a night out with his football team in Southampton city centre last December when he crossed paths with 23-year-old Vickrum Digwa. Henry, who was completely alone and unarmed, noticed Digwa carrying a large, eight-inch ceremonial Sikh dagger, known as a kirpan.

In a brief interaction that would cost him his life, Henry innocently asked Digwa if he was a "bad man" - likely after spotting the terrifying

blade. Interpreting the question as "disrespect," Digwa launched into a savage, frenzied assault, stabbing the helpless teenager five times.

### 21 year sentence

But the horror did not end there. As Henry lay bleeding to death on the pavement, his cynical killer immediately fabricated a defense. When Hampshire Police officers arrived at the scene, Digwa claimed he had been the victim of a "racially motivated attack," falsely alleging that Henry had knocked off his turban and injured his eye.

Shockingly, responding officers swallowed the attacker's narrative hook, line, and sinker.

Harrowing body-camera footage - newly released following Digwa's sentencing to life imprisonment with a minimum of 21 years - shows police handcuffing and arresting the gravely wounded student. In scenes that will cause nationwide fury, Henry can be heard repeatedly gasping that he has been stabbed and cannot breathe.

Instead of administering immediate first aid, one officer coldly replies: "Don't think you have, mate."

By the time the officers finally recognized the catastrophic severity of Henry's injuries, removed the handcuffs, and initiated CPR, it was tragically too late. Henry died in state custody, triggering a landmark Article 2 human rights inquest into whether police actions or omissions contributed to his death.

### firestorm

The lead officer on the scene has since resigned, while three others remain active on the force.

The revelation has ignited a political firestorm over the institutional paralysis gripping British policing. Critics say officers are now so terrified of being labeled racist that they prioritize policing language over saving lives. Reform UK leader Nigel Farage seized on the shocking footage to blast what he called "two-tier policing," asserting that an unverified accusation of a racial slur was treated with

far more urgency than a visible, bleeding mortal wound.

Even Downing Street has been forced to act. While Prime Minister Keir Starmer urged public calm, his administration was forced to admit that controversial police

diversity guidelines - which explicitly instruct officers not to be "color-blind" - now require an immediate, urgent review.

Meanwhile, public fury boiled over into localized violence in Southampton, resulting in ugly

clashes that left 11 police officers and a police dog injured. Home Secretary Mahmood also revealed that internet trolls had misidentified an unrelated officer online, forcing them into emergency relocation after receiving

# American duo cite criticism of Israel as their visas are pulled

■ Cenk Uygur and Hasan Piker banned from entering UK  
 ■ Left-wing pair were due to speak at SXSW London

Two left-wing content creators have been blocked from entering the United Kingdom after they said the Home Office revoked their visas.

US citizens Hasan Piker, who is a Twitch streamer and political commentator and Cenk Uygur, who co-founded and hosts left-wing populist show "The Young Turks" on YouTube, were both due to speak at the SXSW London festival and an event in Oxford.

The pair have blasted the UK government, claiming they were "banned for criticising Israel".

## Are we free anymore?

Piker has come under fire for making pro-Hamas comments while Uygur has called Israel's actions in Gaza "barbaric". The Home Office declined to comment.

Posting on X, Uygur said: "I've been banned from the UK.

"I tried to get on a flight to London to attend SXSW London and give a speech at Oxford. I've been banned for criticising Israel. Are we

free any more?

"This is oppression of western citizens by our own governments on behalf of a different country."

Replying to this post, Piker wrote: "The UK has revoked my visa as well. All at the behest of Israel. The west is betraying 'liberal values' for a genocidal fascist foreign government. Soon we will all become Israel."

## 'hate and division'

It is understood that both men had their Electronic Travel Authorisation (ETA) cancelled.

A decision to cancel an ETA can be based on assessment of the potential risk someone might pose to the UK public good.

Labour MP David Taylor, who last week called for Piker to be barred from entering the UK, thanked the home secretary for the decision.

"There's no reason to open our doors to those who seek to spread hate and division, especially to those who've supported a proscribed terror group," Taylor wrote on X.

SXSW London is a six-

day event in East London's Shoreditch that holds talks about business, technology, music, film and culture.

A spokesperson for the event said they were aware the pair were unable to travel to the UK because of the Home Office revoking their visas.

"Decisions on entry to the UK are a matter for the Home Office and the individuals concerned. SXSW London's role is to convene a broad range of diverse voices and perspectives."

"We remain focused on delivering a programme this week fostering open dialogue and exchange of ideas and featuring more than 800 speakers, artists and screenings," the spokesperson added.

## 'consequences'

Piker has a daily audience of 30,000 for his hours-long streams on the Twitch platform, according to a profile on the SXSW London website, which has since been taken down.

He was listed at an event called "How The American Left Learned To Speak The Internet".

Uygur was scheduled to be part of a discussion called "Techno-Feudalism Is Here. Who Are The Lords?".

Other comments from Piker include a 2019 statement that "America deserved 9/11" which he later acknowledged was inappropriate.

He also stood by com-

ments saying Hamas was "1,000 times better" than Israel and he "would vote for Hamas over Israel every single time" in an episode of Pod Save America.

Piker, who is Uygur's nephew, told Variety last year that he was not antisemitic but is "anti-Israel".

The Community Security Trust, a Jewish community group, said in a statement that it welcomed the decision to bar Piker from entering the UK and "the government's recognition that there must be consequences when public figures cross the line into hate speech".

death threats.

The case has also sparked a fierce legislative debate. It emerged that Digwa had a documented "weapon obsession" and had previously been reported to police by his local temple for stealing £1,000 worth of ceremonial blades, though no charges were brought. Donna Jones, the Police and Crime Commissioner for Hampshire,

has now written to the Prime Minister demanding a national review of Offensive Weapons Act exemptions that allow bladed articles to be carried in public for religious reasons.

The legal fallout continues to spread. Digwa's mother, Kiran Kaur, 53, has also been convicted of assisting an offender after she callously removed the murder weapon from the crime scene. She faces sentencing in July, while the CPS has authorized further charges against

other family members. The Attorney General is also considering reviewing Digwa's 21-year term under the Unduly Lenient Sentence scheme.

On Wednesday, Henry's grieving father, Mark Nowak, made an emotional plea on the steps of the court, begging the public not to co-opt his son's name for hate. "We do not want his death to be used to create further division, hatred, or tension," he said. "We want his story to help make our streets safer for everyone."

# North London turns red!

## ■ Hundreds of thousands line the streets as Arsenal celebrate first title in 22 years

For the first time in 22 years, Arsenal are the Premier League champions - and the players, staff and fans got to celebrate on Sunday with an incredible bus parade through the streets of north London.

With hundreds of thousands of people lining the streets, Arsenal's men's and women's sides took in the adoration of their supporters during a two-and-a-half-hour five-mile loop, which started and finished at the club's Emirates Stadium.

Fans were not allowed immediately next to the ground but the supporters, some of whom had been there since the early hours of Sunday, finally got to see their heroes after the four buses went over a bridge, which had the words 'This belongs to all of us' painted on the ground. The first bus had the Arsenal men's team on board, with Arsenal's women's side, who became world champions when they won the Women's Champions Cup in February, on the third

bus.

The other two buses were full of club staff as well as family members. One of the most impressive sights was when a huge tifo - which had been unveiled before November's north London derby against Tottenham and had the words 'The Arsenal - These streets are our own' on it - was again displayed along the bus route.

Mikel Arteta's side had finished second in the Premier League in each of the previous three seasons, before ending up as champions in 2025-26. At one stage on Sunday, Arsenal midfielder Declan Rice mocked the critics that have said the club have been too reliant on set-pieces to score goals by grabbing the microphone and chanting 'set-piece again, ole, ole'.

Ben White spotted the opportunity to get Rice involved in a singalong and played 'Ice, Ice Baby' on the speaker, but Rice said "I'm not singing!".

He didn't take much convincing and belted out

the lyrics of the Vanilla Ice hit - to the delight of the Gunners fans.

He told Sky Sports: "I love this team, I love the manager. To see the joy we can give people, it's crazy. But next year we're coming back for more."

"This is crazy," said captain Martin Odegaard before singing along and waving a scarf as red smoke from flares filled the streets of north London.

Arsenal finished seven points clear of Manchester City to become English champions for the 14th time, but for the first occasion since 2003-04 when Arsene Wenger's 'Invincibles' won the Premier League without losing a game.

The parade took place only one day after the Gunners had narrowly missed out on creating club history when they lost 4-3 on penalties to Paris St-Germain in the final of the Champions League. After it had finished 1-1 at the end of extra-time, Eberechi Eze and Gabriel both missed penalties in the shootout.

The Duke and Duchess of Sussex have shared two new photos of their daughter, Princess Lilibet, as they celebrate her fifth birthday.

The first image was of the couple smiling and embracing while Prince Harry holds Lilibet, and the second is of the princess with her hand on a flower in a garden.

"Our dream girl. Happy 5th birthday, Lili," Meghan wrote on Instagram.

Lilibet is the couple's second child and is two years younger than her brother Archie.

Meghan recently called Lilibet "Mama's

little helper", after posting an image of them in what looks like a walk-in wardrobe, where the duchess is trying on a coat while her daughter is crouched down nearby.

The latest images of the princess come two weeks after the duchess celebrated the couple's eighth wedding anniversary, with a series of photographs of them from their big day.

Last month, they revealed they are to make a film based on a true story of British troops under siege during the Afghanistan war.

The couple's pro-

duction company, Archewell, is developing a feature film for Netflix based on the book No Way Out by Major Adam Jowett.

It comes after their relationship with Netflix was watered down last year.

After their previous contract ended last summer, it was replaced by a "first look deal", which gives Netflix first refusal on any new proposed shows from the duke and duchess.

In April, the duke and duchess completed a four-day visit to the east coast of Australia in a private capacity as they

## Gazza Italia '90 is still best-selling retro shirt

A FOOTBALL shirt worn by Paul Gascoigne and the England team at Italia 90 is Britain's top-selling retro style ahead of next week's World Cup.

The design was famously seen on Gazza as he wept in frustration after being booked during the semi-final clash with Germany.

It won him a special place in the nation's hearts despite England subsequently crashing out of that World Cup in a penalty shoot-out.

Retail experts say the size of the retro market has doubled since the 2022 World Cup amid record demand.

And Sports Direct, which revealed the 1990 shirt is its No1 seller, said England's Euro 96 shirt, worn by the likes of Gareth Southgate, is also a big hit.

So too is the 2004 England shirt, seen on David Beckham and team at the Euros in Portugal, and Scotland's 1996 shirt worn by stars such as Gary McAllister and Colin Hendry.

Sports Direct and retro shirt maker Score Draw are celebrating the 2026 tournament with a campaign called When Football Was Football.

Its host, Chris McClure's football manager character Steve Bracknall, said: "There is nothing quite like a World Cup.

"Families pile round the telly, mates end up in the pub together and suddenly everyone becomes an expert of formations.

"It brings people together. It taps into the feeling of pride, excitement and togetherness that only football can do."

# Three dead in Devon chopper crash

■ Royal Navy personnel were on training exercise in a Merlin Mk4

Three Royal Navy personnel have died in a helicopter crash during a training exercise in Devon.

Emergency services were called to Sourton Down, near Okehampton, early Wednesday morning after a Merlin Mk4 crashed.

A Royal Navy spokesperson said it was "with deep sadness that we can confirm three members of the Royal Navy have died during a helicopter training exercise".

### 'utterly tragic'

They added: "The families of the service personnel have been informed and have requested a period of grace before further details are released. Our thoughts and sympathies are with their families and friends at this sad time."

Prime Minister Sir Keir Starmer said on X that the fatal crash was "utterly tragic" and his "thoughts are with the families, friends and

loved ones of the three members of the Royal Navy who sadly lost their lives".

Head of the navy, General Sir Gwyn Jenkins said: "I know this will come as a huge shock to all in our naval community, and my deepest condolences go out to the families, friends and loved ones impacted by this tragedy."

He confirmed that the helicopter was a Merlin Mk4, which are known to be based at RNAS Yeovilton in Somerset.

He also thanked Devon and Cornwall Police and the search and rescue teams who responded to the crash.

The Merlin helicopter entered service with the Royal Navy in 1999. There are two versions in use, the Mk2 and Mk4.

Merlin Mk2 helicopters are based at RNAS Cudrose in Cornwall with the Merlin Helicopter Force, which operates 30 Mk2s. This version is primarily an anti-submarine helicop-

ter.

Merlin Mk4 helicopters are based at RNAS Yeovilton in Somerset with the Commando Helicopter Force, which operates 25 Merlin Mk4 helicopters for the Royal Marines.

### 'sounding not right'

Military helicopters often train in the area around north Dartmoor, which lies between the air bases at Yeovilton and Cudrose.

Witnesses at the scene

said they heard noises that sounded like "troubled mechanics" as a helicopter flew over.

One described it as "sounding not right" as it flew over his house and said "it almost took the roof off" his home.

The scene is also close to Okehampton battle camp, a military facility on the edge of Dartmoor which has been used for training Merlin helicopter crews from the Commando Helicopter Force.

In September 2024, a Merlin Mk4 ditched in the Channel during a training exercise, killing Lt Rhodri Leyshon.

In March 2004 a Merlin crashed at RNAS Cudrose in Cornwall. Two men were trapped in the aircraft and later flown to hospital. Three other crewmen on board were also hurt in the incident.

In October 2000, a Royal Navy Merlin helicopter ditched off Skye. Five crew were rescued.

## Magistrate who suggested 'a good hiding' for abusive defendant sanctioned

A magistrate has been sanctioned after suggesting that he would give a "good hiding" to a defendant who was shouting abuse in the dock while being jailed.

Essex Judge Paul Gibson told investigators the defendant was being abusive towards him and his fellow magistrates and filming them on his phone.

Mr Gibson told the probe he had reacted to this behaviour by saying that if the defendant was "anything to do with me I would give him a good hiding", according to a published misconduct ruling.

He claimed the comment was addressed to his fellow magistrates rather than to the person in the dock.

### 'lost his composure'

But Mr Gibson was disciplined by the Judicial Conduct Investigations Office after a complaint was made over his response to the defendant's court outburst.

Investigators found he had "briefly lost his composure while dealing with a difficult and stressful situation". The incident was raised again in open court when the defendant mounted an appeal.

This had the effect of "extending awareness of the conduct to others present and therefore increasing the impact on public confidence in the magistracy and the seriousness of the incident", the ruling said.

It added: "Mr Gibson said he had allowed himself to be provoked by the defendant, and the difficult and stressful nature of the hearing, and by the fact that he was fearful for his colleagues and himself.

"He said that this had led him to make the statement.

"He apologised for his actions and said that

on reflection he had let himself down badly."

Mr Gibson has now retired as a magistrate but he remains on the supplemental list.

### least severe

He previously oversaw criminal court cases as part of the South East Essex Bench.

A nominated committee member of the South-East Region Conduct Advisory Committee concluded that Mr Gibson's actions amounted to misconduct and recommended the sanction of "formal advice".

This is the least severe

of four possible sanctions for misconduct by judicial office-holders, with removal from office being the most severe.

Senior judge Mr Justice Keehan and Lord Chancellor David Lammy agreed on the sanction for misconduct which was imposed on Mr Gibson.

The published ruling does not say at which court the outburst occurred, or when it happened.

It also does not set out the sentence handed to the defendant, and does not reveal whether his later appeal was successful.

**FIFA U-turn as reusable water bottles banned from World Cup venues**

Spectators will not be allowed to carry reusable water bottles into World Cup venues owing to safety concerns, Fifa has said, after a last-minute change to its stadium code of conduct.

The governing body had earlier permitted empty, transparent, reusable plastic bottles inside stadiums but said the updated code prohibited that. Other items such as bottles, cups, jars and cans are also banned to prevent the risk of injury if thrown.

"Fifa is committed to protecting the health and safety of all players, referees, fans, volunteers, and staff," it said. "Fifa made the decision to prohibit bottles to prevent risk and injury to players and attendees.

"Outside bottles are already prohibited at several of these venues for safety considerations and Fifa is applying this consideration across its tournament stadiums."

The move has raised concerns among supporters about coping with heat, with temperatures at a few venues expected to range between 82 and 90 degrees, and access to drinking water inside stadiums.

Fifa said measures would be in place to deal with the conditions. "Fifa works closely with each host city committee and local authorities on heat mitigation factors for fans travelling to the stadium, which can include resources such as misting stations, fans, hydration stations, cooling tents and more around the stadium footprint," it said.

"Inside the stadium footprint, pricing for water bottles for the Fifa World Cup 2026 will remain consistent with other events held at each stadium."

The Free Lions England fans' group posted on X: "What next? Sun cream banned and fans forced to buy it in stadiums?"

The singer also has a palatial home in the Italian countryside.

But he prefers to spend as much time as he can in his Suffolk home, which boasts two on-site pubs.

"He said, 'Yes, I miss the curry because there is no curry like this there'.

"That's amazing, we feel very proud."

Mitu said he asked Sheeran if he would permanently move his family across the pond, but Sheeran responded with: "No Mitu, this is my home, this really is my home."

The singer is often spotted at Portman Road attending Ipswich Town games and grew up in Framlingham.

Mitu said his staff loved meeting him

whenever he visited and his children even met him several years ago.

The staff even once made rapper Stormzy a curry when he was visiting Sheeran in Suffolk. "He's very friendly, like a normal customer," Mitu continued about Sheeran.

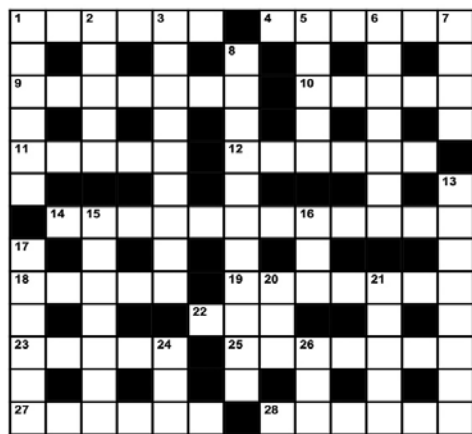
"Even when he comes to the restaurant and it's full of customers, he just says, 'If anyone wants to take a picture, I will take it'.

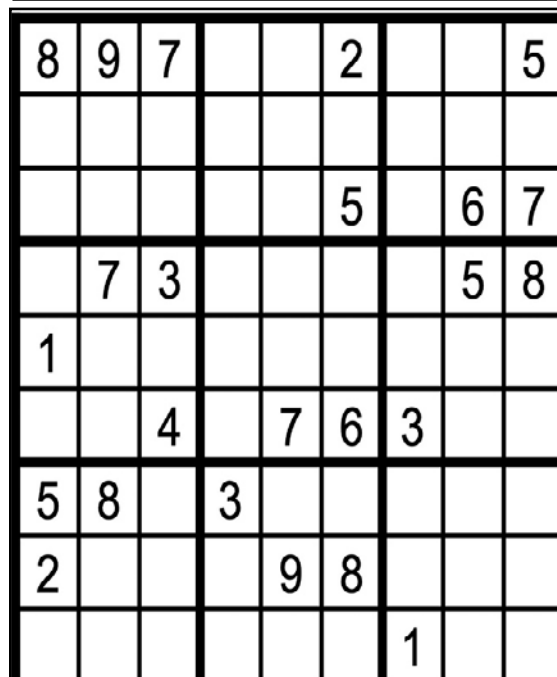

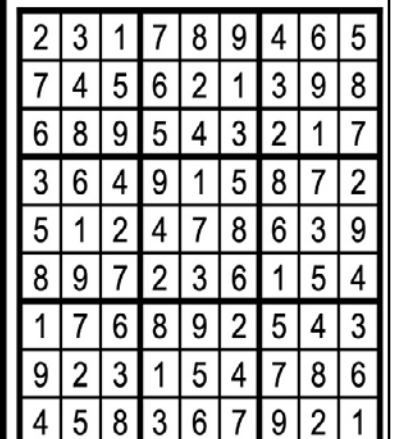

"We had a nice catch-up. It was probably more normal than people would think – just like your friend calling you up, for example, and asking how you're getting on.

"But, yeah, it was really special."

And McTominay has warned Scotland's World Cup rivals they are not there to make up the numbers.

He added: "There's no time to be shy. You have to take challenges like this head-on, and you have to really think about goals and achievements."

# 24 years later, James Milner finally hangs up his boots

■ Veteran midfielder made his debut as a 16-year-old way back in 2002

JAMES Milner has finally brought the curtain down on a career all future footballers should aspire to having themselves.

One which saw the Premier League legend wring the maximum out of the talent he had been given.

Milner was good enough to pursue a career in professional cricket while growing up in Leeds.

But the multi-talented Milner chose football instead – and cricket's loss was the gain of the national sport.

Milner, now 40, went on to spend almost a quarter of a century operating at the highest level.

He made his debut for Leeds in 2002 at the age of just 16, and at the time was the second-youngest player to play in the Premier League.

Milner went on to play for Swindon, Newcastle, Aston Villa, Manchester City, Liverpool and Brighton, making a record 658 top-flight appearances, winning

13 major trophies, including the league and Champions League titles with Liverpool.

He also won 61 England caps and represented the Three Lions at four major tournaments.

He retired from international football in 2016 – Gareth Southgate asked him to reconsider when he took charge but Milner refused in order to prolong an exemplary club career.

The midfielder's longevity will now go down in history, and it owes much to the fact Milner never touched a drop of alcohol, never gave any of his many managers a single problem, and never took what he had for granted.

En route to Miami for the 2014 World Cup in

Brazil, he was asked if he would consider breaking his alcohol ban should the Three Lions win the trophy.

With a deadpan reply, Milner just said, "No, why would I do that?"

Milner became a cult figure on social media after someone created a parody account called 'Boring James Milner', in reference to him being a bit dull.

He took no exception and in later life embraced it as he found it amusing.

He also never forgot his roots, and is said to have paid for a new clubhouse to be built at Horsforth Cricket Club, where he played as a kid.

Milner lasted so long he played alongside Lee Clark and then his son

## City consider Real legal action over Haaland claim

Haaland's father Alfe Inge and agent Rafaela Pimenta said in their joint statement: "All very entertaining but not true.

"We wish all the best for both candidates in the Real Madrid elections."

If all goes to plan, Liverpool will appoint and present Iraola before the week concludes.

The Athletic reported earlier on Tuesday discussions with Iraola have been led by sporting director Richard Hughes, who knows Iraola well having appointed him as Gary O'Neil's successor at Bournemouth in the summer of 2023.

During his three years in charge at Bournemouth, Iraola oversaw 12th, ninth and sixth placed Premier League finishes, as well as securing Europa League qualification for the first time in their history.

It's no surprise that Liverpool's talks with Andoni Iraola have advanced so rapidly with a verbal agreement now in place.

When Arne Slot was sacked last Saturday, senior Anfield figures were determined to make a swift appointment and the Spanish coach was always their first choice for the vacancy.

With Iraola keen to take on the challenge after parting company with Bournemouth, it was simply a case of agreeing personal terms and sorting out the make-up of his backroom staff.

There is no time to lose with so much to be addressed at Anfield this summer. There are some glaring gaps in the squad following the departures of Mohamed Salah, Andy Robertson and Ibrahima Konate as free agents. For others such as Curtis Jones and Harvey Elliott, the future is uncertain as they enter the final year of their current deals.

# ARTETA WANTS MOR!

■ **Gunners boss keen to cement his team as EPL top dogs by signing star Villa midfielder**

Arsenal are expected to act quickly and decisively in the upcoming summer transfer window to solidify their position at the top of English football.

Gunners sporting director Andrea Berta and manager Mikel Arteta have already identified the areas of the squad that need improvement once the window opens on June 15.

Arteta made it clear after the Champions League final defeat to PSG last weekend that they must recruit well in order to defend their Premier League title next term and go one step further in securing their first European title.

Josh Kroenke, the son of Arsenal's billionaire owner Stan Kroenke, has echoed that ambition in recent weeks. And, according to reports, he could hand the Gunners

a sum potentially exceeding last summer's record £250million outlay in an effort to maintain their success.

Morgan Rogers is reportedly open to leaving Aston Villa this summer as he continues to be linked with an Arsenal move. The Gunners are keen on the England World Cup star as they looked to bolster their attacking options.

Rogers, 23, has become Villa's best player over the past few seasons, meaning they are unlikely to want to part ways with the midfielder, especially given that they will play Champions League football again next season.

But, in a major boost to Arsenal's prospects of landing the former Manchester City talent, Rogers believes it is the right time for a fresh challenge. Despite this,

he is not actively pushing for a move away just yet and Villa could demand up to £100m for their talisman, meaning a deal isn't necessarily straightforward.

Arsenal are also reportedly in talks to sign teenager Jeremy Monga from Leicester City. Monga, 16, made his Premier League debut as a 15-year-old during his breakthrough 2024/25 season, making him the second-youngest player to do so after Ethan Nwaneri at the time.

He made 30 appearances across all competitions for the Foxes this term while racking up over 1,000 minutes of senior football. Monga has also signed his first professional contract, which will take effect when he turns 17 in July. But it is expected he will move on this summer, given Leicester's relegation to
