# COME IN, ANDY?

## ■ Burnham could replace Starmer within three weeks

Labour's ruling body has set out the timetable for electing a new party leader which could see Sir Keir Starmer's replacement installed as early as 17 July.

The schedule means Andy Burnham could take over as prime minister from Sir Keir in less than a month, if he continues to be the only MP to enter the race.

Potential candidates have from 9 July to 15 July to collect the backing of 81 MPs and until 16 July to gather the required number of nominations from affiliated bodies such as trade unions, in order to stay in the contest.

If only one candidate meets that threshold, the new leader will be announced at a special Labour conference on 17 July, before being appointed PM by the King.

If more than one MP is able to garner enough support to progress to the next stage, a ballot of Labour party members

and affiliated supporters would take place between 6 and 27 August.

Under that scenario, the final result would be announced on 29 August.

### no rivals

Burnham confirmed his intention to stand shortly after Sir Keir stepped down as prime minister on Monday. There had been suggestions that senior minister Darren Jones or former Armed Forces minister Al Carns could try to stand – however Jones has ruled himself out and Carns is yet to confirm if he will make a bid.

Former Health Secretary Wes Streeting had previously said he would throw his hat into the ring, but gave his backing to Burnham on Monday.

Burnham has also received backing from cabinet ministers including Chancellor Rachel Reeves, Foreign Secretary Yvette Cooper, Education Secretary Bridget Philipson and Health Secretary James Murray. It is looking increasingly likely that Burnham will gather so many nominations no other Labour MP will be able to stand.

Sir Keir has said he wants an "orderly" transition of power

and has authorised civil servants to meet prospective Labour leadership candidates to help them prepare for government.

### 'zombie government'

Despite announcing his resignation, Sir Keir will stay as prime minister until a new Labour leader is elected.

Earlier, his official spokesperson denied that the administration is now a "zombie government".

"The prime minister and all ministers remain in office and the normal business of government continues," the spokesman said.

Donald Trump has given his first public reaction to Andy Burnham, describing him as an "extremely liberal" politician who "probably won't open up" the North Sea for further oil and gas drilling.

He also labelled the former Greater Man-

chester mayor, as "the mayor of a town".

Burnham's team have declined to comment on the US president's remarks.

Trump's intervention underscores that the question of how to handle the US president would be one of the great challenges of Burnham's premiership.

As mayor of Greater Manchester, he has generally avoided commenting on foreign policy.

# Broiling Britain!

■ UK sees its two HOTTEST EVER June days as Met Office issues red warnings and emergency services struggle to cope

Sweltering Britain has suffered through its two hottest June days ever recorded. The mercury rocketed to 98.1°F (36.7°C) on Thursday afternoon, breaking a previous record set just 24 hours earlier.

This historic high was recorded at Merryfield, Somerset, according to provisional figures from the Met Office, marking it as the hottest June day on record.

All four of the UK's nations recorded their highest temperatures of the year so far on Thursday:

**England:** Merryfield's 36.7°C high surpassed the 36.1°C recorded in Gosport, Hampshire, on Wednesday, which had broken a long-standing June record set in both 1976 and 1957.

**Wales:** Recorded its highest temperature of the year and hottest

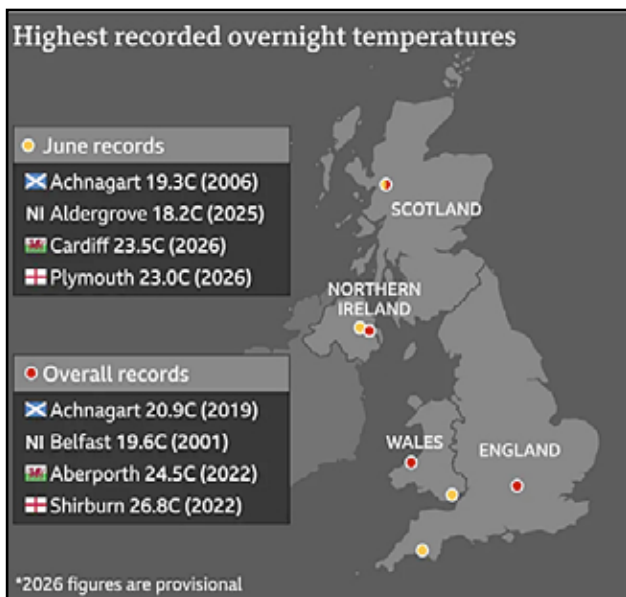
ever June day with a provisional temperature of 96°F in Bute Park, Cardiff. Previously, the highest June temperature in Wales stood at 92°F, recorded in 2000.

**Scotland:** Recorded its highest temperature of the year in Threave, Dumfries and Galloway, reaching 87°F.

**Northern Ireland:** Recorded its highest temperature this year with 86°F in Castlederg, County Ty-

rone.

A rare red warning for extreme heat, which warns of danger to life, is currently in place across southern, central, and western areas of England, as well as parts of Wales. While conditions were expected to improve slightly by the weekend, the Met Office stated that the public should expect population-wide adverse health effects "leading to serious illness or danger to life."

Substantial changes in working practices and daily routines are required, alongside a high risk of failure for heat-sensitive systems, power loss, and transport delays.

## Amber Warnings

Regional Warning: A wider amber warn-

ing is also in place in Wales, southern England, the Midlands, and parts of northern England, with areas as far north as Manchester expected to see temperatures climb above 88°F.

## NHS Impact

The intense heatwave

has disrupted emergency services, closed schools, and wreaked havoc on public services and essential infrastructure. At least six NHS trusts in England have declared critical incidents as they grapple with the surge.

## Government mulls legislation to promote 'trustworthy news content'

■ Concern grows about disinformation on social media

GROWING concern about the influence of fake news on social media platforms has prompted the government to launch a consultation on ways of giving greater prominence to what it describes as 'trustworthy news content', which might include, amongst others, local news websites and public service broadcasters such as the BBC, ITV and Channel 4.

Culture secretary Lisa Nandy explained she feels there's a "generational information gulf."

"There's lots of things on the internet that you can't trust," Ms Nandy said this week. "There's people putting things onto the internet that are not true, and it can be very difficult to find the good things that you know that you can trust. Now we think it's wrong

that parents and grandparents can find things they trust because they're watching it on the television, but children can't because they're watching it on their tablets and phones.

"It is vital that we make sure that people have better access to trusted and accurate news and that our regulated public service media is seen and heard in the fierce battle against mis and disinformation.

"As the media landscape moves further and further online away from traditional broadcasting we must act so that our world-leading TV sector continues to thrive and top quality UK content keeps being produced.

"TV remains at the heart of our society. It is key to supporting social cohesion and is a cornerstone of our democracy,

which is why, as the technology underpinning it changes, we are making sure it is protected for generations to come."

A consultation under British parliamentary procedure is a process of inviting people - including consumers, suppliers and health care professionals - to share their views on an issue to help inform decision-making ahead of legislation being introduced.

The process for deciding what content providers are to be deemed trustworthy has yet to be determined.

In the UK, around 40% of people get some or most of their news from social media.

Globally, it is now the number one source for news. But what that news is, is determined by algorithms devised by tech firms.

# And it's goodbye from him: PM steps down with dignity and melancholy

■ Less than two years after guiding Labour to an historic election victory, Starmer announces resignation as party leader

Sir Keir Starmer announced his resignation as Labour leader on Monday, heralding the end of his time in 10 Downing Street.

He has said he will stay on as UK prime minister until his successor is in place.

The news capped months of growing speculation about Sir Keir's position as his party grew increasingly concerned about what was seen as his uncertain leadership, embarrassing policy U-turns and his apparent inability to stem the rise in popularity of Reform UK, which has enjoyed a strong lead in the opinion polls since last year.

But bad poll ratings were not Starmer's only problem: there was a series of damaging revelations over his decision to appoint Peter Mandelson as his US ambassador last year, and his bad run culminated in elections to the Welsh and Scottish parliaments, as well as local councils in parts of England, in May. These were billed by gloomy Labour MPs as a last chance for him to prove he could turn things around.

## simmering row

In the end, the results were devastating, prompting Wes Streeting to resign as health secretary, as well as a clutch of more junior ministers.

His standing ebbed further when a long-simmering row behind the scenes over defence spending prompted Labour stalwart John Healey to resign as defence secretary earlier this month.

And once Andy Burnham, mayor of Man-

chester and firm favorite among the party's left wing, was elected as the MP for Makerfield in last week's by-election, the writing was clearly on the wall.

After repeatedly taking the temperature of his own party and finding his support ebbing away, Starmer made the decision to step down over the weekend.

## 'good grace'

Stepping into the bright June sunshine outside No. 10 on Monday, with his wife Victoria by his side, Starmer told reporters: "The question my party is asking now is whether I am best placed to lead us into the next general election. I have heard the answer of my parliamentary party to that question, and I accept that answer with good grace.

"I will do everything I can to ensure an orderly handover of power. I will also give my successor my full and unequivocal support."

"Walking up this street two years ago was the proudest moment of my life. A new Labour government, the first in 14 years, a page in our country's history turned after years of disappointment and despair.

"When I leave the biggest job in the country, I shall spend more time on the most important job. Being the best husband I can, to my fantastic wife, Fig, who has been a rock by my side through good times and bad, and being the best dad I can, to my beautiful children, who are my pride and my joy. Thank you very much."

Newly elected MP for Makerfield Burnham,

looks almost certainly to replace Sir Keir next month, but his seemingly inevitable coronation will not be without controversy.

Reform UK called for an immediate general election. Party leader, Nigel Farage, said the public deserved to give their opinion.

## 'just not working'

"Whoever becomes the prime minister will not have been voted for by the British public. And if the next prime minister is the new MP for Makerfield, Andy Burnham, he didn't even stand at the last election on any manifesto at all. And I really do think, I really do think that my call for there to be a general election as soon as is possible, I think you'll find a lot of support for that."

Scotland's first minister, John Swinney, says Sir Keir has made the right decision to step down.

"It was crystal clear that he was losing the confidence of his party, having lost the confidence of the country. And I think it demonstrates as we go through another change of prime minister in the United Kingdom after so many changes in the last ten years, that the Westminster system is just not working. And for Scotland, as we observe this constant change of prime minister, that the answer is for Scotland's future to be in Scotland's hands through the powers of independence."

And in Northern Ireland, the first minister, Michelle O'Neill, said Sir Keir Starmer's departure underlined the chaos of Westminster.

"Tomorrow will be 10 years anniversary since Brexit," she said. "And what we saw throughout the course of that time

has been a revolving door of British prime ministers who never, each and every one of them have never prioritized the needs

and the interests of people here. So I think that what we can see unfolding in Westminster today is more of the same."

## Five year stretch for SNP embezzler

■ Nicola Sturgeon's estranged husband carried out a "calculated crime of dishonesty", judge tells Edinburgh court

Former SNP chief executive Peter Murrell has been sentenced to five years and three months in jail after he admitted to embezzling more than £400,000 from the party.

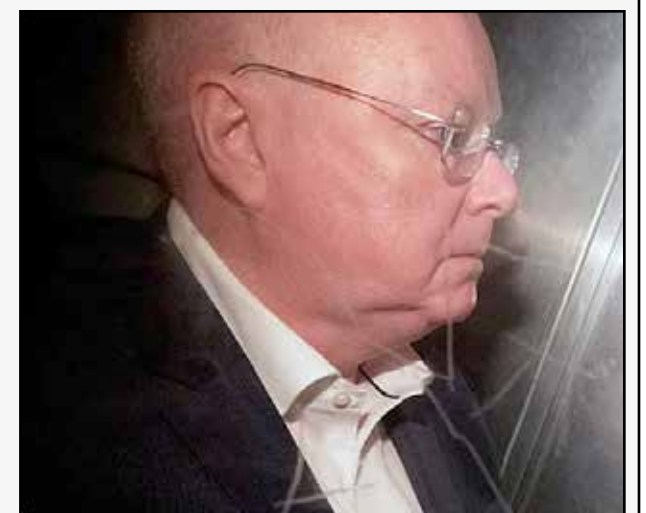
Murrell - the estranged husband of Nicola Sturgeon - used the funds to buy goods ranging from cars and a motorhome to kitchenware and toiletries.

The 61-year-old's sentence was backdated to 25 May, when he was remanded in custody after pleading guilty.

He did not react as his sentence was delivered, staring straight ahead before being led away in handcuffs.

## 'outrageous amount'

Judge Lord Young said Murrell had carried out a "calculated crime of dishonesty" but told the court he had been

unable to identify a clear motive.

Sturgeon has denied any knowledge of his wrongdoing, saying she was "deceived".

At a court hearing on 25 May, Murrell admitted embezzling £400,310.65 from the SNP between 2010 and 2022.

Police Scotland began

investigating the party's finances in 2021 after questions were asked about what had happened to £667,000 raised for a second independence referendum campaign.

Officers initially looking into those concerns ultimately uncovered Murrell's embezzlement

# Former DUP leader Donaldson guilty of child sex offences

■ Facing lengthy jail term, disgraced NI politician resigns knighthood and privy council position

The former leader of Northern Ireland's Democratic Unionist Party, Sir Jeffrey Donaldson, has been found guilty of historical child sex offences, including one count of rape.

Donaldson was charged after two women accused him of sexually abusing them when they were children.

Donaldson was driven away from the court in a prison van after being remanded into custody.

## No emotion

The judge indicated he was facing a lengthy jail term. The former politician showed no emotion as the jury delivered its verdict after ten hours of deliberations.

He was convicted of all

18 charges against him. One of rape, 13 of indecent assault and four of gross indecency. The crimes were committed between 1985 and 2008.

Donaldson's two victims gave evidence during the course of the trial, which lasted for more than four weeks. The defendant suggested to the court that his accusers were lying, but a prosecution barrister put it to Donaldson that the only person telling lies was him, and that he'd been sinful and deceitful.

Donaldson resigned as leader of the Democratic Unionist Party shortly after he was arrested and charged in 2024.

He didn't stand in the general election that

year. He'd been in parliament for almost three decades, making him the longest-serving MP in Northern Ireland.

Shortly after the verdict Donaldson asked for his knighthood to be forfeited.

He has also tendered his resignation from the Privy Council with immediate effect.

## aiding and abetting

The moves were confirmed in a statement issued by his solicitor John McBurney.

It read: "I have this afternoon issued a letter signed by Jeffrey Donaldson to the Cabinet Office indicating a request to renounce and forfeit his knighthood."

Donaldson's wife,

Lady Eleanor Donaldson, was charged with five offences, including four of aiding and abetting her husband's offending. She was ruled unfit for a conventional

trial on mental health grounds and instead went through a legal process known as a trial of the facts, where there could be no criminal conviction. The jury

found that she did the acts of which she was accused.

Sir Jeffrey Donaldson will return to court in the autumn when he'll be sentenced.

# Gatwick campaigners lose expansion appeal

Campaigners opposing Gatwick Airport expansion have lost two High Court challenges against the government but have said they will consider an appeal.

Transport Secretary Heidi Alexander approved a £2.2bn plan in September to move Gatwick's emergency runway 40 feet north, allowing a two-runway operation.

The anti-noise group Cagne and campaigner Peter Barclay told a hear-

ing in January the scheme was unlawful, claiming the government had not properly assessed climate impact.

Ruling earlier, Mr Justice Mould dismissed both bids, concluding the scheme would not "materially impact" the government's ability to meet net zero targets - a decision London Gatwick called a "victory for common sense".

The Department for Transport (DfT) and the airport's owner, Gatwick

Airport Limited, had defended the challenge, with lawyers for the site claiming it was "unarguable".

The scheme is expected to increase Gatwick's capacity from about 280,000 flights a year currently, to 389,000 by the late 2030s.

Travel journalist Simon Calder said the expansion of Gatwick Airport was "the first meaningful airport expansion in decades".

"Certainly for the economy of the Gatwick area,

and for travellers in south east England, this is nothing but an overwhelming positive," he added.

In a 100-page judgment, the judge also rejected an argument against the need for expansion at the

airport, given its proximity to Heathrow, which is about 40 miles (64 km) away via the M25.

They found Murrell had used charge cards, bank transfers and fake invoices to illicitly purchase items including jewellery, cosmetics, stationery, and games consoles.

At the sentencing hearing, Murrell's lawyer John Scullion KC recognised that the only "appropriate" punishment was imprisonment. He said his client had

"behaved dishonestly" and went to considerable lengths to conceal his crimes and avoid detection.

Prosecutors have released a recording of detectives interviewing Murrell asking why he had spent thousands of pounds on fountain pens.

"Over 19,000 pounds is exclusively of pens alone. It's quite frankly an outrageous amount of money to be spending on pens," said a spokesman.

## Royal couple 'will not live' at refurbished Buck House

King Charles and Queen Camilla will not move into Buckingham Palace when £369m of buildings works to update it finish next year, preferring to remain at Clarence House, their London home nearby.

The announcement came as it was revealed the king paid £12.9m in income and capital gains tax in 2024-25 on his personal income, known as the privy purse, making him among the country's top 100 taxpayers. Prince William paid £7.76m for the same period.

Palace finances also revealed that the core sovereign grant – the amount of public money given to the king to carry out official duties – had almost doubled in three years. From 2027-28 it will be £99.9m, up from £51.8m in 2024-25, after a review by the royal trustees: the UK prime minister, Keir Starmer; the chancellor, Rachel Reeves; and the king's accountant and

keeper of the privy purse, James Chalmers.

Charles and Camilla made the decision not to move to Buckingham Palace after "careful consideration and to greatly increase opportunities for public access", and will remain at Clarence House for the duration of his reign, said Chalmers.

They would have access to private rooms at the palace to retire to during the day and for occasional overnight stays. It would continue to be the ceremonial and operational centre of royal life.

"[Buckingham Palace] is and will remain monarchy HQ, the crown jewel of our national buildings, with the sovereign's standard flying proudly from the roof whenever his majesty is in London," said Chalmers.

A royal spokesperson said it would be a "buzzing hive of royal activity in every other way".

# Charles paid almost £13m in tax in 24/25

■ Buckingham Palace described disclosure as 'increasing transparency'

King Charles has disclosed he paid £12.9m in tax for 2024-2025 - becoming the first monarch to reveal their tax bill.

The level of tax paid by the King puts him in the top 100 of UK taxpayers.

The Prince of Wales declared he paid £7.76m tax over the same period, the figures in the annual royal report and accounts show.

It has also been revealed the King and Queen Camilla will continue to live in Clarence House and not move into Buckingham Palace.

The accounts show the main source of funding for the Royal Household, the Sovereign Grant, is rising to just under £100m for the year 2027-28.

The accounts also show the King paid £11.7m in tax for 2023-24, while Prince William

paid £8.34m for the same period.

The publication of how much tax the King and Prince William voluntarily pay was a personal decision made by both men, according to their offices.

Buckingham Palace described the move as increasing transparency and aimed to "encourage wider understanding of our accountability."

Since the King became monarch and William the Prince of Wales, the combined tax bill of father and son paid to HM Revenue and Customs has been more than

£50m.

The new figures do not give any detailed breakdown of how the tax has been calculated.

The King receives an annual income from his Duchy of Lancaster estate set up to give the monarch an independent source of money for official and private expenditure.

It is a portfolio of land, investments and properties. It provides the King with an annual income which in 2025-26 was £25.2m.

Other sources of income, liable for tax, include the King's own investments and savings

alongside money generated by his private estates, Balmoral and Sandringham.

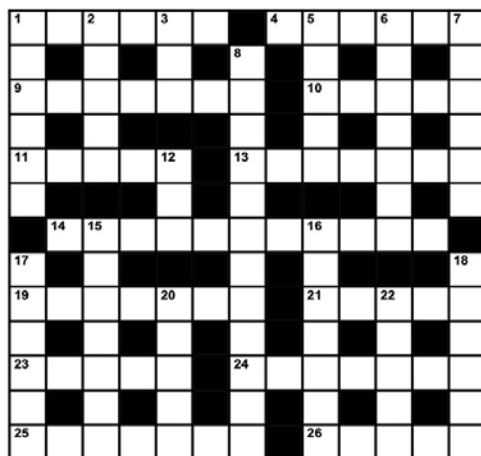
Initially, the Prince William did not release his tax payments when he became heir to the throne - but in line with his father, he has now made his payment of income and capital gains tax public.

Prince William receives an income from the Duchy of Cornwall - a billion-pound 130,000 acre hereditary estate which also includes the Oval cricket ground in London - which funds official duties, his office and private family life.

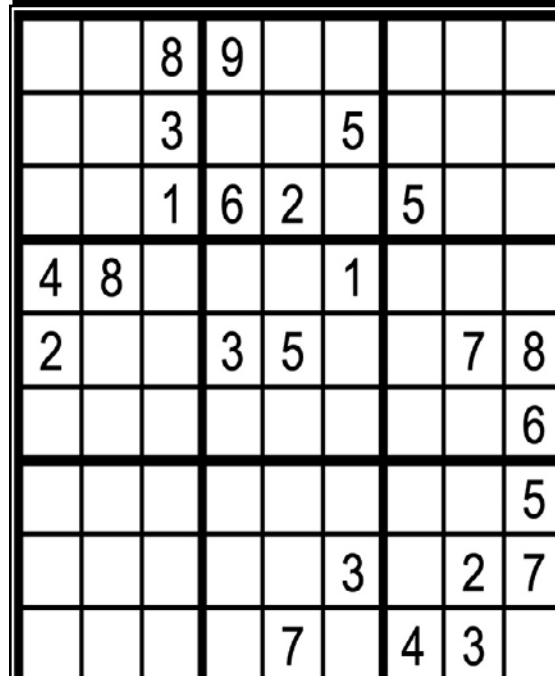

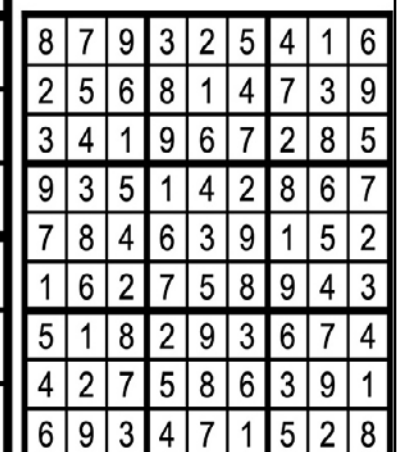

Extreme temperatures have triggered widespread technical issues, impacting IT systems, lab testing, cancer equipment, and diagnostic scanner.

In Portsmouth the Queen Alexandra Hospital declared a critical incident when the “chilly units” providing vital cooling for surgical theatres,

MRI scanners, and IT systems failed. While engineers have since repaired the units, the intense ambient heat means the chillers are taking longer than normal to fully take effect.

Another critical incident was declared at Norfolk and Norwich University Hospitals due to similar technical failures, which put all of the hospital’s MRI scanners completely out of action.

Critical incidents are officially declared when a service comes under extreme pres-

sure, threatening a hospital’s basic ability to deliver care. This declaration enables facilities to cancel routine appointments and receive emergency external support.

The London Ambulance Service reported receiving its highest ever number of life-threatening emergencies across the capital, noting the surge was explicitly “driven by the extreme heat.”

### Europe bakes

The heatwave has gripped most of west-

## British TikTokker Brooke George could face death penalty after Dubai murder charge

■ The 23-year-old influencer says she acted in self-defence after allegedly being assaulted by a British man she met online

A human rights group has said a British TikTok influencer charged with the murder of her boyfriend in Dubai faces execution under UAE laws if she’s convicted.

Detained in Dubai said it was assisting 23-year-old Brooke George from Gravesend in Kent who maintains she acted in self-defence during a violent attack by her 26-year-old British part-

ner. The Foreign Office said it was supporting a British woman detained in the UAE and her family.

According to the organisation, George first met the man on Facebook and travelled to Dubai after the pair developed an online relationship.

Her first visit lasted around a week and was positive, with George

describing it as “the time of my life”.

However, during a second visit, she alleges his behaviour changed dramatically.

She says he became increasingly controlling and abusive, and she discovered he had booked her only a one-way ticket to Dubai. Detained in Dubai said the pair had met at a bar before returning to his apartment,

# Comedy defending leaves Scotland on the verge of early exit

Scotland's hopes of reaching the knockout stages of the World Cup for the first time looked in significant peril at press time after calamitous defending allowed Brazil to sweep them aside 3-0 in Miami and finish top of Group C.

Steve Clarke's side knew they could all-but confirm a historic passage out of the group stages with a point against the record tournament winners.

Before the game, the statisticians said a record of three points and a minus three goal difference would give a team a 42% chance of claiming one of the eight best third-place team spots in the last 32.

But the Scots face an agonising wait until potentially as late as Sun-

day morning to know their fate as the rest of the groups play their final games.

As the British Weekly went to press Thursday evening, Scotland were seventh out of the potential eight third place finishers - but with several of their rivals yet to play.

Should they miss out, they will rue being masters of their own downfall yet again.

Scott McKenna - in for his first start of the finals - hesitated on the ball and was robbed by Bournemouth teenager Rayan. He teed-up Vinicius Jr, and one of the game's most potent strikers gratefully accepted the gift.

The Real Madrid forward - who has scored in every group game - thought he had his sec-

ond when he pick-pocketed Jack Hendry and rolled beyond Angus Gunn.

VAR bailed the Scots out - the officials deciding the defender had been tripped - when they couldn't help themselves.

Carlo Ancelotti was not a happy man, but his talisman soon had his second, nodding in at the back post after the feeble Scots failed to clear in first-half stoppage time.

Vinicius Jr could have had a hat-trick. Brazil could have had five.

And yet Scotland will have felt a bit sore going in at the break two goals down as they looked the best they have this tournament in possession and on the front foot.

Perhaps that's saying

something, though.

Without captain Andy Robertson - who was ripped by Rayan, yet saved by Gunn - in the second half, the Scots again started brightly. But Brazil were toying with them.

Two soft penalty

claims and a Scott McTominay header arrowed at Alisson were forgotten of when Newcastle midfielder Bruno Guimaraes dispossessed Kenny McLean, setting up Matheus Cunha to smash home.

To rejig a well-known

phrase, it's not what you do, but how you do it.

Scotland couldn't have been kinder to Brazil.

Few teams at this tournament need a helping hand, but the South Americans certainly don't need the presents Clarke's side provided.

## Anderson seals City switch

■ England midfielder set to leave City Ground in what may turn out to be a British record deal

Manchester City have agreed a deal with Nottingham Forest to sign Elliott Anderson - potentially worth up to a British record £130m.

The England midfielder, 23, is now set to have a medical before completing his move to Etihad Stadium.

City sources insist the fee for Anderson is closer to £115m, which would be a club record, with no bonuses attached.

However other sources claim the deal is worth up to £130m.

Forest had been holding out for such a fee for Anderson after rejecting two previous offers from City.

The fee could eventually eclipse

the £125m Liverpool paid Newcastle for striker Alexander Isak last summer.

Personal terms are not expected to be an issue and there was always a degree of confidence the deal would get done eventually, once City made a third bid.

Forest are interested in Tottenham's Lucas Bergvall, along with Davide Frattesi of Inter Milan, and are now expected to sign two midfielders this summer.

Anderson is preparing for England's final Group L game against Panama at the World Cup on Saturday and told reporters this week how he has pushed his club future to one side.

"It's pretty easy really, I'm just focusing on the present, I'm blocking it all out," he said.

"I've got a plan and it's to perform for England. I'm putting myself in the best position to cross the line and do that."

Anderson joined Forest for £35m from Newcastle in 2024 and has made 88 appearances for the club, scoring four goals.

Anderson had been on Newcastle's books since his academy days and when his sale to Forest went through, Magpies boss Eddie Howe said he had 'never been so reluctant' to sell a player.

He helped Forest finish seventh in the

England's head coach tried all his alternatives to inject life into a display that was too slow and too predictable - but for all that they are still well placed to top the group and go into the World Cup's last 32.

# James a doubt for Panama

## ■ Declan Rice also struggling with fitness

Reece James missed training with England on Thursday which has thrown his fitness into doubt for the Three Lions' final Group L game against Panama.

The 26-year-old right-back suffered a hamstring issue in the goalless draw with Ghana on Tuesday and did not train with his team-mates in England's penultimate session before Saturday's game.

It now remains to be seen if the Chelsea defender is fit enough to start or be an option from the bench in the final group game at New York New Jersey Stadium.

James is a key member of the starting XI under manager Thomas Tuchel and has been selected in both World Cup games so far.

Declan Rice, who left Boston Stadium after the Ghana draw with strap-

ping on his left calf, was also absent from Thursday's session at England's training base in Kansas City.

But sources indicate the 27-year-old midfielder's fitness is less of a concern.

It remains to be seen if Tuchel is willing to start Rice - particularly given he is at risk of suspension for the round of 32 after he was booked against Ghana.

## Misfiring England frustrated by well-drilled Ghana side

England were unable to repeat the flowing football that overpowered Croatia in their first World Cup game as they were held to a draw by Ghana at Boston Stadium on Tuesday.

Thomas Tuchel's side knew victory would confirm a place in the last 32 - but they were left frustrated by the stubborn resistance and organisation from Ghana.

England took 57 minutes to muster a shot on target and once again lived dangerously in defence, surviving anxious moments when Ghana hit them on the counter-attack as the contest

became a disjointed affair.

Tuchel turned to Bukayo Saka, whose minutes are being managed because of a lingering Achilles problem, and replaced Jude Bellingham with Morgan Rogers in an attempt to break the stalemate.

Saka forced a fine save from Ghana keeper Benjamin Asare, while another substitute Nico O'Reilly headed against the bar, leaving Tuchel and England to settle for a point. Marc Guehi also had a header cleared off the line.

Even though England applied pressure, they

appeared very fortunate not to concede a penalty late on when Ezri Konsa challenged Prince Kwabena Adu in the area, bringing him down without making any contact with the ball.

England remain top of Group L, but must now wait until their final game against Panama to ensure qualification for the World Cup knockout phase.

England's spirits were high after they swept past Croatia with a superb display of attacking football - but this was a sobering brush with World Cup reality against Ghana.

Croatia were deter-

mined to press England and, to an extent, played into their hands, whereas Ghana were happy to sit deep and let Tuchel's team have the ball for long spells.

It is in these circumstances that a touch of X-factor is needed to

make the breakthrough and England simply did not possess it.

Tuchel ran through his options in an attempt to crack the Ghana code, with Saka replacing the disappointing Anthony Gordon, and the Arsenal winger almost fashioned

the breakthrough when he forced a diving stop from keeper Asare.

England finally found some urgency in the closing stages, when O'Reilly held his head in his hands after hitting the woodwork, with Guehi
