# Troubled Prince ponders: to visit, or not to visit?

■ Harry "reconsidering" bringing Meghan and children to UK as he is denied full-time taxpayer-funded police protection

The planned return of the Duke and Duchess of Sussex to the United Kingdom next week has been thrown into deep uncertainty following a fresh dispute over their personal security arrangements.

Sources close to the household suggest that Prince Harry is reconsidering bringing his wife, Meghan, and their two children, Prince Archie and Princess Lilibet, after learning that full-time police protection will not be afforded to them throughout the entirety of their stay.

The family was scheduled to travel to the United Kingdom to mark the official one-year countdown celebrations for the 2027 Invictus Games, which are set to take place in Birmingham. The visit, formally announced on June 26, was highly anticipated as it would have marked the first time the Duchess of Sussex and the children have set foot on British soil since 2022.

However, within hours of the public announcement, the Duke reportedly executed what has been described as an extraordinary U-turn regarding his family's travel logistics.

According to reports originally published by

Vanity Fair, the Duke of Sussex is understood to be "devastated and close to tears" regarding the strict limitations imposed on his family's security apparatus. The decision was handed down by the Royal and VIP Executive Committee (RAVEC), the official body responsible for determining the provision of taxpayer-funded security for members of the royal family and visiting dignitaries.

### "Magical thinking"

But RAVEC has privately denied any U-turn happened, and their position is the same it has always been: that because the Duke and Duchess stepped back from their roles as working royals in January 2020, they are no longer automatically entitled to comprehensive state-funded protection.

One source close to the Committee said: "I don't know why the Prince thought things had changed just for this one visit. We never indicated

anything of the sort. He seems to be indulging in some sort of magical thinking."

Under the specific terms outlined by RAVEC for the upcoming trip, taxpayer-funded security will not follow the family during private movements or public charitable engagements. Instead, the high-level police protection would only be activated when the family is physically present within an official royal residence.

For the Duke of Sussex, whose itinerary includes significant travel and high-profile visits to his personal patronages, this conditional arrangement has been deemed fundamentally insufficient.

### public spaces

Beyond the Invictus Games celebrations in the Midlands, the Duke is scheduled to undertake a series of visits to charitable organizations with which he has maintained long-standing relation-

ships, including WellChild and Scotty's Little Soldiers, a charity supporting bereaved military children.

These engagements naturally require travel

through public spaces and attendance at civilian venues, areas where the Duke feels his family would be uniquely vulnerable without continuous, specialist protection.

The issue of security has remained the primary source of friction between the Duke of Sussex and his the government since his relocation to California six years ago.

# Andy Burnham sets out a vision to 'rewire Britain'

■ Prime Minister-in-waiting pledges to radically devolve power and create a "No 10 of the North"

Labour's likely next Prime Minister has set out a 10-year economic plan promising greater regional powers local governments and a shift away from trickle-down economics.

Andy Burnham used his first major policy speech as Labour leadership frontrunner on Monday to promise the biggest shake-up of political power in modern British history, pledging to hand sweeping new authority to local leaders and relocate part of the prime minister's office to Manchester.

## 'rebalancing of power'

Speaking at the People's History Museum in the city where he spent nine years as mayor, Burnham laid out a 10-year plan to revive a UK economy he described as stuck in a rut since the 2008 financial crash.

"Growth cannot be ordered from the top down. Indeed, it can only be nurtured from the bottom up," he told the audience

on Monday.

Central to his pitch was the creation of a new government hub in Manchester he dubbed "No. 10 North," which he said would become "the nerve centre of a rewired Britain."

Regional mayors would receive expanded powers over housing, welfare and education under the arrangement, which Burnham framed as "the biggest rebalancing of power our country has seen."

The approach draws heavily on what he calls "Manchesterism" — a philosophy he has described elsewhere as "business-friendly socialism" and a rejection of trickle-down economics.

During his mayoral tenure, the policy translated into initiatives including the Bee Network, Manchester's publicly-controlled bus system, and the Good Growth Fund, which directed investment into each of Greater Manchester's boroughs. Burnham is now

betting he can scale that model up to national level.

He also pledged to create new industrial jobs, expand educational opportunity and tackle what he characterised as the wastefulness of the UK's privatised water and energy sectors.

## internal pressure

"When I started as mayor in 2017, we set about building a new approach, a new politics based on the exact opposite of the Westminster approach. Place first, not party first. Problem solving, not point scoring.

Long term, not short term. A decade on, it's incredible how much we've been able to achieve by working together instead of fighting against one another."

Burnham is by far the most likely successor to Keir Starmer, who announced his resignation on 22 June after two years in office defined by slumping poll ratings, ministerial walkouts and

a string of bruising election defeats.

His departure followed months of mounting internal pressure, culminating in Labour's catastrophic May local election results that saw the party lose nearly 1,500 council seats, many of them to Nigel Farage's Reform UK.

Burnham won the Macclesfield by-election on 18 June, a seat vacated specifically to allow him to return to Westminster, securing around 55% of the vote in a result that exceeded pre-election forecasts. He was sworn in as an MP on 22 June, the same day Starmer went public with his decision to step down.

Since then, his path

to Downing Street has grown steadily clearer. Former health secretary Wes Streeting, once considered his most likely rival, threw his weight behind Burnham last week.

Cabinet minister Darren Jones also ruled himself out on Wednesday, telling Sky News: "Andy Burnham is going to be the next prime minister."

Leadership nominations open on 9 July and close a week later; if no one challenges him, he could be in Downing Street by 17 July.

Despite his momentum and the genuine enthusiasm his name generates in parts of the Labour movement, Burnham will inherit a deeply difficult political situation. The

economy remains sluggish, public services are strained and household budgets are squeezed, the same conditions that eroded Starmer's standing. He will also be bound by Labour's 2024 manifesto commitments, including a pledge not to raise taxes on working people.

The Conservative Party was quick to dismiss Monday's address.

"Andy Burnham's big idea is to shuffle power between politicians," said Tory chairman Kevin Hollinrake.

"Not fix the welfare system. Not cut the taxes strangling working families and British business. Not fund the defence our country desperately needs."

## No X please, we're British

■ Culture secretary pulls department off controversial platform

Culture Secretary Lisa Nandy has announced she and her department are leaving Elon Musk's X platform.

Explaining her decision in what seemingly will be her last post on X, Nandy said the platform "isn't healthy for our democracy or our communities and I don't want to support it".

"A platform originally designed for free speech and expression now favours abuse and misinformation over meaningful debate," she wrote.

The culture department becomes the second

government department to stop using X after the attorney general's office, while several MPs also left the platform earlier this year over reports its AI tool was being used to create sexualised images.

Attorney General Lord Hermer defended his decision to ban his office from posting on X last month, telling MPs it "constantly descends to racism and misogyny" and that his department "can do better".

"I can understand why other departments feel they need to be on the

pitch engaging with people, but that is not where the attorney general's office needs to be," Lord Hermer told the Justice Committee in June.

"For the work that I can do, I can engage with people in serious debate, detailed debate, respectful debate, without being on a platform that constantly descends to racism and misogyny."

Prime Minister Sir Keir Starmer has accused Musk of using his platform to "whip up division" in the UK over the murder of student Henry Nowak last month.

# Starmer seeks legacy via huge increase in defence spending

## ■ Drones and autonomous systems to replace big-ticket hardware as UK responds to lessons of Ukraine conflict

Outgoing UK Prime Minister Keir Starmer said that Britain would spend a "record" of almost £300 billion over the next four years to modernize its armed forces in the face of rising threats.

Mr Starmer, expected to leave office next month after losing the support of Labour members of parliament, announced an extra £15bn annually for defence spending up to 2030 when he launched his long-awaited Defence Investment Plan (DIP) on Tuesday.

The plan will see increased money for drones and autonomous systems as the nature of modern warfare changes.

"This record investment puts the security of the British public first, transforming our armed forces and giving them the funding and equipment they need to fight and

defend our nation," Mr Starmer said.

The plan follows months of wrangling within the Labour government over the resources required to modernise Britain's fighting capabilities to counter greater aggression from countries such as Russia and a less reliable United States.

### 'game changing'

Two defence ministers quit earlier this month in a row over the defence plan, including defence secretary John Healey, who said it risked making Britain "less safe".

The resignations highlighted Mr Starmer's weakening authority.

He announced on 22 June that he was stepping down after MPs from the Labour party switched their support to veteran politician Andy Burnham.

Mr Burnham, the

56-year-old former Greater Manchester mayor, will take over as prime minister in mid-July if he faces no challengers for the Labour leadership.

Mr Starmer has called the defence plan "game-changing investment".

"I am absolutely certain that this is the platform on which whoever comes after me can build," he told reporters.

The plan includes more than £5.0bn for drones and autonomous systems over the next four years, the Ministry of Defence (MoD) said in a press release.

### 'hybrid' vessels

The investment will see capabilities ranging from "highly complex autonomous mine-hunting drones to small 'quadcopter' tactical drones, and low-cost 'kamikaze' one-

way attack drones", the MoD added.

The wars in Ukraine and Iran have highlighted the increased use of war-fighting robots.

Ukraine uses roughly 200,000 drones a month to defend itself from Russia's invasion, while at the height of the US-Israel-Iran conflict, 700 offensive drones were being

launched per day, the MoD said.

Mr Starmer said the defence plan will take defence spending to 4.2% of gross domestic product.

The government also announced that from the early 2030s Britain will replace its six ageing destroyer warships with at least six "hybrid" vessels that will "mix crewed and

uncrewed capabilities".

It's taken months of arguments behind the scenes to agree this uplift in defense spending. A defense secretary and an armed forces minister both resigned just weeks ago, saying the funding was inadequate and it's only been made possible by promising cuts to other areas.

## Stay open all night! Pubs get extra time for World Cup clash

Pubs in England and Wales will now be allowed to stay open until 05:00 on Monday, allowing football fans to watch the Three Lions' World Cup clash with Mexico to the final whistle.

The round-of-16 match in Mexico City kicks off at 01:00 UK time.

The government had initially said it would not relax licensing laws further than they already have been for the World Cup.

But in a U-turn later on Thursday, Prime Minister Sir Keir Starmer said pubs could stay open until the final whistle.

Sunday's match is not expected to finish until after 3am Monday UK

time.

Sir Keir said the decision was good news for both supporters and pubs.

"Football might be coming home but we're making sure fans don't have to," he said on Thursday afternoon.

### 'fantastic news'

Publicans and businesses welcomed the change. Emma McClarkin, chief executive of the British Beer and Pub Association, said: "We all know the best place to watch the match is down the local."

Michael Kill, chief executive of the Night Time Industries Association, said it was "fantastic news" that would be "hugely welcomed by

operators".

Licensing hours had already been extended for the World Cup from 23:00 to 01:00 for games with kick-offs from 17:00 up to 21:00 and up until 02:00 for kick-offs between 21:00 and 22:00.

The original opening hour extensions followed a six-week public consultation which opened in December.

Individual pubs normally have to apply to their local council for extended opening hours, at least five working days in advance.

Earlier on Thursday, business minister Kate Dearden said pub opening hours would not be extended further for Monday's 0100 kick off.

She had been re-

sponding to a question from Liberal Democrat MP Max Wilkinson in the House of Commons, who said pubs would "miss out on a real opportunity to get money in the till if

ministers do not make a blanket extension for licensing hours".

Local Government Secretary Steve Reed told broadcasters the government was now passing

emergency legislation through parliament on Friday "so every England fan that wants to go to the pub and cheer their team on gets the chance to go".

## Rape victims told grooming gang leader 'cannot be deported'

■ Provisions in the Immigration Act of 1971 bar removal of Pakistani immigrant who was freed from jail this week

Victims of a notorious grooming gang ring leader have been told he cannot be deported back to Pakistan after his release on Thursday.

Shabir Ahmed, 73, known to his victims as "Daddy", had dual British-Pakistan citizenship and was stripped of his British citizenship following his conviction in 2012 for multiple counts of rape and sexual offences against girls in Rochdale.

But documents published online - allegedly from the Probation Service to one of his victims - state he cannot be deported back to Pakistan.

This is due to provisions in the Immigration Act 1971 which bar his removal because he arrived in the UK before 1973 and has lived in the UK for at least five years before his deportation was considered.

It is understood

Ahmed has been released on licence, that he must initially live at an accommodation which is staffed 24 hours and is subject to an "exclusion zone" centred on Rochdale.

Paul Waugh, MP for Rochdale, speaking to The Daily Telegraph, said: "The people of Rochdale want him booted out of the country and it's simply unacceptable that the government of Pakistan are refusing to take him back."

"If the Citizenship Act needs to be amended to do that, ministers should look at doing just that."

For two years from early 2008, girls as young as 12 were plied with alcohol and drugs, gang-raped in rooms above takeaway shops and ferried to different flats in taxis where cash was paid to use the girls for sex.

At his trial, Ahmed called the judge racist

and took his case to the European Court of Human Rights, claiming he did not get a fair trial.

He was jailed for 19 years in 2012 at Liverpool Crown Court as one of nine men in the Rochdale grooming gang trial convicted of offences against five girls.

Police said the victims were from "chaotic", "council estate" backgrounds and as many as 50 girls could have been victims of the gang.

Judge Gerald Clifton said victims were treated "as though they were worthless and beyond any respect" because they were not part of the gang's community or religion.

In 2022, Andy Burnham, who is likely to replace Sir Keir Starmer as the next prime minister, called on the Conservative government "to do everything within... the government's power" to deport grooming gang members.

A report later found that police did not act despite multiple concerns being raised, citing "serious multiple failures" by police and local authorities.

Ahmed's case follows a similar legal battle by

two other gang members, Qari Abdul Rauf and Adil Khan.

Both were stripped of their British citizenship in 2022, 10 years after their convictions, after fighting a long legal battle which went all the way to the Court of Appeal.

Qari Abdul Rauf and Adil Khan invoked their human rights under article eight of the European Convention on Hu-

man Rights, the right to a private and family life, to avoid deportation.

The Home Office has not said if either have been deported.

### Tunnels connecting Shetland islands move closer to reality

Councillors have backed initial plans to connect some of Shetland's islands with undersea tunnels, which could be in place within eight years.

A feasibility study proposed replacing ageing ferries with tunnels from Shetland's mainland to Yell and from Yell to Unst, describing them as "economically transformative".

Two more tunnels, to the islands of Whalsay and Bressay, could follow under the plans - which it is estimated could cost £1.5bn.

Council leaders say the tunnels would be cheaper than building new ferries and replacing harbours.

At a meeting in Ler-

wick on Tuesday, councillors approved exploring funding options.

Council chief executive Maggie Sandison said the project was not going to be easy, but she thought pursuing a funding solution was the "right thing to do".

This could come from a mixture of private investment, public subsidy and borrowing, alongside tolls to cover maintenance costs.

The council's transport chairperson, Morraig Lyall, said the report showed there were no technical barriers to building tunnels, which would be "cheaper in the long run" than ferries.

The council currently runs ferry services to

## New sex charges brought against Glitter

**Gary Glitter, the former singer whose real name is Paul Gadd, has been charged with historical sexual offences dating back to 1978, the Metropolitan Police has said.**

The charges relate to one count of unlawful sexual intercourse with a girl under the age of 13, and three counts of indecent assault on a girl under the age of 14.

There is one alleged victim, with the offences said to have taken place between the years of 1978-1981 at a residen-

tial address in Kensington.

Gadd (pictured above) is due to appear at Westminster Magistrates' Court on 5 August.

The allegations were first reported to the Met on 9 January 2025 and an investigation into the circumstances was launched.

Gadd was first interviewed on 22 July 2025 in relation to the investigation.

Glitter is currently being held in HMP

Channings Wood in Devon.

Bethan David, Deputy Chief Crown Prosecutor in CPS London, said of the charges: "This follows allegations made by a woman relating to a period of alleged abuse that took place between 1978 and 1981.

"Our prosecutors have worked to establish that there is sufficient evidence to bring this case to court and that it is in the public interest to do so."

nine islands, carrying around 750,000 passengers each year on 12 vessels at a cost of £23m per year.

Costs have risen sharply in the past decade, with some routes struggling to meet demand for vehicle places.

Lyllal said: "The system we have that has served us well for decades is now no longer able to do that.

"It doesn't have the capacity and we're struggling with other things, like the ability to crew the system adequately.

"These barriers to giving the islands a really good service are not going to be easily overcome by replacing ferries with other ferries.

"The tunnel is the an-

swer that we believe will help us solve these problems."

Unst is the UK's most northerly island and home to the UK's only spaceport, at Saxavord, as well as a sizeable aquaculture industry.

The feasibility study says tunnels could boost direct economic activity related to the spaceport as well as spin-off benefits such as other aerospace industrial development and tourism.

Boatbuilder Brydon Barclay of Fluggaboats on Unst predicted a tunnel would transform his company's prospects.

"It's absolutely essential," he said.

"At the moment, we're running with a ferry service that just isn't meeting the demand at all."

In drawing up its plans for tunnels, Shetland has taken inspiration from the

neighbouring Atlantic archipelago 200 miles to the north west.

The Faroe Islands have been building tunnels since the 1960s and now have more than 20, including four which run under the sea, linking island communities.

The network includes a 7.1 mile (11.4km) tunnel which connects the island of Streymoy to two sides of a fjord on the island of Eysturoy via the world's only subsea roundabout.

Last year the then prime minister of the Faroes, Aksel Johannesen, told reporters that Shetland could boost growth, revitalise island life and encourage population growth by emulating his country's tunnel network.

"I think we have learned in the Faroe Islands that investment in infrastructure is a good investment," he said.

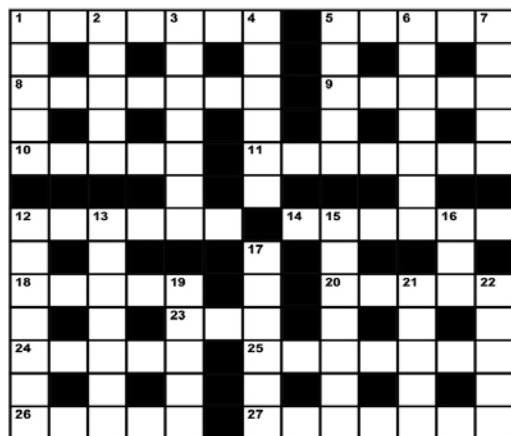


TUNNEL VISION: the inter-island system in the Faroes is seen as a model

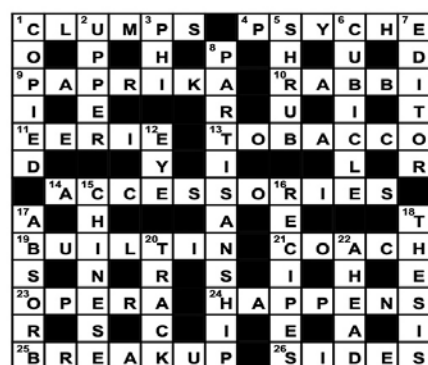

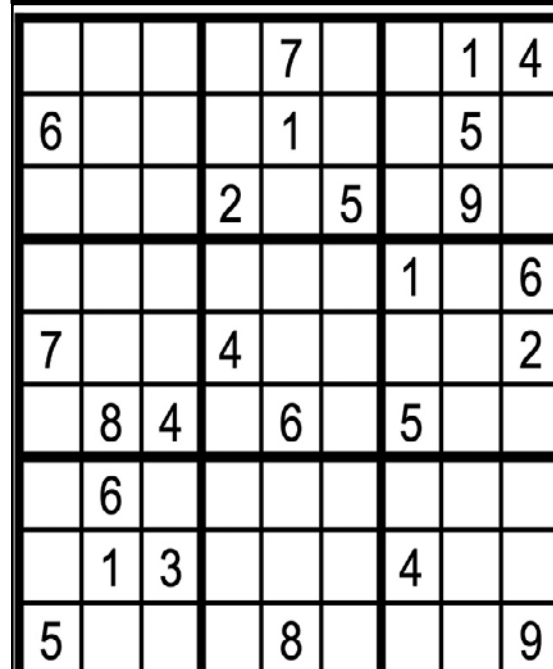

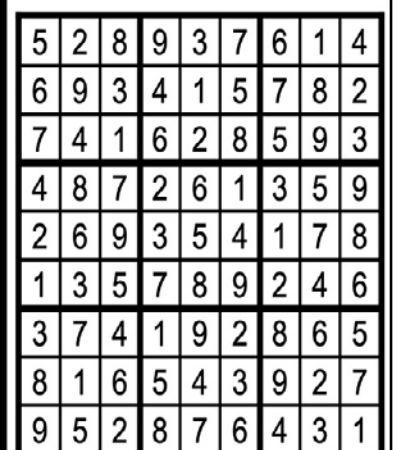

# Tributes flow for Dame Penelope Keith, dead at 86

■ Comic actress starred in two of Britain's most beloved sitcoms, *The Good Life* and *To The Manor Born*

Tributes have been paid to actress Dame Penelope Keith, best known for her roles in the classic 1970s British sitcoms *The Good Life* and *To the Manor Born*, following her death at the age of 86.

In a statement, her family said on Monday that she "died peacefully whilst living with cancer at her home in Surrey".

Felicity Kendal, her co-star in *The Good Life*, remembered her as a "comic genius" who was "a joy to know and work with".

Dame Penelope famously played snobbish suburban neighbour Margo Leadbetter in *The Good Life*, as well as the widowed aristocrat Audrey Forbes-Hamilton in *To the Manor Born*.

The statement released on behalf of her family said: "We are deeply saddened to announce that Dame Penelope Keith died peacefully whilst living with cancer at her home in Surrey where she had lived for more than 50 years.

"The family is grateful for the care and support she received throughout her treatments, and ask

that their privacy be respected at this time."

In her tribute, Kendal said: "I am deeply saddened to hear of my friend Penelope's death.

"The shows I worked on with her were such special times in our lives and demonstrated her comic genius.

"She was a joy to know and work with, and she will be much missed."

Others paying tribute included comedian and presenter Sue Perkins, who praised her on Instagram for having been the "creator of some of the greatest sit com characters of all time".

Broadcaster Gyles Brandreth remembered Dame Penelope as "such a special lady - a wonderful actress, a real friend, so funny, so generous with the time she gave to good causes". He added: "Hers was indeed a good life."

Former culture secretary Sir Jeremy Hunt posted: "Incredibly sad to hear of the passing of Dame Penelope Keith CBE. She was a neighbour and friend where she was dearly loved by

all who knew her in Milford.

"She helped Britain laugh at itself, one of our best national qualities, and brought happiness to millions. RIP dear Penny."

## 'Utter genius'

Also paying tribute, novelist Lissa Evans noted the marked difference between Dame Penelope's characters and her real personality.

"Margo Leadbetter was snobbish, humourless and entitled, and Penelope Keith managed to make her into one of the most adored (and oddly vulnerable) characters ever seen on a sitcom," Evans posted.

"She delivered every line as if it were a jewelled crown on a velvet cushion. An utter genius."

Dame Janet Suzman worked with Dame Penelope at the Royal Shakespeare Company when they were both young, and later on the 1981 film *Priest of Love*.

Speaking to BBC Radio 4's *World at One*, she said her friend and colleague became "like a comedy

Mount Rushmore" and was "enormous fun to work with".

"Those ice pick consonants of hers, that tremendous self-assurance in her character. It's just so transporting... Wonderful actress."

The Surrey-born actress joined the Royal Shakespeare company in 1963 and went on to win an Olivier Award for best comedy performance in 1976, for her role in the



play *Donkey's Years*.

But she became a household name playing Margo in *The Good Life*

from 1975, winning the Bafta TV award for best light entertainment performance in 1977.

## Clarke quits as Scotland coach

■ Despite a poor World Cup campaign, he leaves as only man to take the country to three major tournaments

Steve Clarke has resigned as head coach following Scotland's exit from the World Cup.

The Scottish FA announced his departure in a statement just moments after Croatia's win over Ghana on Saturday, which sealed Scotland's fate.

The players were told on Saturday with Clarke and the squad still at their Charlotte base.

He had signed a new four-year deal only a month ago.

The Scots defeated Haiti 1-0 in their opening Group C match in Boston, the same city where they then lost 1-0 to Morocco, before being beaten 3-0 by Brazil in Miami.

It left them with only a faint chance of going through to the last 32 as one of the eight best third-placed teams - but that hope was extinguished on Saturday, three days after the Brazil defeat.

"The most emotional part of this goodbye is for my players, without whom we wouldn't have had any of the memories that we've accumulated from 2019 until now," said Clarke.

"They deserve all the praise and adulation that they receive and it was truly an honour to be called their gaffer.

"Thanks for having me and good luck to my successor."

Clarke became Scot-

land head coach seven years ago, with the country having not reached a major finals since the World Cup in 1998.

Under his stewardship, the Scots reached two European Championships before making it to this summer's World Cup.

However, despite that qualification success, Scotland underwhelmed in all three tournaments, with the win against Haiti earlier this month the only win across the finals.

Scotland went into Wednesday's game against Brazil well placed to be one of the best third-placed teams in the competition, only for defensive mistakes to undermine that bid.

"While we are all disappointed to have exited the World Cup at the group stage, we must not lose sight of the undeniable progress made during Steve's seven years in charge," said Scottish FA chief executive Ian

Maxwell.

"From starting as a pot four team in 2019 to topping our World Cup qualifying group, he has more than delivered on the remit to take Scotland back to a major tournament.

"We thank Steve for

his record-breaking contribution and know that when the disappointment of World Cup elimination subsides, the Scotland supporters will be thankful for the memories of marching with pride at major tournaments once again."

## Stokes retires from international cricket

■ Controversial England captain and father of 'Bazball' makes announcement in the middle of a Test Match - and promptly takes a wicket

In a move that surprised supporters and shocked even his own teammates Ben Stokes has announced his retirement as captain of England's Test team, and from international cricket.

The news came during the final day of the Third Test against New Zealand, which the tourists won, after Stokes had broken the news to the dressing room on Sunday morning.

"It was shock," Stokes said of the reaction, adding that Brendon McCullum, the team's head coach, "was pretty taken aback". The decision was made public with typically dramatic timing: in the fourth day of a match, 15 minutes before tea, with England in the field and Stokes labouring through a trademark, extended bowling spell.

Having made a reputation for rising to big occasions, he inevitably took a wicket with his first delivery after the news broke. It was, as Joe Root later described it, "the most Ben thing ever".

After the close of play the 35-year-old said he had been seriously considering retirement since the first Test of the series at Lord's, which he described as "a very, very strange week" which "brought back some negative feelings about where I was in my career".

That followed a difficult period since England's humbling 4-1 defeat in the Ashes last winter, which included sustaining a serious facial injury in February.

"I absolutely love cricket, I love the sport," he said after the close of play.

"Over the last 12 months there's been certain moments where I felt like I haven't loved it. Last week back with Durham, there wasn't a moment when I didn't. Being able to compare being back with my county and here, to not feel that sense of love and complete and utter enjoyment like I have done before, you just know."

Root, having given up the captaincy in 2022 say-

ing it had left him feeling like "a shadow of the person that I wanted to be", and as a close friend of Stokes since they first played against each other as 12-year-olds, was among the first to find out about the decision, on Saturday night.

"Someone I've spoken to quite a lot around this stuff is Joe, and he gets it," Stokes said. "It's the best thing I've ever been asked to do, captain this team and captain this country. But there's another side to it all that people don't see and don't understand. As good as it is, there are bits where it does drain you, and does affect you in an emotional way. I've loved every single moment of it, but some times and some moments have been harder than others."

Root was interim captain at the Oval in Stokes's absence but has played down chances of his making a full-time comeback. Harry Brook, who captains the whiteball teams and has been Stokes's vice-captain, is considered

his most likely replacement.

Stokes made his debut in Adelaide during the 2013-14 Ashes and the weekend saw him playing in his 122nd Test, and making his 279th international appearance. Among many career highlights of a player who will be remembered as one of the country's great characters and all-round-

ers, he was a key member of the England teams who won the 2019 50-over World Cup and the T20 version in 2022, author of a heroic match-turning innings at Headingley in the 2019 Ashes. Since his appointment as the team's captain in 2022, along with with the head coach McCullum, he is considered the creator of

the controversial, ultra-attacking and now partially abandoned brand of Test cricket that came to be known as Bazball.

Stokes retires with 7,273 runs and 252 wickets in Test cricket. He is only the second player, after South Africa's Jacques Kallis, to do the double of 7,000 Test runs and 250 wickets.

## WORLD CUP: Kane brace saves England's blushes - and Mexico await in the last 16

England went from despair to ecstasy in short order on Wednesday, as Harry Kane's two late goals meant they came from behind to beat DR Congo in Atlanta to reach the last 16.

Thomas Tuchel's side were 15 minutes away from an embarrassing exit as DR Congo defended the early lead given to them by Brian Cipenga.

It was then that captain and talisman Kane came to the rescue by heading the equaliser after 75 minutes, before lashing in a stunning winner on the turn with four minutes left.

DR Congo goalkeeper Lionel Mpasi made

a string of magnificent saves to keep England at bay – although Yoane Wissa hit the post with the goal at his mercy on the stroke of half-time.

The miss kept England, who had put in a spotty performance till then, in the game.

And with time running out, Kane came to the rescue once more with a superb header from substitute Anthony Gordon's cross.

Kane's fifth goal of this World Cup was even better. He collected the ball on the edge of the box, turned, strode forward and flashed a powerful right-foot finish high past Mpasi to dig

England out of massive hole.

England will now face co-hosts Mexico at their Azteca Stadium in Mexico City on Sunday, 5 July (5pm PST).

When head coach Tuchel – and the Football Association – needed a hero to avoid a desperate defeat, Kane proved once more that world-class players produce the big moments.

And how Kane delivered in Atlanta.

His first was a powerful header that finally beat DR Congo keeper Mpasi - the second choice for Le Havre in France - who had produced a magnificent display to that point.

Credit must also go to substitute Anthony Gordon, who has had a quiet World Cup but was involved in both Kane goals after coming on as a substitute.

England move on the

cauldron of emotion that will be the Azteca Stadium - the scene of their 1986 World Cup quarter-final defeat by a Maradona-inspired Argentina - to face Mexico at altitude.

It is a last-16 tie that looked in serious danger for so long for Tuchel's side.

Mexico will not fear England – although England will feel they can only get better.

## Sleep aids and a secret location: how England hope to evade local spoiler tactics

England are taking precautions before their arrival in Mexico to ensure boisterous locals intent on ruining the players' rest and sleep do not disrupt their preparations.

Thomas Tuchel's side face Mexico in their World Cup last-16 tie on Sunday but are due to arrive in Mexico City on Friday so will spend two nights before the game in the capital.

Mexico's last-32 opponents Ecuador lodged a complaint to Fifa after their squad were deliberately kept awake by noisy Mexico supporters, who used loudspeakers, horns and motorcycles outside the team hotel late at night.

The Ecuador team stayed in the Westin Hotel in Mexico City, and, while England want to keep their location undisclosed, there is a concern that the location will eventually be leaked on social media.

With that in mind, England players and staff who have not brought their own sleeping devices, such as ear plugs or sleep bands, are to be offered natural sleep remedies or white noise audio machines to ensure sleep is not impacted.

The arrival two days before the game is a change in schedule for England, who generally land in the host city the night before.

Among the other challenges England will face is playing the game against Mexico in high altitude.

Mexico City has an average elevation of approximately 2,240 metres above sea level, meaning there is less oxygen available. This can impact the performance of some players, especially when they are not acclimatised to the conditions.

To that end, Mexico have played all four of

their World Cup games so far at high altitude conditions, with three fixtures at the Azteca Stadium in Mexico City and the other in Guadalajara – which is on average 1,566 metres above sea level.

Ideally, athletes competing at high altitude should spend a week or two living at that level in order to allow their body to acclimatise and generate more red blood cells.

Tuchel has conceded his team will be at a disadvantage when England face Mexico this weekend.

"The altitude will be a big disadvantage because we cannot physically adapt to it," said Tuchel.

"And in four days, it's just impossible. More obstacles may come, but we are ready for that.

"My understanding is that we cannot adapt to the altitude. That is just a huge advantage that Mexico will have."
