TEARS FOR KEIR!

■ Starmer bows out as PM amid emotional scenes in the House

Chancellor Rachel Reeves appeared moved to tears as Sir Keir Starmer took part his final Prime Minister's Questions on Wednesday.

Sir Keir heard emotional tributes and faced jokes at his expense in his final outing from the dispatch box before Andy Burnham is set to become the new Labour leader.

The Prime Minister received a standing ovation and applause from hundreds of MPs. Ms Reeves, who is set to be replaced as Chancellor when Mr Burnham enters Number 10, was visibly emotional.

Veteran Conservative MP Graham Stuart began the questioning by linking the PM's departure to the England football team, joking that "400 dodgy referees" had show him a "red card".

'a ruthless game'

He said: "Most of us, Mr Speaker, can only dream of playing the role of Jude Bellingham, scoring the winning goal, leading our team to victory

"Yet the Prime Minister did it. But politics, like football, is a ruthless game, and he's now been handed a red card by the 400 dodgy referees behind him.

"What advice does this Prime Minister have

for the right honourable member for Makerfield [Mr Burnham] to ensure that he, unlike himself, doesn't end up with an early bath?"

Sir Keir replied: "I think that's the first and sadly, probably the last time, I'll be compared to Jude Bellingham. But I will I thank him for that."

warm words

He declined to take a swipe at Mr Burnham, who was not in the Commons on Wednesday.

"And on the question of red cards, I can't tell him how much incoming I had a week ago Monday, after President Trump intervened for their red card, for me to get the England red card adjusted," Sir Keir added.

"Just for the record, Mr Speaker, I didn't. But for my successor and for the England team, I won't give advice. I will simply give my wholehearted support."

Tory leader Kemi Badenoch also had warm words for the outgoing PM, telling the house she particularly admired how the Prime Minister had in-

vited Ukrainian president Volodymyr Zelensky to Downing Street after his confrontation with Donald Trump and other senior members of his administration.

Sir Keir said: "On that meeting with President Zelensky, the day after he was evicted from the Oval Office, he left alone, he got a plane, we got him to come to London, and I asked him to come to Downing Street straight away.

"I walked out to meet him, I gave him a hug, and then I showed him what was in the street which was many people who had come, thinking that he was visiting Downing Street, and the moment he got out the car and hugged me, they cheered from the top of their voices, the British people, to tell President Zelensky exactly what they thought of him and the way he had been treated, and that was a really emotional moment, because it was the first human contact he had effectively had outside of his immediate team since he left the Oval Office."



DODGY RED CARD? football analogies flew thick and fast as Sir Keir departed

Sir Keir thanked his team and said "I love you" to his wife Victoria and children, who were watching in the rear gallery in the House of Commons. Responding to a tearful question from Labour MP Carolyn Harris who thanked him and his family for their "friendship", Sir Keir replied: "Can I thank her question, for her support and friendship to me, to Vic, and to the kids."

'political journey'

"Whatever the challenge, she has always been there for us, particularly Vic and the kids, and I really thank her for that."

He continued: "Every Prime Minister knows when they take up the torch that the day will

come when they have to pass it on. That day has come for me. This is the end of my political journey.

"In six years, went from historic defeat in 2019 to historic victory in 2024, and in two years in Government, I leave the country in better shape than I found it."

standing ovation

He thanked Commons speaker Sir Lindsay Hoyle, fellow MPs and the Civil Service, and paid tribute to his team who had been "prepared to walk through fire" for him.

He ended: "To all those in the gallery whose lives have been changed or improved by this Labour Government, and all

across the country who struggle to be seen or heard, you're the reason I came into politics.

"To my wife and children, I love you. Goodbye."

He received a standing ovation by the majority of the Commons, although the Conservative bench remained seated and did not applaud.

Commons Speaker Sir Lindsay Hoyle also paid tribute to outgoing Prime Minister.

Sir Lindsay thanked him "for his public service, his international leadership, particularly in his steadfast support for Ukraine". He added: "I am sure members will wish to join me in wishing him and his family well in the future."

Spain and Gibraltar celebrate as border fence falls after signing of 'historic deal'

Spain and Gibraltar celebrated the fall of the last frontier fence in western Europe this week after the signing of a post-Brexit deal that brings an end to border checks for residents, tourists and the thousands of Spanish workers who cross into the British overseas territory every day.

The agreement, which was signed in Brussels on Tuesday and came into effect at midnight, marks the conclusion of more than four years of negotiations between the UK, Spain, Gibraltar and the EU after Britain's departure from the bloc.

fluid frontier

The deal eliminates border controls and customs checks to create a fluid frontier, and gives Spain responsibility for Schengen

controls at Gibraltar's airport and port. It has also led to the removal of the border fence that has physically separated Spain from Gibraltar since 1908.

'open wound'

Gibraltar, which was ceded to the British crown under the treaty of Utrecht in 1713, is home to only about 40,000 people and relies heavily on the 15,000 Spanish workers who cross into the territory each day. The Rock, as the territory is nicknamed, is also hugely important to the economy of the neighbouring Campo de Gibraltar region of Andalucía.

Under the previous system, long rush-hour queues formed at the border, especially during periods of heightened ten-

sion between Madrid and London.

Spain's prime minister, Pedro Sánchez, who visited the Spanish border town of La Línea de la Concepción on Wednesday to witness the removal of the final section of the fence, said history was being made as an "open wound" was finally closed.

"The Gibraltar fence – the last wall in continental Europe – has fallen so that we can take a step towards a new era of coexistence and shared prosperity," he said. "This is a deal that has the well-being of the 300,000 Andalusians in the Campo de Gibraltar at its heart, and which opens a new phase in the relationship between Spain and the UK."

Gibraltar's chief minis-

ter, Fabian Picardo, also said the treaty, which does not affect the territory's British sovereignty, marked the beginning of a new era.

'shared opportunity'

"The frontier that has so often divided and con-

strained our region will now become a place of co-operation and shared opportunity," he said. "The daily lives of thousands of people will be made easier, our economy will be given greater certainty and Gibraltar's future will rest on firm legal founda-

tions."

Picardo added: "We have reached this moment without surrendering who we are, without compromising our British sovereignty and without weakening the constitutional protections that define Gibraltar."

Covid inquiry: £10bn in taxpayer money 'wasted'

■ Procurement programs for PPE were slow, inefficient and favored the politically well connected, says latest Pandemic report

The latest report from the Covid-19 Inquiry has found that nearly £10 billion of taxpayers' money was wasted during the pandemic as the UK and devolved governments scrambled to buy per-

sonal protective equipment.

The Inquiry's chair, Baroness Hallett, said the UK entered the pandemic with 'severely depleted and defective stockpiles', leaving front-line work-

ers unprotected and the country reliant on overpriced substandard equipment.

A shortage of the right equipment at the right time had a profound effect on the front line, the

report said. Many doctors, nurses and care staff had to work without adequate PPE and were unable to protect themselves or those in their care from the virus.

Professor Kevin Fong worked for NHS England at the time, supporting colleagues at the hardest hit sites.

He said: "They had nothing. I visited hospitals where they went to work in bin liners, in swimming goggles, they went to hardware shops, got visors, they wore patient gowns, they wore waterproof overalls. This is how desperate they were for PPE."

"And they were not protected, and they knew they were not protected, and yet they still turned up."

"shortage of PPE, particularly in the first few months of the pandemic,

was mainly down to poor planning, the inquiry found. The UK was simply not ready to compete in the global race to buy and import vital health care equipment. So, in late March 2020, against official advice, the government issued a public call to arms for more suppliers to come forward.

To try to sort through all the new offers, a high priority or VIP lane was set up, fast tracking those with political connections. Baroness Hallett described that policy, one of the most controversial of the pandemic, as misguided.

The high priority lane embedded unfairness in the UK government's emergency procurement and it undermined public trust in how the government chose to spend taxpayers' money during the pandemic. It should

not have been set up and it should not be repeated, said the report.

But Hallett said the inquiry could find no evidence of cronyism by ministers or other officials in those final decisions to award contracts. The Cabinet Office Minister at the time, Michael Gove, said that honest mistakes had been made, but allegations of corruption were "unfounded nonsense."

Allegations have been made in the past by people who were politically motivated. But this inquiry has made it clear that those who were responsible for operating PPE procurement may have made mistakes, but they were honest mistakes and cronyism and corruption did not feature at all.

But public suspicions continue to be fuelled by the decision to re-

Three asylum seekers jailed for Brighton beach attack

Two men who raped a woman on Brighton Beach and a third who filmed it have been jailed for what's been described by a judge as a predatory and callous attack.

The asylum seekers from Egypt and Iran attacked the woman in October last year after she became separated from her friends.

Hove Crown Court had been told how Ibrahim al-Shafe from Egypt and Iranian national Abdullah Ahmadi, both 26, led their victim behind a beach hut and raped her in the early hours of October the 4th last year.

21-year-old Egyptian national Karin Aldanisert filmed the attack. The three men had been living at home office approved accommodation for asylum seekers near Horsham in West Sussex at the time.

Al Shafay and Ahmadi were jailed for 21 years and Aldanisert was jailed for 18.5 years for his role in the attack.

Ministers have vowed to deport the three men after they have served their sentences.

dact parts of the report. A whole chapter on the company PPE Medpro linked to the businessman Doug Barrowman and his wife Baroness Michelle Moe was removed while an active investigation by the National Crime Agency is taking place. Both individuals deny any wrongdoing.

This is the fifth of ten separate investigations into different aspects of the pandemic to be published by the Covid Inquiry. Findings on the care sector and the impact on children's education are both due in the autumn.

Widdecombe: could former Conservative minister's murder be part of wider campaign targeting Reform UK figures?

FORMER Conservative MP Ann Widdecombe has been killed in what police describe as a "targeted attack" with detectives still working to understand the motive.

The body of Widdecombe, 78, who was better known in recent years for her role as spokesperson for Reform UK on the Rupert Murdoch-owned channel Talk TV, was discovered on Thursday 9 July at her home in Haytor, Devon. She had sustained serious injuries in an attack police believe took place the previous day.

While Devon police initially said there was no reason to assume a political motive to her death, within days the situation had changed, with Assistant Commissioner Laurence Taylor, Head of Counter Terrorism Policing, taking over the investigation and telling reporters said he did not want to rule anything out.

A white British man, 28, was arrested on Saturday. He was re-arrested on Monday on suspicion of the commission,

preparation or instigation of acts of terrorism.

Taylor said a counter-terrorism investigation is "running in parallel" to the murder investigation but the suspected killing "has not been declared a terrorist incident at this stage".

He told reporters: "It is clear that this was a targeted attack. We are still working to understand the extent of any planning or preparation, and the motivation that sits behind that attack."

"I wouldn't want to comment on what that motivation was."

Taylor added: "There are multiple lines of inquiry that we are pursuing expeditiously, and that includes a number of digital forensic examinations."

The counter terrorism police chief also said he would not comment on whether they were investigating whether a foreign state was involved or on details about the planning and preparation of the attack.

"We are working through what the moti-

vation for the attack currently is," he said.

On Monday, Home Secretary Shabana Mahmood told the House of Commons the suspect was not known to the government's Prevent anti-terror scheme.

Taylor would not comment on whether the arrest on suspicion of terror offences means the suspect potentially committed terrorism offences separate to the murder case, or whether any other politicians were potential targets.

He said: "This is a murder investigation following a brutal attack on a 78-year-old woman

in her own home."

There has been a "deeply distressing impact on Miss Widdecombe's family", he added.

"My request is that we don't over speculate and that we go where the investigation takes us. In terms of motive it would be wrong for me to ascribe either an ideology, or what the motivation might be at this stage."

Later in the week concerns grew about a likely wider conspiracy targeting leading members of the Reform UK party. On Thursday party leader Nigel Farage accepted a meeting with govern-

ment officials to discuss his security. Farage had previously rejected an offer from Parliament for state funded protection last year because he believed it had been downgraded and wasn't sufficient. Reform claim their leader has had almost 600 death threats since February.

The Liberal Democrat leader, Sir Ed Davey, has questioned whether Nigel Farage will approach the meeting in good faith and said claims about his security should be scrutinized. Downing Street said no politician should be targeted or face abuse.

UK gives go-ahead for Ebola vaccine trials

■ Oxford University at forefront of research

A new vaccine to tackle Ebola will launch human trials this week after the UK regulator gave permission for such trials to take place.

Scientists at the University of Oxford started developing the vaccine eight weeks ago when a public health emergency was declared on 17 May.

It is the first - out of four vaccines under development - to enter clinical trials.

Volunteers are being recruited, with the first doses expected to be given to healthy adults in the UK "within weeks".

The Ebola epidemic, centred on the Democratic Republic of the Congo has killed 625 people with 1,792 laboratory confirmed cases.

It is caused by the Bundibugyo species of Ebola, which has started two outbreaks before.

The six different species of Ebola are known as "sisters rather than twins" because while they are similar, they need separate treatments and vaccines. It means there are no approved drugs or vaccines this time.

The outbreak is still

not under control and is taking place in a conflict zone with very mobile populations - heightening the need for a vaccine to help stop the spread of disease.

Dr Katrina Pollock, the

chief investigator of the trial based at the University of Oxford, told reporters: "We're doing phase one (early stage) trials of new vaccines all of the time, precisely to be ready for

exactly this kind of outbreak."

The trial will be on 50 healthy adults aged 18-55. Researchers are also working with partners in Uganda to prepare for trials in Africa.

IMF warns UK against Burnham spending spree

Britain must "stay the course" and stick to Rachel Reeves' fiscal rules in order to avoid market pressures, the International Monetary Fund (IMF) has warned.

The IMF, which advises on policy and gives financial aid to member countries, backed the chancellor's economic strategy amid what it called "domestic uncertainty" and global challenges in the wake of the US-Iran war.

'good balance'

It said the government's medium-term approach "continues to strike a good balance" between deficit reduction and growth-friendly spending.

In its latest assessment, the IMF gave Britain's economic growth outlook a modest upgrade, though conflict in the Middle East is dampening prospects, threatening rising living costs and borrowing rates.

"Staying the course on deficit reduction will be important given market pressures and elevated implementation risks," it said.

It added: "Given elevated implementation risks, sticking to the planned deficit reduction and proactively developing contingency measures would help protect fiscal credibility."

The UK's borrowing costs hit a 28-year high last week, as City traders braced for a potential Labour leadership challenge from Andy Burnham.

The Greater Manchester mayor's declaration that he would seek to return to parliament, paving his way for a leadership challenge, sparked speculation that a new Labour leader could increase spending and government borrowing.

Young pair plead guilty to £39m cyber attack which crippled London Transport

■ August 2024 hack disrupted services for three months

Two men have pleaded guilty to offences in connection with a massive cyber attack which caused Transport for London (TfL) months of disruption and cost the operator £39m.

Thalha Jubair, 20, from east London and Owen Flowers, 18, from Walsall in the West Midlands changed their pleas on what was expected to be the first day of a six-week trial at Woolwich Crown Court on Monday.

The pair admitted to charges of conspiring to commit unauthorised acts against TfL under the Computer Misuse Act.

TfL previously said the hack disrupted services

for three months when it began on 31 August 2024. The breach affected an estimated 10m customers.

Flowers also pleaded guilty of attempting to hack computer systems belonging to California-based Sutter Health and another US company, SSM Healthcare Corporation.

The transport operator's online services were impacted and customers were unable to see some information boards because they went offline during the attack.

Data from TfL's Oyster refunds system was accessed and the incident also affected TfL's customer refund system,

leaving some out of pocket for much longer than usual. It also closed down the application system for Oyster photocards for children and young people.

TfL wrote to thousands of customers to tell them about the unauthorised access to some personal

information.

Investigators from the National Crime Agency (NCA) said they believed the "network intrusion" in summer 2024 was carried out by the online criminal group known as Scattered Spider.

The group has been linked to other cyber at-

tacks on Jaguar Land Rover and retailers including Marks and Spencer.

Following the guilty pleas, the NCA said both men were had been arrested at their home addresses on 16 September 2024 as part of a joint in-

WE DON'T WANT HIM! Pakistan resist British efforts to deport Rochdale grooming gang leader

"Regardless of where he was born, the onus lies on where he grew up, was raised, groomed, and unfortunately spoiled."

Pakistan is resisting attempts by the UK government to deport a freed ringleader of a Rochdale grooming gang.

Tahir Andrabi, a spokesman for Pakistan's Ministry of Foreign Affairs, said that Shabir Ahmed must be dealt with in accordance with UK laws and the government of Pakistan has "no connection whatsoever with this matter".

dual citizenship

Calls have mounted for Ahmed's deportation but legislation from 1971 bars it. Ahmed's removal depends on Pakistan accepting him despite the UK government proposing to change the law.

Ahmed had dual British-Pakistani citizenship before being stripped of his UK passport following his 2012 conviction for multiple counts of rape and sexual offences against girls.

'internal matter'

Ahmed, who came to the UK in the late 1960s, was one of nine men from Rochdale and Oldham found guilty of exploiting girls as young as 13 at two takeaway restaurants.

Andrabi said Ahmed's "heinous crimes demand serious introspection rather than the quest to search for extraneous causes".

He said: "The matter in question is entirely an internal matter of the United Kingdom.

"The individual concerned is a British national who spent his entire adult life in the UK and was duly convicted by a British court for reprehensible offences committed on British soil.

"no connection"

"Any decision regarding his release, supervision of usual legal status, falls exclusively within the jurisdiction of the competent British authorities and must be dealt with in accordance with the laws of the United Kingdom.

"Regardless of where he was born, the onus lies on where he grew up, was raised, groomed, and unfortunately spoiled."

He added: "The government of Pakistan has no connection whatsoever

with this matter.

"We cannot be associated with any decisions relating to the individual's release or subsequent treatment under the British law."

Ahmed was jailed for 22 years and released on licence this month.

Victims of the gang were told provisions under the Immigration Act

1971 barred the removal of any Commonwealth citizen who arrived in the UK before 1973 and had been in the country for five years.

Under the UK government's proposed amendment, foreign criminals would no longer benefit from these protections where they are guilty of some serious crimes.

Heading caused Nobby's brain damage, coroner rules

■ World Cup winner died in 2020, left bed-bound by his dementia

England World Cup winner Nobby Stiles died with a brain condition caused by repeatedly heading a football, a coroner has ruled at his inquest.

The former Manchester United and 1966 World Cup-winning midfielder died with severe dementia in 2020 aged 78 and had headed a football about 140,000 times in his career, Stockport Coroners' Court heard.

Neuropathology expert Dr Daniel Du Plessis told the court: "I'm quite convinced his heading the football that many times has caused his CTE [chronic traumatic encephalopathy]."

Senior Coroner Alison Mulch recorded the cause of death as Alzheimer's disease, contributed to by CTE, along with another neurodegenerative condition and cerebrovascular disease.

Norbert "Nobby" Stiles, born in Collyhurst, Manchester in 1942, was a tough-tackling defensive midfielder.

He was capped 28 times by England and played nearly 400 times for Manchester United.

'no surprise'

He lived in Stretford, Greater Manchester, before he died in a care home on 30 October 2020, having been left bed-bound by his dementia.

His family has campaigned for football authorities to do more to help ex-players cope with injuries they claim were caused during their playing days.

Speaking outside court after the hearing, Stiles' son John said the coroner's ruling was "no surprise" but the football industry "refuses to provide help" and warned his father's could be the first of many

similar inquests.

Giving evidence to the inquest earlier, John said: "Heading the ball in training was absolutely massive", adding that, on a very conservative estimate, his dad had headed the ball 40 times a day, five times a week over each 10-month season.

He said his father was "very humble - he just happened to achieve quite a lot in the professional game".

'feeling of doom'

He added: "He went into his house and you wouldn't know he was a footballer. Football was left at the door."

"Family was always his first priority and then his friends"

The coroner put it to him that it seemed "football, it wasn't a dominant factor" in his dad's life.

He replied: "It really wasn't at all - he never

talked about it - it was just something that happened to him.

"We were much more proud of the father than the footballer."

The court heard that Old Trafford used to have a ball that would hang down from the stand and the players were encouraged to head it.

Stiles' son stressed to the hearing that "this wasn't forced upon them but they obviously didn't know what was happening".

The family started noticing Stiles was forgetting things and asking the same question several times in his late 50s and early 60s.

"For a long time, there was a terrible impending feeling of doom by the family - we didn't know what was happening but

we could feel it coming on," John said.

By 2010, his dad was not well and "that was when he made the decision to sell his medals", he told the inquest.

The inquest was told expert analysis of Stiles' brain showed his severe dementia was as a result of Alzheimer's disease but also CTE.

Du Plessis, a consultant neuropathologist at Sal-

ford Royal Hospital, said: "In this case, it is quite clear that Mr Stiles had advanced dementia and he died of his dementia - that is the primary cause of death here."

"Added to the mix was CTE - we know it is caused by people who have head injuries."

"I'm quite convinced his heading the football that many times has caused his CTE."

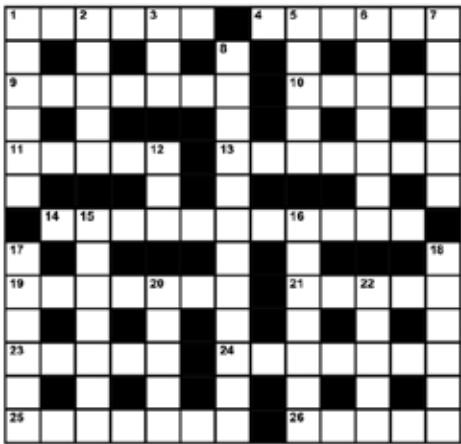

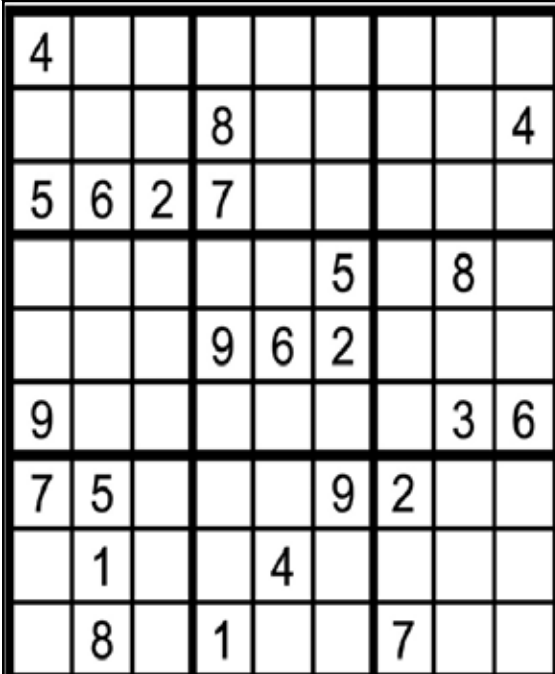

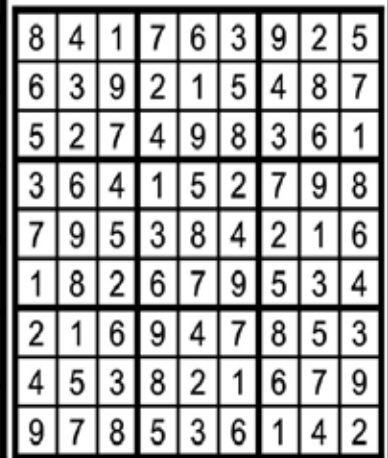

vestigation with the City of London Police.

The agency said investigators seized laptops, desktop computers, hard drives and USB devices from Flowers' home.

One laptop contained

a screenshot showing connectivity to TfL infrastructure, while videos found on the device appeared to show Jubair accessing TfL systems during the attack. The NCA said the pair communicated via Telegram and an online collaborative workspace.

Energy drink ban for U16s on tap in the UK

Children under 16 will be banned from buying high-caffeine energy drinks in England from April, the government has said.

Drinks containing more than 150mg of caffeine per liter will be illegal to sell to children and younger teenagers in shops, restaurants, cafes, vending machines and online.

Lower-caffeine soft drinks, such as Diet Coke, are not affected and neither are tea and coffee. However, drinks including Red Bull, Monster, Relentless and Prime would all breach the limit.

The new rules aim to reduce obesity levels in children and prevent issues such as disrupted sleep, increased anxiety and lack of concentration, as well as poor school results.

Announcing the new measures, first proposed last year, Public Health Minister Sharon Hodgson said the ban "demonstrates our firm commitment to creating the healthiest generation of children ever".

The ban, subject to parliamentary approval, will be enforced by local authorities and businesses that break the law could face fines of up to £2,500.

Around 100,000 children in England consume energy drinks every day and has warned the beverage.

Ten unreleased David Bowie tracks set to be shared with the public

Ten unreleased tracks by David Bowie are set to be shared with the public, recorded in the early part of his career when he was known as Davie Jones.

David Bowie: The Shel Talmy Recordings has been billed by the singer's label as "the most complete collection of tracks recorded by a nascent David Bowie" with his then-producer Shel Talmy.

The collection includes contributions from guitarist Jimmy Page, who would go on to form Led Zeppelin, and pianist Nicky Hopkins, who also worked with the Beatles, The Who and The Rolling Stones.

One of the unheard singles, I Want Your Love, was uploaded to streaming services on Wednesday ahead of the release of the full collection on 18 September.

Other previously unheard songs set to be released include Cupid, Leave Her to Me, You Gotta Tell Her, Certain Woman, Today, I Live in Dreams and I Do Believe I Love You.

Some singles from this period of Bowie's career have previously been made available – including Can't Help Thinking About Me and Do Anything You Say.

Other tracks set to be included in the new compilation are titled You've Got A Habit Of Leaving and Baby Loves That Way.

Writing in the sleeve notes that accompany the album, music historian Alec Palao said: "David Bowie the artist

is a book of chapters, the turn of each page delivering something completely different and unexpected from the last.

"Each fascinating phase in his career should be considered complementary. This collection, a primary chapter if not the very earliest instalment in David's musical journey, deserves legitimate consideration. Producer Sheldon Talmy, who died in 2024, is best known for his hits You Really Got Me with the Kinks and My Generation by The Who.

He and Bowie first met while frequenting London's Denmark Street, which was the centre of the British music industry of the time.

The Soho street was where songwriters sold their songs to the big music publishers at the time.

US ex-pat Talmy signed Bowie and the Manish Boys in December 1964, but the singer had already moved on and formed Davie Jones & The Lower Third.

The majority of the

Bowie went on to become one of the world's most influential music stars

recordings Bowie made with Talmy featured The Lower Third or were solo demos.

The year after those songs were recorded, the singer changed his

name to David Bowie to avoid confusion with Davy Jones of the Monkees.

He enjoyed his career breakthrough in 1969 with Space Oddity, be-

fore developing his Ziggy Stardust alter-ego in 1972, and went on to become one of the most successful and influential stars in music history.

edgement that ceding ground on the pitch when defending a lead is a natural instinct for players.

But, equally, there is believed to be a consensus among certain players that Tuchel's tactical switches and substitutions exacerbated their defensive retreat.

Certain players believe the team should have had greater license to press the ball during the closing stages in an effort to at least try and push Argentina away from their goal – even just to provide some respite for the defenders.

But instead, while some players recognized it as the team simply resorting to clearing their lines and regrouping their shape in defence – it was a tactic some didn't agree with.

There is certainly a sense from some players that they could have been bolder and braver in those closing stages – not necessarily to go hell for leather in search for a second but to strike a balance between withstanding the Argentine pressure but also giving their opponents something to worry about in attack.

Another said: "The Argentine full backs were both on yellow cards, with the pace have on the bench it was insane to not replace Gordon with Marcus (Rashford) and put Bakayo Saka on the right. We desperately need an out ball but there was nobody to give it to."

Of course, players not necessarily agreeing with their manager's approach is not uncommon.

Professional footballers are used to carrying out instructions, even if they don't agree with the direction.

But some of the consternation from players towards how England were instructed to finish the game certainly paints an interesting picture heading into the rest of Tuchel's reign.

Tuchel: new boss just like the old one?

It all felt rather familiar as England exited the World Cup with a 2-1 semi-final defeat by Argentina on Wednesday.

Too timid when ahead, poor use of substitutes, sitting back too deep and when faced with their first real big opponent of the tournament, and a crushing defeat.

All well-known – if at times perhaps unfair – criticisms of Sir Gareth Southgate's England teams.

But this was under the management of Thomas Tuchel, the German brought in to signal a change of approach for England – one that was supposed to bring a first World Cup in 60 years.

So with comparisons being drawn between Tuchel and his predecessor, what has really changed for England?

In March 2025, Tuchel was asked about England's Euro 2024 campaign under Southgate.

He did not hold back. Tuchel felt that England did not have "a clear playing style".

When asked what was missing, he reeled off a long list: "The identity,

the clarity, the rhythms, the repetition of patterns, the freedom of players, the expression of players, the hunger.

"[England] were more afraid to drop out of the tournament, in my observation, than having the excitement and hunger to win it."

Fast forward 16 months and Tuchel's analysis of his predecessor's side could indeed be applied to his team's 2-1 loss to Argentina.

What was Tuchel trying to do differently to Southgate?

The German has taken a system-first approach to international management. His World Cup squad left out a wealth of technical talent including Phil Foden, Cole Palmer and Trent Alexander-Arnold.

Before raw quality or star names are considered, Tuchel had in mind the type of team he wanted to see, leaning on specific tactics and the aforementioned "repetition of patterns".

And so the players he selected were the ones that he felt could best carry out the roles he wanted

in his England system.

Tuchel selected similar profiles to maintain the squad's style, banking on nothing but plan A working – something which ultimately did not happen.

The "identity" of his side was supposed to come in the form of a few key principles.

Tuchel and his assistant coach, Anthony Barry, have spoken about borrowing ideas from the current version of the Premier League.

Building up short, enticing pressure, playing quickly across the middle of the pitch – whether through powerful carry-

ing or long balls – to find runners in attack against fewer defenders were all ideas England were seen trying to do every game, to varying levels of success.

The second half of the 4-2 win against Croatia, in their opening match, was perhaps the closest example of what Tuchel's ideal version of England was meant to be.

The other part of Tuchel's system that was continually emphasized was use of wide triangles to create chances, with the 52-year-old reluctant to see his side build through the centre.

Rotations and runs off the ball between the full-back, central midfielder and winger before arriving at the byline was supposed to be the main method of chance creation for Tuchel's England, but as much as they tried to make it click, it again did not come to fruition.

Once the dust has settled and the tears have dried, the nation will be left with those all-too-familiar questions: where did we go wrong? Is the answer a new manager? Different players? And finally, and most painfully: will we ever win a major tournament again?

Meanwhile, at least England's Test coach has been canned...

Brendon McCullum has been sacked as Test coach in another staggering twist in the unravelling of the England team.

Two weeks after Ben Stokes made the stunning announcement to step down as captain and retire from international cricket, McCullum's exit brings a definitive end to the Bazball era.

The New Zealander will continue as England's white-ball (One Day Test) coach, but he leaves the Test team following a string of poor results and several off-field incidents.

Director of cricket Rob Key will remain in position, with the decision to remove McCullum com-

ing after the hierarchy of the England and Wales Cricket Board spent time reflecting on the situation surrounding the men's team.

"I've absolutely loved coaching the Test side and I'm incredibly proud of what we've achieved together," said McCullum. "There've been some unbelievable highs and a few tough days along the way, but that's all part of taking on a challenge like this."

"Of course I'm gutted not to be continuing, but I respect the decision. My focus now is on giving everything I've got to the white-ball teams and helping England keep moving forward."

England have lost sev-

en of their past nine Tests, including the 4-1 Ashes hammering in Australia. McCullum, Stokes and Key were backed to remain in charge following that defeat, only for England to be beaten 2-1 by New Zealand.

The defeat by the Black

Caps – England's first in a home series of at least three Tests for 14 years – was overshadowed by a nightclub incident involving Stokes and Gus Atkinson, then Stokes' abrupt retirement.

Now, the England Test team has no head coach

and no captain, with the next series against Pakistan beginning on 19 August.

Harry Brook appears favourite to be named as Test captain, though that appointment could now hinge on the identity of the next head coach.

World Cup 26:

Heartbreak Yet Again.

■ Familiar failings as England surrender lead to lose World Cup semi-final to bitterest foe

England were left heartbroken - yet again - on Wednesday with their World Cup dreams shattered as Argentina struck twice late on to come from behind and win a dramatic semi-final in Atlanta.

Thomas Tuchel's side looked on course to reach England's first men's World Cup final since their win in 1966 when Anthony Gordon gave them the lead in a feisty encounter after 55 minutes.

Argentina, however, were inspired and turned the contest around when Enzo Fernandez struck a magnificent equalizer with five minutes left, before Lautaro Martinez headed in a stoppage-time winner from Lionel Messi's cross.

England's wait for success goes on as they now face France in the third-place play-off, while Argentina will attempt to retain their crown against Spain on Sunday.

The searing atmosphere inside and outside Atlanta Stadium was mirrored by a feisty first half littered with 19 fouls, as American referee Ismail Elfath struggled to keep control.

Fernandez came closest with a long-range drive just off target, but it was England who made the breakthrough when Morgan Rogers justified his selection with a perfect right-wing cross for Gordon to score at the far post.

Argentina were stung into action and it required a brilliant reflex save from England keeper Jordan Pickford to keep out Nico Gonzalez's header.

As England came under severe pressure, Alexis Mac Allister headed against the post before Argentina finally levelled five minutes from time, beating the defiant Pickford with a 25-yard drive.

Tuchel had set up England to defend the box with four central de-

fenders, but Argentina's momentum was unstoppable, Mac Allister hitting the woodwork once more before England finally crumbled in the 92nd minute and Martinez scored to settle an enthralling semi-final.

England, as they have done on other occasions when victory seemed theirs for the taking, most recently under Sir Gareth Southgate, were suddenly consumed by caution

- and head coach Tuchel must take his share of responsibility.

From a position of rel-

ative control, only relative in this sort of atmosphere against Argentina in a World Cup semi-final,

Tuchel and England conceded the initiative with devastating consequences.

Dissent in squad over tactics

England's defensive retreat in their agonising World Cup semi-final 2-1 loss to Argentina on Wednesday has become the big talking point - and that topic is also being hotly debated among members of Thomas Tuchel's squad.

A number of sources have indicated to reporters that a clutch of key players were left disappointed at how the team approached the final stages of the game.

However, fresh comments from Tuchel have emerged in which he said that it was never the plan to drop deeper and that "it's maybe not in

our DNA...to control the game and ball".

Leading 1-0 with 35 minutes left to play, England appeared to be on course for their first men's World Cup final since 1966.

But the momentum shift was startling. While it was natural for Argentina to start chasing the game, England have been criticised for seeming to hand their opponents the initiative.

England manager Tuchel set his team up with a back-five to defend their lead - only to see it being overturned in the closing stages amid wave after wave of Argentina

pressure.

TV pundit Wayne Rooney said the defeat "started from the manager and the decisions he made".

Players saw their families and loved ones immediately after the defeat in Atlanta and it is understood there was a definite sense in those moments that the way the team was set-up after going ahead was a contributing factor in their downfall.

At least three senior players are known to have complained privately about the team's approach during the closing stages.
