Burnham pledges to “bring back hope”

“Britain needs to show the world that we can regain our stability once again.”

Andy Burnham pledged to “bring back hope” to Britain, as he began his tenure as prime minister by appointing Labour stalwart John Healey as chancellor.

In his first speech to the nation in Downing Street, Burnham said he wanted to bring forward the “biggest changes in the last 40 years” to British politics.

Speaking on Monday as replaced Sir Keir Starmer at No. 10, Burnham outlined his intention to unveil a 10-year “new plan for Britain” later this year, explaining this would lay out a path to where he believes “we all want Britain to be”.

Burnham promised to make announcements this week to “give people some breathing space now, some help with the cost of living” and explain how he would pay for them.

“Britain needs to show the world that we can regain our stability once again. And that is our challenge, to make politics work, to make it

work better. I know people at home are fed up with politics.

I hear you, and I want to be honest with you. We have not been good enough, and we need to be better. We will be,” he pledged.

“Let us make this the moment when Britain starts to believe again, the moment we bring back hope. Thank you very much, everybody.”

Burnham also started making cabinet appointments after removing loyalists of his predecessor. Out went Rachel Reeves as chancellor, David Lammy as deputy prime minister and justice secretary, and Steve Reed as communities secretary.

Healey, who quit Sir Keir’s government due to a row over defence spending, was in as chancellor.

With Burnham say-

ing he wants to honour the UK’s commitments on defence spending, Healey will face the challenge of finding the extra money he believed the last government failed to deliver to keep the UK safe.

‘work in lockstep’

Speaking to broadcasters, Healey said the pair will “work in lockstep to meet the fiscal rules with a buffer against uncertainty” and on how they will “make life more affordable for working people right across the

UK”.

Ed Miliband moves from energy secretary to foreign secretary, replacing Yvette Cooper who is now the health secretary.

Miliband said it was the “honour of my lifetime” to become foreign secretary, a role his brother David held between 2007 and 2010.

Shabana Mahmood remains as home secretary and Louise Haigh takes on the role of Burnham’s fixer across government, serving as first secretary of state, chancellor of the

Duchy of Lancaster and minister for the Cabinet Office.

Angela Rayner returned to a cabinet job as housing secretary, a role she previously held in Sir Keir’s government. She stood down in September 2025 after admitting she underpaid stamp duty on her £800,000 flat in Hove.

Wes Streeting, the former health secretary who at one stage was seen as a possible leadership challenger, is the new defence secretary.

Conservative Party

leader Kemi Badenoch welcomed Burnham to his new role but said he has not “set out a clear plan for government”.

She said “Britain needs a leader who can take difficult decisions, not a people pleaser” and criticized him for “promising to undo Margaret Thatcher’s policies”.

Burnham’s first policy pledge as PM was to end rough sleeping in the country, something he promised for Greater Manchester but failed to achieve during his time as mayor for the area.

Streeting blasts Moscow after live fire off the coast

British and Russians trade barbs after frigate's gunnery practice 40 miles south of Plymouth

The new defence secretary, Wes Streeting, has said it was 'performative and irresponsible' for a Russian warship to fire live weapons off the British coast on Monday.

The vessel carried out a 30-minute drill off the Devon coast after giving a warning to British and French forces.

The Russian frigate Neustrashimy (English: Dauntless) had informed the Royal Navy Offshore Patrol Vessel, HMS Tyne, of its intention to conduct gunnery activity, and later responded to Streeting's criticisms by insisting there was no link between the exercise and Andy Burnham taking office as prime minister.

"All [military] exercises and all actions undertaken by our warships are carried out in strict compliance with international and maritime law," Kremlin spokesman Dmitry Peskov said.

"Therefore, there is no need to see any signals in this," he said.

However, Peskov add-

ed that Burnham had sent signals to Russia, saying: "One of the first things the new British prime minister did as he took office was to declare his unconditional support for Ukraine and, accordingly, declare the UK's intention to continue doing everything it possibly can to continue the war."

safer distance

Streeting said Russia "should be in no doubt about the resolve" of the new government and prime minister.

The live-fire exercise took place in international waters and lasted for 30 minutes.

The Russian warship requested that the Royal Navy's HMS Tyne reposition to a safer distance, which it did.

The Russian frigate was also being monitored by a French military aircraft which made radio contact with the warship asking it to clarify its intentions.

Publicly available flight data indicated at least four Royal Air Force and Royal Navy

aircraft were flying off the coast of Dorset mostly above the UK's territorial waters, including two Eurofighter Typhoons, a Voyager air refuelling tanker and a Super Lynx helicopter, at the time.

This comes in the wake of several other recent incidents. Last month, another Russian warship, the Admiral Gurovich, fired warning rifle shots towards a retired British couple as they sailed their yacht across the Channel to France. And up in the Norwegian Sea, HMS Prince of Wales was buzzed this month by a Russian warplane, which dropped sonar boy listening devices into the sea nearby.

Russian submarines had been spotted suspiciously close to Britain's vital undersea data cables.

For the new defence secretary, Wes Streeting, this was his first challenge on day one.

Streeting told reporters: "Firstly, we should see yesterday's events as performative and ir-



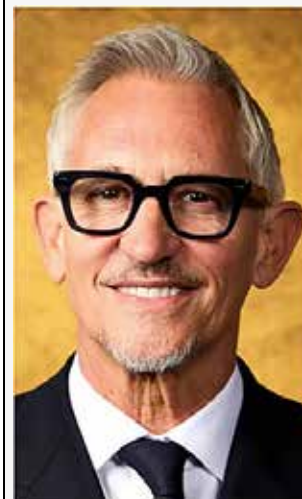

responsible. It's not the first time that Russia has behaved like this, and frankly, it's the tip of the iceberg of the daily threats that this country

faces and our allies face. And Russia should be in no doubt about the resolve of this government and this Prime Minister. "Our resolve to stand

against Russian aggression in Ukraine, but also Russian aggression against all of our allies," remains undimmed, he said.

Please tax us more, "Patriotic Millionaires" tell government

Millionaires including former footballer Gary Lineker and music producer Brian Eno have written to new prime minister Andy Burnham asking to be taxed more.

In an open letter, 120 well-off Britons told Burnham: "We can afford it. We're not talking about higher taxes on those who get up and go to work for their income every day, but on the very richest whose income is derived from the wealth they hold."

Organised by Patriotic Millionaires, the letter said it would lead to a

more equal society, and urged a "devolution of wealth and power from the very richest".

People can already give money or stocks voluntarily to the Treasury using a donation facility.

'untouched capital'

Conservative leader Kemi Badenoch said Lineker is "very welcome to pay more tax he can write a cheque to the Treasury, no one is stopping him."

Patriotic Millionaires support a 2% tax on wealth over £10m.

"Millionaires are a

patriotic bunch," the letter states. "We love this country and we want it to succeed."

"But success requires investment and a primary source of untouched capital investment is sitting with us, in untaxed potential."

Other signatories include Richard Curtis, who wrote the film Notting Hill, and Ian Gregg, the former managing director of Greggs and son of the bakery chain's founder. Scottish crime writer Val McDermid and former financial trad-

er-turned-equality campaigner Gary Stevenson also signed the letter.

Chief Secretary to the Treasury Emma Reynolds said she would welcome UK millionaires increasing the amount of tax they pay but said any major changes would be announced during a Budget.

"I welcome the fact that people of good means are saying that they want to pay more. They can pay more," she said and pointed to the Treasury's donation link.

The renewed call for higher tax on the wealthy follows a similar campaign in previous years.

Burnham did not rule out a wealth tax when asked about it by Lineker - formerly the BBC's highest paid presenter - a few days before he became prime minister.

He suggested he may have "to ask for a little more" tax at some point.

Lineker was paid around £1.3m a year before he left the BBC. He is worth a reported £30m.

In 2023, Lineker won his appeal against HMRC over a £4.9m tax bill, after the UK tax authority pursued him over taxes on income from both the BBC and BT Sport, from 2013 to 2014, and 2017 to 2018.

The latest call from Patriotic Millionaires said there is a "need to embrace a new kind of devolution of wealth and power, from the very richest in order to reinvest back into our greatest asset in every region".

It added that in its own poll, the majority of millionaires wanted a higher tax on themselves.

Reds and England legend Kevin Keegan dies at 75

■ The man player by Bill Shankly for £35,000 from Scunthorpe United turned into an inspirational player for Liverpool, Hamburg and England

Former England captain and manager Kevin Keegan has died at the age of 75, seven weeks after he revealed he had been diagnosed with stage four cancer, his family have confirmed.

One of English football's most decorated players, Keegan enjoyed spells at Scunthorpe United, Liverpool, Hamburg, Southampton and Newcastle during an illustrious playing career.

He later went on to manage Newcastle, Fulham, England and Manchester City.

Keegan revealed he had stage four cancer in June, which is the most advanced stage of cancer and means the disease has spread to other parts of the body.

'much-loved husband'

A statement on behalf of the Keegan family said he was "surrounded by his wife and daughters in his final moments".

"Kevin, a double Ballon d'Or winner, was a much loved husband, father and grandfather," it continued.

Newcastle United paid tribute, describing Keegan as "one of the most iconic, influential and deeply loved figures in our club's history".

The club statement added: "Kevin was more than a legendary footballer and manager. He was the beating heart of Newcastle United for generations of supporters."

"Kevin's impact will not be measured by appearances or results. It will live on in the memories he created with club and country, the dreams he inspired wherever

he went, and the generations of supporters around the world who fell in love with football because of him."

'defining figures'

Liverpool, for whom Keegan played for between 1971 and 1977, said Keegan's "indomitable spirit and remarkable contribution will be forever etched in our history and his legacy will live on".

Hamburg said football had lost one of its "defining figures" and they would always "cherish" his memory, while Fulham said Keegan "forged a strong connection" with the fans, who would "forever hold wonderful memories" of his short time at the club.

Keegan's first club, Scunthorpe, described him as "one of the best players of his generation", with an "inspirational demeanour" and "brilliant personality".

England and Manchester City both offered their condolences to the Keegan family, with the latter describing him as "one of the most iconic and fondly remembered figures in English football".

The Three Lions will celebrate Keegan's life when they host Spain in a Uefa Nations League match at Wembley on 26 September.

As a player, Keegan won major honours with Liverpool, claiming three league titles, the European Cup, two Uefa Cups and the FA Cup over a six-year spell.

He helped Hamburg win the Bundesliga and won back-to-back Ballons d'Or in 1978 and

1979. He remains one of only four English players to have won the award to date.

On the international stage, Keegan scored 21 goals in 63 games for England between 1972 and 1982, and went on to manage them from February 1999 until October 2000.

England job

Keegan is one of the most transformational figures in Newcastle's history - the mastermind behind 'The Entertainers', who challenged for the Premier League title in 1996.

Keegan guided the club to promotion to the Premier League in 1992-93 before leading them to second place in 1995-96.

He led England to Euro 2000 before resigning in October following a World Cup qualifying defeat by Germany at Wembley.

Keegan managed City from 2001 to 2005, then returned to Newcastle for an eight-month spell in 2008.

Keegan revived Newcastle's fortunes as a player before carrying the Geordie nation with him on a thrilling ride as manager, first by taking

the club back into the top flight, then delivering a magnificently entertaining team that challenged for the highest honours - even if they ultimately fell short.

His time at Newcastle will also be recalled for his famous "I will love it if we beat them" TV outburst aimed at Manchester United boss Sir Alex Ferguson as Newcastle's 12-point lead in the 1995-96 title race evaporated - but the unconditional love the Geordies felt for Keegan was never diluted.

Born in Armthorpe near Doncaster, Keegan came to then Liverpool manager Bill Shankly's attention playing more than 100 games for Scunthorpe United, sitting on a bin outside Anfield while the legendary Scottish boss and Scunthorpe counterpart Ron Ash-

man finalised one of the all-time great bargains of a £35,000 deal in 1971.

Keegan was regarded by some observers as simply a hard-working player who made himself great through sheer grit and determination. The initial assertion was correct, but he was much more than that.

Shankly, not one to knowingly undersell his players, told Keegan within a fortnight of arriving at Liverpool that he would play for England.

The new signing scored on his Reds debut on the opening day of the 1971-72 season against Nottingham Forest at Anfield, a scruffy finish set up by John Toshack. It was the start of a beautiful football relationship with the club - as well as with the Welshman.

Farage enjoys some 'instant Karma'

Nigel Farage has mocked a heckler after she crashed her car moments after shouting an insult at him.

The Reform UK leader, who was campaigning in Clacton, was captured by a news crew standing beside a road with some colleagues when the incident occurred.

A grey Vauxhall Astra drives past, and a woman can be heard shouting "w***er" out of the open window. However, she seemingly doesn't see that the traffic lights ahead have turned red - and plows into the car in front, much to the amusement of Farage's supporters watching on.

It comes ahead of the Clacton by-election on August 13, in which Mr Farage will take on Count Binface and dozens of other independent candidates.

The by-election was triggered when the Reform leader stood down as MP on July 7 amid media and parliamentary scrutiny of his finances and backers.

One person can be heard to retort: "She won't be doing that again in a hurry."

Mr Farage posted a video of the incident on X, along with the caption: "This lady shouted abuse at me and then crashed her own car. That's what you might call instant karma!"

All major political parties are boycotting the Clacton by-election, dismissing it as a stunt following controversy surrounding Mr Farage's undeclared £5 million donation from crypto billionaire Christopher Harborne.

Widdecombe stuck with hammer 21 times by her killer

■ Yorkshire man accused of killing former Tory MP appears in Westminster court

Ann Widdecombe was hit on the head with a hammer 21 times at her home as she ate lunch in an attack that was caught on camera, prosecutors have told Westminster Magistrates' Court.

Prosecutor Kashif Malik said the man charged with her murder, Joshua Kerry, arrived at her house on 8 July in a red Vauxhall Corsa and entered through the front door.

Kerry, who prosecutors say was in the property for two minutes and was wearing black gloves, then allegedly hit Widdecombe repeatedly with a hammer in her kitchen, tipped her from her chair and took her wallet before driving off.

The 28-year-old from South Yorkshire later also appeared at the Old Bailey and was remanded in custody.

At the Old Bailey hearing, prosecutor Alistair Richardson said the attack on Widdecombe had been carried out with a "ferocity of violence".

Malik told the court that Widdecombe did not attend a pre-arranged online interview with Channel 5's Matt Allwright show that had been scheduled for 8 July.

The show's production team tried to contact Widdecombe through her personal assistant, who then asked Widdecombe's gardener to check on her, the court heard.

Prosecutors said the gardener entered the house via the open front door on 9 July and found Widdecombe lying face down on her kitchen floor with a serious head injury.

Malik told the chief magistrate that security camera footage from her home in Haytor, Devon, showed she had been fatally attacked the day before.

He added that police were still investigating whether there was a terrorism connection or political motivation for the attack.

Kerry, from Rotherham, was charged with one

count of murder on Monday night following an investigation led by counter-terrorism detectives.

He appeared emotionless in the dock and spoke only to confirm his name, date of birth and address during the short hearing at Westminster Magistrates' Court. He was not asked to indicate a plea.

He will next appear at the same court on 9 October for a case management hearing.

A provisional trial date has been listed for 8 June 2027.

The court heard that a pathologist had given a provisional cause of Widdecombe's death as a blunt force injury to the head.

Widdecombe's career in politics spanned decades.

She served as Conservative MP for Maidstone in Kent for 23 years and was appointed to ministerial roles in Sir John Major's

government in the 1990s.

Following her departure from the Commons, Widdecombe appeared on the BBC's Strictly Come Dancing in 2010 and was a runner-up on Celebrity Big Brother eight years later.

She later represented South West England as a Member of the European Parliament (MEP) for the Brexit Party and in 2023 she joined Reform UK as a party spokeswoman.

Drought declared in North Wales as UK's long hot summer goes on

North Wales has become the first part of the UK to declare a drought after weeks of hot, dry weather have left river levels at record lows.

The areas affected include North and South Gwynedd, Oonys Mawn, Dee, Clwyd and Upper Severn after three heat waves in a row took a heavy toll, leaving the land dry and rivers thirsty. A drought has been declared in catchments across North and Mid Wales. Levels are either already at or approaching record lows, leading to concern over fish dying in warm, shallow rivers.

'getting desperate'

Groundwater levels are low too, creating problems for livestock farmers like Tiddy Rob-

erts from Abergele in the county of Conwy, who told reporters: "We're on well water and the well's dried up and we've got one spring going. We've been carrying water up from the local town to help supply the cows and things. No, it's really getting desperate for water now."

The drought status doesn't apply to reservoirs. Water companies in Wales say they are coping, but demand has been higher than usual, with tankers needed to move supplies around.

Wales is on course to record its driest July in almost 190 years, and while there is some rain forecast for the weekend, it's due to be followed by another period of hot, dry weather.

Elsewhere in the

country seven local water companies have announced a hosepipe ban, with Thames Water the latest - although England is not officially in drought yet. But eight areas are now classed as being in prolonged dry weather, the stage before drought. England has received just 3% of its normal July rainfall with no rain at all in some southern and eastern areas.

'new normal'

Some ponds and wetlands have dried out, some rivers have stopped flowing, and farmers have begun harvesting early with lower cereal yields expected. The dry weather, combined with unusually high temperatures, is also driving up demand for public water supplies

by up to 30% on the hottest days.

Helen Wakeham, who chairs the National Drought Group, said: "What we're seeing is a new normal, if you like. We had drought in 2022. We had drought in 2025. We went from very, very dry in last summer through to flooding and above average rainfall over the winter. So that puts pressure on all of us. It puts pressure on water for drinking water supply.

heat dome

"It makes conditions really difficult for farmers. So lack of water is really an issue for all of us.

And a climate scientist at Oxford University, Chloe Brimacom, says the intense heat this year

is exacerbating the lack of rain by drawing yet more moisture from the ground.

"When we have what's called a heat dome, that hot air hits the ground, has a baking effect on the ground, drying it out further, potentially pushing us further into the fact that we could now see a hydrological drought in parts of the UK."

Drought was declared across much of England, Wales and Eastern Scotland last summer and officially only ended four months ago. A very wet autumn and winter replenished rivers, reservoirs and groundwater, slowing its return this year. But the Met Office warns climate change is making UK summers hotter and drier.

RIP Garry Sobers: a giant of international cricket

Barbados-born star enjoyed two decade career representing the West Indies, and was considered the sport's greatest all-rounder

INTERNATIONAL CRICKET lost one of its true legends at the weekend with the death of Sir Garfield Sobers at 89.

A national hero of Barbados and perhaps the most widely-respected ambassador of cricket in the postwar period, Sir Garry, as he was known, was rightly chosen as one of the leading five cricketers of the 20th century - and will be remembered as arguably the best all-rounder in the history of the game.

Sobers was a legend in the West Indies on the back of a Test career that spanned 20 years, and was knighted soon after his retirement.

But he will also be fondly remembered in England after playing for county side Nottinghamshire - for whom he wrote his name into the record books when he became the first man to hit six sixes in an over in a professional game.

left handed batter

Decades before coaches began to insist their players be 'multi-dimensional' cricketers rather than only contributing in one facet of the game, Sobers was the ultimate all-round sportsman.

A hard-hitting left-handed middle-order batter, he was capable of bowling in three distinct styles, as well as being an athletic fielder and a fine close catcher.

Indeed, he would often take the new ball, bowling left-arm fast-medium - and then return later in the innings having switched to orthodox left-arm spin, or even left-arm wrist-spin. When added to his batting and fielding, he was a captain's dream - effectively five cricketers in one.

Garfield St Aubrun Sobers was born in Bridgetown on 28 July 1936, but

was only five when his merchant seaman father was killed in World War Two, leaving his mother Thelma to raise half-a-dozen children.

Young Garry was born with an extra finger on each hand, which were removed during childhood.

Having excelled at several sports as a schoolboy, he was recruited to local club cricket in his early teens and made his first-class debut at the age of 16 against the Indian tourists at his home town's Kensington Oval - the ground whose pavilion would one day bear his name.

Sobers was selected to bat at number nine and bowl spin for a star-studded Barbados line-up - he was one of eight current or future Test players, of which no fewer than four would be knighted. He took four wickets in the first innings and three in the second.

And with only one other first-class appearance under his belt, his Test debut came 14 months later as a 17-year-old chosen to take on England in the final Test in Jamaica in early 1954 after the Windies' regular left-arm spinner Alf Valentine fell ill. Again, he

captured four wickets on debut.

Although the famous 'Three W's' - Clyde Walcott, Everton Weekes and Frank Worrell - were the established middle order, Sobers was elevated to number six on his next Test appearance when Australia toured in 1955, and soon showed signs of his all-round quality.

Having made 47 in the second Test, he found himself as an emergency opener in the fourth, where he hit the first three balls he received - from legendary Aussie all-rounder Keith Miller - for four.

Sobers toured England for the first time in 1957, and despite only recording one half-century in five Tests, he lit up Trent Bridge - a ground where he would later shine - with an unbeaten 219 against his future county side Nottinghamshire.

Though a player of undeniable potential, it was four years into Sobers' Test career before he broke three figures for the first time, in his 17th Test - but spectacularly rewrote the record books in doing so.

Coming in at number three against Pakistan at Jamaica's Sabina Park, So-

bers shared a mammoth second-wicket stand of 446 with Conrad Hunte, who was run out for 260 - but by the time West Indies declared on 1 March 1958, Sobers - still only 21 years old - was 365 not out.

In demand

It broke the previous record Test score of 364 set by England's Len Hutton in 1938, and would remain a record until 1994. But it was also the harbinger of a purple patch of batting form for Sobers, who hit five further centuries in his next five Tests, and as his seam bowling improved, he became the world's leading all-rounder of the 1960s.

Sobers was a man in demand - playing in England for Radcliffe in the Central Lancashire League between 1958 and 1962, and Norton in the North Staffordshire and South Cheshire League from 1964-1967. Meanwhile, his success in Australia in 1960-61 earned him an invitation to play for South Australia in the Sheffield Shield for three subsequent seasons.

He is perhaps best known to English cricket fans for his exploits on 31

August 1968 at Swansea. Looking for some quick runs to set up a Notts declaration - and decided to take on Glamorgan seamer Malcolm Nash, who was experimenting with left-arm spin.

It turned into an expensive experiment as Sobers launched six successive deliveries over the ropes. Sobers was briefly caught by Roger Davis at long-off from the fifth ball - but the fielder fell over the bound-

ary rope in taking the catch, and six was signalled.

The sixth ball was smashed out of the ground to give Sobers another world record that has only been matched once in first-class cricket (by Ravi Shastri in 1985), and several times in limited overs games.

Sobers remained good friends with Nash, and was among the first to pay tribute when the bowler died in 2019.

[City] wanted me, I was absolutely determined to make this move happen," Anderson said.

"You want to test yourself at the highest level. Being at City means I have that opportunity.

"As soon as I arrive in Manchester after a break, I will be doing everything I can to establish myself in the City team."

After joining Forest from Newcastle United in 2024 for £35m, Anderson became an integral player as the club finished seventh in the Premier League and qualified for Europe for the first time in 30 years.

Last season, Anderson helped Forest to the Europa League semi-finals and was the Premier League leader for touches and duels won.

He also became a key feature of Thomas Tuchel's England side, featuring in every game at the World Cup.

City agreed to pay a club record fee for Anderson, exceeding the £100m spent on Jack Grealish in 2021, and fended off competition from Manchester United.

Talks around Anderson's future were ongoing during the World Cup and an agreement was reached between Forest and City on the eve of England's Group L game against Panama.

He will join a team led by former Chelsea head coach Enzo Maresca, who arrived in June after Pep Guardiola stepped down as City manager after 10 years in charge.

"They're winners, they're relentless, and that's the sort of team I want to be a part of - champions and people who win trophies," Anderson said.

Gunners set their signs on £70m Bruno

Arsenal are set to make a £70m offer for Newcastle captain Bruno Guimaraes.

Brazil international Guimaraes is a priority target for the Gunners, with the midfielder keen to join the Premier League champions. Newcastle are aware of the 28-year-old's preference to join Arsenal this summer.

Talks over a potential move for Guimaraes are ongoing and are believed to have accelerated in recent days. The agreement of personal terms is not expected to be an issue, though it remains to be seen if Arsenal's £70m offer will meet Newcastle's valuation. Sources close to Newcastle insist the Magpies have no intention of selling Guimaraes this summer and

that there has been no direct approach from the Gunners for their player.

Arsenal are determined to strengthen their squad with high-quality players this summer as they look to build on last season's title. The north London side were interested in signing Morgan Rogers, who has joined Chelsea for £117m, from Aston Villa - but refused to go higher than their £80m valuation of the player. It is understood Arsenal were given the opportunity to match Chelsea's offer for Rogers but declined.

Similarly, Arsenal have a hardline maximum valuation of Guimaraes and are unwilling to overpay despite their desire to sign the midfielder. Arsenal also have a major interest in

Villa defender Ezri Konsa and have enquired about the England international's availability. Konsa is Arsenal's first-choice defensive target.

The Gunners also have Como's Jacobo Ramon on a list of defenders they would like to bring in, but it is understood

clauses in the Spaniard's contract make a deal difficult.

Having missed out on Rogers, the Gunners remain in the market for attacking reinforcements. Atletico Madrid forward Julian Alvarez is Arsenal's dream target, but the player's current de-

sire to join Barcelona and the cost - which could exceed the British record fee of £125m set when Alexander Isak moved from Newcastle to Liverpool - pose obvious difficulties. Arsenal have also explored a move for Paris St-Germain winger Bradley Barcola.

Tielemans seals United switch

Manchester United have completed the signing of Yuri Tielemans from Aston Villa on a five-year deal.

United have met a release clause of £35m for the 29-year-old midfielder, who has just helped Belgium reach the World Cup quarter-finals.

Tielemans has spent the past three seasons with Villa, having initially moved to the Premier League to join Leicester City in 2019.

"It's hard to describe just how proud I am to join Manchester United," he said. "Signing for such a special club feels incredible.

"It is the culmination of years of dedication since I first fell in love with football."

Tielemans will wear the number 18 shirt vacated by fellow midfielder Casemiro, who left Old Trafford when his contract expired at the end of the season.

A former team-mate of United's current first-team coach Jonny Evans,

Tielemans is noted for scoring Leicester's winner against Chelsea in the 2021 FA Cup final and for Aston Villa in their Europa League final triumph over Freiburg in May.

He made his senior debut for Anderlecht aged 16 years and 82 days, and left for Monaco in 2017, just after his 20th birthday.

Despite still being in his 20s, Tielemans has already played 668 games for club and country, scoring 79 from 578 club appearances.

United's director of football Jason Wilcox said: "Youri has consistently been one of the most outstanding midfielders in the Premier League throughout the past seven years.

"He has all of the technical qualities, as well as the ambition and mentality, to thrive at Manchester United.

"Youri's consistency is exceptional, and he will add further composure, creativity and leadership to our squad."

Last season, Tielemans suffered separate calf and ankle problems that restricted him to 35 appearances in all competitions for Villa, the lowest number in a campaign during his time in England.

He scored a memorable 89th-minute equaliser at the World Cup for Belgium against Senegal, and then converted an extra-time winner from the penalty spot for his 15th goal from 90 caps as they won 3-2.

But his tournament came to a premature end when he was injured in the warm-up before Belgium's 2-1 quarter-final defeat by Spain.

Tielemans' signing follows that of fellow midfielder Andrey Santos and goalkeeper Karl Darlow, while a move for Atalanta midfielder Ederson has been put on hold.

ARSENAL have confirmed defender William Saliba is set to miss an "extended period" after suffering a back in-

The 25-year-old had been managing a back issue for several weeks and carried the problem into the World Cup but was forced off after 30 minutes of France's semi-final loss to Spain.

After returning to London and being seen by a specialist, it was decided that surgery is not needed with a managed recovery programme to be commenced instead.

Saliba was forced to sit out France's World Cup bronze final defeat by England.

Earlier in the World Cup, he said: "I've had some minor niggles for several months.

"I've been gritting my teeth because there was the Champions League and the Premier League.

"The World Cup comes round only once every four years, so you've got to grit your teeth."

Saliba made 50 appearances across all competitions for The Gunners last season, as they ended a 22-year wait to win the Premier League and also reached the Champions League final.

Mikel Arteta's side will take on Manchester City in the Community Shield on Sunday, 16 August - five days before the Gunners begin the defence of the Premier League title, hosting promoted Coventry City.

Blues splash £117m on Rogers

■ Chelsea stun Arsenal to snap up England star

Chelsea have made England midfielder Morgan Rogers the most expensive British player in history by signing him for Aston Villa for a fee of £117m.

On Monday, Rogers returned from the United States, having featured for England at the World Cup, to undergo a medical in London and sign a six-year contract with an option for a further year.

"I'm joining the biggest club in London," he said in his announcement video.

"The way the club wants to go and how it wants to move forward is something I want to be a part of. I think it was just perfect for me. I just can't wait to get going."

The move comes as a genuine transfer window shock - so how did they do it and what does it mean for the rest of the squad?

It had been widely expected that Rogers, who was Villa's most prized asset, would be available only for an English transfer record fee, but many expected Arsenal to be the frontrunners.

However, Chelsea had been tracking Rogers for more than two years and had quietly made him their top attacking target. They moved quickly after England's semi-final defeat by Argentina last Wednesday out of his desire to focus on the World Cup.

On Thursday, after the 2-1 loss, a combined effort involving the club's sporting directors, head coach Xabi Alonso and co-owner Behdad Eghbali helped secure a deal. Even Chelsea captain Reece James was making the club's case from within the England camp, while those close to the negotiations say Cole Palmer was also

aware of developments as, in Rogers' words, "one of my best friends in life".

It was a well-planned operation involving figures across the club and resulted in Rogers being signed in under 48 hours.

The deal was underpinned by the strong relationship between Chelsea co-owner Eghbali and Aston Villa owner Nassef Sawiris, with the agreement being finalised on Saturday afternoon, shortly before Rogers took to the field in England's bronze-medal victory over France.

After the deal was agreed, Arsenal were offered the chance to match the bid but they informed Villa they were committed to their lower valuation and were willing to let him join Chelsea on those terms.

They will now consider alternative targets, including Paris St-Ger-

main's Bradley Barcola and Bournemouth's Junior Kroupi.

Although Chelsea had tracked Rogers for more than two years, the clubs had previously discussed a potential deal during

the 'Profit and Sustainability swaps' of 2024.

Chelsea's move also represents a recalibration of their transfer tactics.

In April and his last interview, Eghbali accepted Chelsea needed "to

add more ready-made players at this part of the project, to take [it] to the next level, to be consistent over time," adding: "You tweak a model, you improve, you learn from mistakes."

The 23-year-old midfielder, who joins from Nottingham Forest, has signed a contract which

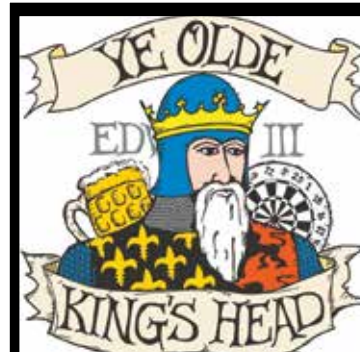
runs until June 2031.
