HUGE WILDFIRE RAVAGES SUFFOLK

FIRST THE DROUGHT, then the wildfires. More than 100 firefighters were struggling this week to tackle a wildfire that had grown to the size of 210 football pitches (370 acres) and had been burning for more than 24 hours on the Suffolk coast.

The county's fire service said the "unprecedented" blaze broke out on Dunwich Heath, near Leiston, at about 17:00 BST on Wednesday.

A spokesperson for the Sizewell B nuclear power station, about three miles (5km) from the fire, said it was monitoring the "dynamic situation".

The fire service said its response to the fire would continue for another 48 hours at least,

and that changing wind conditions were making it difficult to predict how it may spread.

'national support'

Homes and a holiday caravan park were evacuated after the fire broke out and there are fears for rare birds and wildlife whose home is the heath and nearby RSPB Minsmere.

On Thursday evening, Suffolk's chief fire officer, Jon Lacey, said:

"Eighteen fire engines and 120 firefighters are involved in the response, but difficult terrain and limited access routes are making it hard for crews to reach some areas of the wildfire."

He confirmed approximately 100 to 150 people had been evacuated from their accommodation.

An update on the fire service's website said it was being supported by firefighters from neigh-

bouring brigades, with engines also being sent from London.

"We have also requested additional national support, including wildfire specialist appliances, officers, and tactical advisers," it said.

'incredibly emotional'

Prime Minister Andy Burnham pledged to give the fire service "all the support it needs" to tackle the "very serious" heathland blaze.

Communities Secretary Angela Rayner

praised firefighters for their "skill and dedication and bravery".

Green Party leader Zack Polanski has called for Burnham to host an emergency Cobra meeting to discuss the outbreak of wildfires in Britain, including in Suffolk.

Sizewell B power station said the fire was "not affecting operations".

Jude Bayly, who owns caravans in the evacuated area, said she felt "incredibly emotional"

about the wildfire.

"I feel every time I speak to a son or my husband I feel very weepy and that's just shock, I would imagine," she said.

"The devastation of this area, which is a natural beauty, and the wildlife is just awful.

"You see it on the television with France and Spain and you're quite removed from it and then it's here and I feel quite as if it's actually... I'm not really taking it in."

Drought declarations grow as Britain roasts in a long, hot summer

Drought has been declared across more than half of England and all of Wales as hot, dry weather takes its toll on the country's water supplies.

The Environment Agency (EA) announcement this week covers much of central, eastern and southern England, and is a public sign that further restrictions on water use might follow.

It added that the impacts are already being felt, including low river flows, early harvests and high risk of wildfires. More than 20 million people are already under hosepipe bans.

North Wales and the Upper Severn river basin entered drought conditions last week, Natural Resources Wales said.

Scotland does not declare drought but monitors "water scarcity". Some parts of eastern Scotland are in the most extreme category of "significant scarcity", according to the Scottish Environment Protection Agency.

The affected areas are: East Anglia, Hertfordshire and the whole of London, the Thames Valley, Hampshire and the Isle of Wight, Devon and Cornwall, the West Midlands and Wessex, covering Dorset, Somerset, Wiltshire, and South Gloucestershire.

The declaration is a public sign that the EA is stepping up its response to the dry conditions, including increased monitoring and controls on how much water can be taken from rivers and groundwater.

It can mean hosepipe bans being introduced if they are not already in place.

"The hot and dry weather means we are currently using water faster than nature can replenish it," said Helen Wakeham, director of water at the Environment Agency and chair of the National Drought Group.

Late spring and summer have been exceptionally hot and dry. The quick switch between wet and dry conditions is sometimes called "climate whiplash".

In particular, July has seen 7% of the average levels of rainfall in England so far, with just 1% across southern England.

Some parts of Devon and Hampshire have gone more than a month without rain.

"The warm and exceptionally dry conditions experienced across much of England over recent months are continuing to have a significant impact," said Will Lang, chief meteorologist at the Met Office.

Early August could bring some rain to parts of the country, but the Met Office has said there is no sign of sustained rainfall that would make a significant difference to the dry conditions.

The combination of low rainfall and prolonged high temperatures - meaning greater evaporation of moisture - has quickly depleted water reserves in soils, vegetation and rivers.

These conditions have led to a "flash drought", the EA has said. This is where drought begins suddenly rather than over many months or years.

Burnham tells Trump he will be 'pragmatic' on North Sea Oil

Prime Minister Andy Burnham has said he told US President Donald Trump he would take a "pragmatic approach" to the issue of North Sea oil and gas.

Trump has long urged the UK to increase drilling and claimed that Burnham had pledged to "open up the North Sea" in their first phone call together.

Asked about the president's comments, the new prime minister said: "There is a resource there.

When people are struggling - you can't ignore that and hence me indicating that to the president."

Burnham has faced pressure from some trade unions, industry figures and some of his own Labour MPs to back

increased drilling in the North Sea.

In its 2024 general election manifesto, Labour promised not to issue new licences for drilling but said it would honour existing ones.

As energy secretary in Sir Keir Starmer's government, Ed Miliband was a staunch supporter of Labour's manifesto position. He has previously described the licence issued to Rosebank, Britain's largest untapped oil and gas field, as "climate vandalism".

Miliband is now the foreign secretary in Burnham's government.

Although the government has not made any announcements on the issue, Trump has praised what he perceives as a change of stance by the UK government.

In a social media post, published the day before Burnham became prime minister, Trump wrote: "The People of Aberdeen, in Scotland, are dancing in the streets because the new Prime Minister, Andy Burnham, has stated that he will be opening up, all the way, the invaluable North Sea Oil!"

This week, when asked about his conversation with Burnham, Trump said: "He said he's going to open up North Sea oil."

"If he does that, you're going to be a wealthy country."

Burnham: NHS 'will collapse without reform'

Andy Burnham has said "the NHS will collapse" if social care is not reformed but said he could not put a timeline on changes.

In his first major interview since becoming prime minister, Burnham said he would not want to leave office without bringing in "substantial change" to the social care system.

The prime minister also suggested making it harder to claim benefits, saying the country had to get serious about getting the welfare bill down.

Burnham said that if the government did not reform social care, the NHS would "collapse under the weight of trying to care for people who've really not needed to end up in the NHS system".

But pressed on whether he would create a new system before the next election, he said he "couldn't put a timeline on it right here, right now", though he would put "whatever political capital I have into fixing broken social care".

Burnham first proposed a universal system of social care in England in 2009 when he was health secretary under Gordon Brown and pursued the idea of a compulsory levy to fund it.

That Labour government also floated the idea of allowing people to defer the payment until after they died, which led to the Tories branding it a "death tax".

Adult social care provides state support to help people live more independently, including assistance at home.

Crooked funeral director to be jailed for more than 65 offences

Crooked funeral director Robert Bush will be sentenced this week after pleading guilty to 67 offences spanning 12 years and affecting hundreds of victims.

Bush, 48, who ran Legacy Independent Funeral Directors in the UK, gave grieving families the wrong ashes while their loved ones' bodies were left at his site for months.

Police were contacted by someone with access to the site in March 2024, expressing concerns over "care of the deceased" at the Hull business.

When officers searched the premises they found 31 bodies that should have been cremated months earlier, including a stillborn baby that had been there for almost two years.

wrong ashes

They also found more than 100 sets of ashes, some with name labels and letters attached to the box.

Police found that many families of the deceased found at Legacy had already been given ashes by Bush, revealing a widespread practice of him giving grieving relatives the wrong ashes.

Investigators also learned that Bush also stole from charities by failing to pass on donations collected at funerals.

In April Bush pleaded guilty to 30 counts of preventing a lawful and decent burial, and theft from 12 charities including the Salvation Army and Macmillan Cancer Support.

He had already admitted 30 counts of fraud by false representation relating to bodies found at the site, and four "fetus allegations" of fraud,

where he presented ashes to women falsely saying that they were "the remains of their unborn".

'deeply affected'

Bush also pleaded guilty to a further charge of fraud, covering the ashes of 57 people between 2017 and 2024, and one of fraudulent trading relating to funeral plans between 2012 and 2024.

The sentencing at Hull Crown Court is listed for five days, and is expected to hear from more than 100 victims.

Bush, formerly of Kirk Ella, East Yorkshire, but now of Otley, West Yorkshire, is on conditional bail.

Three of the officers who investigated the scene at Hessle Road back in March 2024, being 'shaken, moved and deeply affected' by what they found there, particularly the discovery of the remains of Jasmine Beverley's unborn baby, Sunny.

One of those was CSI investigator Colin Jordan,

who said: "This find had a profound effect on me and the whole team. This was by far the most upsetting part of the operation and still affects me now, when I am relaying the sequence of events. I find it difficult to put into words the indignity afforded to both those recovered and their families, but more so, the indignity afforded this fetus. When it upsets seasoned professionals,

with many years of experience in the field of body recoveries, it is clear just how bad the conditions were."

Another victim's statement was given by the chairperson of WISHH, a charity in Hull raising money for local hospitals. WISHH is one of the 12 charities Bush stole from. Sue Lockwood said his crime means the public may feel less confident

about donating in future:

"[It's...] a disturbing reality to know that we can do nothing to put right the dishonesty of the defendant who not only denied the intentions of the grieving families but also denied those in hospital in need of the benefit of the gift made in memory of a loved one. We, and they, deserved better from someone in a position of trust."

Burnham vows to bring back technical schools

Secondary school pupils in England will be able to study subjects like manufacturing and AI in addition to core academic learning under reforms outlined by Prime Minister Andy Burnham.

The government said the courses, which would be available from Year 10, would be linked to local industries and designed to give children a clearer pathway into work.

Data published this year showed more than one million young people across the UK were not in education, em-



ployment or training, the highest level in more than 12 years.

Few details have been published about how the

new vocational courses would work in practice and it is not clear how they would operate in areas with low industrial

activity.

But the government expects the new pathways into work to be up **cont. on page 4, col. 1**

and running in some areas by 2028.

The government also announced a new bursary of up to £4,500 for some families who would lose out on money if their children wanted to do an apprenticeship, because the child benefit they would lose out on would be worth more than the apprenticeship starter salary.

'just not right'

Speaking at a train manufacturing site in Derby, Burnham said: "We've had a system built for too long around the university route and it sends a message to some young people that they're some kind of second-class citizens, and it's just not right."

"They need an education system that works for them as well, that offers a path to all young people, that's balanced between academic and technical."

The prime minister said he was "on a mission" to reduce the number of young people not in education, employment or training - known as "Neet" - but declined to put a target date on his ambition.

"The trend is rising at the moment, so the first thing I've got to do is to stop that rise," he said.

"It's hard to put a firm date on the moment when you can say there are fewer than now."

However, shadow work and pensions secretary Helen Whately said while there was a "broad consensus" on improving vocational education, it was "not a big bold announcement".

She said: "What's going on there is a drastic shortage of jobs because Labour's policies over the last couple of years have killed job opportunities for young people. This announcement will not solve that."

Funding cuts spark doubts over future of Jodrell Bank's iconic observatory

For nearly 70 years, the Lovell Telescope has stood watch over the Cheshire countryside, a great white dish tilted at the heavens, listening for the faint whispers of the universe.

But that could soon come to an end. Despite a record increase in the science budget, the government's UK Research and Innovation Agency, UKRI, has decided to cut support for Jodrell Bank and the network of telescopes connected to it.

The UK Research and Innovation Agency says it's had to cut the observatory's annual £2.8 million budget because planned research costs for physics and the running of its labs have escalated.

It's a decision that astronomers, such as Professor Catherine Haymans of Edinburgh University and Astronomer Royal for Scotland, can't understand.



Cutting the observatory's budget was described as "an act of national self-harm"

"For me, this is really devastating news and an act of national self-harm, in my opinion, that lacks real joined up thinking from the government, because this observatory has been producing spectacular science."

Archbishop doubles down on slavery reparations

The Archbishop of Canterbury has renewed her commitment to a controversial £100m fund over the Church of England's role in the transatlantic slave trade.

Dame Sarah Mullally was speaking on a visit to Cape Coast Castle in Ghana where enslaved Africans were held before being trafficked to the Americas.

She said touring the castle made her reflect on the crimes committed by the institution she leads.

"We played a part in the transatlantic slave trade. That is clear. Part of the Christian belief in repentance is about action, so we are putting in place action to support those communities that feel the legacy of the slave trade," she added.

This is Dame Sarah's first pastoral visit to Africa since being installed as head of the Church of

The prime minister's bichon frise-poodle cross will instead remain in the north of England, Mr Burnham revealed during his first major broadcast interview.

Larry unvanquished

He was asked whether his family pet would join Larry, the renowned "chief mouser" to the Cabinet Office, who has become famous the world over.

Responding to the query, the prime minister affectionately referred to

his own dog as "Famous Axel".

Mr Burnham added: "I think he's going to have to stay up north I think, because he's kind of got that angry little man

thing going on. He's got a bit of poodle in him.

"He's a bich-poo, I think they call it - or a poochon - whatever the phrase is. And, yeah, he wouldn't get on with

Larry, let me put it that way, and I don't think the nation would thank me, would they, if I brought Axel down to disturb Larry's world?

"So I think he's staying

up here."

Axel the Bichon-Poo spent just 12 days at Dogs Trust Shrewsbury before he was adopted by Andy Burnham and his wife around 10 years ago.

England at a ceremony in Canterbury Cathedral in March.

At Cape Coast Castle, which came under British control in the 1660s, Dame Sarah was shown dungeons where slaves were held, and the so-called "door of no return" through which they were forced on to ships.

The archbishop said: "You can't help but be deeply moved by the horrific conditions that people were kept in and the way that they were treated."

"It completely throws you off balance and brings home the evil that was transatlantic slavery."

The Church of England has previously apologized for its associations with the slave trade.

Its missionary arm ran slave-farmed plantations in the Caribbean to fund the spread of Anglicanism, individual members of clergy were slave owners, and the Church received large donations from slave traders.

Teen 'hitman' guilty of UK murder plot

■ Young Norwegian recruited by Swedish crime group Foxtrot Network

A Norwegian teenager has been convicted of plotting a murder after travelling to the UK to carry out a contract killing for a Swedish crime group with links to the Iranian state.

Johannes Natland was just 18 when he was arrested by firearms officers in his Huddersfield Hotel in 2025. Under his bed were two handguns and ammunition.

Iran links

He had flown into Manchester Airport the night before, following instructions from his handlers sent to him on his smartphone, a video showing him where the guns were stashed in woodland, another showing him where to find money for his hotel and details of where to locate a stolen car.

Natland had been recruited for the murder by an even younger

Norwegian teenager working for the Foxtrot Network, a Swedish organized crime gang with strong links to the Iranian regime. They've become infamous for using teenage hitmen who are disposable.

The intended target has never been identified.

This week at the Old Bailey, Natland was convicted of conspiracy to murder following a retrial. He had previously pleaded guilty to two counts of possessing a prohibited firearm and possessing ammunition without a firearms certificate.

Frank Ferguson, Head of the Special Crime and Counter Terrorism Division, said: "This was a calculated plan to kill for money."

"This case shows how organized crime networks operate across borders and exploit

young people to carry out serious violence.

"Thanks to swift and coordinated police work, this plot was stopped before anyone was harmed."

"The evidence in this case -including telephone evidence, text messages, CCTV footage and witness testimony - clearly left no doubt that Natland intended to carry out this crime."

"This conviction sends a clear message: if you come to this country to commit serious violence on behalf of organized criminals, you will be caught and we will make sure you are brought to justice."

The Foxtrot Network, founded in 2021, is a Swedish-based criminal network engaged in the smuggling of drugs and violent crimes. The violent assignments can be cross-border and are advertised in group chats, on applications like Snapchat, Telegram and Signal.

The network often enlists the help of perpetrators who are very young, and with whom they have no direct link.

Messages recovered

from Natland's phone showed he had been recruited to carry out a killing for €25,000.

In one exchange a contact using the name "Agent47" described the location of the assignment as "Great Britain. As easy as can be."

Natland told his girlfriend he was "going on a crazy mission" before travelling to the UK. He said he was going to kill someone, and life would be wonderful". After collecting the weapons, he messaged her to say "in the bag is bang" and sent her a selfie holding

a firearm, which he captioned "soon it will happen".

CCTV footage showed him collecting the weapons and later buying heavy-duty gloves matching those seen in his own videos handling the guns.

The final message sent to him before his arrest read: "We have much to do tomorrow."

He was arrested by specialist firearms officers in his hotel room at around 5.15am on 19 March 2025, with the firearms and £2,000 in cash recovered.

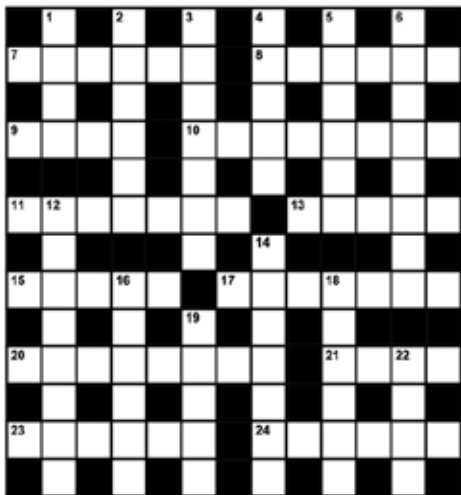

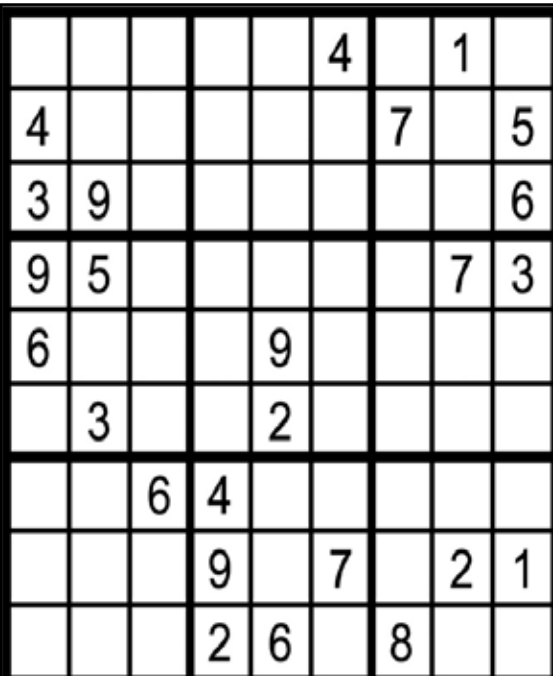

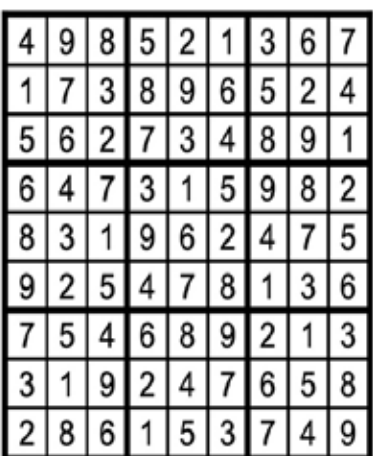

From the Goodies to a twitcher: RIP Bill Oddie

Bill Oddie, who shot to fame in the 1970s one of the comedy trio Goodies and whose love of birds led to a second career as a wildlife presenter has died. He was 85.

Oddie was a multi-talented performer who found his greatest comedy success on television with his fellow Cambridge University Footlights members Tim Brooke-Taylor and Graeme Garden in The Goodies, a sketch show that combined the anarchic elements of Monty Python's Flying Circus with "silly" sight gags. Oddie's self-taught musical skills steered the trio into the charts with his compositions – pastiche rock'n'roll songs such as The Funky Gibbon and Happy Love. And when that was all over, he carved out a new career as the small screen's most famous birdwatcher, credited with encouraging new generations to become

enthusiasts for the natural world.

Oddie's path to fame began when he wrote musical numbers for the Footlights revue A Clump of Plinths. He appeared in it at the 1963 Edinburgh festival with other Cambridge students, including Brooke-Taylor and the future Pythons John Cleese and Graham Chapman. Within weeks, the show transferred to the West End of London, retitled Cambridge Circus, and to Broadway the following year.

A 1963 BBC radio version was turned into a sketch series, I'm Sorry I'll Read That Again, which ran for six years from 1964. After the first year, Oddie was joined as the show's regular script-



writer by Garden, a later Footlights recruit. When its successor, I'm Sorry I Haven't a Clue – an improvised parody of panel games – began in 1972, Oddie was a team member for two years.

Brooke-Taylor and Garden continued on that show after Oddie left, but kept their partnership with him going on TV in The Goodies, which started in 1970 and carried on for 10 years. In this, they all wrote and appeared in surreal sketches blending slapstick and stop-motion film techniques as they travelled around on a "trandem" (a three-seater bicycle) – frequently falling off – for their agency promising to do "anything, anytime". Oddie was projected as the hairy,

untidy one, Brooke-Taylor as pompous and Garden as professorial. When the BBC struggled to find a budget for further episodes, ITV took it on with a 1981 Christmas special and a six-part series the following year.

After a foray into children's TV, Oddie threw himself into communicating his lifelong love of birds and other wildlife to viewers in series such as Birding with Bill Oddie (1997-2000), and Bill Oddie Goes Wild (2001-03), as well as one-off documentaries in far-flung countries.

He teamed up with Kate Humble and Simon King to present the live outside broadcasts Wild in Your Garden (2003) CONT:/

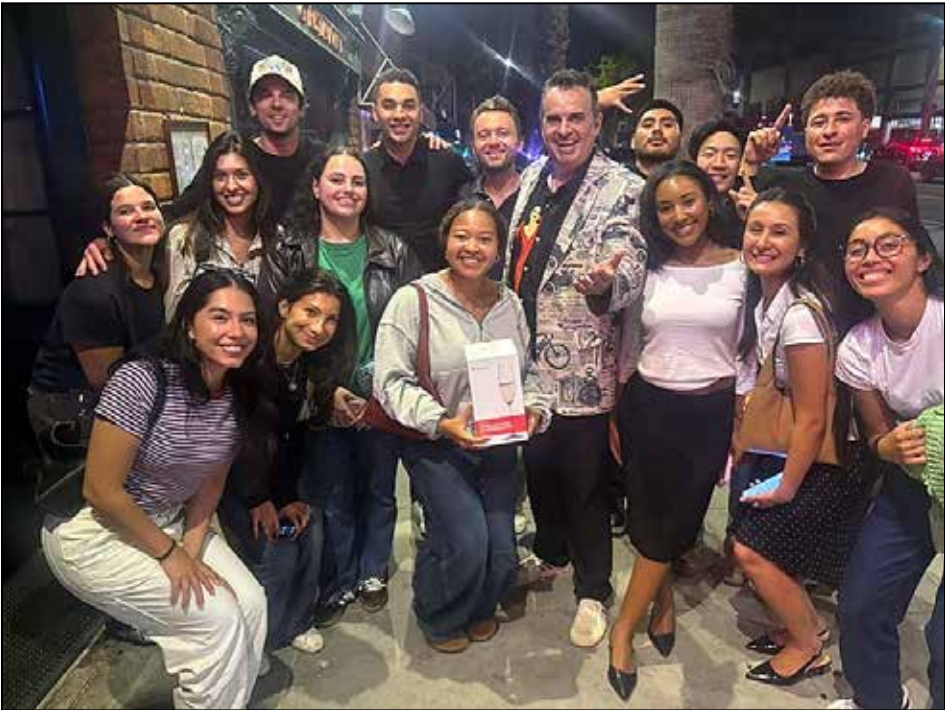

His many books included Bill Oddie's Little Black Bird Book (1980), Birding with Bill Oddie (1997) and his autobiography, One Flew into the Cuckoo's Egg (2008).

Oddie is survived by Laura and their daughter, Rosie; by Kate (the actor Kate Hardie) and Bonnie, the daughters of his first marriage, in 1967, to the actor-singer Jeanne Hart, which ended in divorce; and by three grandchildren.

At press time a deal to sign Brighton striker Danny Welbeck was all but finalized while Jordan Henderson has cancelled his Brentford contract to enable a move to the Bridge.

Henderson, 36, was under contract until 2027 but the Bees confirmed they had reached a mutual agreement with the England midfielder to terminate his deal. Welbeck will become the oldest signing under the Todd Boehly and Clearlake Capital ownership, until Henderson's likely arrival with the west Londoners. It is part of new manager Xabi Alonso's drive to add experience to Chelsea's squad, which has been the youngest in the Premier League for the past two seasons. Their focus on youth has been viewed as a factor in their inability to challenge consistently for major honours.

Towards the end of last season's disappointing campaign, when they finished 10th and won nothing, Chelsea co-owner Behdad Eghbali said their recruitment model needed a "tweak".

Wellbeck's arrival would leave Chelsea with six senior strikers on their books, with others available for loan or sale. Among those who could leave on either a permanent deal or loan are Nicolas Jackson, Liam Delap and Marc Guiu. The Blues have also brought in Dutch striker Emmanuel Emegha from sister club Strasbourg this summer and he could remain part of the squad. Henderson, meanwhile, would add further experience and seniority to the squad, having been selected by Thomas Tuchel as part of England's leadership group at this summer's World Cup.

Serial winner Stones joins Inter on a free

England defender John Stones has joined Italian champions Inter Milan on a free transfer and signed a two-year contract.

The 32-year-old left Manchester City when his deal expired at the end of June after 10 successful years at the Premier League club.

Stones said he had "lived all my dreams out" after helping City win six Premier League titles, the Champions League, two FA Cups, five League Cups, three Community Shields, the

Club World Cup and the Uefa Super Cup.

Since he became a free agent, the centre-back has attracted interest from clubs across Europe, including Chelsea and Juventus.

Inter Milan were crowned Serie A champions for the 21st time last season and will start their title defence against newly promoted Monza on Saturday, 22 August.

Former Barnsley defender Stones made 295 appearances for City, scoring 19 goals, after joining from Everton for £47.5m in 2016.

He has won 93 caps and was part of the England squad who finished third at this summer's World Cup, starting the quarter-final victory against Norway and 2-1 semi-final defeat by Argentina.

Amid uncertain future, Rashford bids fond farewell to Barcelona

Marcus Rashford has shared a farewell message on social media to Barcelona and their supporters - making it evident that a permanent transfer has been passed over.

The forward found himself frozen out at Manchester United 12 months ago following a falling out with Ruben Amorim and, after a brief loan spell at Aston Villa, managed to secure a high-profile season-long move to the Catalan club.

Built into the loan agreement was the option to make the transfer to the Nou Camp permanent, but Barcelona chose not to pay the £26 million (\$34.9 million) it would have required. Rashford had been candid about the fact that he would have welcomed the opportunity to represent the La Liga side beyond this season.

Rashford netted 14 times in 49 appearances, delivering some meaningful contributions, including a goal in an El Clásico

victory, as Barcelona successfully defended their La Liga title.

However, he was never a guaranteed starter with Lamine Yamal and Raphinha occupying the wide positions, which resulted in fierce competition, and he has expressed his gratitude as he prepares to return to Manchester.

He wrote on his Instagram: "I'm very grateful to everyone at the club for making my time here such a positive and memorable

experience. I've enjoyed every moment and will take many special memories with me. I wish the club and all its supporters the very best of luck and every success in the season ahead. Visca el Barça."

A permanent switch to Barcelona became increasingly difficult when the Catalan giants splashed £70 million (\$81.7 million) on Anthony Gordon, who made the move from Newcastle United. Rashford's compatriot also operates on the wing, sug-

gesting the Spanish club had alternative targets in mind, given they could have secured the United loanee for considerably less.

A return to Old Trafford, where he has not featured for well over 18 months, is made more feasible by Amorim's dismissal. The Portuguese coach sidelined Rashford and was vocal in his assessment, stating that he and the forward did not share the same soccer philosophy.

England turn to familiar face

THE ENGLAND cricket team have returned to a familiar face to lead them following the retirement of Ben Stokes - with Joe Root returning for his second stint as captain.

New Zealander Stephen Fleming has also been confirmed as the new head coach of the Test team.

Marcus Trescothick will take interim charge for the three-game series against Pakistan that starts at Headingley in three weeks, with Fleming due to arrive in the country "later this summer" and assume the reins for this winter's trip to South Africa.

Following what the England and Wales Cricket Board described as "a

rigorous process, which involved numerous high-quality candidates", Fleming emerged as a unanimous choice. Rob Key, the managing director of men's cricket, who led the recruitment process, said England were "very fortunate that someone of his calibre is willing to take on the challenge", adding: "I believe he is the best person to guide a team stacked full of potential and turn that talent into a world-class outfit that can not only achieve success but sustain it."

Fleming, who has signed a four-year contract to September 2030, replaces his friend and former international teammate Brendon McCullum, who was sacked

earlier this month after England's poor performance in the Ashes was followed by a series defeat at home to New Zealand.

The pair will work alongside each other, with McCullum remaining in charge of the white-ball sides, and the decision to appoint Root as captain allows McCullum's burgeoning partnership with Harry Brook, who captains England in limited overs cricket, to continue.

Fleming captained New Zealand in 80 Tests, more than any other player from that nation, winning 28 and losing 27. Root has already captained England in 65, the most of any Englishman, winning 27 and losing 27.

The 35-year-old stood



Root previously captained England from 2017-2022

down from the role in 2022 saying that "it's hit home how much of a toll it has taken on me and the impact it has had on me away from the game", but

enjoyed returning for one of the three Tests against New Zealand and has now agreed to resume the burden on a permanent basis.

■ Magpies boss calls it quits after disappointing 2025-26 season and forced sale of star players

Newcastle manager Eddie Howe is set to leave the club with immediate effect.

Howe came under pressure last season as Newcastle finished 12th in the Premier League after losing 17 of their 38 games.

The 48-year-old's final match in charge was a 4-1 defeat by Bristol City in a pre-season friendly on Wednesday.

Matthias Jaissle, manager of Saudi Pro League side Al-Ahli, is expected to be appointed as Howe's successor.

Howe joined Newcastle in November 2021,

a month after the Saudi Public Investment Fund bought the club.

The club's need to conform to financial constraints have resulted in a number of their star players either leaving or being tipped to do so, and while initially inclined to say on, hostility from some of the fan base and his own exhaustion have prompted Howe's change of heart.

It is understood Howe communicated his intention to leave to the Newcastle hierarchy around a fortnight ago.

Newcastle initially asked him to reconsider and continue leading the

club next season.

Eventually, though, Newcastle accepted Howe's wishes but asked him to stay as they identified his replacement - a request the coach accepted.

Howe is said to be deeply emotional about the decision but it is one that has been on his mind for a number of months.

Newcastle spent in the region of £240m on new players 12 months ago, but Howe was left frustrated by the departure of striker Alexander Isak to Liverpool.

In January, he described losing Isak as "ever-challenging", and

in several media conferences stressed the need for reinforcements.

Howe has lost two key players this summer - Sandro Tonali to Tottenham and Anthony Gordon to Barcelona - while

Arsenal are chasing captain Bruno Guimaraes.

Howe replaced Steve Bruce as manager and ended Newcastle's 70-year wait for a major domestic trophy by winning the 2025 Carabao Cup.

He led the Magpies to Champions League qualification in 2023 and 2025.

Last season, Newcastle reached the Champions League last 16, losing 8-3 on aggregate to Barcelona.

French star LaCroix seals Blues switch



Chelsea have signed France's World Cup defender Maxence Lacroix from Crystal Palace for £52m - with Danny Welbeck and Jordan Henderson likely to follow.

The 26-year-old Lacroix (above) capped seven times by France, has penned a contract at Stamford Bridge until 2032.

The Frenchman joined Palace from Bundesliga side Wolfsburg in 2024 for an initial £15.5m and became a regular under Oliver Glasner last sea-

son.

Lacroix made 55 appearances in all competitions as Palace won the Uefa Conference League, the club's first major European trophy.

The defender made three appearances for France during the 2026 World Cup, including against England in the third-place play-off, as Les Bleus finished fourth.

"I think when I saw the players like Reece [James], like Morgan [Rogers], I'm just really happy to be also in a way

in their story, you know? To write part of the Chelsea story with them," Lacroix said.

"I'm really proud, really happy, to be part of this beautiful project and I just want to start playing.

Lacroix is Chelsea's third signing of the summer transfer window, joining Morgan Rogers and Marco Palestra in moving to west London, as the club prepares for its first season under new boss Xabi Alonso.
