OPERATION FORTRESS: Reform's high seas gamble

■ Farage grabs headlines again with plan to use Royal Navy to turn back small boats

In an ambitious - and undeniably contentious - pitch to British voters, Reform UK has unveiled plans to deploy the Royal Navy to turn back small boats carrying migrants across the English Channel.

Dubbed Operation Fortress, the party has billed the proposal as nothing short of the largest military operation in the Channel since the Second World War.

Unveiled at a London press conference on Monday, the policy outlines a strategy in which the military would active "intercept" vessels originating from France and Belgium and forcibly return them across the water. According to Reform UK, the scheme carries the endorsement of former senior military figures and remains fully compliant with international law on the grounds that its core aim is humanitarian.

different reality

Mr Farage argued that his Operation Fortress would prevent deaths in the Channel.

"It will save lives. It will help the French in fulfilling their job of stopping the boats. And it will save a huge amount

of money.

"When you think about it, what is the Royal Navy for? If the Royal Navy is not there to protect this country from invasion, then frankly, I can't see what its purpose is."

The mechanics of the plan, however, immediately raise formidable legal and diplomatic questions.

Reform UK's Home Affairs spokesman, Zia Yusuf, argued that the United Kingdom could push migrant vessels back without needing Paris's prior approval. Yusuf contended that The Schengen Convention of 1990 which abolished border controls across 29 mostly EU member European countries means migrants arriving in Europe must be processed in the first safe country they reach but in practice they're often allowed to move on, via several countries, to their desired destination. Mi-

grants wanting to get to Britain end up in northern France, or the Belgian coast.

But international maritime law presents a starkly different reality. It requires that nation states must rescue individuals in distress at sea but that those rescued cannot simply be disembarked on foreign soil without the explicit consent of the host country.

'unworkable'

Under existing bilateral agreements, continental authorities already work to intercept thousands of migrants before they can set sail for the English coast. For those who do manage to make the perilous journey, the current procedure relies on the UK Border Force and Coast Guard vessels. These crews board the incoming small craft and escort the migrants safely to ports along the south coast of England for processing.

Yusuf acknowledged the move could spark a "diplomatic argument" between Paris and London - which it did almost immediately, one French politician describing the plan as 'reckless and unworkable'.

The announcement came hours after Prime Minister Andy Burnham vowed to be 'relentless' in combatting small boat crossings after some 60,000 migrants overwhelmed the border of the Spanish territory of Ceuta on the north African coast on Thursday and Friday of last week.

Britain is separated from Ceuta by the chan-

nel, several European countries and more than a thousand miles, but Burnham said his concern was with "the broader issue of the Schengen [free travel] Area and our relationship with it," saying he would seek regular dialogue with the European Union on the matter.

Burnham stressed that in order to defeat people trafficking gangs organizing the boat crossings refugees needed "safe routes" of reaching Britain. Currently, people must get to Britain before they can claim asylum, an almost impossible hurdle for nationals of countries from which

most migrants hail without resorting to traffickers.

Conservatives spokesman Chris Philp was withering in his analysis of the plan: "The Reform Policy, I'm afraid, as usual, is basically some ideas scribbled on the back of a fag packet. By the way, I'm not averse to taking action at sea if it's credible. But the Reform policy isn't credible."

The number of people crossing the English Channel in small boats fell 43% in the first seven months of this year, compared with the same period in 2025, according to Home Office data.

Former neo-Nazi steps down as Tory candidate for West Country seat

"We need to have a bar when it comes to standing for public office, and I strongly believe that this individual falls very, very short of that."

A former neo-Nazi who was controversially selected by the Conservative Party to contest a local council election in Somerset next year has withdrawn his candidacy.

Joshua Bonehill-Payne had previously been jailed for racially aggravated harassment of a Jewish Labour MP.

Tory leader Kemi Badenoch had defended the decision to select him as a candidate for the new Somerset Council seat of Crewkerne South, saying he had been rehabilitated and her party "believes in second chances".

But Bonehill-Payne said he had now withdrawn his candidacy, and had been offered a position as an anti-extremism adviser to the party.

In a social media post, he said the position with the Conservative Party's Culture and Integration Commission would focus on advising on how to

prevent young men from being radicalised.

Joshua Bonehill-Payne admits that when he was 21, he embraced anti-Semitism. He was jailed for three years in 2016 for a campaign of anti-Semitic posts and was also convicted of the racial harassment of people, including the former Labour MP, Luciana, now Baroness Berger, who's Jewish. But he says that prison changed him and has spent the years since opposing anti-Semitism and carrying out training for the police and others on how to combat extremism.

Berger, who now sits as Baroness Berger in the House of Lords, described the appointment as an "insult," adding that making him a party adviser was "no better than allowing him to stand as a council candidate".

The decision to pick him for the Somerset seat

sparked a huge political backlash, with Jewish groups declining the offer from Bonehill-Payne of a meeting.

The criticism of his candidacy from Jewish groups made Bonehill-Payne's decision to step down feel increasingly inevitable.

There are likely to be questions about Badenoch's judgement in this case after her decision to defend him so publicly raised eyebrows in Westminster.

UK Foreign Secretary Ed Miliband said Bonehill-Payne "should never have been a candidate ... given the harassment that he visited on Luciana Berger, a colleague and a friend of mine".

"[The] Conservative Party should answer for why he was a candidate in the first place and also for any future activities he might be undertaking on behalf of the Conservative Party," he said.

DROUGHT UK: as Britain bakes, blame game comes to a boil

July 2026 was the driest month in southern England since records began nearly 200 years ago, the Met Office has said.

England and Wales also provisionally recorded their driest July since records began in 1836. Wales had its joint warmest July on record for mean temperature, and England recorded its second warmest July.

The Met Office said the "remarkable conditions" this year came amid a summer marked by multiple heat records.

The heatwaves have been made more intense and more likely by the fossil fuel-driven climate crisis. The heatwave that affected western Europe at the end of June was the most severe and widespread ever.

July was the sixth consecutive month this year to have had above average mean temperatures, with only January so far experiencing mean tem-

peratures below average.

Dr Amy Doherty, a science manager at the Met Office, said: "The combination of record-breaking dryness, exceptional warmth and unprecedented sunshine has delivered one of the most notable summer months in our historical records."

Hosepipe ban

The Environment Agency said the conditions were affecting farmers, wildlife and the amount of water available for public and business use.

Half of England and the whole of Wales were last week declared to be officially in drought. In England, 40% of the population are under a hosepipe ban.

Nineteen counties recorded less than (or equal to) 1mm of rainfall in July. These were: Berkshire, Dorset, East Riding of Yorkshire, East Sussex,

Essex, Gloucestershire, Greater London, Herefordshire, Isle of Wight, Kent, Leicestershire, Lincolnshire, Northamptonshire, Nottinghamshire, Oxfordshire, Rutland, Surrey, Warwickshire and West Sussex.

The drought is stoking rising anger among some Britons that the government is not doing more - sentiments echoed by the leader of the Green Party in England and Wales, who has accused the government of a dereliction of duty on the issue.

Zach Polanski said that the UK was facing the biggest threat to the country since the Second World War, arguing that after the recent heat waves and wildfires, the government had come up with precious little detail about how it would protect people from this crisis, which he said was putting lives and livelihoods at risk. Polanski

Man charged in murder of British aid worker

A man accused of killing a British aid worker and disposing of her body in a suitcase has appeared in court charged with homicide with intent.

The body of Elisabeth-Jane Ross, 38, was discovered by a homeless man in a derelict building in the Kypseli area of the Greek capital on 18 July.

The suspect accused of killing Ms Ross, also known as Lisa, is widely reported to be Sharif Ahmadzai, 26, an Afghan boxer who left his home country after being orphaned as a teenager.

The authorities are yet to publicly confirm his identity.

Ahmadzai previously appeared in court on Wednesday, having arrived in an unmarked car accompanied by masked police officers.

He arrived at the Court of First Instance

claimed there was urgent action the government could take, including increasing the number of firefighting helicopters funded by taxing fossil fuel firms.

He also proposed cool spaces in every local area, which would be free for people to use, financial help for households to heat proof their homes, and bringing water companies back into public ownership. Addressing Andy Burnham directly, Polanski challenged him to stick to Labour's policy of no new oil and gas drilling in the North Sea, after there were reports that he may allow further production.

"Some will say we can't afford to make these changes. These last few weeks are showing we can't afford not to. We are facing an existential threat. People are dying. People are scared."

in Athens at about 10.40am local time on Thursday, in the back of a grey Hyundai car with blacked-out windows.

During the hearing held behind closed doors, it is understood he was assigned a court-appointed lawyer and given time to prepare his defence.

Ahmadzai returned for a second hearing on Thursday, and again was flanked by masked officers as he arrived and left court.

no plea

Ahmadzai's lawyer, Christos Erdas, confirmed his client exercised his right to remain silent during the hearing, and that he did not submit a plea in relation to any of the three charges he faces.

Ahmadzai, who was initially detained on illegal weapons possession charges, is facing a charge of homicide with intent, as well as accusations he stole more than €10,000 (£8,573) from the victim's bank accounts using her bank cards.

'deep pain'

The judge ordered Ahmadzai be kept in pre-trial detention while further evidence is compiled, ahead of another hearing at a future date.

In a statement, Ms Ross's family said: "Lisa will always be remembered by us as kind, principled and selfless.

"Her integrity was absolute and she dedicated her life to helping others in need. We are in deep pain and we ask for time and privacy as we come to terms with our loss.

Greek police said last week there were no signs of injury or harm when Ms Ross' body was discovered. They said further tests are being carried out to establish how she died.

The court complex is in the city's Evelpidon Street, a short walk from the derelict building where the charity worker's body was discovered.

Police said the suspect was detained for questioning after investigators reviewed CCTV footage from near the abandoned building.

After allegedly killing Ms Ross, who is understood to be from Edinburgh in Scotland, Ahmadzai is accused of sending a series of messages from her phone to her friends and family before switching off the device.

He is then said to have bought another phone and texted her friends in Athens, including his wife, impersonating an unnamed jihadist saying he had killed the Scot because of her religion, Greek newspapers Proto Thema and Ta Nea reported.

The newspapers reported his wife told the police she suspected her husband's involvement

in the death when she woke up to find he was not in their apartment and tracked his phone to where Ms Ross was staying.

Ms Ross is believed to have died between five and seven days before she was found.

The Hellenic Police, Greece's national force, were able to identify her using fingerprints and with the help of Interpol.

Ms Ross arrived in Greece on 26 June and was initially staying with friends in Piraeus, a port area of Athens.

She is then said to have gone to meet American friends in another part of the city, but it is unclear if she arrived at the event.

Authorities are awaiting the results of tissue analysis to determine whether she died from

suffocation, as suggested by a preliminary assessment by the medical examiner.

The Foreign, Commonwealth and Development Office (FCDO) said earlier: "Our thoughts are with Elisabeth's family during this difficult time.

"We are providing consular support and are in contact with the local authorities."

Jail for benefits fraud who kept dead mum in freezer

A man from South Wales has been jailed for keeping his dead mother's body in a freezer while continuing to claim her pension and benefits for almost three years.

Christopher Phillips, of Porthcawl, was his mother, Sylvia's main carer and lived with her until her death in March

2023. Instead of reporting her death to the authorities, two days later, he bought a chest freezer, wrapped her body in a blanket and placed her inside covering her with flowers. The court heard how he slept downstairs to be near his mother and would sometimes open the freezer to hold her hand.

For almost three years, he continued to accept her pension payments, benefits and winter fuel allowance, a sum of more than £78,000.

Sylvia's body was discovered only when the local medical practice asked police to conduct a welfare check on her in February 2026. Christopher Phillips ini-

tially claimed she was staying with family in London before officers found the freezer in the dining room.

As she sentenced the 60-year-old, Judge Tracey Lloyd Clark said his deceit was deliberate and sustained.

"You deliberately concealed your mother's death and took steps to

give the impression that she was still alive. You continued to collect her prescriptions and lied to medical professionals and eventually to the police."

He was sentenced to two years and four months in prison after pleading guilty to fraud and preventing a lawful and decent burial.

New baby for Eugenie

Princess Eugenie has given birth to a baby girl at a hospital in Lisbon, Portugal.

The baby was born on Monday at 18:20 BST, weighing 6lbs 9oz.

This is Princess Eugenie's third child with her husband, Jack Brooksbank, following the births of her sons August Philip Hawke Brooksbank, who was born in 2021, and Ernest George Ronnie Brooksbank, who was born in 2023.

A statement from Buckingham Palace read: "Their Majesties The King and Queen and other members of The Royal Family were delighted to be informed of the news."

In a post on Instagram, the princess, 36, wrote: "Jack and I are so excited to announce Baby Girl Brooksbank!!

"We are beyond in love with our girlie."

They are yet to announce a name.

The new arrival - who will not be an HRH - will be 15th in line to the throne, moving ahead of their great-uncle the Duke of Edinburgh, Prince Edward.

The couple live between Portugal and Ivy Cottage, in the grounds of Kensington Palace.

They announced Princess Eugenie's pregnancy in May. She posted a photograph of her young sons holding a baby scan with the caption: "Baby Brooksbank due 2026!"

The Palace said on social media at the time: "His Majesty The King has been informed and is delighted with the news."

Eugenie and Brooksbank married in October 2018.

The baby will be a fifth grandchild for the princess's father, Andrew Mountbatten-Windsor.

Jimmy Cricket, comedian known for his 'And there's more!' catchphrase, dies aged 80

■ Family-friendly style made the comic a household name in the 1980s and he was awarded a papal knighthood in 2015 for services to charity

Jimmy Cricket, the northern Irish comic who became a regular fixture on British television throughout the 1980s, has died aged 80.

Known for his catchphrase: "And there's more!", Cricket fronted his own ITV series of the same name on which he rocked his signature look of tailcoat, short trousers and wellington boots marked clearly with "L" and "R" on the wrong feet. He also appeared at the 1984 Royal Variety Performance as well as in the BBC's long-running light entertainment vehicle *The Good Old Days*.

A statement from his family posted on the Jimmy Cricket Facebook page read: "Our beloved Jimmy passed away this morning after a short illness. He spent his last few days surrounded by his family, love, laughter

and songs."

Born James Joseph Mulgrew in Cookstown, Northern Ireland, Cricket left school aged 16 and began working as a Butlin's Redcoat a couple of years later. After moving first to Stockport and then Rochdale, Cricket worked the northern comedy circuits in England throughout the 1970s, gaining his big break when he reached the semi-finals of TV talent show *Search for a Star* in 1980.

'so much laughter'

He spent the 1980s as a household name, with numerous appearances in *The Krankies Klub* and *The Good Old Days*. In 1987 he was the featured celebrity on an episode of *This Is Your Life*. By the mid 1990s he had moved towards radio, starring in four series of

the acclaimed BBC Radio 2 show Jimmy's Cricket Team alongside other comedy talent.

Cricket had a reputation as a family man, marrying May Tweedie in 1972. The couple had four children.

The family statement said: "Jimmy brought so

much laughter and happiness to countless audiences throughout his career. Whether on stage, screen or radio, or if you met him in person. But that was nothing compared with the happiness he gave to his family. A devoted husband to May for 52 years. A wonderful

dad to his four children and a very silly grandad indeed to his four grandchildren. He was our greatest champion and loved us all loudly. Forever our clown, he was cracking jokes to the wonderful NHS staff and to us all right until the end."

A bit TOO fringe? Edinburgh uproar as Foxy Knoxy debuts one-woman show

THE EDINBURGH Festival Fringe was beset by controversy this week after the opening of comedy show fronted by an American woman once convicted of murdering a British student.

Amanda Knox, who was convicted but later acquitted of murdering British student Meredith Kercher in Italy in 2007, has defended her solo comedy show following calls for it to be cancelled.

The sold-out show called *Cartwheel*, discusses motherhood and how she will explain the case to her daughter.

Knox told reporters she is not the first person to use comedy to talk

about traumatic events and said her material focuses on "how the world is unsafe and unfair towards women".

But Stephanie Kercher, the victim's sister, said she is concerned it will "normalize and trivialize" violence against women, and Meredith, in particular.

Stephanie told reporters: "What I would say [to Knox] is to think about the family here, think about her friends and to turn the tables if it was your sister that this had happened to, because I know you have a sister as well."

A petition against the show, set up by a friend of Meredith, has been

signed by nearly 5,000 people.

It states the show disrespects her memory and risks making light of such a harrowing event.

Stephanie Kercher added she did not believe Meredith would find these topics of any comedic value.

She said: "Our family's pain is immense. I can't explain to you how much pain our family have been through, and also we're talking two decades later now, this pain.

Now 39, Knox is married with two children and lives in Washington state.

Knox, from Seattle, and Kercher, from Sur-

rey, were both exchange students sharing a house in the university town of Perugia.

Alongside her then-boyfriend, Raffaele Sollecito, Knox was arrested on suspicion of murdering Kercher, 21, who was found dead in

their house.

Her throat had been cut and she had been sexually assaulted.

Knox was found guilty and spent four years in an Italian prison before she and Sollecito were acquitted through an appeal.

Joint enterprise: missing kneecap finally returned

An Abbott's kneecap has been returned to Somerset after it was pocketed by a schoolboy on a trip to Glastonbury Abbey more than 70 years ago.

George Box, described as a scallywag by his widow, was just 11 years old when he ducked under the ropes during an archaeological dig at the Abbey in 1956 and took the medieval bone from an open tomb.

After George died last year, his widow got in touch with Glastonbury Abbey to confess to her late husband's childhood pilfering. The Abbey says she described him as a scallywag who had not only taken the bone, but a fragment of medieval floor tile too.

In 1970, George emigrated to Australia, where the Abbot's kneecap and tile were on display in a glass cabinet in his hallway. But it was only after he admitted the theft to his wife that he finally agreed that both artifacts should be returned.

One of three remaining Trafalgar flags to stay in Britain after fundraising campaign

Royal Navy flag flown from HMS Royal Sovereign will be put on view in Newcastle

A Royal Navy flag that was flown at the Battle of Trafalgar will remain in Britain following a fundraising campaign.

The Union Flag was flown from HMS Royal Sovereign, flagship of Vice-Admiral Cuthbert Collingwood, second-in-command to Lord Nelson at Trafalgar in 1805.

It had been due to be sold outside the country, but an export bar was put in place because of its historical significance and a fundraising drive to save it began.

The flag will now be put on display in Newcastle, the city in which Collingwood was born and many of his men were raised.

Susan Collingwood-Cameron, the great-great-great-niece of Collingwood, said: "This flag is said to have

been made by sailors on board the ship, many of whom came from Tyne-side and were affectionately referred to by him as his 'Tars of the Tyne'.

"It will be a tribute to them, and the important role they played, in one of our greatest moments in history. There may well be descendants of their families still living in the area."

defining moment

Measuring 1.525 metres by 2.745 metres, the flag was hand-stitched in wool bunting. It is scarred, but remains in good condition.

Battle of Trafalgar was a defining moment in the Napoleonic Wars, and there are just three remaining flags from it.

The flag was kept as a souvenir by Charles Aubrey Antram, a 17-year-old who was serving as

a master's mate on the ship, and passed down through his family until it came into a private collection.

North East Museums has raised more than two-thirds of its £700,000 fundraising target to purchase the flag and create a permanent home for it at the Discovery Museum in Newcastle.

The National Heritage Memorial Fund supported the purchase with a £400,000 grant, and further support has come from other organisations

as well as the Collingwood family.

The flag cost £450,000 with a further £250,000 needed to transport, store and conserve it in a permanent display. The museum group is crowd-funding the outstanding amount.

Keith Merrin, the director of North East Museums, said: "It is wonderful to have acquired this rare and historically significant flag to ensure it remains in the UK and specifically in north-east England, which was

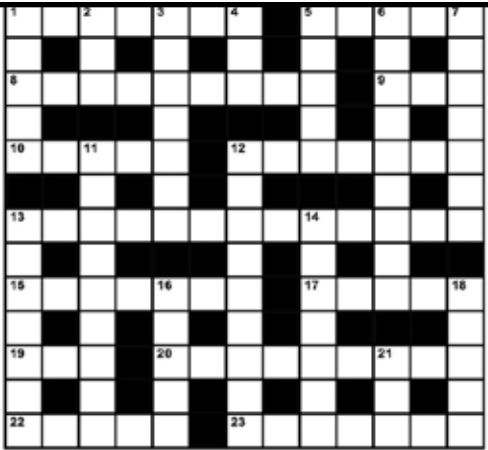
home to Vice-Admiral Collingwood and many of his crew.

"Collingwood is a popular figure in the North East, but perhaps isn't given the national hero status that he and his crew deserve.

"Our fundraising continues so that we can create a permanent display with the flag as the centrepiece at Discovery Museum in Newcastle, where it can be enjoyed by hundreds of thousands of visitors each year."

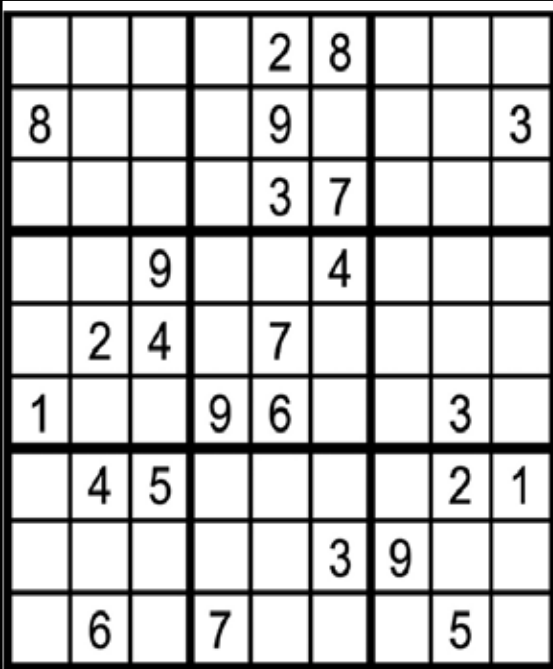

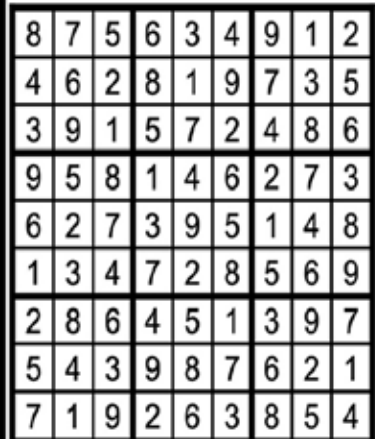

Saying goodbye to the Britannia

Santa Monica loses yet another British watering hole after thirty glorious years

SANTA MONICA: the words 'end of an era' are used far too much in this day and age, but this week they couldn't be more accurate.

After more than three decades as a beloved fixture for the local ex-

pat community, the Britannia Pub at 318 Santa Monica Boulevard has closed its doors for the last time following the expiration of its lease on July 31.

Long operated by Sonia Cain with help from

her family, the British pub and restaurant is making way for a Taco Bell Cantina, a transition that has prompted a wave of nostalgia and some local concern about the changing character of the Third Street Promenade area.

The pub has been a vital watering hole for British expats and thirsty locals for more than thirty years, welcoming one and all with a great selection of crowd-pleasing bevies including Guinness, Stella, Heineken, ciders, and rotating IPAs. But Sonia ensured it was always much more than a place to merely whet your whistle, with the pub also serving a full menu of British classics including fish and chips, bangers and mash, shepherd's pie, sausage rolls, and a hearty Captain's Breakfast featuring Irish bacon rashers, bangers, eggs, hash browns, stewed tomatoes, Heinz baked beans, and sourdough toast. And don't get us started on that Liverpudlian banter... which was free and usually served in large portions.

And the success of the place wasn't just Sonia's leadership, but also to their loyal crew of bar staff, doormen, and the

inimitable Joey, who was always there to lend a helping hand.

The crew celebrated one last time at the weekend as friends, family and locals gathered to say goodbye to a much-cherished institution. There were plenty of memories, laughter and tears.

Despite what many would consider an ideal location smack bang in the middle of downtown Santa Monica and the Third Street Promenade, it wasn't all plain sailing. The pub had to deal with vandalism in 2016, the George Floyd riots in 2020, the Covid closures and the broader struggles of the Third Street Promenade, which has seen steep declines in foot traffic in recent years.

But Sonia stuck it out through thick and thin, and the pub will henceforth exist only in our distant and melancholy memory, another chapter in the annals of bygone British hospitality in the area that has included, (in our memory at least), The Mucky Duck, Milly O'Malley's, The West End, The Two Drops O' Scotch, the Cock & Bull and of course, the legendary King George V.

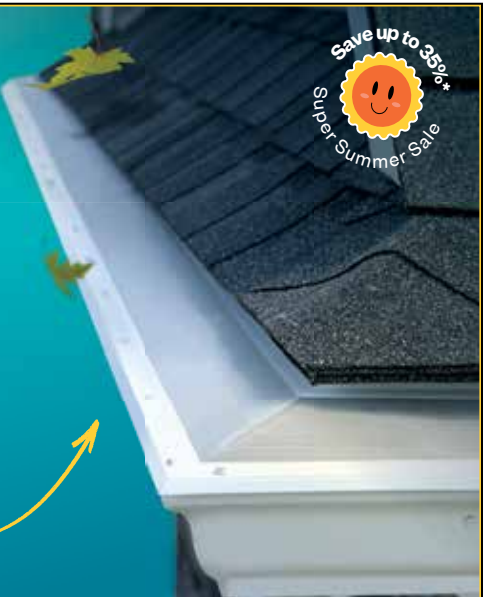

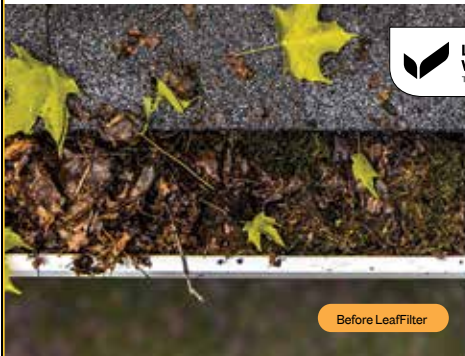

Salah confirms Trabzonspor switch

After months of speculation, Mohamed Salah's next destination has finally been confirmed.

The Liverpool legend inked a two year deal with Turkish side Trabzonspor on Thursday following the expiry of his contract at Anfield, bringing an end to one of the most successful careers in Premier League history.

The move has surprised many.

For years, Saudi Pro League clubs pursued Salah, while Major League Soccer was also viewed as a realistic destination for one of world football's biggest stars. Instead, the 34-year-old has remained in Europe by joining Trabzonspor, a club better known for upsetting Turkey's established order than dominating it.

So why has Salah chosen Trabzonspor, and

what can both player and club expect from one another?

If Salah was determined to stay in Europe, Trabzonspor might not have been the obvious choice.

Money alone does not explain Salah's decision. Saudi Arabian clubs had

long identified the Egyptian as one of their priority targets, with Al-Ittihad even making a late approach, while Sporting Kansas City were among the MLS clubs interested in bringing him to the United States.

Both destinations could

have offered enormous monetary rewards. Instead, Salah opted to stick with European football.

He will be very well paid in Turkey. In a posting to the Turkish stock exchange, Trabzonspor confirmed he will be paid £14.5m per season and will receive a 20% share of revenue from Salah-branded merchandise.

Trabzonspor finished third in last season's Super Lig and will compete in this month's Europa League play-offs. Victory over two legs would see them qualify for the league phase, while defeat would send them into the Conference League.

For a player who helped Egypt reach the knockout stages of this summer's World Cup and produced one of the finest campaigns of his career in 2024-25, continuing to compete in Uefa competition appears to have carried significant weight.

Turkey's traditional powerhouses are Galatasaray, Fenerbahce and Besiktas, with most of the country's biggest-name arrivals historically choosing one of the Istanbul giants.

Besiktas did attempt to sign Salah before negotiations collapsed over the financial structure of the deal.



GIANNI INFANTINO: will he ever leave?

UEFA keep up the pressure on embattled FIFA boss

European teams could still boycott competitions including the World Cup as Uefa says Fifa's defence of its president Gianni Infantino "changes nothing".

The English FA has sent a letter withdrawing its support for Infantino in reaction to the plan to sell off stakes in the World Cup to private investors.

European governing body Uefa said in a statement its conditions had not been met, despite Infantino's plan being aborted.

"First, the proposals to sell off the major competitions had to be withdrawn and secondly," Uefa's statement said. "Assurances have to be made that such attempts to disfigure the game in this way will never be made again."

"These conditions have not been met."

Uefa has already said it has lost confidence in Infantino, calling the Fifa Forward Enterprise (FFE) proposal a "shabby, back room, opaque deal".

World governing body Fifa said during Wednesday's meeting "mistakes" regarding FFE were "acknowledged", saying it was "not the intention" for the Fifa Council and members association to "feel excluded from the process and that the process should have been handled differently".

Uefa's statement in response added: "Uefa

made it abundantly clear in its statement on Saturday that it has lost confidence in Gianni Infantino's presidency. That position holds.

"Yesterday's announcement that some people employed by the Fifa president (and whose careers depend on his favour) agree with him changes nothing."

Infantino arrived at Fifa's offices in Rabat, Morocco on Wednesday with many wondering whether he would still be the Fifa president when he left.

But this was not the 56-year-old being ordered to a hearing to explain his actions.

It was Infantino who summoned members of the Fifa management board to sit around the table with him, to talk through the events of the last week.

Secretary general Matthias Grafstrom, Infantino's right-hand man, had been critical in an internal memo to staff, calling the FFE proposals "a sad and reproachable series of events".

After the meeting finished it appeared to be water under the bridge, with Infantino and Grafstrom pictured sat next to each other and smiling at a Women's Africa Cup of Nations match between Malawi and Zambia.

If there were clear-the-air talks, they appear to have worked.

Van de Ven close to new Spurs deal

Micky van de Ven is close to agreeing a new five-year deal with Spurs.

The Netherlands international defender joined from Wolfsburg in 2023 on a six-year agreement that runs until 2029.

Van de Ven was considering his future in north London before the appointment of Roberto De Zerbi in March.

And the arrival of the Italian manager, who helped keep Spurs in the

top flight, has been crucial in the 25-year-old's decision to seek new terms.

"It's really good that you can see the club has made some changes," said the defender.

"You can see the club has a new ambition. It's something that's really important for players who have been here for a long time."

"Last season was a stressful season, unacceptable from our side,

so to leave all of that behind and go into the new season fresh means a lot."

Spurs have finished 17th in the Premier League in back-to-back seasons and their battle to stay in the top flight ran to the final day of the 2025-2026 campaign.

After a turbulent nine months featuring three managers, Van de Ven said he is looking forward to a brighter future under De Zerbi.

League after a 4-3 defeat by Newcastle on 7 January.

Leeds are investing in the potential of a young goalkeeper whose highlights have largely come in the Championship with Burnley, where he conceded just 16 goals in 45 appearances. Bruno on the verge of Arsenal move

Brazilian star expected to seal £75m switch this weekend

Arsenal are set to complete their protracted move for Newcastle United captain Bruno Guimaraes.

Guimaraes was expected to move to the Premier League champions this weekend for a fee of about £75m following a breakthrough in talks. And a full agreement is now almost done, with Guimaraes waiting for permission to leave Newcastle's training base in La Manga, in Spain, to finalize the formalities of his move to Emirates Stadium.

The Gunners are now making preparations for the Brazil midfielder's medical this week.

Guimaraes, who joined Newcastle from Lyon in 2022, has made clear his intention to join Arsenal as the 28-year-old has emerged as Mikel Arteta's first-choice central midfielder target.

Guimaraes' former club Lyon are entitled to 20 per cent of Newcastle's profit on the midfielder, and will earn £6-7m from the deal.

Back in early July Guimaraes informed Newcastle of his desire to leave the club and move the north London, with Arsenal initially expressing a willingness to pay up to £60million. This followed a verbal bid - worth below £60m - from Arsenal which was rebuffed by Newcastle, who had maintained that they would not be entertaining offers for the player.

Guimaraes has two years left on his Newcastle contract, having signed a five-year deal in October 2023. That contract had a temporary £100m release clause inserted, but it expired in June 2024 without being exercised.

Guimaraes' impending

departure will be the latest high-profile exit from Newcastle this summer. Eddie Howe has departed his role as head coach, with Matthias Jaissle of Al Ahli set to replace him. Newcastle sold winger Anthony Gordon to Barcelona for €80m and midfielder Sandro Tonali to Tottenham Hotspur in a deal worth £100m. They missed out on Freiburg's Johan Manzambi, who instead joined Aston Villa, and Victor Munoz, who opted for a move to Liverpool.

Guimaraes joined Newcastle from Lyon in January 2022 in a deal worth €50m including add-ons. He has made 153 Premier League appearances for the club, scoring 30 times and recording 26 assists, and was also part of the team that won the Carabao Cup in 2025. The midfielder featured 41 times

in all competitions last season, providing nine goals and eight assists. Guimaraes started all five of Brazil's games at the 2026 World Cup, providing four assists.

Newcastle have brought in 18-year-old midfielder Sean Steur from Ajax in a deal worth in the region of €25m, and 20-year-old midfielder Aladji Bamba from Mo-

naco in a deal worth up to €40m. Newcastle also had a bid of around £46m rejected by Tottenham for midfielder Lucas Bergvall, who is also being pursued by Nottingham Forest.

Trafford leaving City for Leeds

Leeds United have signed Manchester City goalkeeper James Trafford in a deal worth up to £45m.

The England international has left Etihad Stadium just a year after returning from Burnley in a £27m move last summer.

Trafford, who was part of England's World Cup squad this summer but did not feature, made 17 appearances for City last season - four in the Premier League - but played a big part in their Carabao Cup and FA Cup triumphs.

The 23-year-old's move to West Yorkshire comes after the arrival of Champions League-winning goalkeeper Gianluigi Donnarumma, in September, ended Trafford's

hopes of establishing himself as Manchester City's first-choice goalkeeper.

The move represents a new record fee for a British goalkeeper, surpassing the previous benchmark of £30m which Everton paid Sunderland for Jordan Pickford in 2017. It also makes him one of the most expensive goalkeepers in history, with only Kepa Arrizabalaga (£68m)

and Alisson (£62m) commanding higher fees.

More than £80m has now been spent on Trafford in initial transfer fees. As part of the deal taking him to Leeds, City will retain a 20% sell-on clause and have matching rights - meaning if they match a future offer for Trafford they will get first refusal on him.

Leeds boss Daniel Farke appears willing
