ECLIPSE CRAZY!

■ Millions gather across Britain to witness 'amazing' celestial event

MILLIONS of people enjoyed a unique spectacle this week as the Moon moved in front of the Sun in the UK's first maximum solar eclipse in nearly three decades.

The phenomenon was also visible across large parts of Europe and North America, and there was a rare total eclipse in Iceland and Spain.

Crowds fell silent at Land's End in Cornwall, the most westerly point in England, as 98.5% of the Sun was covered.

Hundreds excitedly gathered on a cliff top overlooking the Atlantic to watch darkness fall for around a minute.

Van Sabellina, 31, from Truro, watched the

eclipse with her husband and their baby.

She said: "It was amazing – once in a lifetime. We were very lucky with the weather and being able to witness it in Land's End was spectacular.

"It was a bit eerie. You feel the change in temperature from hot to refreshing and cold. I feel very lucky to have watched it. We don't know when there will be another one."

Judy's Body Art, a shack next to the Land's

End sign, sold over 140 pairs of eclipse glasses in just two hours. Owner Judith Dyulaine Buskas said: "We have been very busy today."

Another way to view without damaging the eyes was to use a colander to spot-project the eclipse on to a sheet of paper.

Abdul Othman, 28, watched at the National Space Centre in Leicester. A crowd of 400 cheered after counting down from 10 until the eclipse

reached its maximum coverage.

Abdul said: "It's a once in a lifetime opportunity. You hear about it all the time in your life, and then to see it with your own eyes and actually see the moon go across the sky and turning the Sun into just a little crescent, it's kind of surreal. And then when you see the sky getting darker, that's also quite amazing to see."

Dhara Patel, who is a space expert at the centre, said: "We've had solar eclipses over the last couple of years, about 30% coverage, but this is a different scale. And what's really nice is it's a way to connect with nature – looking up at the sky at objects that we typically take for granted."

People also swarmed to Greenwich Park, South East London, to experience the eclipse.

Kim Rebecca, 26, of Canada Water, said: "You could definitely notice it getting darker."

The city asset management worker added: "I have never seen an eclipse before and it is an amazing phenomenon. It is still hot but it is noticeably cooler than it was."

"There was champagne corks popping. It has been good because it has been a real community thing and got a lot of people together."

Will O'Grady, 36, who is studying physics at Cardiff University, took a telescope to Cardiff Bay and shared it with passers-by. He said: "Loads

of kids loved it. It's nice for people visiting from another country as well, their English is not great, but you get the idea of 'have a look'.

"For two hours everyone gets together and does the same thing. It doesn't matter if you know anything about it, or whether you're a geek like me. That's what I love about things like this."

Northern Spain and Iceland were among the nations to get a totality – meaning the moon covered nearly 100% of the Sun's surface. The display was received with whoops and cheers in Reykjavik, Iceland's capital, and many were stunned into silence in Burgos, Spain.

Reality bites as PM blasted for dithering over early release of violent offenders

■ As prison overcrowding reaches crisis point, Burnham faces fury over possible release of cop killers after just six years in jail

Andy Burnham is facing his first tough test as Prime Minister amid growing concern about the early release of violent offenders back onto British streets.

If the recently-elected Burnham was hoping to ease into the job amid the usually news-lite silly season of August, those hopes came to an abrupt halt this week amid outrage at the prospect of two cop killers being released early next year amid record prison overcrowding.

'confident'

Jessie Cole and Albert Bowers who were jailed for 13 years for manslaughter in 2020, following the death of PC Andrew Harper, were scheduled for release in January before a media-fuelled petition to prevent them from being freed gathered almost a million signatures in just three weeks.

On Monday Burnham said he was "confident" Cole and Bowers could be excluded from the government's early release scheme.

The prime minister has now ordered the justice secretary to find a way to bar their release, marking a shift from last week, when he said there was "nothing more" he could do without risking the collapse of the prison system.

Harper's mother, Debbie Adlam, told reporters she was in "turmoil" following conflicting reports about whether two of her son's killers would be released from prison early, describing the handling of the situation as a "hash".

Conservative shadow home secretary Chris Philp accused Burnham and Labour of "re-traumatizing victims and their families with their constant U-turns".

On Tuesday evening, an open letter signed by 50 chief constables, commissioners and law enforcement leaders called on Burnham to examine "every lawful option" to determine whether the earlier release of Harper's killers can be prevented.

'people pleaser'

They welcomed the prime minister's intervention, adding: "This provides an opportunity not only to examine every lawful avenue in PC Andrew Harper's case, but to ensure similar concerns do not arise again."

In his first few weeks in Downing Street, Andy Burnham could hardly have been clearer that his aim as prime minister is to

make people feel better.

His supporters inside the Labour Party characterise him as a leader with the political nous to prioritize policies that will make a difference, and the communication ability to sell those messages to the masses.

His critics, including Conservative leader Kemi Badenoch, have branded him a "people pleaser" who doesn't want to take difficult decisions.

The conundrum over how to manage the early release of prisoners is an acute example of the tricky political decision-making that inevitably comes with power.

bly comes with power.

Over the weekend, the Ministry of Justice said that exempting more prisoners from early release risked "prisons reaching capacity and collapsing".

Burnham said a new plan to prevent more prisoners from being freed long before the end of their sentences would be presented to Parliament in September.

It comes after he initially announced some prisoners convicted of rape, serious child sex and other grooming offences would be barred from early release, after a review of the scheme he ordered af-

ter he became prime minister.

He added: "I know I can look people in the eye and say to them there is nothing more I could have asked for without risking the prison system reaching capacity and collapsing within months."

But on Tuesday, Burnham insisted he had never accepted "there was nothing more that could be done" to prevent the early release of more offenders, including Harper's killers.

"I came into office and started pushing on this issue, and I have pushed every single day in office," he added.

Navy all at sea as it emerges their high-tech drones are sending signals to China

■ Officials claim no sensitive information was transmitted, but the finding underscores worries about military supply chains

The Royal Navy has stripped internet connectivity from a fleet of K3 Scout surveillance drones after cameras were found sending signals to China.

A routine cyber vulnerability assessment uncovered so-called heartbeat communications passing between the drones' cameras and an IP address located in China.

The vessels, used by the Coastal Forces Squadron and 47 Commando, form part of a £12 million fleet purchased since March 2026.

Kraken Technology Group, a British defence contractor that supplied

the K3 Scout drones, sourced the cameras from a third-party manufacturer based overseas.

The company had reportedly given assurances about the security of those components before they were ever fitted onto the vessels.

"We are aware that some third-party, NDAA-compliant cameras had a small number of components originating from outside the UK," said a Kraken Technology Group spokesman.

"After a full audit by

both Kraken and the Royal Navy we are confident no sensitive information has ever been shared outside of intended channels and any potential vulnerabilities have been identified and closed."

Despite that reassurance, Kraken later admitted that checks on the origin of the components had failed and confidence in the platform had been lost entirely.

Nato trials

The Ministry of Defence maintained that its own networks and systems had not been affected by the discovery in any way.

"A thorough investigation found no evidence of MoD data or systems being compromised," said a spokesman for the Ministry of Defence.

The K3 Scout, designed to carry a 1400lb payload and operate continuously for 30 days, has also been bought by the US Special Operations Command.

It has also taken part in a series of Nato trials in the Baltic Sea alongside allied navies from the region.

The drones also formed part of a future defence package offered to help secure movement through the Strait of Hormuz.

The breach has renewed scrutiny of the Government's drone procurement strategy, which is backed by a £5 billion investment pledge.

The government has promised to make defence purchasing "unashamedly pro-Britain," yet the case shows how deeply Chinese-made components remain embedded in British-labelled military hardware.

Single boat carrying 230 migrants crosses Channel

■ As public anxiety grows over issue, Government stresses total numbers are down on recent years

A small boat has crossed the English Channel carrying 230 people, the largest number to make the journey in a single vessel.

It breaks the previous record set in July, when 165 people made the crossing on a single vessel.

The boat arrived in the UK in the early hours of Monday.

A picture taken off the coast of northern France (right) showed the inflatable boat was so full many passengers had to dangle their legs in the water as it entered the busy shipping route.

'buckling'

A Home Office spokesperson said this latest incident demonstrated the "reckless and dangerous tactics employed by criminal gangs... who continue to put lives at risk by cramming ever greater numbers of people onto unseaworthy vessels".

French rescuers said the 15m (49ft) boat was "buckling" in the water

and could have led to a "tragedy".

The boat was already carrying about 50 people when it was seen heading towards a beach to pick more passengers up, the crew in Berck-sur-Mer added.

French maritime officials said 30 migrants were left stranded by the tide during a boarding attempt at Berck beach in northern France.

They were brought to safety by maritime and land-based rescue services, the statement from France's Channel and North Sea Maritime Prefecture said.

The boat carrying 232 people continued its journey, before two passengers requested assistance and were taken to Calais by a French Navy rescue ship, the statement added.

There are signs smugglers have been putting increasing numbers of people into each boat.

In 2018, there was an average of seven people per boat - but last year, that had risen to 62.

Last Tuesday, 173 migrants had to be rescued from a single boat which caught fire.

Some 258 migrants arrived in the UK in four boats on Saturday, ac-

cording to Home Office figures, with 423 arriving in five boats on Sunday.

However, the number of crossings overall is on course to be lower this year.

The provisional total for the number who have made the crossing so far in 2026 is 15,242, which is down by 43%, while the number of boats that have successfully crossed is down by 49%.

UK almost certain to register warmest summer on record

The UK is on course to record its warmest summer on record for mean temperature, with only average conditions needed for the remainder of August to surpass the record set only last year.

Provisional Met Office statistics show that the UK's mean temperature for meteorological summer so far (1 June to 10 August) currently stands at 61.66F, which is almost 3F above the 1991-2020 average.

To equal the current UK summer mean temperature record the remainder of Au-

gust would only need to average slightly below the 1991-2020 long-term average for meteorological summer. Any warmer than this would establish a new UK record, with records starting in 1884.

The signal is even stronger across England and Wales.

England was hotter than the rest of the British isles, with an average temperature of 64.7F so far, about three degrees above average.

The UK's record warmest summer on record for average maxi-

mum temperatures, set in the iconic summer of 1976, also looks under threat, with the remainder of August needing to be slightly above the 1991-2020 summer average to exceed this.

'well above average'

Met Office senior scientist Mike Kendon said:

"Another record-breaking summer now looks increasingly likely for the UK, following the second-warmest June, and second-warmest July on record and yet another heatwave imminent. We've seen

temperatures hit 38°C (100.4F) in June, 35°C (95F) in early and late July, and this threshold is looking to be reached again in the next few days. It's worth remembering we also reached 35°C in late May and easily exceeded both the May and June previous all-time temperature records this year. These statistics are a clear reminder - if one were needed - of the stark changes that we are seeing in the UK's climate.

"Looking ahead, forecasts indicate temperatures will remain

well above average through much of the coming week, with another spell of heatwave conditions expected to develop in some areas. While individual hot spells do not determine seasonal records on their own, sustained periods of warmth throughout the summer have contributed to the exceptionally high average temperatures we've seen so far."

As temperatures on the continent surpassed 104F at the peak of the summer's fifth heatwave, the thermometer at Kew

Gardens in west London on Thursday surpassed the previous high of 38C on 28 June, the Met Office said.

An amber extreme weather warning was issued on Thursday across east and south-east England, including London, the Midlands, north-west England, south-west England and parts of Yorkshire and Humber.

In mainland Europe, Bordeaux in France reached 102F while Spain saw a maximum of 108F recorded at Miranda de Ebro, prompting fresh fears of wildfires in the two countries.

energy issues

Elsewhere record-low water flows on the Danube have deprived thermal power plants of cooling water and forced some to reduce output as electricity demand for cooling grows. Romania on Thursday stopped the second of two reactors in its only nuclear power plant, which supplies about a fifth of the country's electricity. The plant's director told Agence France-Presse he did not foresee a restart within the next 10 days.

In Hungary, one of a number of central European countries to break national heat records last week, engineers have resorted to laying stones to boost the water level of the Danube by the Paks nuclear power plant, which avoided a full shutdown in July but is producing only 25% of its usual output, up from 10% earlier this month.

More than 70% of England is now officially in drought.

The newly added areas include parts of the east and south of England.

HOW SWEET IT IS! Uni boffin makes chocolate from entirely British ingredients for first time in a century

■ The Reading 100 Chocolate Bar marks the university's 100th anniversary

A chocolate bar which is good enough to eat has been made using entirely British ingredients for the first time in nearly a century.

It uses cocoa not from Brazil or Bali, but Berkshire.

Created at the University of Reading, it was named the Reading 100 Chocolate Bar to mark the university's 100th anniversary.

It is the first of its kind since 1932, when Rowntree's gifted a six-year-old Princess Elizabeth the only other bar of commercially viable UK-grown chocolate ever made.

cocoa quarantine

Food security master's student Maha Khan created the chocolate bar by harvesting, fermenting and processing the Reading-grown cocoa.

While the UK's chocolate market is worth £10.4bn, it is entirely reli-

ant on imported cocoa.

Maha said she made the bar to highlight the challenges facing the cocoa growing industry.

She said: "It is incredible that we can make 100% British chocolate – but in the context of climate change, pests and diseases, there are estimates that 30 to 40% is lost.

"And we've seen with these heatwaves, climate change, these problems and challenges are only going to get exacerbated."

The cocoa was grown at the University of Reading's International Cocoa Quarantine Centre, a collection of more than 300 types of cocoa plant.

The climate-controlled centre in Berkshire is carefully managed to prevent the spread of pests and diseases between different cocoa-growing regions of the world, while also providing scientists with

the opportunity to study the plants.

Maha said it was important to highlight the research being done at centre "which not many people are aware of".

"It is the primary hub of transfer for 97% of cocoa growing countries," she said.

"So the cocoa is quarantined there for two years, and so from those plants that are growing I decided to make this chocolate bar."

"I harvested the cocoa from the quarantine centre, removed the pulp,

the beans, fermented it, which takes about seven to 10 days, then I laid it out in the sun, because we've had glorious weather, that helped dry it.

"And from then it was just a process of drying, roasting, and at the university facilities I used the lab to winnow, grind, crunch, blend with the milk and sugar."

"It's a lot of work," Maha added.

Prof Carol Wagstaff, director of AgriFood Futures at the University of Reading, said: "The UK

chocolate industry rests on a supply chain that starts thousands of miles away in the tropics of Africa, South America and Asia.

"A resilient global market is crucial to the many smallholder farmers who underpin the industry and find themselves farming in some of the regions most exposed to risks from climate change, as well as to chocolate makers and chocolate lovers in the UK.

Ace in the hole: amateur golfer nails 411 yard hole-in-one

An amateur golfer says he couldn't stop shaking after hitting a hole in one from a mighty 411 yards.

Matthew Vigers achieved the feat during a league match at the Great Barr Golf Club in the West Midlands at the weekend, and his drive is has set a new record for Britain's longest hole-in-one.

The 32-year-old, who plays off a handicap of +1, hit his driver off the tee but could not find his shot when he reached the green.

After a few minutes searching he decided to have a quick look in the hole - and saw his ball.

Matt said: "It was really surreal. I just froze to start with. The lads

ran over and we all belly slammed and high fived.

"It was a moment I will never forget for sure. It was brilliant. I think we were all shocked. Typically, the ball wouldn't go that far.

"It is just unheard of to get a hole-in-one really let alone on a par-four."

Matt says his average drive is about 300 yards but wind and hard ground helped him stretch out to 411 yards.

Matt's effort beat the previous effort by three yards - that belonged to Peter Vickerman, who aced the 408-yard par-4 seventh hole at Littlestone Golf Club in Kent in 2014.

Matt, from Droitwich, Worcs., only returned to

regular golf in February after eight years living abroad.

His hole-in-one - also known as an albatross - came in a scratch match at the Walsall golf club, playing with a friend against two others.

The four-ball found three balls when they got to the green of the hole, named Twin Oaks - but Matt's was missing.

They searched the bushes, around the fairway and over the back of the green but it was nowhere to be seen.

On a whim, Matt decided to check the hole and says his friends gave him strange looks for even checking.

He said: "At that point I looked a bit silly,

so I thought I might as well check the hole — and there it was, nestled in the bottom.

"I had to take two or three looks. I couldn't believe it. They didn't

From Wales with love: rare turtle returned home to Gulf of Mexico

A critically endangered turtle has completed a 5,000-mile journey home to the Gulf of Mexico more than two and a half years after being washed up in North Wales.

In that time, Rossi, as the Kemp's Ridley sea turtle has been named, has been nursed back to health by local volunteers.

But saving Rossi's life was only half the battle, and a complex logistical operation early this week saw him safely delivered back to his natural habitat.

Tuesday morning saw an early morning helicopter flight from Anglesey to London, the first stage of Rossi's journey home. From there he was loaded into an insulated crate and smothered in KY Jelly to prevent dehydration for a ten hour flight to wildlife officials in Houston, Texas.

At press time Rossi was safely in the hands of officials near Padre Island in Texas, where he is scheduled to be released on August 18 after further health checks and being fitted with a satellite tracker.

"International trade in food can be a good thing, providing economic stability for communities whilst using natural energy resources for production, and we need to invest in research to keep threats at bay."

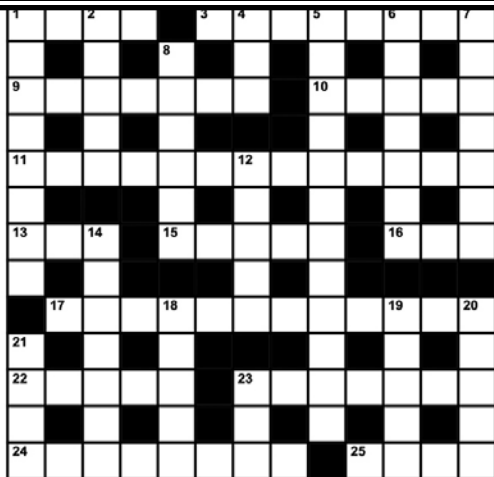

Safely across The Channel: Bayeux Tapestry 'in wonderful state' in British Museum

■ Famed historical artifact goes on public display for one year in September

The Bayeux Tapestry, which is now housed in the British Museum, is in a "wonderful state", the French Culture minister said this week, having viewed it on site.

The early medieval masterpiece, which tells the story of the events leading up to 1066 and the Norman Conquest, is being checked over by French and British conservators ahead of going on display in September.

There has been alarm from some, particularly in France, that the tapestry was too precious to move from there to the UK.

French culture minister Catherine Pégard said: "We can see that all the precautions have been taken... I believe that it will reassure all the sceptics".

She was thronged by French and British media as she viewed

the 11th Century embroidery, along with the chair of the British Museum, the former Chancellor George Osborne.

Osborne praised the "French and British experts" who transported the tapestry from Bayeux Museum in Normandy to London.

'amazing job'

"It is the first time the tapestry has been seen in England for 1,000 years.

"They have done an amazing job in transporting this very very delicate item across the Channel and unfurling it here for us," Osborne said.

"It's our responsibility, this generation's responsibility, to do what previous generations have done, which is look after this tapestry so it's there for all time".

Professor Michael Lewis, curator of the museum's Bayeux Tap-

estry exhibition, first suggested back in 2013 it should come to Britain after he realized the Bayeux museum would need to close for renovation.

unbearable strain

He called the collaboration between the French and British teams "remarkable".

Much of the stitched masterpiece, which is actually coloured yarn embroidered on linen rather than a woven tapestry, is currently covered up in giant polyester sheeting, to protect it from light damage.

Over 18 painstaking hours this week, teams of French and British conservators and British Museum staff unfurled the 70-metre long artwork from the folding stand where it had been concertinaed, surrounded by protective mattress-type padding.

At its home in the Bayeux Museum, the 230ft-long artwork was hung, rather than laid flat, in a long display case that included a right-angled corner. In 2024, the Science and Mechanics in Conservation of Her-

itage engineering team began devising a way to safely remove it, with the museum set to close for refurbishment. The aim was to "fold" the artwork without actually folding it, as doing so would have placed unbearable strain on the tapestry at each fold.

After Emmanuel Ma-

cron, the French president, confirmed plans to loan the tapestry to the British Museum, their research was put into practice. Workers slowly bent the tapestry back on itself around special tubes every two metres, in a zig-zag fashion. Between each of these deliberately curv-

ing "folds" was placed a fabric screen "like a pillow". The outer surface of each screen was made from Tyvek, a frictionless material.

The exhibition of the Bayeux Tapestry will open on 10 September and cost up to £33 for over-16s, the British Museum has confirmed.

UEFA Super Cup: Parisiens lift trophy again but young star Madjo shines for Emery's men

Paris St-Germain made it back-to-back Uefa Super Cup titles after a narrow 2-1 victory over spirited Aston Villa Wednesday night.

Desire Doue's 62nd-minute winner - after a video assistant referee (VAR) check for offside - sealed the success for the Champions League holders in Salzburg.

Khvicha Kvaratskhelia thumped in a delightful 20th-minute opener for PSG, before Villa's Brian Madjo announced himself in fine style with a 45th-minute leveller.

The 17-year-old striker became the youngest scorer in the Super Cup when he struck on his debut at the Red Bull Arena.

Madjo, an England Under-17 international, had already missed two fine chances - shooting wide

and heading over - before volleying in John McGinn's cross at the back post just before half-time.

It marked a perfect ending to an eight-month battle to play, with Villa banned from registering him by Fifa, after he joined from Metz for £10m in January.

Madjo was a constant physical threat to the PSG defence, but his goal was not enough to stop the French side retain the trophy they won for the first time last year by beating Tottenham on penalties.

Villa, playing in the Super Cup after winning the Europa League in May, had their chances, forcing PSG keeper Matvey Safonov into solid saves.

But defeat meant boss Unai Emery has now lost all four of his finals in the competition after also

missing out with previous clubs Sevilla and Villarreal.

Somali official Omar Artan made history as the first non-European referee to take charge of the contest, having been denied entry into the United States for this summer's World Cup.

Pre-game, captain McGinn promised Villa fans they could still expect "as much as possible" this season despite the high-profile exits of Morgan Rogers and Youri Tielemans.

A battling performance in Austria backed those words up as, even in this defeat by PSG, Villa scared the European champions for a second time in 18 months, following their 5-4 Champions League last-eight defeat in 2025.

Owners Fenway Sports Group (FSG) confirmed last month that the group had "expressed interest in making a strategic minority investment in Liverpool Football Club".

Bhatia is the son-in-law of Indian billionaire businessman Lakshmi Mittal

and had been a director and co-owner of Queens Park Rangers for 18 years before relinquishing his stake in the club last month.

American businessman Bezos, founder of e-commerce giant Amazon, is the fourth-richest person
