ROYAL HOMECOMING!

■ In stunning U-turn, Harry and Meghan announce they will return to UK within a month

The Duke and Duchess of Sussex dropped another bombshell this week - with the news they are planning to move back to the UK.

Reports from multiple sources suggest Prince Harry and Meghan intend to relocate from the US later this month to a private, non-royal residence outside London.

The couple's children, Prince Archie, seven, and Princess Lilibet, five, are enrolled to start at a British school in September.

King Charles was told of the move on Sunday.

There are no current plans for either Prince Harry or Meghan to resume their roles as working Royals. The Sussexes and their children visited the King at his Highgrove home in July this year, but it is understood the move was not discussed.

Royal sources suggested the King was unaware of the move before last weekend but he welcomes the opportunity to see more of the Sussex family in a private and personal capacity. No change is expected to the official status of Prince Harry and Meghan and they will remain as private individuals.

relations strained

The Sussexes left the UK and stepped back from their royal duties in early 2020, before settling in California in March that year. Family relations had been strained since, with July's visit to the King and Queen Camilla being a key development in their relationship.

The Palace described the meeting at the King's private home in Gloucestershire as a "private family occasion". It was the first time the King had seen his grandchildren in person in more than four years.

security beef

Prince Harry and Meghan had not been in the UK together since 2022, when they attended the funeral of Queen Elizabeth II. Security for the couple has long been a point of tension, with the duke's July visit being reconsidered because his request for police protection was rejected.

Last year, Prince Harry lost a legal challenge over the levels of security he and his family are entitled to while in the UK. The duke had sought to overturn a decision that had downgraded his security after he stopped being a working royal and moved to the US with the duchess. It is unclear what provisions will be made for their security once they

return to the UK.

Royal expert Robert Hardman said it is likely that some of the security issues "have been resolved" but details - or who is going to foot the bill - are still unknown. "Surprise is an understatement," he told the BBC's Radio 4 Today programme of the move, adding that the Sussexes "have always been very good at delivering surprises".

'missing the UK'

Hardman said the children being enrolled in school is significant and that it signals that they are going to be raised as "British rather than American".

After the announcement of the Sussex-

es' intended return, a Home Office spokesperson said decisions on the security of royals were taken by the Executive Committee for the Protection of Royalty and Public Figures (Ravec), and the UK government's protective security system was "rigorous and proportionate".

Prince Harry has previously said that worries about safety have prevented him from coming to the UK and bringing his wife and children.

During his July visit the duke promoted his Invictus Games for injured service men and women, which will be hosted in Birmingham next year.

David Wiseman, chief programmes and strategy officer at Invictus Games Foundation, said that there had been a suggestion of the move when he saw Harry in July.

"He did mention to me actually that he was missing the UK, so there was a bit of a hint that he might be coming across, but I took that as a bit of sentimentality," he told the Today program.

He said the move was "excellent news".

"I will be really pleased to have him back in the country. Moving is stressful for anyone so I hope it all goes well and the children settle well at school," he added.

REFORM: Unemployed must work for the council or face losing their benefits

■ Robert Jenrick said the long-term unemployed would have to scrub high streets, carrying out minor repairs and 'beautify neglected places'

Benefits claimants will be made to clean up their local communities and do charity work or face being stripped of their benefits under Reform UK plans.

Robert Jenrick, the party's Treasury spokesperson, said the long-term unemployed would have to work 20 hours a week scrubbing high streets, carrying out minor repairs and "beautifying neglected places".

The scheme would be run by local councils and those who do not accept work placements will have their funding cut.

The policy forms part of Reform's "welfare to

work" scheme, which also includes stopping foreign nationals claiming almost any benefits in a bid to cut £50 billion from Britain's welfare bill.

'unfair'

Personal independence payments (Pip), paid to some disabled people, and the health element of Universal Credit for working-age adults would be abolished.

Mr Jenrick told an event in central London on Monday "those taking everyone else for mugs, under a Reform government, it's going to stop".

He said: "They'll work to clean up high streets

and parks, to beautify neglected places, to carry out minor repairs, to staff libraries and community centres to perform many other tasks from the list that we've published today.

"We'll also embrace local charities and community groups and ask them to help us and take part. If claimants refuse to participate or fail to show up, they'll face penalties.

"Let me speak very plainly. If people who are capable of work refuse, then they'll get nothing. That's fair."

Since the pandemic there has been a significant rise in the number of people claiming bene-

fits in the capital. There are some 201,000 more working-age Londoners relying on unemployment benefits than in 2019, bringing the total to 349,500 people across the city, according to research by Trust for London.

The ban on foreign nationals claiming benefits would include Europe-

an Union (EU) nationals with settled status in the UK, Mr Jenrick said.

This would require renegotiating the UK's Brexit deal with the EU and could potentially result in British expatriates losing equivalent rights.

"The British taxpayer is acting as the welfare state for the world. That is unfair," Mr Jenrick

said.

But Labour insisted the "vast majority" of migrants have no access to benefits.

Pro-EU campaign group Best for Britain also argued that denying benefits to those with indefinite leave to remain would tear up the UK's EU withdrawal agreement.

PM 'not embarrassed' by text exchange with hoaxer posing as Trump chief of staff

■ I handled it in the right way, insists Burnham

Andy Burnham says he is not embarrassed that he exchanged messages with a person posing as US President Donald Trump's chief of staff.

The prime minister

added all politicians face "these challenges" but insisted he did "everything right" in how he handled the security breach.

News website Politico first reported that Burn-

ham communicated with a person claiming to be Susie Wiles. Burnham said there was a "minimal exchange of information of zero consequence".



BURNHAM: "All politicians are receiving these pressures and these challenges,"

Liberal Democrat MP James MacCleary has written to Parliament's Intelligence and Security Committee (ISC) to ask them to consider investigating what he called an "egregious security breach".

It is understood the communication between Burnham and the person posing as Wiles was in the form of messages and there was no conversation between the two.

Asked if he was embar-

assed about the incident, Burnham told broadcasters: "No, I am not because there was a minimal exchange, nothing of consequence and quickly I realized that this needed to be reported and I did so.

"So I handled it in the right way. All politicians are receiving these pressures and these challenges, but I did everything right."

Pressed on what action is being taken to find out

who was behind the incident and to improve systems, Burnham said the "correct action" had been taken both in the UK and the US, without providing further details.

On Monday, Downing Street did not say when the messages were exchanged, or how many there were, nor whether they were over WhatsApp or another system.

said on Monday that the latest incident "had nothing to do" with Wiles' phone being hacked.

Wiles, a key Trump ally, told people at the time that her phone had been hacked after an impersonator - or impersonators - used her contacts file to message other top US officials.

Burnham is not the first high-profile UK political figure to have come into contact with an imposter.

In 2024, the Foreign Office confirmed then-foreign secretary Lord Cameron had been the victim of a hoax call in which someone pretended to be former Ukrainian President Petro Poroshenko.

Former Prime Minister Lord Cameron also exchanged some text messages with the impersonator pretending to be Poroshenko, who was president of Ukraine between 2014 and 2019.

The Foreign Office said it released details of the exchange publicly over fears it could be "manipulated".

"I want to speak on Diana's behalf and do so in an openly positive way," - Earl Spencer

Earl Spencer is to publish a new book telling the life story of his sister, Diana, Princess of Wales, from his perspective.

Swan Song: Diana, My Sister is due to be released in the UK next month, nearly 30 years after she died.

"I want to speak on Diana's behalf and do so in an openly positive way," Earl Spencer said of his reasons for writing the book.

He added that he hoped it would enable people to understand who she really was: "A one-off, dynamic character, full of love, charisma and self-doubt, who gave life a hell of a go, and left the world a far better place, despite exiting the stage while still so young."

Princess Diana, who died aged 36 following a car crash in Paris in 1997, would have turned 65 on 1 July this year.

Her sons Prince William and Prince Harry were aged 15 and 12 re-

spectively at the time of her death.

In a statement released on Tuesday to mark the new book, Earl Spencer said he had been "inundated yet again" with requests for interviews about his sister, with the 30th anniversary of her death approaching.

'untruths'

"This has convinced me to write down my own thoughts and memories, once and for all, rather than having the discomfort of again reading the opinions of others, many of which are based on untruths that have become accepted over time," he said.

"The aim of this book is to tell the truth about Diana from her brother's perspective, just as I attempted to do when speaking at her funeral," he added, referring to the eulogy he delivered in Westminster Abbey in September 1997.

He said he hoped the book would be of interest to those who "still

cherish" Diana's memory from when she was alive.

'selfless humanity'

"And I would be delighted if those too young to remember her in her heyday feel - after reading this - that they 'get' who she really was," he continued.

In his eulogy, Earl Spencer described Princess Diana the "very essence of compassion, of duty, of style, of beauty",

adding: "All over the world she was a symbol of selfless humanity... a standard bearer for the rights of the truly downtrodden."

He also used the speech to criticise the media, calling her the "most hunted person of the modern age" and pledged to protect Prince William and Prince Harry and prevent them suffering a similar fate.

The book is expected to be out on 22 Septem-

ber in the UK, and will be published by Penguin Michael Joseph, a division of Penguin Random House.

Daniel Bunyard, publishing director at Penguin Random House UK, said: "While these pages contain many revelations that will draw considerable attention, readers will find, for the first time, but also for all time, a fitting tribute to the beloved woman who was Princess Diana."

Angela Rayner visits 'horrendous' aftermath of West Midlands wildfire

■ 19 homes were destroyed in the fire, just one of 1100 drought-related blazes in England and Wales this year

The housing secretary Angela Rayner has described as "absolutely horrendous" the burnt-out remains of homes gutted by fire last week, following her visit to the West Midlands on Monday.

She walked among the shells of houses on Quarry Park Road in Stourbridge, Dudley, where flames took hold on Thursday afternoon, destroying 19 homes across five streets in total.

Residents who fled their properties to escape the flames begun to return home on Sunday.

"The community have been exceptional, looking out for each other,"

Rayner said, as more human stories of personal loss and heartbreak emerged.

"The emergency services, the police, the fire, the ambulance service, the local authority, the local MP and the community have come together to really support each other," the housing secretary said.

"But it is devastating to see the level of damage and the emotional turmoil of losing everything, and that's what these families have gone through."

Simon Tuhill, chief fire officer for West Midlands Fire Service, said the blaze, which spread

over about 500 acres, would take some time to investigate because of its size.

"Fires across the West Midlands have been occurring over the past month or so due to the dry conditions, and most of those fires can be attributed to human causes," he said.

Rayner said there was a "pattern" with wildfires and climate.

"We have introduced £100 million more equipment and we've got specialist fire crews now that look at wildfires, and they have been pushed by what's happened," she said.

"We'll be making sure

that we come together and we design a fire service that is able to respond to the challenges that we face.

"But it's clear that these challenges are becoming more frequent."

Eleven year-old Thea spotted the Stourbridge fire in the fields near her home. Her mum Sarah told reporters: "It was

horrendous, absolutely horrendous to see the fire coming in from the side and there were other fires sparking up, because it was windy that day.

"The embers were carried and started fires in different areas."

The family's home escaped damage, but Sarah said it was "heart-break-

ing" to see the impact it had on others.

"I feel so sorry for everyone who has lost their homes," she said.

Three fundraising appeals in Stourbridge have raised more than £20,000 for those affected, something which Sarah said made her "proud to be a Stour-

Don't go drilling, musos implore Burnham

■ As PM ponders resuming North Sea drilling, more than 200 entertainers sign petition urging him to find alternatives

ONE OF the biggest decisions facing Andy Burnham early in his tenure at Number 10 is the thorny choice of whether or not to give the go ahead for new oil drilling in the North Sea.

The Prime Minister must balance the competing needs of the environment and consumers, who are facing ever-more expensive fuel bills and rising uncertainty about the supplies from the Middle East as Donald Trump's war with Iran drags on with no end in sight.

Burnham is keenly aware that Reform UK and the Conservatives are making political hay out of Britain's dependency on foreign imports, while he is keen to avoid alienating core Labour voters who consider the environment the number one issue facing not just the UK, but the planet.

But one group of prominent Britons are not shy about making their feelings known: musicians.

This week Thom Yorke, Romy and Brian Eno were among 200 prominent entertainers who signed a petition urging the PM to reject new North Sea drilling.

Robert Smith, Olly Alexander and Paris Paloma also among signatories to letter saying the proposed exploitation of Rosebank and Jackdaw fields defies climate reality.

untapped oilfield

The letter called on the prime minister to reject any new drilling, warning that the project would fail to lower energy bills or provide energy security as most of the oil was likely to be exported.

Other performers who put their name to the missive include Radiohead's Ed O'Brien and Philip Selway; Bobby Gillespie of Primal Scream; Alexis Taylor of Hot Chip; Anoushka Shankar, Kevin Rowland, Anna Calvi, Jacob Collier, David Gray and the electronic duo Bicep.

The government's

consultation on the project, which lies about 80 miles north-west of the Shetland Islands, closed on Monday. Ministers will now decide on its future as well as that of the Jackdaw gasfield off Aberdeen, whose consultation concluded a week ago.

Adura, the company behind both projects, has said the projects would result in £10.8bn in investment and support 3,500 jobs at the peak of construction, with 880 employees over its production lifetime.

However, environmental activists argue that extracting fossil fuels from the UK's largest remaining untapped oilfield will accelerate climate chaos. Estimates suggest Rosebank could produce more than 250m tonnes of CO2 over its lifetime, equivalent to 70% of the UK's annual emissions.

The artists wrote in their letter: "The climate crisis is no longer something we fear for future generations; it is

shaping our lives today. Heatwaves are disrupting schools, workplaces, hospitals, transport networks, festivals and live events."

Eno, who is a co-founder of the campaign group EarthPercent, said Burnham had previously stood with

artists and campaigners calling for an end to fossil fuel expansion.

"So he has a choice to make," Eno said. "He can stand with the fossil fuel industry and approve Rosebank, or he can stand with the people who will live with the consequences of that de-

cision.

"We are already seeing what a hotter world looks like, with record heat and devastating wildfires across Britain and Europe. At this point, continuing to expand fossil fuel production isn't pragmatism, it's a failure to face reality."

Amid rising Russian threats, Burnham doubles down on British support

■ Moscow warns UK will 'pay' after UK-made drones strike Russia

"We are providing support so that Ukraine can defend itself," UK Prime Minister Andy Burnham said on Tuesday.

British Prime Minister Andy Burnham has said the United Kingdom will continue to offer its full and unwavering support to Ukraine despite Russian threats of "consequences."

His remarks came after the Russian Embassy in London on Monday warned Westminster would "pay" after UK-made drones were report-

edly used in Ukrainian strikes on Russian soil.

The embassy accused the UK of "deliberately opting for an escalation of the Ukraine crisis" and of "acting as an accomplice and co-perpetrator" in Ukrainian attacks.

Responding to the embassy's statement during a trip to Wolverhampton on Tuesday, Burnham said: "This is the UK doing what it has long said it would do, which is to support Ukraine 100% against this illegal war led by Vladimir Putin."

"We are providing support so that Ukraine can defend itself," he continued, adding that the UK was not a "fair-weather" friend and that it would "be there in Ukraine's hour of need."

Ukraine has been ramping up what it calls its "long-range sanctions" on Russia in recent months, launching deep strikes against energy infrastructure and logistics facilities as it seeks to cripple Moscow's economy and grind down Russian President Vladimir

Putin's war machine.

Over the weekend, Ukrainian President Volodymyr Zelenskyy said Ukrainian forces struck an oil facility in Ust-Luga, close to the Estonian border, as well as

Russia's Progress rocket and space centre, a facility involved in the manufacturing and operation of space launch vehicles and rockets, as part of this strategy.

The General Staff of the

Armed Forces of Ukraine has said that launch vehicles produced at the Progress centre are used to "place Russian military, reconnaissance, and communications spacecraft into orbit."

Harry's Return: as hopes for royal reconciliation rise, thorny issue of security remains

The Duke and Duchess of Sussex's surprise announcement that they will return to the UK this month has reignited questions over the level of their publicly funded security in Britain.

Prince Harry and Meghan plan to relocate from the US to a private, non-royal residence outside London, with their children, Prince Archie, seven, and Princess Lilibet, five, enrolled to start at school in September. Their UK security was downgraded after they stopped being working royals in 2020 and moved to the US, where they have paid for their own protection.

The Royal and VIP Executive Committee (Ravec), an independent body overseen by the Home Office, will now have to make a new decision as previous arrangements were based on the

Sussexes not living in the UK permanently.

Ravec had concluded that because Prince Harry was going to be an infrequent visitor to the UK, his security needs would be assessed on a case-by-case basis.

"private matter"

Earlier on Thursday, Prime Minister Andy Burnham said the couple's security arrangements were a "private matter".

Burnham, who does not decide about security for the Royal Family, added: "It's a matter for Harry and for Meghan, and we wish them well in the move that they are making."

The Home Office has said the UK's protective security system was rigorous and proportionate, but "it is our long-standing policy not to provide detailed information on those arrangements, as

doing so could compromise their integrity and affect individuals' security".

Security for the couple has long been a point of tension, with Prince Harry losing a legal challenge last year over how much he and his family were entitled to when visiting the UK.

The Sussexes left the UK and stepped back from their royal duties in early 2020, before they settled in California, where they have employed a private security team to protect them.

limited security

Depending on Ravec's reassessment of the couple's new permanent circumstances in the UK, the pair could now get the level of taxpayer-funded security they always wanted.

But there is no suggestion the couple are going to become full-time

working royals again, so they may not qualify for the levels of security Prince Harry had before

he and his wife left the UK six years ago.

Other non-working royals get only limited

security, and if that happens to Prince Harry, it could be the source of further tensions.

Britain should join EU migration pact to reduce small boat crossings, claims Lib-Dem leader

The UK should join the EU's new Migration and Asylum Pact as a way of tackling small boat crossings across the Channel, Liberal Democrat leader Sir Ed Davey has said.

The agreement, which came into force in June, aims to speed up the asylum process, increase the number of irregular migrants returned to their home countries and spread responsibility for asylum seekers across the EU.

Sir Ed argues that signing up to the pact would allow the UK to return asylum seekers to the

first EU country they entered, thereby "destroying the business model" of the gangs behind the crossings.

Labour said the government's efforts to work with European countries to tackle small boat crossings were "bearing fruit".

A Labour spokesperson said more than 47,000 crossings had been prevented in two years and 70,000 people with no right to be in the UK had been removed.

"There's more to do and that will only happen by working in collaboration with the EU," the spokesperson added.

So far this year, more than 14,000 people have arrived in the UK by small boat - a fall of 43% compared to the previous year.

The EU's new pact, which was nearly 10 years in the making, introduces mandatory screening and an updated database to track those arriving in the bloc.

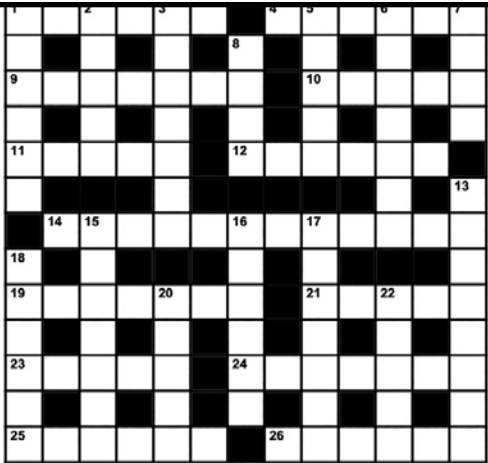
Under the rules, EU nations must take in migrants from those member states that see the highest number of arrivals - such as Italy and Greece - or instead provide extra funding

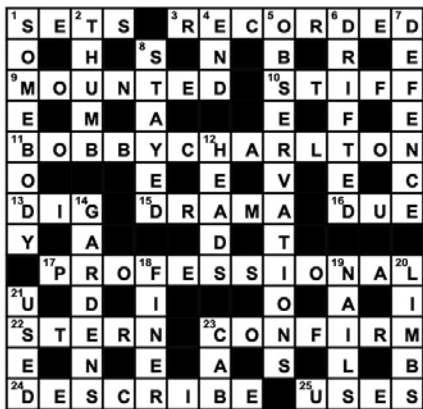

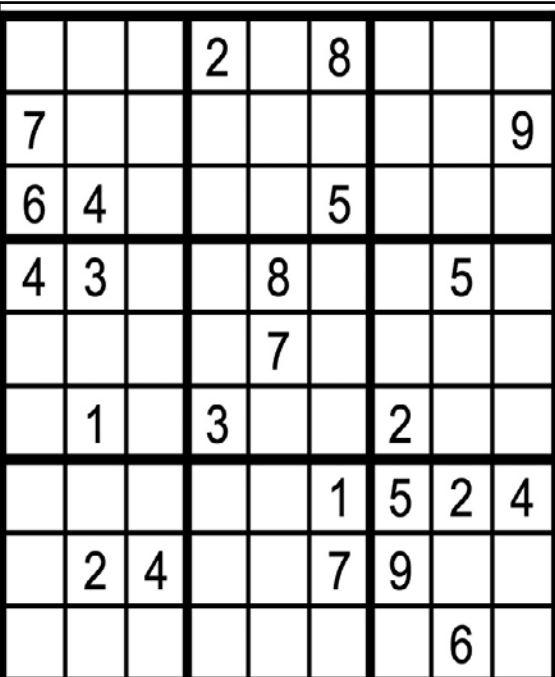

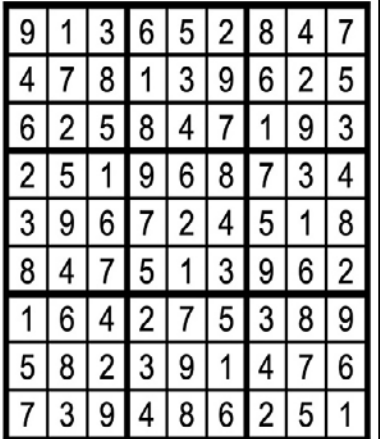

Saying farewell to Bonnie

As Wales mourns a homegrown superstar, manager pays tribute: "She was always a star but never a diva"

SWANSEA, Wales: Fans crowded outside a Welsh church Monday where family and friends remembered the husky-voiced singer Bonnie Tyler as a star loved worldwide.

Tyler's "If I Sing You A Love Song" played as her rose-covered coffin was carried into Swansea Minster for the invite-only funeral that was projected on a screen outside. Her "It's a Heartache" played as the coffin was placed in front of the altar.

'very gratified'

"Bonnie was always a star but never a diva," her manager, Matthew Davis, said in one of several tributes.

"She never forgot her roots or where she came from. She would have been amazed and very gratified at the massive outpouring of love from all over the world that has occurred since her sudden and unexpected passing."

The Grammy-nomi-

nated pop star, beloved for her 1983 chart-topping power ballad "Total Eclipse of the Heart," died last month in a hospital in Portugal at 75. She had been hospitalized in May in Faro, where she had a home, for emergency intestinal surgery.

'no fake stuff'

The funeral was held less than a week after her signature song served as the soundtrack at celebrations marking a total eclipse that darkened skies across parts of Europe.

Crowds lined the streets Saturday in her seaside Welsh village of Mumbles as a hearse carried her coffin, draped in a Welsh flag, home.

Kathleen Davies, who joined the crowd outside the church, said she was starstruck when she first saw Tyler but later came to learn she was down to earth.

"She's Welsh through and through," Davies said. "Everything about

her, she's natural, there's no fake stuff. When you see her on the interviews, she's just who she is."

Tyler was born Gaynor Hopkins, a coal miner's daughter in public housing with an outside toilet in Skewen, Wales, about 7 miles (11 kilometers) outside Swansea. She grew up with three sisters and two brothers.

Canon Justin Davies said in a eulogy written by her family that she first performed in a contest at a rugby club in the late 1960s, singing "Those Were The Days," made famous by Mary Hopkin.

"She came in second and won just one pound,

but was hooked," Davies said. "The rest, as they say, was history."

Tyler went on to earn three Grammy nods and in 2013 represented Britain at the Eurovision Song Contest, where she came in 19th. She was honored as a Member

of the Order of the British Empire in 2022 for her services to music by Queen Elizabeth II, thanks mainly to "Total Eclipse of the Heart."

The ballad shot to the top of the charts in Britain and the United States and has had more than 1

billion streams, boosted by real eclipses in 2017, 2024 and most recently during last week's solar eclipse.

She was also known for "Holding Out For a Hero," from the soundtrack of the film "Footloose."

or resources. Joining the agreement would require the UK to accept some asylum seekers from the EU. However, the Liberal Democrats argue numbers would be lower than those currently coming to the UK by small boat

and that they would be screened before entering the country.

The party says the scheme would save British taxpayers money, with the cost of participating - around £100m a year - amounting to a fraction of the £5bn spent on a "failing asylum system".

Sir Ed said: "We have

a plan that would finally end the small boats crisis: a pact with every EU country that will allow us to return people who come over the Channel, taking away the major pull factor and destroying the business model of the criminal gangs."

Like the Liberal Democrats, some Labour pol-

iticians have made the argument that that Brexit led to an increase in small boat crossings.

Reform UK has previously dismissed such claims as "complete misinformation", arguing that EU membership "did nothing to make it easier to return asylum seekers".

Premier League champions Arsenal produced a statement win over rivals Manchester City on Sunday to lift the 2026 Community Shield in Cardiff.

Mikel Arteta's side took the lead after just 23 seconds when Myles Lewis-Skelly slipped in Riccardo Calafiori, who slotted an effort past Manchester City goalkeeper Gianluigi Donnarumma.

Arsenal then doubled their lead in the 28th minute through Kai Havertz's downward header after summer signing Christos Tzolis had nodded Martin Odegaard's cross back across goal.

Three minutes into the second half, Tzolis found Odegaard in the City box and the Norwegian forced Donnarumma to the floor with an excellent fake shot before passing the ball into the opposite corner.

The Gunners' victory over the FA Cup holders gave them their second trophy in four months and their 18th Community Shield title overall.

The match was played at Principality Stadium while Wembley hosts Canadian singer The Weeknd's 'After Hours til Dawn' tour.

With two assists, Greek forward Tzolis starred on the left side of Arsenal's attack.

The 24-year-old was directly involved in a league-high 40 goals for Club Brugge last season, scoring 17 times and providing 23 assists

Tzolis, who cost Arsenal £34m this summer, is back in England having made 30 appearances for Norwich between 2021 and 2024.

New team-mate Bruno Guimaraes also started Arsenal's win but had a quieter game at the base of the Gunners' midfield.

Lewis-Skelly was another player who impressed by setting up Arsenal's first amid transfer links to Chelsea and Manchester United.

Odegaard had an effort cleared off the line by Josko Gvardiol just before half-time, while second-half substitute Bukayo Saka blasted an effort over from a good position late on.

Manchester City were playing their first competitive game without Pep Guardiola as their manager in over 10 years, since Manuel Pellegrini oversaw a 1-1 draw with

Swansea in May, 2016.

New manager Enzo Maresca gave £116m signing Elliot Anderson his competitive City debut and started Phil Foden, who had been out of favour under Guardiola last season.

Jack Grealish also came on in the second half for his first City appearance in 15 months.

City were unable to match Arsenal's physicality but did test goalkeeper David Raya numerous times, with the Spaniard doing well to keep out low, driven shots from Foden and Antoine Semenyo.

Their defeat was the biggest in the Community Shield since 2014, when Arsene Wenger's Arsenal also beat Pellegrini's City 3-0.

CRICKET: Brook in full flow as England take control

Four balls later, Root was left angry with himself by playing across the line to seamer Khuram Shahzad to be lbw for 66.

Konsa seals Gunners switch

■ **Champions not resting on their laurels as they take summer spending past £150m**

Aston Villa defender Ezri Konsa **underwent a medical with Arsenal** on Thursday before a £50m-plus move to the Emirates Stadium.

Arsenal agreed a deal with Aston Villa for the England international on Wednesday following weeks of negotiations.

The centre-back has now been given permission to travel to north London.

Arsenal reopened talks with Villa over a deal for Konsa last week but still fell short of reaching an agreement. The Gunners then appeared to pivot towards Bayer Leverkusen's Jar-

ell Quansah before successfully refocusing their efforts on Konsa.

The 28-year-old, who joined the Villans in July 2019, has made 286 appearances over the past seven seasons.

Konsa featured 48 times last term in all competitions, scoring two goals and contributing one assist, as Unai Emery's side lifted the Europa League and finished fourth in the Premier League to secure Champions League football for 2026-27.

Konsa has not featured at all during Aston Villa's preseason, including the 21 defeat to Paris

StGermain in the Uefa Super Cup, after Emery gave him four weeks off following the World Cup.

He played in every game of England's World Cup run as the Three Lions finished third.

Speaking after the final warmup match against Borussia Monchengladbach, Emery explained the absence of Konsa, Emiliano Martinez and Ollie Watkins, saying: "They are joining us after this match."

Usually, winning the Europa League and qualifying for the Champions League would leave a club in a position

of strength.

However, Villa have been picked apart this summer to become a victim of the system they have been vocal against.

Ensuring they comply with Uefa and the Premier League's financial

rules led them to sell Morgan Rogers to Chelsea for a record £117m.

Even then, Yuri Tielemans - who like Rogers scored in May's Europa League final win over Freiburg - was also sold to Manchester United.

Villa wanted to alter their left-back profile so Lucas Digne was allowed to join Paris St-Germain, with Atletico Madrid's Matteo Ruggeri replacing him.

Scottish passion was the key, says new boss Pocognoli

New Scotland boss Sebastien Pocognoli says the passionate nature of Scottish football was a key factor in his taking the job.

Pocognoli, 39, was confirmed as Steve Clarke's successor on Sunday and introduced himself to the media on Monday.

Clarke ended his seven-year reign earlier this summer after Scotland failed to progress from the World Cup group stage after a victory over Haiti was followed by defeats by Morocco and Brazil.

Former Belgium defender Pocognoli left Monaco at the end of last season and previously led Union Saint-Gilloise to their first league title in 90 years in 2024-25.

He becomes only the second foreign boss of the Scotland men's team, after the German Berti Vogts, and believes he has what it takes to build on Clarke's "strong foun-

"I'm very proud to be here," Pocognoli said, flanked by Scottish Football Association (SFA) chiefs Ian Maxwell and Craig Mulholland at his introduction.

very important. I never go to a challenge where I can't feel the connection.

"Scotland is a passionate country and I think also, regarding the strong foundation that Steve Clarke and his staff laid, that I can use this heritage to put the next accent on the style of play while also developing players for the future.
