# THEY'RE BACK!

■ With no fanfare - and zero security - Harry and Meghan touch down in Birmingham  
■ Chickens left behind in Montecito as controversial couple fly the coop

**The Duke and Duchess of Sussex have arrived back in the UK.**

Prince Harry, Meghan and their children Archie and Lilibet are flew into the country privately from California, and landed in Birmingham shortly before midday on Wednesday.

A spokesman for the Duke and Duchess of Sussex said "this is not something we would comment on".

There did not appear to be a police presence as Harry and his family left the airport.

Last week, it was reported that the couple would be relocating to the UK in August. They will not return to official duties but will live in Britain as non-working royals.

## Dogs, no chickens

It is thought the family will base themselves at a private property outside of London in the Cotswolds area.

Archie and Lilibet have been enrolled in school and the new term is due to start next week.

Though not confirming the family's arrival in the UK, a spokesman for the Sussexes did say their

chickens were staying in California, but they were bringing their dogs Mia and Pula with them.

The chickens, which the couple rescued, have regularly featured on Meghan's Instagram account and also appeared in her Netflix program.

The Sussexes left the UK and stepped back from their royal duties in early 2020, before settling in California in March that year.

King Charles was told of the move earlier this month. The family visited the King at his Highgrove home in July this year, but it is understood the move was not discussed.

Before that visit, Prince Harry and Meghan had not been in the UK together since they attended the funeral of Queen Elizabeth II in 2022.

The Prince and Princess of Wales have also been informed of their plans.

The Sussexes' security in the UK has been the subject of debate since the news of their return broke.

Last year, Prince Harry

lost a legal challenge over the levels of security he and his family are entitled to while in the country.

## Legal costs

The duke had sought to overturn a decision that had downgraded his security after he stopped being a working royal and moved to the US.

It is unclear what provisions will be made for their security in the UK and who will pay for it.

After the announcement of the Sussexes' intended return, a Home Office spokesperson said decisions on the security of royals were taken by the Executive Committee for the Protection of Royalty and Public Figures (Ravec), and the UK government's protective security system was "rigorous and proportionate".

Prince Harry has previously said that worries about safety have prevented him from coming to the UK and bringing his wife and children.

Last month, the duke and six other public figures lost their High Court privacy case against the

publisher of the Daily Mail and Mail. The face paying up to £34.5m to Associated Newspapers in legal costs.

Meanwhile, their potential to earn a living took a blow when it emerged a potential role for the Duchess of Sussex in the Netflix series The Gentlemen has reportedly been axed following a backlash.

Meghan, 45, was said to have been in talks to join the third season of the Guy Ritchie comedy-drama but according to multiple reports, US actress's casting has been withdrawn due to the furious backlash in Britain. Former Vanity Fair editor Tina Brown broke the story on her influential Substack feed, saying: "This does not bode well for Meghan's acting comeback in the

The Gentlemen, starring Theo James and Kaya Scodelario, was created by British filmmaker Ritchie and is a spin-off from his 2019 film of the same name.

Meghan, who made her name as Rachel Zane in the TV drama Suits, stepped away from acting when she and Harry got engaged in 2017. She was said to be in talks to join the third season of The Gentlemen, which

has yet to be green-lit.

If it got the go-ahead and Meghan had landed the role, sources suggest it could have earned her well over £1million.

Some reports claim Meghan's prospective new job in The Gentlemen was a key factor in their decision to relocate.

Last year the pair signed a downgraded deal with Netflix, which ended its partnership with Meghan's lifestyle brand, As Ever.

## Russia withdraws Ambassador has Ukraine tensions continue to grow Embassy in London says Andrey Kelin left last month after seven years in diplomatic post

RUSSIA has withdrawn its ambassador from Britain amid rising tensions between London and Moscow.

Andrei Kelin (right) left under a shroud of secrecy last month after more than seven years in the role and no replacement been appointed.

This has prompted fears of a complete breakdown in communication between Moscow and London.

Tensions increased as Russia threatened the UK with "consequences" last week after British-made drones were used to strike Russian territory for the first time.

A spokesman for the Russian Embassy claimed Mr Kelin had made "considerable efforts to preserve contacts and channels of communication" with London, and warned that the government was choosing a "path of confrontation" with Russia.

### 'more constructive'

The spokesman added: "He left Britain in the hope that a more constructive and respectful dialogue could eventually be restored, should the



UK reconsider its policies towards our country."

Withdrawing an ambassador is a formal way of expressing displeasure with a country without completely severing diplomatic ties.

The ambassador's departure was announced internally at the embassy during a party for Russia Day on June 11.

However, no formal announcement or statement about the move was made to the public.

It comes as Andy Burnham arrived in Ukraine for his first overseas visit as Prime Minister. Co-chairing a meeting of the Coalition of the Willing he announced plans to pave the way for

SCALP long-range missiles – the French version of the UK's Storm Shadow – to be developed on Ukrainian assembly lines.

Ahead of the visit, on Ukraine's independence day, Mr Burnham said: "On Ukraine's 35th anniversary of independence, the Ukrainian people should be in no doubt: the UK is behind you today and for as long as it takes.

"I am proud of the contribution our country has made to Ukraine, and I want the Ukrainian people to hear it directly from me that our support will not waver. After all, Ukraine's security is our security."

## First Briton recorded killed fighting for Russia in Ukraine

A British national has been killed in Ukraine while fighting for Russia.

Bradley Townsend is said to have died following an attack by a remote-controlled FPV drone in Ukraine's eastern Donetsk region. His death on 10 June is believed to be the first of a British citizen fighting for Russia in the conflict.

The 33-year-old left his home in Barnsley, South Yorkshire, earlier this year after telling his family he was going to Romania, according to the Yorkshire Post.

The Foreign, Commonwealth & Development Office (FCDO) confirmed it was aware of reports a British national had died in Ukraine, adding it was in contact with his family.

The news emerged as Andy Burnham arrived in Kyiv for his first foreign trip as UK prime minister.

The visit coincided with the 35th anniversary of the country's independence from the Soviet Union.

In a video shared

online on 4 April, Townsend featured alongside Ben Stimson and Aiden Minnis - who were given Russian citizenship for fighting in the occupied Donbas region.

In the video, uploaded to a Russian recruitment account, Townsend described himself as "a normal working-class lad from Yorkshire".

Filmed by Stimson with Minnis interviewing, Townsend discussed the implications of his decision to leave the UK and fight for Russia during the video.

He said: "I came with the idea that I proba-

bly won't be able to go home, definitely get persecuted if I went back."

He later added: "I'm not here for a suicide mission, but I understand that's what can happen."

Stimson, from Oldham, and Minnis, from Wiltshire, are believed to be the first British nationals fighting for Russian president Vladimir Putin since he ordered the full scale invasion of Ukraine in February 2022.

Stimson was previously jailed in the UK in 2015 for joining pro-Russian separatists in the east of Ukraine.

## Tungsten mining restarts in Devon

### ■ Government cash helps reopen mine near Plymouth ■ Ultra-hard metal considered strategically vital

A mine said to have one of the "most significant" deposits in tungsten in the Western world is to go into full production after a cash injection, bosses say.

The government is investing £71m to restart Tungsten West's Hemerdon mine, near Plymouth, Devon.

Bosses said they hoped they would be at full production by the end of March 2027 in a project which would create 350 jobs and secure access to the mineral used in defence.

Boss Jeff Court said:

"We started very, very quickly on the back of the announcement... The timing is perfect for us in terms of getting that extra boost for funding... We have done everything we can do to make the project much more robust [after going on hold in 2022]."

Tungsten is an extremely hard metal, used in the defence, aerospace, next-generation energy and electronics industries, with 80% currently produced by China.

The UK's National Wealth Fund said the

multi-million investment established the government as a significant long-term partner in one of the UK's most strategically important mineral projects, with rights to negotiate and procure up to 50% of the tungsten produced.

Tungsten West took over the disused mine in 2019 but put plans to reopen on hold three years later, blaming rising costs and a low market price for the mineral at the time.

# Farewell Tim Curry, the Rocky Horror icon

■ Actor who shot to fame in *The Rocky Horror Picture Show*, dead at 80

■ Star enjoyed a long career, finding later fame as Pennywise

English actor Tim Curry, best known for playing the outlandish Frank-N-Furter in film musical *The Rocky Horror Picture Show*, has died at the age of 80.

Curry first played the role on stage before the film version, which was released in 1975 and has remained a cult favourite.

The actor also played fearsome clown Pennywise in the 1990 TV version of Stephen King's *It*, and was Long John Silver in 1996's *Muppet Treasure Island*.

## 'sweet transvestite'

His other films included *Annie*, *The Hunt for Red October*, *Home Alone 2*, *Scary Movie 2* and he was nominated for three Tony Awards on Broadway.

Born in Warrington in 1946, Curry's first acting job after university was in the original London production of groundbreaking rock musical *Hair* in 1968.

In 1973, a fellow cast member, Richard

O'Brien, asked Curry to audition for his new musical, and cast him in the role of the flamboyant lingerie-clad "sweet transvestite" Dr Frank-N-Furter.

Curry first put his stamp on the character of the riotous scientist on stage in the upstairs theatre at London's Royal Court in 1973.

## fan favorite

The show's popularity snowballed and resulted in a big-screen adaptation, which also starred Susan Sarandon, Barry Bostwick and O'Brien.

It was not an immediate hit at cinemas but became a fan favourite and holds the record for the longest-running theatrical release in film history.

Welsh actor Luke Evans, who played the role in a Broadway revival, called Curry "a force, a bright fierce flame, an exquisite charm".

In a letter he recently wrote to Curry, Evans thanked him for his

fearlessness and for "creating something so enduring, and for inspiring generations of actors to be a little braver than they thought they could be".

## 'Don't dream it, be it'

"Being compared to you has been one of the greatest compliments I've ever received, even though it's a comparison no one could ever hope to live up to," he wrote in the letter.

The official *Rocky Horror Picture Show* on Broadway account similarly thanked the late actor for "giving the world a little more freedom, a little more fearlessness, and through the tears in our eyes, the courage to BE IT" - a nod to Curry's deliver of the famous line from the musical, "Don't dream it, be it".

Curry's varied career also saw him appear on screen in 1982 musical film *Annie* as Miss Hannigan's con-artist brother, 1985 murder mystery *Clue*, fantasy *Legend* alongside Tom Cruise also in 1985, and 1995 gorilla thriller *Congo*.

On stage, he received his first Tony nomination for playing Mozart in the original Broadway production of *Amadeus* in 1981.

## Online fans

Further Tony nominations came his way for *My Favorite Year* in 1993, then in 2005 for playing King Arthur in Monty Python musical *Spamalot*.

His performance in 2008 video game *Command and Conquer: Red Alert 3* found him fame with a new generation of fans online.

As Soviet Premier

Anatoly Cherdenko, Curry's bombastic delivery of one line, and his apparent efforts to stifle a giggle as he said it, became a legendary meme online: "I'm going to escape, to the one place that hasn't been corrupted by capitalism... space!"

One clip of the moment has more than 10 million views on YouTube, and has been endlessly shared across social media.

A statement from Curry's representatives following his death said: "Across five decades, he moved fluidly between comedy, horror, drama, and music, delighting himself and his legion of fans with his countless dynamic personas."

and the investment had "come at the exact right time for the project".

He also said it was "very important to us as it shows an incredibly strong level of support, right up to Number 10 [Downing Street] in the UK government".

Plymouth Sutton and Devonport's Labour MP Luke Pollard told the BBC: "Tungsten is important in national defence as an armour-piercing metal... it's used in missile production and a whole array of defence appli-

cations."

Pollard, Minister for Defence Readiness and Industry, added: "It's because of that and because the world is getting more dangerous and critical minerals like tungsten are more valuable and in demand that the government has stepped in to make an investment in Tungsten West."

He said it would "allow the UK to be more resilient" in challenging times.

"If the world is to be more dangerous, and we know that it is, we, as a country, need to be able to secure our own supply of these minerals," he said.

# Two PCs dead as wrong-way driving craze spreads

## ■ £1m raised in days for young families left behind

BRITAIN was left stunned this week by the tragic death of two police officers in a wrong-way crash near Middlesbrough.

PC Matthew Blades and PC Tom Clough died during the early hours of

Saturday when a Volkswagen Passat, going the wrong way on the A66 at South Bank, hit their vehicle. The five young men in the Volkswagen also died.

Both officers had young families, and an appeal quickly raised over £1m for their survivors.

Among the donations to the police officers' fundraiser, which was launched by the Cleveland Police Federation, was £4,000 from the Cleveland branch of the National Association of Retired Police Officers.

Its chair Grant Thorburn said the officers' deaths had "hit home hard" and that seeing the tributes and donations paid to them had been "humbling".

### 'compact force'

He said: "Once you're a police officer, you're always a police officer, so even after you retire, particularly in Cleveland, it's such a small, compact force, everyone knows everyone else."

The Independent Office for Police Conduct (IOPC) previously said that officers had been pursuing the Volkswagen Passat seven minutes after it was connected to earlier

alleged criminal activity, but the pursuit was abandoned 10 seconds before the crash when the Passat turned on to the dual carriageway.

PC Matthew Blades and PC Tom Clough had been in a vehicle looking for the Passat after its cloned registration plates triggered an automated number plate recognition camera, although they were not involved in the pursuit, the IOPC said.

### 'our super hero'

PC Blades, a 37-year-old father of two, was described by his family as a "beloved husband" and the "most devoted father".

"He may have left this world committed to the duty he believed in, but his greatest legacy will always be the love he gave to his family," his wife said, adding he would be "forever our super hero".

The deaths prompted a huge investigation into organized crime figures in the area bringing the arrest of 17 people within two days.

Among those detained were a 16-year-old boy, an 18-year-old man and a 21-year-old man, all on suspicion of participating in an organized crime group. A 55-year-old man

was arrested on suspicion of assisting an offender and a 23-year-old man on suspicion of threats to kill.

Cleveland Police said the arrests followed overnight operations with support from the National Crime Agency, which investigates serious and organized crime, and the North East Regional Organized Crime Unit.

A 26-year-old man was charged with possessing

Class A and Class B drugs with intent to supply and possessing criminal property. He was remanded in custody until a Sept. 21 hearing at Teesside Crown Court, which hears more serious criminal cases.

The crash was originally linked to a TikTok craze popular in the UK where young men film themselves driving the wrong way down motorways in

the wee small hours. But it soon emerged that the car involved had links to serious and organized criminal activity.

Four of the five dead men in the Passat had a combined 37 previous convictions for offenses including possession of a bladed article, car theft, drug possession, racially aggravated intentional harassment and driving offenses.

## Teenage people smuggler facing jail

A teenager who piloted a dinghy carrying a then-record 165 migrants across the English Channel to the UK has pleaded guilty to endangering others during a sea crossing.

Chan Mathok Atak, 19, originally from South Sudan, admitted the offence at Canterbury Crown Court in relation to a crossing on 23 July.

Rescuers said they were astonished and alarmed to see the number of people packed onto the dinghy.

It was said to have been about the same length as a bus before it began deflating in the world's busiest shipping lane.

Prosecutors said Atak created a risk of death or serious personal injury to others on board the boat.

Endangerment at sea is a new offence created to target those alleged to have steered small boats over the Channel.

At the time of the crossing, the dinghy set a record for the largest number of people brought over in a single boat since dinghy arrivals began on the south coast in recent years.

The figure has since been surpassed, and earlier this month, a record 230 people reached the UK in a so-called "mega dinghy".

Atak is due to be sentenced on 11 September.

## Pensioner left giddy as whisky barrel investment nets £270,000

A whisky barrel purchased for £130 is to go on sale for £270,000.

Surrey pensioner Angus Kerr said he had bought the Glenrothes single malt in 1971 as an investment, hoping it would help pay for his children's school fees.

He said it was now worth an "unbelievable" sum, as the barrel was the oldest of its kind known to be in existence.

"I don't drink scotch," Kerr said. "If I did, I would be looking around for something that was £18, no more.

That's my sort of level."

"That was silly"

Kerr, a former commodities trader, said he had made the purchase after hearing about a company selling barrels of new-fill whisky.

"I thought at least I can go for a swim in it if it all goes belly up," he told reporters.

Kerr said he had hoped to sell the barrel five years later for a profit, but the company went bust and he lost contact with them.

"I just threw my hands

# Sir Billy Boston dead at 92

■ Rugby League legend turned to the code after color barrier prevented him playing for his hometown rugby union team

■ Boston played with distinction for the Great Britain team, and was part of the side which won the 1960 World Cup

Rugby league legend Sir Billy Boston has died aged 92.

Last year, he became the first player in rugby league's 130-year history to receive a knighthood. Born in Cardiff in 1934, Boston grew up playing union but - overlooked by his home club - came to the attention of rugby league scouts while on national service in the north of England, signing for Wigan in 1953 as a 19-year-old.

Despite having played just a handful of games in league, the young winger's talent was quickly evident and Boston was picked for the 1954 Great Britain side that went to Australia and New Zealand - becoming the first black British player to tour down under.

He reached the 100-try milestone in just 68 matches after his switch

from union.

Boston's scoring ratio is extraordinary, claiming 478 tries in 488 games for Wigan and helping them win three Challenge Cups and the Championship.

Boston would go on to score 24 tries in 31 appearances for Great Britain and was part of the side that won the 1960 World Cup, scoring a try in the final as they beat Australia 10-3 at Odsal Stadium in Bradford.

### 'all to do with colour'

Boston finished his playing career as a second row with Blackpool Borough.

In all, Boston scored 571 tries in his career - a total surpassed only by Australian legend Brian Bevan in top-class rugby league - and is one of the truly great British rugby league players.

However, in media interviews including with the BBC, Boston made it clear he would have swapped all his rugby league achievements if his path to recognition in his home town and nation had not been blocked by racial prejudice.

On one occasion he told BBC Sport he "enjoyed every minute playing rugby league" but added that "I would have (given up his rugby league achievements) to play for Cardiff and Wales in rugby union".

He said: "I think it was all to do with colour. But there you are, I don't know. You have to ask the people of Wales for that."

"Because there were a few other people, Colin Dixon, Clive Sullivan, Johnny Freeman, all outstanding black rug-

by players from Cardiff who went north and who perhaps didn't get a crack of the whip at union."

Boston went on: "The only bad thing in my life was I never got a cap for Wales [in union]."

"I'd have given it all up... [and] done it for Wales instead of having

to leave my town where I was born. You know, you regret not having played for your country where you were born."

After his retirement from the game, Boston ran the Griffin Hotel close to Wigan's Central Park Ground where one of the stands was named after the Welshman.

He is immortalised in two more statues, in Wigan where he is an adopted son and in his home city of Cardiff.

Boston was appointed an MBE in 1986, and was among the first to be inducted into the Welsh Sports Hall of Fame when it was launched in 1990.

in the air and thought, 'OK, that was silly'," he added.

However, a few years later, the 81-year-old was contacted out of the blue by a Glaswegian company, which said he owed them money for storing the barrel.

After getting waylaid by "business, kids and life in general", Kerr said he had only recently contacted broker Mark Littler to try to sell the barrel, which contains enough for approximately 287 bottles.

Kerr said the tasting experts had declared the 57-year-old whisky "absolutely fantastic".

"It could have lost its

alcohol content or ended up being very oaky and horrible, so it's very fortunate," he added.

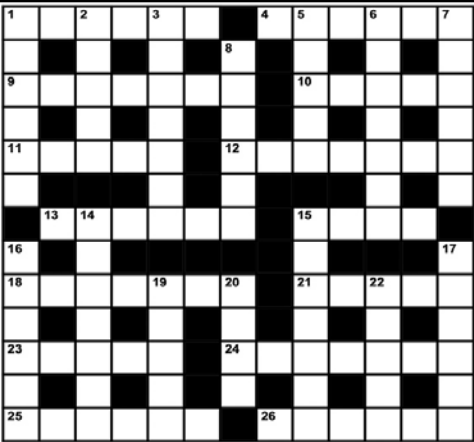
"What we need to find is Elon Musk, [Jeff] Bezos or someone for who £270,000 is just spare change to them."

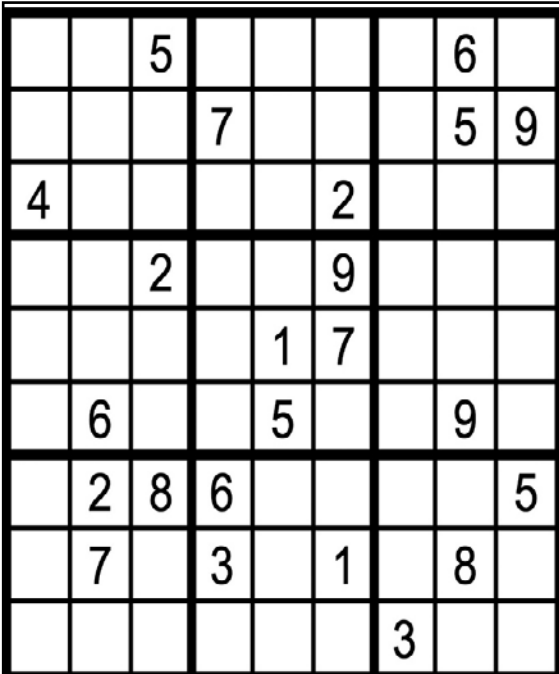

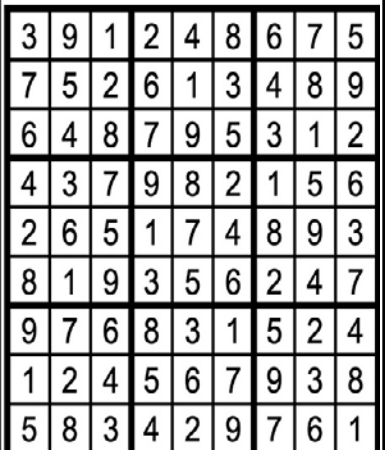

# Tensions peak as selfie hunters and hikers clash at the top of Snowdon

■ Highest peak in Wales suffers congestion as day trippers linger while 'doing it for the 'gram'

Visitors to Wales' highest mountain are being urged to respect others by not skipping queues to reach the top following rows among climbers.

Recent hot weather means there have been bumper summer crowds at Yr Wyddfa, also known as Snowdon, where people have reportedly waited more than one hour to reach the 1,085m (3,560ft)-high summit.

Social media videos have shown arguments among queue-jumpers and those patiently waiting their turn to touch the metal plate that marks the top.

A recent video showed Marc Screeton, from Manchester, being heckled as he bypassed the line, saying: "Imagine queuing on a mountain? No chance."

But others have said

queuing is necessary for safety reasons.

Eryri National Park Authority said its policy remained one of "self-policing" at the summit.

The mountain's growing popularity in Eryri National Park, also known as Snowdonia, has led to bottlenecks, and queues are now common on the stone steps leading to a metal plate or trig point where people pose for photos and videos.

Two charity hikers raising money for motor neurone disease were recently heckled after skipping queues to reach the summit in May.

Speaking to reporters, walkers on the mountain had mixed views about those jumping the queues.

Lucy Taylor said: "I think you should queue because it's really quite

dangerous and everyone's trying to get up there - it's just not safe."

Tina Millard from West Bromwich said: "I don't think that you should have to queue."

"It's a mountain, you should just be able to go up and that's it."

"We're not at Alton Towers for a ride. It's a mountain, it's for everyone," she said.

Carl Lynch from Dunstable, Bedfordshire said: "It should be: 'go up there, two minutes and then move on for everyone else'. Simple as that."

Alun Jones, an area warden for Eryri National Park Authority, urged those wanting to reach the trig point to be "considerate and don't skip the queue".

While queuing is often not compulsory, it is often an "unwritten and unspoken" social contract, according to an expert in moral philosophy.

Johann Go, who is also assistant professor of ethics at University College London, said: "So it's not that I have to queue, but given that others are al-

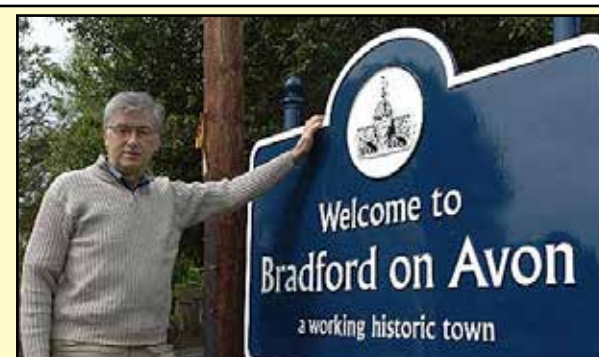
ready restraining themselves, if I were to then jump the queue, I would be saying 'to hell with them' and that my time is more valuable."

## Classic village finally gets its dashes erased

It's been dubbed the Great Dash Debate.

And finally, after more than a century, the Wiltshire town of Bradford-on-Avon is getting rid of its hyphens with a little help from Google.

In 1899, the Great Western Railway put dashes in the name of Bradford-on-Avon's railway station, and the punctuation has stuck ever since. There are now thousands of incorrect references online, with Google Maps, TripAdvisor and Wikipedia among the worst offenders. Artificial intelligence has already been infected, as Gem-



ini, Chachi PT and Claude each include the hyphens when asked how to spell the town's name.

Now, a local marketing agency is taking on what it calls the horizontal hate crime, in a bid to remove the dashes from websites and real life signs. It's working with the modern Great Western Railway company

to change the station sign and Wiltshire Council to update the road signs. Now, Google has agreed to join the campaign, saying its map listings should reflect official government sources.

So, after 127 years, Bradford-on-Avon is finally beginning to get its dashes back where they belong. Nowhere.

# Dream debut for Danny

Danny Welbeck scored on his debut as Enzo Fernandez was left out of Chelsea's 2-0 win over Luton Town in the third round of the Carabao Cup on Thursday.

The 35-year-old summer signing from Brighton headed home from close range early in the first half, before Hakeem Odoffin later diverted an attempted clearance from Estevao Willian's shot into his own net.

Fernandez, who in talks with City, was left out of the squad after appearing as a substitute in Monday's 3-2 Premier League win at Fulham.

It came amid reports in Argentina suggesting he had asked to be left out as he attempts to make the switch to Etihad Stadium.

However, Alonso disputed those claims, insisting: "It was a decision

I took.

"He's a good professional. He's training well and I have nothing to say about him.

"It was just a decision that we had to take, thinking about the game that we're playing tonight and we'll see for Sunday [against Brighton]."

On the pitch, Chelsea dominated much of the first half, but inspired Luton goalkeeper Josh Keeley produced a series of excellent saves, beginning with a double stop to deny Cole Palmer in the 11th minute.

Welbeck later saw a header saved, while Keeley was at full stretch to push Reece James' free-kick around the post during a busy opening 20 minutes.

The Hatters also had opportunities through defenders Benny Benagr

and Odoffin from set-pieces later in the half, but neither seriously troubled Chelsea goalkeeper Mike Penders on his debut.

Before half-time, Estevao dragged a good opportunity wide from inside the penalty area, while club-record signing Morgan Rogers volleyed against the crossbar on his home debut.

Palmer's curling effort clipped the woodwork midway through the second half, while former Chelsea midfielder Kasey Palmer shot wide on his return to his boyhood club.

After Welbeck broke Luton resolve, the League One side struggled to create clear-cut chances to get back into the tie before Odoffin's 79th-minute own goal sealed victory for the Blues.

City will also be up against another of their former midfielders in Kevin de Bruyne when Napoli visit Manchester, with Sporting, Porto, RB Leipzig, AEK Athens and Lens their other opponents.

Europa League winners Villa, returning to the competition after a season away, will host PSG and Dortmund and

travel to Barcelona and Galatasaray.

Unai Emery's side also face Club Brugge, Fenerbahce, Viking and Slavia Prague.

Manchester United, returning after a two-year hiatus, will meet Bayern, Atletico Madrid, Roma, Sporting, Leipzig, Villarreal, Sabah and Como.

Liverpool, meanwhile, host Atletico, Porto, Villarreal and Lens while visiting Inter Milan, Brugge, Fenerbahce and LASK.

The first league-phase matches will be played on Tuesday, 8 September and the last round of games will take place on 27 January 2027, with the exact schedule to be released on Saturday.

This season's final will be held in Madrid on 5 June.
