Charles was 'giddily elated' at Diana's death, claims Spencer

■ War of words breaks out between Palace and Diana's brother ahead of his controversial new book

Earl Spencer, brother of Diana, Princess of Wales, has claimed King Charles "sounded giddily elated" when he called him after her death in 1997.

In a controversial new book about Diana, he alleged the then-Prince Charles sounded like a "lottery winner" after the news.

Buckingham Palace strongly pushed back on Wednesday against the credibility of the book, after an initial extract claimed Charles had said of Diana: "We'll forget her soon enough."

A spokesperson said: "While we do not comment on books as a matter of principle, His Majesty is mindful that the pain of fraternal grief can cloud reason, affect judgment and colour memory in ways others do not recognise, even many years after such a loss."

different perspective

The latest claims are once again highly personal in their attacks on King Charles and the royals, interpreting their motives in a very harsh light.

The evidence is Earl Spencer's own recollection of conversations about that emotional time around his sister's death, almost 30 years

ago.

What remains to be seen is how the public might respond to the allegations, whether they might support this book as a new and different Spencer perspective, or whether they might feel it to be inappropriate to be sharing such private disputes.

Representatives of Prince Harry have said they do not want to comment on the book and Buckingham Palace has pointed back to its response from Wednesday, when it rejected the account of Prince Charles in the wake of Diana's death in Paris.

In excerpts from Earl Spencer's memoir published in the Daily Mail, he recounts being alerted to the car crash on 31 August, 1997, by a phone call from his sister Jane in the middle of the night at his home in Cape Town, South Africa.

During the calls that followed, which confirmed the death, the then-Prince Charles telephoned him, he writes.

The book alleges: "Unlike my other callers,

who were stunned, barely able to articulate their condolences and offers of help, he sounded giddily elated - like a lottery winner, I remember thinking at the time."

'not in love with her'

According to Earl Spencer, Charles informed him he had told Princes William and Harry of their mother's death first thing that morning, in their bedrooms at Balmoral.

The royal couple had divorced in August 1996.

Swan Song: Diana, My Sister is due to be published next week. In the memoir, Earl Spencer writes of his sister's troubled marriage - claiming a friend of Diana's had told him that on the eve of their wedding in July 1981, Prince Charles had told her he was "very happy to marry her, but... not actually in love with her".

hugely popular

Things became "very difficult indeed" in the marriage early on, Earl Spencer writes, adding that he is "sure that both

spouses despaired of the other at times".

He now believes his sister had attention deficit hyperactivity disorder (ADHD), and as part of her condition suffered from Rejection Sensitive

Dysphoria - describing the latter as an "intense emotional pain in the face of others' rejection or criticism".

In her later years, he writes, Princess Diana considered taking her

own life on more than one occasion but love for her sons "stopped her from going further".

The death of Diana, a hugely popular figure, had created a volatile at-

Different PM, same commitment to Nato, Burnham tells Rutte

■ UK defence spending expected to rise to 2.7% of GDP next year

ANDY Burnham has assured Nato chief Mark Rutte that the UK's commitment to the alliance remains, despite the change in Prime Minister.

Secretary general Mr Rutte on Tuesday wished the PM "good luck" in the job when they met for the first time to discuss defence.

Mr Burnham declared: "There's been a change of Prime Minister but never any change in the UK's unwavering commitment to Nato and our Nato obligations."

He highlighted the commitment that is being made by British armed

forces who are "serving in Nato missions around the world".

Mr Burnham told Mr Rutte: "It's critical for us always to show our firm commitment to Nato, and that's what we will be doing today."

In return Mr Rutte called Britain "one of the leading forces in Nato".

political pressure

The pair examined a robotic dog while viewing cutting-edge defence tech at RAL Space, a research facility in Didcot, Oxon.

The Labour leader is under political pressure to show how the UK will meet its Nato commit-

ment of allocating 3.5% of gross domestic product – a measure of the size of the economy – for core defence spending by 2035.

Current Chancellor John Healey resigned as then-Premier Sir Keir Starmer's Defence Secretary in a row over funding, arguing that it was necessary to reach 3% by 2030.

Spending is currently expected to rise to around 2.7% of GDP next year.

Mr Rutte used a speech later to praise the UK for being "serious about security".

He said: "It is leading, along with Nato allies,

the pushback against Russia's dangerous and reckless campaign against us.

"Collectively we will continue to strengthen our ability to deter and

defend all allies, against any threat.

"Nato will not be intimidated by Russia's campaign of hostile actions.

"Russia wants to stop

us helping Ukraine – but their actions will only lead us to do more. Russia's actions are a sign of weakness, and a symptom of Putin's failure in Ukraine."

"I'd love to see a unified Ireland" says Trump on Dublin visit

JUST a week on from declaring that the US might not support the UK in a clash with Argentina over the Falkland Islands, Donald Trump stuck the boot into the all-but-moribund Special Relationship by calling for a united island of Ireland.

Speaking at the start of a two-day visit to Ireland, Mr Trump said he

would "love to see" reunification, adding "it's going to happen eventually".

And he doubled down on his remarks the following day while attending the Irish Open at his Doonbeg golf resort, saying he "loved" the backlash.

MPs from across the political spectrum responded vigorously to

Trump's remarks, but many sought to tread a fine line between condemning the remarks and stressing the UK's continued alliance with the USA.

Labour MP Angela Rayner said the government remained committed to the Good Friday Agreement, while Shadow Foreign Secretary Tom Tugendhat said Mr

Trump's comments were "unhelpful".

Reform UK's Robert Jenrick said the president is "completely wrong".

It came as the First Ministers of Scotland, Northern Ireland and Wales held independence talks with the stat-

ed aim of dissolving the United Kingdom.

Housing Secretary Rayner said: "Donald Trump is Donald Trump. We're really serious about the Good Friday Agreement and we continue on that path."

Mr Tugendhat said the

president was "playing games".

Under the terms of the 1998 Good Friday Agreement, the Northern Ireland secretary is obliged to hold a border poll if they believe unification is supported by a majority of voters.

Sheeran shambles: Ed's tour in chaos after multiple support acts quit over corporate "censorship"

■ Four opening acts and the live band for Sheeran's US tour depart after removal of rapper over 'free Palestine' comments

The fate of Ed Sheeran's Loop Tour was hanging in the balance this week after all of the British singer's remaining opening acts quit in solidarity with the rapper Macklemore, who was dropped from the remaining North American dates over pro-Palestinian comments.

Though Sheeran wrote that he was "appalled by the conflict between Israel and Palestine" and "the suffering and pain caused on both sides", he said that attempts to broker conversations among parties had been unsuccessful and the "venue's and

and hurtful to the Jewish community".

In 2013, Macklemore apologized after wearing a black wig, beard and hooked nose onstage in Seattle, which critics said was an anti-semitic caricature.

Kraft added: "I would welcome the opportunity to sit down with Mack-

Hours after Sheeran released a statement saying it was the promoter's decision to remove Macklemore from the tour and not his, the rest of his supporting acts - Irish singer Aaron Rowe, Danish pop band Lukas Graham and songwriter Finneas - as well as Sheeran's house band, Beoga, announced that they were pulling out in protest.

petition for removal

In a two-minute speech on 4 September ahead of Sheeran's show at the Gillette Arena, Macklemore told the audience he wanted the people of Gaza and "the occupied West Bank" to know "we have not forgotten about them", along with the words "free Palestine".

The remark prompted a petition calling for Macklemore's removal from the tour from the Israeli American Council and the opposition of some venue owners - including Robert Kraft, the billionaire owner of the New England Patriots and a prominent do-

the promoter's decision was final".

"Macklemore coming off tour was the promoter's decision, it was not mine," he wrote in a multipage post on Instagram. "I would never let down the fans who had made plans, nor would I abandon the touring crew and the other support acts and musicians who rely on me for work and to make a living."

"recent actions"

"I have spent this week trying to build bridges, to find a solution and unfortunately, was unable to do so," he concluded. "I know who I am, both as a person and as an artist, and those who know my heart know my values too."

In his own statement on Monday, Kraft did not deny refusing to allow Macklemore on stage at his Gillette Stadium outside Boston, and said the decision was based on both Macklemore's "recent actions" and "a broader history of antisemitic rhetoric and imagery that we believe has been deeply offensive

lemore and discuss the facts, because ultimately our goal is the same - peace for all people, an end to suffering, and an end to all hate."

Announcing his decision to leave the tour, Finneas wrote on social media: "Artists must not be silenced when they speak up for the oppressed."

"I have decided to withdraw from my upcoming tour dates with Ed Sheeran. I stand with Palestine and its people."

"forced famine"

The decision came shortly after Aaron Rowe, an Irish singer who opened for Sheeran in Australia earlier this year and was scheduled for the 10 remaining dates in North America, announced his own withdrawal from the tour. "I don't take the decision lightly," he wrote on Instagram.

"Ed has been a friend to me and has changed my life, I could never thank him enough for this."

"But as Irish people we know all too well about genocide, forced famine

and violent occupation. I cannot stand by and allow billionaires to use their position of power to silence the rightful voices of those who speak up against Israeli genocide and who highlight the savage murder of children. I would lose all respect for myself to carry on as normal."

The Irish band Beoga, which performs as Sheeran's backing band, announced after Rowe that they would also depart the US tour to protest the "silencing of Macklemore by Zionist lobbies".

"We are a traditional Irish band who never saw ourselves playing in stadiums of that size and that opportunity is not lost on us," they wrote on social media. "We have been friends with Ed for over 10 years now and will continue to be. We believe in dialogue as a means of progressing the plight of the Palestin-

ian people."

The Danish pop band Lukas Graham also dropped out of the tour on Tuesday afternoon. "We should be able to speak about war, about civilians being killed, about children who deserve to grow up. Wherever they live. Whatever flag flies

over them," wrote lead singer Lukas Forchhammer on the band's social media.

"Money doesn't give you the right to own the conversation. Nobody's bank balance should decide who gets to speak or which suffering we're allowed to acknowledge."

PM calls a halt after death of his father

PRIME Minister Andy Burnham cancelled all engagements for 24 hours this week following the death of his father.

The PM's dad Roy, 86, a former telephone engineer, died on Monday following a lengthy battle with Alzheimer's disease.

Mr Burnham had been set to host business leaders at 10 Downing Street on Monday and a weekly Cabinet meeting the following day.

In a statement, Downing Street said: "The PM has cancelled engagements for [Monday and Tuesday] due to the passing of his father, Roy."

Mr Burnham has spoken about his father's illness, which meant that he did not know his son had become Prime Minister.

The experience is one of the driving factors in the PM's aim to reform the social care system.

In an interview on the eve of taking office in July, Mr Burnham revealed the extent of his father's illness.

The politician said Roy was unaware that he was on the brink of power. He added: "That's a sadness because he would be [proud]."

"The way I look at it, it's his achievement as well.

"A whole-family achievement, although he doesn't know it."

In a major speech about the reform of social care later that month, Mr Burnham promised to help "my dad and the millions like him" faced with the unfairness of the current system.

His proposals included accelerating plans for a National Care Service, improving pay, training and career progression for care workers and launching cross-party talks aimed at addressing the long-term challenges facing social care.

The Gang of Four aiming for the end of the UK

NATIONALIST leaders in Scotland, Wales and Northern Ireland have agreed to work together to break up the United Kingdom.

Scottish First Minister John Swinney declared that Andy Burnham will be the last Prime Minister to govern the UK in its current form, as he signed a memorandum of understanding with his counterparts.

Northern Ireland's First Minister, Michelle O'Neill, revealed she took encouragement from US president Donald Trump, after he declared over the weekend that a united Ireland would be a "fantastic thing".

And Welsh First Minister Rhun ap Iorwerth said there was a "determination that it was for our people to decide" their futures.

All three nations are led by politicians committed to leaving the UK, after Welsh nationalists Plaid Cymru ended 27 years of Labour rule in May's elections.

The SNP, which is

committed to Scottish independence, has run the government there since 2007 while Sinn Féin politician Mrs O'Neill became First Minister of Northern Ireland in February.

'coming to an end'

Her party calls for the province to leave the UK and unite with the Republic of Ireland.

In a joint statement demanding referendums to determine the future of each nation, the leaders declared: "Westminster's time is coming to an end."

Mr Swinney insisted Scots would vote to leave the union if a poll was held today, despite rejecting independence by 55%-45% in 2014.

And he claimed Mr Burnham's commitment to devolution in England, which involves giving more powers to regional mayors, "leads you to the logic of recognising the right of the people of Scotland, in my case, to decide their own future".

The Scottish leader

said: "I think he will be the last Prime Minister of the United Kingdom, because the people of Scotland, if given the choice of independence in a referendum will take that choice."

Mrs O'Neill welcomed Donald Trump's comments in support of Irish unity, after the US president said he "would love to see" Ireland unified.

Accompanied by Sinn Féin president Mary Lou

McDonald, the leader of the opposition in Ireland, Mrs O'Neill said: "The comments from the President of the United States very much reflect the fact that the unity debate is very much alive."

Mr Burnham's spokesman said: "The Prime Minister is committed to delivering change across all four nations of the United Kingdom and believes strongly in the Union."

"The Prime Minister will continue to ease pressures on household finances, and deliver greater economic security, rather than engage in constitutional debates or further referendums."

Conservative leader Kemi Badenoch said: "Building a country requires a lot of work."

"But if all we're talking about is how to get out, we're not actually bringing people together."

The Great Northern Run: PM leaves the 'dodgy shorts' behind

PRIME Minister Andy Burnham joined thousands of runners at the Great North Run on Sunday, running to raise money for a homeless charity.

Mr Burnham, wearing a Number 10 bib, was running in the half marathon to raise money for Changing Lives, which he visited last month to launch a national drive to end rough sleeping.

'don't change'

The Prime Minister, who took part in the run in a personal capacity, said the North East "doesn't always get the attention it deserves" and "it's good for the whole country to have

its eyes on this wonderful part of the world today".

Speaking to the BBC before the race yesterday morning Mr Burnham said: "People said to me when I became Prime Minister: 'Don't change'. I've been doing the Great North Run for a few years, so I thought I'll come and do it again."

"And hopefully leading from the front, getting out there. I'm a big believer that everybody should do a bit of activity, whatever it is people can do."

Wearing a pink running shirt and a number 10 race bib, Mr Burnham joked: "When I'm doing my job, I can hardly give

up halfway round, can I?"

Speaking near the start line, he added: "I've been doing a bit of training."

"But the dodgy running shorts have been left at home in Manchester."

"I couldn't offend all of the great people of the North East. So they're at home, and I bought some new ones."

Mr Burnham donated 15% of his first month's salary as Prime Minister to Changing Lives, after promising to give a share of his wages to charity each month.

ing Lives chief executive, said: "We're delighted that Andy is running for Changing Lives and grateful to everyone who gets behind him."

Passports for Piddington: tiny village votes to leave UK over migrant center fears

■ Oxford community of 350 revolts over proposed plan to house 1,250 male asylum seekers nearby

PASSPORTS for Piddington could become a reality after a tiny Oxfordshire village voted to leave the UK.

A vote was held in the village of 350 people in protest at the Labour government's plans to house 1,250 male migrants on an old MoD site nearby.

The vote was held outside the village hall at 7am Monday when returning officer Susanne Parden delivered the result of a symbolic Piddington independence ballot. She announced that 285 residents back leaving Britain.

The turnout was nearly 92%, with just 26 residents voting against the motion. One ballot was spoiled.

Within minutes, a man was erecting Principality of Piddington signs.

Parish council chairman Tim McNally told a gathered throng of media: "I just want to say something to Andy Burnham, the Prime Minister of this great, great country that we're in, the Speaker of the House of Lords, Speaker of the Commons... this is an example of democracy in operation."

The vote was timed to coincide with World War II Battle of Britain commemorations this week, and Mr McNally said this is a new "battle for Britain".

"danger and risk"

Piddington graphic designer Christina Gower, 26, said she could easily start designing symbolic passports.

She added: "It has been amazing to watch this

community of adults just pull together and make a stand."

Alan Hopkins, 59, has lived in the village for 17 years.

He told reporters: "I think we've caught the imagination of the country, we've been apolitical and I'm very proud to be a Piddingtonian."

"I'm fearful for the women and children of this parish. Unfortunately, statistically, there is danger and risk, there's always risk with 1,200 people."

He added: "If you think how much they will have to spend to make the MoD site suitable for the migrants, it's horrendous – that money is a lot of hip replacements, a lot of knee replacements."

Fellow resident Samantha Phillips, 61, said: "This

is democracy not hypocrisy, rather than the version of democracy the government are peddling. Andy Burnham should come here.

"All we're asking is for the government to come and engage with us."

The area earmarked for mass asylum seeker housing by the Home Office is Bicester Site A, a former Ministry of Defence storage facility.

The Home Office's Urgent Crown Planning Application is yet to be approved, but the nature of the application means that it does not have to listen to locals' views.

Piddington is not alone in facing Home Office plans to convert a nearby former MoD site. Towns and villages in Yorkshire, Suffolk, Essex and East Sussex are also being looked at.

The Home Office said: "The government is closing every asylum hotel, saving taxpayers over £1billion."

"We are working to fairly house asylum seekers across the country."

Boris narrowly avoids Russian drone on Ukraine visit

BORIS Johnson narrowly avoided being hit in a Russian drone attack while on a private train travelling through Ukraine on Sunday.

Dignitaries were heading back to Poland from the Yalta European Strategy security conference.

Mr Johnson's train had an emergency evacuation alert after a drone hit the train behind only a mile from the Polish border and Nato territory, but they later carried on across the border.

Ukrainian Railways claimed Mr Johnson's train

may have been the intended target.

He said: "When are we going to give them the air defences they need? Why won't we unfreeze Putin's cash and give it to Ukraine? There is about £10 billion in London. Britain could show a lead."

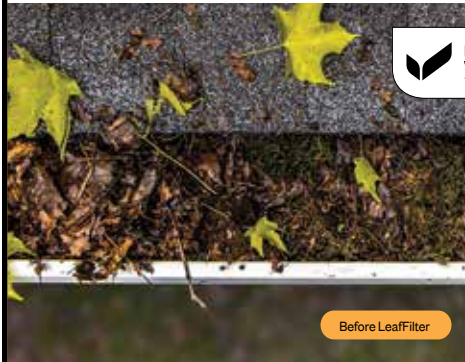

■ Carabao Cup: dream debut for young talent as Maresca's men shimmy past Canaries

Teenager Floyd Samba enjoyed a dream first-team debut by scoring twice to help Manchester City begin the defence of their Carabao Cup crown with a 5-0 thrashing of Championship outfit Norwich City on Thursday.

The son of former Premier League defender Christopher Samba, the 17-year-old scored in each half as the hosts made light work of their second-tier opposition to set up a fourth-round tie against Brighton - who knocked out Manchester United on Wednesday.

Enzo Maresca's side had initially found it difficult to make inroads on the Canaries defence, with full-back Rico Lewis drifting a rising effort narrowly over the crossbar, but they took total control by scoring two goals in three minutes.

Manchester City found the breakthrough courtesy of Samba's flicked header from fellow debutant Allan's cross, while Rayan Cherki coolly finished off when bearing down on goal from Ayyoub Bouaddi's pass.

Brazilian Allan went from provider to goalscorer at the start of the second half, showing quick feet to shift the ball on to his left boot before drilling a low finish, before Samba curled in delightfully for his second and Ryan McAidoo added a fifth late on for the home side.

Philippe Clement's men thought they had grabbed a consolation when substitute Mohamed Toure slipped home a cool finish past Geronimo Rulli, but the goal was ruled out for offside and preserved a clean sheet on the Argen-

tine goalkeeper's debut.

Manchester City, second in the Premier League, at home against a Norwich side 14th in the Championship never seemed like producing a shock result.
