Help the UK with Falklands? Don't count on it, says Trump

Donald Trump has hinted he would not come to the UK's aid in a potential future conflict with Argentina over the Falkland Islands.

In an interview with GB News, the US president said that Britain had "not been there to help me" with his country's war with Iran, despite later saying his military did not need any support.

Trump's latest remarks come after he

previously said the US could revise its neutral position on the islands' sovereignty if the UK failed to increase defence spending.

Argentinian President Javier Milei made a televised statement on Thursday night in which he revived his

nation's "historic" claim to the islands.

Milei said he will seek to toughen penalties on oil companies operating in the waters near the Falklands, alluding to oil projects such as Sea Lion, led by the firms Rockhopper Exploration and Navitas Petroleum, with British and Israeli capital, respectively.

"Today our national cause faces an urgent danger," Milei said.

"The islands are ours and they were taken from us," he added, before announcing that the country will build a naval base in Tierra del Fuego, near the Falklands.

'long time ago'

The Falklands, in the south-west Atlantic Ocean, remain the subject of a sovereignty dispute between Britain and Argentina, more than 40 years on from an armed conflict over the territory.

When asked if he would "come to the UK's aid" during a potential territorial dispute, Trump told GB

News: "Well look, I was there when they had the first war.

"That was a long time ago and I watched it so carefully, and you comported yourselves very well. You took it back pretty strongly, but it's a long way away."

Turning his attention to the US' current conflict with Iran, he added: "So, your country's not doing well. Don't forget, you get a big percentage of your oil from the Strait of Hormuz, and you weren't there to help me.

'pretty sad'

Your country was not there to help me. We didn't need help,

but I did ask Nato, and I asked your former leader, 'why didn't you send a couple of ships?'

Trump said the-then prime minister, Sir Keir Starmer, told him no vessels were available, which "was pretty sad", he added.

He also said: "Nato was not there, even though they get - most of those countries get - a big portion of their oil from there. So we're doing that by ourselves".

Argentina and the UK waged a brief but bitter war over the territory in 1982. A British military task force ejected Argentine forces, which had landed on the Falklands to stake a

territorial claim.

Seventy-four days of fighting led to the deaths of 255 British military personnel, three islanders and 649 Argentine military personnel.

Previous US administrations have formally recognized the UK's de facto administration of the islands, but have not taken a formal position regarding sovereignty.

Trump's comments come after he was asked by the BBC if he was reviewing the US position on the islands.

The president replied: "I always review every position. That's just one of many."

Country must recognize its 'wrong turns' says Burnham in his first Commons speech as PM

■ The prime minister said Britain needed to be brutally honest about the mistakes of the last 40 years of UK politics

Andy Burnham has blamed Brexit and Margaret Thatcher for a decade of low growth in the UK, arguing that Britain needs to be brutally honest about having taken "a series of wrong turns" in the last 40 years.

In his first Commons appearance since he took over as prime minister about six weeks ago, Burnham told MPs he wanted to build a new sense of optimism so "we can make this next decade better than the last".

The British people wanted "much more substantial change" on the big issues facing the country, he said. "That is what I will bring. Britain is not where any of us would wish it to be. Things are not working as they should."

The UK economy has taken a 6% hit from the effects of Brexit, according to economists' analysis of internal Bank of England data on thousands of British companies since the referendum a decade ago.

Shortly before Burnham's Commons address, Keir Starmer, his predecessor, announced he would stand down as an MP, saying he wanted to focus on international affairs, triggering a tricky first by-election test for Burnham in a seat where the Greens fancy their chances.

'relentless'

The cabinet was told on Tuesday that the government will have three key priorities: cutting costs of essentials like childcare and mortgages; the regeneration of communities; and greater public control of water, housing and energy.

Burnham told his ministers they must be "relentless" in fulfilling his priorities, but his plans are set against a tough economic backdrop. The chancellor's headroom against Labour's fiscal rules could be halved at his first budget if the current global bond sell-off persists, and economists warn mortgage rates

could go up this autumn.

In his Commons statement, the prime minister also hinted that he would commit to spending 3% of GDP on defence by 2030, saying he had appointed John Healey as his chancellor "precisely because" of his position on military spending. He also signalled he is open to renationalizing the water industry – saying he is looking at "all possible solutions", as the sector is a "leaking monument" to the failures of privatisation.

'consensus'

Burnham also opened the door to looking again at electoral reform in Labour's next manifesto. "I do believe there needs to be a mandate to make that change. There are different views in this house, but I believe we will need to get a consensus at the next election. And if there is that consensus, then a change can be made in the next parliament."

He also announced he would attend the Cop31 climate summit in Turkey and continue pursuing green energy – but that he would be "pragmatic" on supply, amid expectations he will approve the Jackdaw gasfield.

"The mistake is saying it's got to be one or the other for political purposes. The truth is, it's going to have to be both."

The prime minister, whose Makerfield constituency voted for Brexit, has previously argued it would be a mistake to rerun the referendum, but has said that he wants the UK to rejoin in

his lifetime. He suggested the next UK-EU reset summit could take place in November.

'drifting'

Political power was centralized, economic power privatized, the country de-industrialized. Austerity followed, hollowing out councils and depriving them of the agency to act to reverse any of this," he said during a three-hour stint in the Commons.

"And then Brexit compounded the damage, ushering in a decade of low growth and stalled regeneration. Change

begins with honesty ... Unless we are blunt about what went wrong, we won't turn things around.

"Far from taking back control, the combination of these policies took control out of the hands of communities up and down Britain for 40 years. Too many places have been drifting."

He added: "The government I lead will be relentless in giving people and places what they were promised 10 years ago: ownership and control, and from that control over their destiny comes change and growth."

Tory leader shuffles her cards

KEMI Badenoch has ousted Sir Mel Stride as Shadow Chancellor in a reshuffle of her top team.

The Conservative leader replaced him with Andrew Griffith in an overhaul of her Shadow Cabinet ahead of Parliament's return on Monday and the party's conference next month.

Claire Coutinho, who was Shadow Energy Secretary, will take on Mr Griffith's previous Shadow Business Secretary role when she returns from maternity leave in the new year.

Sir Mel will return to

the backbenches alongside fellow Tory heavyweights Dame Priti Patel and Sir James Cleverly.

Tom Tugendhat will take over from Dame Priti as Shadow Foreign Secretary, while Sir James announced on Saturday that he was standing down as Shadow Housing Secretary to have a tilt at being the Tory candidate for Mayor of London.

Sir James's role will be taken by Katie Lam, who was elected in 2024.

Mrs Badenoch is gearing up amid speculation new Prime Minister Andy Burnham could call a gen-

eral election, which is not due until 2029, in the next 12 months.

A senior Conservative source said she was "changing the way the party approaches economic policy and creating a new economic leadership team for the next phase, focused on growth, higher living standards and fiscal credibility".

The insider added: "The team will be led by Andrew Griffith, a no-nonsense, pro-growth Shadow Chancellor with real business experience. Claire Coutinho will be

Andrew's deputy across the economic brief, as well as Shadow Business Secretary, and will make sure growth translates into higher living standards."

Mrs Badenoch said Sir Mel "came into the job at an exceptionally difficult point for the Conservative Party".

'great honour'

She added: "He brought experience, seriousness and stability when those things were badly needed."

Sir Mel described his time in the role as a "great honour", and added: "It is essential that the next Conservative government does things very differently, backing business like never before and getting government out of the way."

His replacement Mr Griffith said: "Kemi and I are united in our view that Britain needs an economic revolution and a team working to deliver that."

But his appointment came under fire from Reform UK's Treasury spokesman Robert Jenrick, who said: "The Tories have just brought back Boris Johnson's 'Net Zero Business Champion' who co-authored Liz Truss's mini-Budget."

"They haven't changed and still aren't sorry for the damage they inflicted on our country."

Labour Party chair Bridget Phillipson said: "Promoting a key architect of Liz Truss's disastrous mini-Budget tells you all you need to know about Badenoch's complete lack of judgment."

Other appointments included Rebecca Paul as Shadow Culture Secretary and Harriet Cross, Shadow Scotland Secretary.

Andrew 'committed sex crimes in the US', leading Congressman claims

■ Thomas Massie is leading an effort to pass legislation to have three million more Epstein files released by a reluctant Trump administration

A member of Congress has alleged in a speech on the floor of the US House that Andrew Mountbatten-Windsor "committed sex crimes in the US".

Thomas Massie, a Republican representative from Kentucky, named more than a dozen people he alleged were Jeffrey Epstein's "co-conspirators" or associates.

"We want perpetrators of these crimes to be investigated and prosecuted," Massie said, naming 14 people including Mountbatten-Windsor, Jes Staley, the former Barclays chief executive, David Copperfield, the magician, and Thomas Pritzker, the former executive chairman of Hyatt Hotels Corporation — before adding, "and Prince Andrew, who committed sex crimes in the US".

All deny any wrongdoing.

petition

Massie delivered the speech in the House as he led an effort to pass legislation to have three million more files related to Epstein released by the Trump administration.

"Perhaps hearing these names will shame the Department of Justice into delivering justice," said

Massie, who lost his bid for re-election in May.

Massie has begun collecting signatures for a petition to force a vote on a second Epstein Files Transparency Act, which he said would give "state [attorneys-general] access to Epstein files required to prosecute perpetrators under state law, and makes it easier for survivors to sue to get their files".

protection

The Speech or Debate Clause in America's constitution gives members of Congress protection for statements made as part of legislative proceedings, allowing Massie to name people he accuses of being Epstein co-conspirators without facing defamation lawsuits.

Mountbatten-Windsor has never been charged with a crime in the United States. He has, however, been accused in US court of sexually abusing Virginia Giuffre when she was 17. The former duke denied the allegations, and the civil case was settled without an admission of liability.

Giuffre alleged in a federal lawsuit that Mountbatten-Windsor abused her in 2001 and



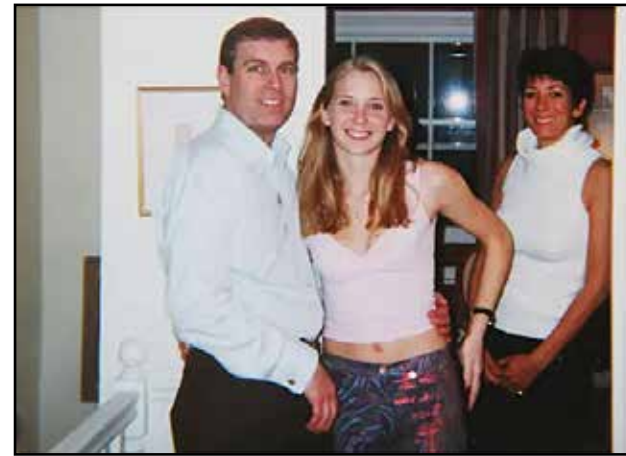

2002, including encounters in New York and at Epstein's Manhattan townhouse, as well as in London.

In a statement to The Times, Giuffre's family said they "commended" Massie's speech on the House floor.

"Andrew Mountbatten-Windsor should be investigated for his sexual crimes committed on US soil, not only against our sister Virginia Roberts Giuffre, but also against others of whom we are aware," said her brothers, Sky Roberts and Daniel Wilson, and her sisters-in-law Amanda and Lanette.

"Many of the crimes committed by Jeffrey Epstein and his collabo-

rators remain in the three million-plus documents that are being illegally held by the DoJ, in spite of the passage of the Epstein Files Transparency Act into law. It is time for them to be made public."

The former Duke of

York was arrested by Thames Valley police on allegations of misconduct in a public office after allegations that he shared sensitive information with Epstein during his time as the UK's trade envoy.

Macron and Burnham huddle on how to tackle small boat crisis

Andy Burnham and French President Emmanuel Macron have discussed how to "scale up" efforts to tackle illegal migration and move the UK closer to Europe, as the new prime minister hosted his first foreign leader in Downing Street.

In an official readout of their meeting, No 10 said the pair also discussed production of long-range

missiles in Ukraine.

Meanwhile, the prime minister raised Israeli plans for new settlements in the West Bank, which he condemned as "unacceptable".

Burnham said it was "so fitting" that Macron was his first overseas visitor since becoming PM in July, describing him as "our nearest neighbour and close friend Emmanu-

el".

"It shows what collaboration can achieve, just as we are also showing on Ukraine, on small boats, and also on strengthening the UK-EU relationship," Burnham added.

Macron said: "This is a very strong relationship. For me it is extremely important, and I'm here with willingness and a commitment to get closer."

The French leader's visit to the UK was primarily to mark the Bayeux Tapestry's loan to the British Museum. He met King Charles at the museum on Wednesday, ahead of the medieval tapestry going on public display next week.

In bilateral talks on Thursday, No 10 said Burnham and Macron agreed they were mak-

ing headway in reducing small boat crossings in the English Channel but now needed to go further.

They also "discussed the UK's drive to get closer to Europe", while Burnham raised concerns about the potential impact of the Made in Europe procurement plan, being drawn up in Brussels to protect EU industries, on British sectors.

2026 summer was hottest on record

HIS summer was the UK's hottest on record, provisional data from the Met Office showed.

The average mean temperature – which includes day and night – over June, July and August was 16.5C.

This is the warmest ever in a dataset going back to 1884.

Dr Amy Doherty, of the National Climate Information Centre at the Met Office, said: "The conditions we saw this summer broke UK climate records once again.

"Particularly notable is how much we've exceeded the previous summer mean temperature record, set just last year." That record was 16.1C.

Ms Doherty added: "The figures also knock the infamous summer of 1976 down to seventh for average summer mean temperature, with the top five warmest all occurring since 2003."

In all, the UK experienced five heatwaves over the summer, with an incredible 40 days of temperatures above 30C. This beat the previous record of 34 days.

Drought was declared across Wales and more than two-thirds of England, while raging wildfires devastated many parts of the country.

The highest temperature recorded was 38.1C at Kew Gardens in South West London on August 13.

This was the UK's fifth-hottest day on record but it fell short of the all-time high of 40.3C set in Coningsby, Lincolnshire, in July 2022.

Despite the overall lack of rain, the heavy downpours experienced by many late last

BoE boss warns of growing AI threat

■ Top banker said companies around the world should prepare for security breaches "involving simultaneous disruption across multiple firms"

The governor of the Bank of England has warned G20 finance ministers that artificial intelligence could cause a global economic downturn and pose a significant cyber security risk to financial systems.

Andrew Bailey said any collapse of growth in the AI sector could lead to a "future market correction" that spreads worldwide.

In an open letter to finance ministers in the US on Monday, he said companies around the world should prepare for security breaches "involving simultaneous disruption across multiple firms".

growing concentration

Earlier this month, a group of 100 firms, including Google, Microsoft, Anthropic and OpenAI, urged countries and groups to beef up their cyber defences before AI grows powerful enough

to override them.

Bailey told the G20 finance ministers that a combination of highly priced stock markets, increased borrowing by investors, and the growing concentration of money into a small number of major technology companies could amplify any future market correction.

homegrown AI

"The issue is not simply that investors are borrowing more, but that leverage is interacting with high valuations and market concentration, in particular the increasing cross-investment between artificial intelligence (AI) companies and hyper scalers, in a way that could amplify a future market correction," he said.

Bailey has called on those in charge of financial security to develop "appropriate steps to support safe and respon-

sible model release and deployment on a global basis".

Bailey, who was writing in his capacity as chairman of the Financial Stability Board international watchdog (FSB), expressed concern about the "volatility" prompted by the effect of energy supply shocks caused by the US-Iran war.

His warning comes as the UK government is seeking to grow the country's "sovereign AI" capacity, developing

homegrown AI technology to ensure the UK is not dependent on services from abroad.

Ministers want to see companies compete for the funding to help tackle challenges like cutting waiting lists in the NHS and bolstering cybersecurity and defence.

But there is growing concern that AI companies are increasingly developing models that can easily override the safeguarding systems of banks and financial centres.

This summer has seen OpenAI, Anthropic and Meta all reveal their AI tools doing things they should not, with some AI agents going so far as to impersonate real people in order to get past security hurdles.

The FSB which Bailey leads is a global watchdog which monitors finance ministry officials, banks and securities regulators. It includes officials from the US, UK, France, Germany, Canada, Japan, Australia, China and Saudi Arabia.

Government close to greenlighting controversial North Sea gas field

The UK government is set to give the go-ahead for a controversial new gas field off the coast of Aberdeen.

Approval for the Jackdaw project could come as soon as mid-September, just before Parliament breaks for party conference season, according to government and industry sources.

The gas field was approved by the former Conservative government in 2022 but was delayed by a legal ruling from a Scottish court, after environmental groups successfully argued that consent was given without fully considering the climate impact.

Jackdaw's owner says it will provide gas to supply up to 6% of the

UK's demand at peak production, but environmental groups say it will only supply 2%.

Campaigners launched legal challenges after Jackdaw was approved in 2022 and when the Rosebank oil field off Shetland was given the green light in 2023.

climate assessments

The Court of Session in Edinburgh ruled last year that Rosebank and Jackdaw had been unlawfully approved because the government had failed to take into account the climate impact of burning extracted oil and gas from the sites.

A judge ruled that more detailed climate assessments had to be

published, and these updated estimates were put out for consultation in July.

Both Jackdaw and Rosebank are operated by Adura, a joint venture between energy giants Shell and Nor-

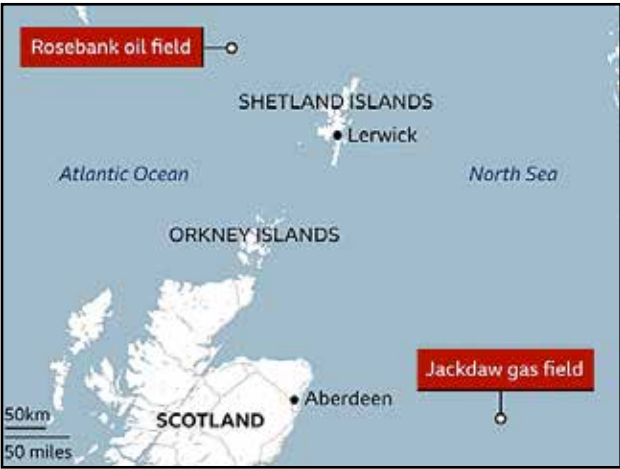
way's Equinor. Aberdeen-based firm Ithaca also owns 20% of Rosebank.

It has estimated that Jackdaw could produce 35.8m tonnes of carbon over its 11-year lifetime, the equivalent of 90%

of Scotland's emissions for 2023. Adura said a more likely estimate was about 23.6m tonnes - equivalent to 60% of the 2023 figure.

Environmentalists insist that more drilling

would be unconscionable, hampering efforts to cut planet-warming carbon emissions as deadly heatwaves and extreme weather affect billions across the globe.

jobs boost

They also say starting production would not protect energy security and that transitioning sooner to greener technologies would be better for supporting jobs.

But industry bodies argue that starting production at the sites would provide much-needed

jobs and improve the UK's energy security as overseas conflicts threaten supply.

Advocates of the project also told the BBC that Jackdaw's output is critical to extending the life of other North Sea infrastructure including Shearwater - a large offshore oil and gas production hub that processes hydrocarbons before piping them to coastal refineries and terminals.

Adura said that if approval comes in September, the field could start delivering gas to UK homes by this winter as the construction is "99% complete".

Volunteer banned from cleaning graves over 'health and safety' fears

Ben McGregor says the local South Tyneside authority has threatened him with legal action, despite praise from local families

A council has threatened a Good Samaritan with legal action for voluntarily cleaning neglected gravestones.

Ben McGregor, 25, who lost his father and best friend to suicide, voluntarily washes headstones in order to "do his bit for the community".

Mr McGregor manages his cleaning requests through a Facebook page, and said he always ensures he has the permission of the grave owners before embarking on any project.

South Tyneside Council ordered him to stop after it was "made aware" that graves in

Hebburn were being cleaned "without authorisation".

The council added that it would be "inappropriate" to allow memorials to be cleaned "in areas where safety checks have not taken place".

Safety, risk, insurance and liability checks needed to be carried out

before Mr McGregor could continue his cleaning, it said.

Quoted in the Daily Mail, Mr. McGregor said: "I was sitting on my dad's bench in the graveyard and I couldn't help but notice what a state it was in.

"I thought to myself, why not do something

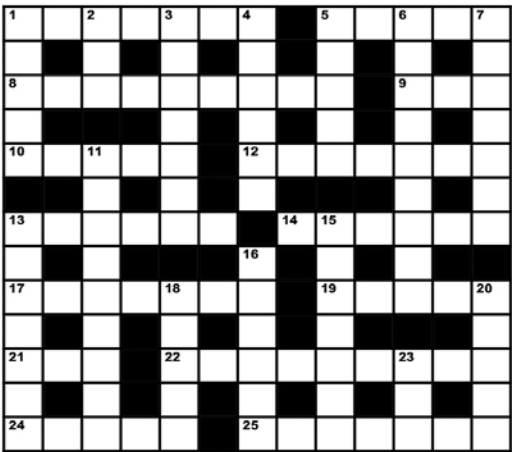
about it? I lost my dad to suicide in 2012, and my best mate also took his own life five years ago.

"I have suffered with my own mental health. If I am helping other people it helps me."

He said the council's letter "has blown my mind" and added it was "doing my head in".

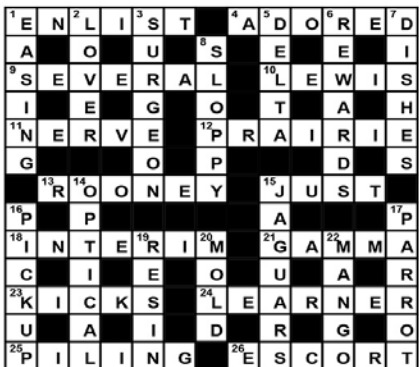

The Met Office claimed that the recent heat was

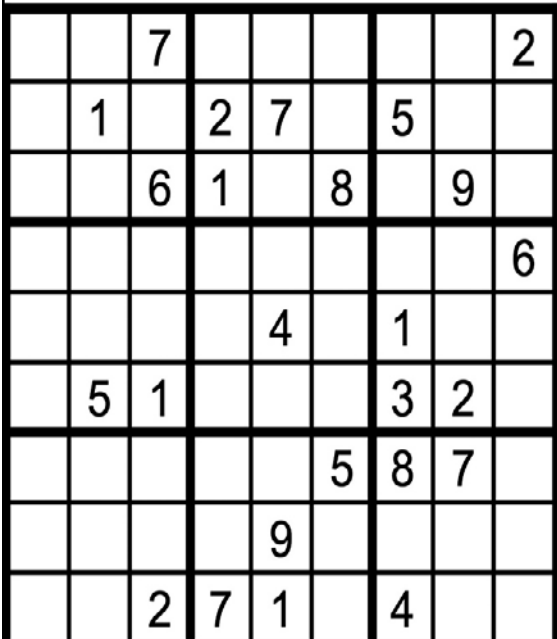
made 130 times more likely because of human-induced climate change.

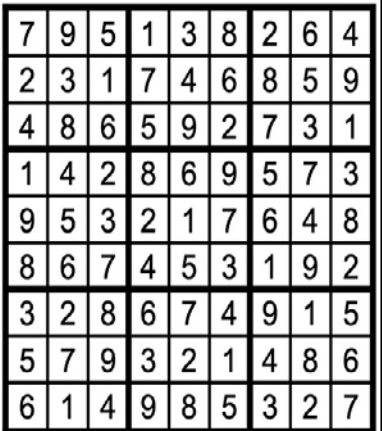
and vulnerable people that this summer was the UK's hottest.

Notting Hill carnival sees hundreds of arrests - but passes mainly in peace

POLICE arrested hundreds of revellers during the Notting Hill carnival – as it marked its 60th year at the weekend.

Hundreds of thousands packed the streets of West London each day of the bank holiday to enjoy the three-day celebration of Caribbean culture.

The Metropolitan Police said the mood on Family Day Sunday was very friendly despite 243 arrests. Further arrests were made on Monday.

The force said: “While officers responded to a number of incidents as would be anticipated at an event of this scale, the mood has been over-

whelmingly positive and celebratory.”

Notting Hill Carnival attracts around two million revellers during the bank holiday weekend for a street party, which includes glittering dance troupes, steel bands and blaring sound systems.

The Met and festival organizers have improved safety and security at the carnival, after it gained a reputation for violence and drug use.

In 2025, the Met made more than 500 arrests in the carnival’s two main days. The previous year, eight people were stabbed, including 32-year-old mother Cher Maximen, who died.

Bayeux tapestry loan symbolises ‘entente amicale’ between France and UK, says King Charles

The loan of the Bayeux tapestry was “the best possible symbol” of the “entente amicale” between France and the UK, King Charles said on Wednesday, as he visited the famous embroidered masterpiece at the British Museum in London.

Though the tapestry recounts a conflict, “here it is today, nearly 1,000 years later, as a precious symbol of trust, at a time when trust seems sadly to be in short supply between nations,” he said.

The “70 metres of memory and artistry” were a reminder “that our two nations have been bound together for almost a millennium”, added Charles, speaking at the new exhibition and accompanied by the French president, Emmanuel Macron and UK prime minister, Andy Burnham.

In a speech partly delivered in French, he said: “We have defended our values together in times of peril; we continue to do so today across the world.”

He continued: “May this tapestry – and the treasures that will travel in return – stand as symbols not only of our shared past, but our shared future: a future

woven, as it should be, by Britain and France together.”

Macron, also speaking in French and English, said that the return of the tapestry “had required a little patience”, since he first spoke of it in 2018.

“Since the first British request dates back to 1931, I choose to regard eight years as something of a speed record,” he said.

He added that, with the tapestry in Britain, his hopes were that the two countries could “forge a bond as close as the threads of this thousand-year-old embroidery”.

The tapestry – the embroidered record of the

Norman conquest – has returned to the UK for the first time in almost 1,000 years, and is on loan until September 2027 as part of a special trilateral agreement between the UK, France and the museum.

Charles’s reference to entente amicale followed his use of the phrase to rebrand the famous “entente cordiale” between the two nations in his banquet speech at Windsor Castle when he hosted the Macrons in July last year.

During Wednesday’s visit, he expressed his “deepest appreciation” to Macron and the French people “for the trust you have placed in the United

Kingdom by agreeing to this unprecedented loan”.

He said: “It once depicted warriors crossing the Channel; yet today it forms part of a cultural exchange that will see some of the British Museum’s own precious artefacts travel to France in return, in a spirit of friendship.”

Thanking all those who made the loan possible, he added: “Anyone studying the tapestry’s scenes in detail will notice that, even in the 11th century, historic events rarely happened without extensive discussion, careful planning and a great deal of organisation beforehand.”

Spurs manager Roberto de Zerbi said last week the Brazil forward (above) had asked to leave the club and he looked close to joining former club Everton before Tuesday's transfer deadline, but a deal fell through. The 29-year-old has now been left out of the club's squad to play in top-flight games for the first half of the season.

It is understood Richarlison does not feature in Tottenham's plans this season, which was explained to the player before Tuesday's deadline. He is expected to leave the club in the coming days, with the transfer windows in Turkey and Saudi Arabia still open.

Richarlison joined Tottenham from Everton in the summer of 2022, having joined the Toffees from Watford in 2018.

He has entered the final year of his contract at the London club and, while he started Tottenham's defeat by Brentford in their opening game of the Premier League season, he was not included in De Zerbi's squad when Spurs lost 2-0 at home to Newcastle United on Saturday.

After the game, De Zerbi said: "Richarlison, I don't know. He said too many times he wants to leave."

Earlier in August, the Spurs boss said that the Brazilian was uncertain about his future, noting that "it's not easy to find another striker like Richarlison".

However, Spurs recently signed Manchester City striker Omar Marmoush on loan and he replaced Richarlison against Newcastle.

Barcola deal easy as 1-2-3 million

■ Despite splashing out a net £219m, Iraola says Liverpool won't pay 'crazy money' for short-term fixes

LIVERPOOL have completed the £123m signing of Bradley Barcola from Paris Saint-Germain this week...but manager Andoni Iraola found himself defending the club's summer transfer strategy and said the club were right not to pay "crazy money" for short-term fixes.

Barcola had become a main target for the Reds as they look to bolster their attack following the departures of Luis Diaz and Mohamed Salah in the past two summers.

He moved to PSG from Lyon in 2023 for a reported £38.5m and has won three Ligue 1 titles, two Champions Leagues, the French Cup twice, as well as the Uefa Super Cup and the Fifa Intercontinental Cup.

The fee agreed between the two clubs in-

cludes covering a solidarity payment PSG owe Lyon as part of the deal that took Barcola to Paris three years ago.

Barcola, who scored three goals for France in this summer's World Cup, can also play on the right or through the middle and could provide cover for Alexander Isak while Hugo Ekitike recovers from a serious Achilles injury.

Liverpool had the highest net spend in the Premier League this summer, with Barcola the biggest chunk of their £219m outlay, but contrary to the wishes of many fans, they did not sign a right-back, defensive midfielder or right-winger but Iraola, who believes Barcola could be deployed in Mohamed Salah's old position on the right, insisted he had no qualms

with the squad at his disposal.

"I'm very happy with all the signings we've made," he said. "I know the next question: 'Do you want more signings in other positions?' At the end the club has decided those signings we have done are the ones that improved our team and our position.

"There were other options we decided not to take, for different reasons: sometimes it is sporting reasons because they don't improve what you have, sometimes it is economical reasons as it didn't make sense in terms of the market to do those movements. But I'm happy now I know what we have, I have a lot of quality in the team and now it is the moment for us, for the players, for me to develop what we

have."

Leoni has been sidelined with an anterior cruciate ligament injury since last September but is expected to resume first-team training during the international break, which starts this month.

There is no date on Bradley's and Ekitike's return from serious knee and achilles injuries respectively, but Iraola said the club had to plan for the long term and wait for all three to recover.

Iraola said: "The club

has decided not to sign someone because we need them for these two or three months and instead trust the players we have, us working with the players we have and thinking of the long term."

Enzo seals £125m City move

"I always dreamed of being at a club as big as City," says controversial Argentine midfielder

Enzo Fernández has said he had always dreamed of playing for "a club as big as Manchester City" in his first interview since completing his big-money transfer from Chelsea.

The Argentina midfielder left Stamford Bridge to join City in a British record-equalling £125 million (\$169m) deal late on deadline day.

Fernández won the Club World Cup and the UEFA Conference League during his time in London but suggested he can go on to greater glories with City.

"I'm really happy to be here. I always dreamed of being at a club as big as City," the World Cup winner told the club's website.

"I'm grateful for the opportunity. It's a very

emotional moment for me and my family, to take this step at 25 years old, in a football career that I always dreamed of.

"I'm so happy to be here, enjoying these first few hours I've had at the club. I can already see just how big it is and we will enjoy ourselves and win

Chelsea had set their own deadline of Aug. 14 for clubs make offers for Fernández but that passed and City only firmed up their interest late in the transfer window.
