UK levies sanctions on Israeli settlements

[The UK has announced sanctions on illegal Israeli settlements in the occupied West Bank, accusing Israel's government of turning a blind eye to the "ethnic cleansing" of Palestinians by settlers.

Foreign Secretary Ed Miliband said the move marked the "beginning of a new approach" to the Israeli-Palestinian conflict, which "not only calls out injustice and suffering but acts".

Israel's Foreign Minister Gideon Saar responded by accusing him of spreading an "outrageous lie" and announced counter-measures including shutting the UK's consulate in East Jerusalem.

The UK sanctions will ban settlement goods but also act against companies and individuals providing services for settlement expansion.

The sanctions were launched alongside France and Canada, which in a joint statement with the UK said the action "marks a further turning point in our approach to protecting the two-state solution".

Settlements are illegal under international law, and there has been a rise in violence towards Palestinians in the West Bank by settlers in recent months.

In a statement to MPs, Miliband said: "The British government agrees that there is ethnic

BAYEUX FEVER SWEEPS LONDON!

■ Thousands scramble for tickets as 1,000-year-old tapestry goes on display
■ Iconic 70-metre embroidery depicts 1066 Norman invasion of William the Conqueror

Frenzied history lovers are flocking to central London this month as 'Bayeux Mania' grips the nation.

Excited visitors couldn't hide their delight as the British Museum opened its doors to a sell-out blockbuster exhibition showcasing the world-famous Bayeux Tapestry- on loan from France for the very first time since the 11th century.

The 1,000-year-old masterpiece, which dramatically depicts the 1066 Battle of Hastings and the iconic defeat of Anglo-Saxon King Harold II, has triggered full-blown tapestry fever across Britain.

Crowds

Desperate art lovers have been frantically discussing online how to snag coveted tickets, national newspapers are printing souvenir pull-outs, and a pub directly opposite the museum has even tem-

porarily renamed itself "The Beer Tapestry" to join in the buzz.

Inside the grand halls, museum staff got into the spirit by donning full medieval battle gear- complete with helmets, shields, and swords - to welcome the breathless crowds.

'just magical'

Due to the huge demand, visitors are being given 40 minutes on a custom elevated platform to soak in the stunning 70-metre-long masterpiece before stepping down to admire the painstaking detail of the stitching up close.

"It's just magical, isn't it?" gushed Pauline Gairey, 53, a finance professional who travelled all the way from Wales after fondly remembering the tapestry from her

school days.

Solicitor Richard Samuel, 60, was equally stunned as he emerged from the exhibition: "It's amazing that the colour is still so vivid... it's amazing it's survived so well and so long."

Meanwhile, 56-year-old Charmaine Tsia, a customer service manager visiting from Australia, marvelled at "the length of it and just the incredible detail."

Believed to have been hand-stitched by

English seamstresses before being whisked away to France centuries ago, the spectacular artwork holds a deep connection to the British monarchy.

Just last week, King Charles III himself enjoyed an exclusive preview alongside French President Emmanuel Macron to celebrate the masterpiece depicting the conquest by his ancient ancestor, William I.

The historic 10-month loan comes

as the tapestry's usual home in northern France undergoes major refurbishments. In a historic swap, French museums will display England's priceless 7th-century Sutton Hoo collection of Anglo-Saxon treasures, including ancient helmets, shields, and metalwork.

The initial ticket sales sold out within minutes of being available, with another tranche of tickets available next month.

Dover Chaos: No. 10 blasts “thuggish and intimidating behaviour” at port

Downing Street has condemned the “thuggish and intimidating behaviour” of far-right activists who blocked roads in Portsmouth this week when a boat carrying asylum seekers arrived in the city, two days after similar scenes in Dover.

Hundreds of men, some dressed in black and wearing balaclavas, tried to stop the arrivals from being transported for processing until 3am, when police removed them with threats of arrest.

Hampshire police said later that a number of police, coastguard and Border Force vehicles had been damaged, and a few officers had suffered minor injuries. It said the force was investigating possible offences of assaults on officers and criminal damage.

The crowd was seemingly organised by Daniel Thomas, a far-right agitator closely linked to Tommy Robinson, the longtime anti-Islam and far-right figure whose real name is Stephen Yaxley-Lennon.

Thomas was also behind the scenes in Dover on Saturday,

when crowds of people dressed in black and wearing balaclavas blocked the road around the port.

Andy Burnham’s official spokesperson said: “The intimidating and thuggish behaviour we saw over the weekend in Dover and Portsmouth is absolutely unacceptable. We condemn it unreservedly. We’ll always respect the right to peaceful protest but not where it crosses the line into disorder.”

‘poison’

On Monday night, Burnham said Labour had a “solemn responsibility” to stop the “politics of poison seeping into our streets”.

Speaking to the parliamentary Labour party at a closed-door meeting in Westminster, the prime minister said there was “a lot at stake” and that the party must “counter fear with positivity and hope”.

Thomas, who uses the name Danny Tommo on social media, was recorded telling the crowd that Portsmouth was “now ground zero” for the arrival of asylum seekers on boats from

France, saying “enough is enough” and “Dover was a dummy run”.

Home Secretary Shabana Mahmood has told police chiefs that lessons must be learned from how they handled last weekend’s anti-migrant protests in Dover and Portsmouth - saying she expects officers to use all powers necessary.

In a meeting on Thursday she asked for reassurance that plans were in place for the police to move quickly and effectively in dealing with far-right groups seeking to intimidate communities.

It comes after masked activists brought Dover to a standstill on Saturday and in a protest on Sunday in Portsmouth about 200 people tried

to block migrants being driven away for processing.

Reform facing Met probe over foreign financing

The Metropolitan Police is carrying out a criminal investigation into Reform UK over allegations it broke foreign funding laws, following a broadcast by Channel 4 News last week.

An undercover reporter recorded two senior

Reform aides apparently suggesting a way around electoral law to secure foreign party donations, one of which would have totalled £500,000.

The police investigation by the Met’s Special Enquiry Team is being folded into an inquiry that has

been under way into other donations to the party.

A Reform UK spokesman said the party “denies any wrongdoing and will fully cooperate with the investigation”.

“We won’t be commenting further while a

live investigation is under way."

A Met spokesperson said it had received "a number of reports relating to donations and polling involving a political party", after the film by Channel 4 News and Verbatim Investigations was shown on Thursday evening.

In its statement, the Met Police said: "All allegations under investigation relate to potential offences under the Political Parties, Elections and Referendums Act 2000."

"Detectives continue to liaise closely with the Electoral Commission and Crown Prosecution Service as enquiries progress."

footage

The police spokesperson said detectives were seeking to obtain footage relating to the broadcast.

The film overshadowed the party's conference in Birmingham and led to the party losing two key figures - Dan Jukes, chief of staff to the leader Nigel Farage, and James Orr, head of policy.

In the news report, an undercover investigator posing as the son of an American donor is recorded raising a concern that his father wouldn't be able to directly donate to the party within the law.

Electoral law states that to be a permissible donor to a UK political party you must be a UK registered voter, or a company registered in the UK.

Jukes appears to suggest that the donation could be in the UK-based son's name, although the money would have come from his American father.

Elsewhere, James Orr, the party's head of policy suggests that the father could pay for opinion polling to support one of Reform's cam-

paigns.

Farage and Jukes were also filmed at a lunch in Clacton where it is suggested the US donor, who was being played by an actor, gives £500,000 to Reform through his son.

'loose pub talk'

Farage told reporters he "frankly wasn't listening" to the discussion about the potential donation. Channel 4 News has said the payment was never made.

He dismissed the comments made by his aide in the film as "loose pub talk including a couple of boasts that simply were not true".

Jukes has denied "any wrongdoing" and said he had "stepped back from politics in order to clear my name".

Last week, Orr told Sky News he would cooperate with the party's internal investigation "fully".

The Met had already been investigating whether payments to Reform in the weeks before the last election complied with donation laws.

The probe is examining donations given directly to the party by Fiona Cottrell, mother of longstanding Nigel Farage ally, George Cottrell.

It is also examining payments from a company controlled by Reform's deputy leader Richard Tice, which received £1m from Fiona Cottrell in June 2024.

Labour Party Chair Bridget Phillipson said: "Farage needs to wake up and realize the buck stops with him."

"Reform's failure to take responsibility for their actions shows just how unfit they are for office."

The Liberal Democrat's Cabinet Office spokeswoman Lisa Smart said: "Every Reform MP urgently needs to state whether they or their campaigns have benefited from any foreign money."

cleansing of Palestinians in areas of the West Bank, perpetrated by settler terrorists.

"And all too often the Israeli government has turned a blind eye to this and worse, members of it have made statements and taken actions to support the forced displacement of Palestinians."

He said ethnic cleansing was defined by the UN as a "purposeful policy designed by one ethnic or religious group to remove by violent means another ethnic or religious group from certain areas".

'two-state solution'

Miliband said the official view of the government was that the Israeli occupation of the West Bank was unlawful because of the "entrenchment of its control, its intention to extend permanent sovereignty, and its expansionist agenda via illegal settlements".

He said this position, which is in line with a 2024 advisory opinion from the International Court of Justice, should be reflected in the UK's "economic relationship" with the occupied West Bank.

As a result, over the next six to nine months, the UK will introduce "a new comprehensive sanctions regime", he said.

The foreign secretary also announced a ban on advertising illegal West

Bank settlements in the UK.

"The sanctions regime will target illegal settlements and settlement expansion, not Israel," Miliband added.

Later on Tuesday, Prime Minister Andy Burnham said the targeted measures were "aimed not at the Israeli people, but in support of the two-state solution".

Announcing the closure of the consulate - which represents the UK government in Jerusalem, the West Bank and Gaza - Israel's Foreign Minister Saar said at a press conference: "We know that we have many friends in Britain."

"Unfortunately, we have a hostile Labour government that is consistently operating against the State of Israel, and it has left us no choice but to respond to its hostile

actions."

He added that 11 UK MPs, including Jeremy Corbyn, Diane Abbott and all five sitting Green Party MPs, would be banned from entering Israel, accusing them of "antisemitic and anti-Israel activity".

The UK also issued a joint statement with 11 other countries; France, Canada, Denmark, Spain, Finland, Ireland, Iceland, Norway, Poland, Portugal and Sweden.

It said the group was unequivocally committed to the two-state solution and would introduce national measures or support European restrictions on trading goods with West Bank settlements.

The UK announcement comes after Israel opened up tenders for the construction of some 1,200 settlement homes in the so-called E1 area - a strate-

gically important area east of Jerusalem. The plans have drawn widespread international condemnation. Israel has held off on plans to build in the area for decades under global pressure.

Miliband told the Commons the UK's "new approach" was necessary because plans for the E1 development in the West Bank would render a two-state solution "unviable" by "cutting through the heart of Palestine".

Elsewhere, he said the Hamas-led attack on southern Israel on 7 October 2023, which triggered the Gaza war, carried "terrible echoes of the centuries of persecution of the Jewish people" and stressed Israel had "the right to protect its people and defend its territory".

However, he added, "that cannot justify what has happened in Gaza".

Burnham thrown under the bus as iconic vehicle maker sheds jobs

ANDY Burnham was accused of "sacrificing British jobs" as Jaguar Land Rover this week confirmed it was axing 4,000 roles.

The majority of cuts will hit UK staff. JLR employs 34,000 workers at sites in the West Midlands and Merseyside.

Tories blamed gov-

ernment rules banning the sale of new petrol and diesel vehicles from 2030, and hybrids from 2035.

Carmakers must also ensure a third of new car sales are electric under the Zero Emission Vehicles Mandate, but have struggled to convince motorists to switch.

JLR is further reeling from the impact of a five-week cyber attack shutdown last year, which has been blamed on Russia.

Pub tapestry
no small beer

IN POSSIBLY the most British news of the year so far, just a stone's throw away from where the Bayeux Tapestry is on show in central London, an homage of a similar kind is going on display.

The eight-metre-long Beer Tapestry depicts another important moment in UK history, the development of the nation's beloved drink.

The masterwork was unveiled at The Museum Tavern, a stone's throw from the British Museum, and like the Bayeux Tapestry, the Beer Tapestry opens in 1066...only this version shows William the Conqueror toasting his success with a foaming flagon of ale.

The tapestry goes on to show a history of beer through the ages, from depicting hops arriving in English ports from the Low Countries before moving on to show British naval ships during Napoleonic times and the beer rations with which their victorious sailors were rewarded, continuing on to the Second World War where the women took charge of the brewing whilst the men were at war. The story ends with a depiction of a modern British brewery.

Jack Palmer, Head Brewer at Greene King Brewers, told the Press Association that the Beer Tapestry had been created as a 'fun way to help people celebrate the heritage of the Bayeux Tapestry, and maybe teach people a bit about the history of beer as well.'

There's been a pub on the site since 1723 when the Dog and Duck first opened its doors, renaming itself the Museum Tavern in 1759. With this new wheeze, profits can surely only grow....lager.

Royal couple 'surprised' by Charles letter

King pre-empts 'misunderstandings' by underlining Harry and Meg's non-royal status

A spokesperson for the Duke and Duchess of Sussex says the couple were surprised to see a letter sent on behalf of King Charles clarifying that Prince Harry and Meghan remained non-working royals.

The spokesperson said the couple, who have recently moved back to the UK, "were a little surprised not to have been told about this in advance".

But royal sources say Prince Harry and Meghan were made aware of the letter, sent on Monday afternoon, before it was made public.

It is also understood a security committee, which includes Home Office representatives, is meeting this week to look at the level of taxpayer-funded security that should be given to the Sussexes who are now resident in the UK.

The Royal and VIP Executive Committee - known as Ravec - decides security for roy-

als and public figures and Prince Harry has previously complained about a lack of adequate police protection in the UK.

The Home Office does not comment on such decision making - and would be unlikely to reveal the outcome of such a meeting.

"The UK government's protective security system is rigorous and proportionate. It is our long-standing policy not to provide detailed information on those arrangements, as doing so could compromise their integrity and affect individuals' security," said a Home Office spokesperson.

private capacity

In terms of Prince Harry and Meghan being "surprised" by the King's message on Monday - it's understood that reflects the lack of time given to them to respond.

The letter, sent on behalf of the King, spelt out the non-working

royal status of Prince Harry and Meghan, who moved back from California with children Archie and Lilibet last month.

They will still not be able to use titles of "His and Her Royal Highness", and remain "private citizens", says the letter sent on behalf of the King by the Lord Chamberlain, a top Palace official.

The letter was sent to Prince Harry's team, government departments, military officials and Lord Lieutenants,

according to Palace sources.

Lord Lieutenants, who are the monarch's local representatives, and government staff are often involved in royal visits and engagements.

This letter makes clear that any engagements carried out by the Sussexes will be in a private capacity and they will not be representing the Royal Family.

It seems to be something of a shot across the bows, making clear

that any Prince Harry and Meghan visits should not be treated as royal engagements.

The message from the King emphasizes that the position agreed in 2020 when the Sussexes left the UK - the so-called Sandringham Agreement - is still in place.

This ruled out any "half-in and half-out" status, so Harry and Meghan could not pursue their own commercial interests while continuing to be working royals.

Rantzen ‘too fragile’ to travel abroad to end her own life

Dame Esther Rantzen has said she is now “too physically fragile” to travel to Switzerland to end her life at an assisted suicide clinic.

The veteran broadcaster, 86, said she would have to fly to the country, where the practice is legal, alone, which she could only have done before her life became “unbearable” and before she was ready to end her life.

The Childline founder, who is terminally ill with cancer, first revealed in December 2023 that she had joined the Dignitas clinic.

Dame Esther used her statement on Thursday to reiterate a plea for MPs to vote in favour of legalizing assisted dying in England and Wales when proposed legislation is revisited by Parliament on Friday.

She announced she had joined Dignitas

about a year after being diagnosed with stage four lung cancer.

“Unfortunately, when I was strong enough to make the flight and go to Dignitas, my life was not unbearably painful, indeed I was able to relax in my beloved cottage in the New Forest,” she said.

“And by the time life did become unbearable, I was too physically fragile to make the journey and go through the Dignitas process.

“So even though I had spent the money and made the plans, I was not ready to end my life back then, and did not realise that would be my last chance.”

Dame Esther added that “everything I didn’t want to happen I’m having to go through now”, with loved ones either unable to visit her or “see me suffering pain or indignity” when they

do.

The prominent assisted dying campaigner said the law - which she described as “messy and cruel” - must “change and change quickly”.

Helping someone end their life is currently considered a criminal offence across England, Scotland, Wales and Northern Ireland. Jersey legalized assisted dying for terminally ill adults earlier this year.

MPs are considering a draft law that, if passed, would make it legal in England and Wales under specific circumstances for people who are terminally ill with less than six months to live.

While Dame Esther, who is best known for presenting the BBC programme *That’s Life!* for 21 years, is among several leading figures in favour of the bill, there are also campaigners against it, including

Paralympian Baroness Grey-Thompson.

They fear that a change in the law could mean that disabled and other vulnerable people could be pressured to end their lives, while also criticising the wording of the proposed legislation as not providing strong enough safeguards.

The bill has been through several drafts and has been scrutinised by several Parliamentary committees and the House of Lords, which submitted 1,200 amendments.

The bill was previously introduced in 2024, but the last session of Parliament ran out of time before it was passed.

Former F1 boss pinched in Portugal

Billionaire ex-F1 boss Bernie Ecclestone has reportedly been arrested at a Portuguese aerodrome for illegally carrying a shotgun.

The 95-year-old is said to have been held at Tires Aerodrome in the municipality of Cascais close to Lisbon after landing there in his private jet.

Airport police belonging to Portugal’s PSP force are understood to have made the arrest during a “routine operation”.

The weapon Ecclestone was allegedly carrying was described locally as a shotgun.

Ecclestone admitted he had travelled with the gun without the correct documentation and was held up for hours.

His Brazilian wife, Fabiana Flosi, 49, is now trying to rectify the situation.

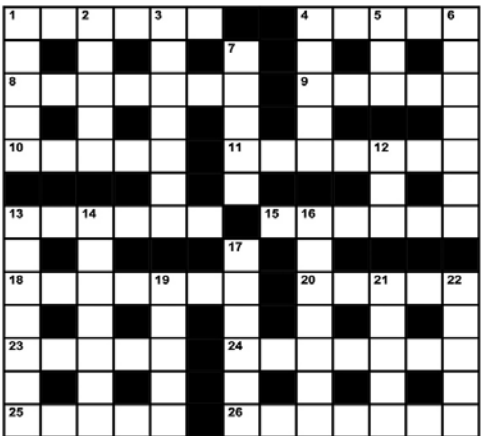
Ecclestone told reporters: “I had a gun that I was bringing over from Switzerland to Portugal for clay-pigeon shooting.

“It’s as simple as that. I have guns at home there that are licensed.

“We cleared customs on arriving here – I know the guys there – and they were fine with everything. No problems.”

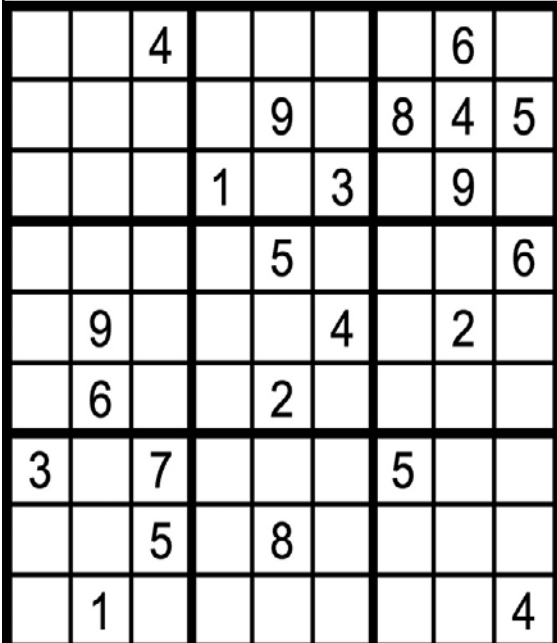

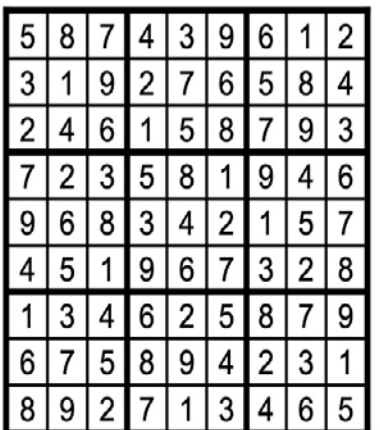

Harry Potter creator's mega yacht apparates into Marina Del Rey

■ \$150m gin palace docks for minor local repairs

There are plenty of monstrous boats in Marina del Rey. But when a 290-foot, \$150 million superyacht arrives with its name covered, people tend to notice.

That's what happened this week when Samsara, the luxury yacht reportedly owned by Harry Potter author J.K. Rowling, pulled into the Los Angeles harbor. The vessel's identifying name was concealed, but the disguise didn't last long. Locals and boat-watchers quickly identified the yacht, built by Dutch luxury boatbuilders Oceanco, with one marina resident reportedly calling it "the worst-kept secret on the marina".

Built in the Nether-

lands and delivered in 2015, the 290-foot yacht was originally named Infinity and commissioned for Harbor Freight founder Eric Smidt. After a subsequent stint with Australian billionaire Brett Blundy, it reportedly changed hands again in 2023, when Rowling acquired it and renamed it Samsara - a Sanskrit term associated with the cycle of birth, death and rebirth.

'beach club'

And this is no ordinary floating condo. Samsara reportedly accommodates 14 guests and roughly 26 crew, with seven guest cabins, a five-meter circular swimming pool, cinema, gym, Jacuzzi, massage room,

elevator and a "tranquil beach club."

There's also a 69-meter support vessel carrying additional equipment and toys, plus a helicopter hangar, diving center, workshop and medical facilities.

The yacht's Marina del Rey appearance has also reignited attention around Rowling's long-running controversy over transgender rights and gender identity. Rowling has repeatedly defended her views on sex-based rights and single-sex spaces, while LGBTQ+ advocates and critics have accused her of promoting anti-trans views. Rowling says she supports the safety and rights of transgender people while opposing policies she believes compromise women's sex-based rights.

Commenters on social media sounded off on the boat's sight-

ing and the author's outspoken comments on the LGBTQ+ community. Others simply commented on her wealth. Her estimated net worth is somewhere in the \$1.2 billion ballpark.

"All for writing some kooky children's book series," wrote one in-no-way-envious commenter. "Capitalism pays."

According to reports, Samsara's name was covered because the yacht "often attracts protesters."

Rowling has not publicly confirmed that explanation, and she has not commented on her upcoming Marina del Rey visit.

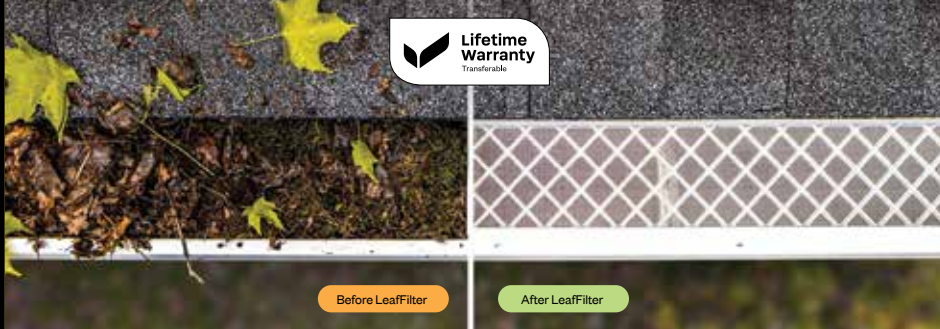

Haaland downs Porto

Erling Haaland scored twice as Manchester City began their Champions League campaign with a comfortable victory against Porto on Tuesday.

Norway star Haaland scored the only goal against Coventry on Saturday and was the match winner once more, nestling a header into the far corner and rolling home another to take his tally to 36 Champions League goals for City in only 40 appearances.

City have been knocked out by Real Madrid in each of the past three season but their return to Lisbon's Estadio do Dragao - where they lost the 2021 final against Chelsea - was a much more pleasurable experience.

Enzo Maresca's side have started the Premier League season with three straight victories and they controlled this contest, with an impressive showing by teenager Ayyoub Bouaddi's on his first start for City.

Porto goalkeeper Diogo Costa had an inspired first half, twice denying Haaland with superb reflex saves, while also keeping out efforts from Antoine Semenyo and Phil Foden.

Francesco Farioli's side have won all five league games so far this season but were left frustrated at home and often showed how tough a task they have in Europe, failing to manage a single shot in the opening 45 minutes.

Though Alan Varela curled narrowly wide after his side fell behind to Haaland's opener and William Gomes also screwed off target, they ended the contest without being able to call Gianluigi Donnarumma into action.

The result means 2004 champions Porto have won only two of their past 17 games against English teams in European competition, while City will be aiming to lift the trophy for the first time since their Treble-winning campaign in 2023.

Odegaard oh-so-good

Martin Odegaard's excellent start to the season continued as the Arsenal captain came to his side's rescue against Napoli in Naples on Wednesday.

The Gunners were guilty of wasteful finishing and were heading for a frustrating draw in their first game in the Champions League since losing last season's final in agonising fashion.

However, Odegaard had Arsenal's 1,500 travelling fans celebrating after a fine finish from outside the box - the captain's fourth goal in five games, including the Community Shield.

Piero Hincapie dropped to his knees after the full-time whistle and thumped the ground with his hands in relief at the result.

Arsenal won all eight group phase games on their way to last season's final, and they are up and running after a fine win in Italy.

Mikel Arteta's side had missed three great chances to punish last season's Serie A runners-up before Odegaard's winner.

There were 29 passes in the build-up to Arsenal's winner, their second-most on record (since 2003-04) for a Champions League goal (33 for Lucas Perez's second at Basel in December 2016).

Mikel Merino was presented with a glorious chance to mark his first

club start since January but the Spain midfielder headed straight at goalkeeper Alex Meret midway through the first half.

Then Bukayo Saka looked set to break the deadlock only to lift his attempt over the bar before Hincapie blazed over from inside the six-yard area.

The Gunners did endure a couple of scares most notably when David Raya spilled a shot from outside the box by Kevin de Bruyne, but Ben White was quickest to react and clear the ball before the home side could pounce.

Happy Returns for United

■ Carrick's men sweep Azerbaijani champs aside on breezy return to Champions League

Manchester United enjoyed a breezy return to the Champions League, brushing aside Sabah FK 4-0 on Thursday at Old Trafford.

It was the Red Devils' biggest Champions League victory since 2020 and although the Azerbaijani champions came through four rounds of qualifying to reach the main league phase of the tournament for the first time and had their chances, they were also given a brutal lesson in the gulf in class between the level they are used to and the Premier League, whose five entrants have all opened their respective campaigns by picking up three points.

With just three days to prepare for Sunday's Manchester derby, United head coach Michael Carrick would have been pleased to effectively kill the contest by half-time, thanks to goals from Matheus Cunha, Bruno Fernandes and Benjamin Sesko.

For Sesko in particular, it was an important night. Starting for the first time since 3 May, the Slovenian brought a focus to United's attack which has not been evident for their opening three Premier League games.

It surely puts him in contention to start against Manchester City, which begs the question who will be on the left - Cunha or Marcus Rashford, who remained on the bench throughout.

The conundrum is one Carrick will relish because, while he said at Everton on Sunday that United's start to the season had "not been that bad", he also knows four points from three games cannot become four from four.

As far as the Champions League goes, United could not have asked for more accommodating opponents after more than a thousand days out of the competition.

With trips to Atletico Madrid, Como and Sporting Lisbon ahead, plus home games with Roma and Bayern Munich, victory was important to ensure there was no early ground to make up, as is now the case in the Premier League.

Cunha opened the

scoring after good work down the left by Patrick Dorgu, before Bruno Fernandes doubled the lead after Yuri Tielmans had danced through the Sabah defence and squared it for an easy finish.

Sesko got in on the act on the stroke of half time, beating the offside trip from just inside his own half thanks to a perfectly timed pass from Bryan Mbeumo.

Lisandro Martinez rounded off the scoring in the 68th minute with a poacher's finish after a mixup in the Sabah back line.

But it was Sesko grabbed the headlines - and praise from manager Michael Carrick, who said of his Slovenian star later: "He definitely offers a different kind of threat... That's the beauty of it, really. We know what Ben gives us. There's not many around that kind of give you what Ben does."

Villa cast aside domestic woes

Aston Villa breathed life into their season as they edged to a narrow 3-2 Champions League victory over Club Brugge on Tuesday.

First-half goals from John McGinn, Emi Buendia and Nicolas Jackson earned the Premier League side a battling victory in Belgium.

Hugo Vetlesen had briefly hauled the hosts level after McGinn's opener, but Buendia and Jackson - with his first goal for the club - put Villa in charge.

Nicolo Tresoldi's 61st-minute penalty after Aaron Wan-Bissaka's handball left the visitors facing a nervy last 29 minutes during which Tresoldi hit the post.

But Villa held on for a result they will hope to use as a platform to build from after three successive league matches without scoring, as manager Unai Emery looks to integrate 10 new signings.

The Europa League winners have lost six of the starting XI from their triumphant night in Turkey, including £117m Morgan Rogers after his exit to Chelsea.

Skipper McGinn - their longest-serving player - who energised their season, became Villa's record European scorer in the process with his 12th goal.
