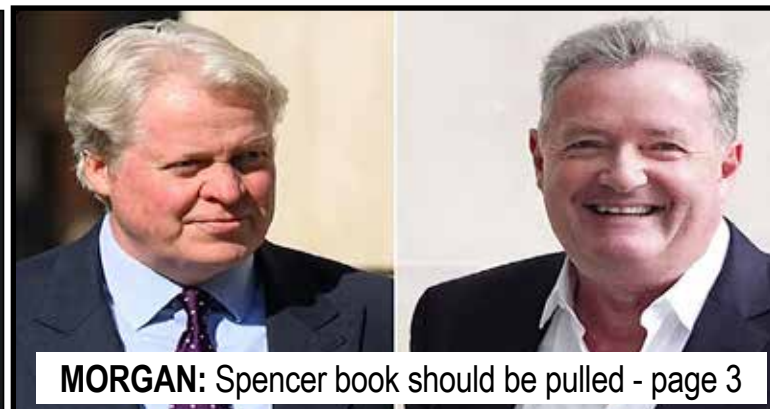

TRUMP: Burnham is 'a natural business person'

■ Prime Minister emerges almost unscathed from first meeting with US President

US President Donald Trump hailed Andy Burnham on Tuesday as a "natural business person" at what the PM's team described as a smooth first face-to-face meeting.

After days of preparation for the Trump meeting, Burnham emerged relatively unscathed, with the US leader only taking issue with what he called a "terrible deal" to cede sovereignty of the Chagos Islands, home to a US-British air base.

Otherwise, Trump praised Burnham, saying Britain's seventh prime minister in a decade was someone with whom he could do business and a patriot who had put Britain on the up after replacing the former prime minister, Keir Starmer, in July.

'doing very well'

"I think right now, based on my relationship with the prime minister, Andy, I think that ... we're doing very well," Trump said after they met on the sidelines of the United Nations General Assembly in New York for around 40 minutes.

"I think he's a natural business person. We've had a lot of discussions, even before this meeting

we were talking with each other numerous times on the phone."

Burnham, who travelled to New York on Monday to take part in the UN assembly, had said little beforehand about his expectations for the meeting with Trump, saying only that in their two phone calls he had 'found a connection' with the US president.

'very encouraging'

Afterwards, he repeated that earlier conversations had established that connection "and that very much came through today".

"(I) can certainly work with him. It was a very encouraging meeting," Burnham told reporters, saying the two leaders had found "common ground" on dealing with cost-of-living pressures, ending the conflict in the Middle East and industrialising nations to spur economic growth, among other issues.

"He was very upbeat about the country's (Britain's) prospects, which,

to be honest, was great to hear."

Before arriving in New York, Burnham had sought common ground with Trump on AI, a focus of his comments to the UN on Monday in which he described the technology as having the ability to bring "huge benefits" to the British and global economy.

Trump has said he wants to cherish AI rather than stifle its growth, dismissing fears about it as a hoax and "sick conspiracy".

The US leader has said concerns can be addressed through the existing justice system without extra regulation - an issue that might cause some friction with Britain.

'more up now'

While the two leaders seemed to find common ground on a number of issues, there were some pitfalls.

Trump again criticised Britain's move, under Starmer, to cede sovereignty of the Chagos Islands while

retaining control of Diego Garcia air base on a 99-year lease.

Burnham later told reporters he had inherited the problem and would work to find a resolution between the different sides. "It was clear that we need to come to that agreement, but I'm confident we can find it working with our US partners," he said.

Burnham also showed a willingness to disagree with Trump if it is in his nation's interest, saying he would "stand firm in the face of any threats" to the right of Falkland

Islanders to self-determination and to remain British.

In August, Trump said he was reviewing the United States' neutral position on the remote archipelago in the South Atlantic. Days later Argentine President Javier Milei — who will address the UN on Wednesday — said he would impose sanctions on oil companies drilling in the islands.

Burnham added that the UK was "still ready to play our part in the Middle East, in terms of helping you stop the con-

flict, open the Strait [of Hormuz]".

"We're with you that Iran must never be a nuclear power," he continued.

The PM spoke about what they covered in their meeting - issues on trade, the Falklands, and others.

The US president then says that relations with the UK are "more up now" than they were when Keir Starmer was prime minister.

"Based on my relations with your prime minister Andy", he says, "I think we're doing very well".

Omagh inquiry 'torture', says widowed husband of mother of four

■ Kevin Skelton accuses Irish government of 'not cooperating'

A man who lost his wife in the Omagh bombing has said he is "finished" with a public inquiry into the atrocity following the delivery of video evidence from a senior Garda officer.

Kevin Skelton accused the Irish Government of "not cooperating" with the proceedings and described watching the evidence on Thursday as "torture".

It came as a barrister said the inquiry intends to "seek answers from the Republic of Ireland" about "outstanding questions" relating to the theft of the car used in the 1998 bombing.

The hearing on Thursday was played a "sequence of events" statement from Detective Superintendent Emmet Casserly, attached to the Special Detective Unit of An Garda Síochána with responsibility for dealing with terrorism.

The inquiry was set up by the previous government to examine whether the explosion

could have been prevented by UK authorities.

"I won't be back"

Mother-of-four Philomena Skelton was 39 when she died in the attack while on a shopping trip with her husband and three daughters.

Her husband, Kevin Skelton, said he was "disappointed, but not surprised" at the contribution from police in Ireland.

He said: "We know how many questions,

there were 53 questions sent in and there was about two answered.

"They are not cooperating with the inquiry. I don't care what they say.

"The Irish Government is not co-operating, they never have."

Mr Skelton pointed out the bomb was made in the Republic of Ireland.

He said: "The south of Ireland has the questions to answer but they are not going to answer."

He added: "It would drive you nuts. I won't be back. That is it, that's me finished.

The dissident republican car bombing in Omagh on August 15 1998 killed 29 people, including a woman

who was pregnant with twins, in the worst single atrocity in the Troubles in Northern Ireland.

The Omagh Bombing Inquiry, chaired by Lord Turnbull, is holding evidential hearings in Belfast.

The latest phase of hearings, which will last for several weeks, is concentrating on the period before and after the bombing and will examine how it was carried out and who was responsible.

RAF jamming satellites of 'hostile nations' as space arms race grows

Britain's military has been jamming other nations' satellites to defend the country for the past year, it emerged this week.

The RAF has been using a ground-based system to block signals from satellites used by hostile states.

It is understood the system could also be used to prevent a hostile nation's satellites from tracking the movement of the UK's nuclear armed submarines or other sensitive military operations, such as those involving special forces.

new RAF Unit

It comes as the head of the RAF said the UK faced "unprecedented threats" from adversaries in space, coinciding with the creation of a new RAF unit set up to defend Britain's satellites.

The Ministry of Defence (MoD) said the new Space Effects

Squadron will be focused on "disrupting, degrading and denying hostile threats in space".

The squadron will protect British satellites used to warn of incoming missile attacks, provide communications and help guide ships, the MoD said.

'under threat'

In a speech on Wednesday, Defence Secretary Wes Streeting said daily lives depend on satellites that power everyday technologies like mobile phones and banking apps, adding the loss of GPS would cost the UK economy £1.4bn a day.

"Our dependency on space is precisely why it is increasingly under threat from our adversaries," he said.

"We depend on them for everything from weather forecasts, energy supplies, and financial transactions to sat-navs, mobile phone

connections, and Amazon deliveries," said Streeting, adding that the loss of "everyday conveniences would undermine our daily freedoms, and trust in our institutions."

Speaking at the UK Space Conference, Streeting said the threat from Britain's adversaries was growing in "scale, speed and sophistication", adding that the "challenges in space increasingly mirror the geopolitics on Earth".

'world leading'

A number of nations are believed to have similar ground-based systems against satellites. Last year the then head of the UK's Space Command said Russia was trying to jam UK satellites with ground based systems "every week".

The defence source described the UK's terrestrial electronic

Spencer book 'should be pulled' insists Morgan

■ Outspoken broadcaster draws apology for factual errors in Diana book

Piers Morgan has called for Earl Spencer's book about Princess Diana to be pulled from the shelves over a factual error.

Earl Spencer, Princess Diana's brother, apologized to Morgan for incorrectly describing him in the memoir as the editor of the Daily Mirror when the Mirror

Group published "highly intrusive photographs of Princess Diana at the gym" in 1993.

Morgan said he accepted the apology but that his lawyers would be "laying out that we want the offending pages to be removed from this book. And if that means they pulp the first edition, so be it".

Late reports suggest that Penguin, the publishers of *Swan Song: Diana, My Sister*, will be amending this one point in future editions of the book.

The photographs of Princess Diana mentioned in relation to Morgan in Earl Spencer's book were published by the Sunday Mirror on 7 November 1993.

At the time, Morgan was working at The Sun and did not join the Mirror as its editor until 1995.

'completely wrong'

Earl Spencer admitted "his assumption was incorrect" and "apologises to Mr Morgan for this error", a statement said.

In his account, Earl Spencer described how he personally rang tabloid newspaper editors to withdraw the invitations to Diana's funeral in 1997. This included Piers Morgan, who the book blames for a mirror newspaper story that intruded on Diana's privacy with pictures of her exercising in a gym.

Except that Piers Morgan wasn't the paper's editor at the time.

Morgan added: "He's apologized this afternoon for getting it completely wrong, but again describes himself as an historian and says it's his duty to correct the record. Well, in that case, I am asking for the book to be withdrawn."

'certain context'

Earlier in the week Spencer warned he could write a "hit piece on the Royal Family" but insisted it wasn't a threat, as he would never do it.

He made the bold statement while defending the release of his controversial book, which has made headlines

worldwide for its string of vociferous allegations against the King.

Those include the claim that Charles had told the Earl, "we'll forget her soon enough", just days after her death.

But the author insisted the memoir – titled *Swan*

Song: Diana, My Sister – is not a "hit piece on the King".

Speaking to ITV, the Earl said: "This is about Diana. It was impossible to give the full story of Diana's life without putting in context certain things."

"This is not a threat at all because I'm not going to do it. If I wanted to write a hit piece on the Royal Family, I could do that – that's not my job."

"My job in this book was to celebrate Diana, it's exactly the same as with the eulogy."

Counter-terror forces thwart Manchester synagogue attack

Counter-terrorism police said on Tuesday they had arrested two people as part of an investigation into a suspected terrorist plot to target the Jewish community in northern England.

Police said the two men, aged in their 30s, were arrested in central Manchester on Sunday under counter-terrorism legislation with searches also carried out in Salford and Liverpool.

"This has been a long-running proactive investigation which has led to the disruption of what we believe to be a plot to target the Jewish community in the Manchester area," Vicki Evans, Senior National Coordinator for Counter Terrorism Policing, said in a statement.

She said detectives did not believe that there was any ongoing threat, but police in Manchester said they had stepped up a policing operation during upcoming Jewish High Holy days. The two men were being held in custody in London while further investigations are being carried out.

Almost a year ago, two Jewish worshippers were killed in an attack on a synagogue in Manchester during Yom Kippur, the holiest day

in the Jewish calendar, which was committed by a British citizen of Syrian descent who had said he was acting for Islamic State.

"We are acutely aware this news will cause further concern to the Jewish community, as well as the wider public, especially given the significant High Holy day period," Evans said.

"I want to reassure them we are working incredibly closely with colleagues in Greater Manchester Police and partners to ensure we're doing everything we can to keep them and the wider public safe."

Britain has seen a significant rise in antisemitism since the Hamas attacks on Israel in October 2023 which triggered the subsequent war in Gaza. There was a spate of arson attacks on targets linked to the Jewish community in London earlier this year, while in April two Jewish men were stabbed in what police said was a suspected terrorist incident.

That led Britain to raise its national terrorism threat level to "severe", with then-Prime Minister Keir Starmer saying the country's 290,000 Jews were living in fear.

warfare capability as "world leading, and more".

The threat to GPS systems used in sat-navs and mobile phones is especially acute, according to Air Chief Marshal Sir Harv Smith.

arms race

"Major disruption to GPS would cost the UK economy to the tune of

£1.4 billion every day," Smith said on Monday.

"Sat-nav systems would fail, congestion on the roads would create havoc, our emergency services would take much, much longer to reach those in need. So make no mistake, the satellite services you may have taken for granted now face unprecedented threat."

Last week US confirmed for the first time that it had also deployed an unspecified

"weapon" in space to defend its own satellites.

Both China and Russia condemned the move – warning of an arms race in space.

However, Washington has already accused both Russia and China of developing their own space weapons – ranging from electronic jammers, lasers to blind other satellites and even projectiles that can be fired from satellites in orbit.

UK resident charged over Rwanda war crimes

A man has been charged with crimes linked to the genocide in Rwanda in 1994 in the first case of its kind to be brought in the UK.

Dr Vincent Brown, formerly Dr Vincent Bajinya, 65, who used to live in Kigali, the capital of Rwanda but now lives in Islington, north London, appeared at Westminster magistrates court on Tuesday charged with seven offences.

The charges are one of conduct ancillary to genocide and six offences of conduct ancillary to murder as a crime against humanity, the Crown Prosecution Service (CPS) said.

Frank Ferguson, the head of the CPS special crime and counter-terrorism division, said: "The charges relate to allegations that Dr Brown took part in the genocide against the Tutsi in Rwanda in 1994.

"He is alleged to have directed and incited acts of murder and genocide carried out by others.

"The Crown Prosecution Service made its decision after reviewing a file of evidence submitted by the war crimes team at the Metropolitan police.

"We concluded that our legal test for bringing criminal charges had been met.

"The Crown Prosecution Service makes prosecution decisions independently of police and government, on the evidence available and in accordance with the law. Criminal proceedings against Dr Brown are now active.

"The defendant has the right to a fair trial, and it is extremely important that there should be no reporting, commentary or sharing of information online that could prejudice those proceedings."

'Pay with a smile' facial recognition technology trialled in London cafes

■ Coffee lovers test drive new facial recognition payment method at Kiss The Hippo cafes in Bloomsbury, Chelsea and Soho this week

Digital financial firm Revolut is piloting a new facial recognition payment system in London that allows customers to pay for items with a "simple glance".

The Pay with Smile feature is now available at participating businesses using Revolut Register terminals, with the pilot launching in the capital this past Thursday. Customers will initially be able to try out the technology at Kiss the Hippo cafes in Bloomsbury, Chelsea and Soho. Those who simply cannot wait a second for their morning macchiato can simply tap Pay with Smile on a Revolut Register screen before completing a facial identity check, which is similar to using facial recognition to unlock a smartphone or access a banking app.

opt-in

The technology then verifies a customer's identity against the checks they completed when signing up to Revolut. If the facial match is successful, an account-to-account payment is authorised.

Customers must actively opt in to use the feature through their Revolut app settings. Revolut said customers will not be enrolled automatically and can withdraw their consent at any time.

Alex Codina, general manager of merchant payments at Revolut Business, said: "By combining high-performance processing with facial recognition technology, we're replacing

outdated, fragmented tills with a hyper-efficient checkout experience designed to solve consumer and merchant pain points." The company said facial recognition data is encrypted end-to-end, while personal data will not be stored by participating merchants.

Scotland drug deaths rise by 11%

■ Country already struggles with the worst fatality rate in Europe

Deaths related to illicit drugs rose by 11% in Scotland last year to 1,133 as the country struggles to tackle the worst fatality rate in Europe.

National Records of Scotland (NRS) said the figure for 2025 was 116 higher than the previous year, bringing the total deaths in a decade to more than 11,000.

After adjusting for age, there were 214 drug-related deaths per million people.

NRS defines drug-related deaths as those where the underlying cause was drug poisoning, a controlled substance was in the body at the time of death, and drug use led directly to the death.

Efforts to save lives over the past year have been hampered by criminal gangs mixing powerful synthetic opioids such as nitazenes with existing

drugs including heroin, cocaine and fake Valium pills.

Nitazenes were implicated in 247 deaths in 2025 - more than 22% of the total. The figure had more than trebled from 76 deaths the previous year.

Opiates and opioids, such as heroin, continued to be the most common type of drug implicated in deaths, accounting for 78% of the total.

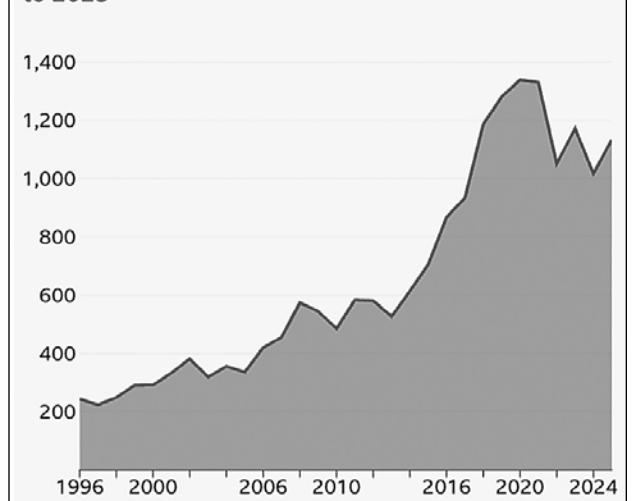
Cocaine was implicated in 52% of deaths, the highest figure since NRS began publishing specific data in 2008.

NRS said the increase in deaths - which came after a 13% fall in 2024 - had been driven by a rise in deaths of male drug users. This increased by 19%, while the rate of female deaths fell by 5%.

The rate of drug-related deaths in the most deprived areas of Scotland was 15 times as high as in

the least deprived areas.

The average age of death has increased from 32 in 2000 to 46 years in 2025.

Over a five-year period from 2021-25, Glasgow recorded the highest average death rate at 380 per million, followed by 340 per million in Dundee and

310 per million in North Ayrshire.

When comparing Scotland with the rest of Europe, NRS measures the death rate among 15-64 year olds - which was 277 per million in 2025.

The next highest rate in Europe was Estonia with 112 deaths per million in 2024.

War of words grows ahead of Ireland-Israel clash

- Irish PM backs manager of over ‘genocide’ comments
- Hallgrímsson accused of ‘stupidity’ by Israel’s FA

Ireland’s prime minister, Micheál Martin, backed his country’s football manager, Heimir Hallgrímsson, after Israel’s football federation accused Hallgrímsson of “stupidity, ignorance and hypocrisy” over comments about the war in Gaza.

“I think those are unacceptable remarks; they should be withdrawn,” Martin told reporters in New York, where he was attending the UN general assembly this week.

“Israel can’t keep denying what the world knows, and what the world understands.”

Hallgrímsson sparked the row after saying before two Nations League fixtures against Israel: “We’re not playing with genocide, we’re playing against genocide. We’re playing against Israel, we’re not playing with Israel.”

Martin said Hallgrímsson’s comments reflected concerns about the scale of death and destruction in Gaza, also citing remarks by the UN secretary general, António Guterres.

‘tricky time for us’

On Wednesday Hallgrímsson, preparing his team for their opening fixture against Kosovo, expressed gratitude for Martin’s backing. “What I said at the last press meeting has taken the attention away from maybe what’s most important; we are playing an important game against Kosovo,” Hallgrímsson said.

“Maybe, from a leadership point of view, not clever for me to take the attention like this. But to answer the question, we are thankful for all the support we get. It’s a tricky time for us.”

The dispute comes

amid mounting controversy in the Republic over the fixtures, scheduled for 27 September and 4 October. More than 160 Irish sportspeople have signed an open letter calling on the national team to boycott the matches, and protesters gathered outside the team’s Dublin hotel on Monday. Further protests are planned around the country in the run-up to the games.

sanctions

The Football Association of Ireland (FAI) passed a motion last November requesting that European football governing body, Uefa, suspend Israel from international competition. The FAI has said it has little choice but to fulfil the fixtures or risk sporting and financial sanctions.

Ireland’s designated home match on 4 Oc-

tober was moved from Dublin’s Aviva Stadium to Backa Topola, Serbia, after concerns over disruption and security. The 27 September match, officially Israel’s home fixture, will also be played at a neutral venue, in Debrecen, Hungary.

Tolkien to be honored at the Abbey

J.R.R. Tolkien, writer, artist, scholar and linguist is to be honoured in Westminster Abbey in Poets’ Corner alongside his close friend and fellow writer, C.S. Lewis.

A major new memorial celebrating Tolkien’s creative vision and storytelling by artist Stephen Broadbent will be revealed at a dedication ceremony in Spring 2027, which is also the 90th anniversary year of The Hobbit and 50th anniversary year of The Silmarillion.

The new memorial has been inspired by Tolkien’s Tree of Tales, which he called the Tree of Amalion. Featuring the imagery of a tree in a forest as its central theme, it will be a significant new artwork for the Abbey, inlaid vertically

within a stone pillar in the south transept and rising 2.5 metres high.

Predominantly made from native woods found in the UK, it will include a piece of the iconic black pine, known as ‘Tolkien’s tree’, which was felled from Oxford University’s Botanic Garden in 2014. The tree, a Pinus nigra, was a favourite of Tolkien during his time in Oxford.

Known to millions around the world as the author of The Lord of The Rings and The Hobbit, Tolkien spent most of his life as a distinguished academic at Oxford University, where he taught Old and Middle English, and Old Norse. Outside his academic life he created fantasy books, children’s stories, poetry and illustrations, as well

as inventing languages and alphabets.

The Lord of The Rings was a sequel to Tolkien’s 1937 children’s book The Hobbit. Considered one of the greatest fantasy books ever written, it has shaped the modern fantasy genre and is one of the best-selling books of all time.

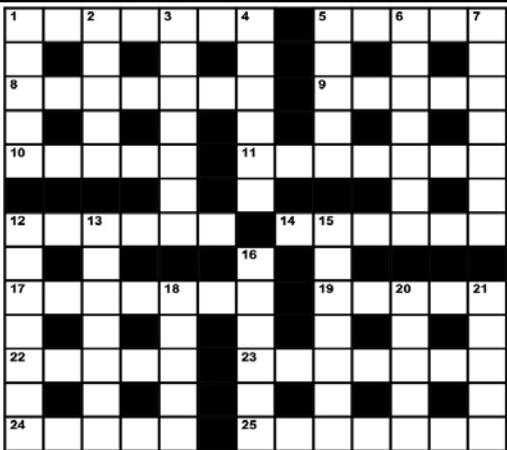
Over 150 million copies have been sold; it has been translated into over 35 languages and inspired award-winning adaptations for film and television.

Broadbent studio in Chester, led by Stephen Broadbent, who has a 40-year background in public art projects, secured the commission following a competitive process. The final design concept was informed by discussions with Tolkien scholars and experts.

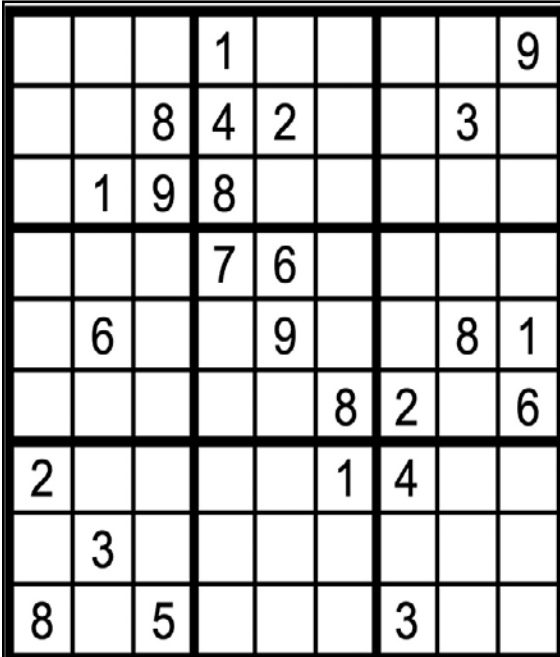

The health aisle culture shock faced by British transplants in America

You can prepare for driving on the other side of the road.

You can learn that sales tax appears at the till.

What's harder to anticipate is walking into an American pharmacy with a headache and discovering that the medicine you've bought for years seems to have disappeared.

For British expats in America, the health aisle can be an unexpectedly persistent culture shock. The problem usually isn't availability. It's unfamiliar terminology, bigger packs and an overwhelming number of products promising to treat slightly different combinations of symptoms.

The most useful adjustment isn't learning new brands. It's learning to shop by active ingredient.

Paracetamol?

One of the first surprises is that paracetamol is called acetaminophen in the US. To most of the rest of the world, it's still paracetamol.

That sounds like a straightforward translation, but it changes the way you shop.

Someone used to recognising a familiar box suddenly has to identify what the medicine actually contains.

I'd argue that's a useful habit to develop. Brand recognition feels reassuring, but the active ingredient gives you more meaningful information.

Choice=Complications

The contrast becomes sharper in the cold-and-flu aisle.

You might find daytime formulas, nighttime versions, "severe" products and multi-symptom medicines sitting side by side. It can look impressively tailored, but a product covering six symptoms isn't automatically better if you only have two.

There's also the risk of buying different products containing the same active ingredient.

Acetaminophen, for example, appears in hundreds of pre-

scription and over-the-counter products in the US. Someone taking a standard painkiller and adding a multi-symptom cold treatment therefore needs to check whether both contain it.

That's where the American Drug Facts label becomes valuable.

It's all in the label

US over-the-counter medicines use a standard Drug Facts format showing the active ingredient, purpose, uses, warnings and directions.

For newcomers, I'd treat it almost like a translation guide.

Two boxes may both promise "cold and flu relief" while containing different combinations of medicines. Equally, products with completely different branding can contain the same active ingredient.

Checking that information cuts through the marketing on the front of the pack and makes it easier to com-

pare products properly.

It's probably the single most useful habit British newcomers can adopt in an American pharmacy.

A question of scale

Scale adds another layer of culture shock.

American health aisles often reinforce the wider sense of abundance found in US retail. A bottle containing dozens or even hundreds of tablets can look striking if you're accustomed to buying smaller packets in Britain.

The important distinction is simple: pack size doesn't change dosing instructions.

A bigger bottle contains more doses. It doesn't mean the medicine should be taken more frequently or treated more casually. Strength and directions still need to be checked on the individual product.

That becomes especially important when something looks similar to a

medicine you previously bought in Britain.

Eventually, most British expats in America stop noticing these differences. "Acetaminophen" becomes familiar, and the Drug Facts panel stops looking unusual.

I wouldn't try to recreate a British medicine cabinet simply by choosing the closest-looking American alternatives, though. A better approach is to check the active ingredient, strength and directions each time, particularly with multi-symptom medicines.

If the label still leaves you unsure, asking a pharmacist is safer than relying on packaging or assumptions carried over from the UK.

Perhaps that's the real health-aisle culture shock. America offers enormous choice, but navigating it well means paying less attention to what the front of the box promises and more attention to what's actually inside.

A close-range effort from Koumas - who was flagged offside - early on was as encouraging as it got for Craig Bellamy's troops as Ronaldo, Ruben Neves and Dias spurned opportunities for the hosts.

With the goal at his mercy, Ronaldo failed to hit the target with a volley from six yards out shortly after the restart.

The frontman thought he had his moment in the limelight just before the hour mark as he poked beyond Ward, although the goal was disallowed for offside following a check from the video assistant referee.

Ireland come up short in Kosovo

The Republic of Ireland opened their Uefa Nations League campaign in deflating fashion as impressive Kosovo ran out deserved winners in Thursday's Group B3 opener in Pristina.

Having troubled the Irish defence throughout the game, striker Vedat Muriqi headed the winner seven minutes from time after Ermal Krasniqi's initial effort came back off the crossbar.

While the Irish players claimed Dara O'Shea had been pushed by Muriqi in the build-up, the goal stood following a video assistant referee (VAR) review.

The Republic of Ireland, playing their first competitive game since March's World Cup play-off semi-final loss to the Czech Republic, managed only one shot on target in a largely toothless display.

Chiedozie Ogbene spurned the away side's best chance in the 22nd minute when he blazed a shot over the bar after being teed up by James Abankwah.

"They deserved the win if I'm absolutely honest," said Republic of Ireland boss Heimir Hallgrímsson.

"There was nothing we didn't know about how

they'd play but it was an off day for a lot of our players."

Hallgrímsson's team move on to Sunday's controversial game against Israel - the first of two meetings over the next 10 days - which has dominated the build-up to this international window.

The build-up to Thursday's game - a first senior international between Kosovo and the Republic of Ireland - was not without difficulties for either side.

The hosts were forced to deal with captain Amir Rrahmani's abrupt retirement after he fell out with the Football Federation of Kosovo.

The Republic of Ireland's preparations, meanwhile, were overshadowed by the ongoing controversy over the upcoming fixtures against Israel, the prospect of which Hallgrímsson said has made his players uncomfortable.

Before leading his players into Sunday's first meeting with Israel in Debrecen, Hungary, Hallgrímsson was tasked with overseeing a winning start to their latest Nations League campaign.

We can't play like Spain!

NATIONS LEAGUE: Controlling games 'not in our DNA' says England star ahead of clash with world champs

Anthony Gordon says that controlling games is not in the English "DNA" but the Three Lions could win major tournaments if they stop "trying to replicate Spain".

The Barcelona winger was speaking at St George's Park as the England squad prepare to take on world champions Spain on Saturday - their first match together since the World Cup.

England lost their semi-final 2-1 to Argentina, before beating France 6-4 in the bronze medal match.

Ending on a high meant England achieved their best finish in a World Cup since 1966.

But many have criticised the manner in which England were

beaten by Argentina, after head coach Thomas Tuchel substituted goal-scorer Gordon and went to a back five.

The tactical tweak invited pressure, with Enzo Fernandez equalising before Lautaro Martinez scored a stoppage-time winner.

Gordon said that he had "never felt worse", after the game and believes that the "scar" left by defeat may mean the England squad take a different approach in the next tournament.

"[The] scar doesn't have to be a negative one because it might lead us to victory in the next tournaments," Gordon said.

"We can't keep looking at other countries and trying to be like them, because we're not them

- we're English and we have our own strengths which they don't have, so maybe we start playing the way we're good at."

Gordon moved to Barcelona from Newcastle for £69.3m in the summer.

He says that the experience of playing in La Liga - with and against some of Spain's top stars - has made him realise just how different the nation's approach is to football.

He is not convinced English players can be taught to play more like the Spanish, with their intricate possession-based game.

"I'm speaking from a point of view where I feel like we are trying to replicate Spain," Gordon said.

"Because I'm in Spain, I know we have just as

good players, but they have different qualities, so why are you trying to make those players the same as the Spanish players? Because the Spanish players lack the things that we have and vice versa."

England have lost two

consecutive European Championship finals, and been beaten by France and Argentina in the past two World Cups.

Those outcomes have led to repeated questions about whether the team are good enough at controlling possession

against elite nations.

Spain won the World Cup by beating Argentina and dominated with 65% of the ball in the final, restricting opponents led by Lionel Messi to just two shots in 120 minutes of play, neither of which hit the target.

Portugal win but Welsh keep it tight

Portugal kick-started the defence of their Nations League title with a hard-fought victory over Wales on Cristiano Ronaldo's return to Lisbon.

Joao Felix's deflected strike proved decisive midway through the first half Thursday night

at Estadio Jose Alvalade - where Ronaldo, 41, started his professional career with Sporting 24 years ago.

Ronaldo missed a glorious chance in addition to having a goal disallowed for offside early on in the second half

before being withdrawn as the hosts continued to threaten to add to their lead.

Wales' best chance fell to Liverpool forward Lewis Koumas, although Ruben Dias produced a crucial last-ditch block
